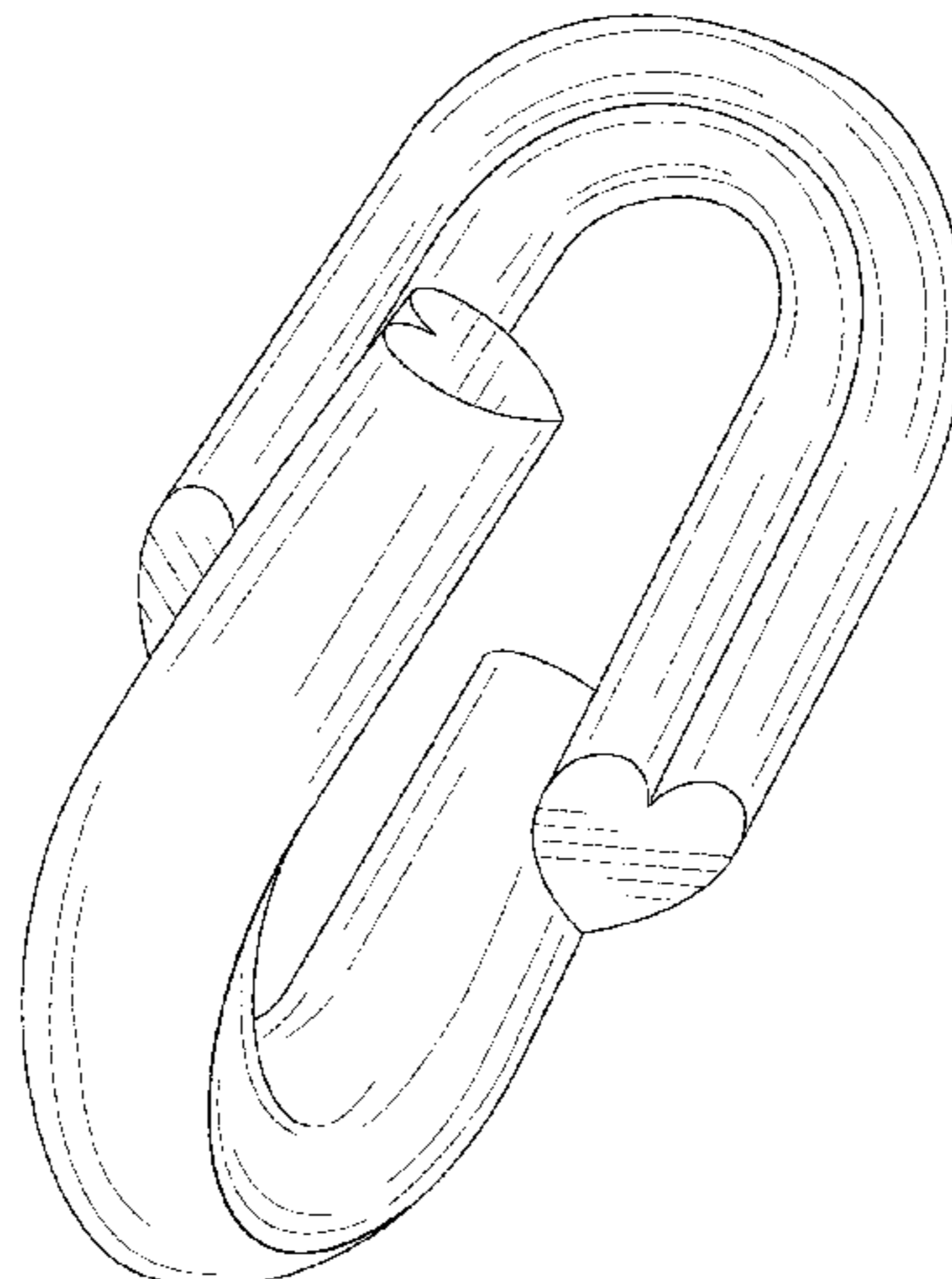
(57) **CLAIM**

The ornamental design for a jewelry link, as shown and described.

DESCRIPTION

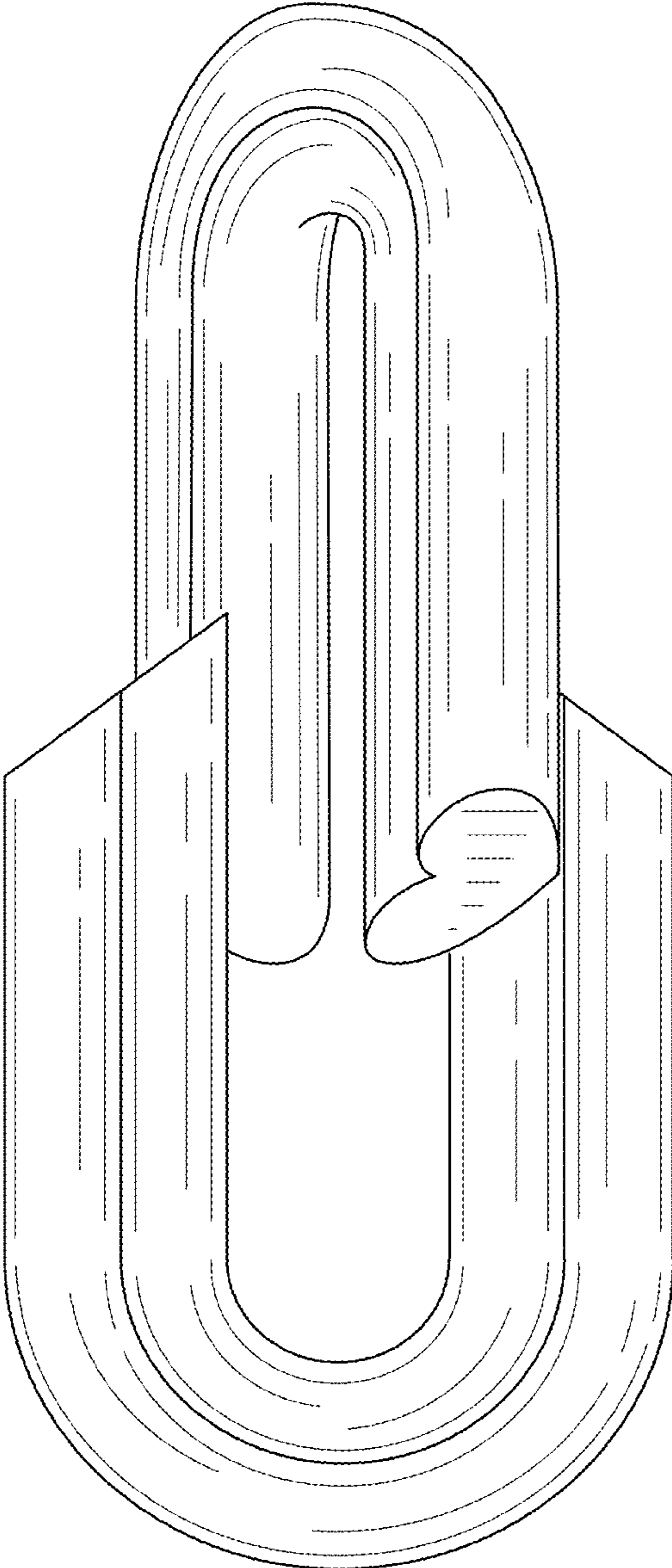

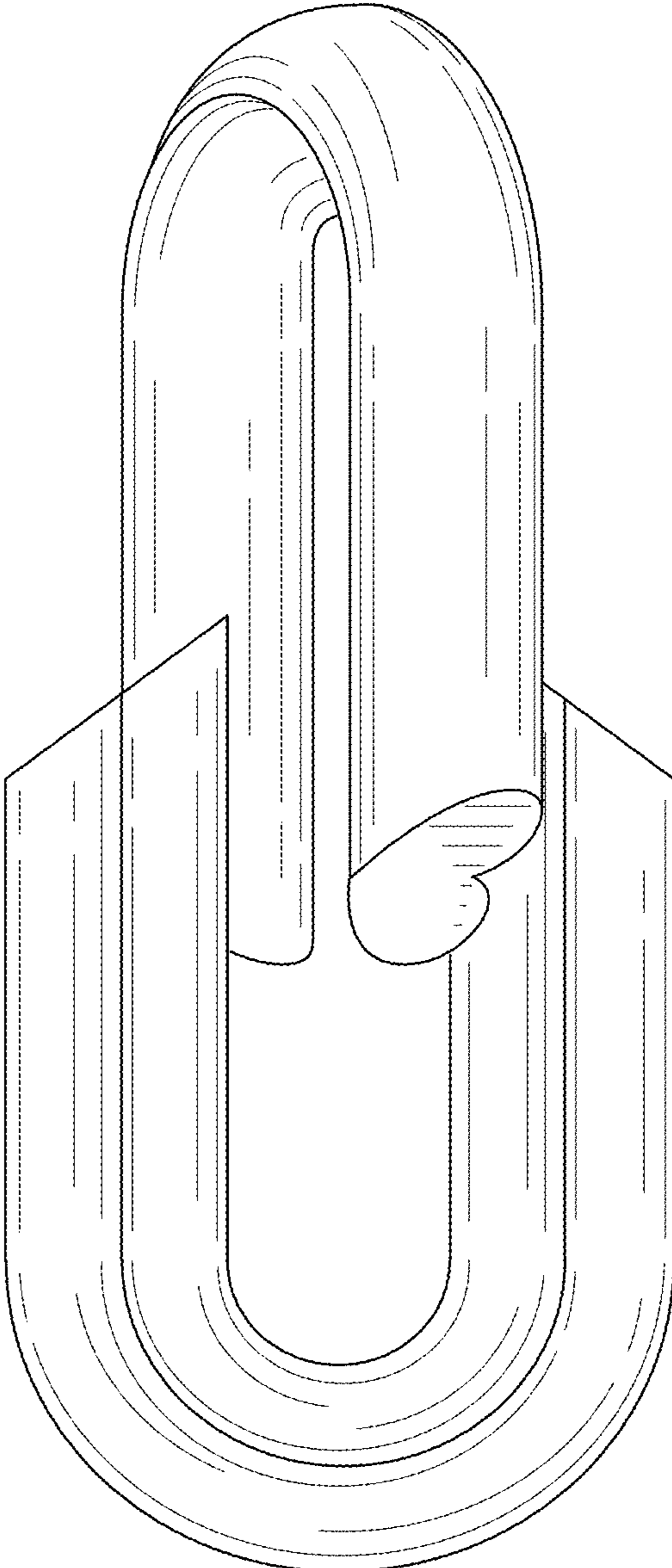

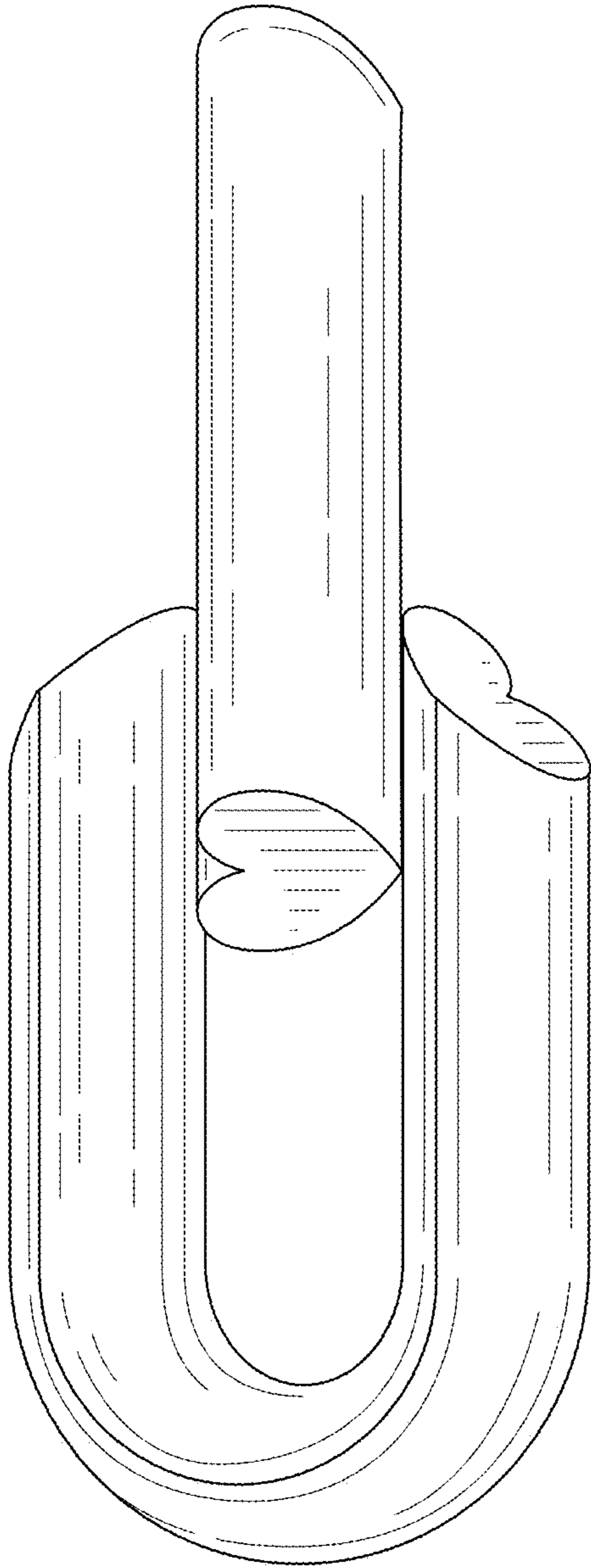

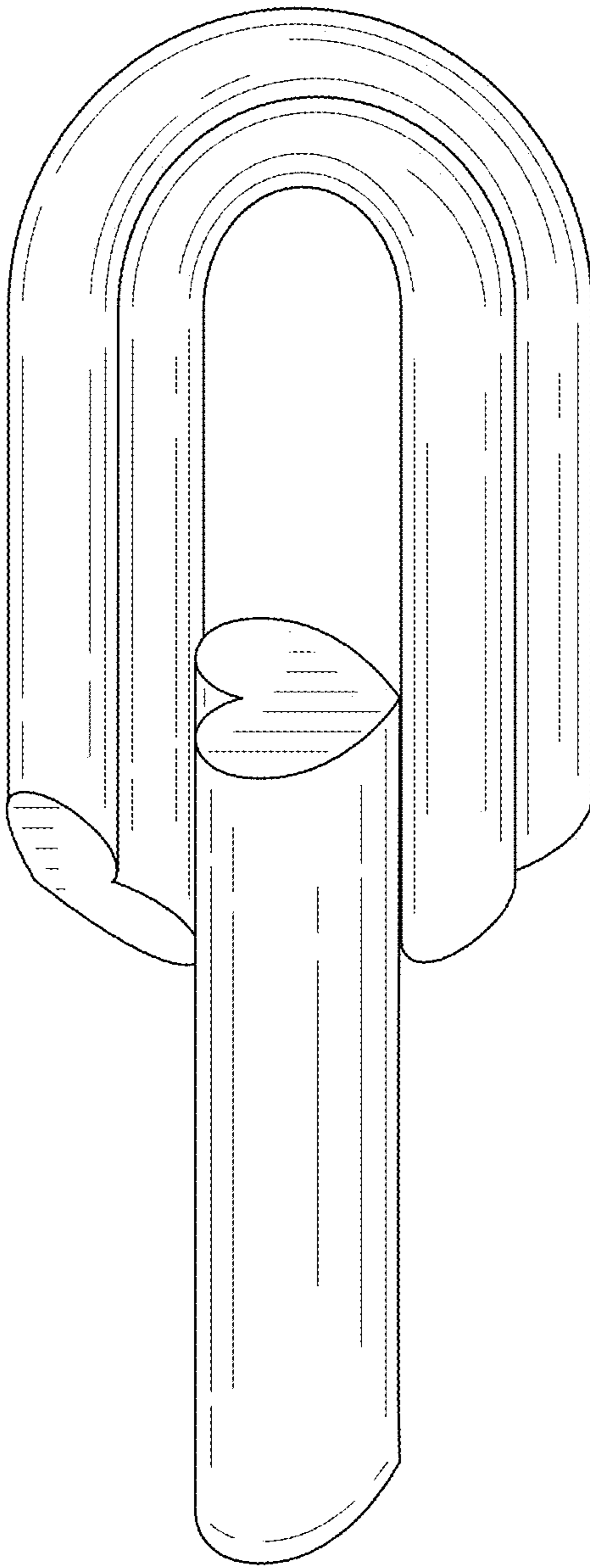

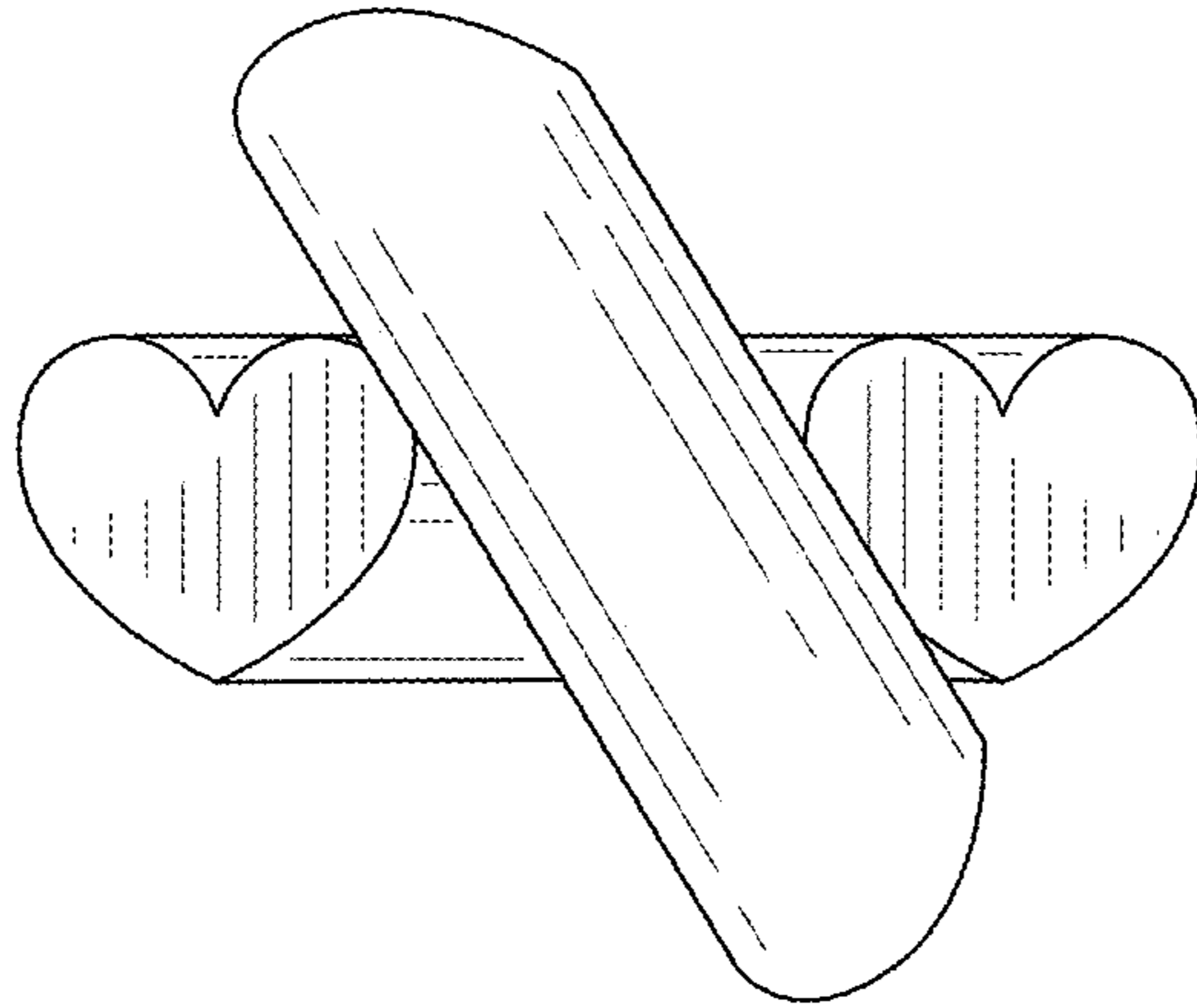

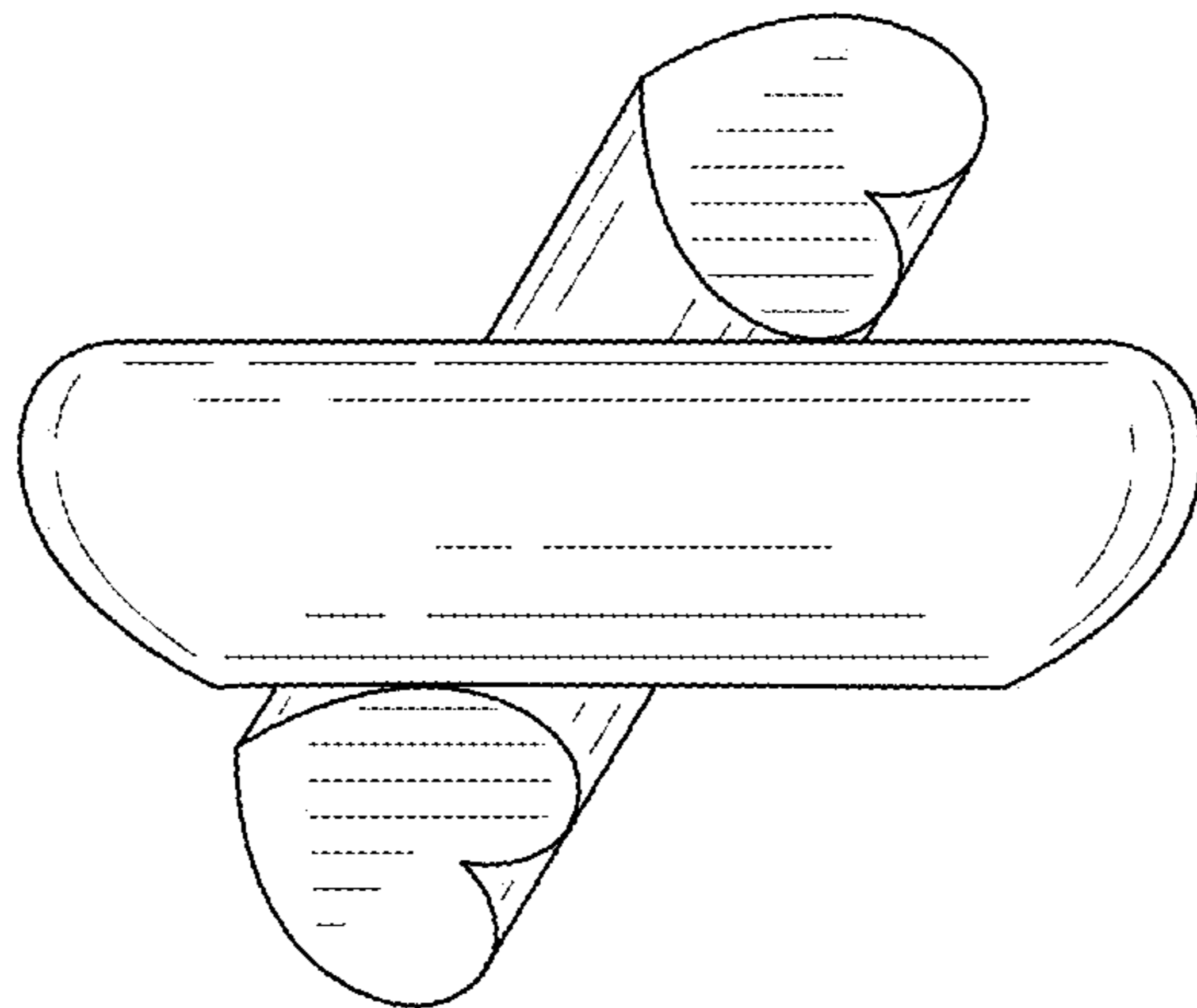

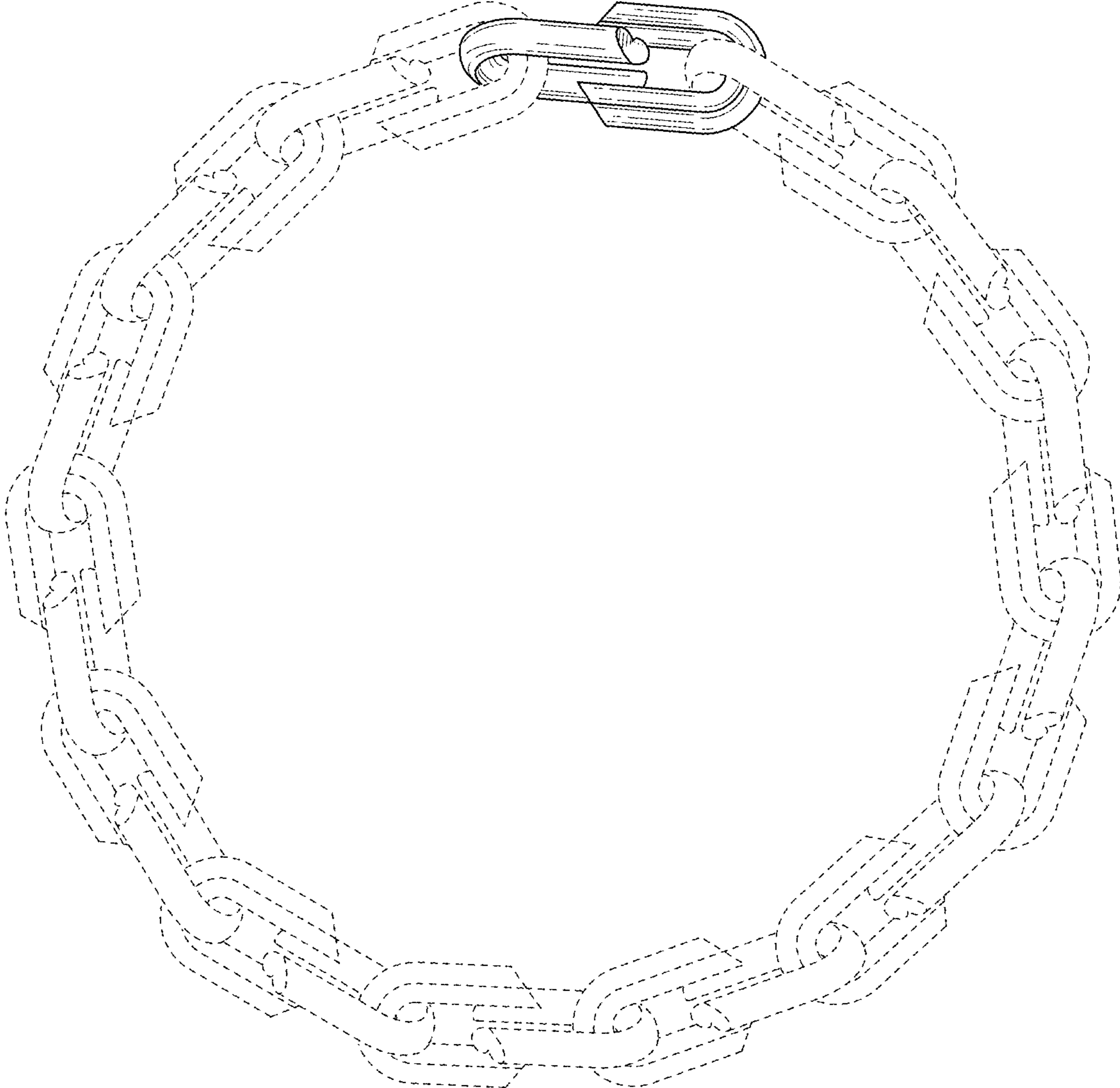

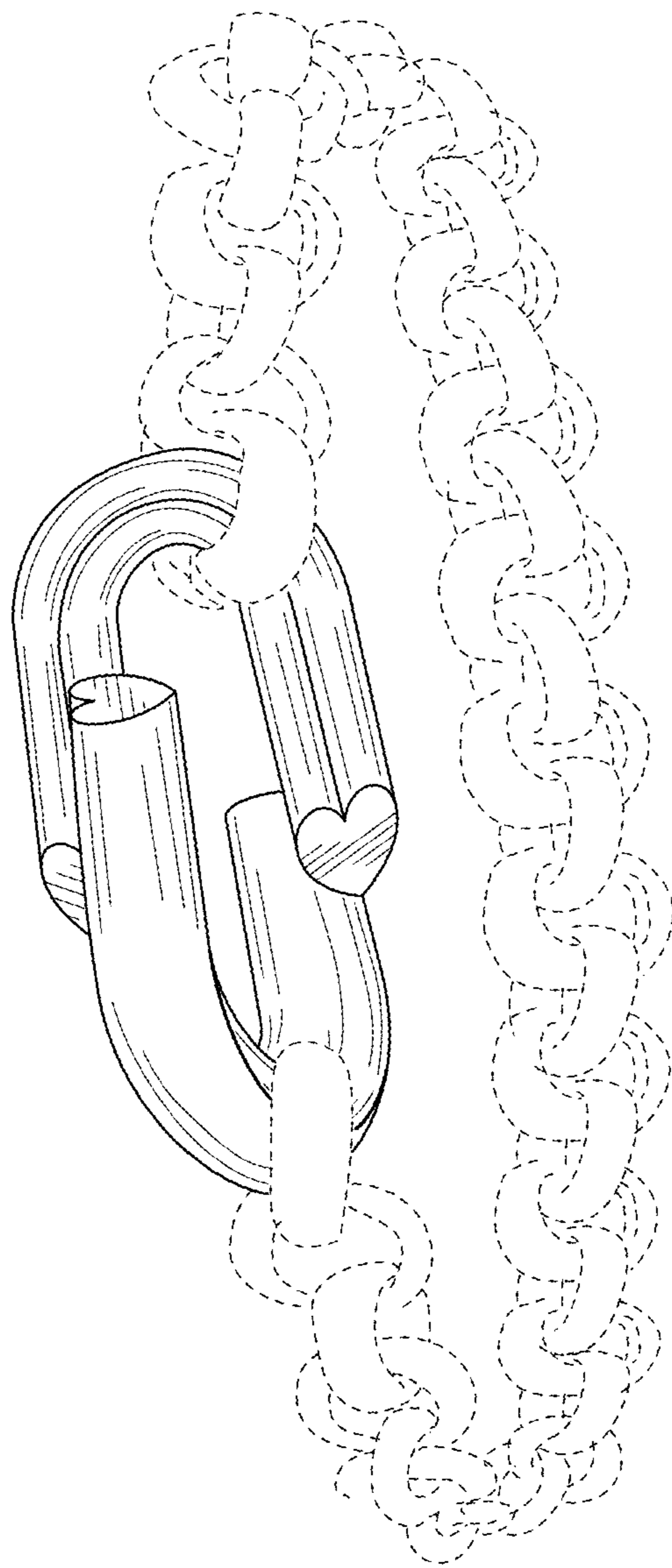

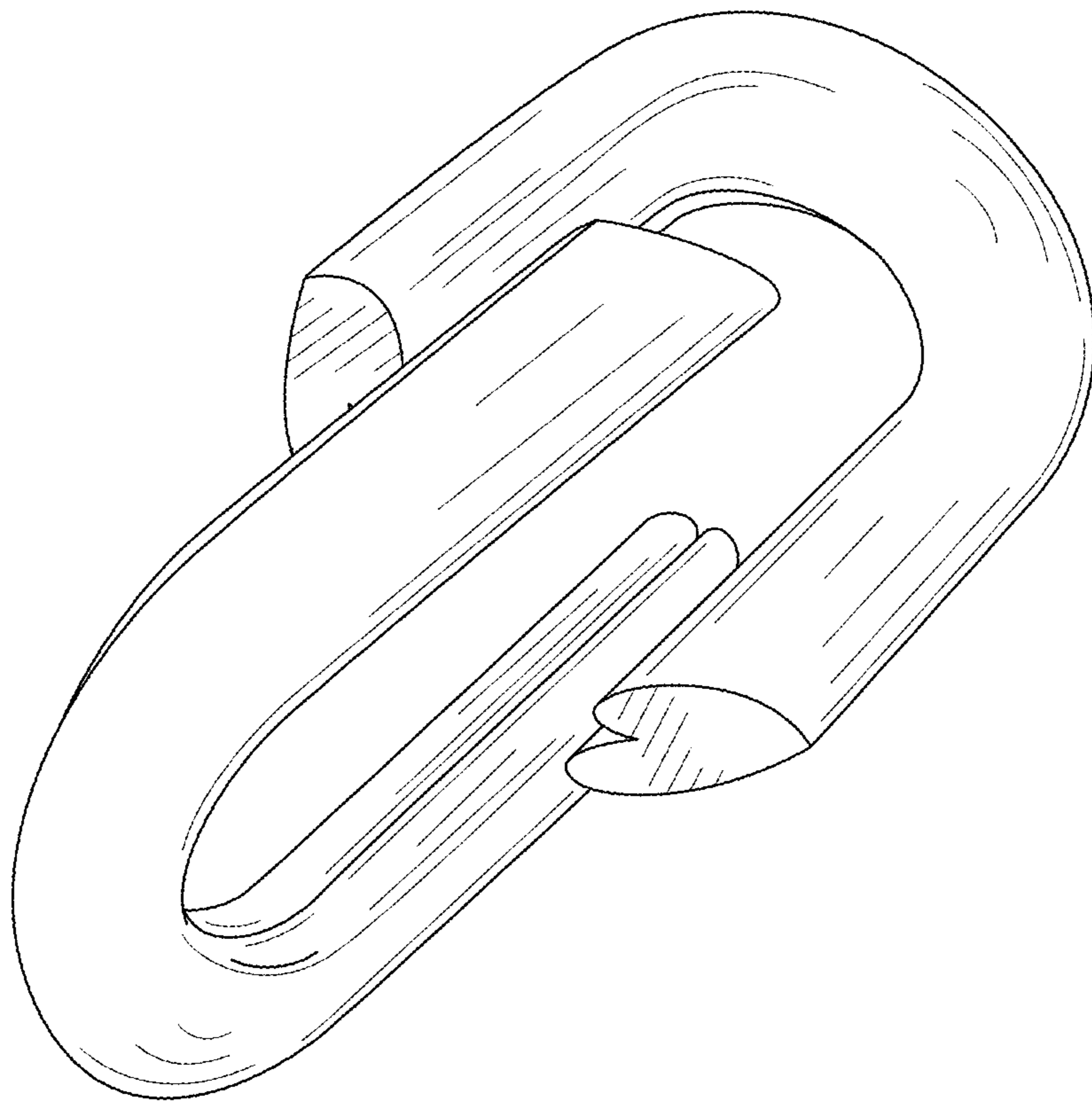

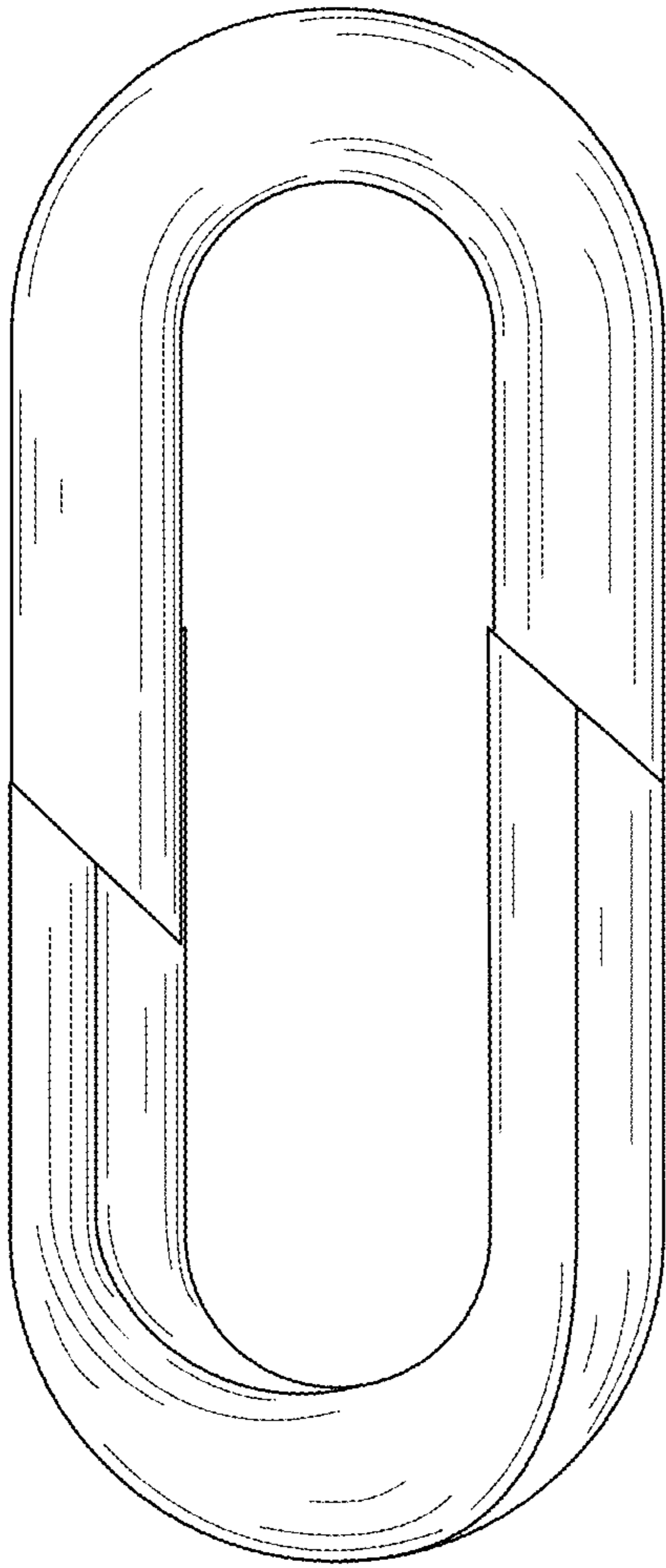

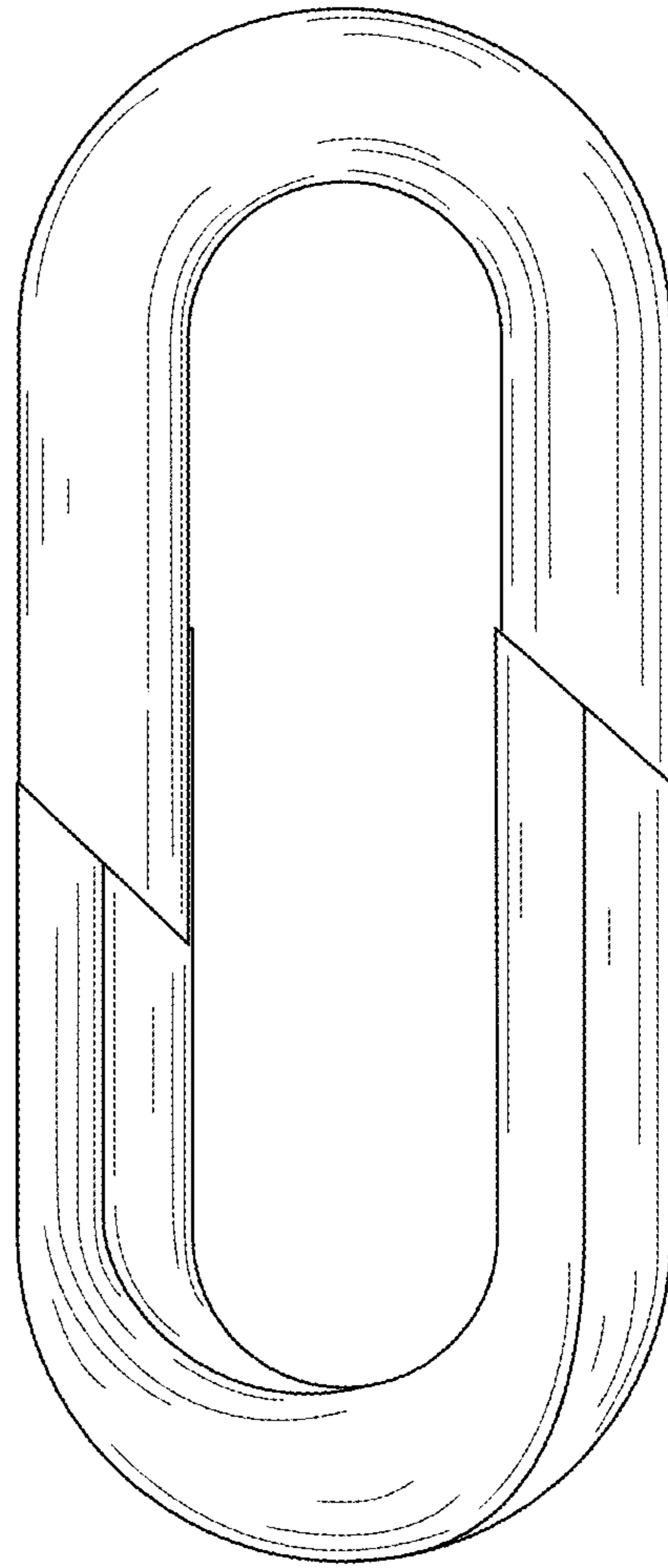

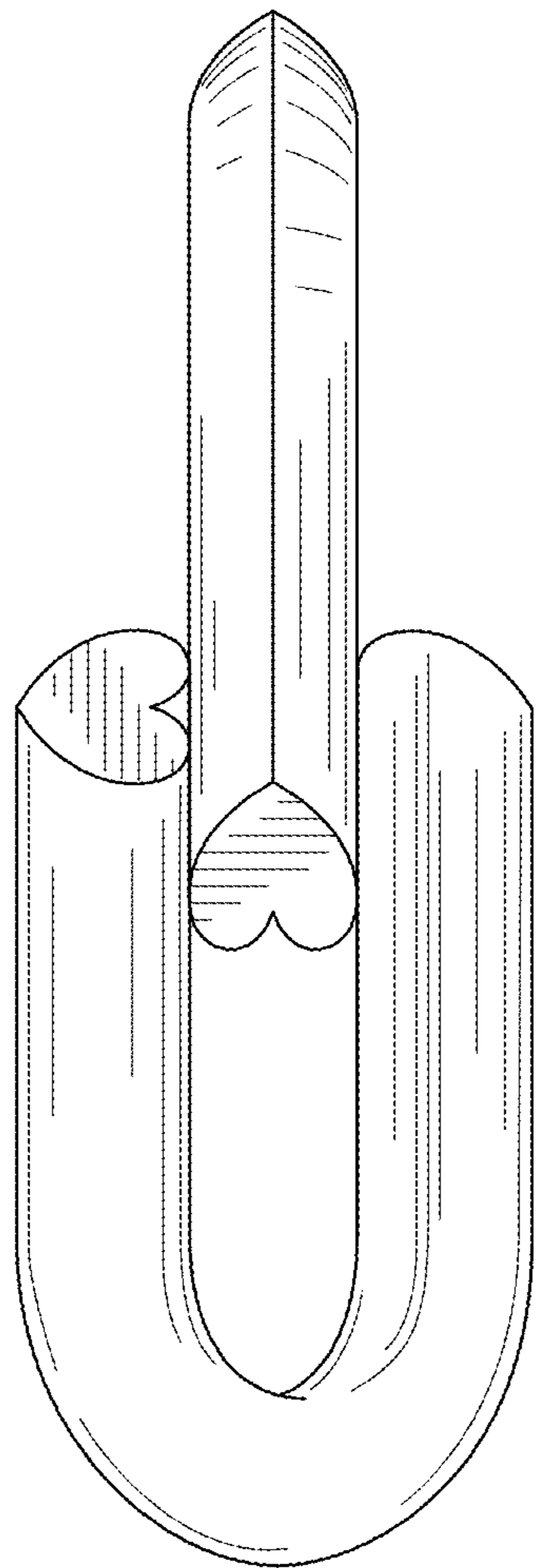

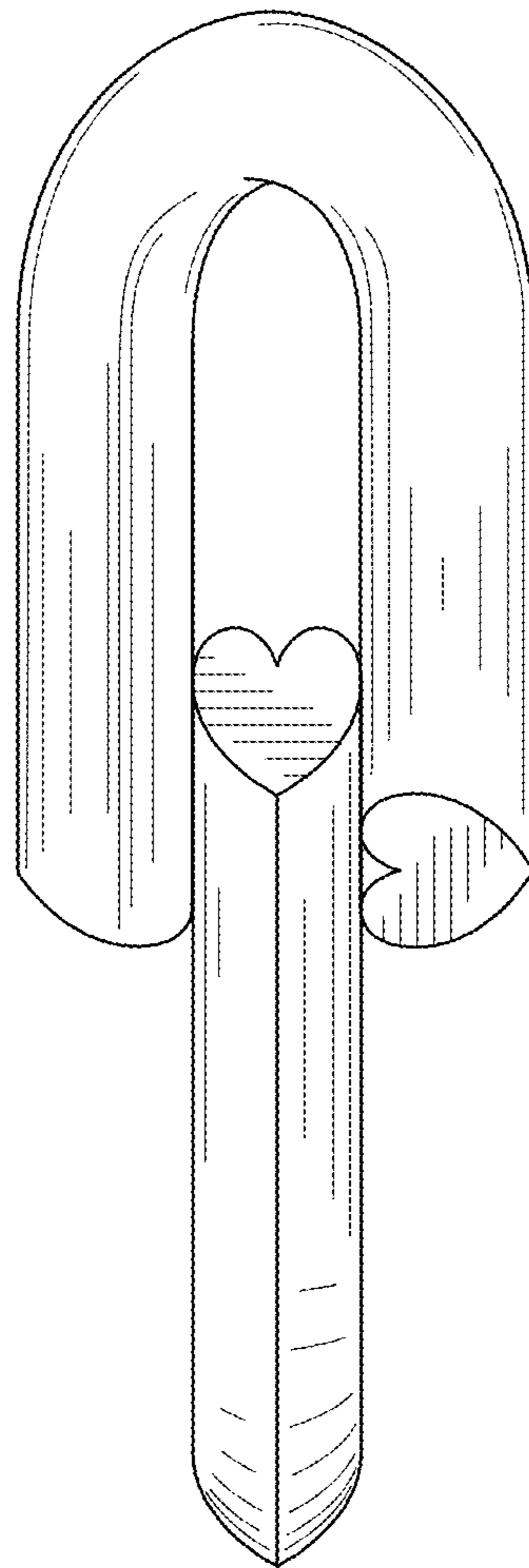

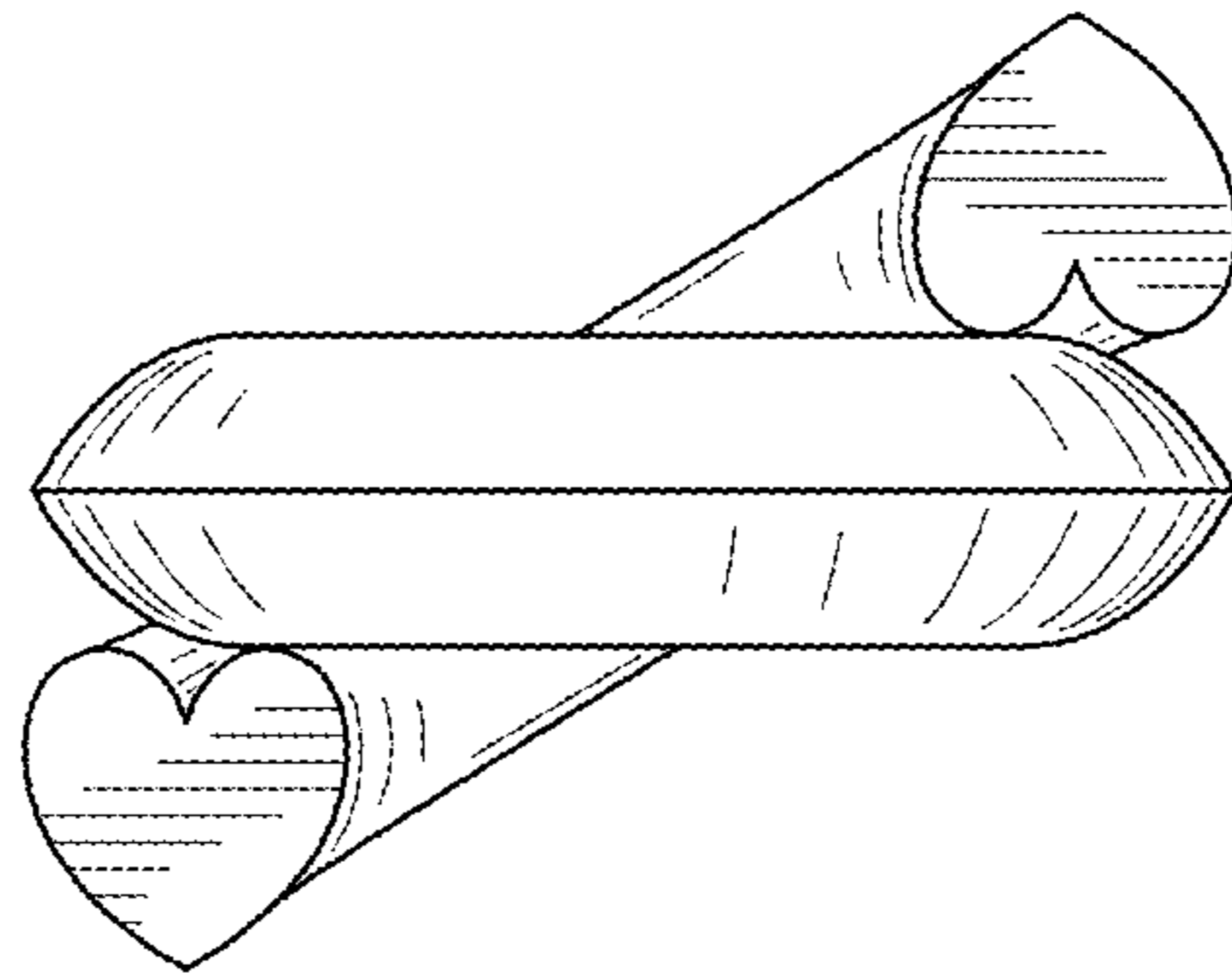

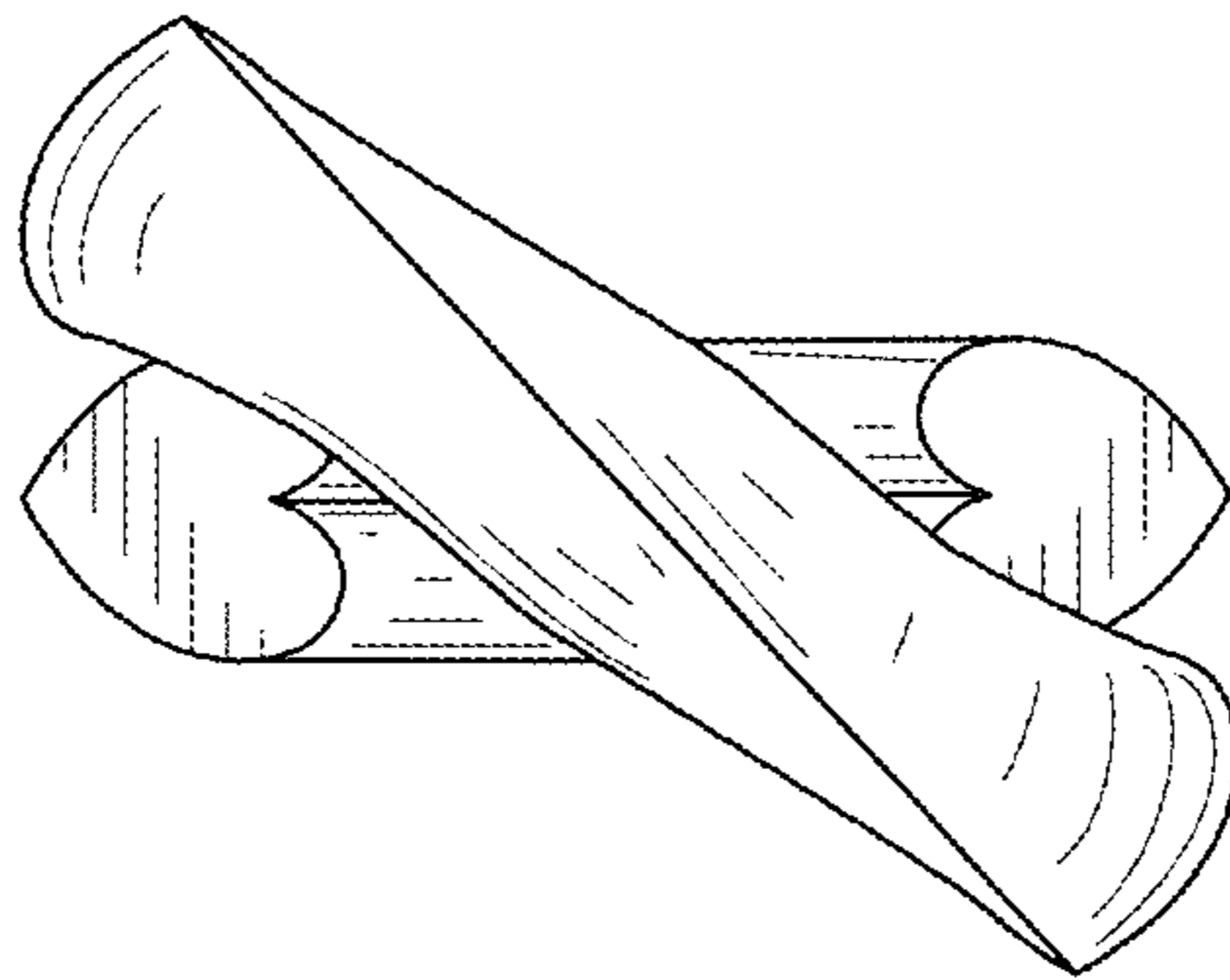

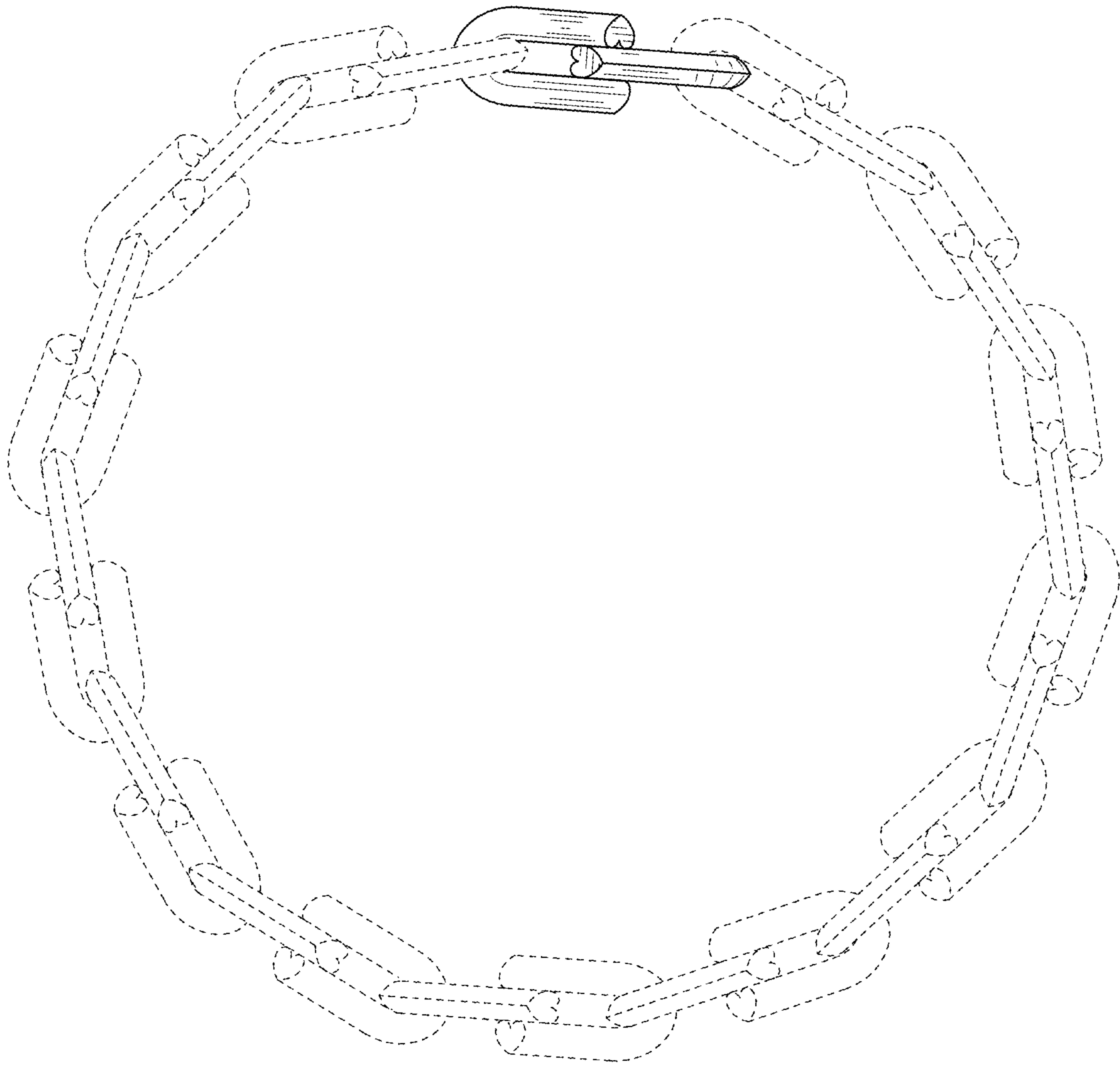

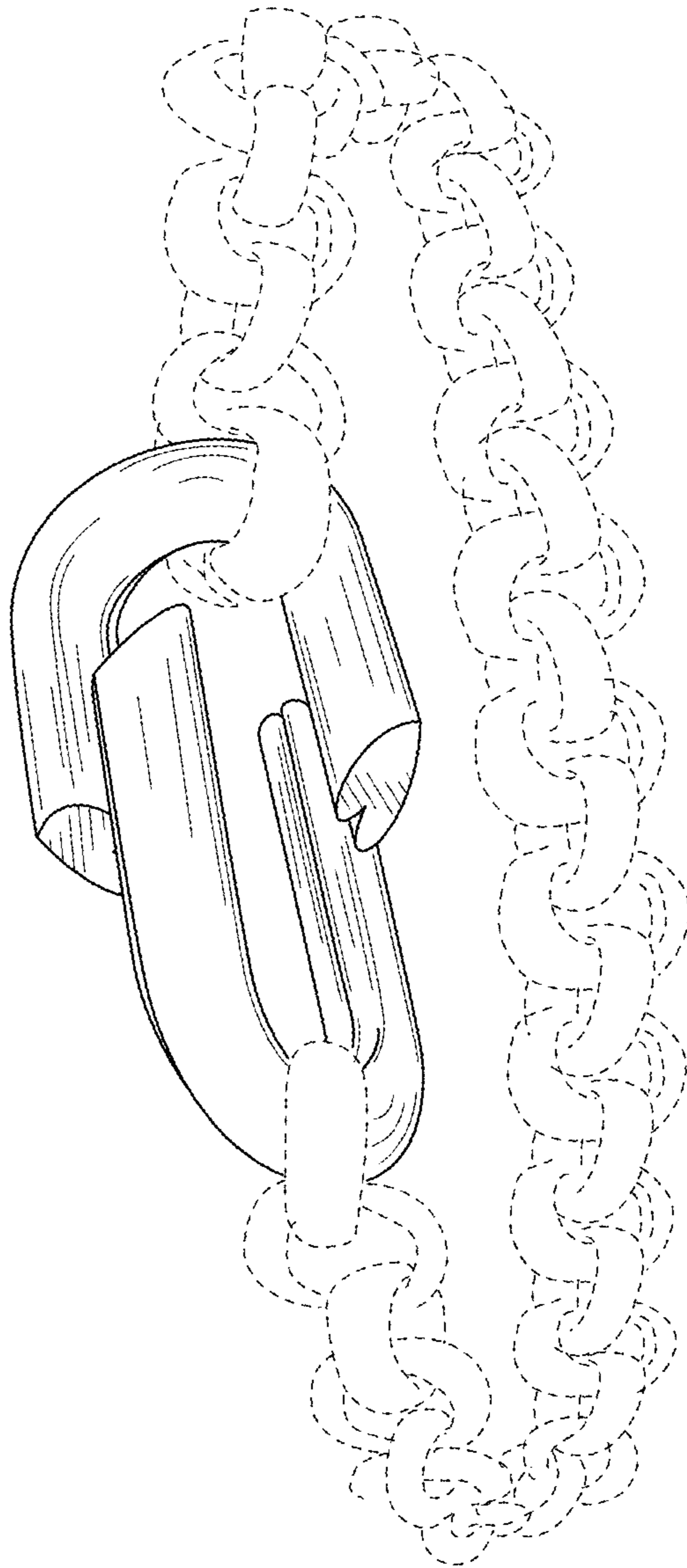
