(57) **CLAIM**

The ornamental design for a Christmas tree topper bow, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, right and top perspective view of a Christmas tree topper bow, showing my new design, shown in a used condition attached to four ribbons shown in broken lines.

FIG. 2 is a rear, left and bottom perspective view thereof.

FIG. 3 is a front elevation view thereof.

FIG. 4 is a rear elevation view thereof.

FIG. 5 is a left side elevation view thereof.

FIG. 6 is a right side elevation view thereof.

FIG. 7 is a top plan view thereof.

FIG. 8 is a bottom plan view thereof.

FIG. 9 is another front, right and top perspective view thereof, shown in a used condition attached to six ribbons shown in broken lines; and,

FIG. 10 is another front, right and top perspective view thereof, shown in a used condition attached to seven ribbons shown in broken lines.

The broken lines shown in the drawings are included for the purpose of illustrating portions of the Christmas tree topper bow that form no part of the claimed design.

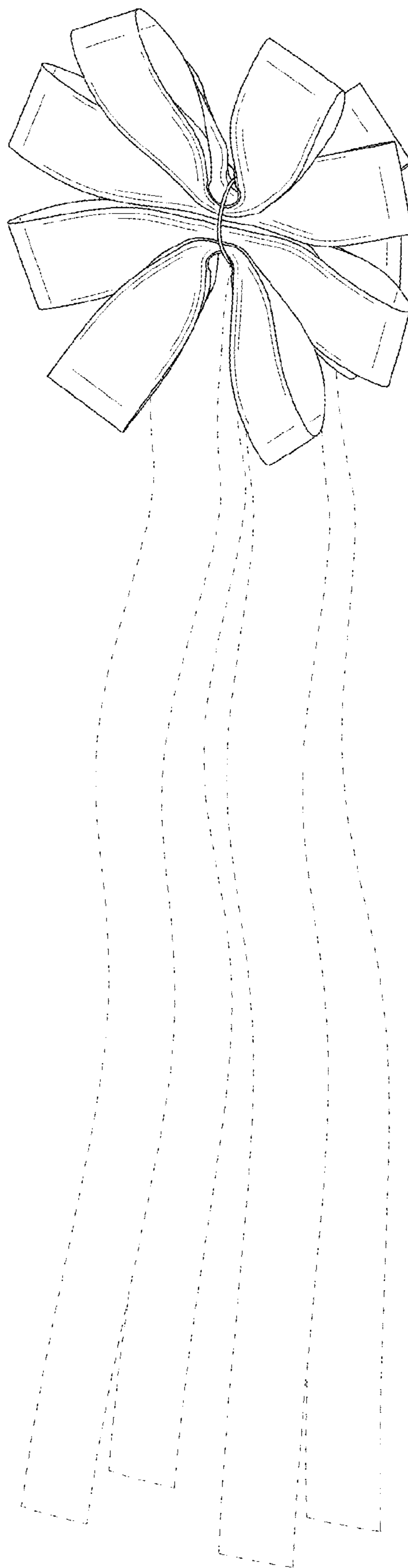

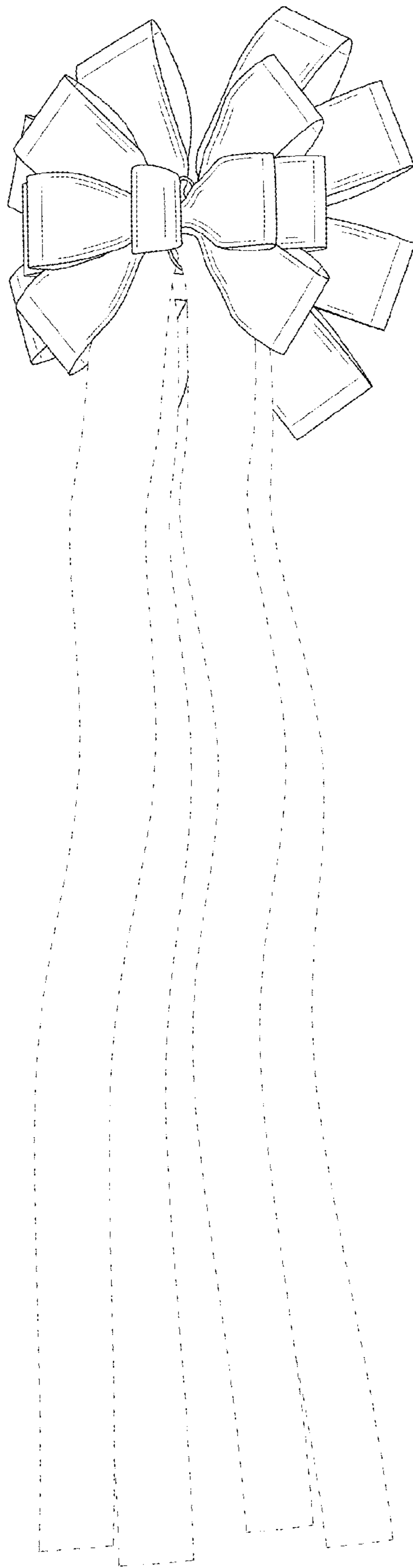

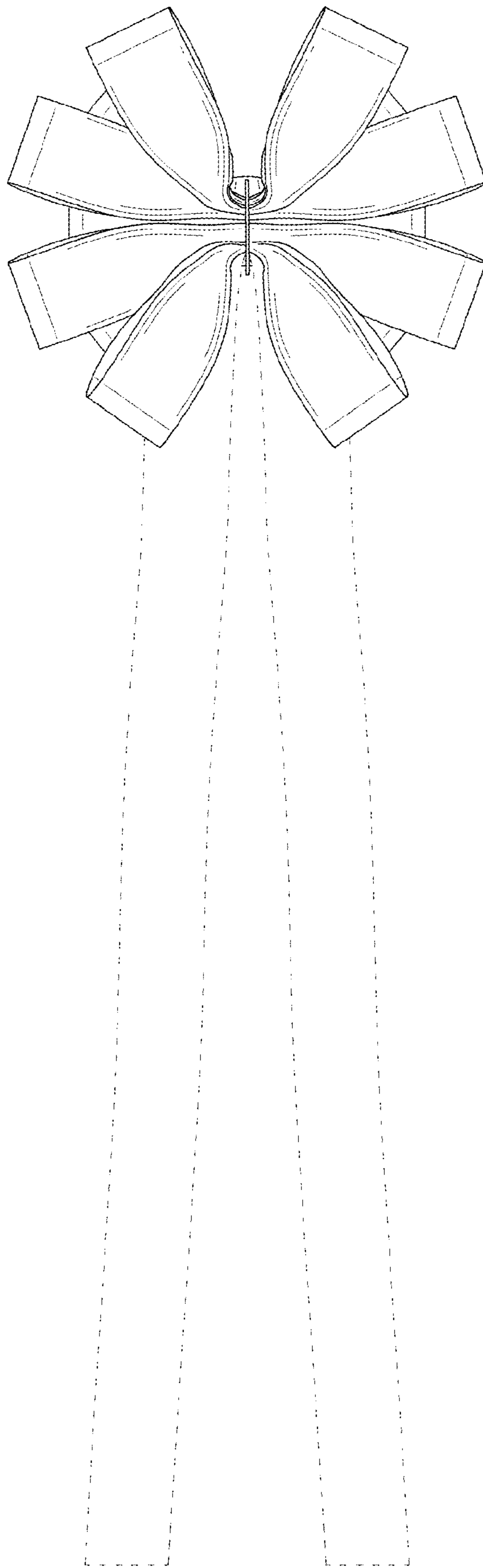

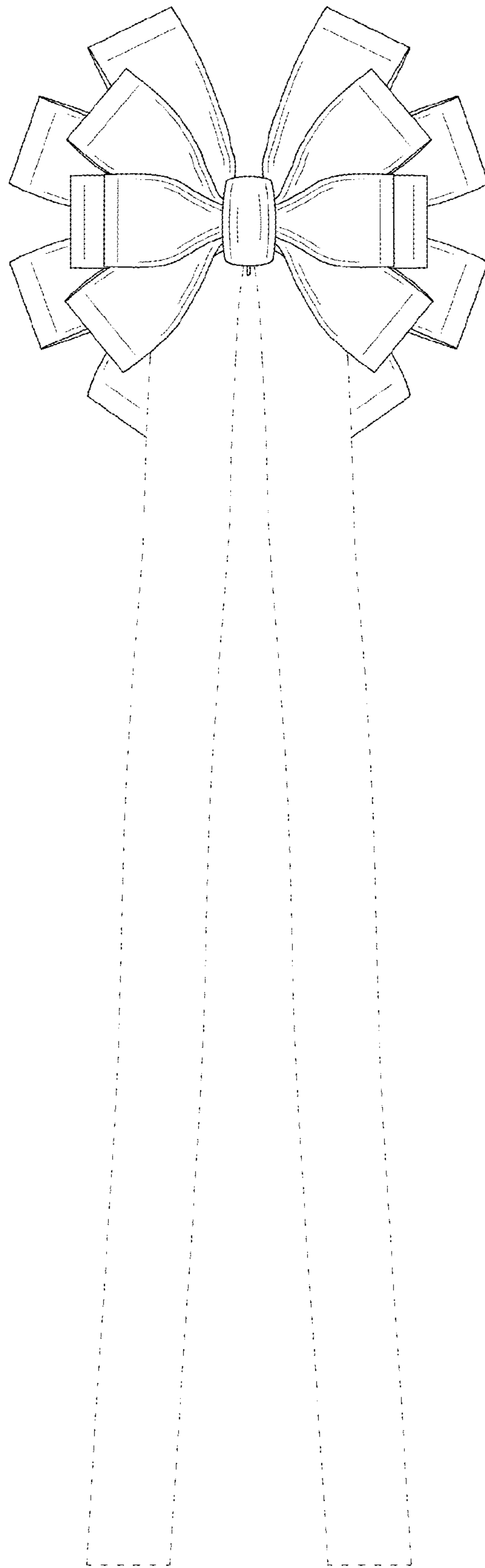

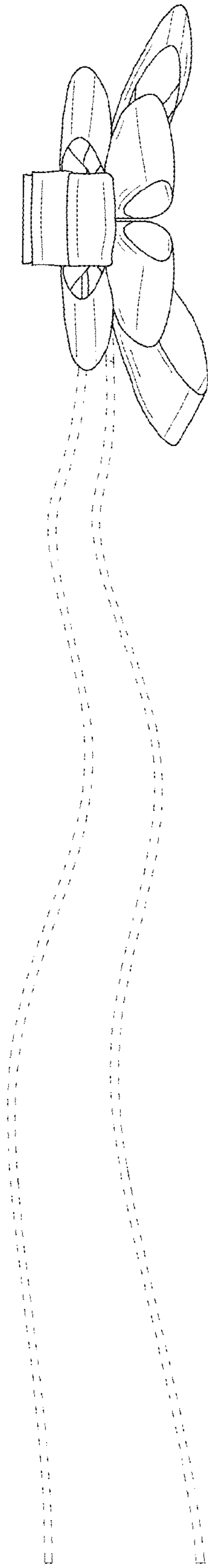

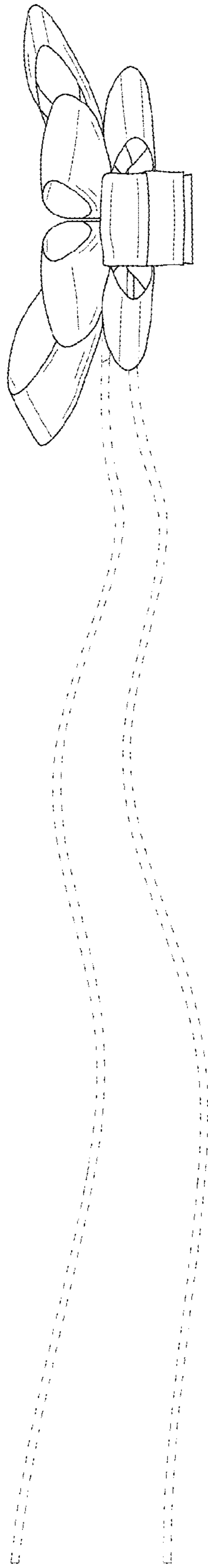

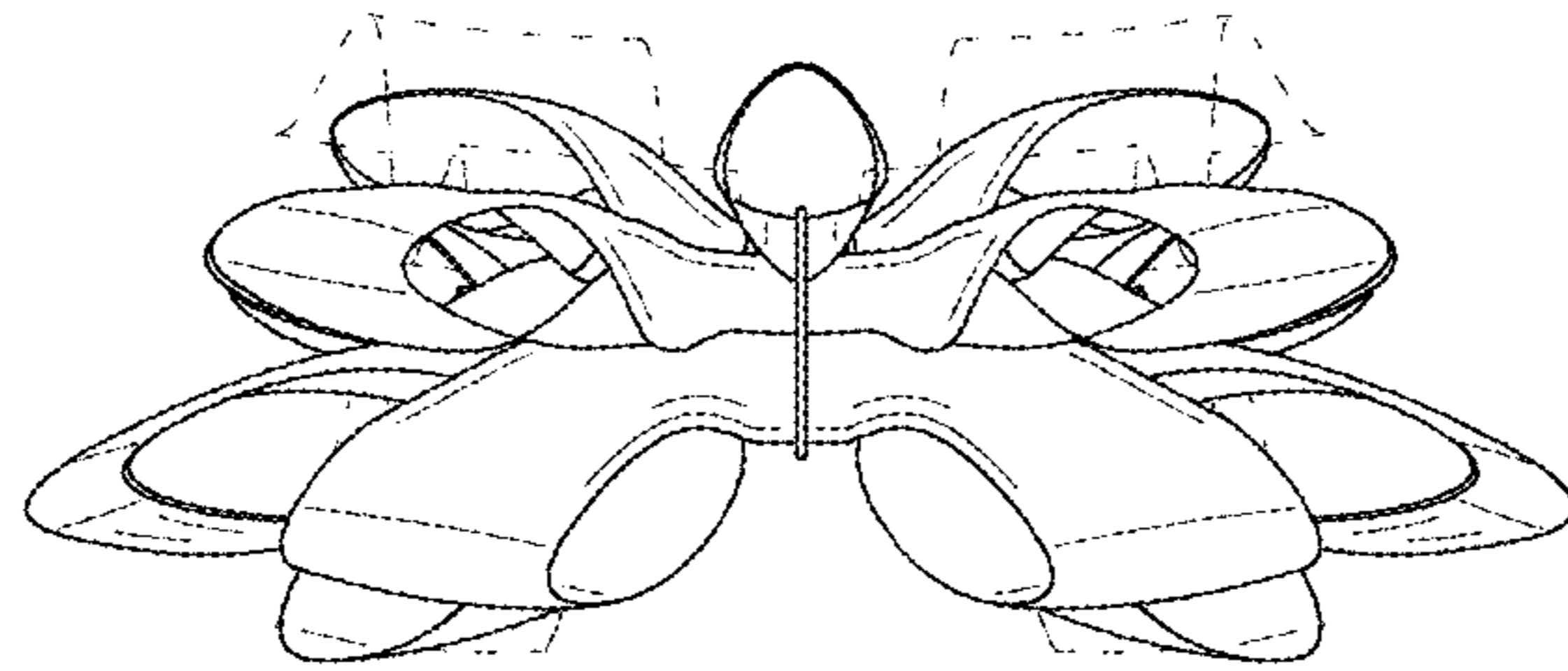

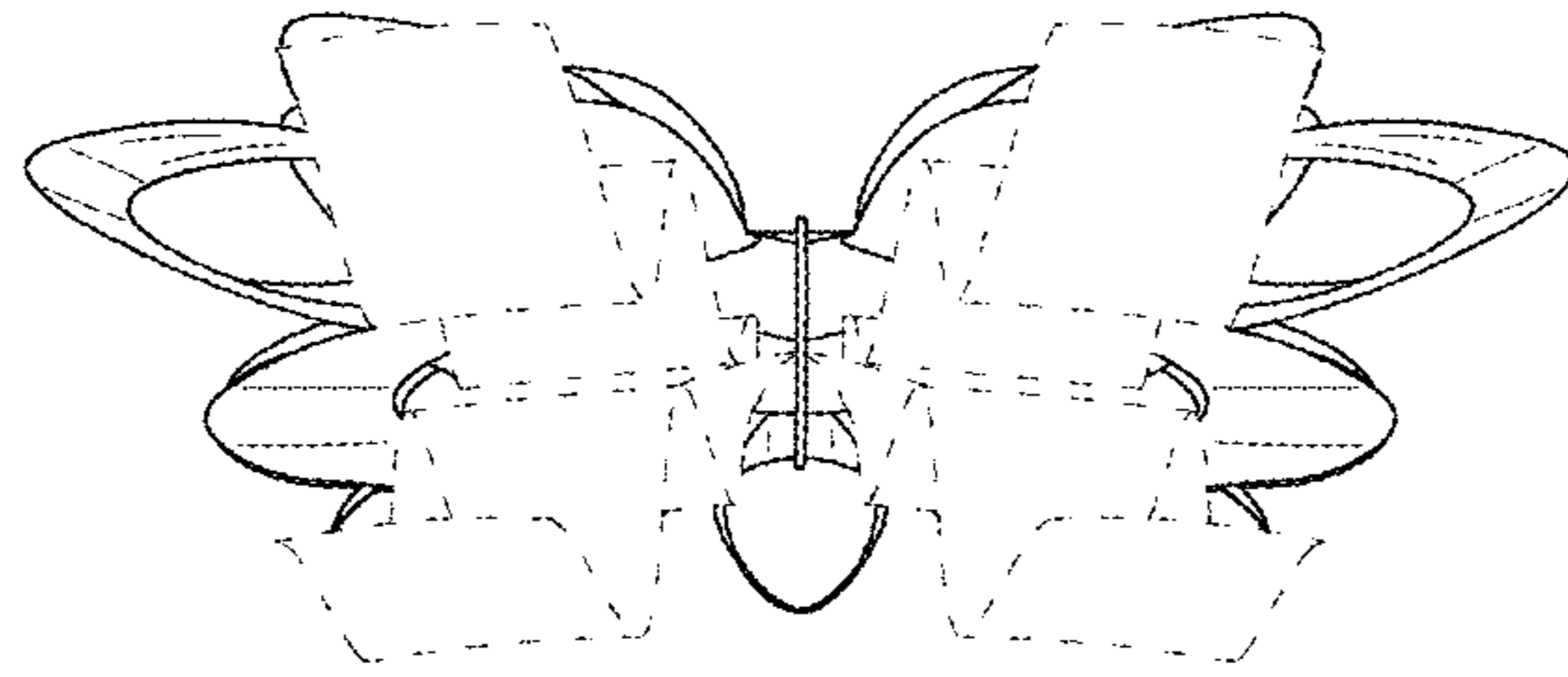

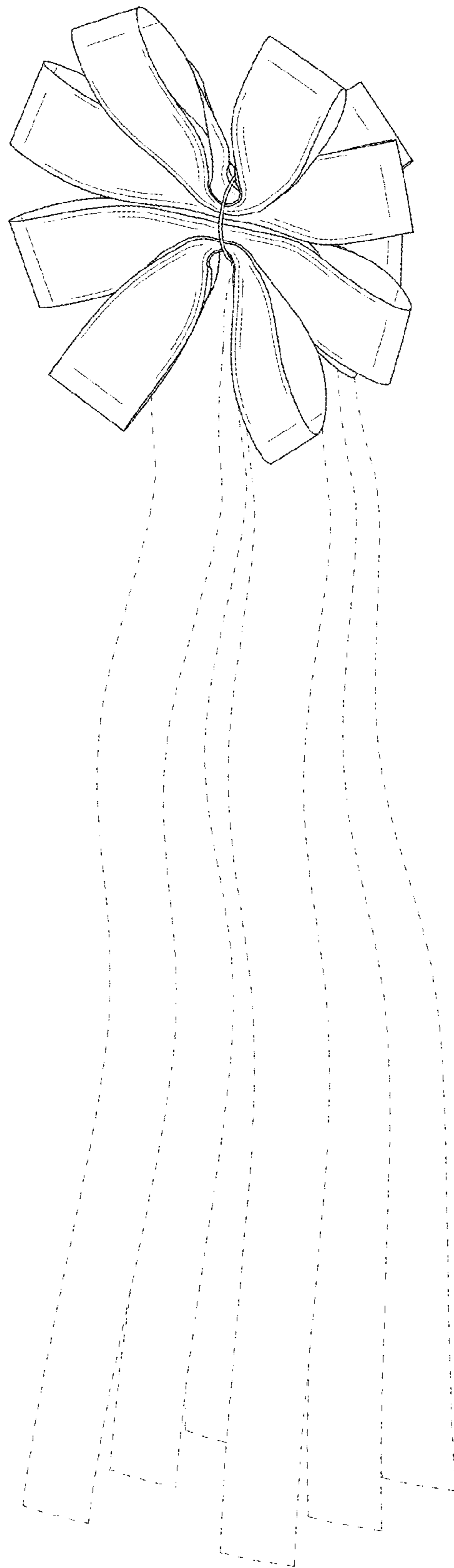

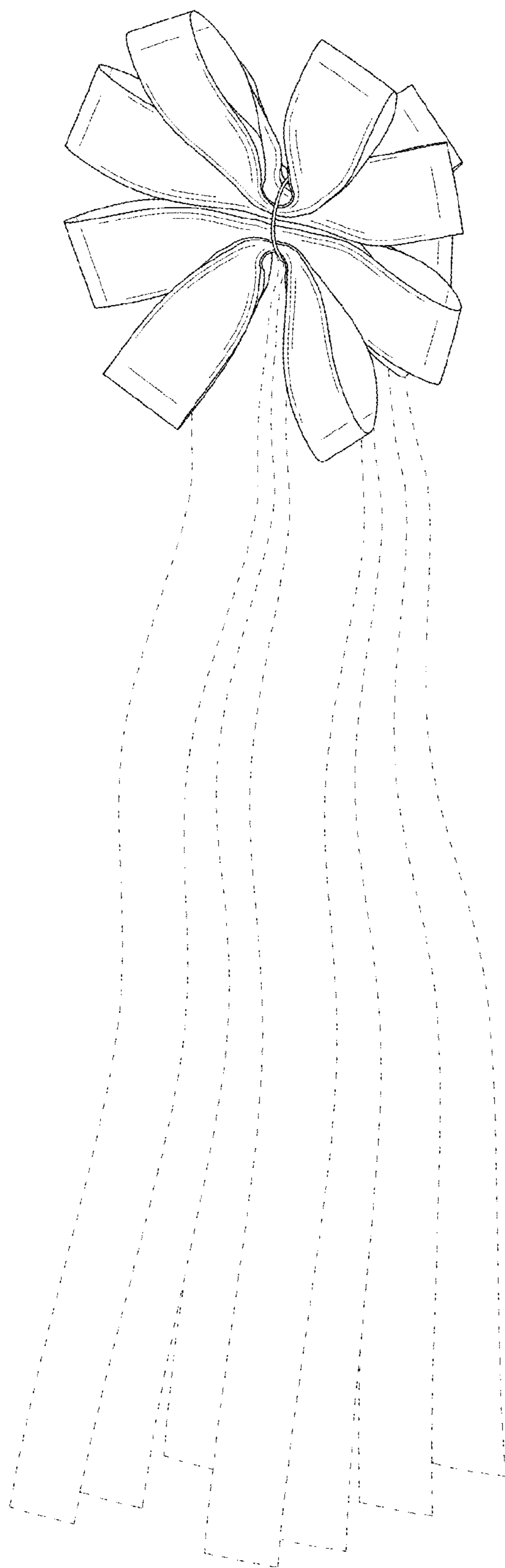
