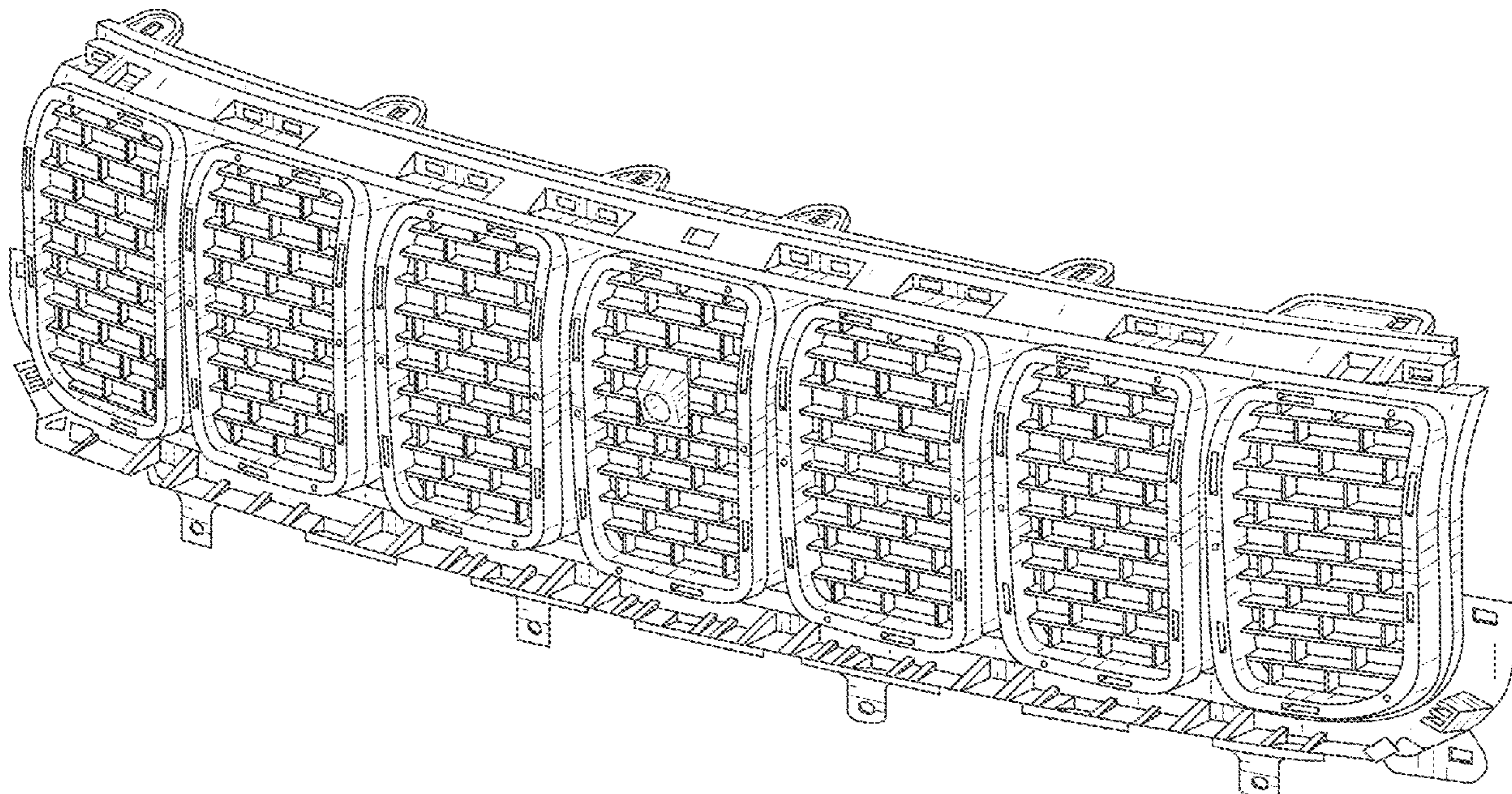
The ornamental design for a grille insert, as shown and described.

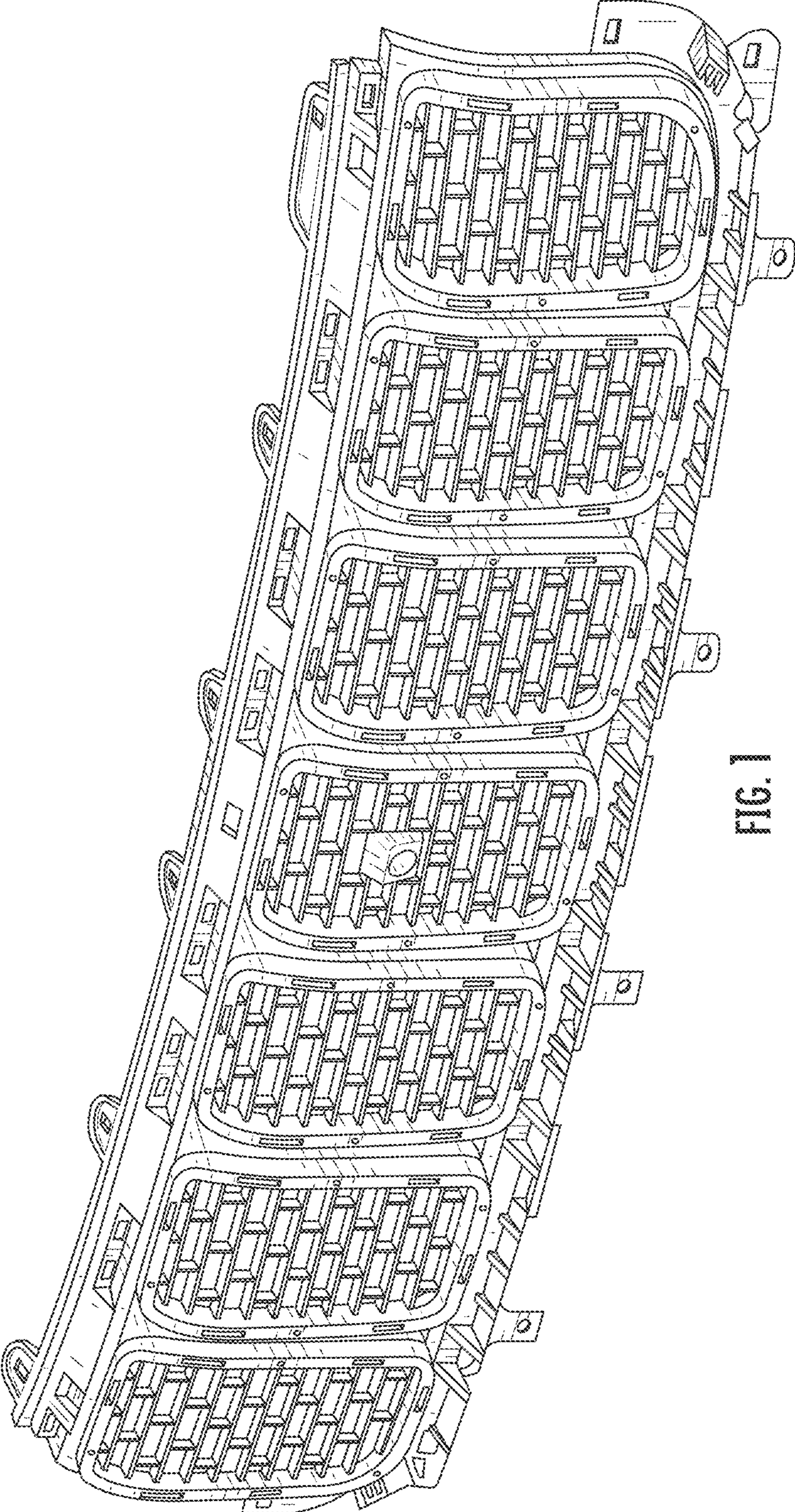

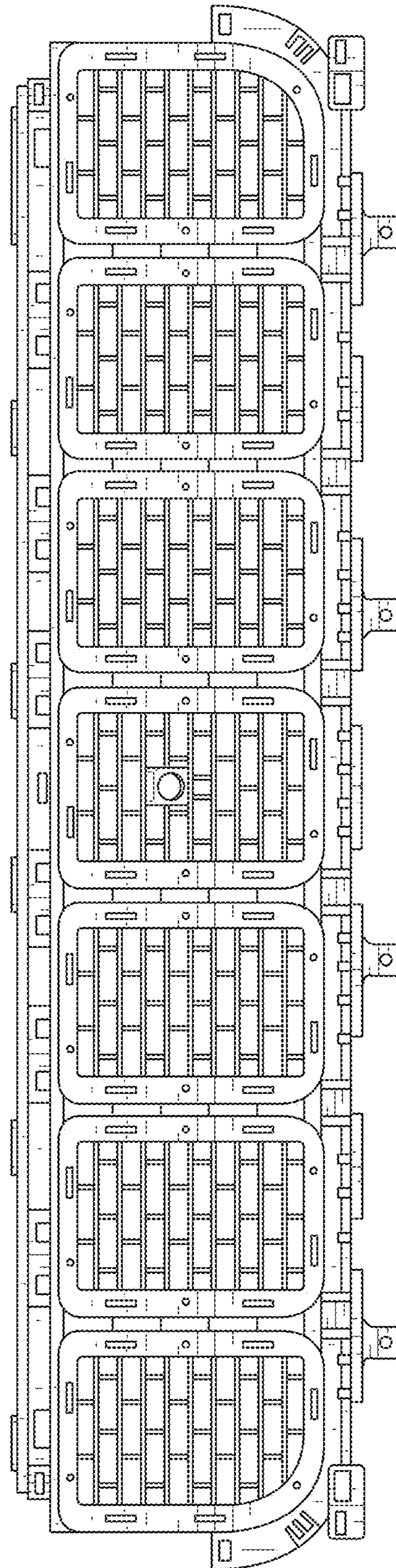

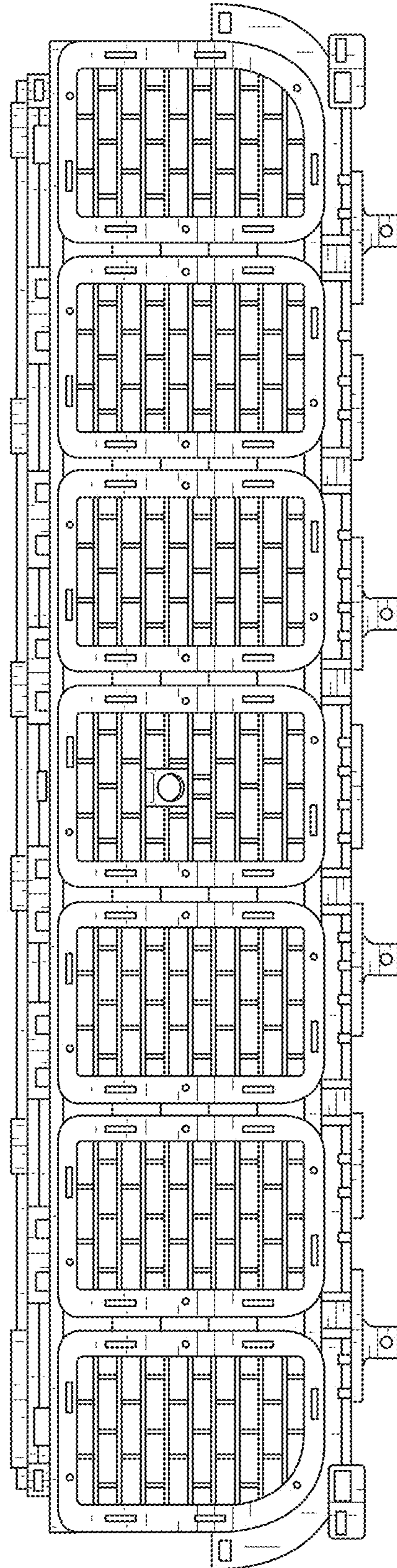

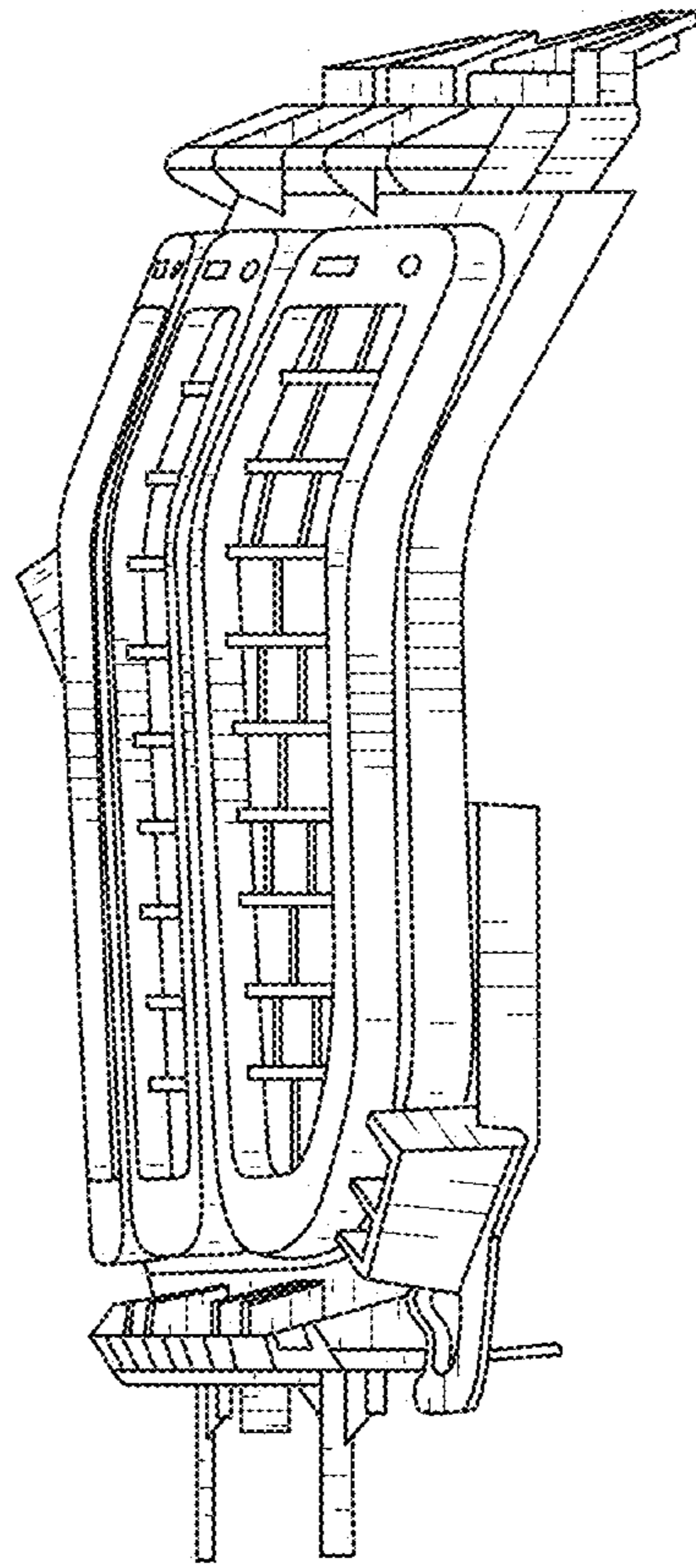

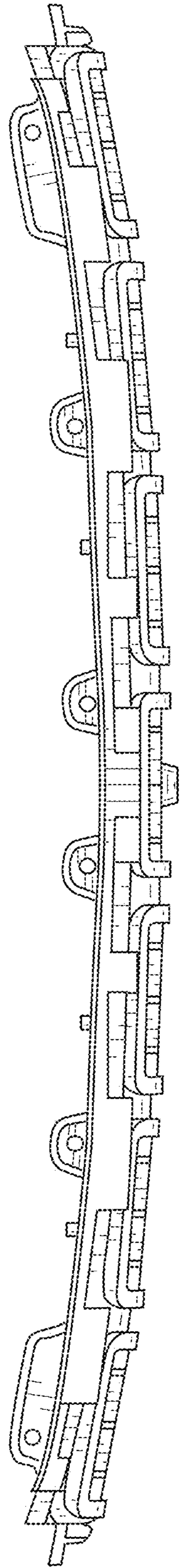

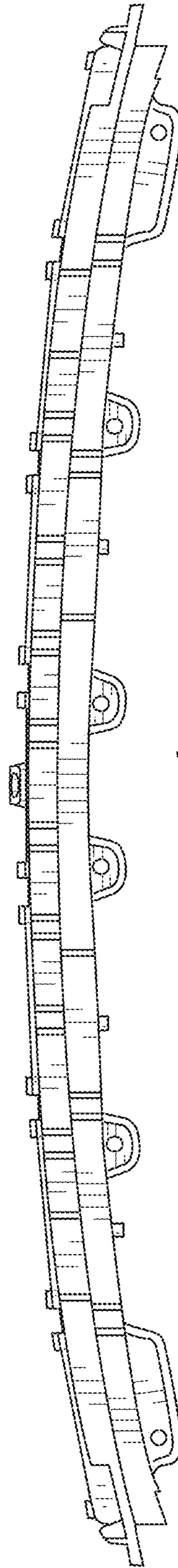
