The ornamental design for a protective cover for cellphone, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a protective cover for cellphone showing a kickstand in an open state showing my new design;
FIG. 2 is a rear perspective view of the protective cover for cellphone;
FIG. 3 is a front elevational view of the protective cover for cellphone shown in an alternate configuration with the kickstand in a closed state;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a left side elevational view thereof;
FIG. 6 is a right side elevational view thereof;
FIG. 7 is a top plan view thereof;
FIG. 8 is a bottom plan view thereof; and,
FIG. 9 is another perspective view thereof.

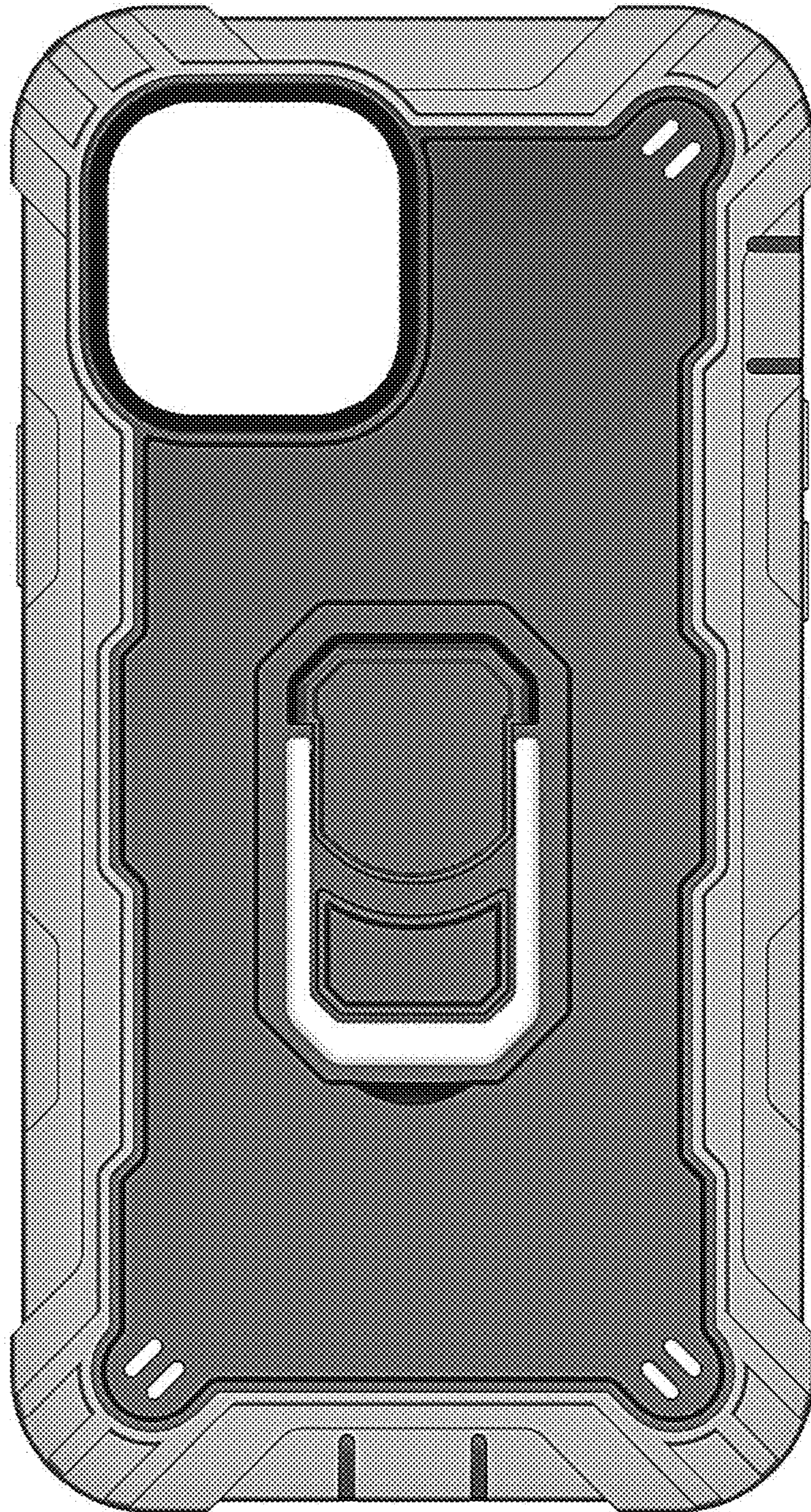

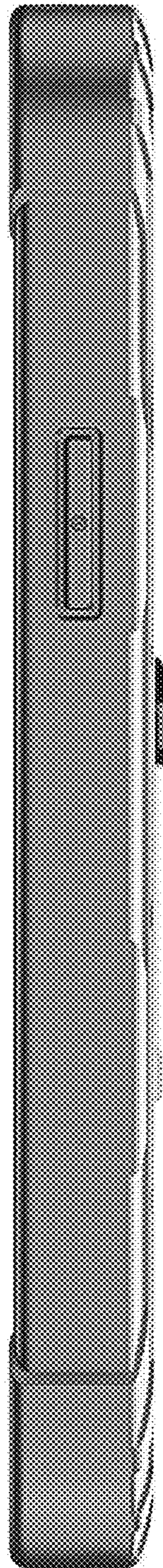

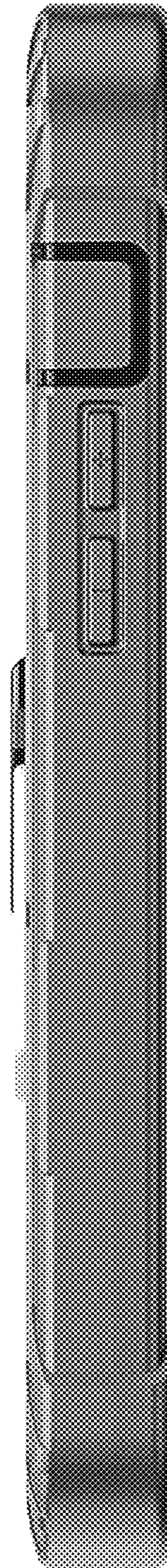

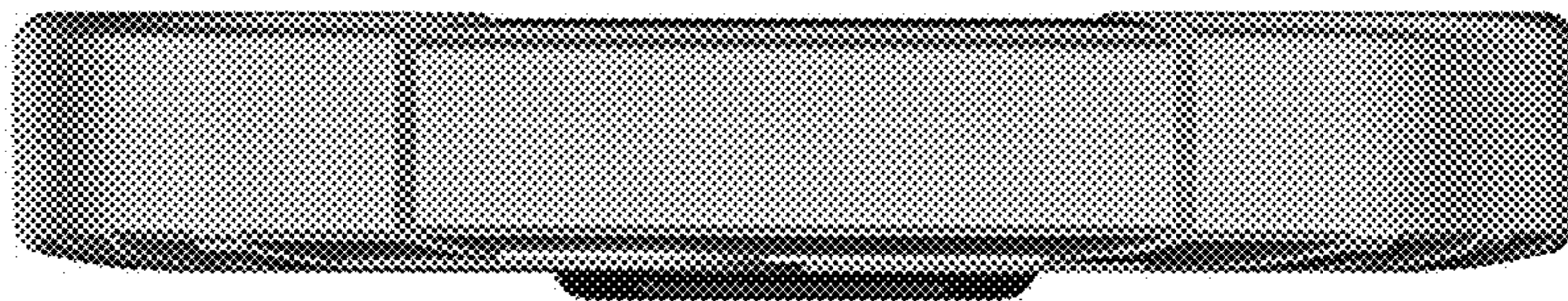

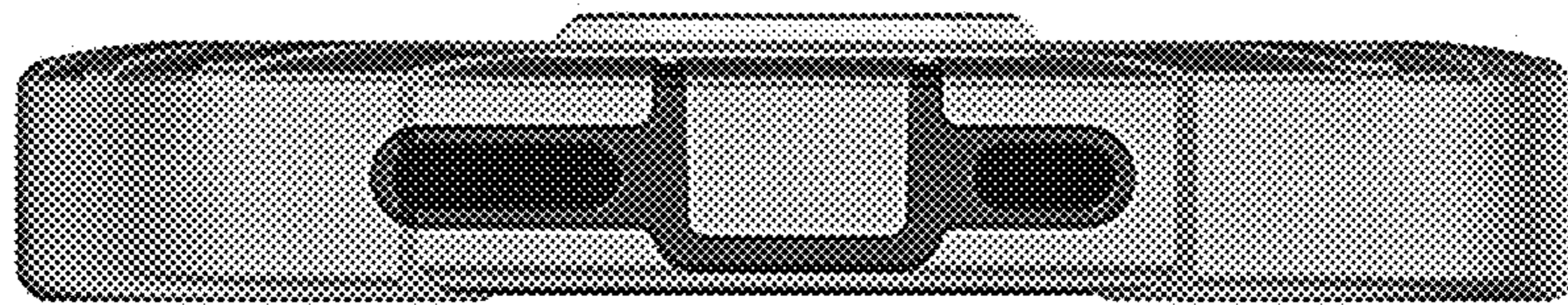
