**DESCRIPTION**

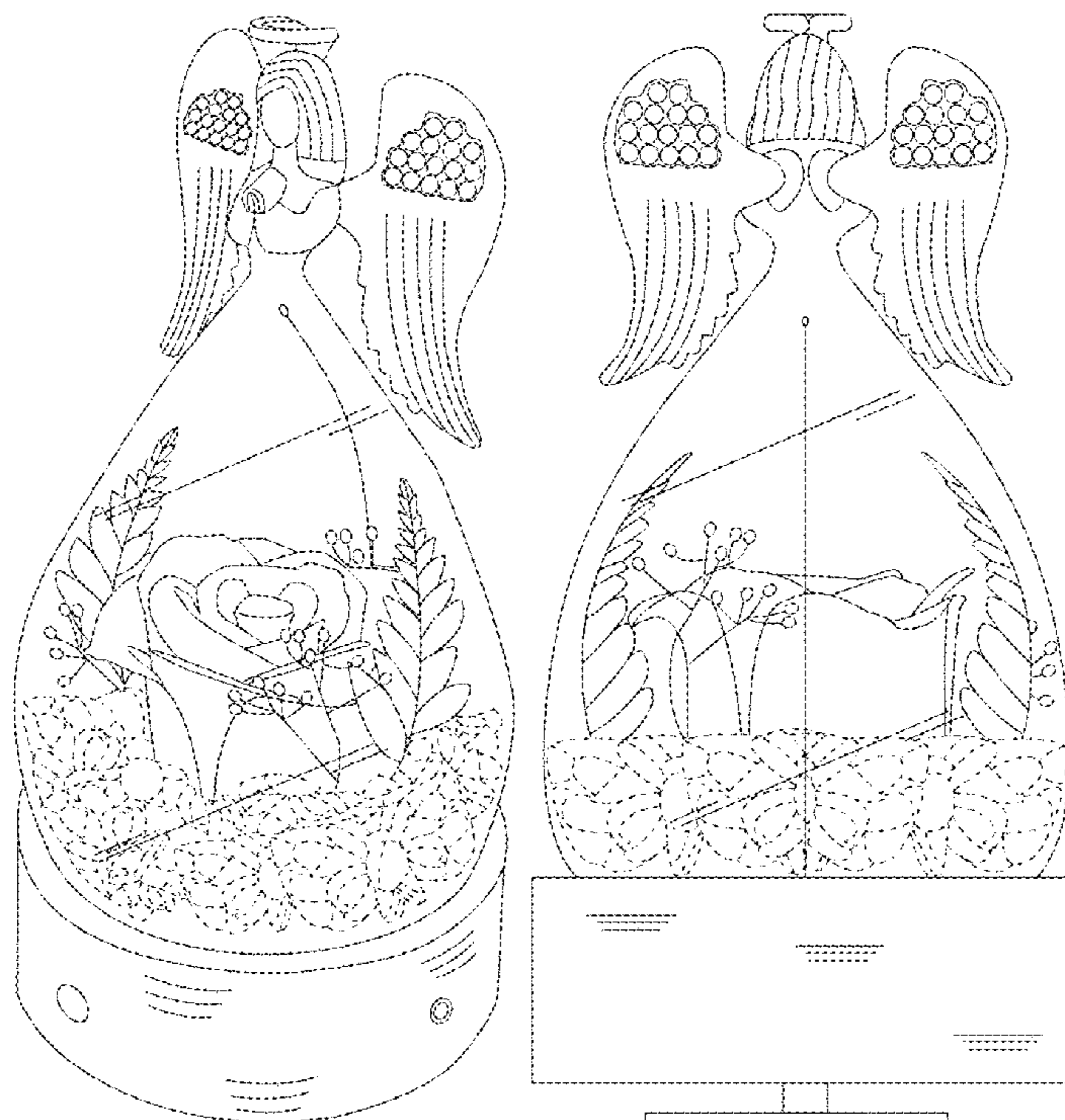
FIG. 1 is a perspective view of a music box, showing my new design;

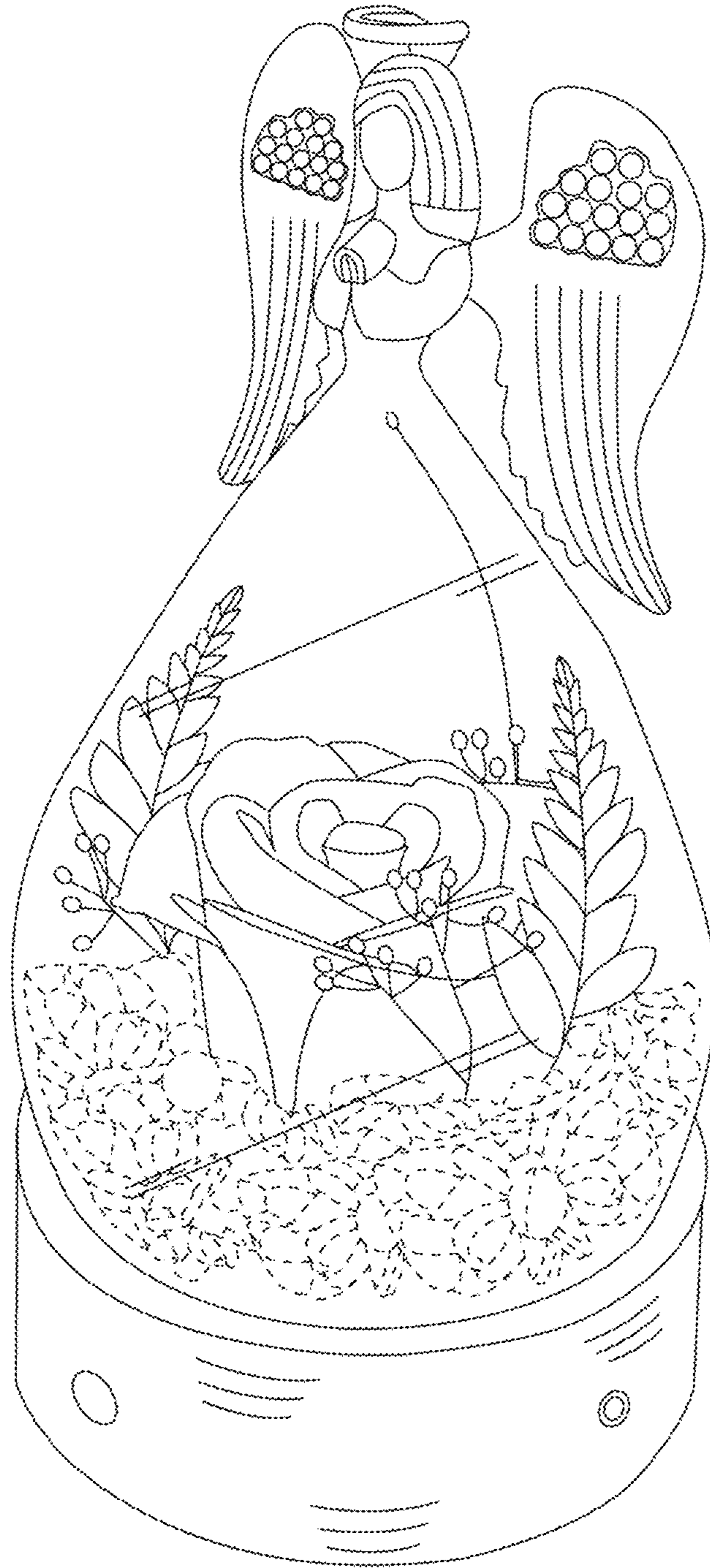

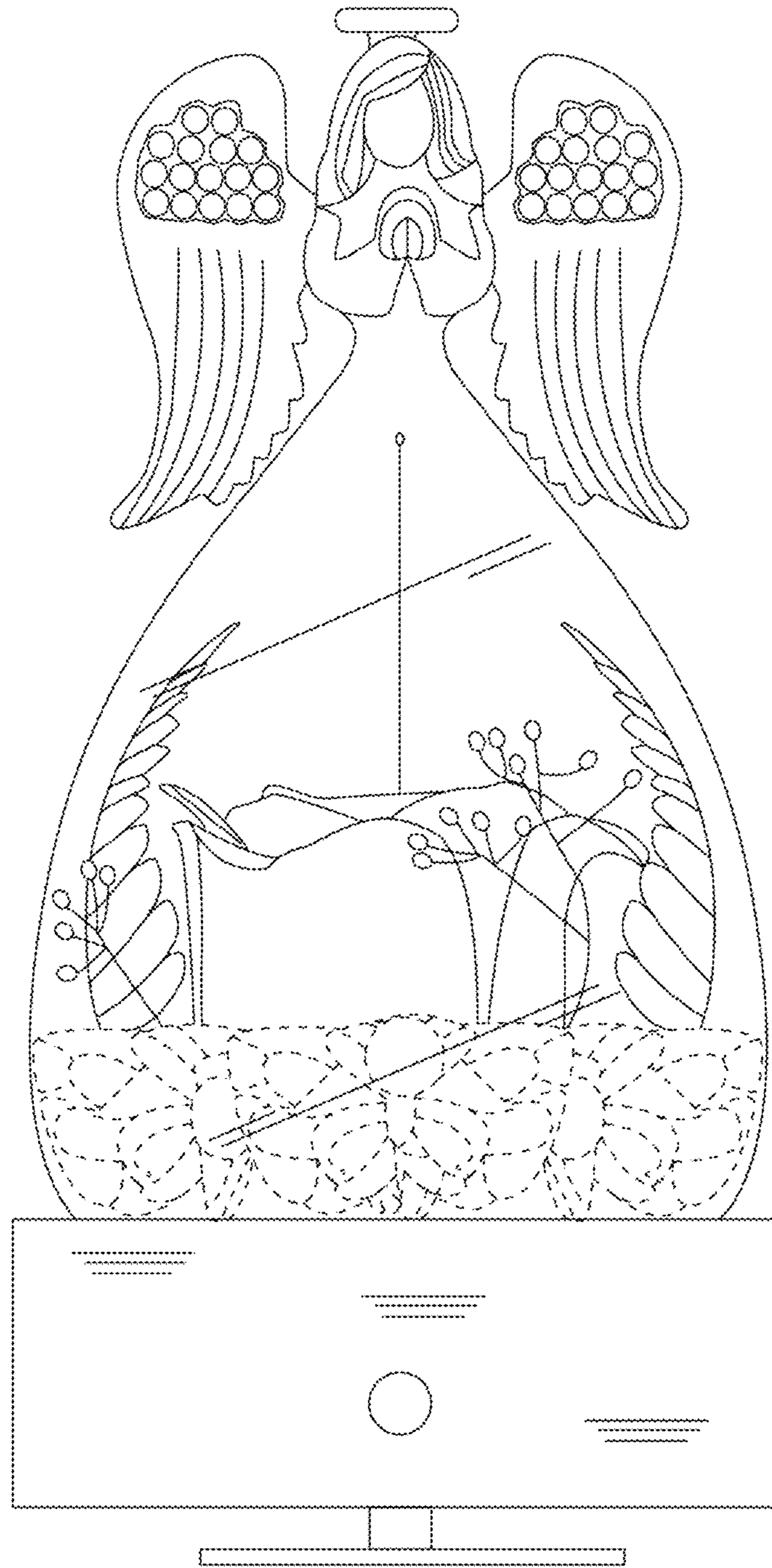

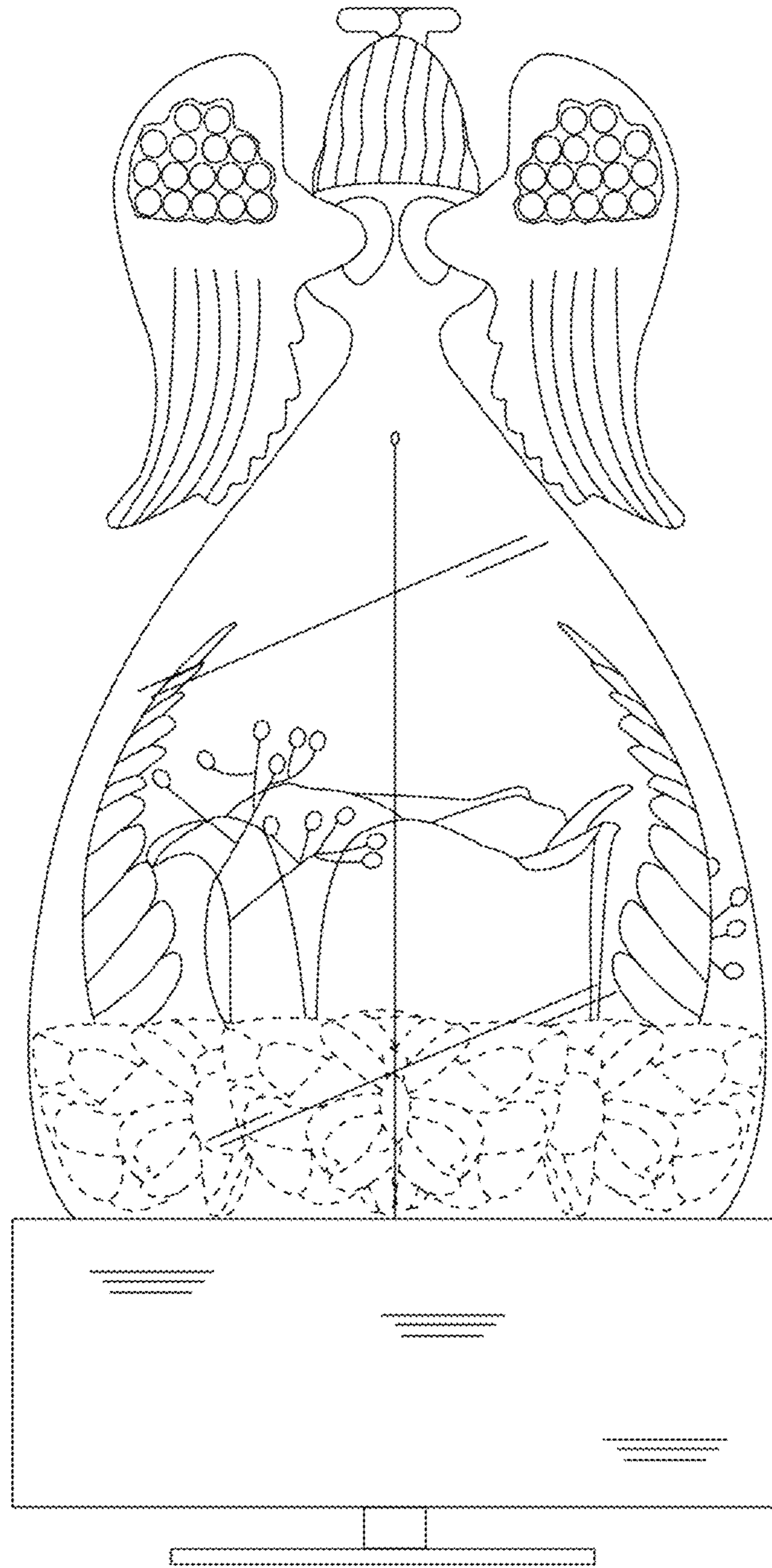

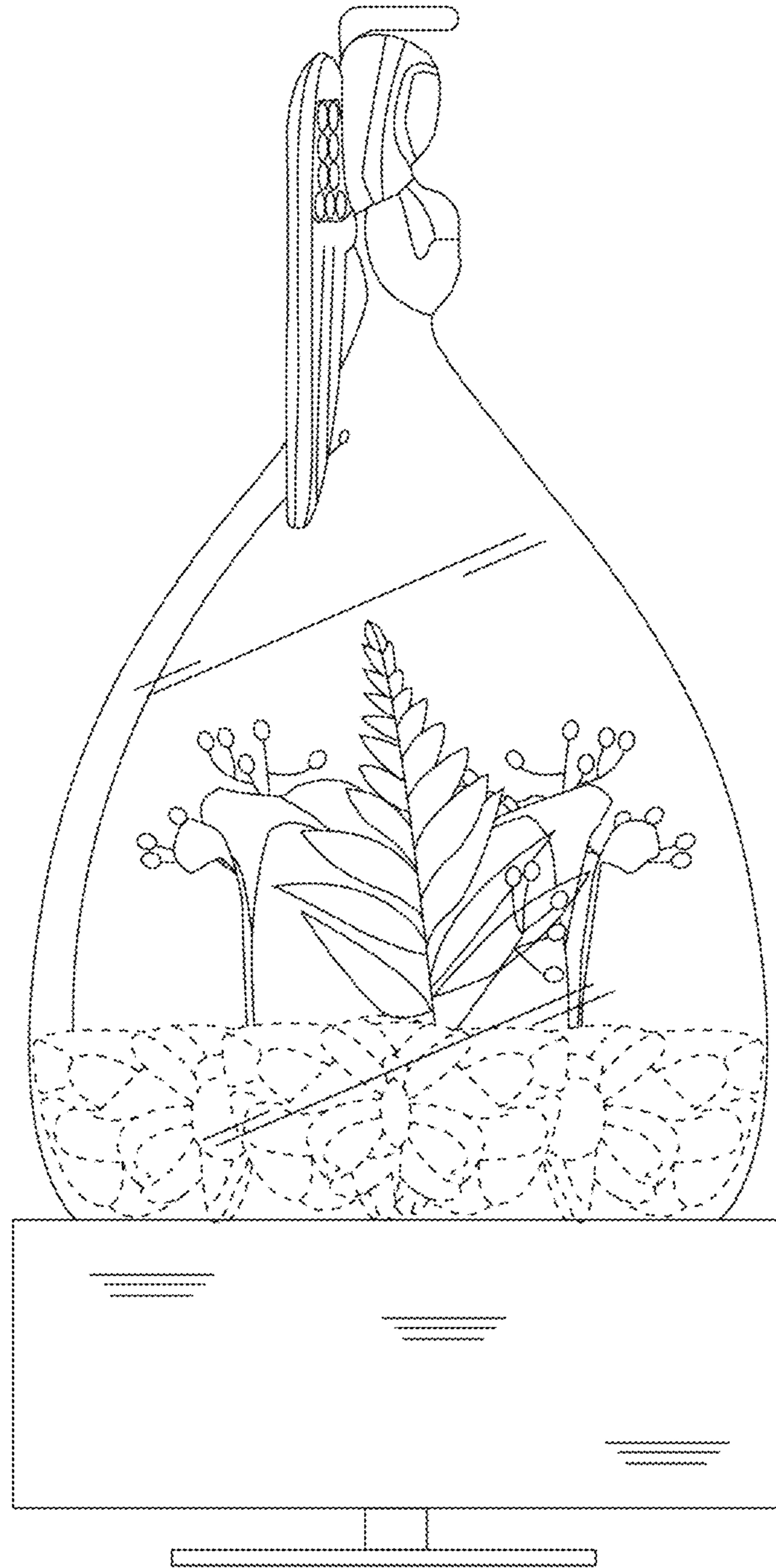

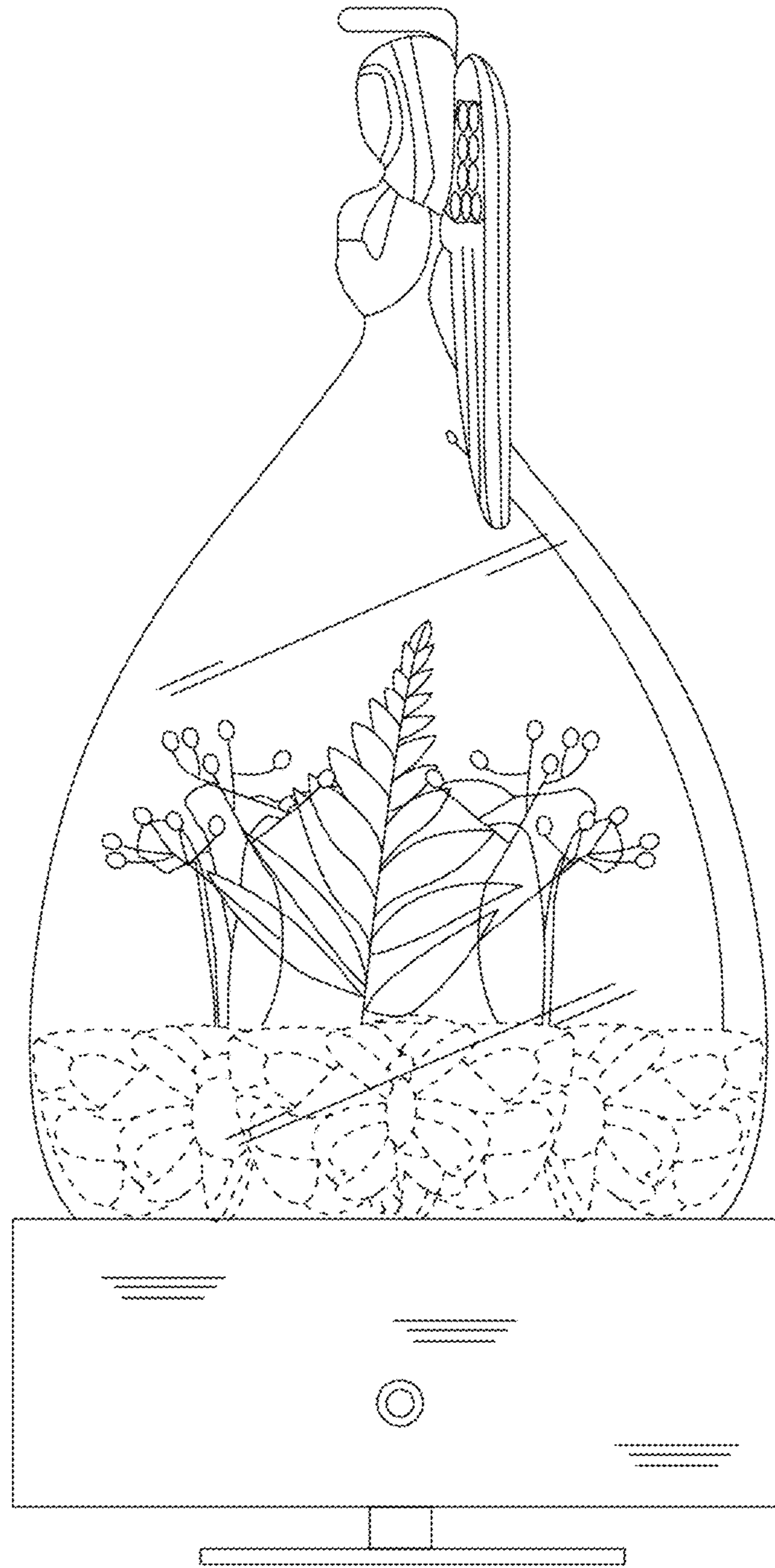
