DESCRIPTION

FIG. 23 is a top plan view of FIG. 17;

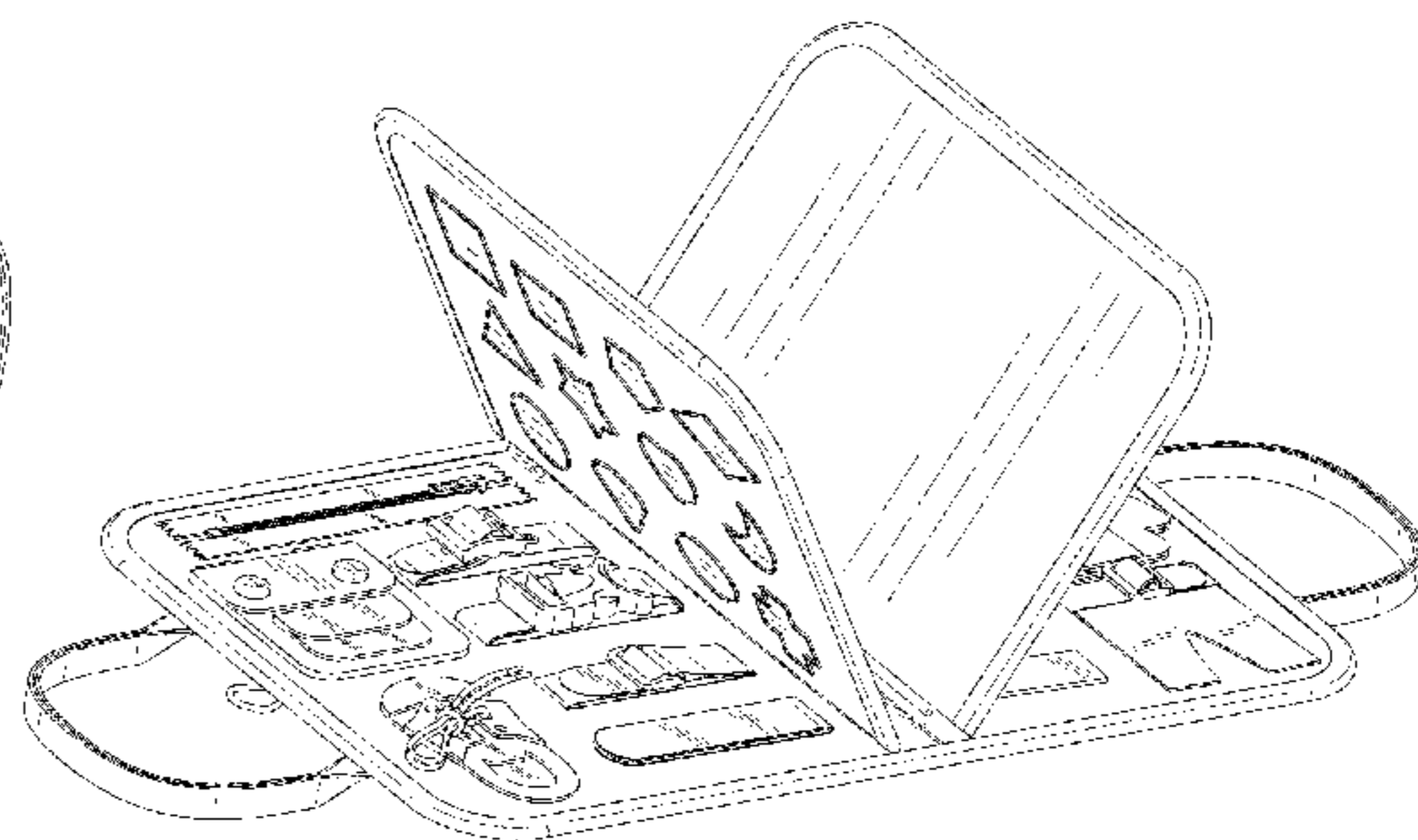
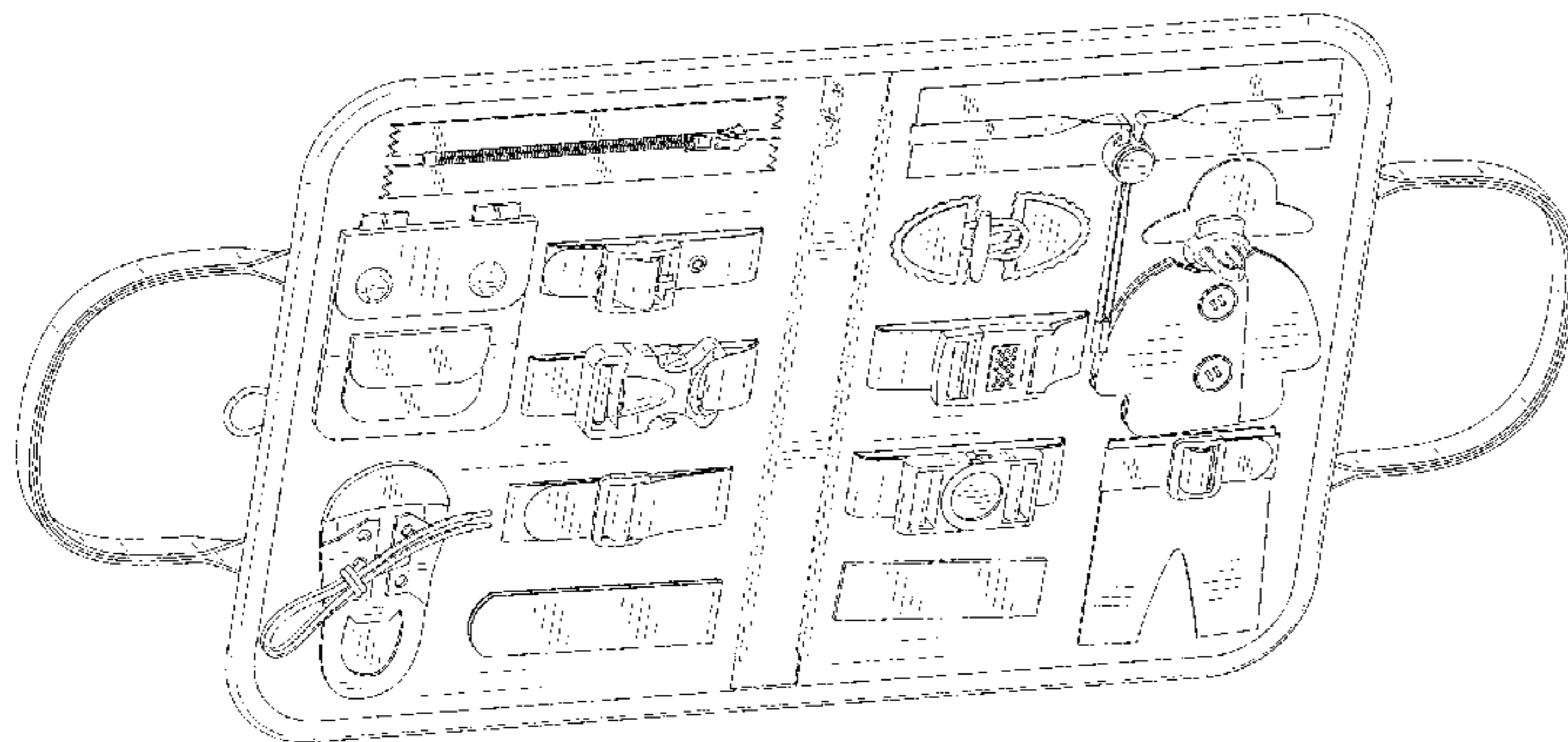
FIG. 24 is a bottom plan view of FIG. 17;

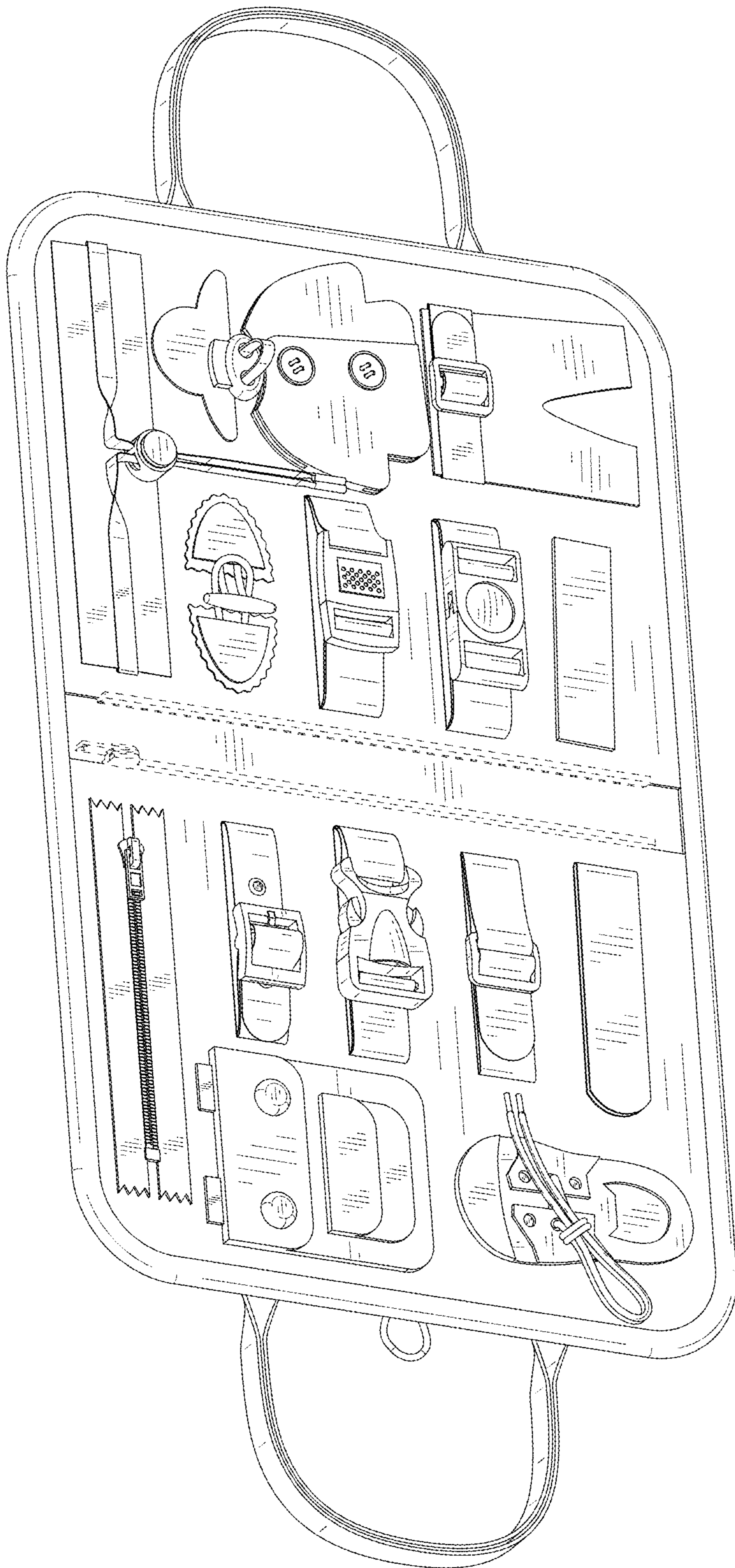

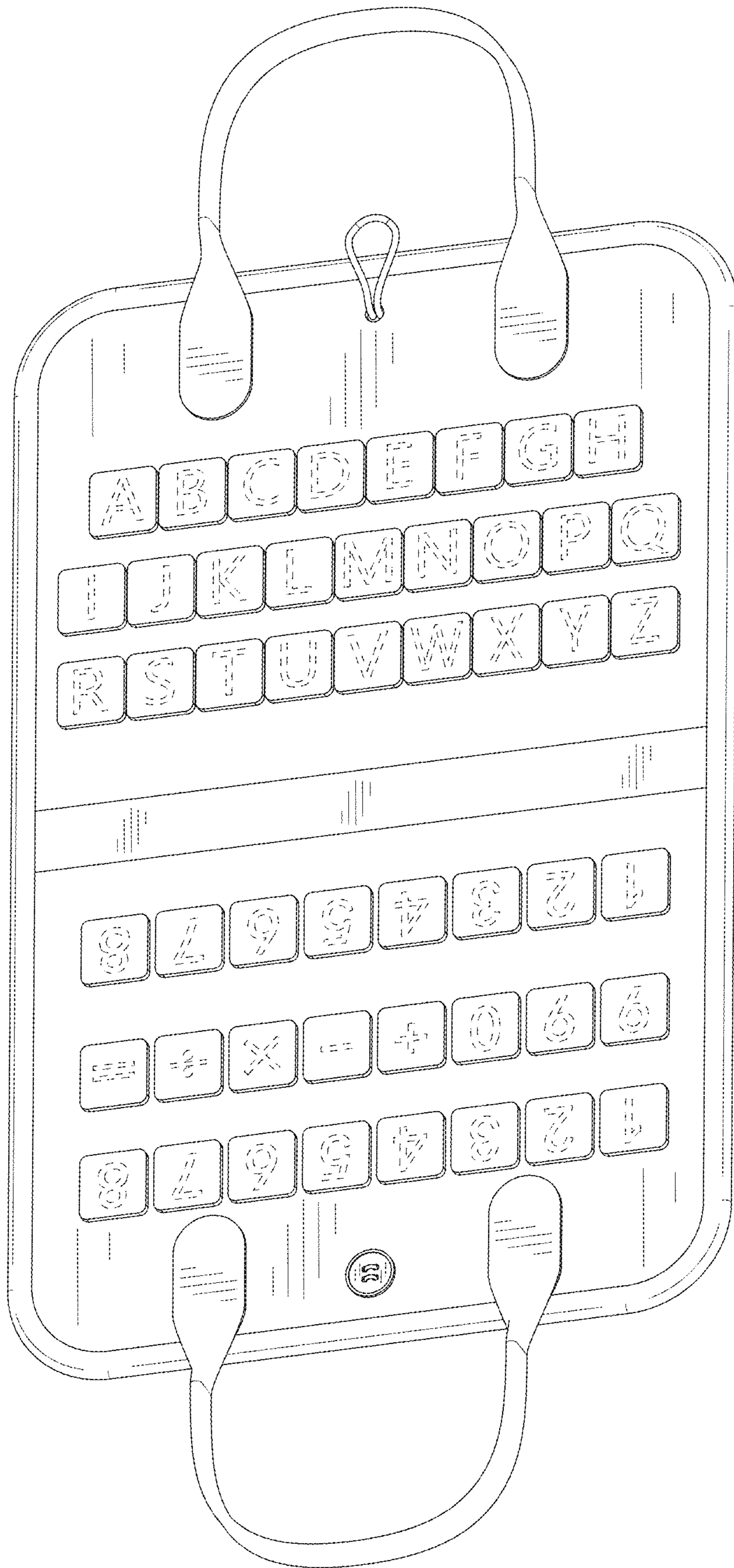

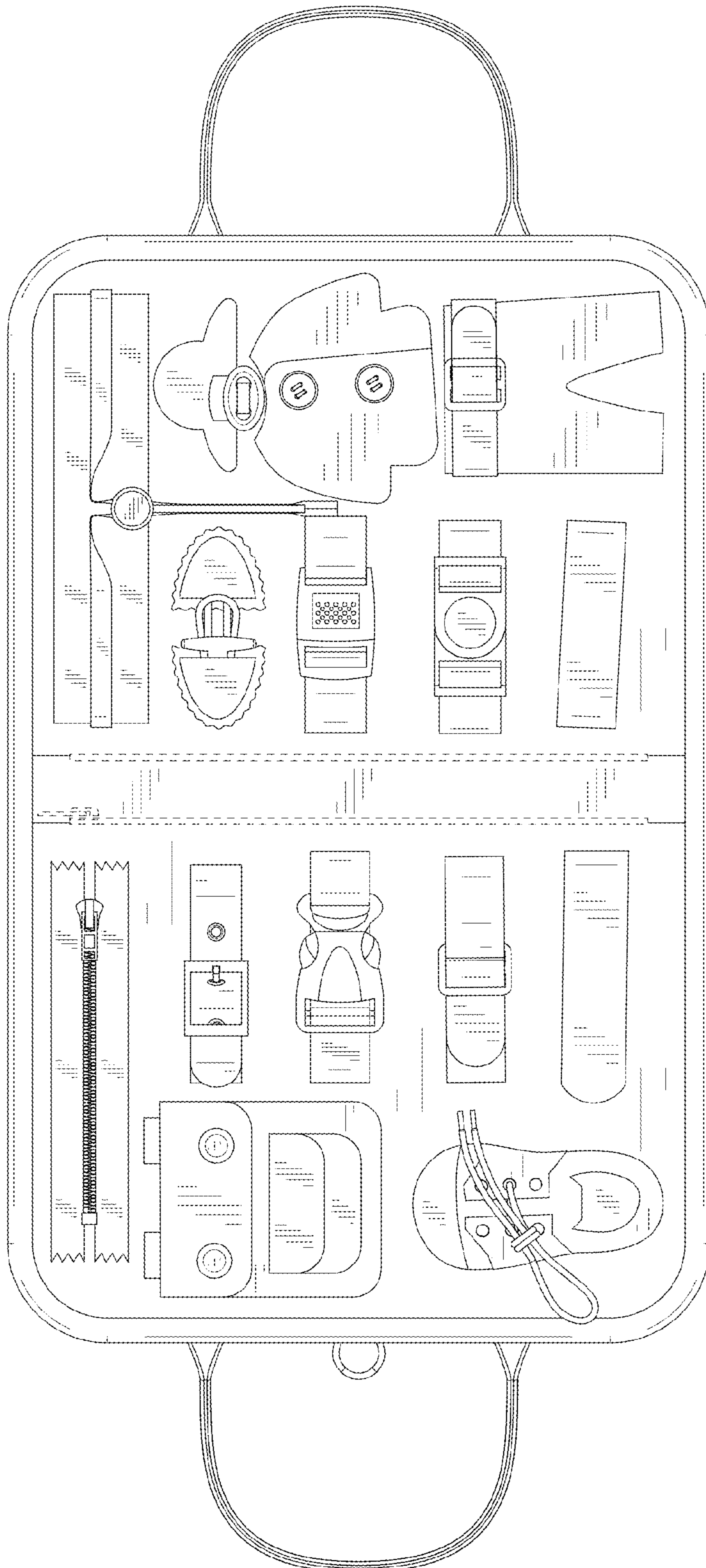

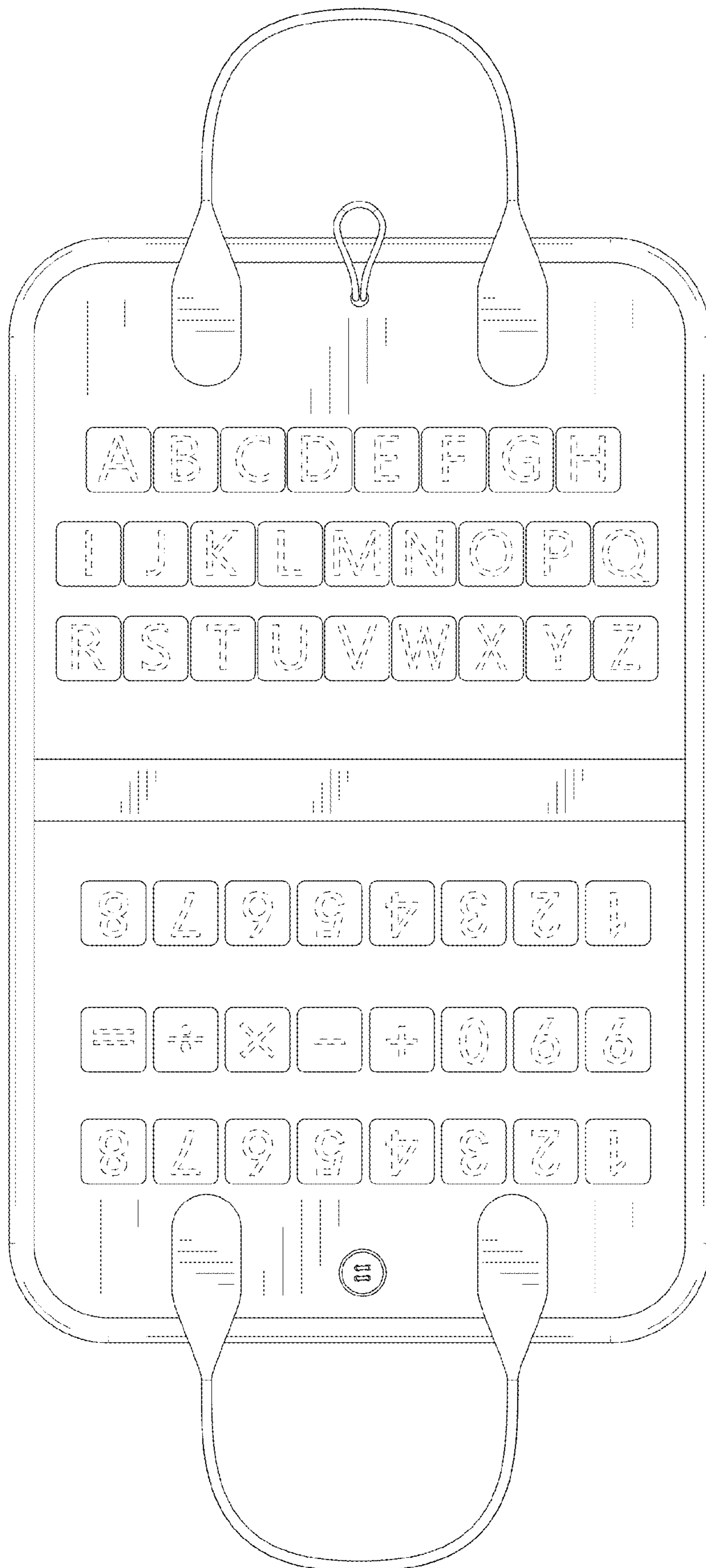

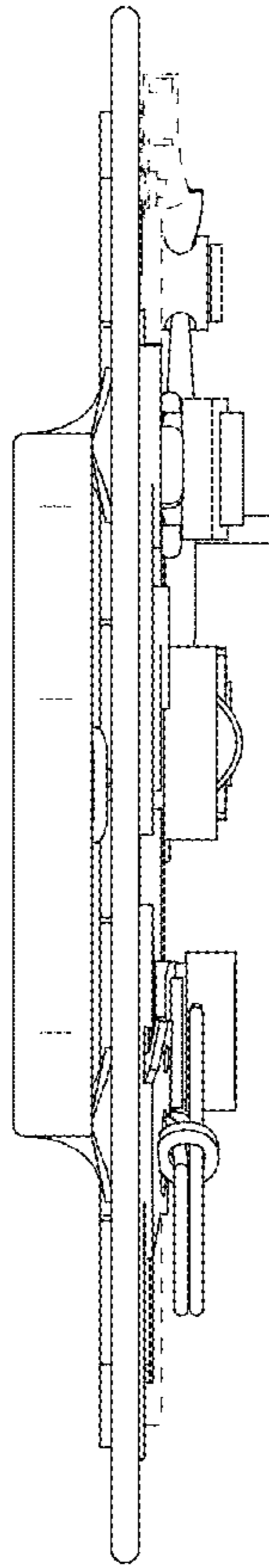

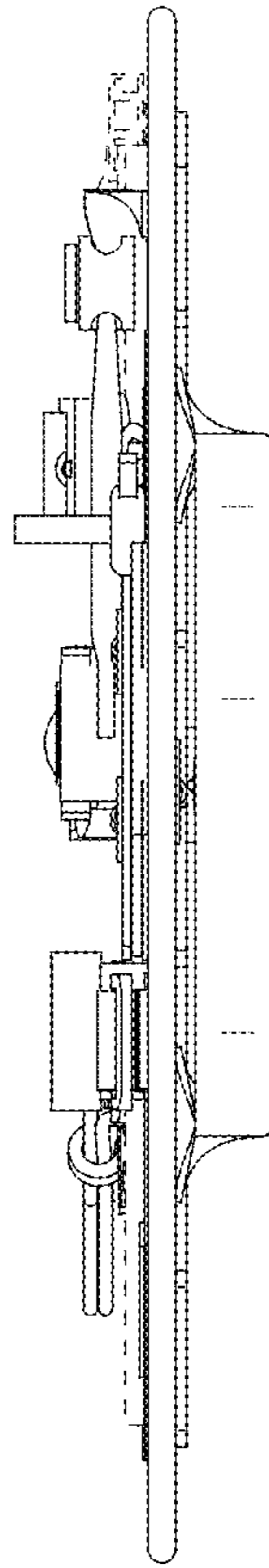

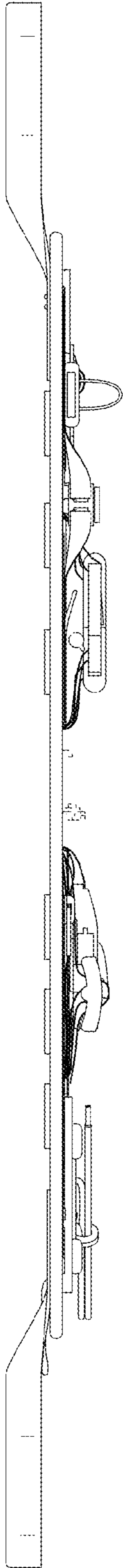

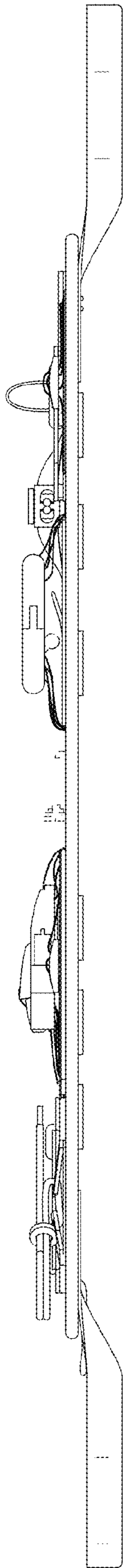

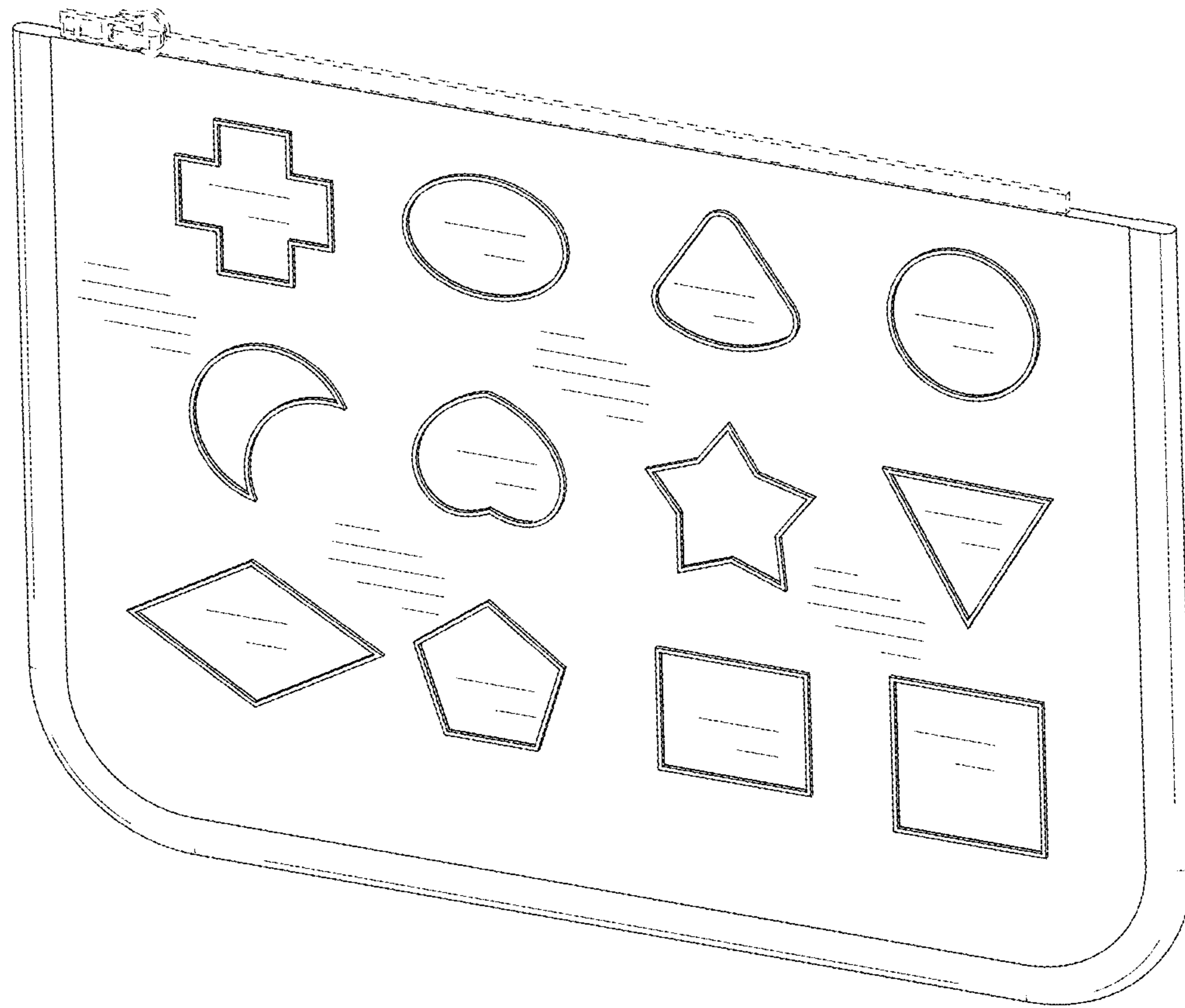

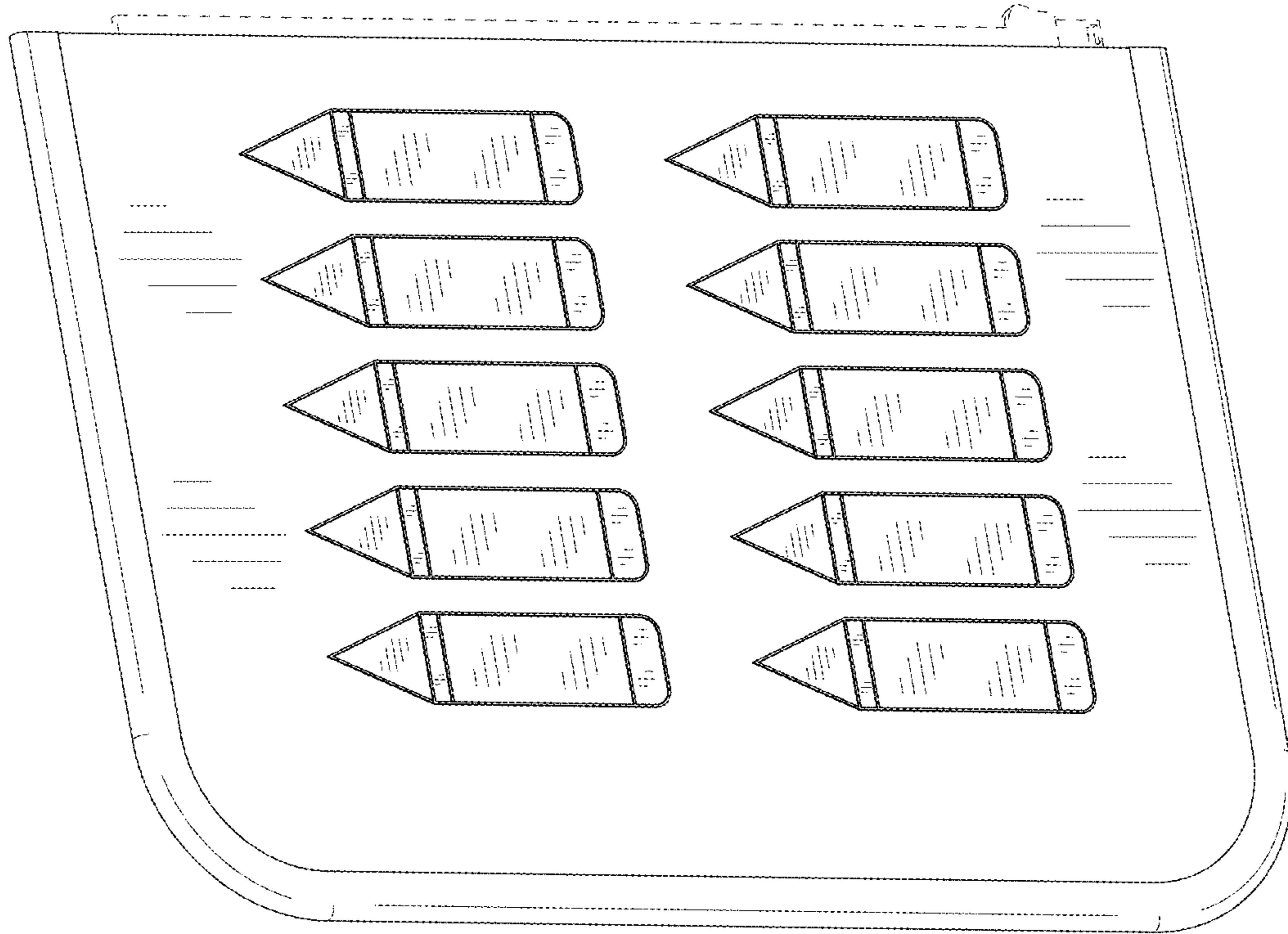

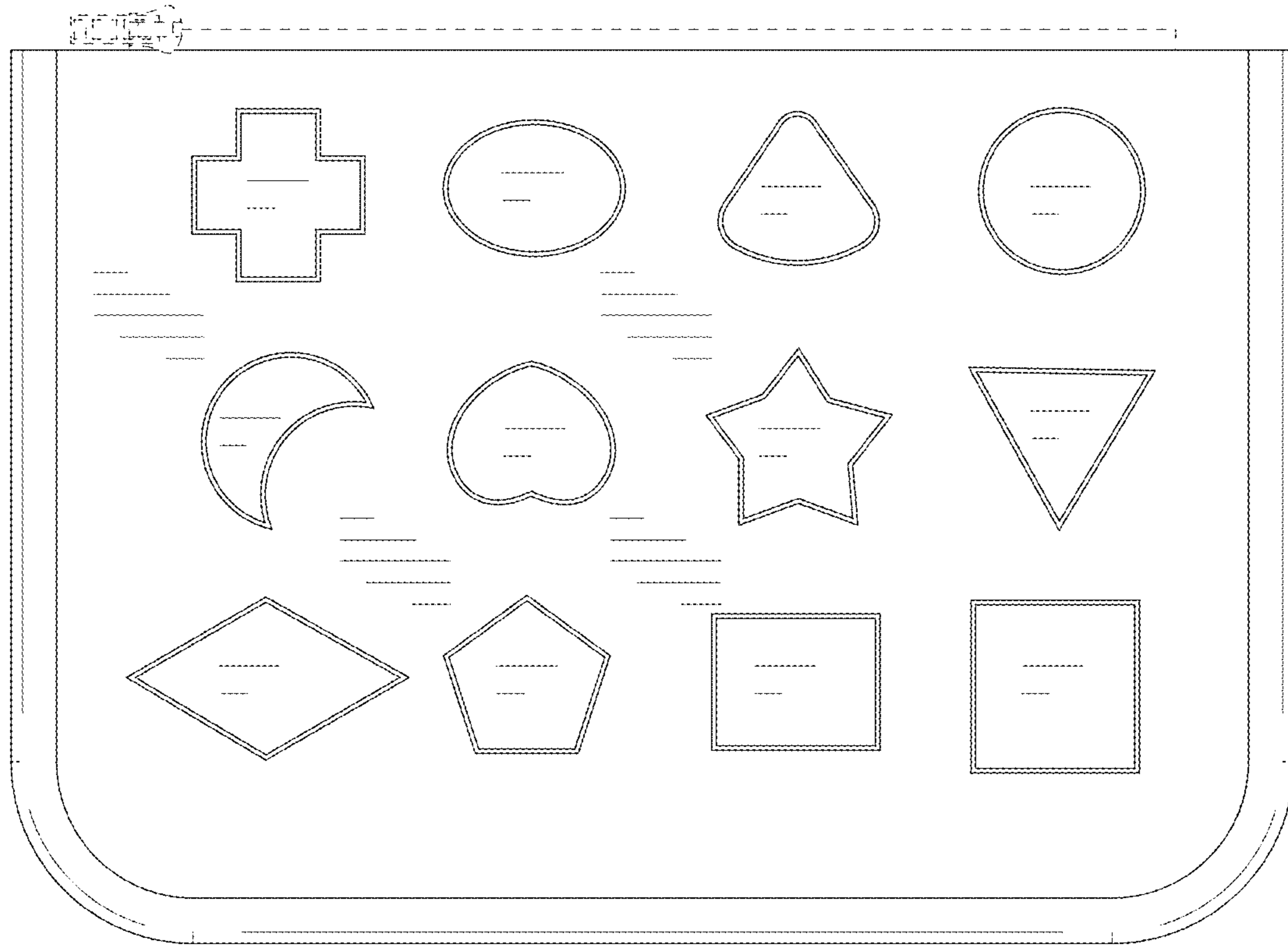

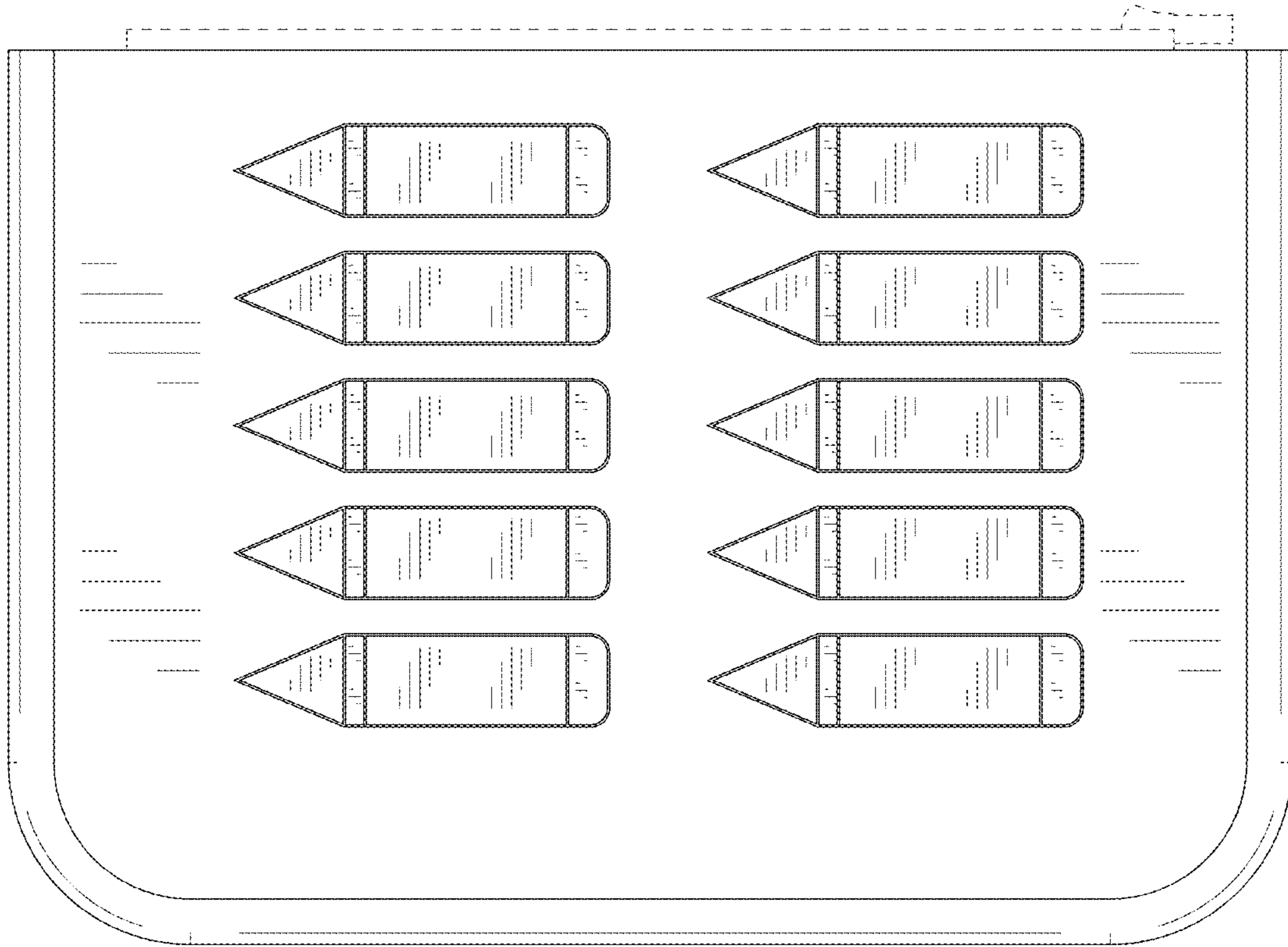

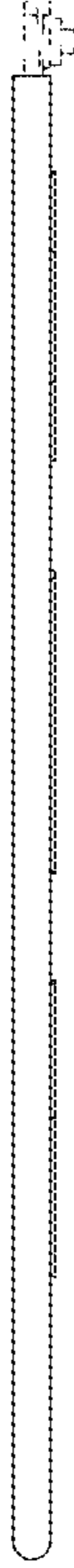

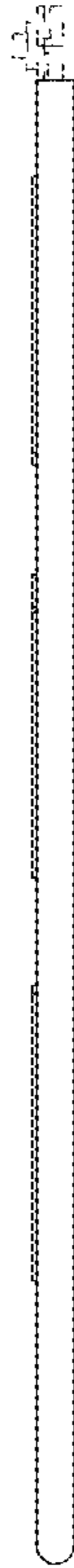

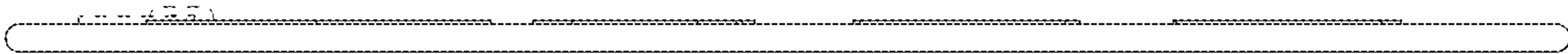

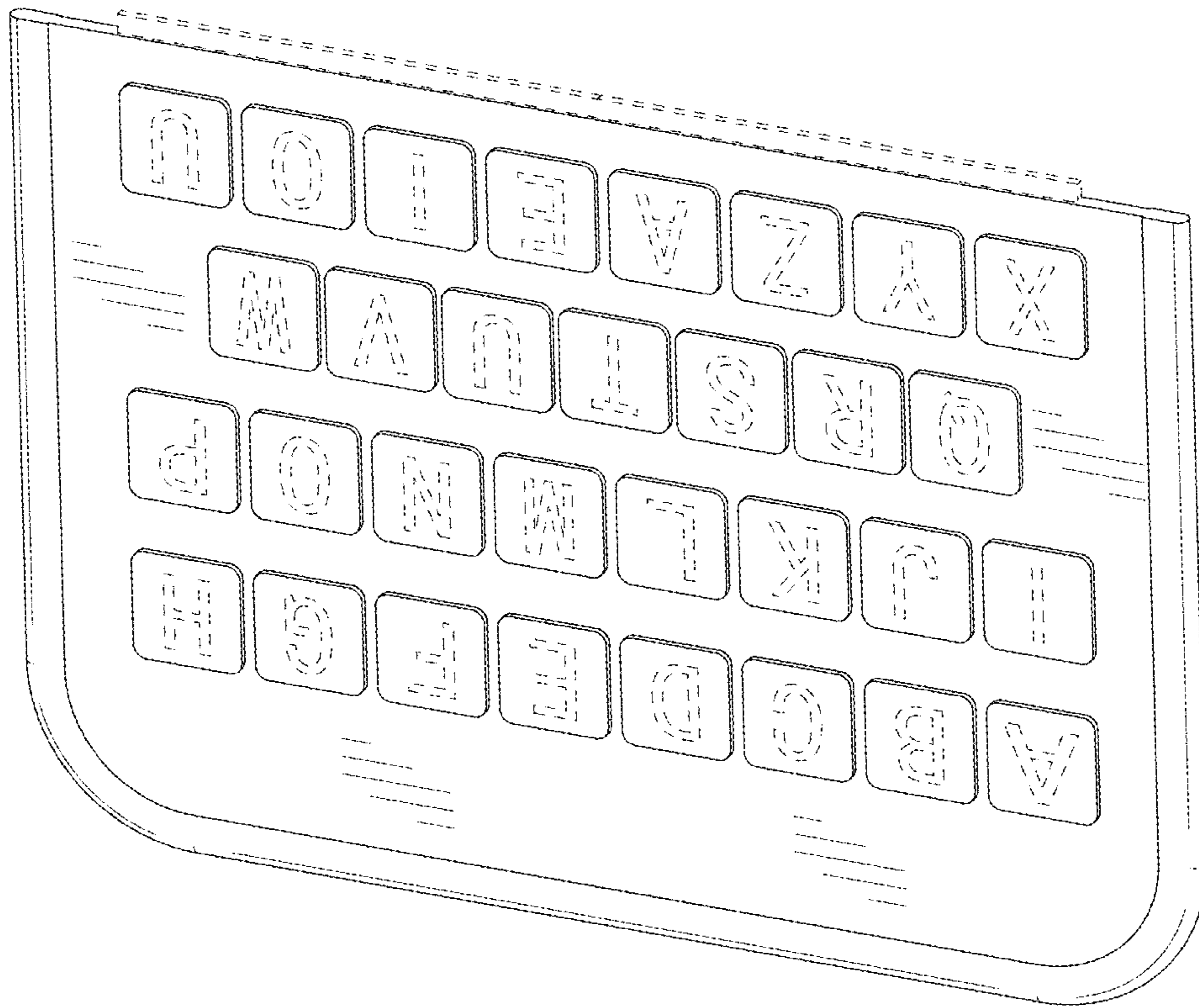

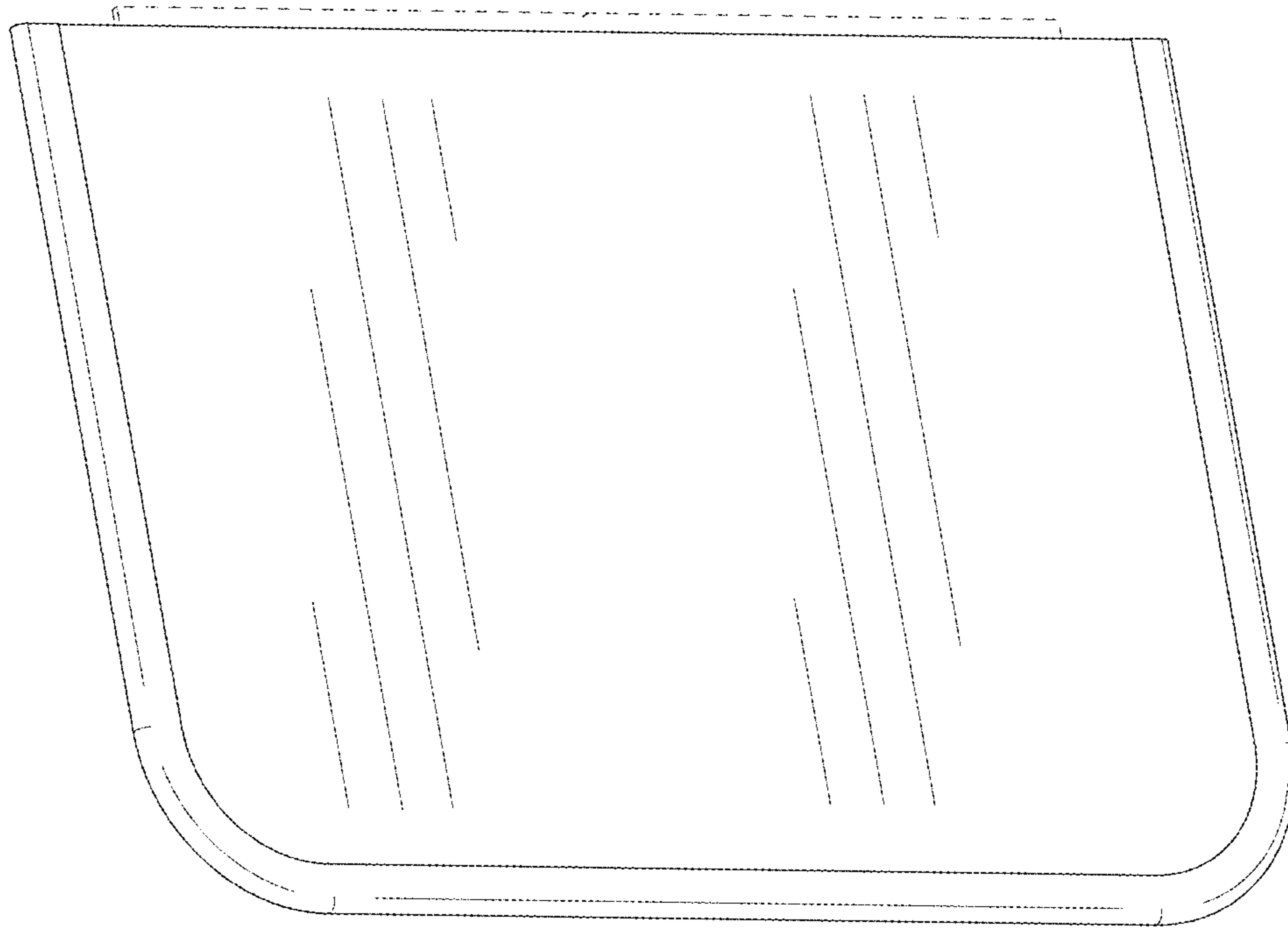

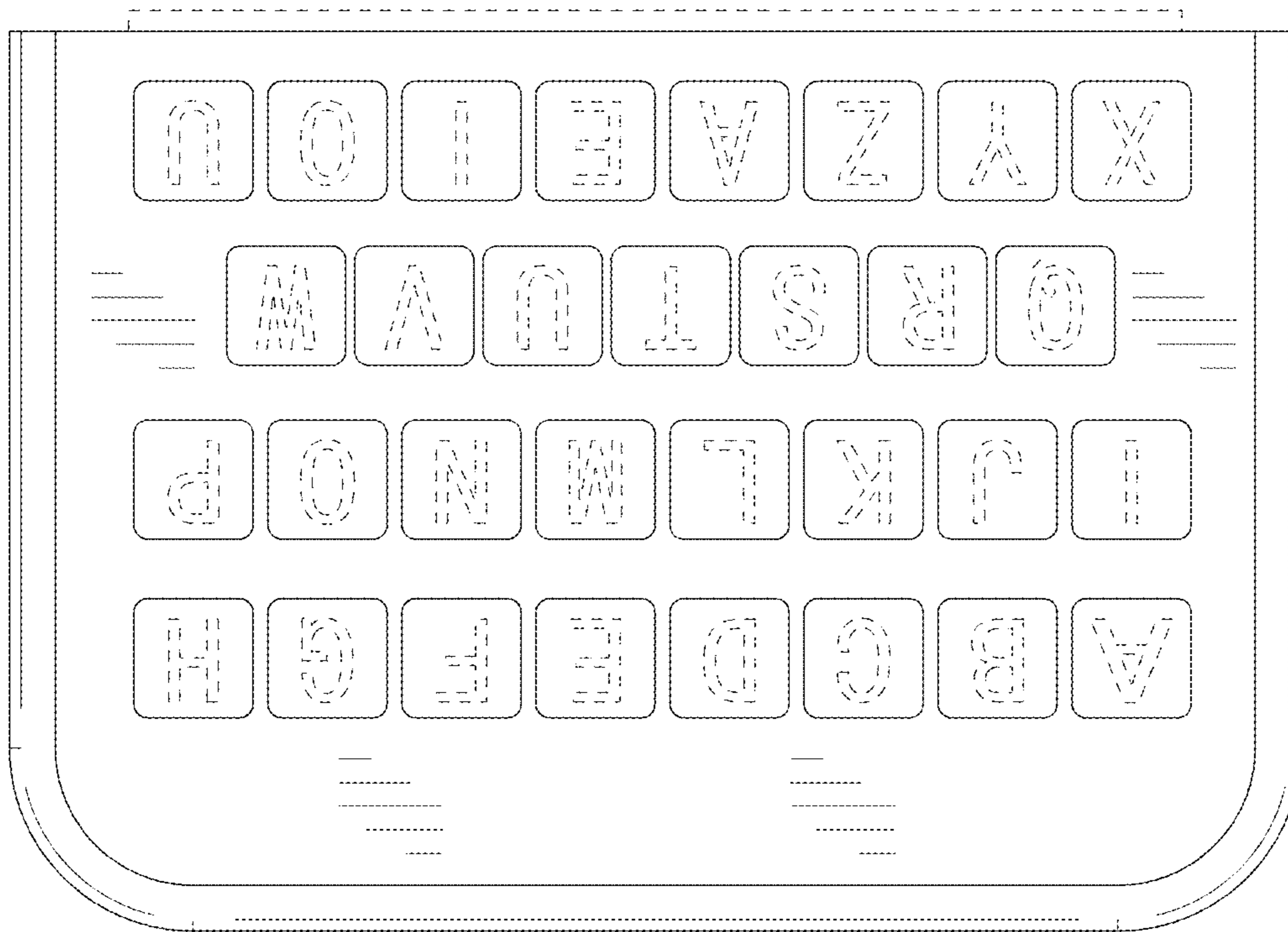

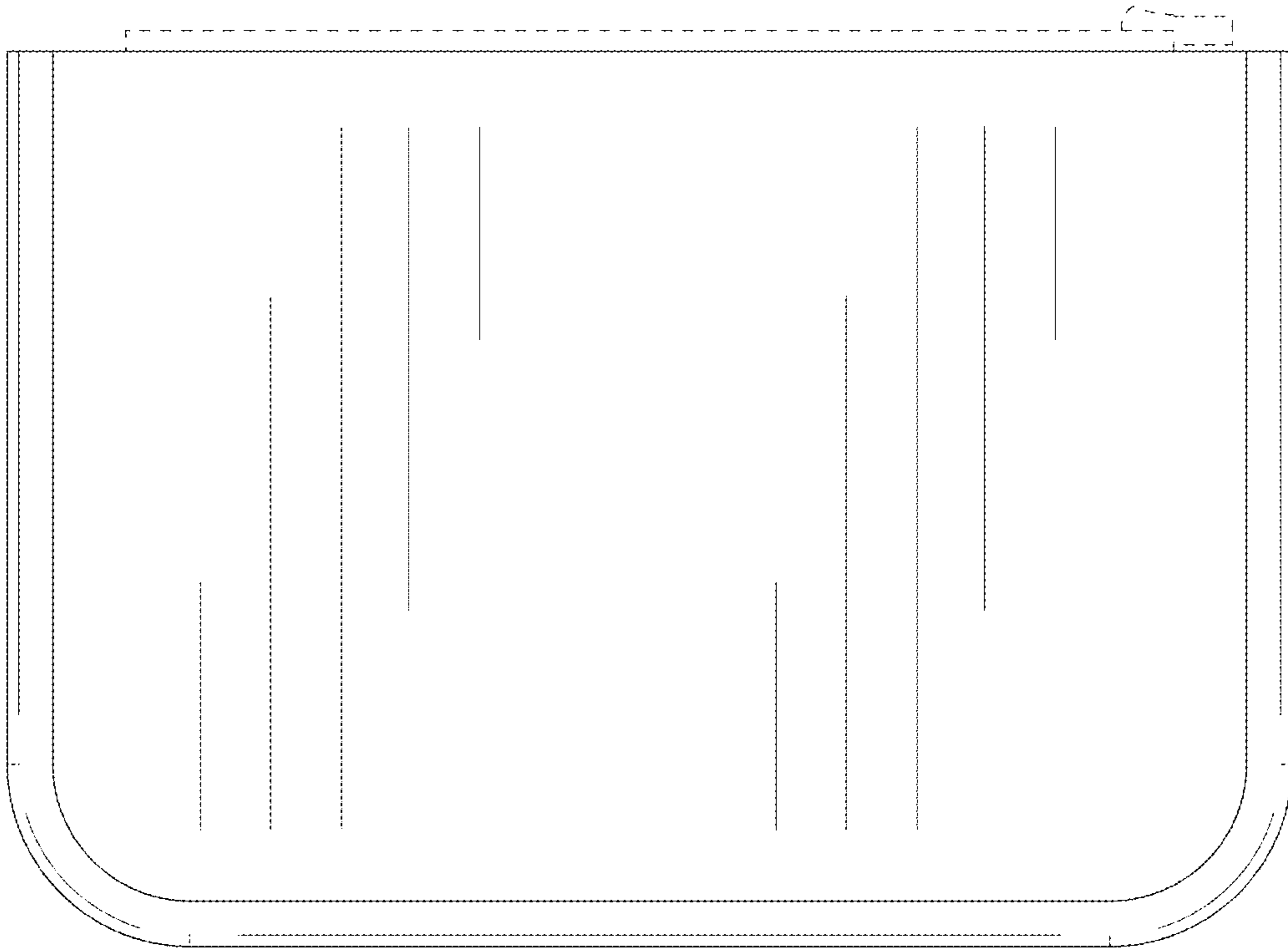

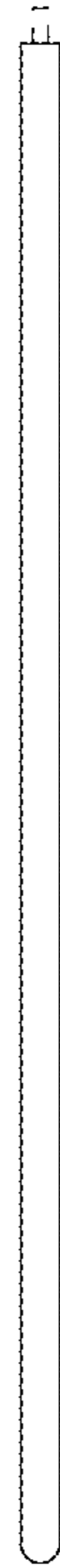

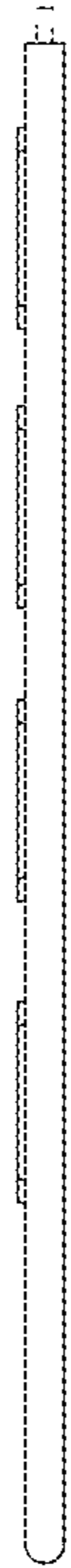

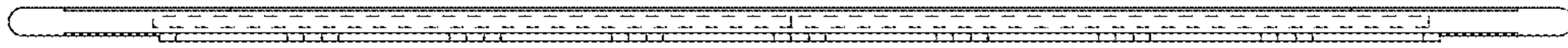

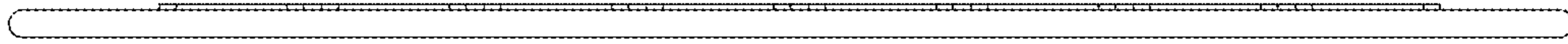

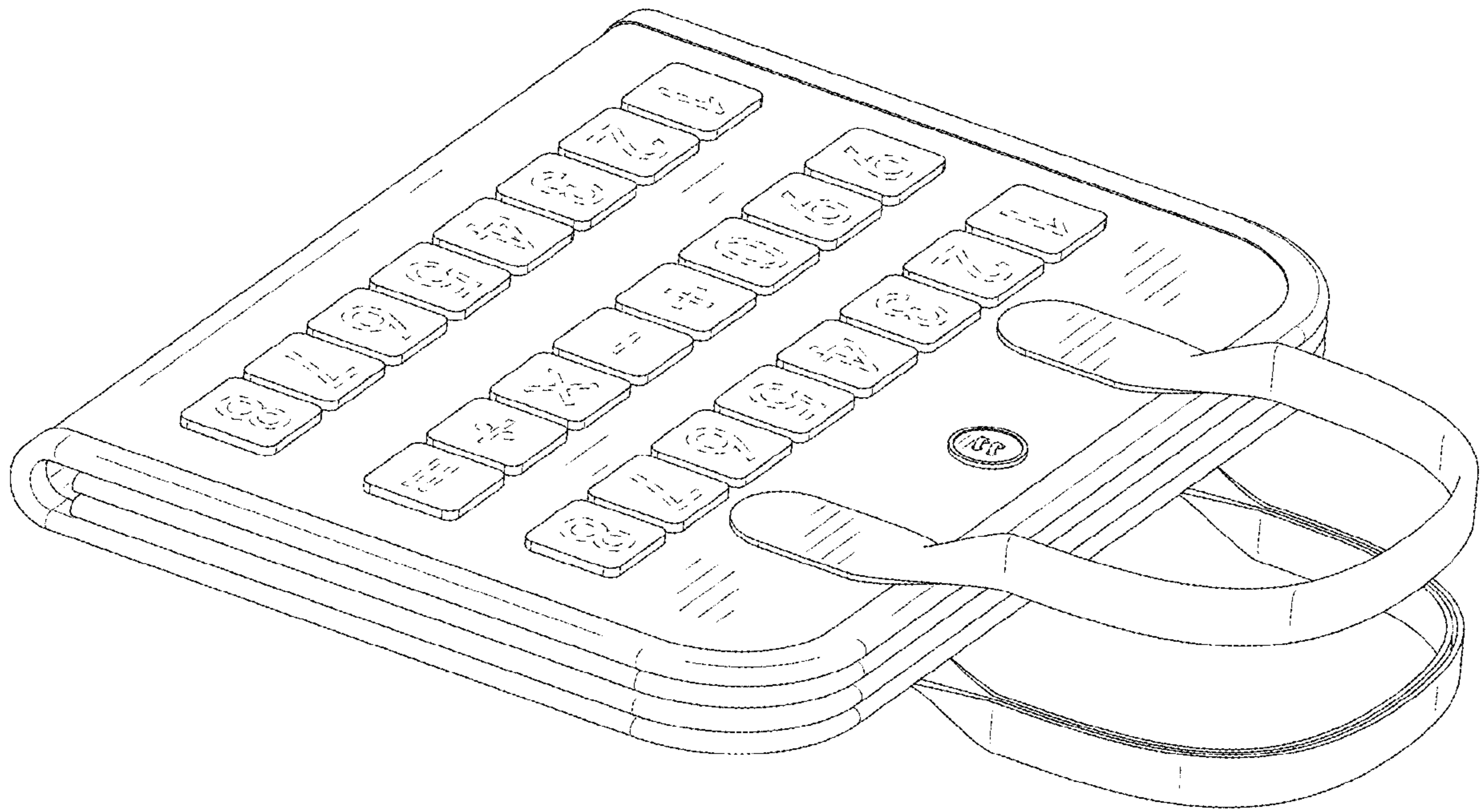

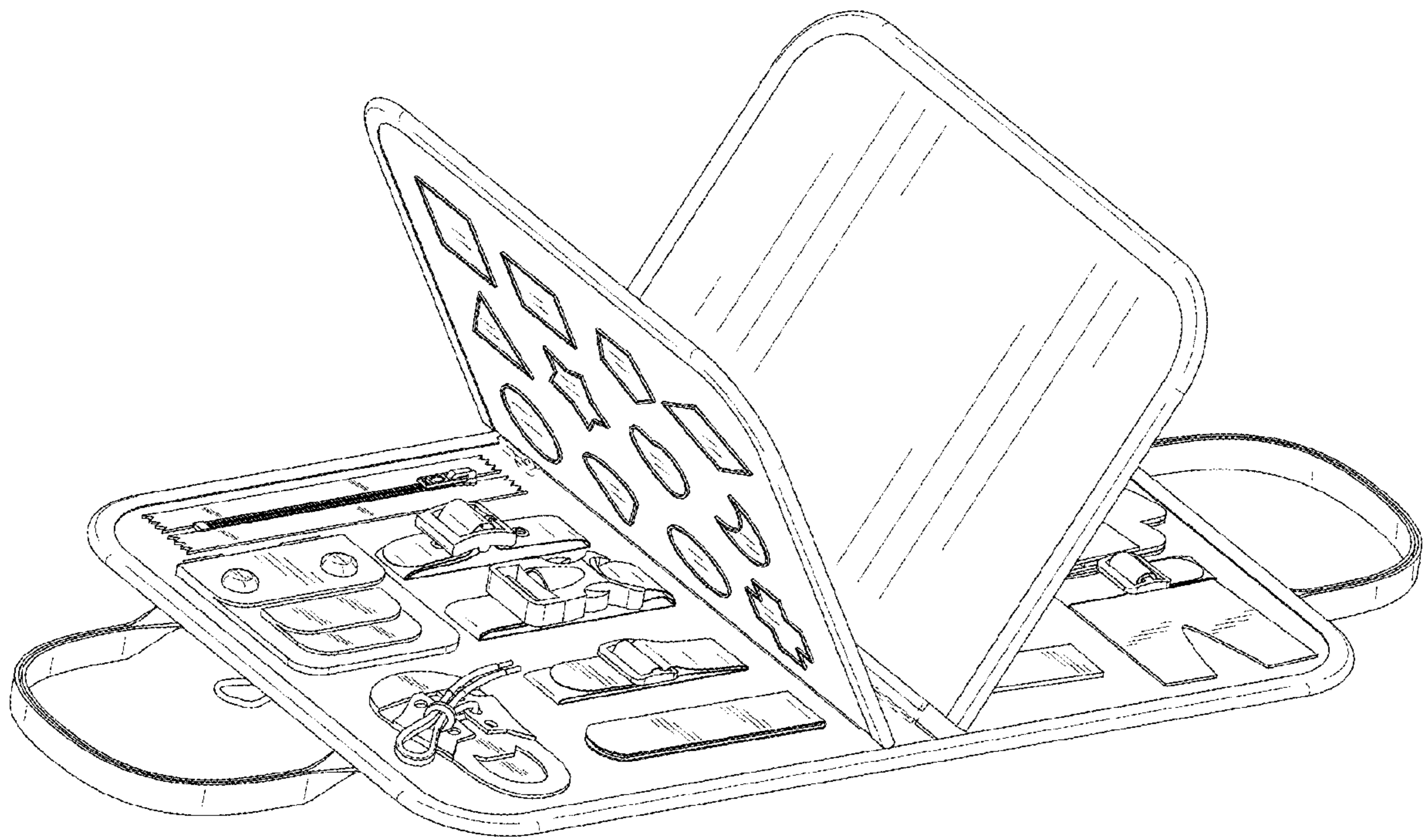
