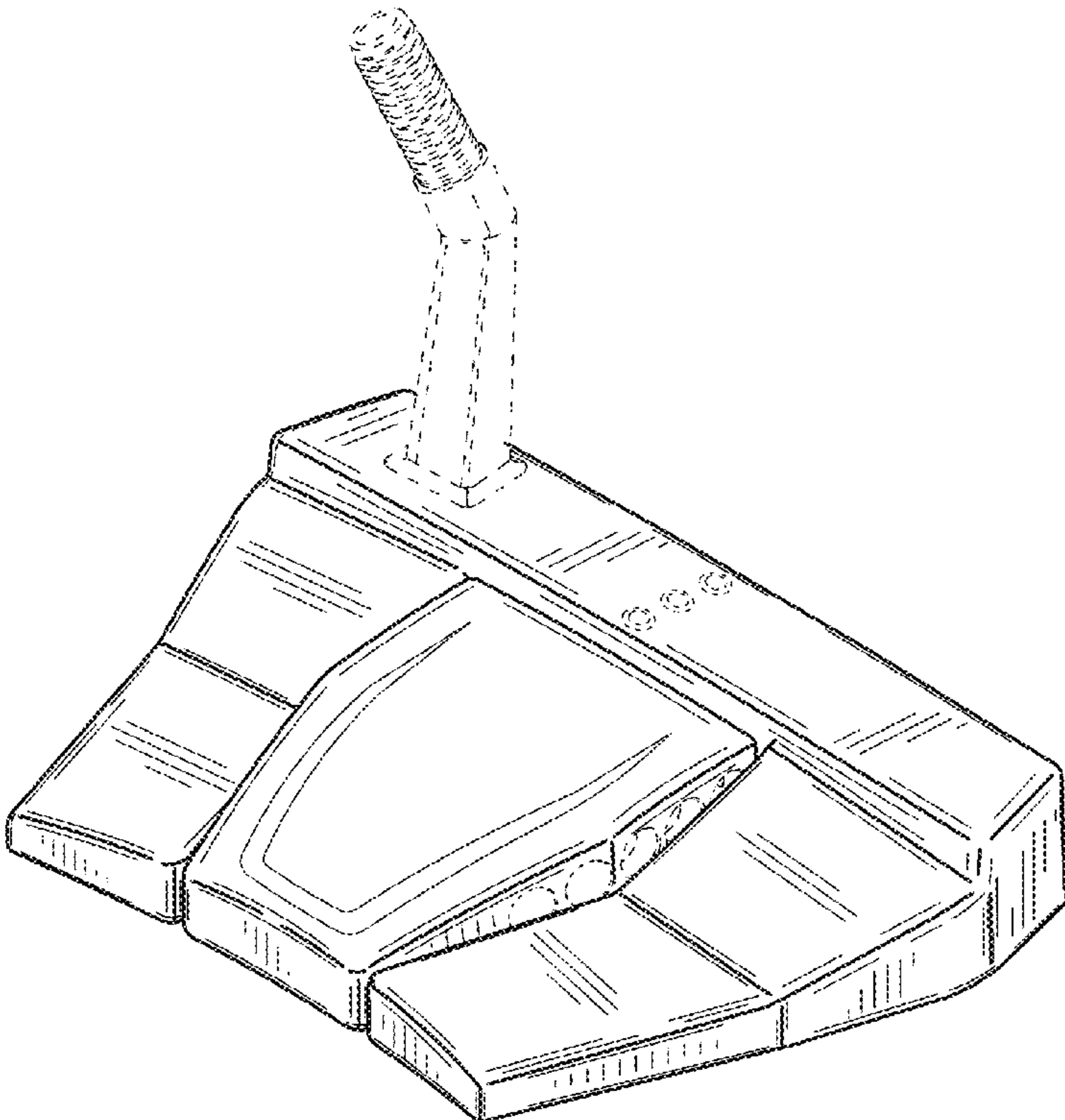
FIG. 1 is a perspective top plan view of a putter golf club head showing my design;

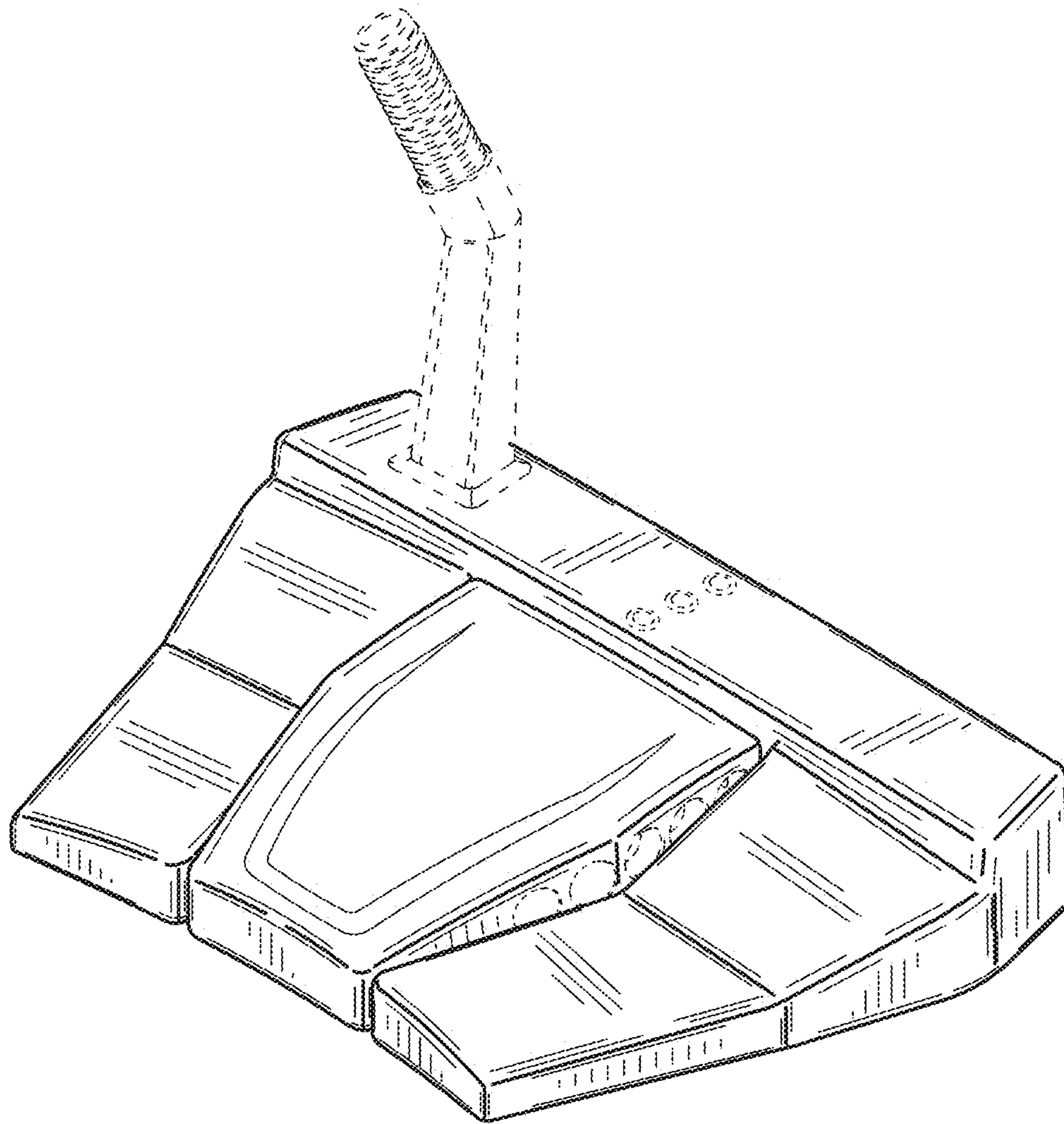

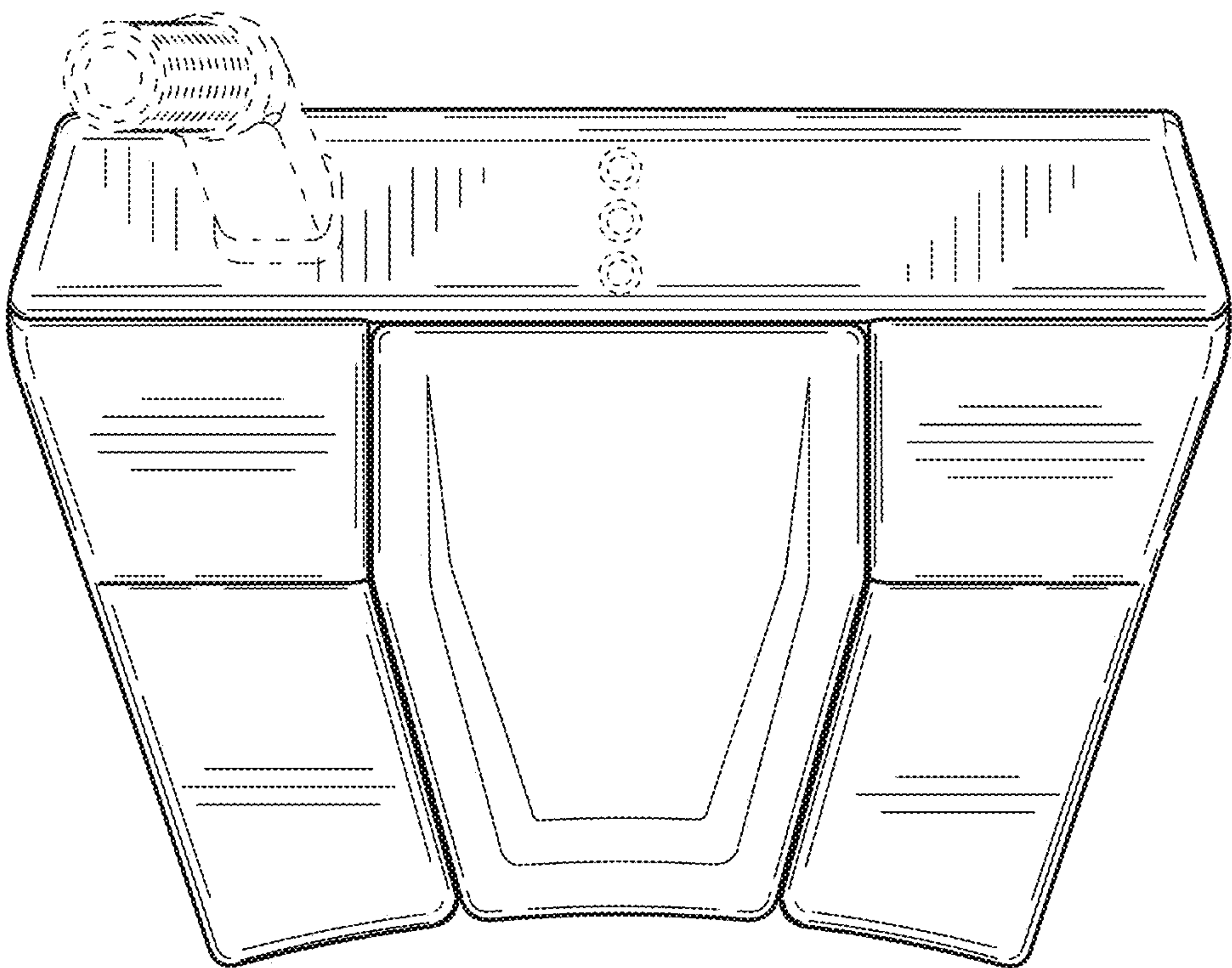

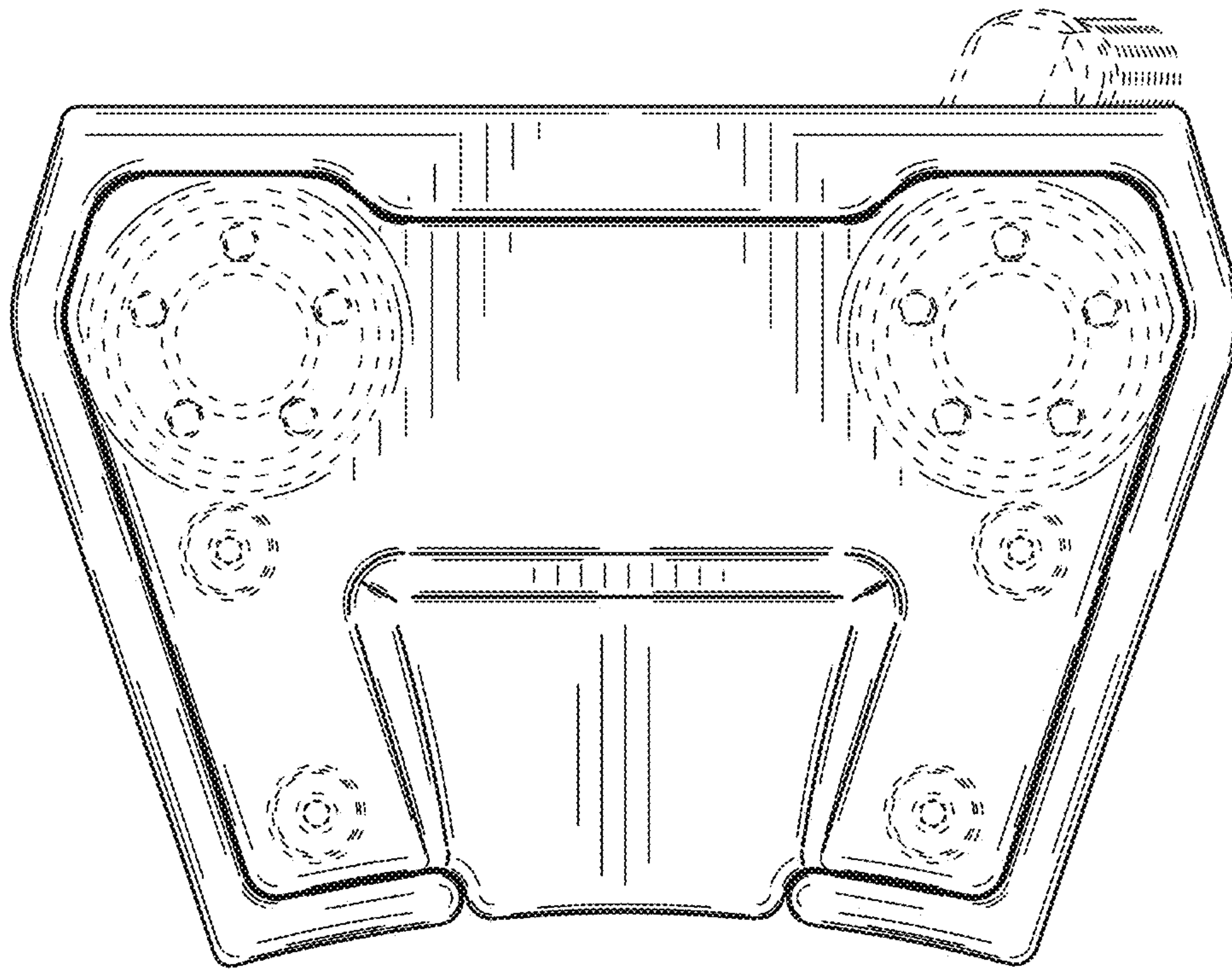

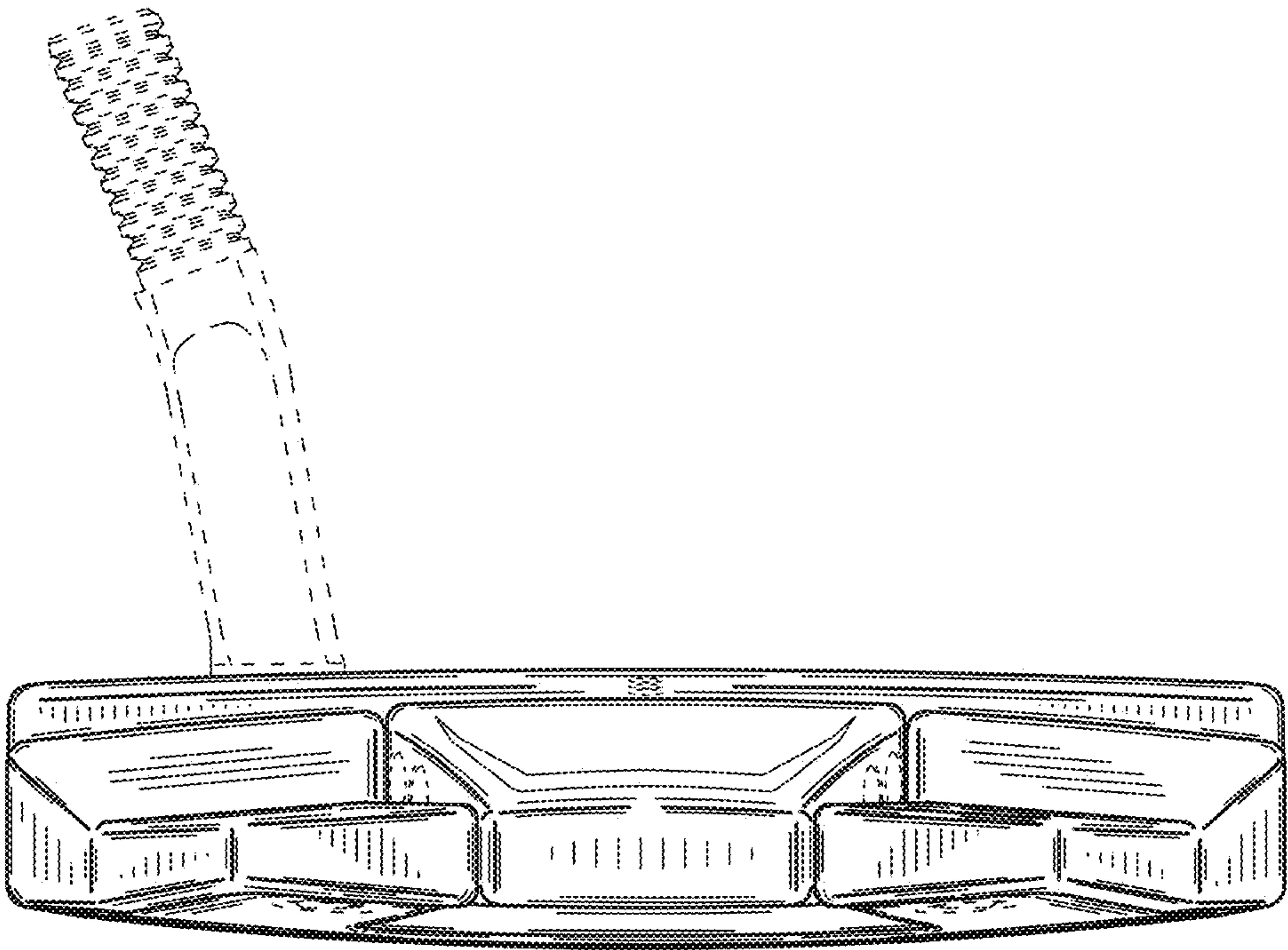

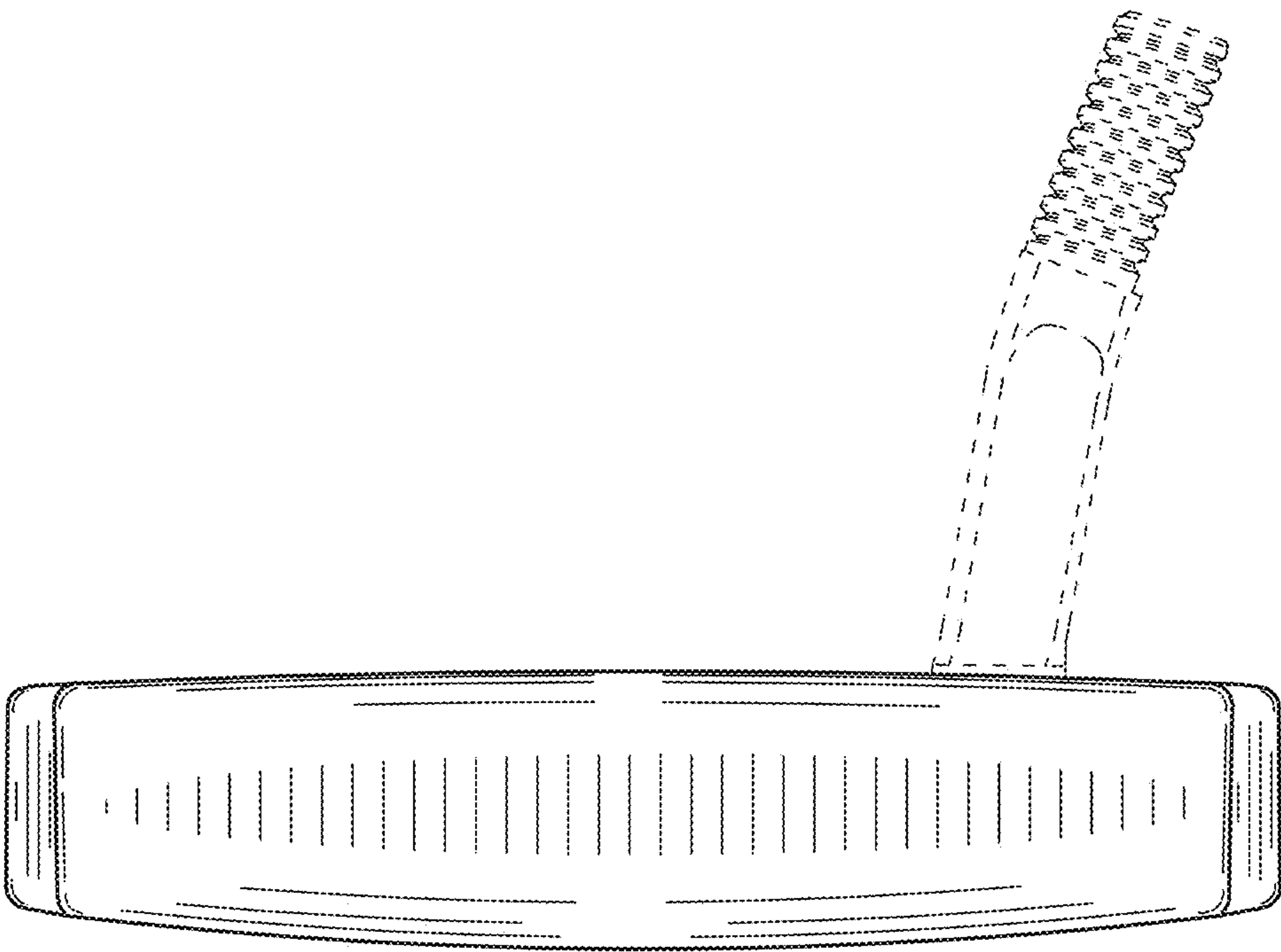

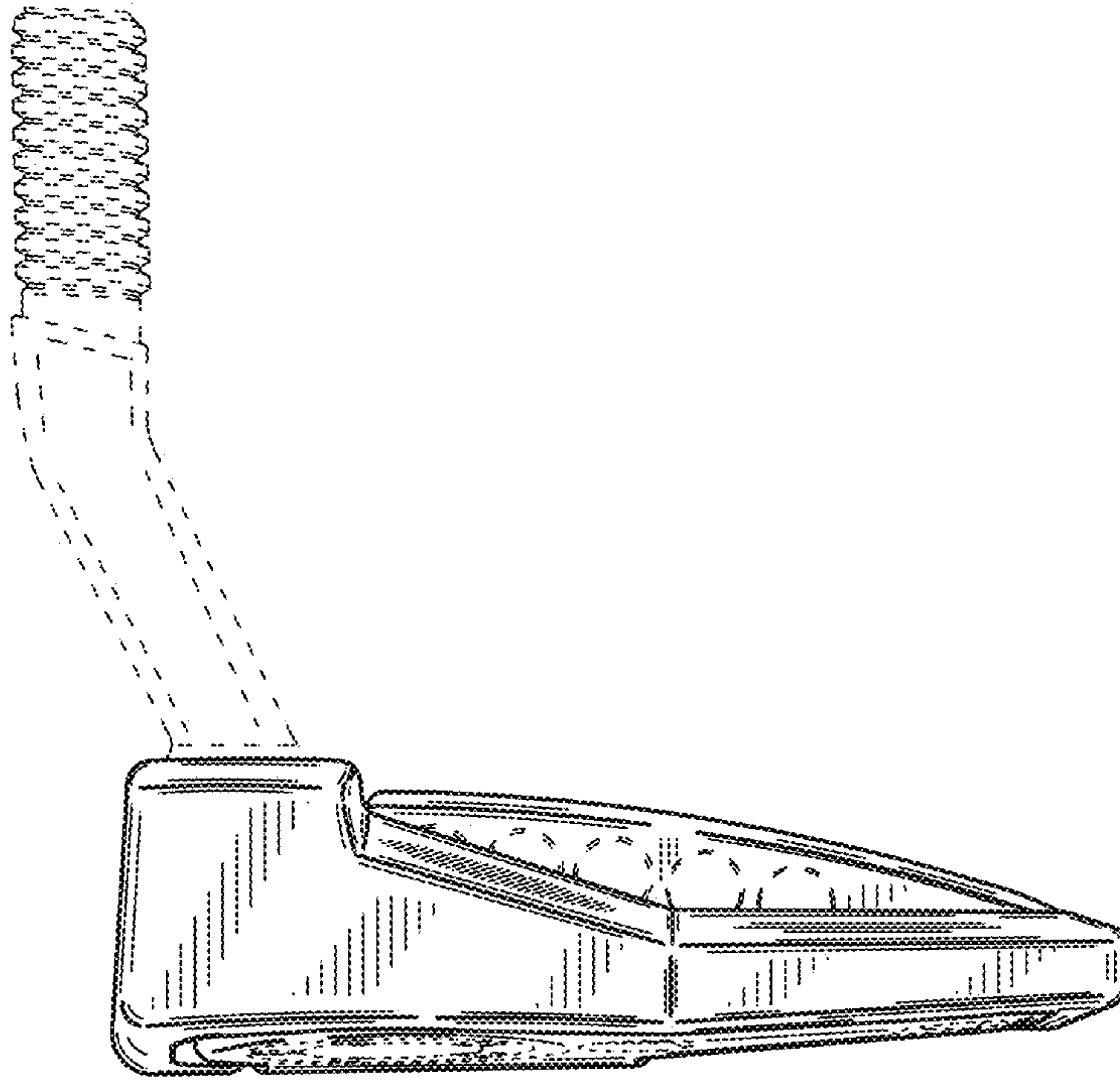

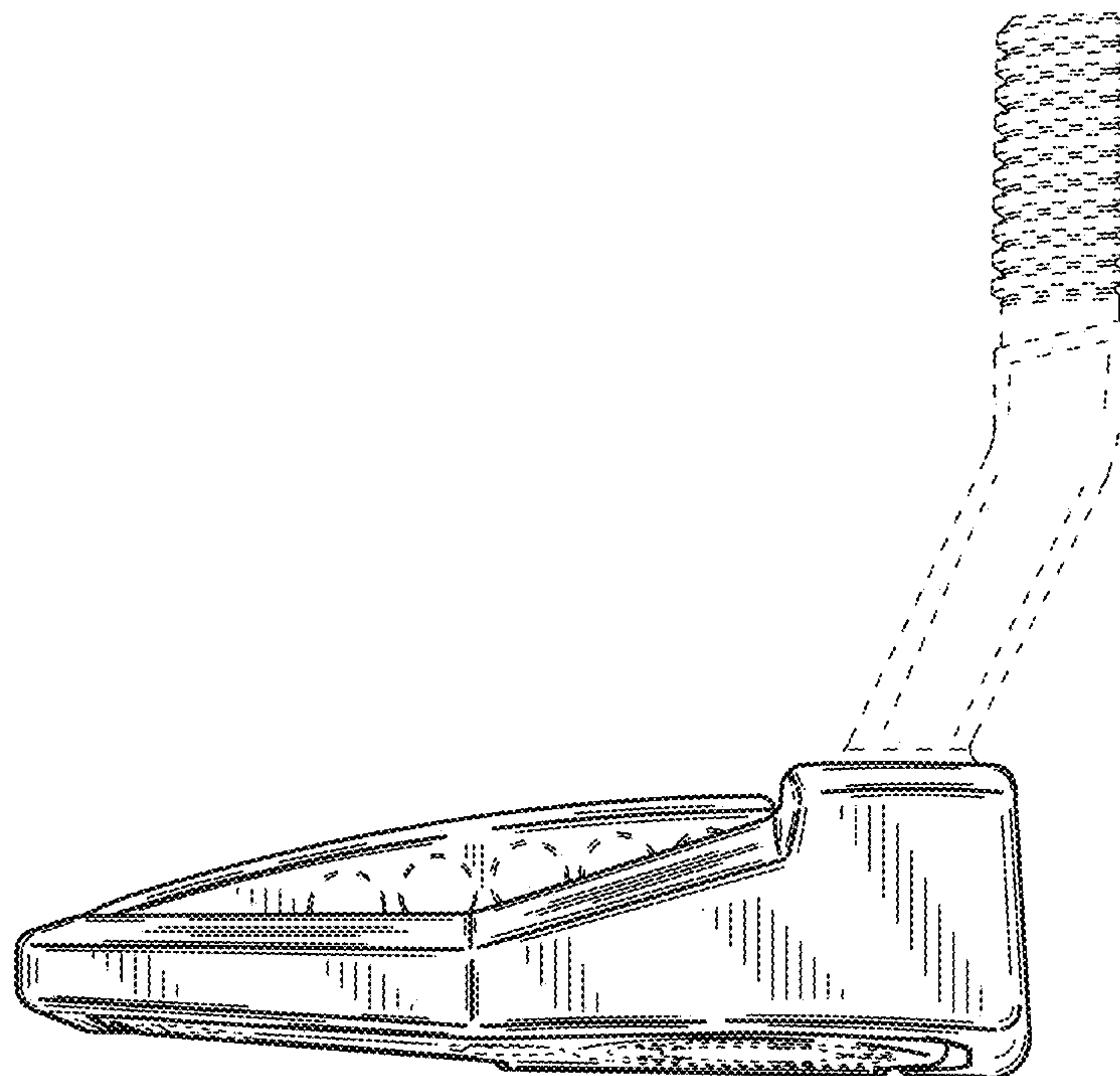
