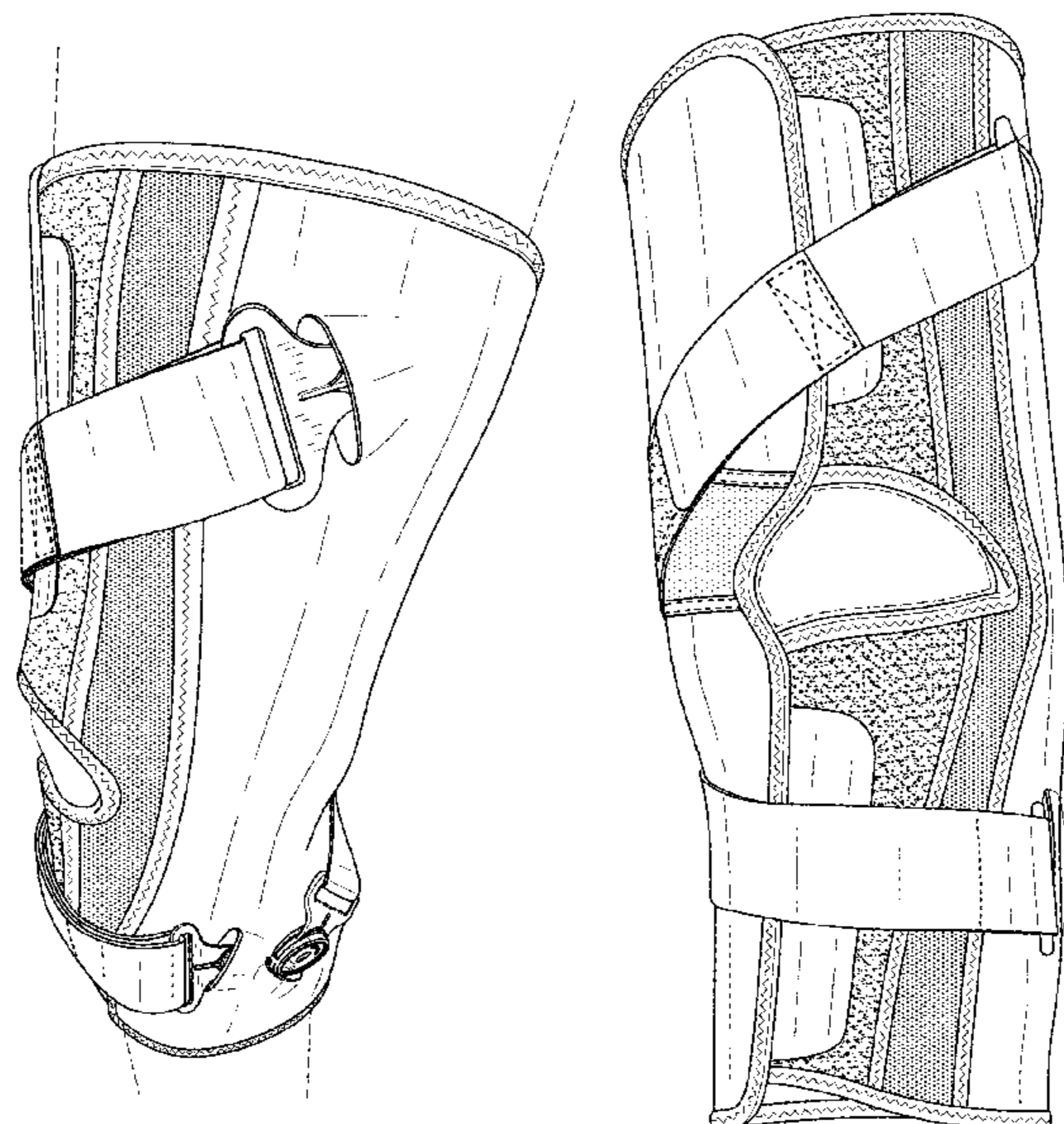
(57) **CLAIM**

The ornamental design for an orthopedic device having wrap and single strap, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of an orthopedic device having wrap and single strap showing our new design; FIG. 2 is a rear perspective view thereof; FIG. 3 is a front view thereof; FIG. 4 is a rear view thereof; FIG. 5 is a top view thereof; FIG. 6 is a bottom view thereof; FIG. 7 is a left side view thereof; and, FIG. 8 is a right side view thereof. The broken line showing portions of the orthopedic device having wrap and single strap and the broken lines showing stitching along the surface of the orthopedic device having wrap and single strap form no part of the claimed design. The broken line human figure in FIGS. 1 and 2 is for the sake of showing the claimed design in a condition of use, and forms no part of the claimed design.

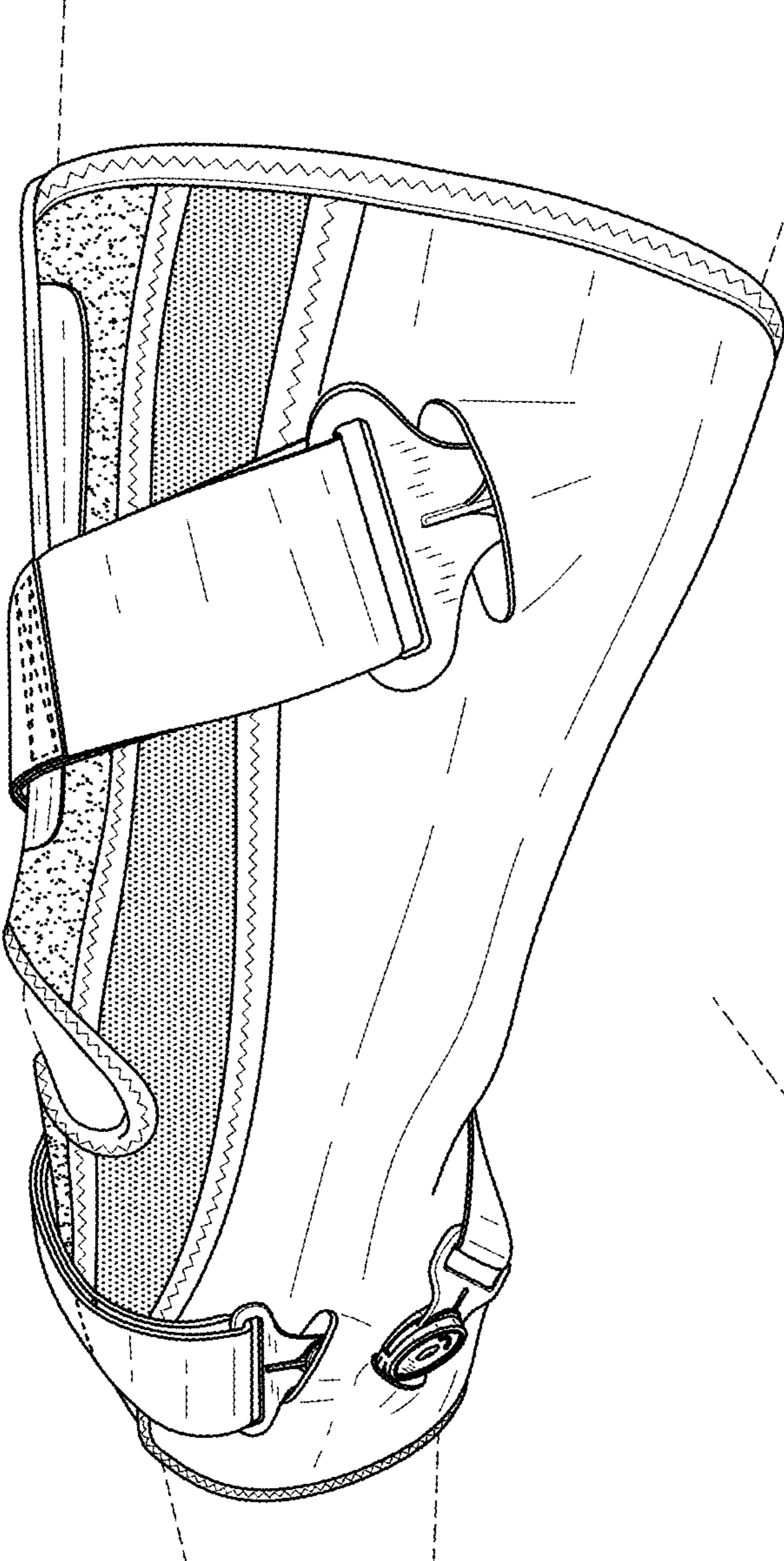

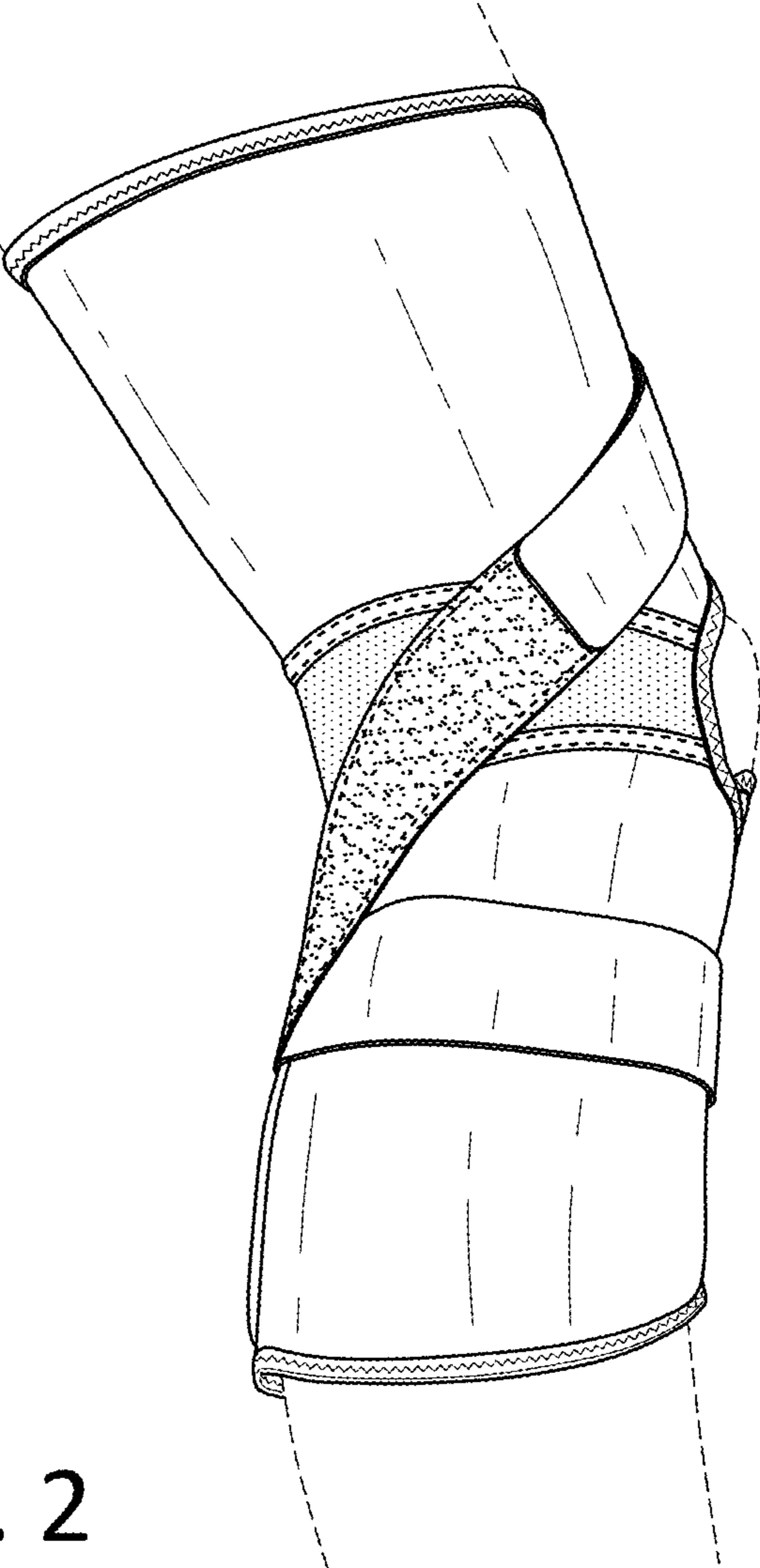

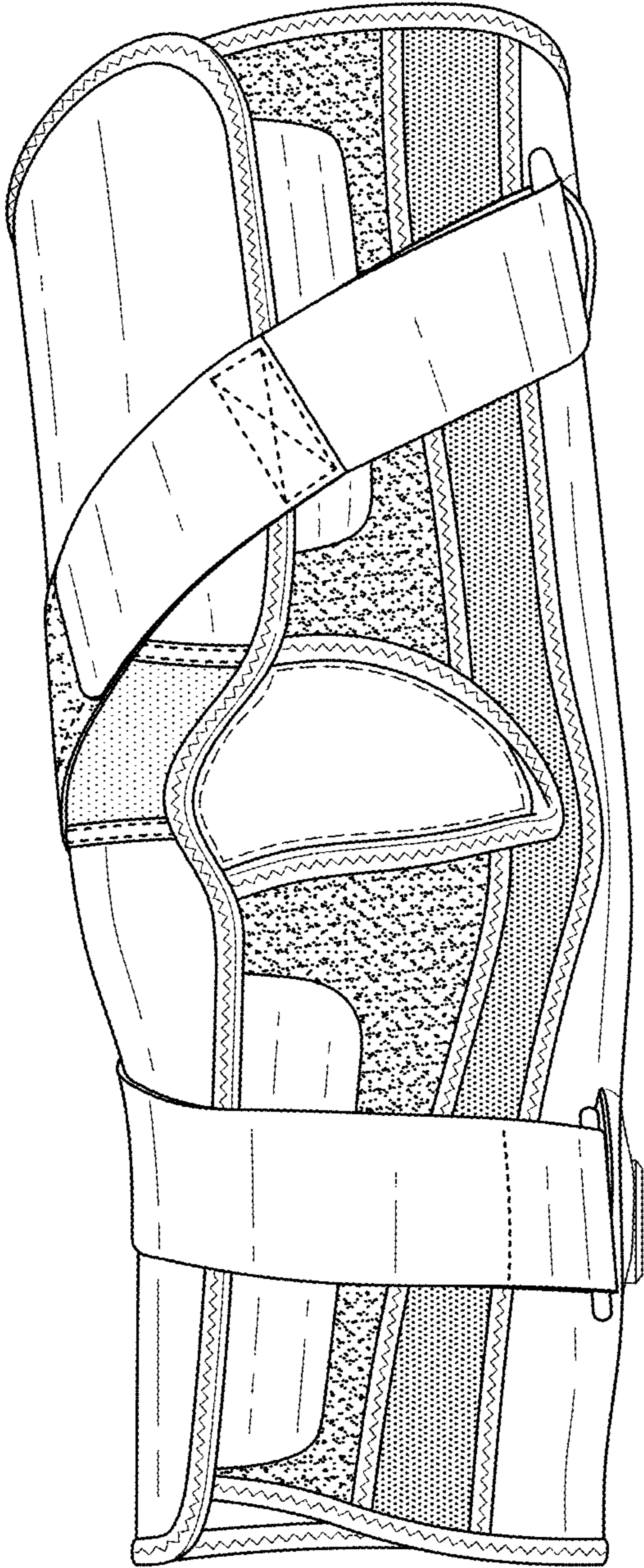

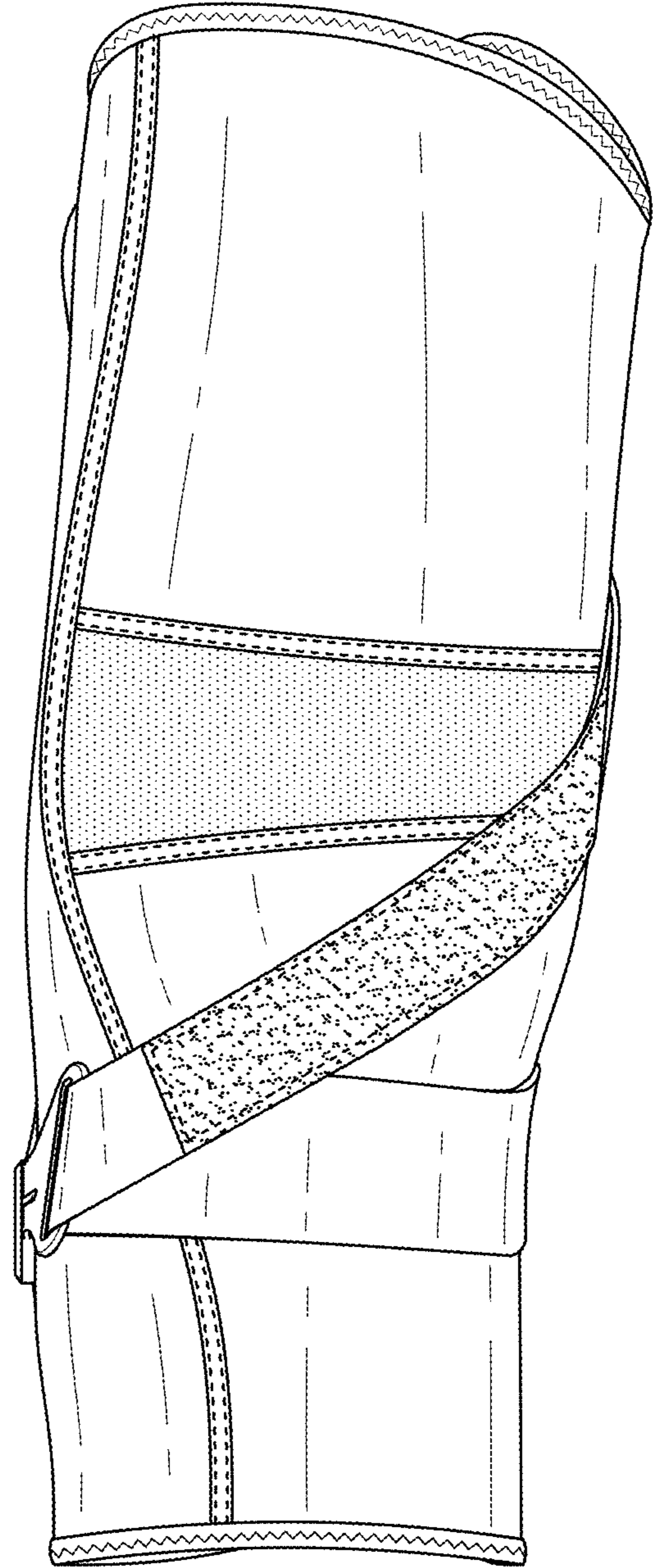

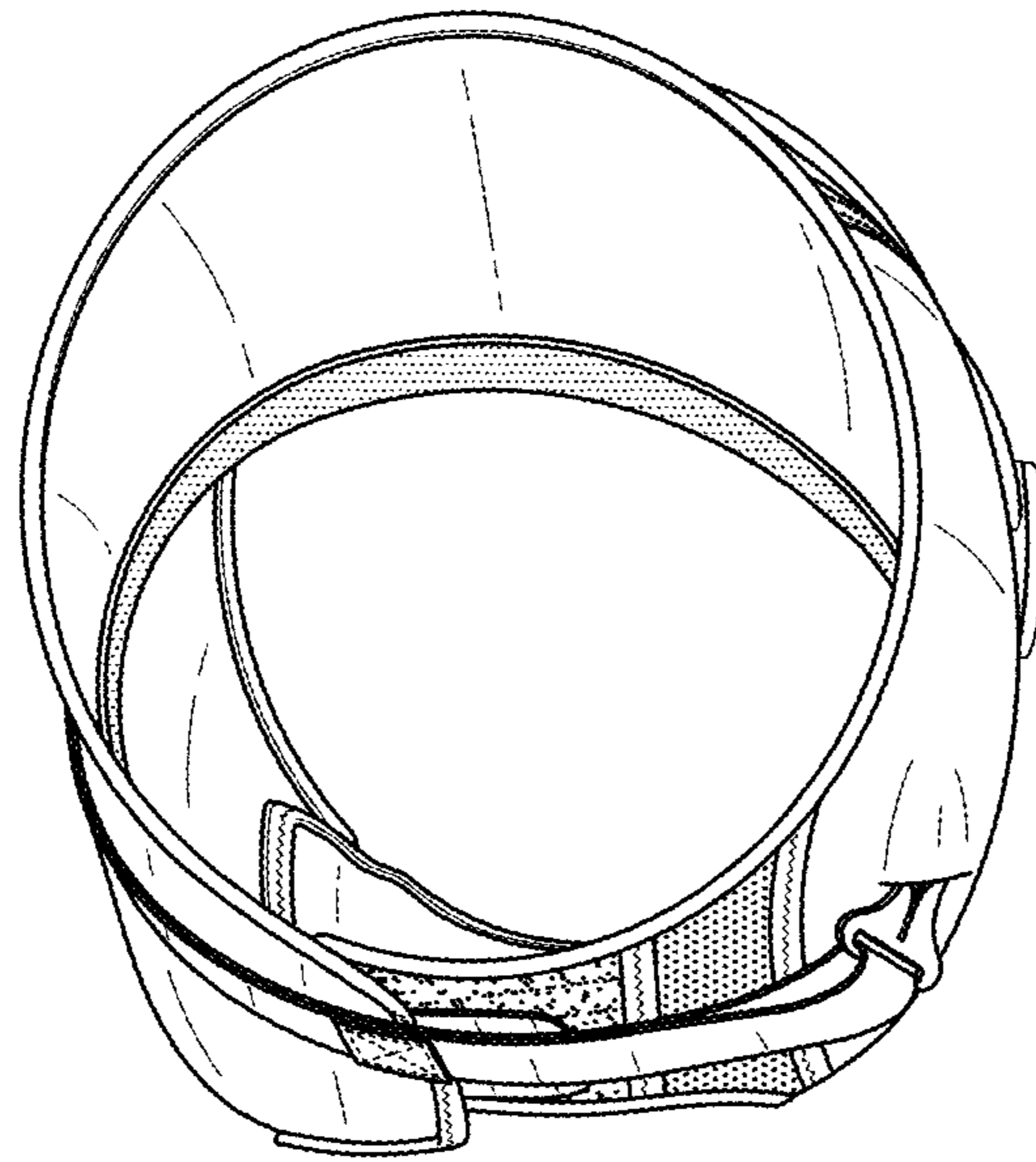

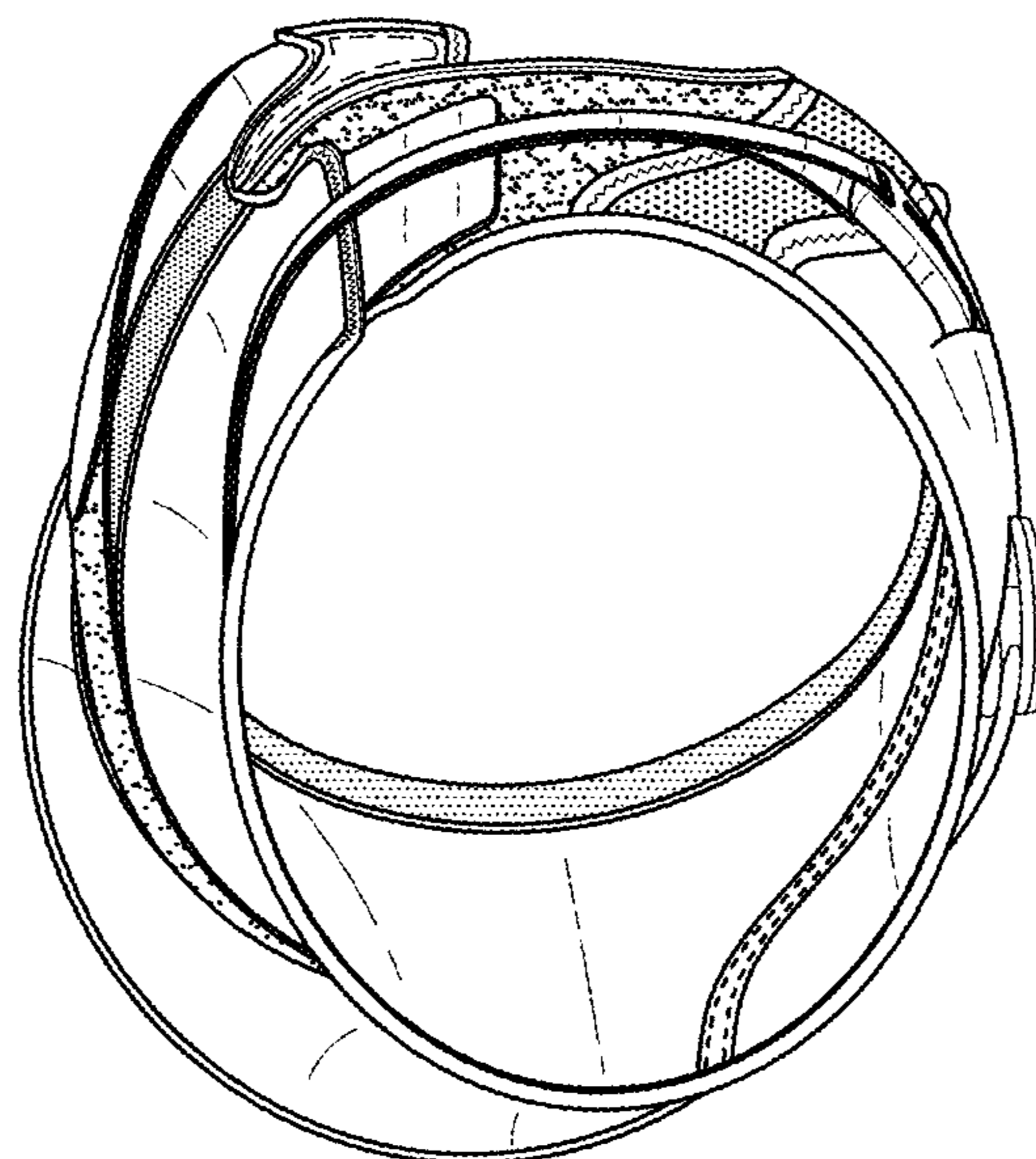

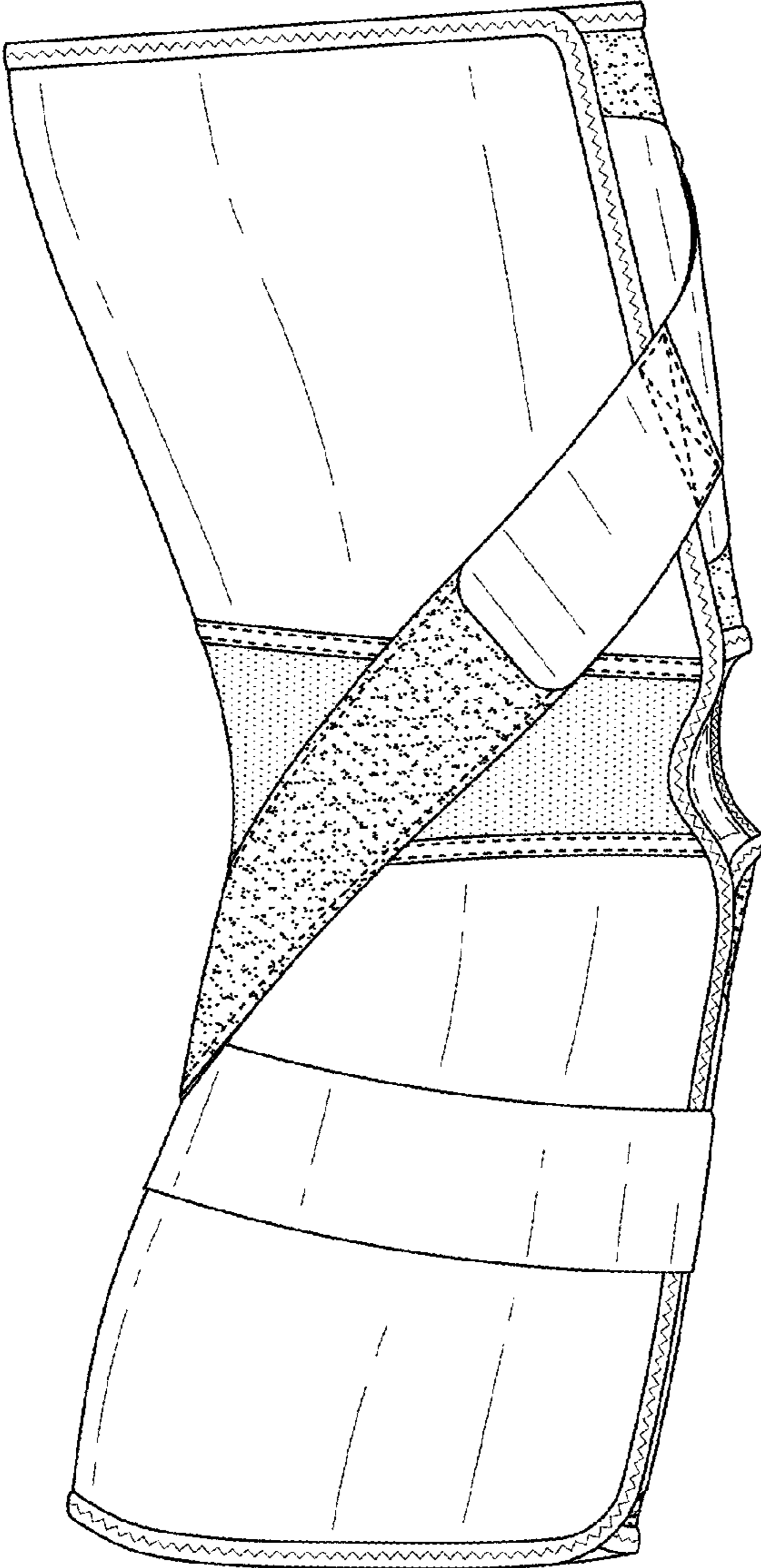

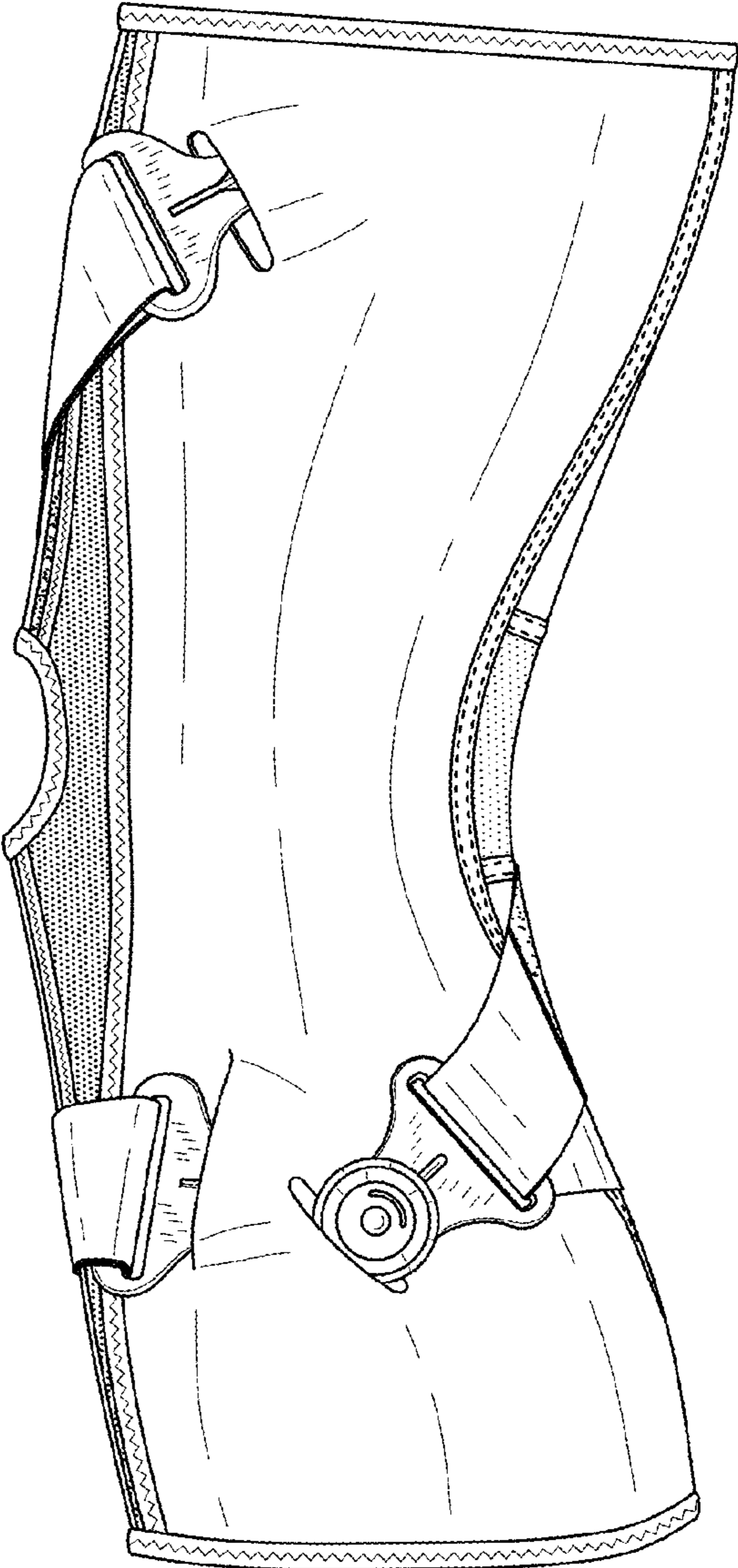
