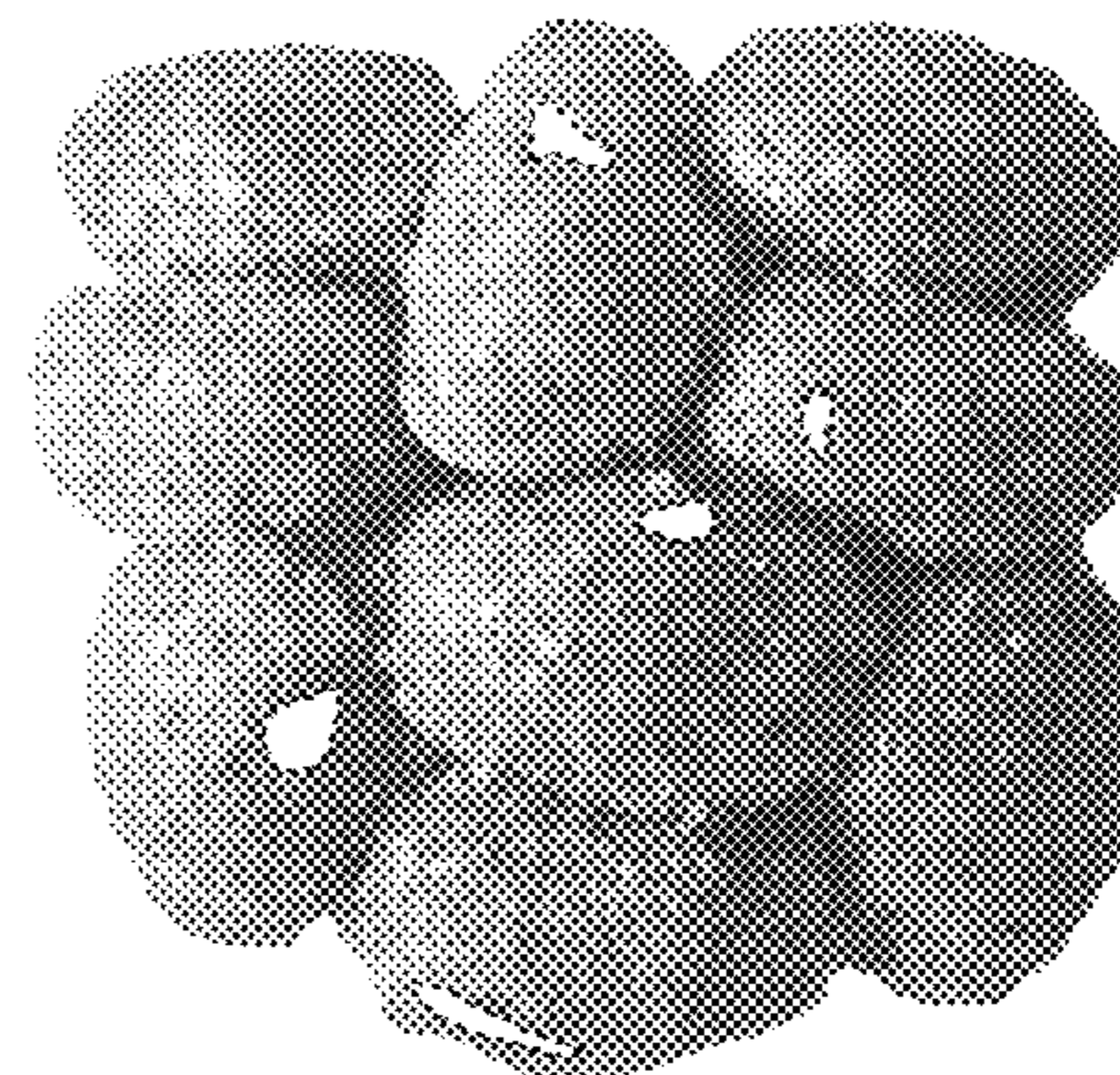
(57) **CLAIM**

The ornamental design for a cereal piece, as shown and described.

DESCRIPTION

FIG. 1 is a front, top and left side perspective view of a first embodiment of a cereal piece according to our new design; FIG. 2 is a top plan view thereof; FIG. 3 is a bottom plan view thereof; FIG. 4 is a left side elevation view thereof; FIG. 5 is a right side elevation view thereof; FIG. 6 is a rear elevation view thereof; FIG. 7 is a front elevation view thereof; FIG. 8 is a front, top and left side perspective view of a second embodiment of a cereal piece according to our new design; FIG. 9 is a top plan view thereof; FIG. 10 is a bottom plan view thereof; FIG. 11 is a left side elevation view thereof; FIG. 12 is a right side elevation view thereof; FIG. 13 is a rear elevation view thereof; and, FIG. 14 is a front elevation view thereof. Broken lines shown in the drawings illustrate portions of the cereal piece that form no part of the claimed design.

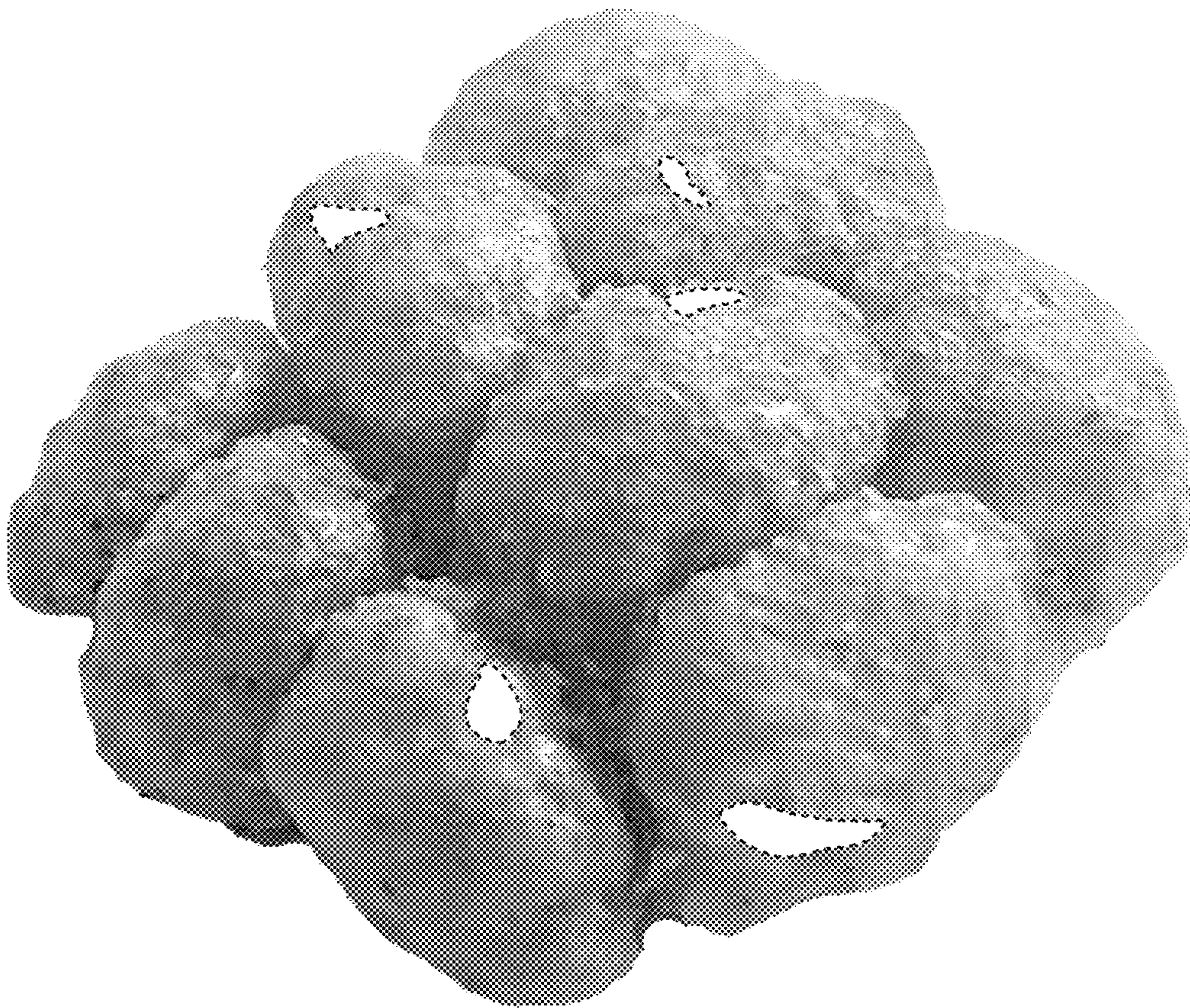

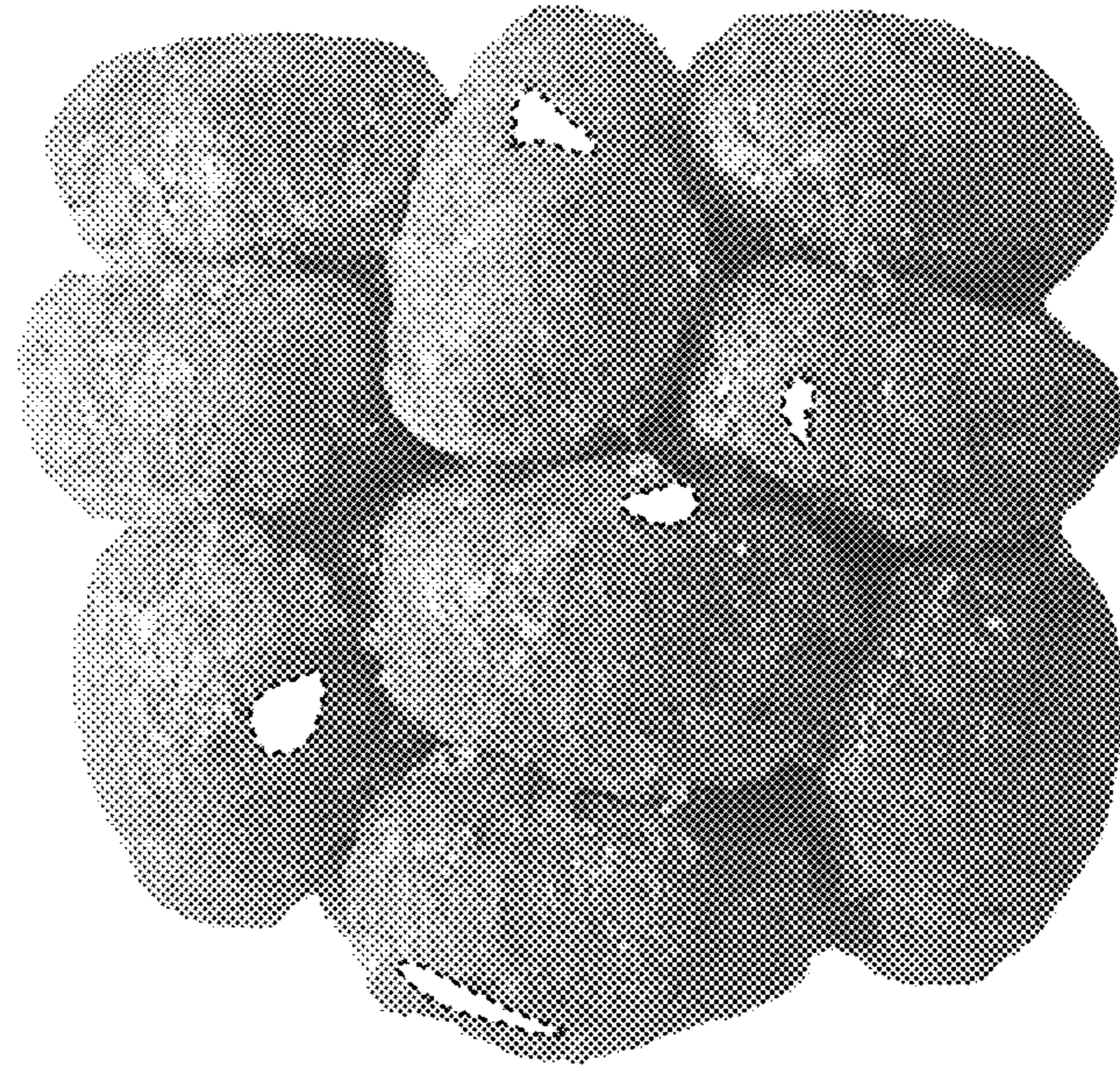

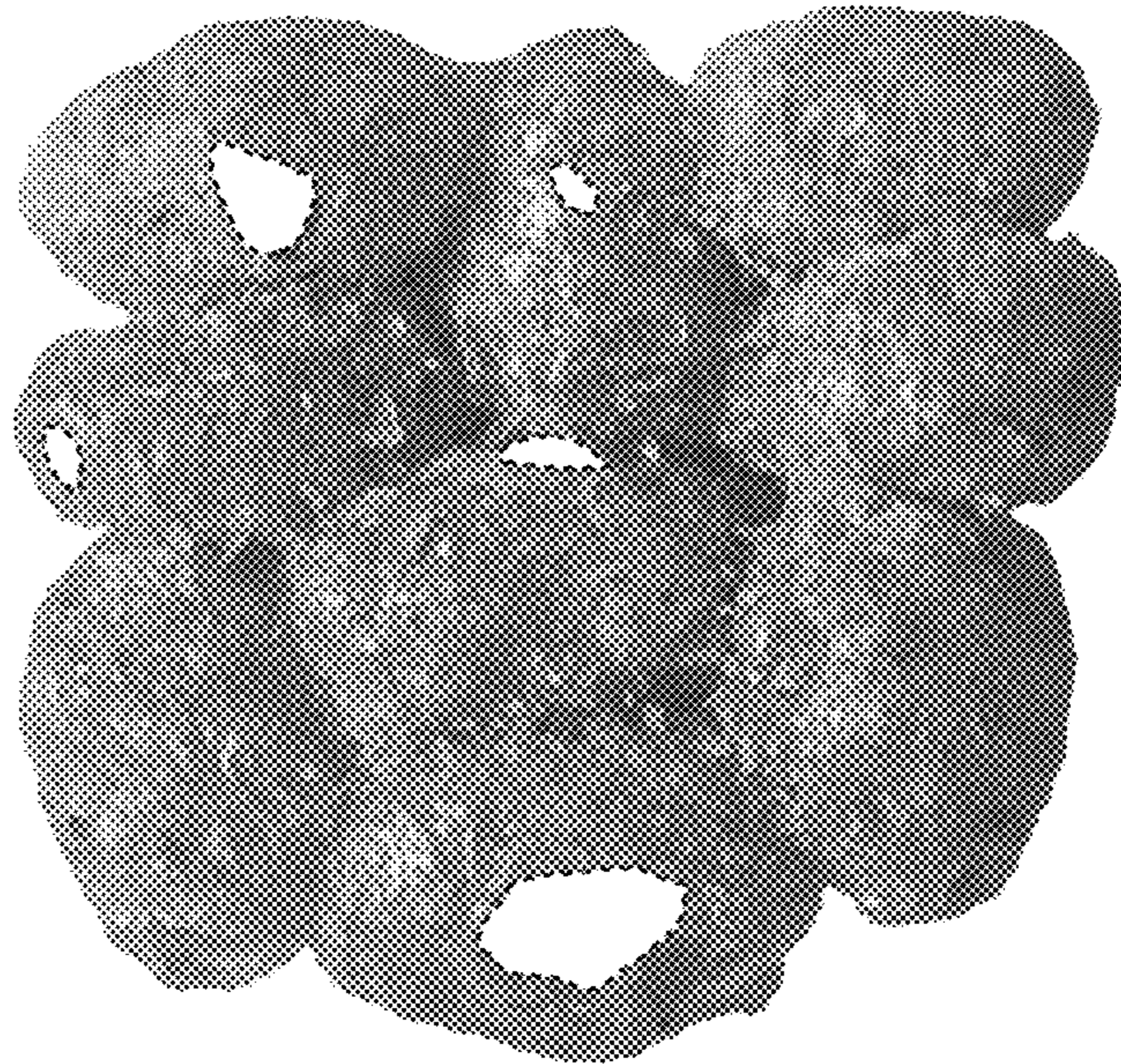

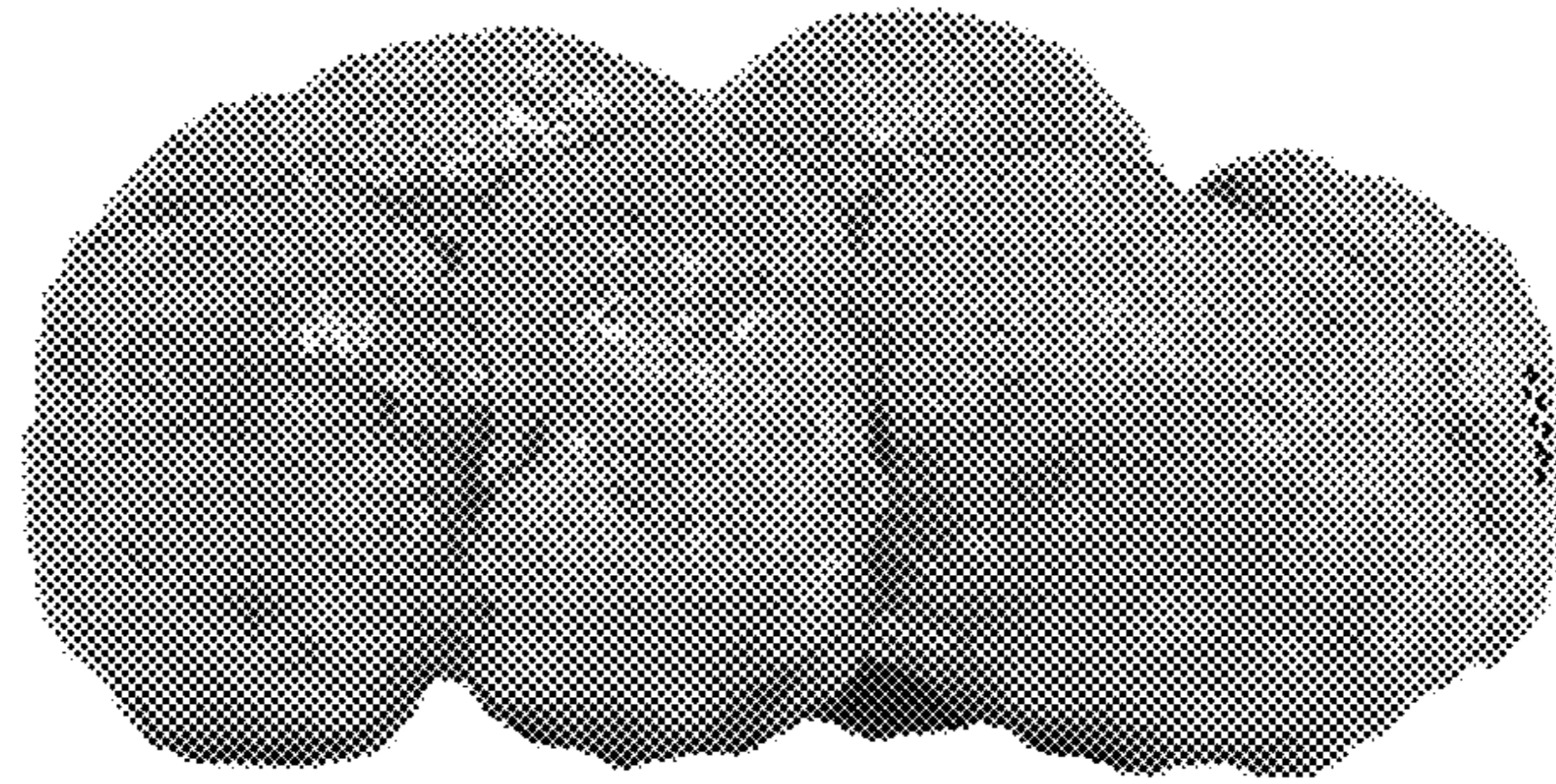

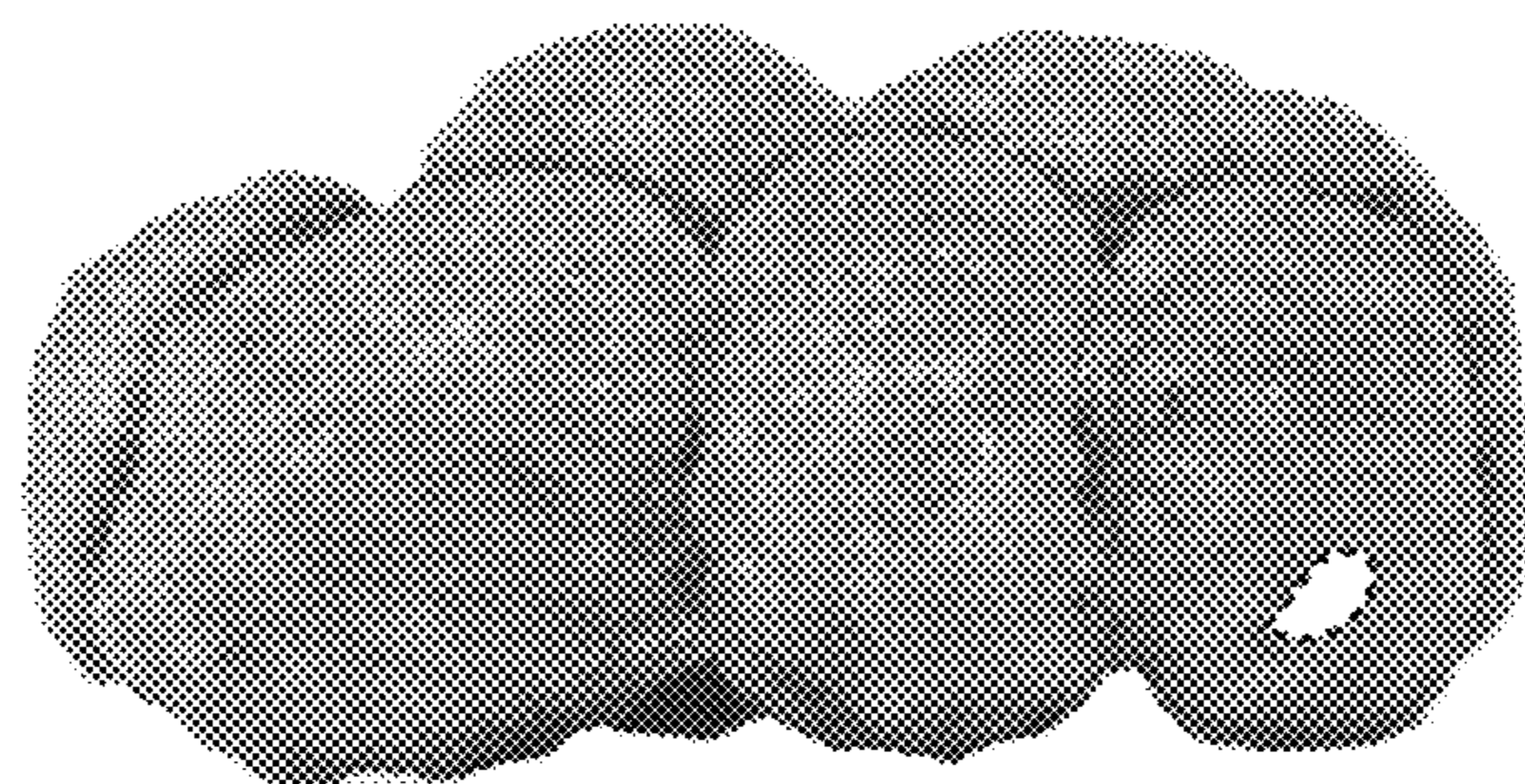

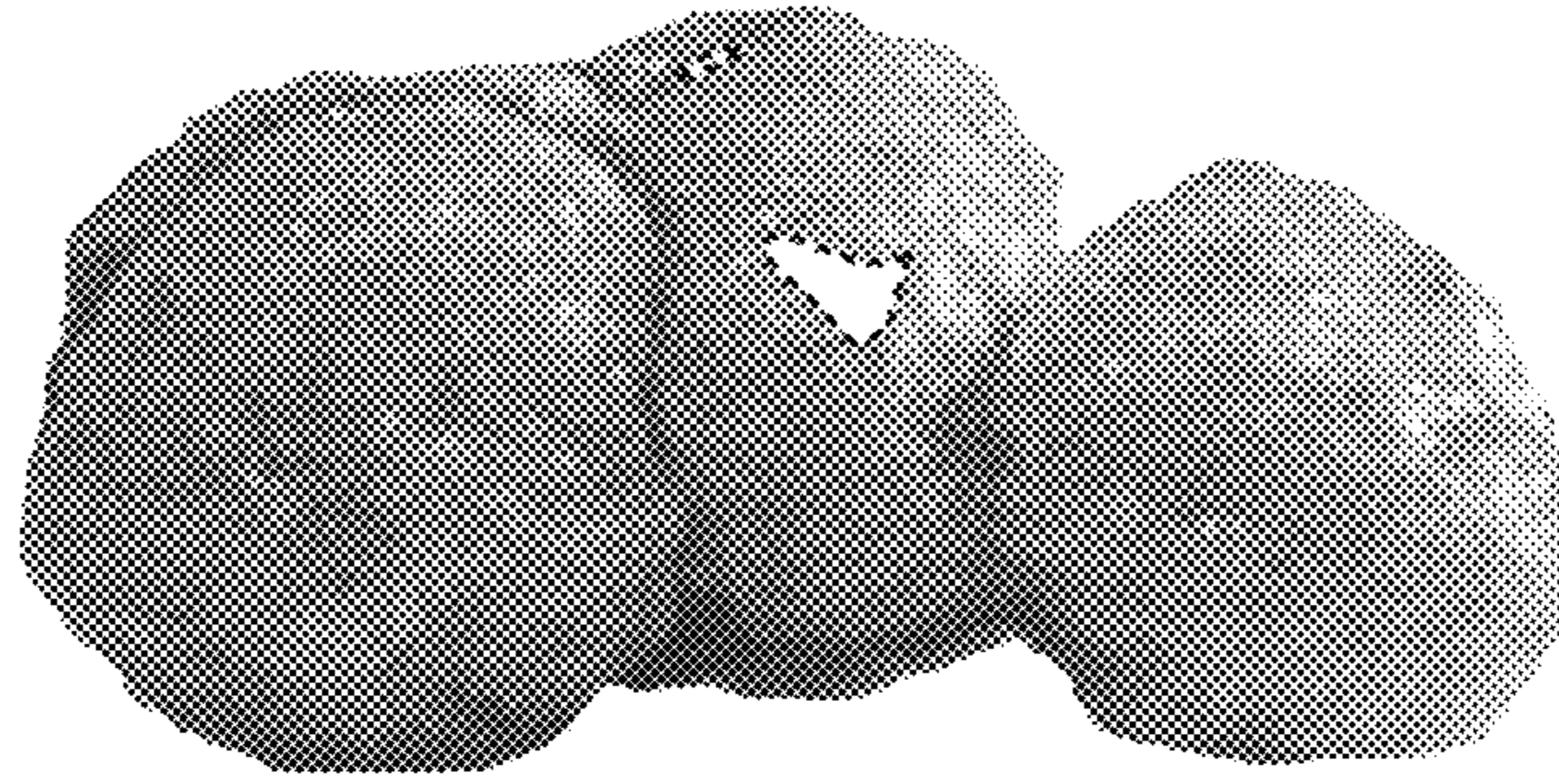

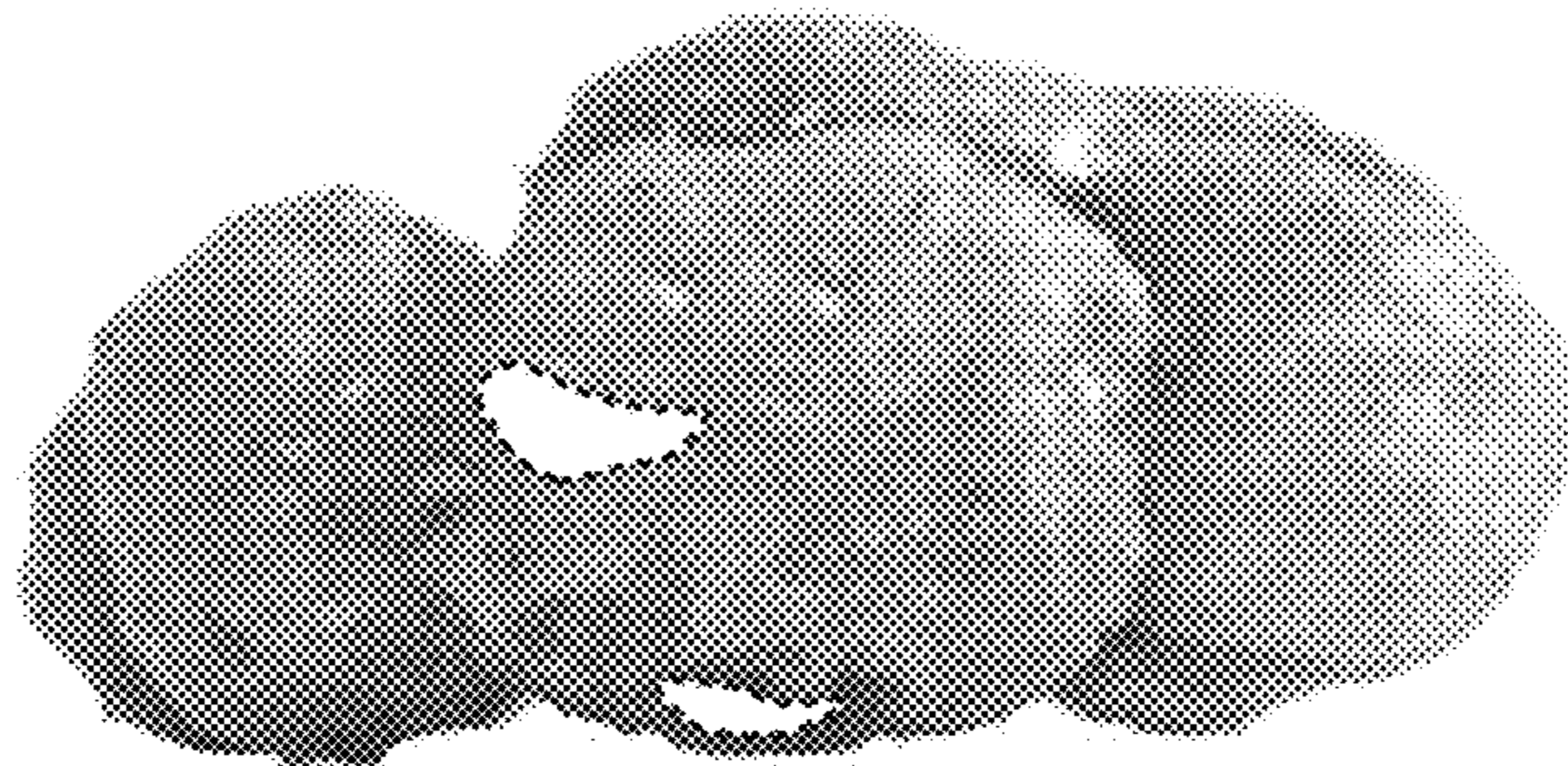

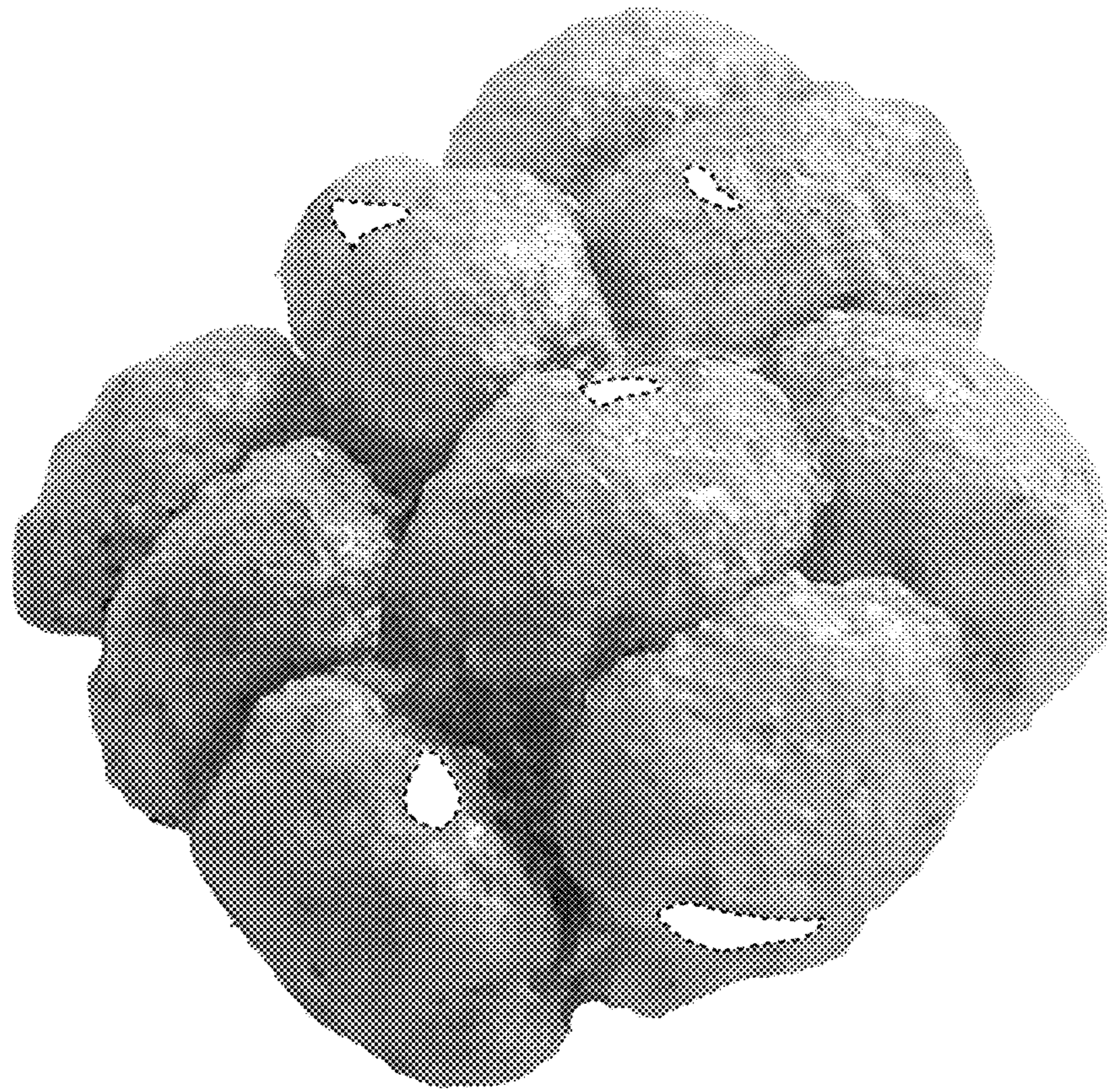

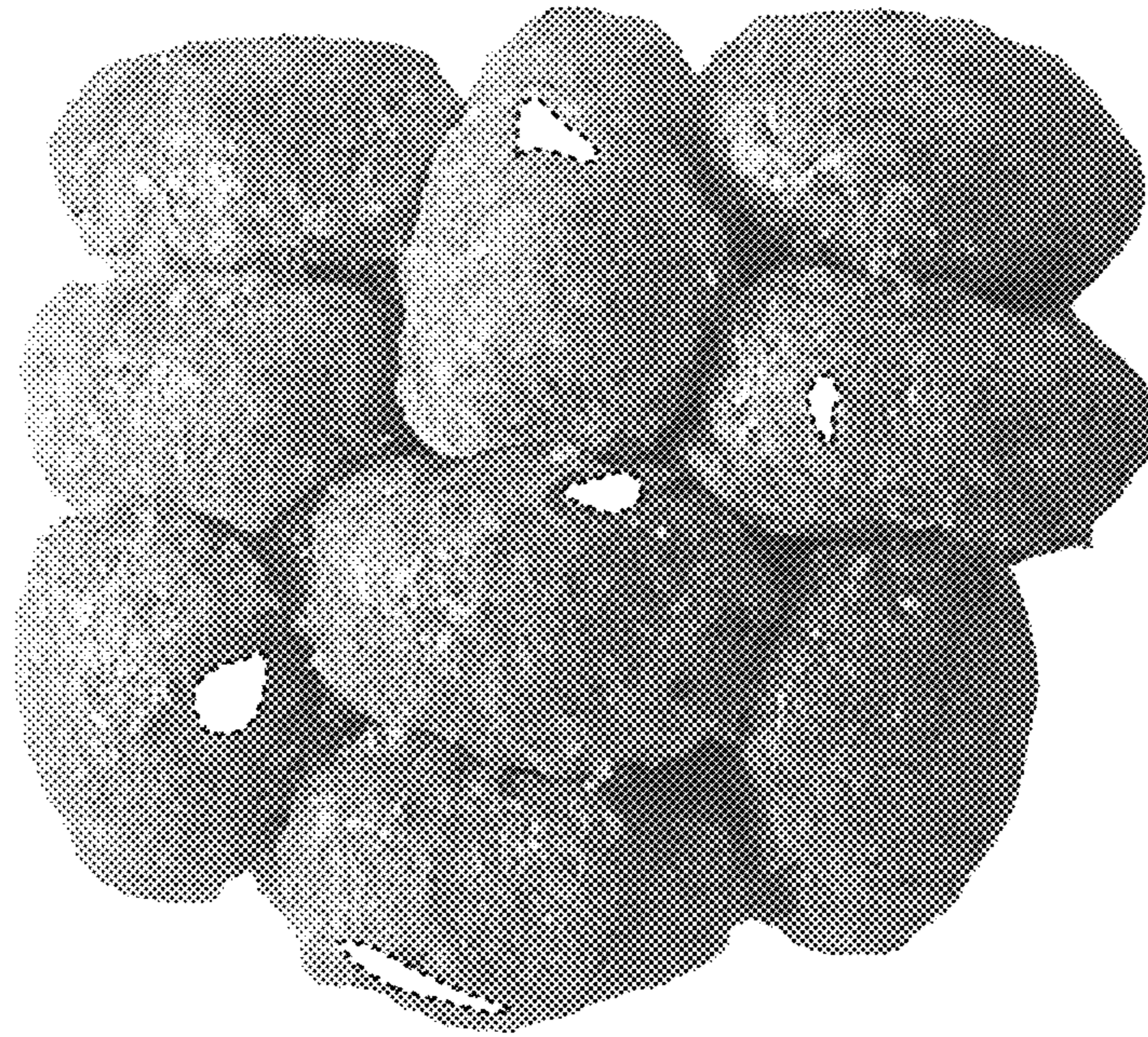

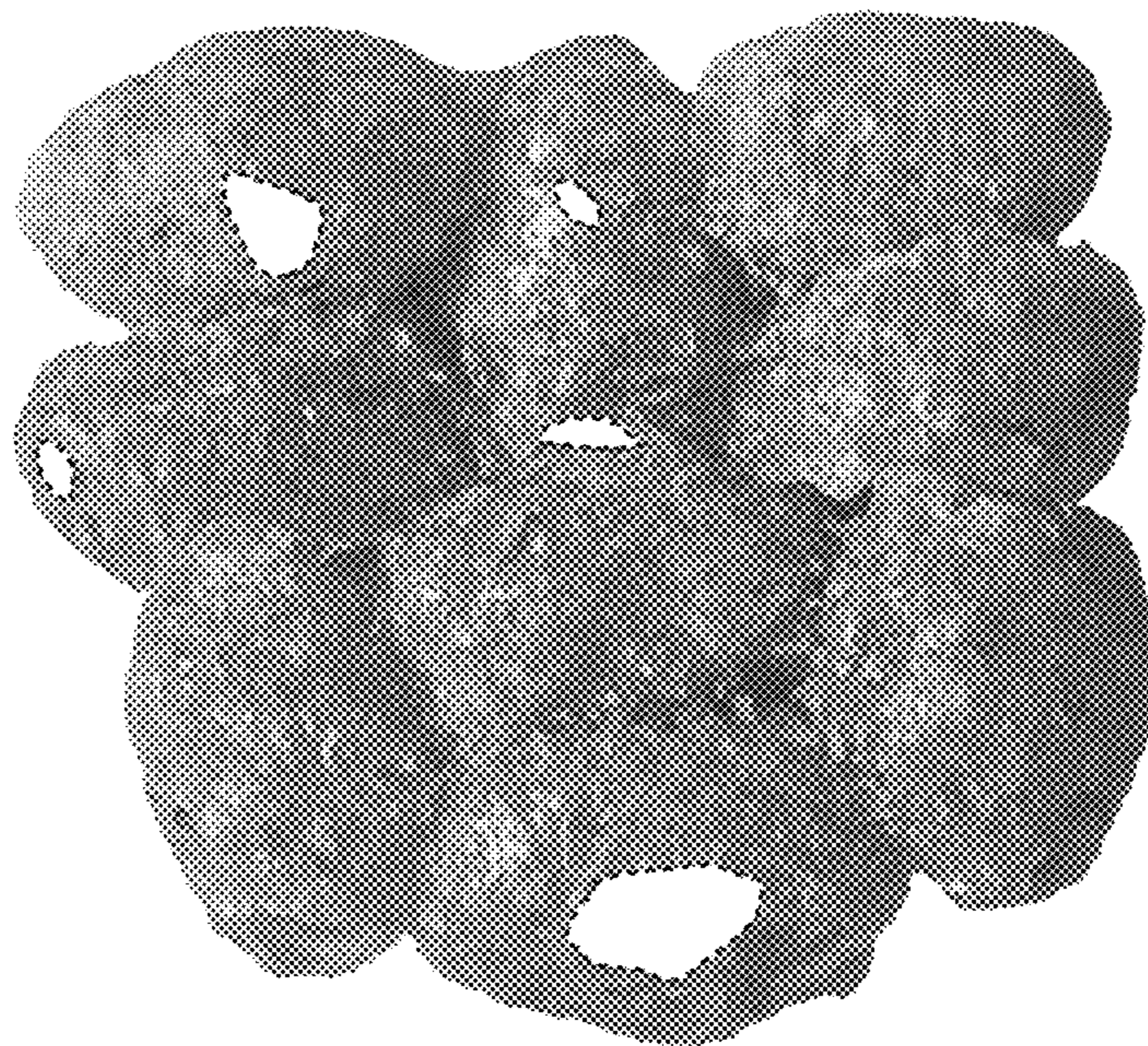

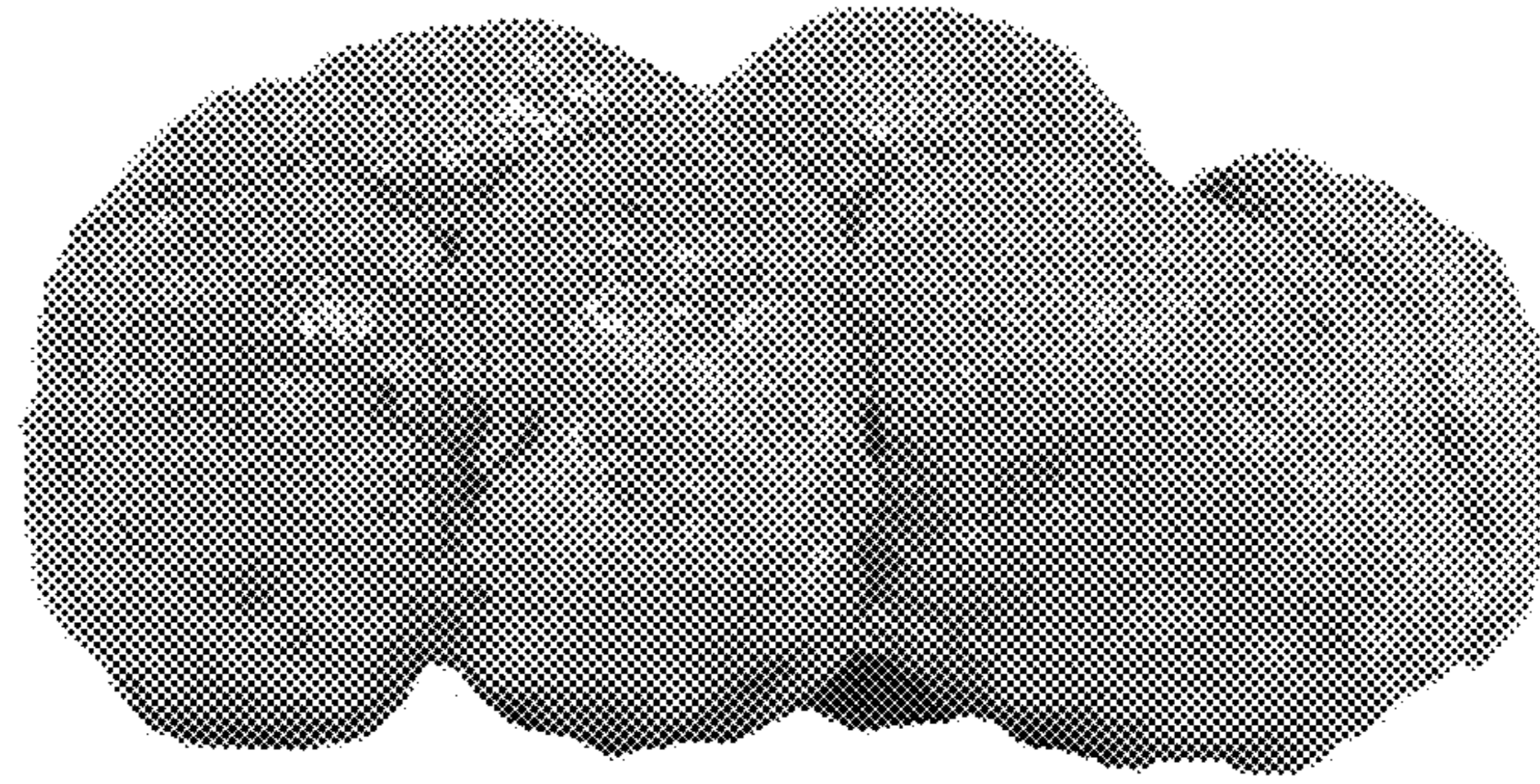

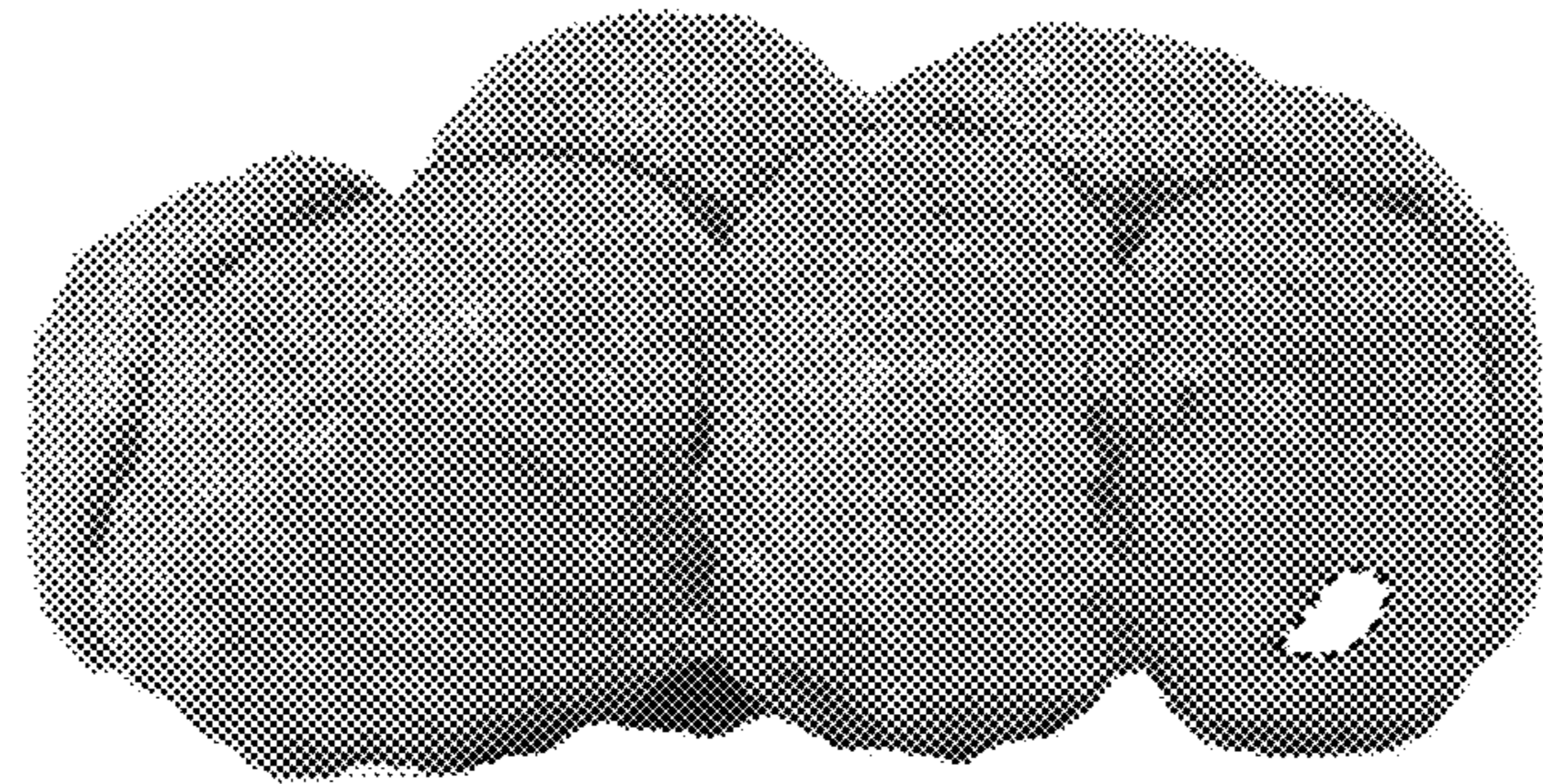

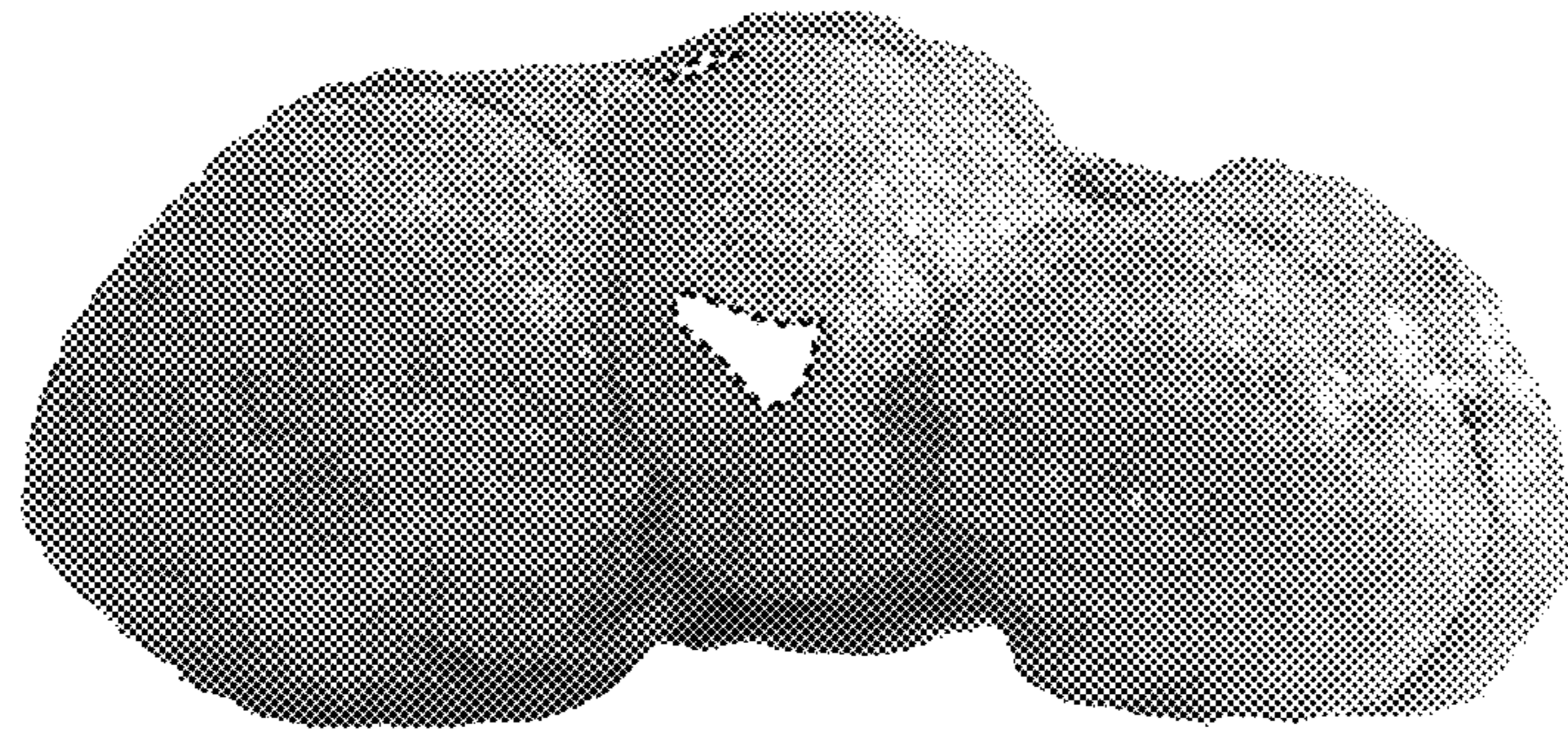
