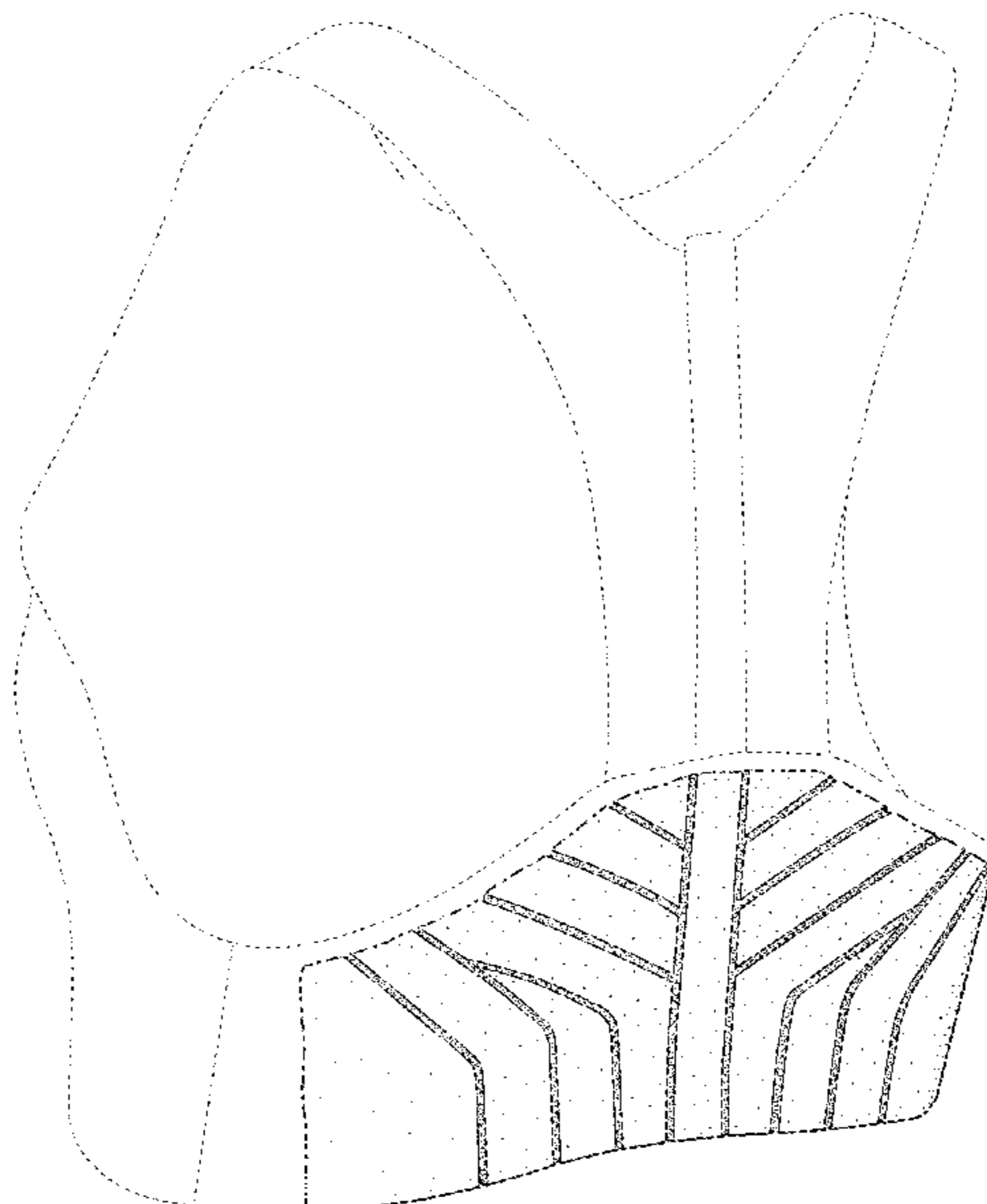
(57) **CLAIM**

We claim the ornamental design for a bra, as shown and described.

**DESCRIPTION**

FIG. 1 is a right, rear perspective view of a bra, showing our new design;  
FIG. 2 is a left, rear perspective view thereof;  
FIG. 3 is a rear view thereof;  
FIG. 4 is a left side view thereof; and,  
FIG. 5 is a right side view thereof.  
The dot-dash broken line represents an unclaimed boundary of the claimed design. The broken lines depicting the remainder of the bra show features that form no part of the claimed design.

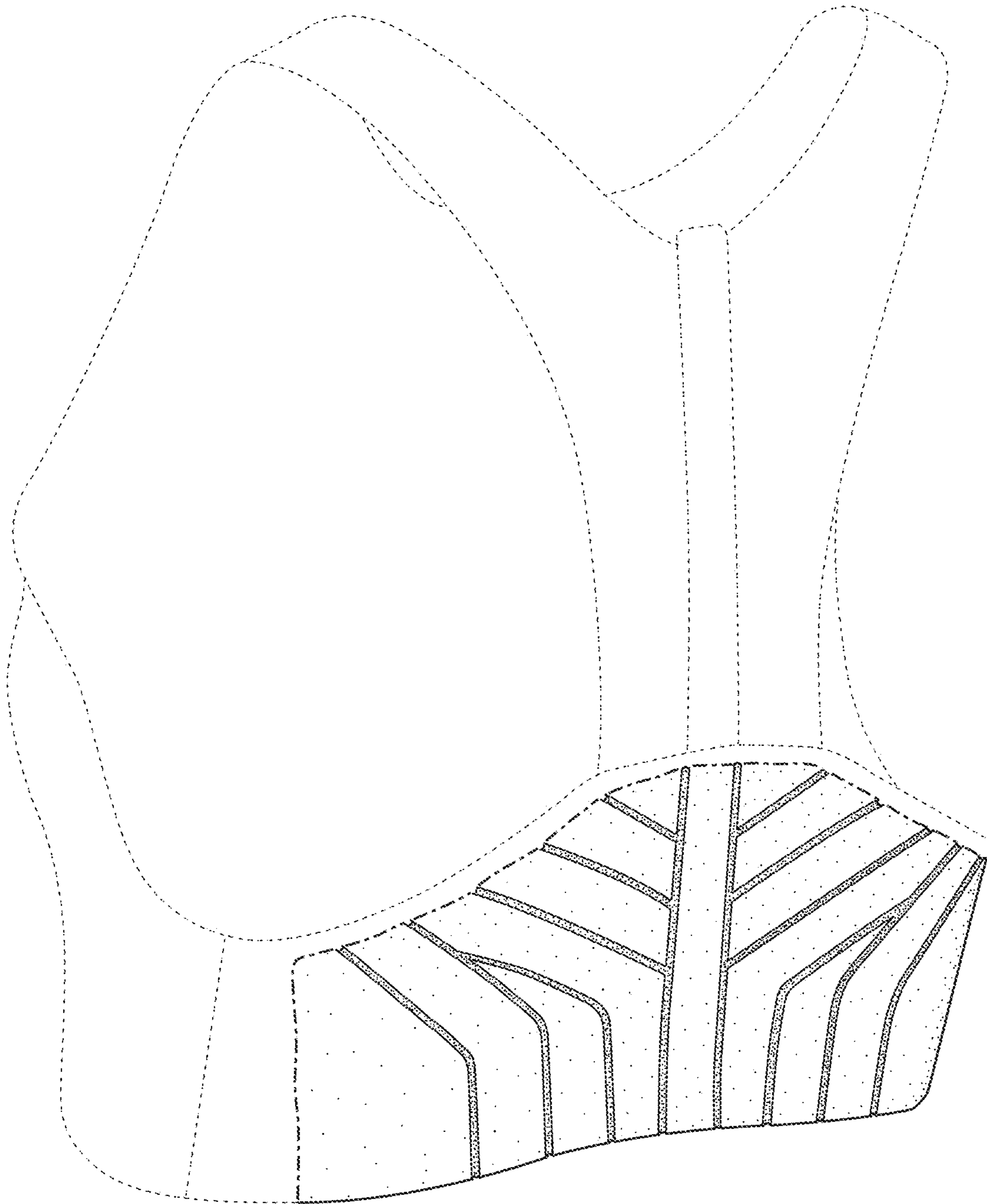

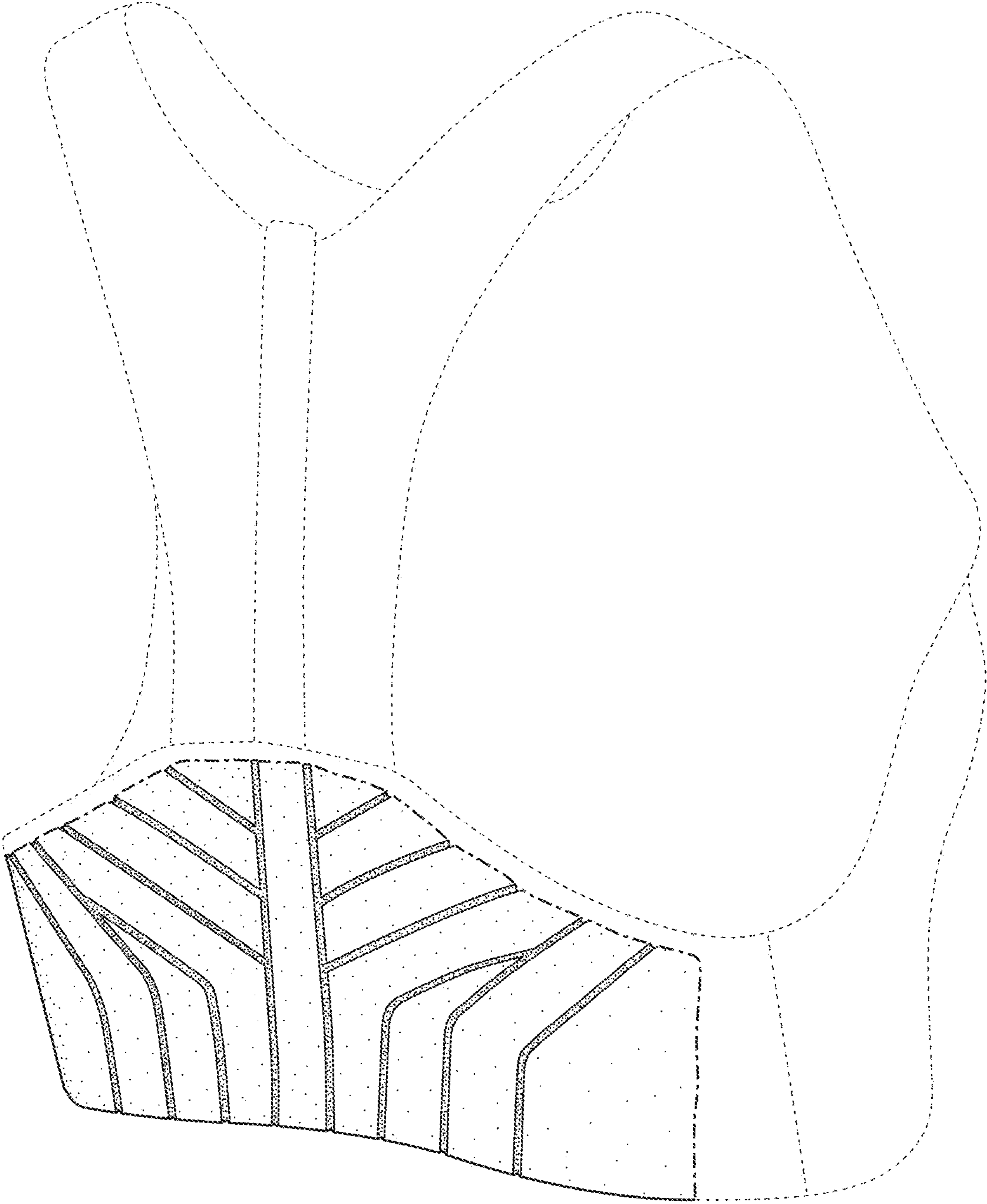

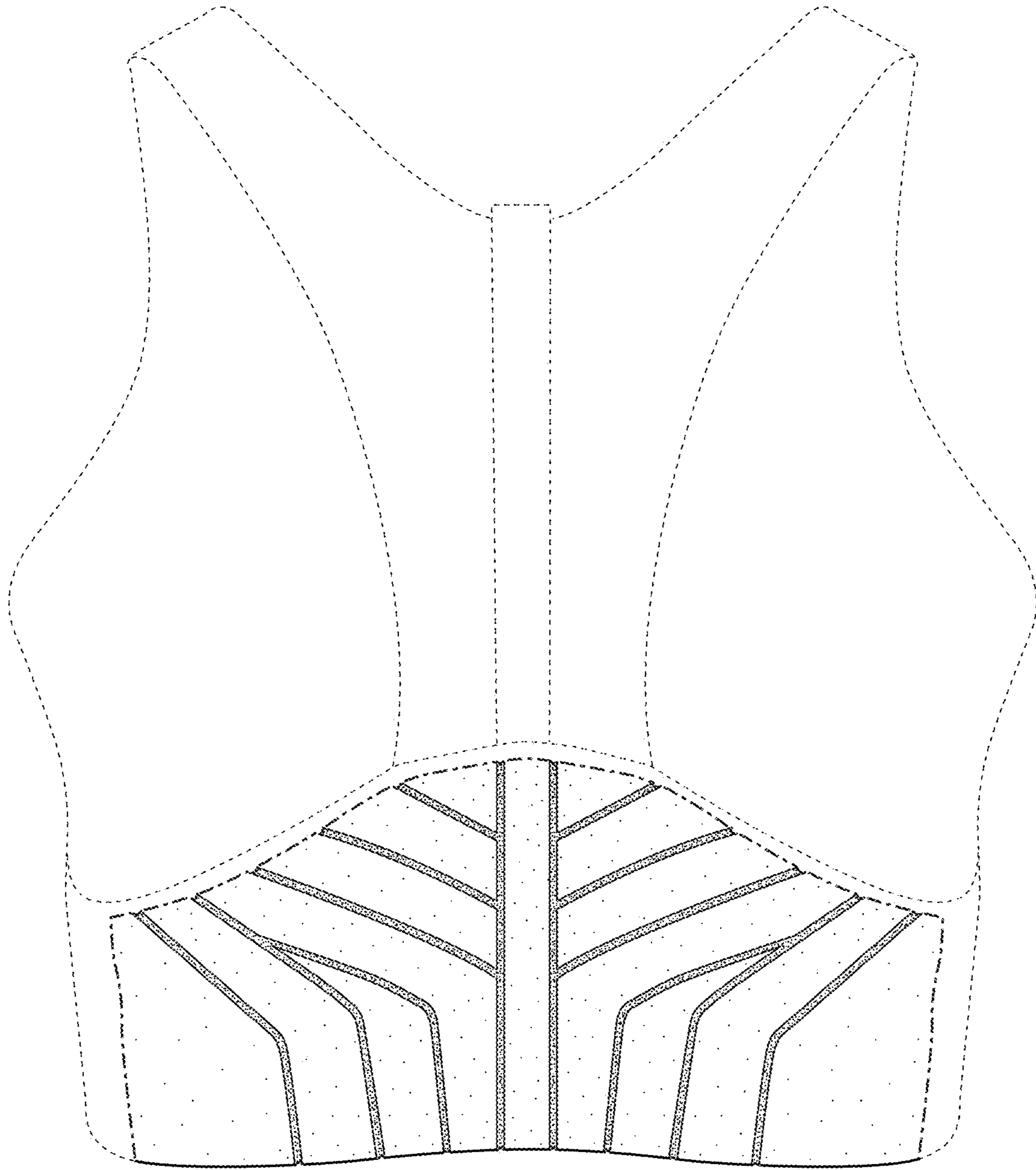

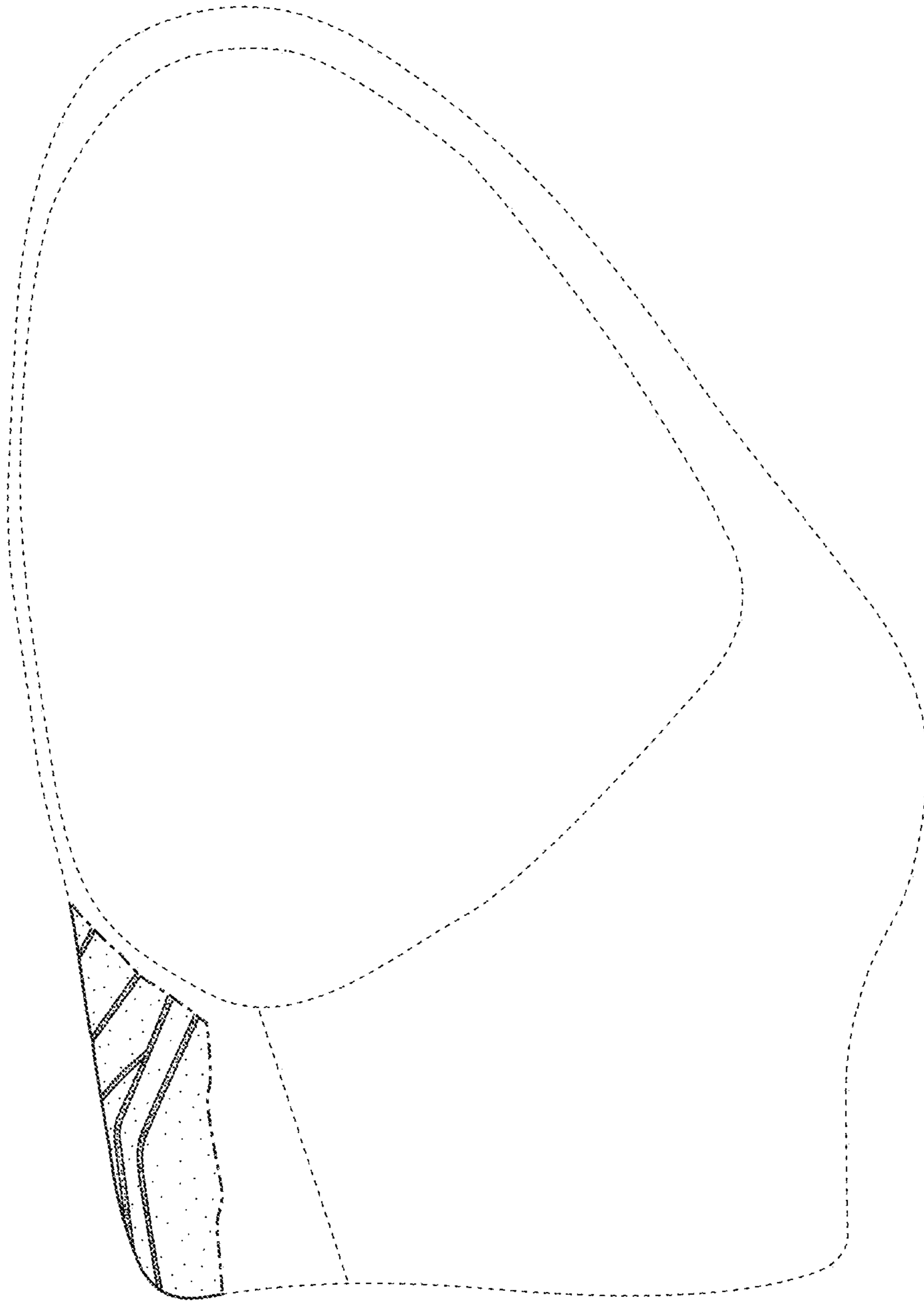

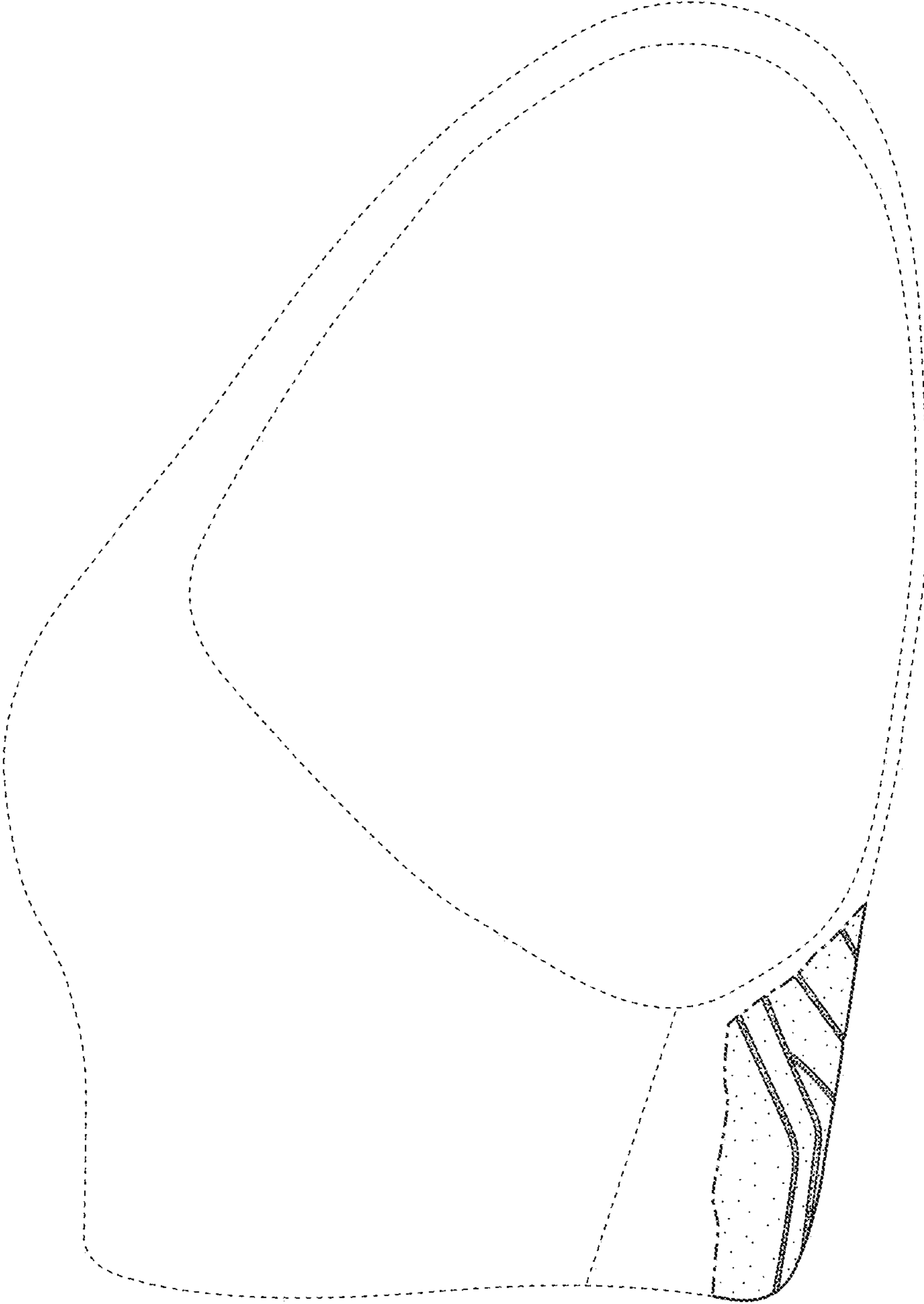
