DESCRIPTION

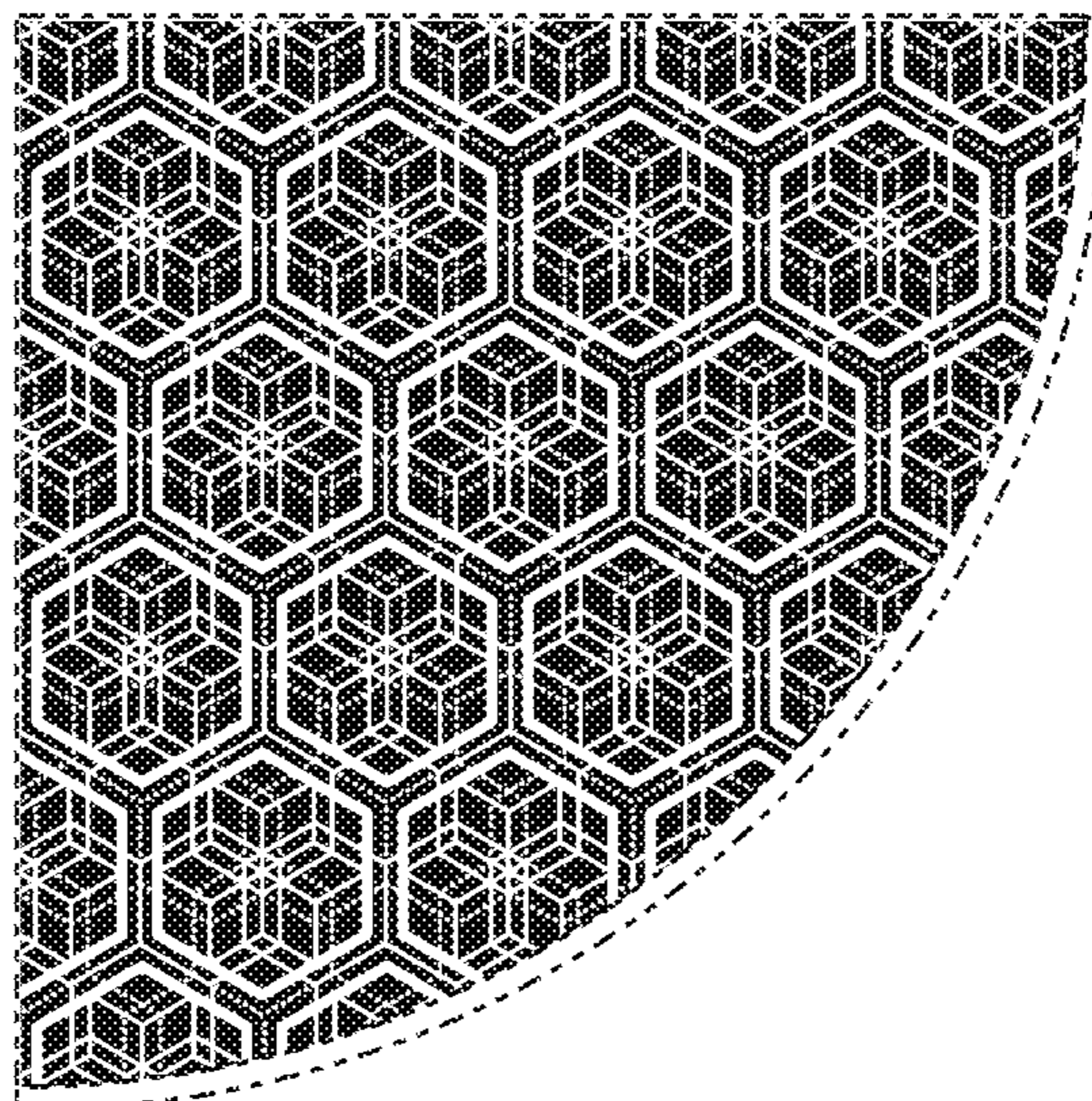

The surface ornamentation applied to the cookware is flat, thickness or depth form no part of the claimed design.

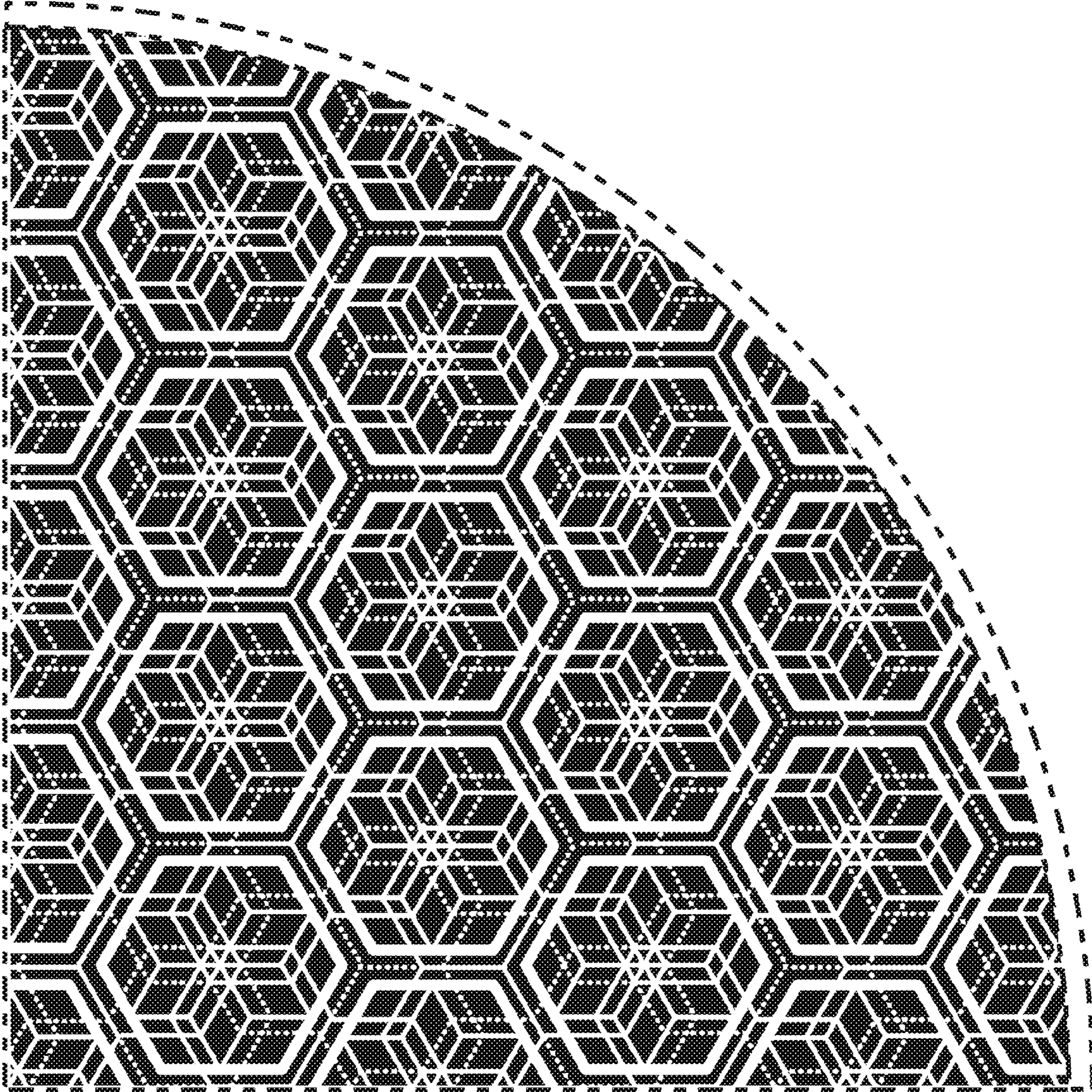

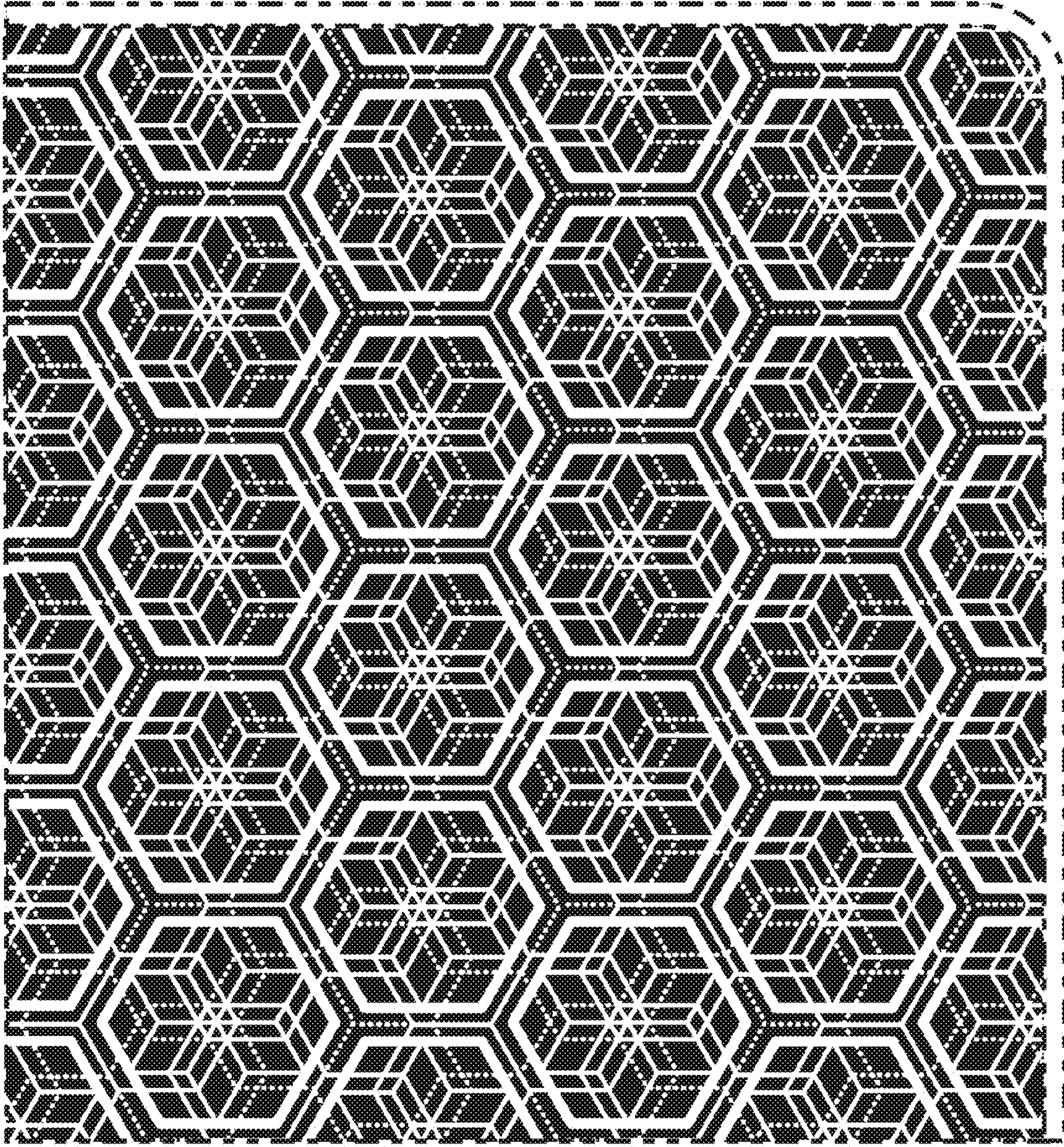
