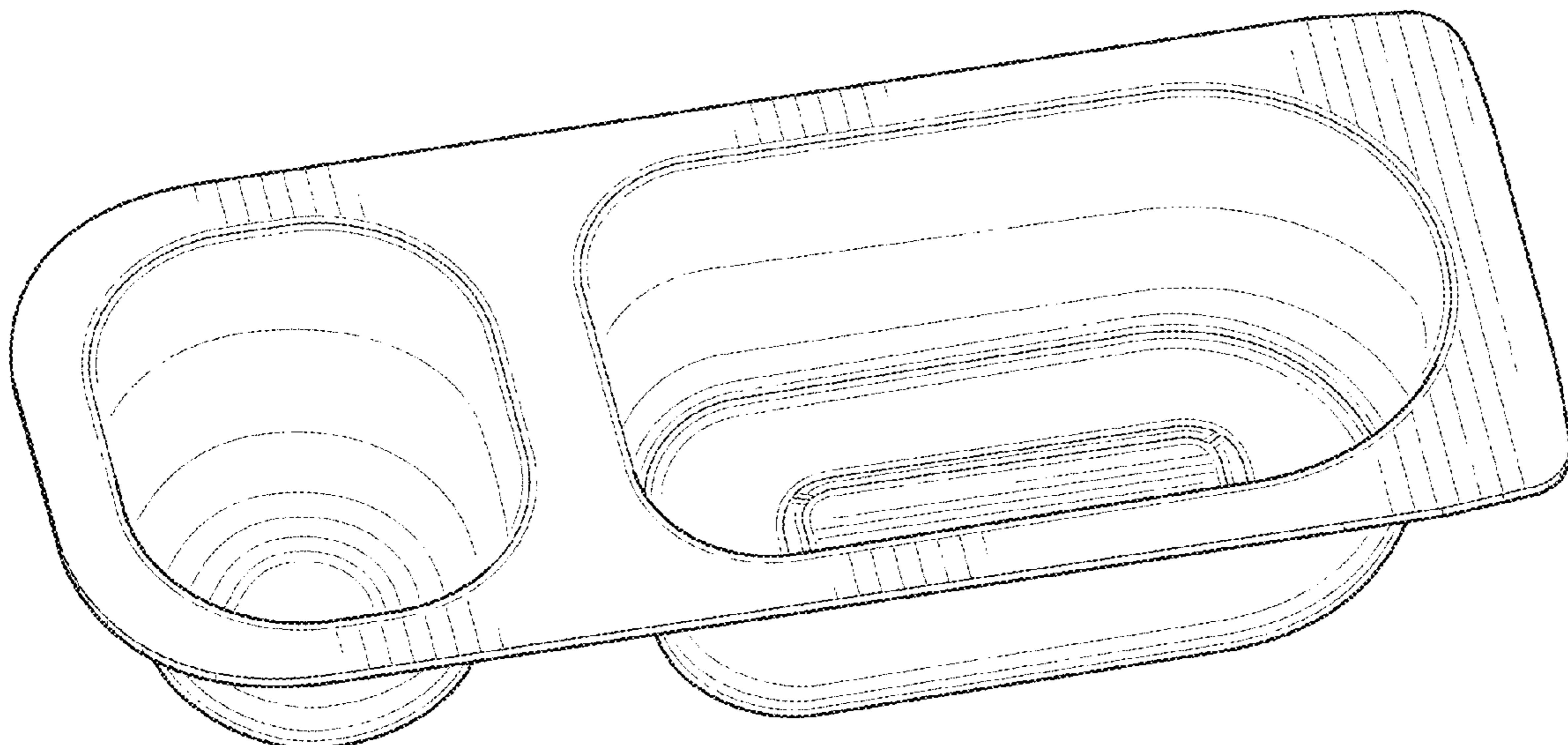
(57) **CLAIM**

DESCRIPTION

FIG. 1 is an upper right perspective view of a dual compartment food container according to our new design; FIG. 2 is a top plan view of the dual compartment food container of FIG. 1; FIG. 3 is a bottom plan view thereof; FIG. 4 is a left side view thereof; FIG. 5 is a right side view of the dual compartment food container; FIG. 6 a rear elevational view thereof; and, FIG. 7 is a front elevational view thereof.

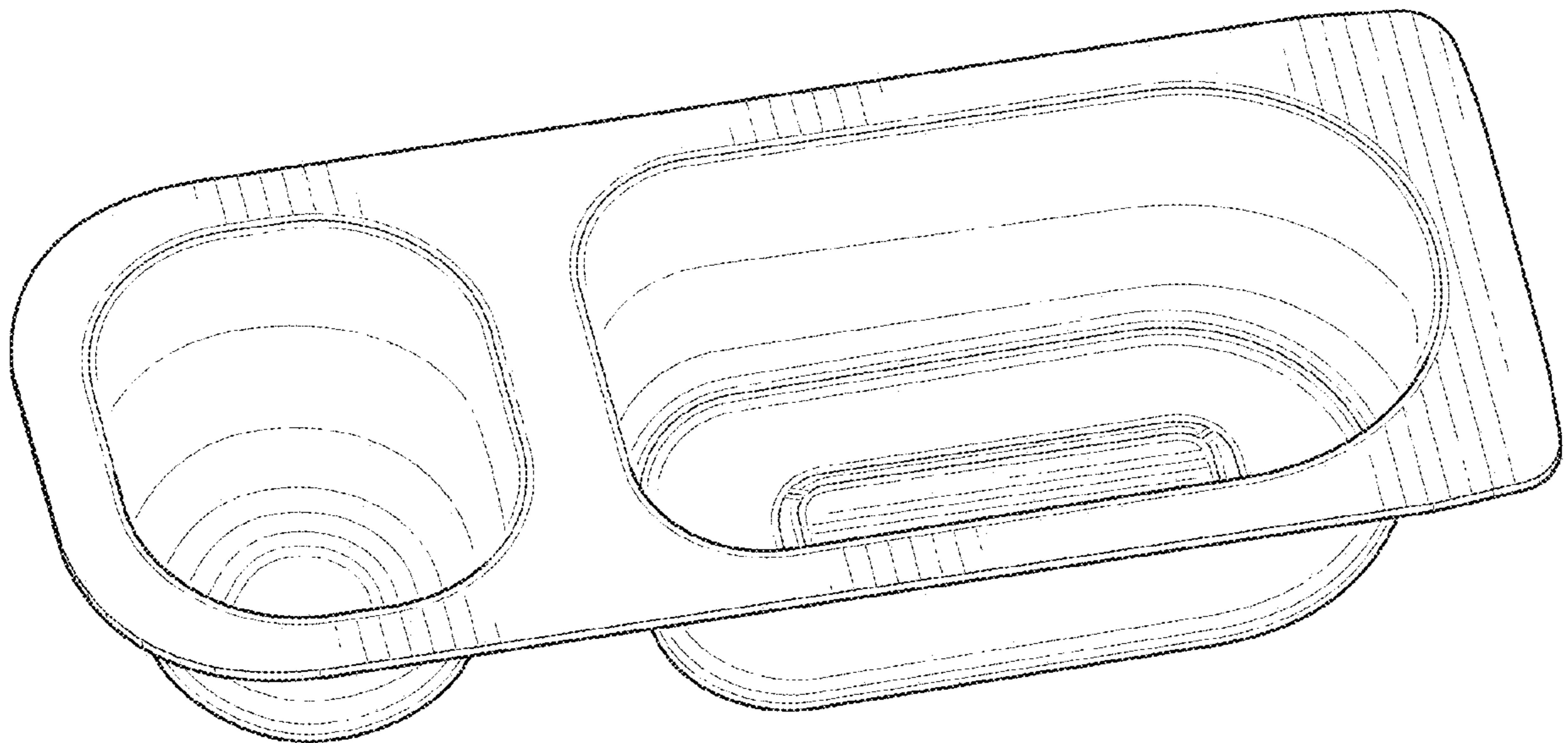

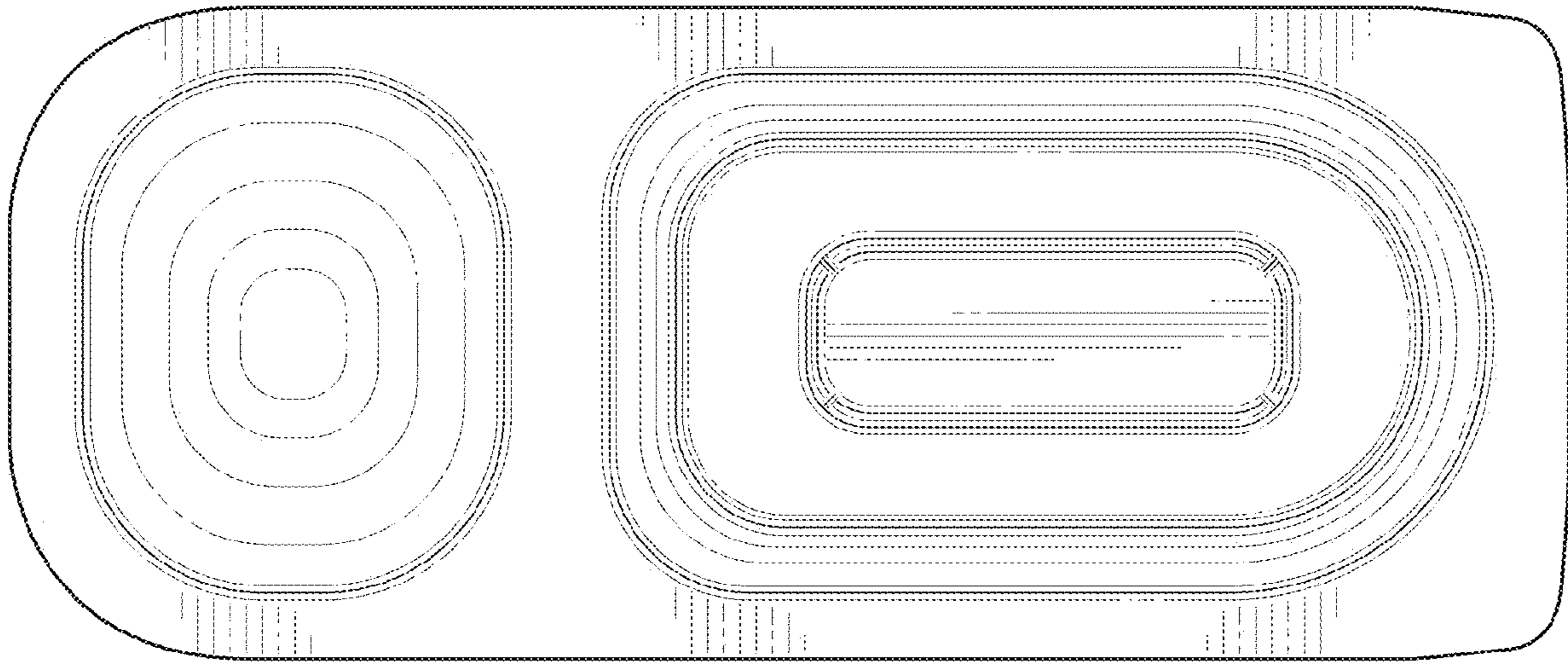

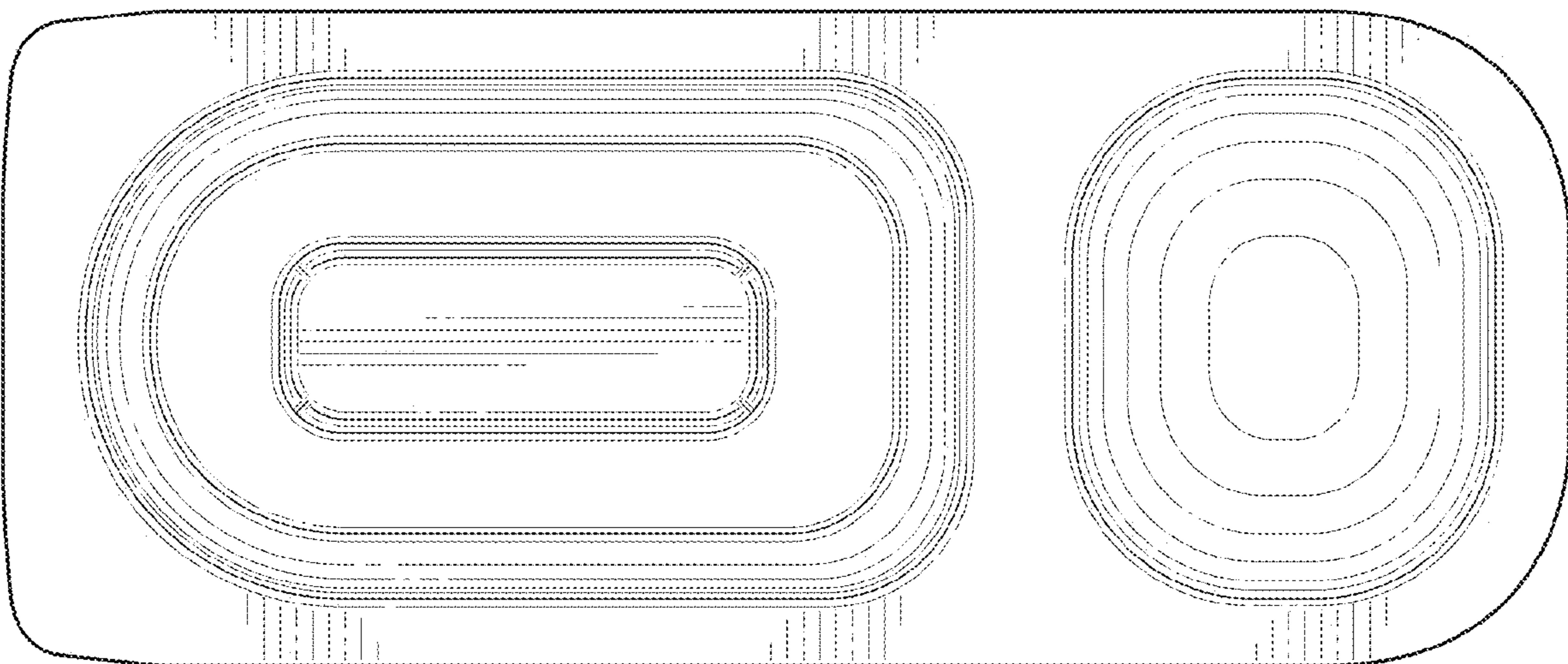

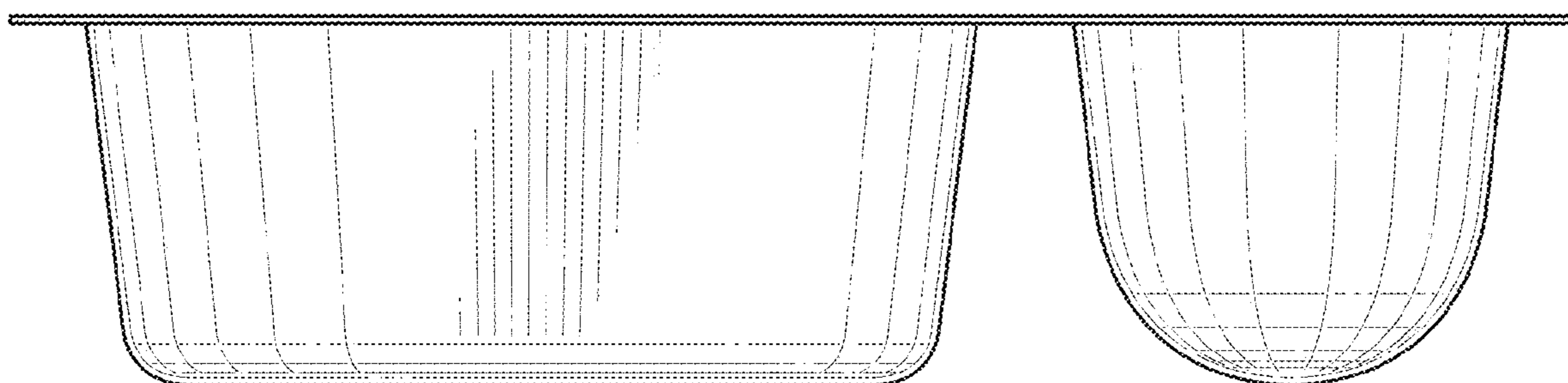

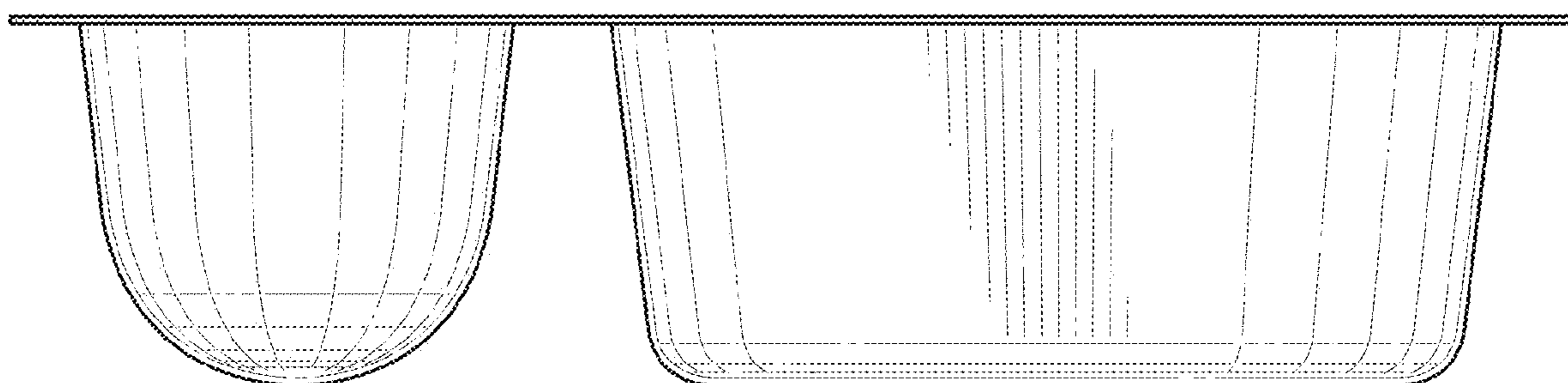

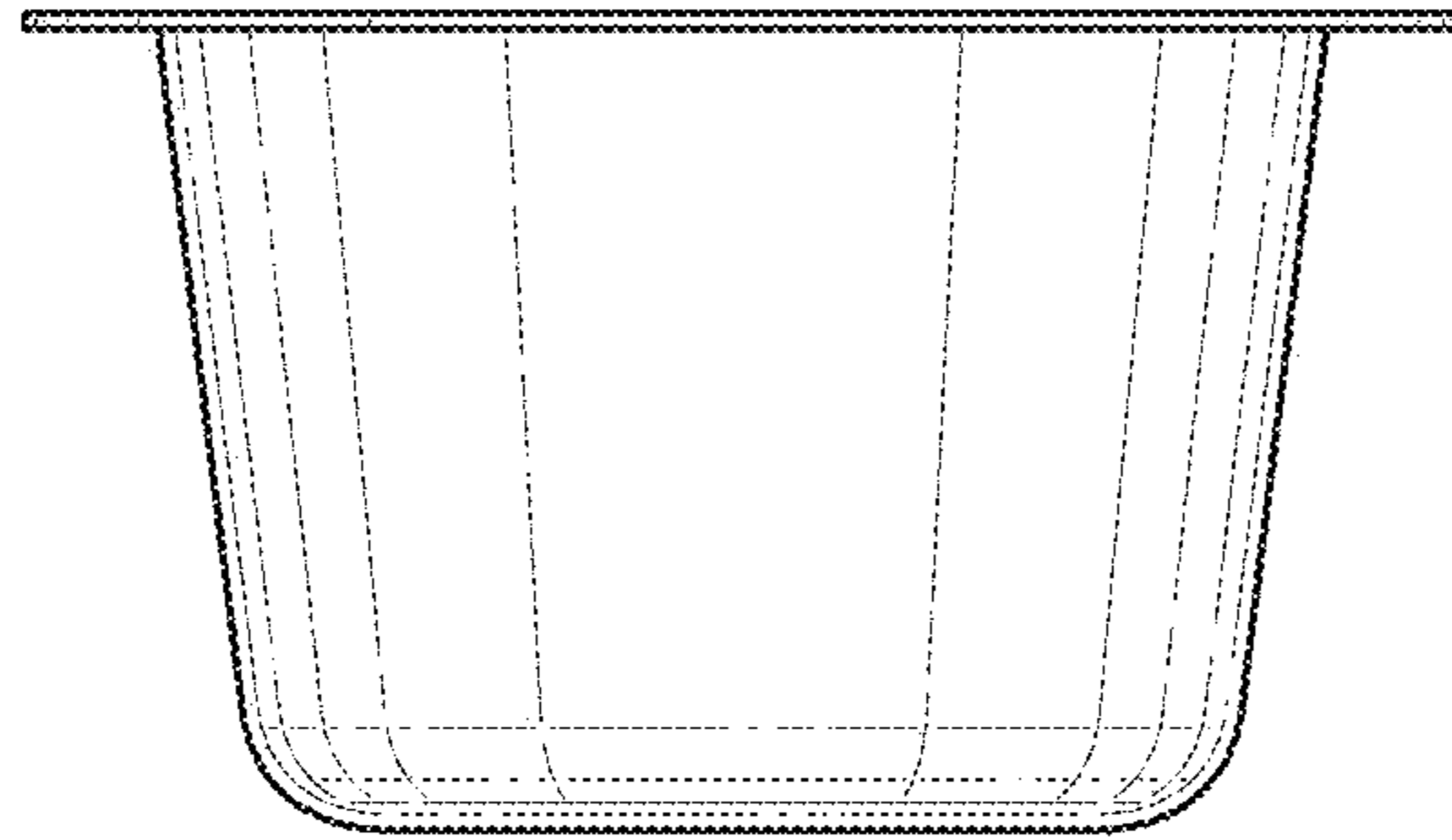

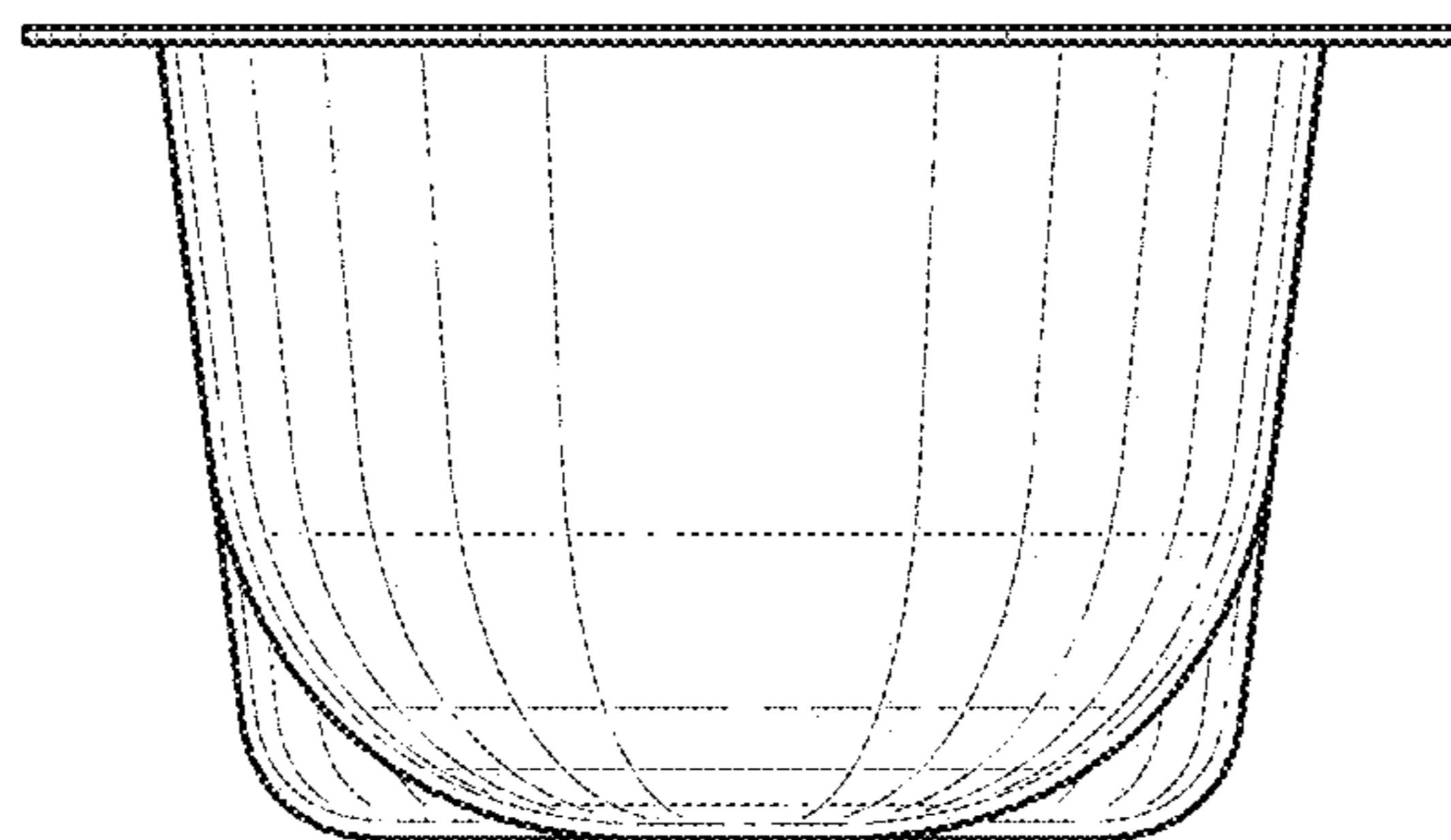
