FIG. 7 is a bottom view thereof.

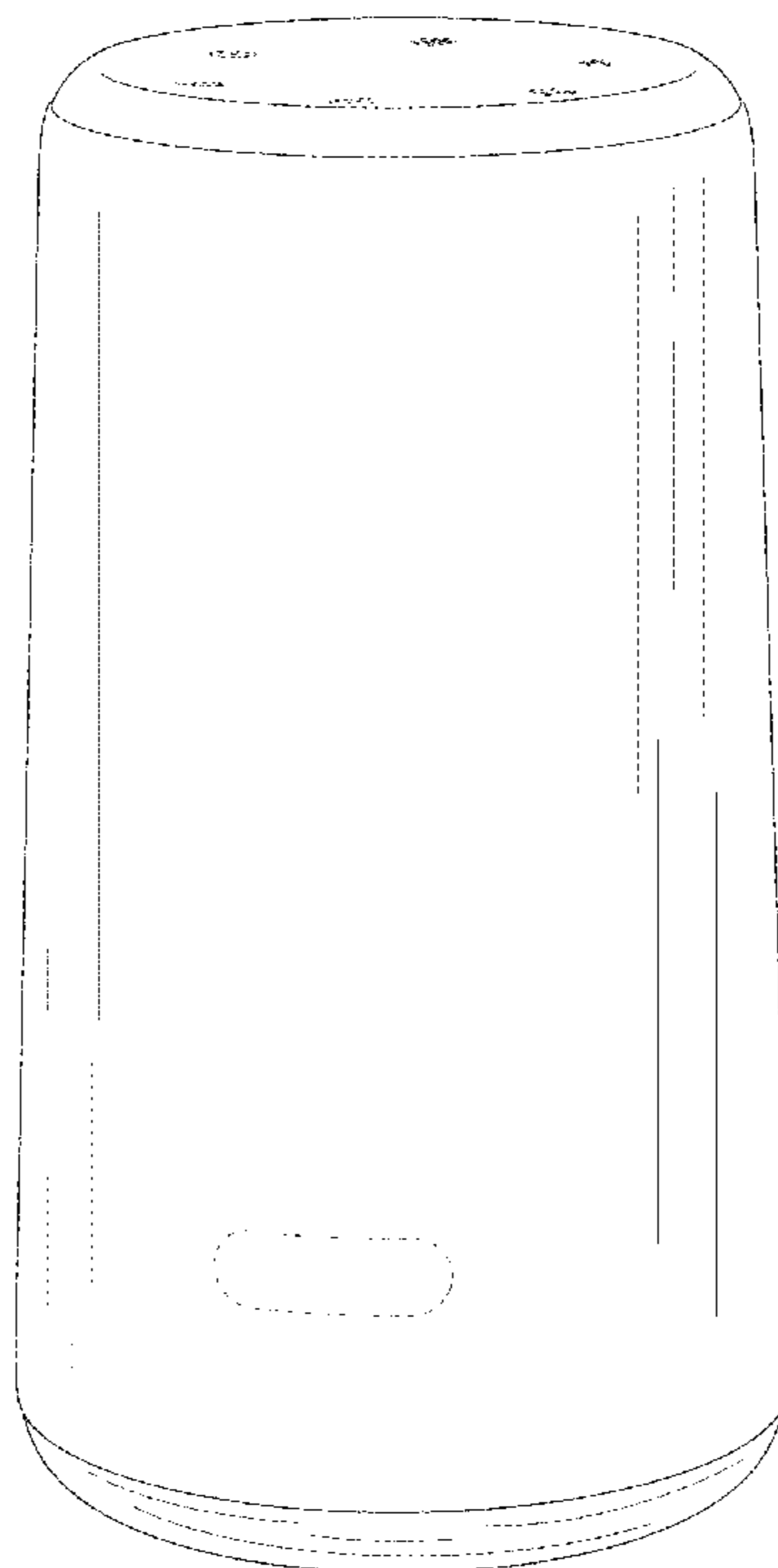
The broken lines in the drawings illustrate the portions of the speaker, which form no part of the claimed design.

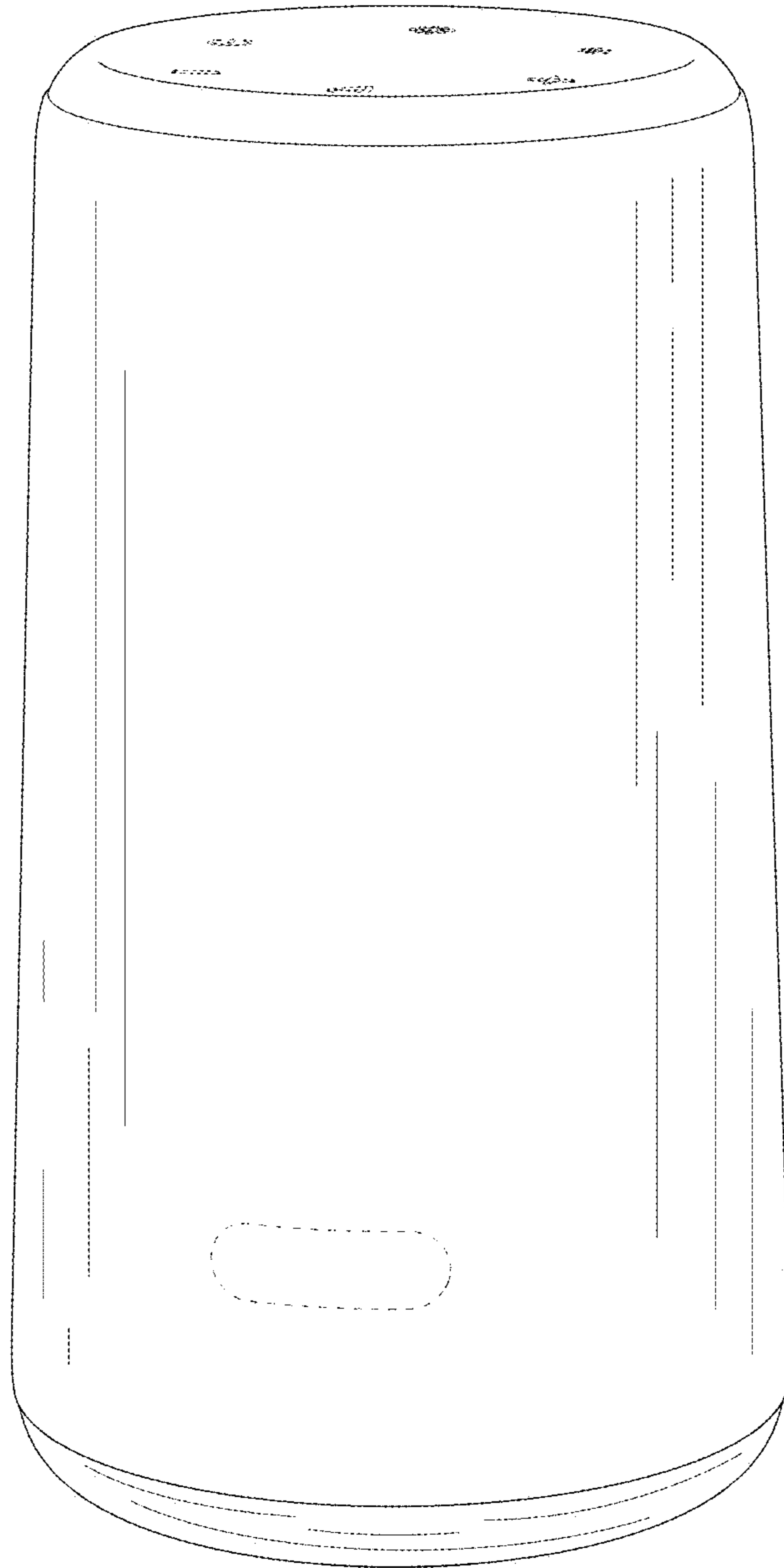

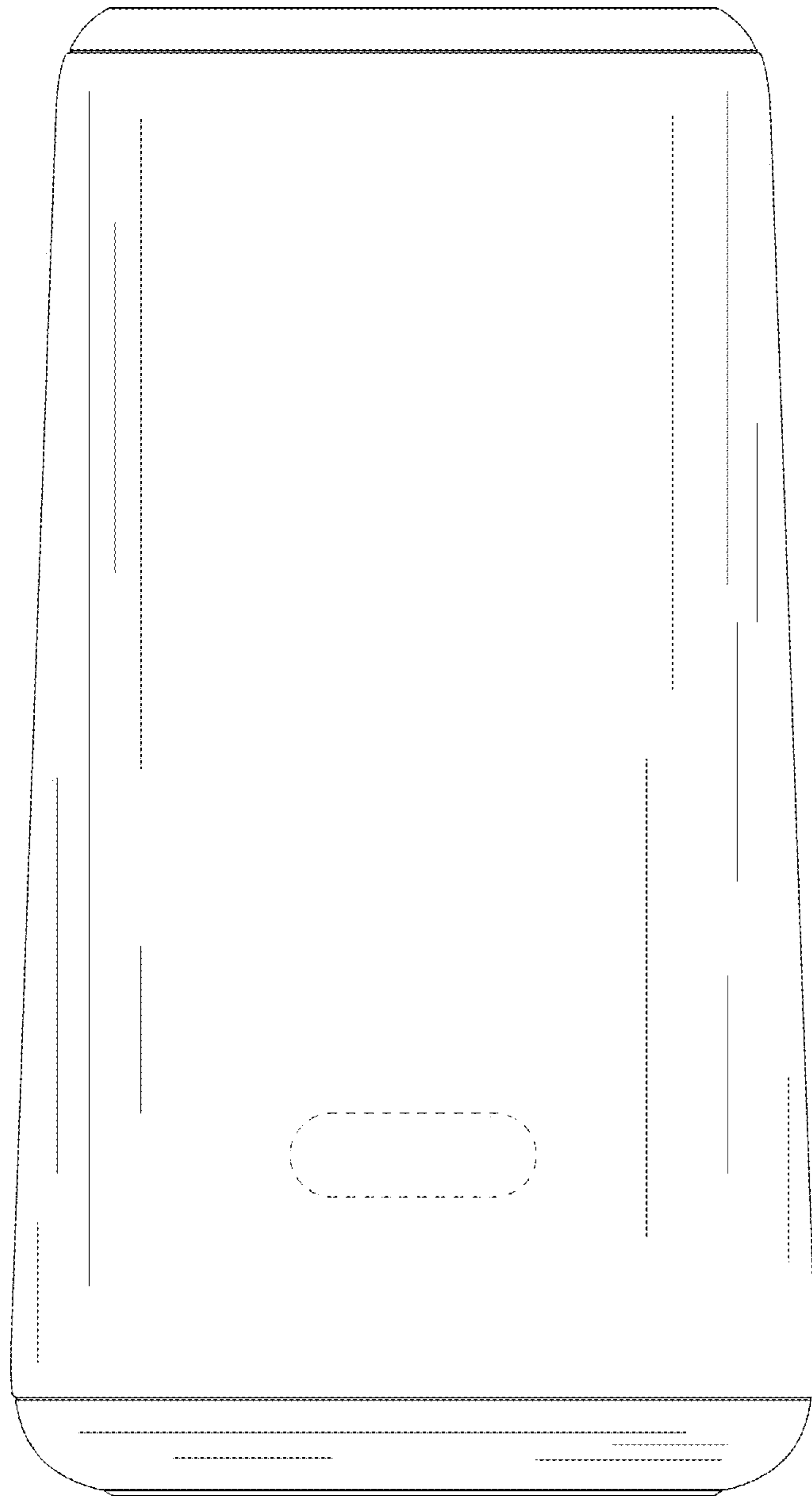

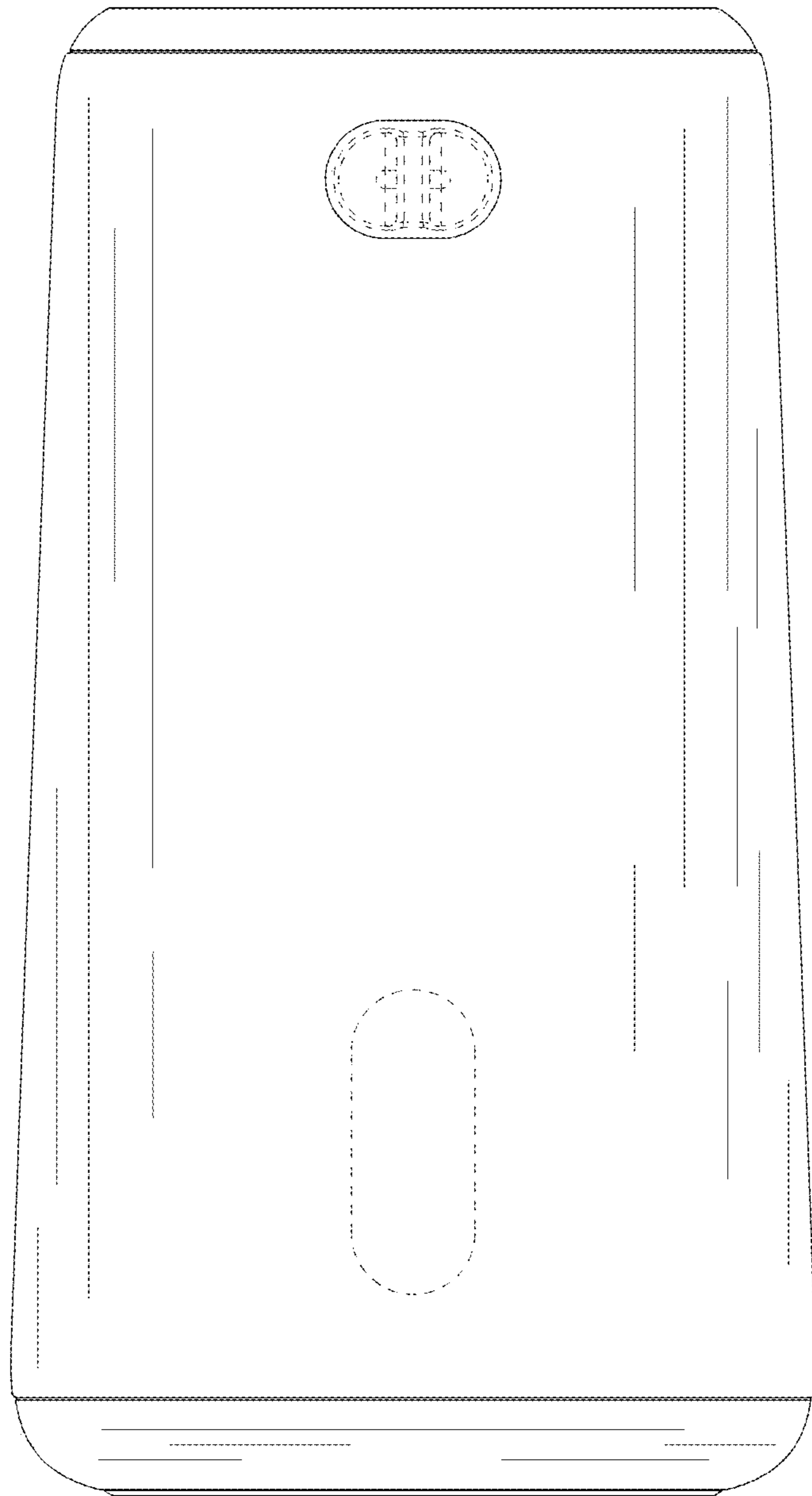

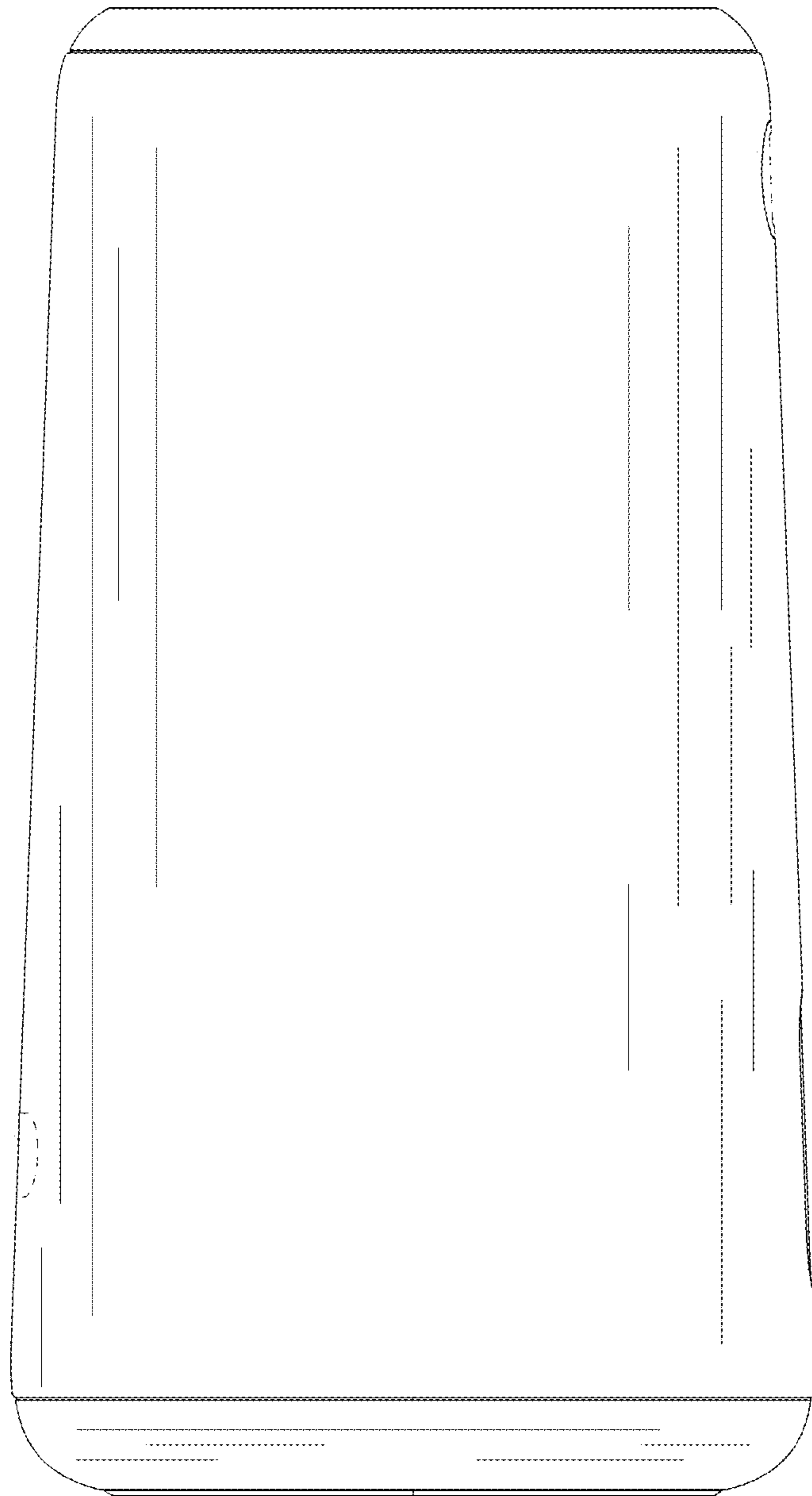

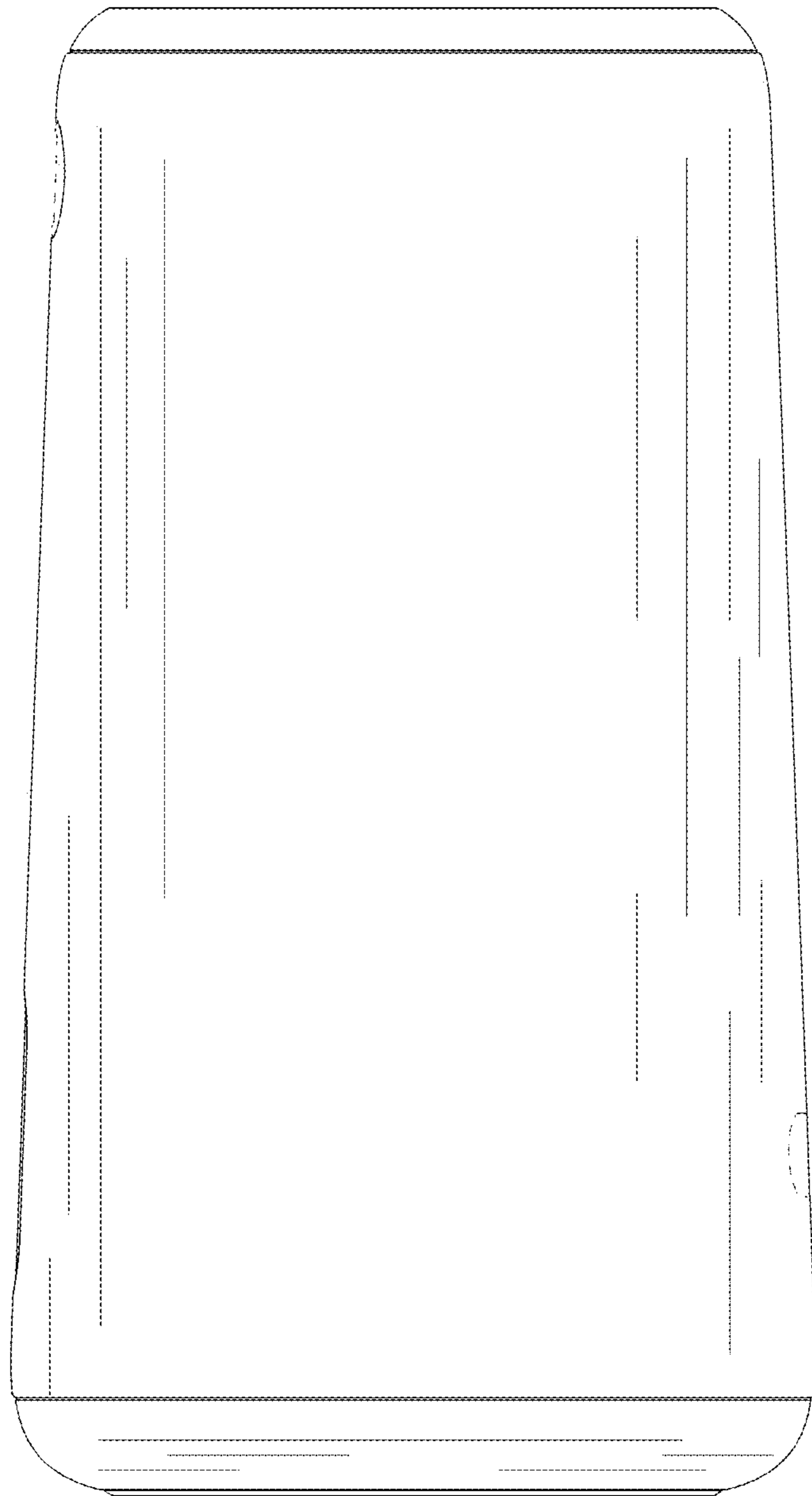

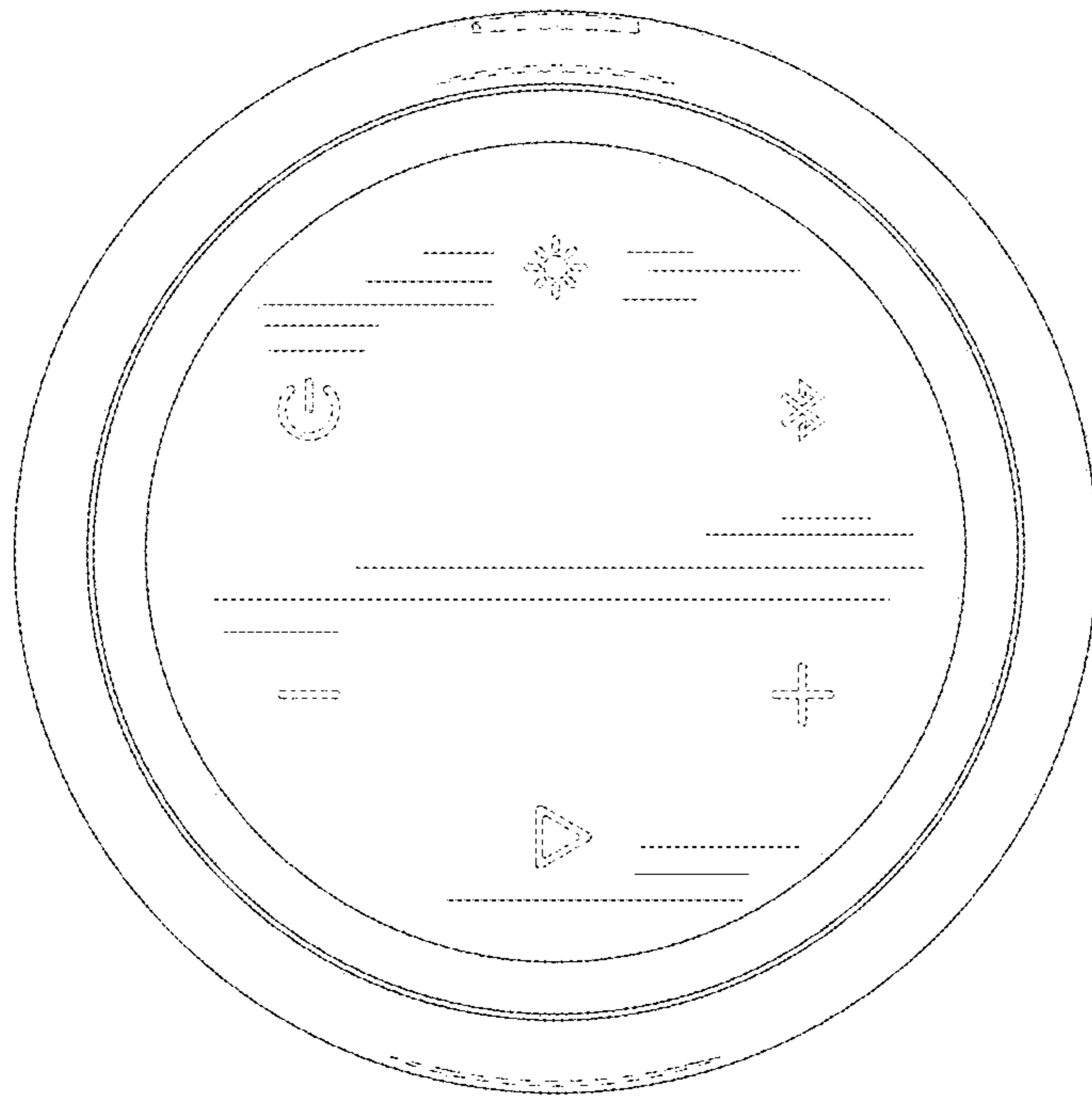

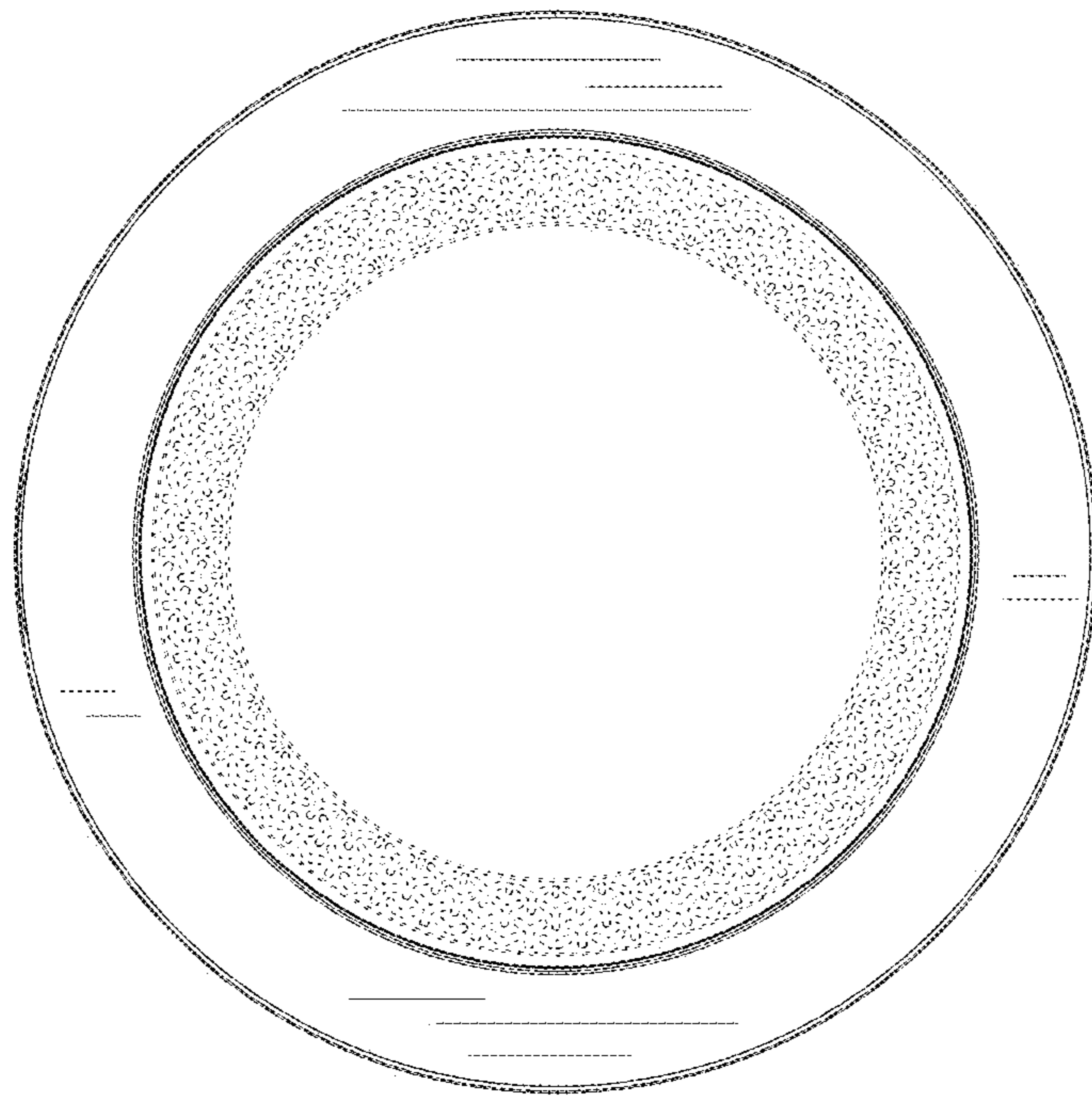
