DESCRIPTION

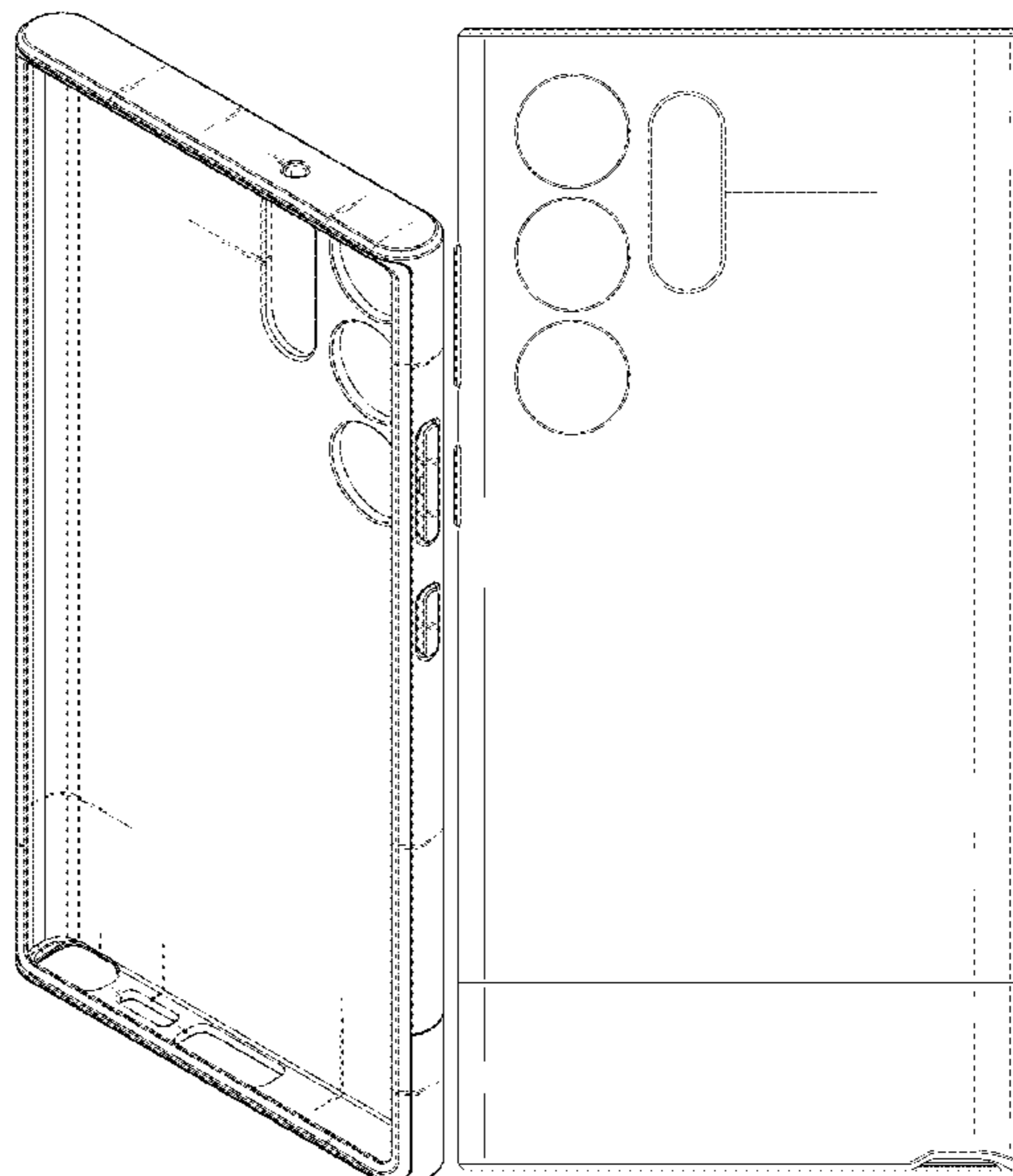
FIG. 1 is a front, top, and right side perspective view of a cover for electronic communications device, showing my new design;

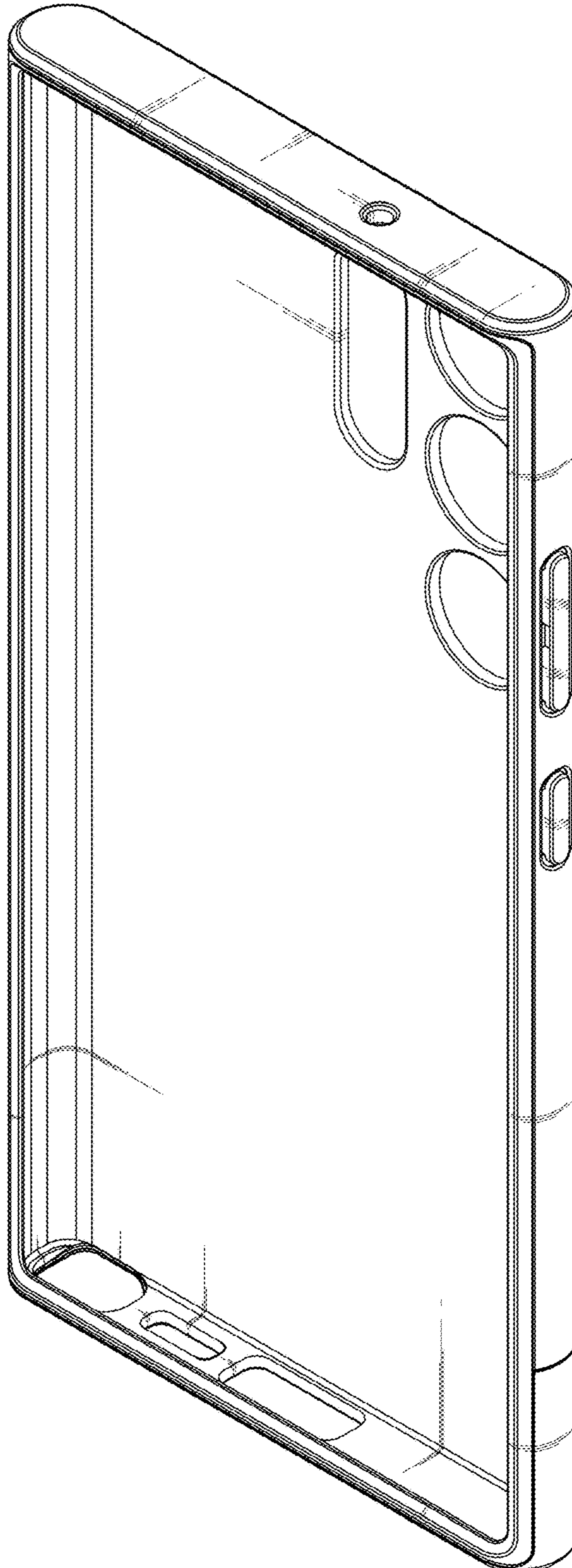

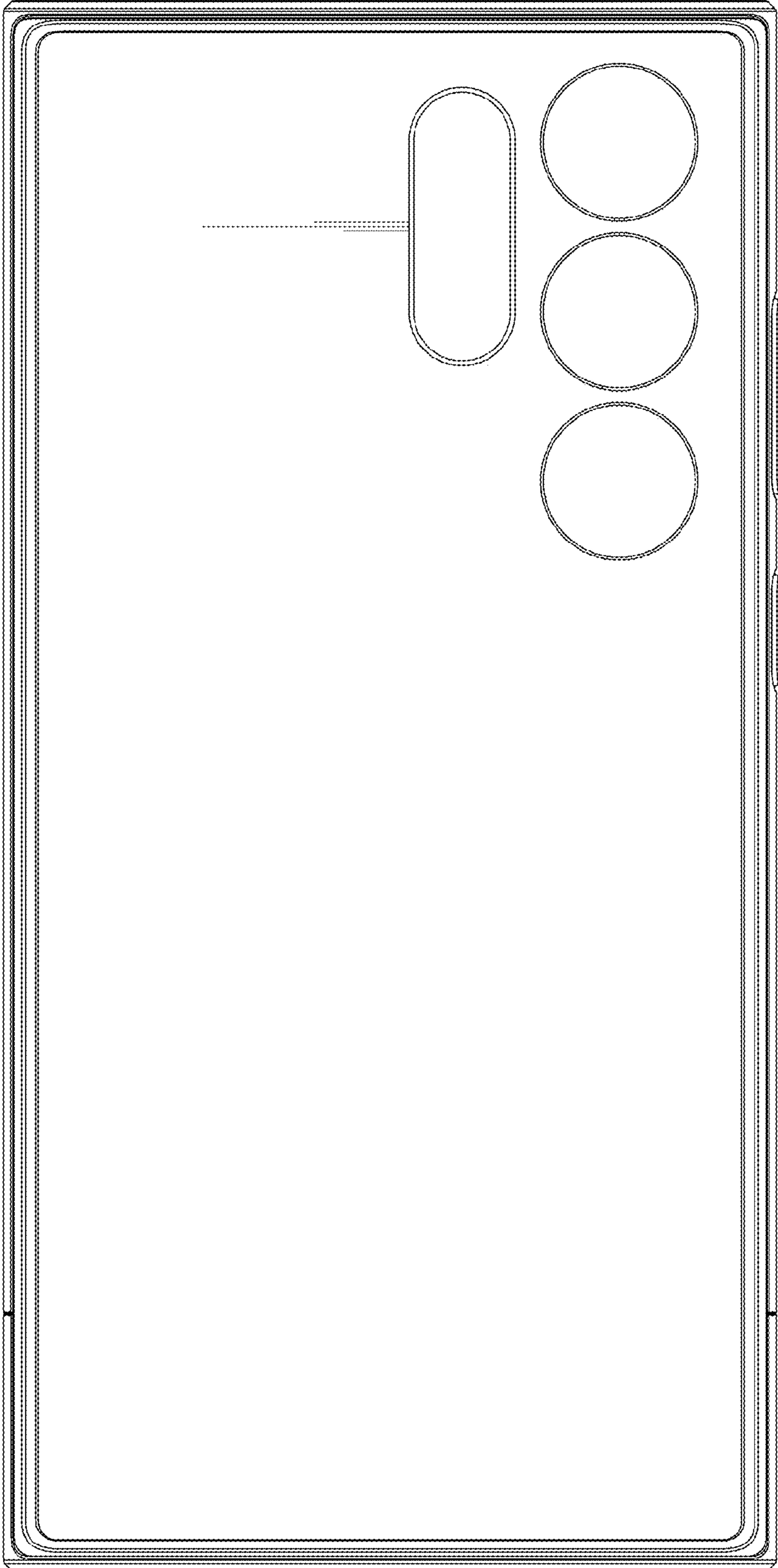

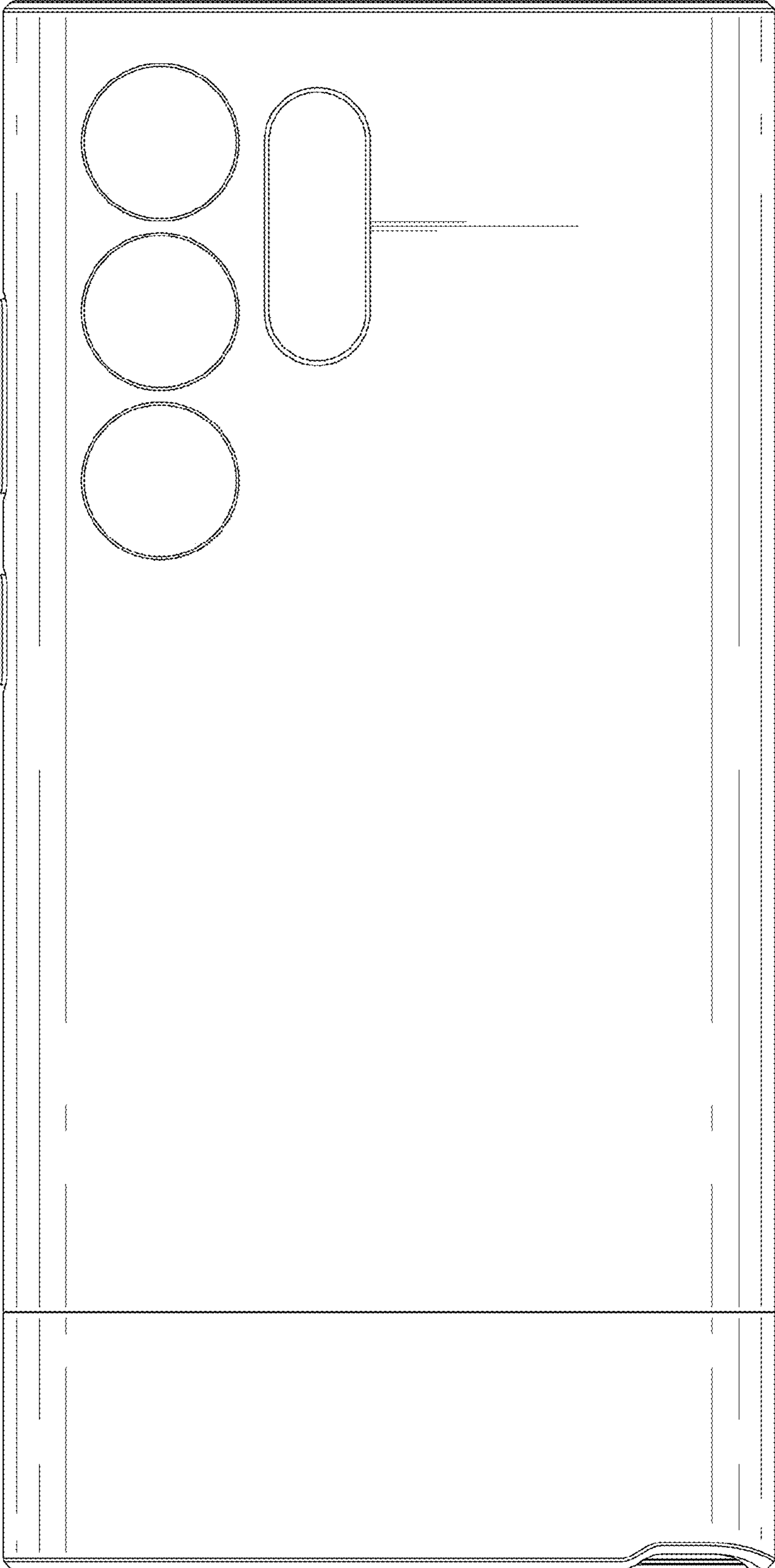

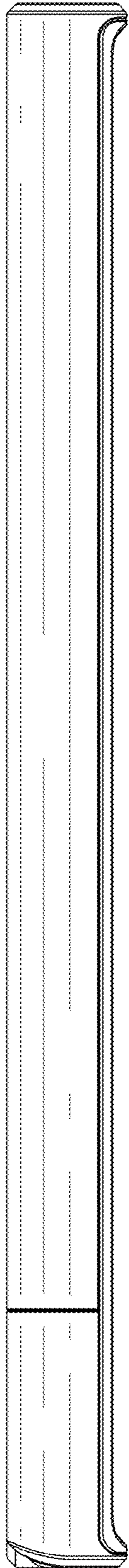

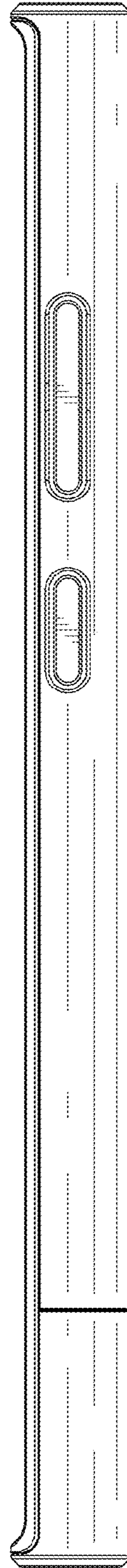

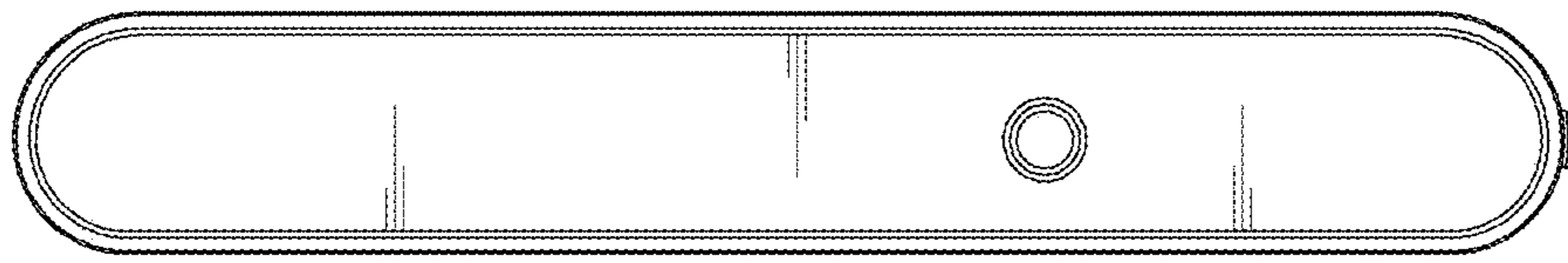
