The ornamental design for a display screen or portion thereof with animated graphical user interface, as shown and described.

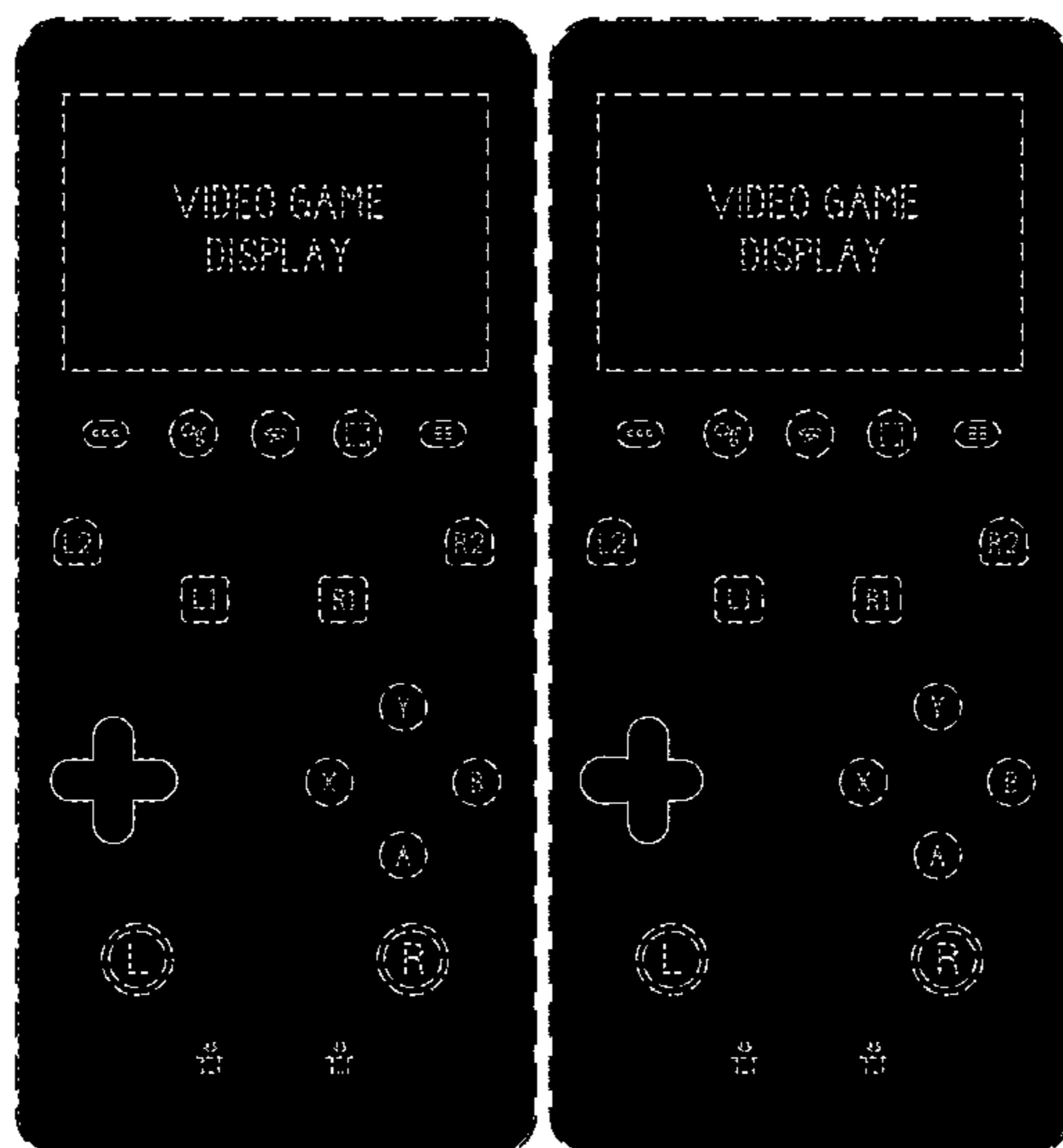
DESCRIPTION

FIG. 1 is a front view of showing a first image in a sequence of a first embodiment according to the claimed design; FIG. 2 is a front view of a second image in the sequence thereof; FIG. 3 is a front view of a third image in the sequence thereof; FIG. 4 is a front view of a fourth image in the sequence thereof; FIG. 5 is a front view of a fifth image in the sequence thereof; FIG. 6 is a front view of showing a first image in a sequence of a second embodiment according to the claimed design; FIG. 7 is a front view of a second image in the sequence thereof; FIG. 8 is a front view of a third image in the sequence thereof; FIG. 9 is a front view of a fourth image in the sequence thereof; FIG. 10 is a front view of a fifth image in the sequence thereof; FIG. 11 is a front view of showing a first image in a sequence of a third embodiment according to the claimed design; FIG. 12 is a front view of a second image in the sequence thereof; FIG. 13 is a front view of a third image in the sequence thereof; FIG. 14 is a front view of a fourth image in the sequence thereof; and, FIG. 15 is a front view of a fifth image in the sequence thereof.

The appearance of the transition is sequential from FIG. 1 to FIG. 5 in the first embodiment, from FIG. 6 to FIG. 10 in the second embodiment, and from FIG. 11 to FIG. 15 in the third embodiment. The process or period in which an image transitions to another image forms no part of the claimed design.

The broken line showing a display screen, and all other broken lines showing portions of the graphical user interface illustrate portions of the article. None of the aforementioned broken line subject matter forms part of the claimed design.

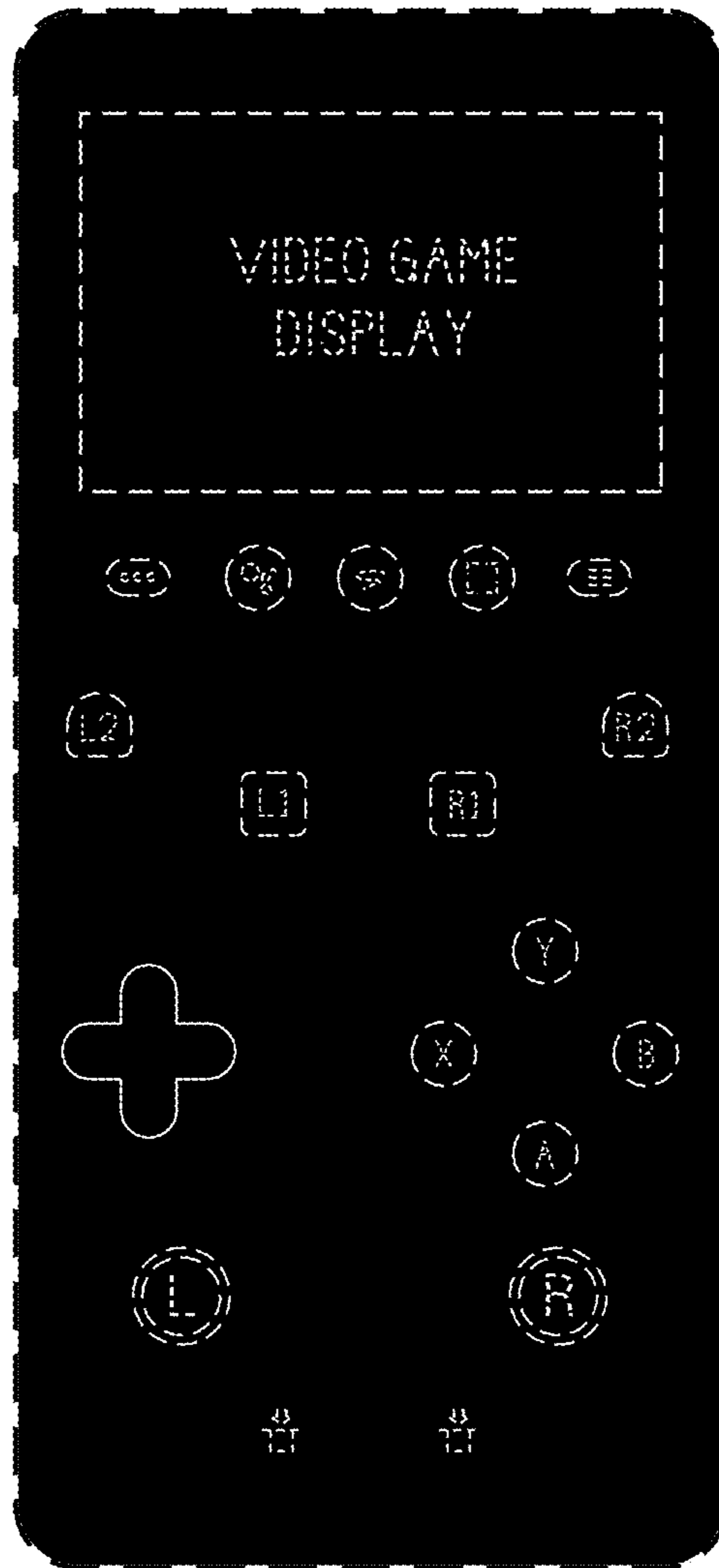

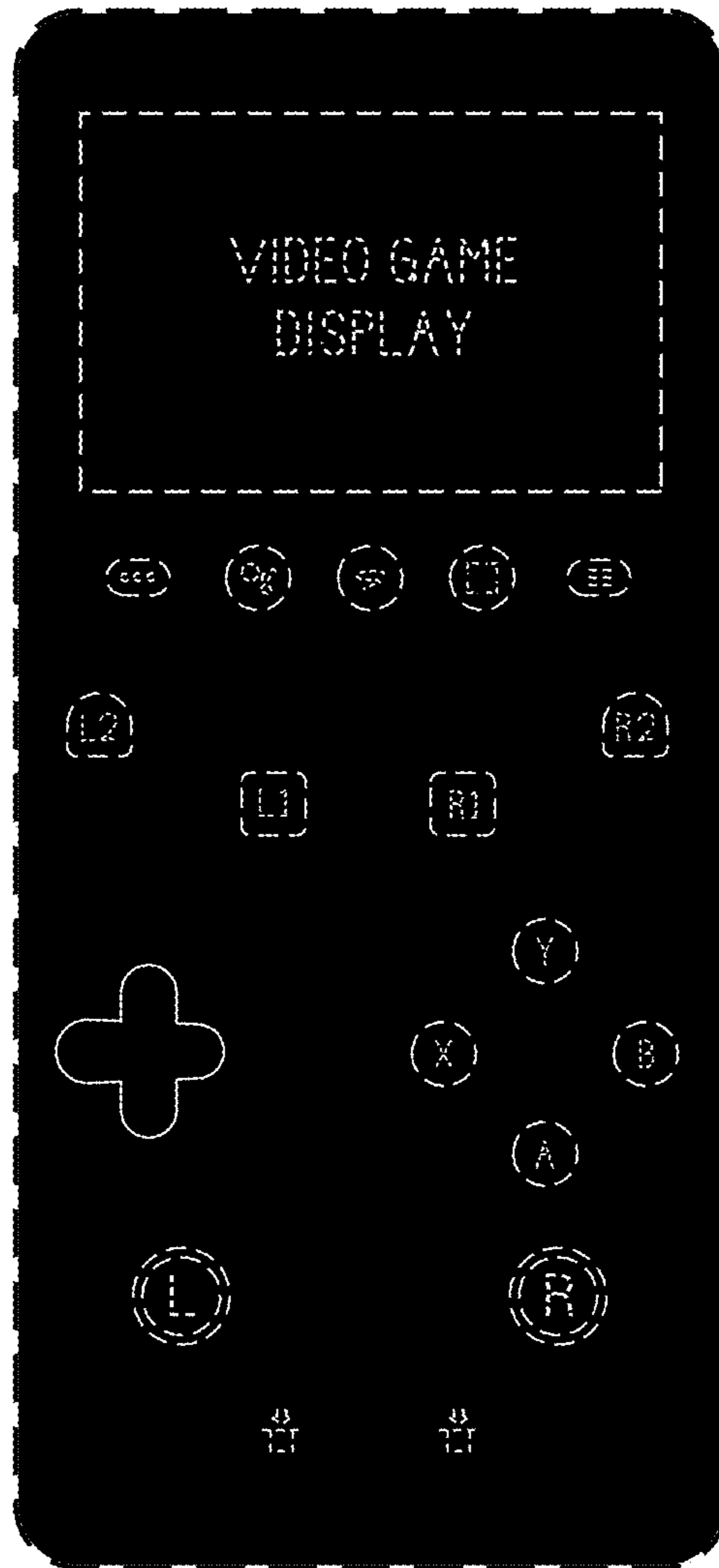

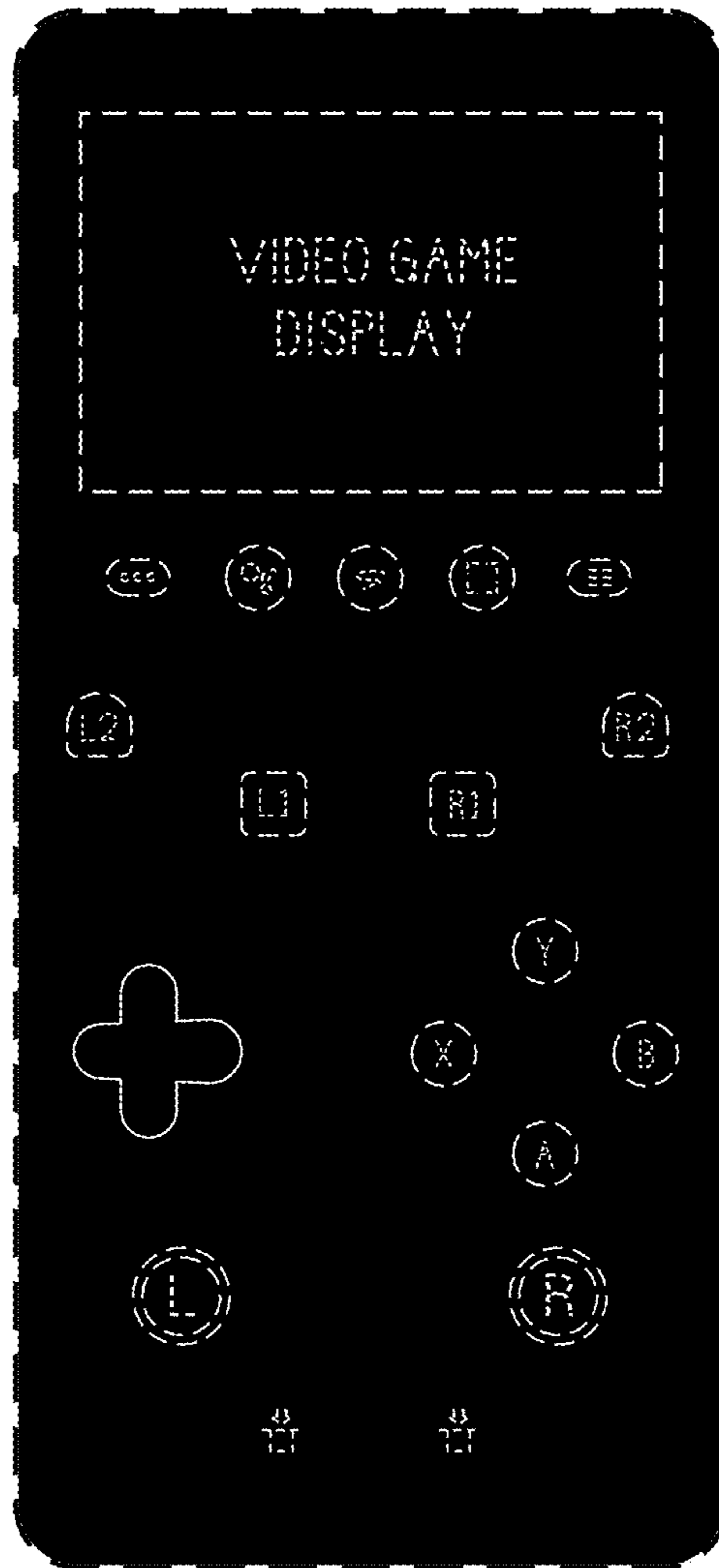

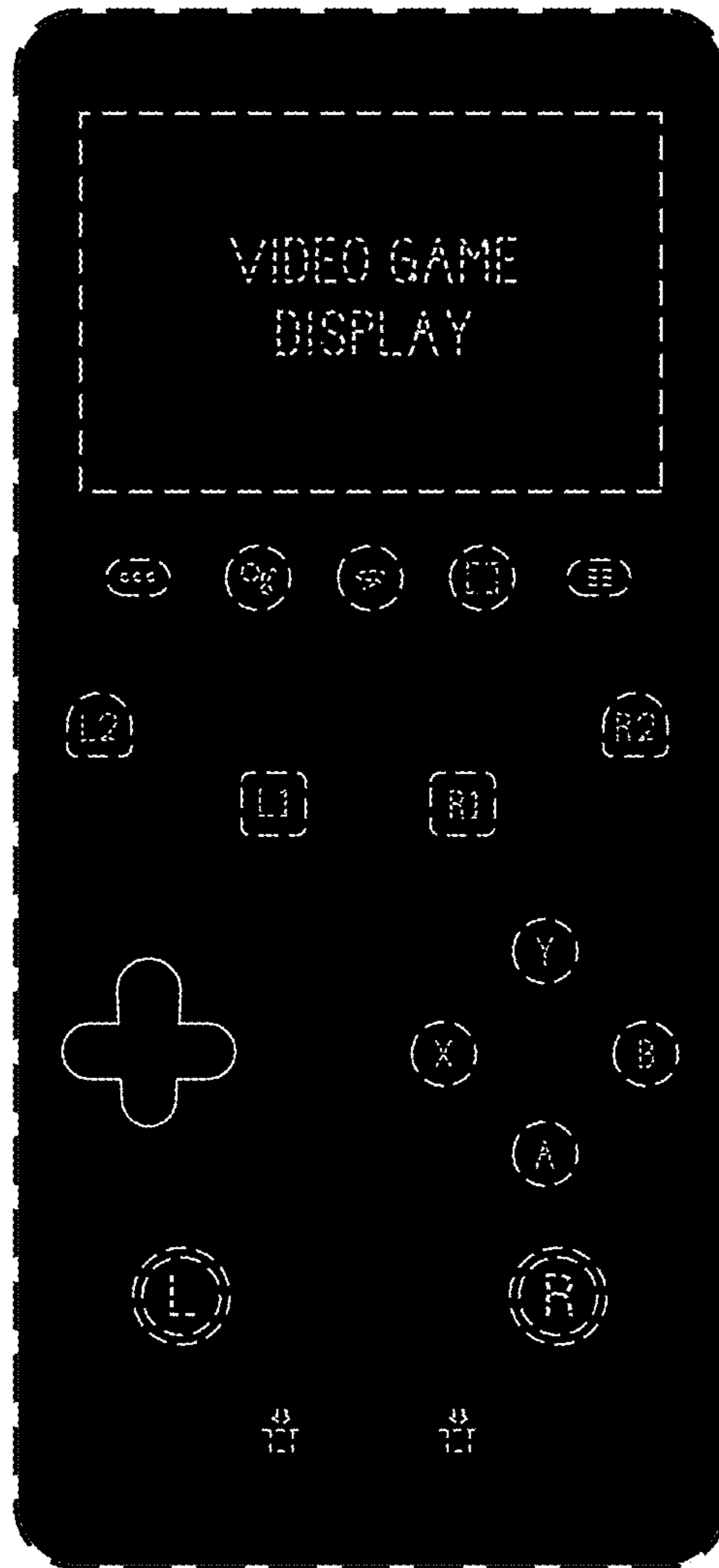

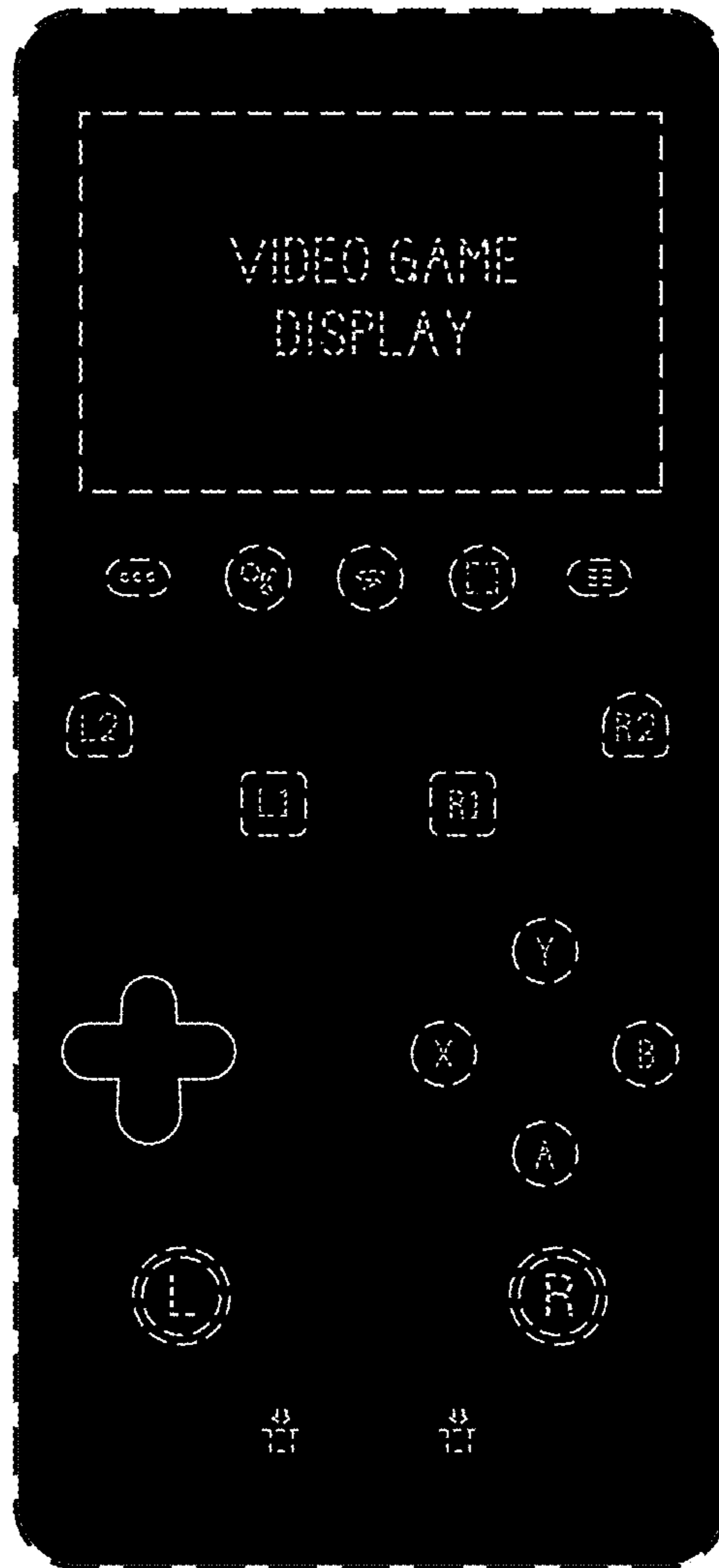

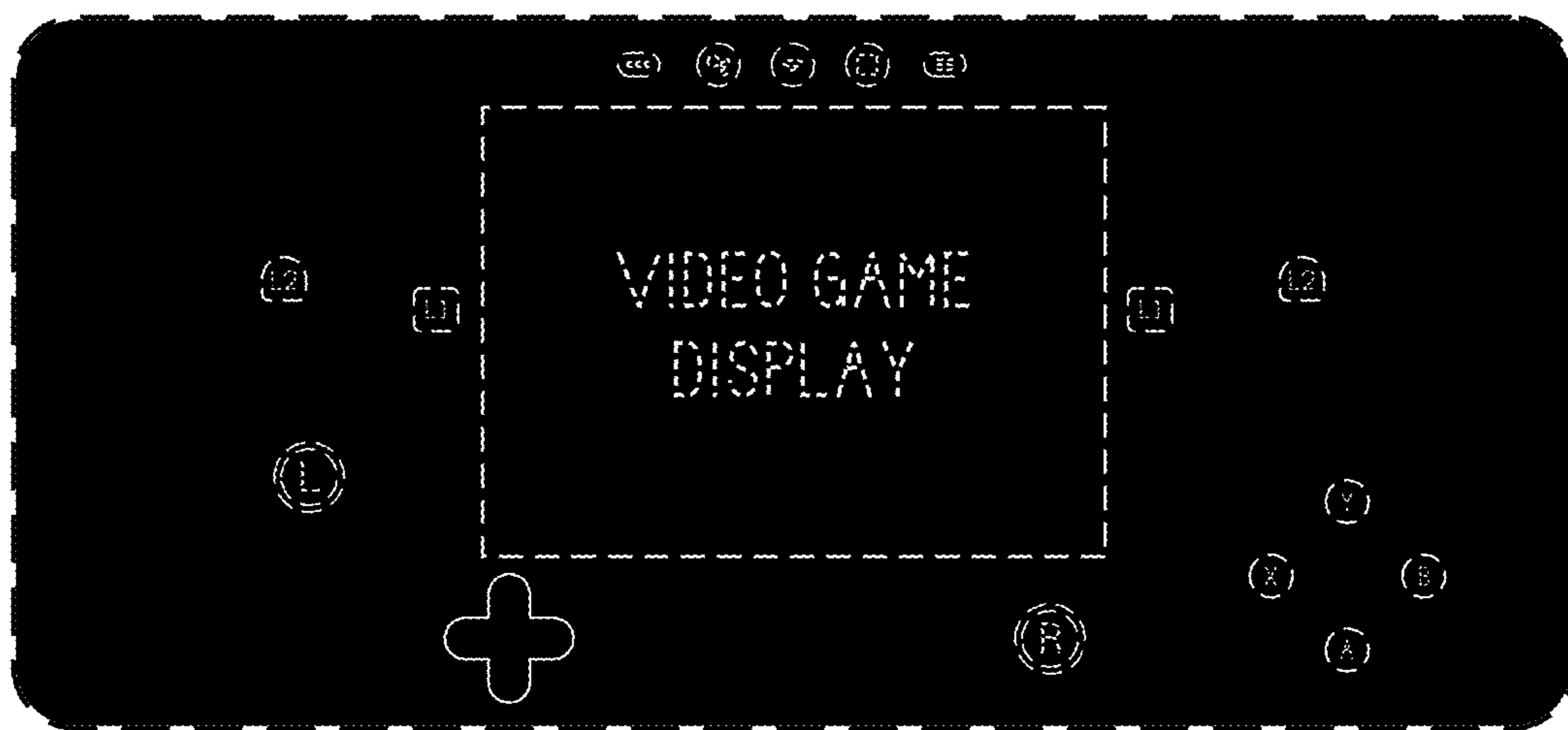

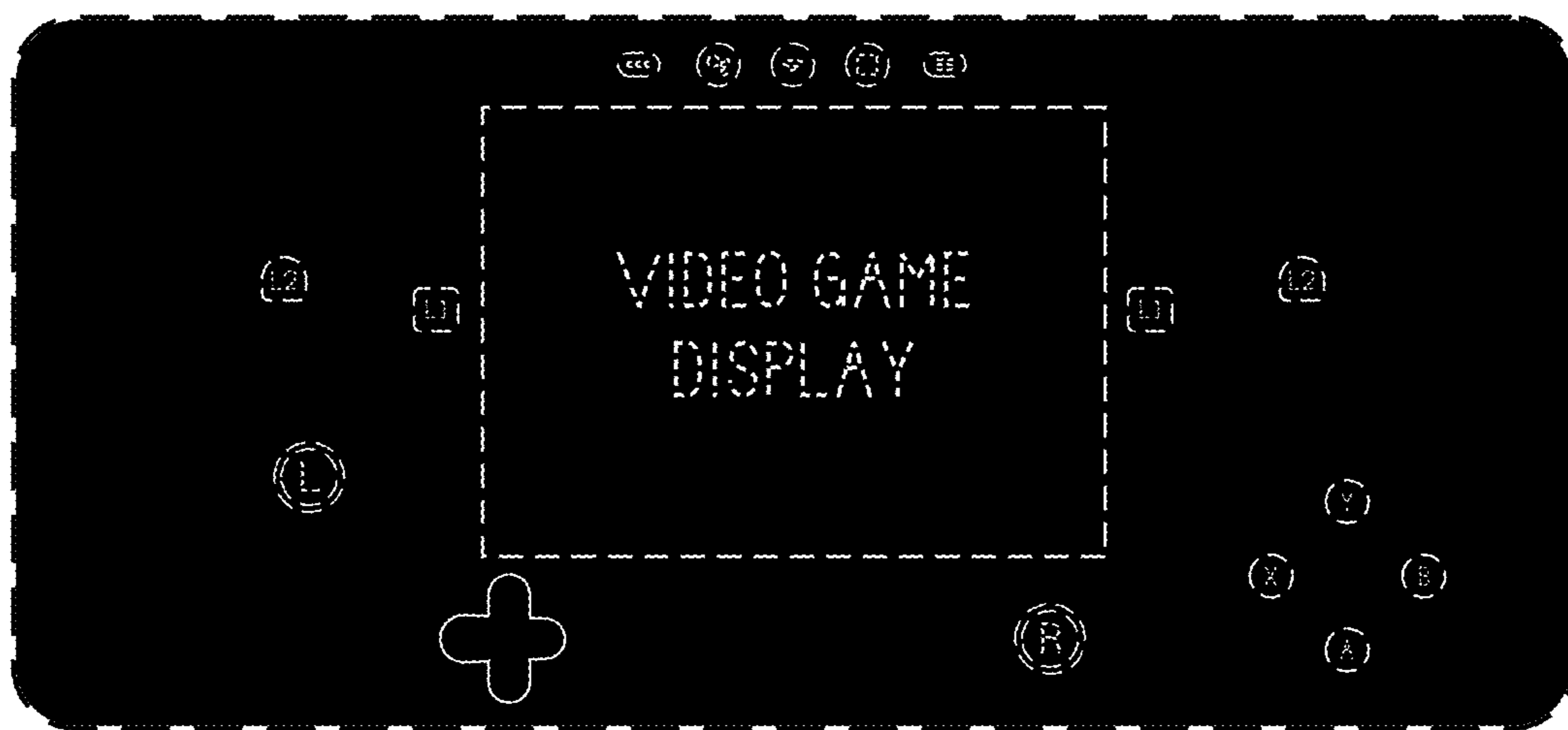

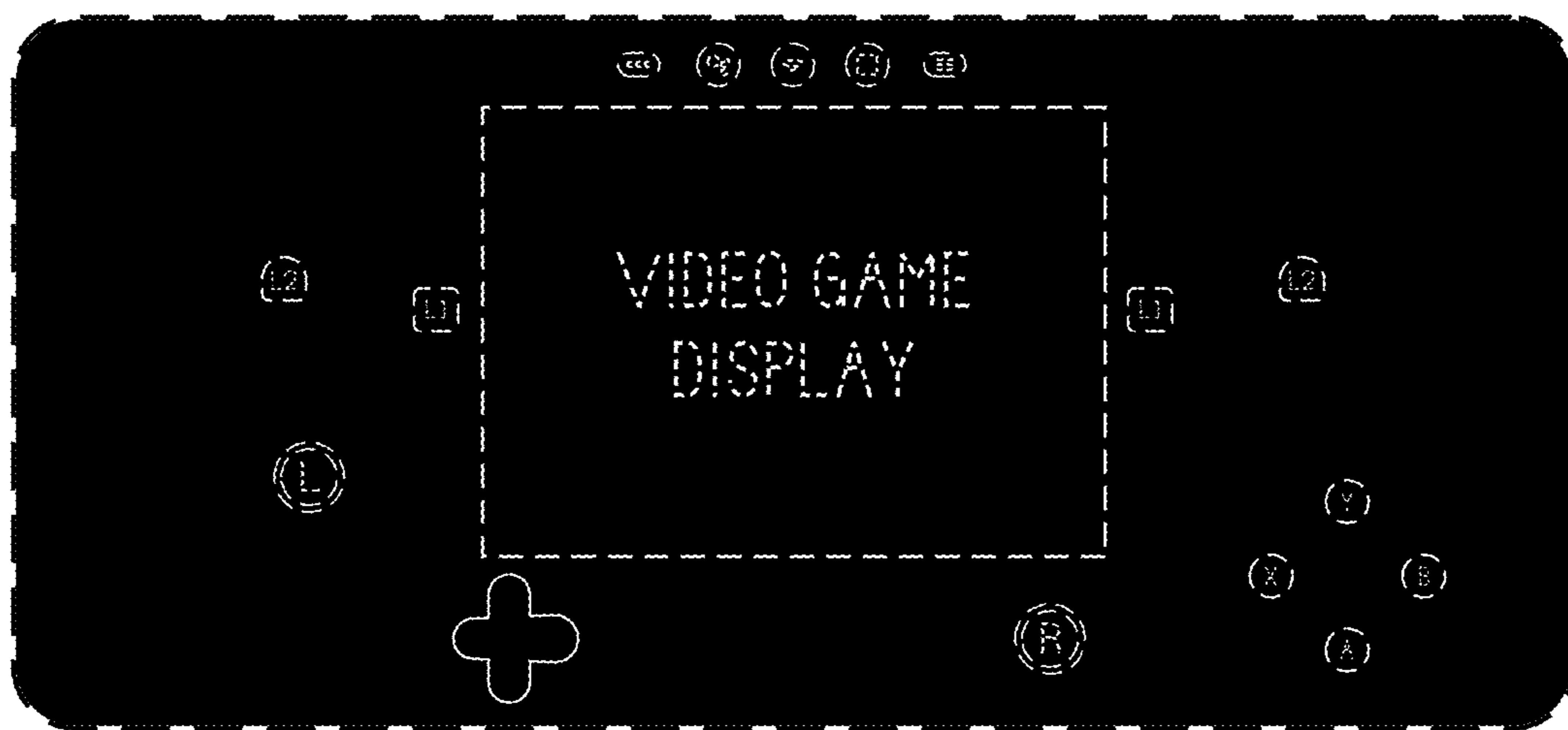

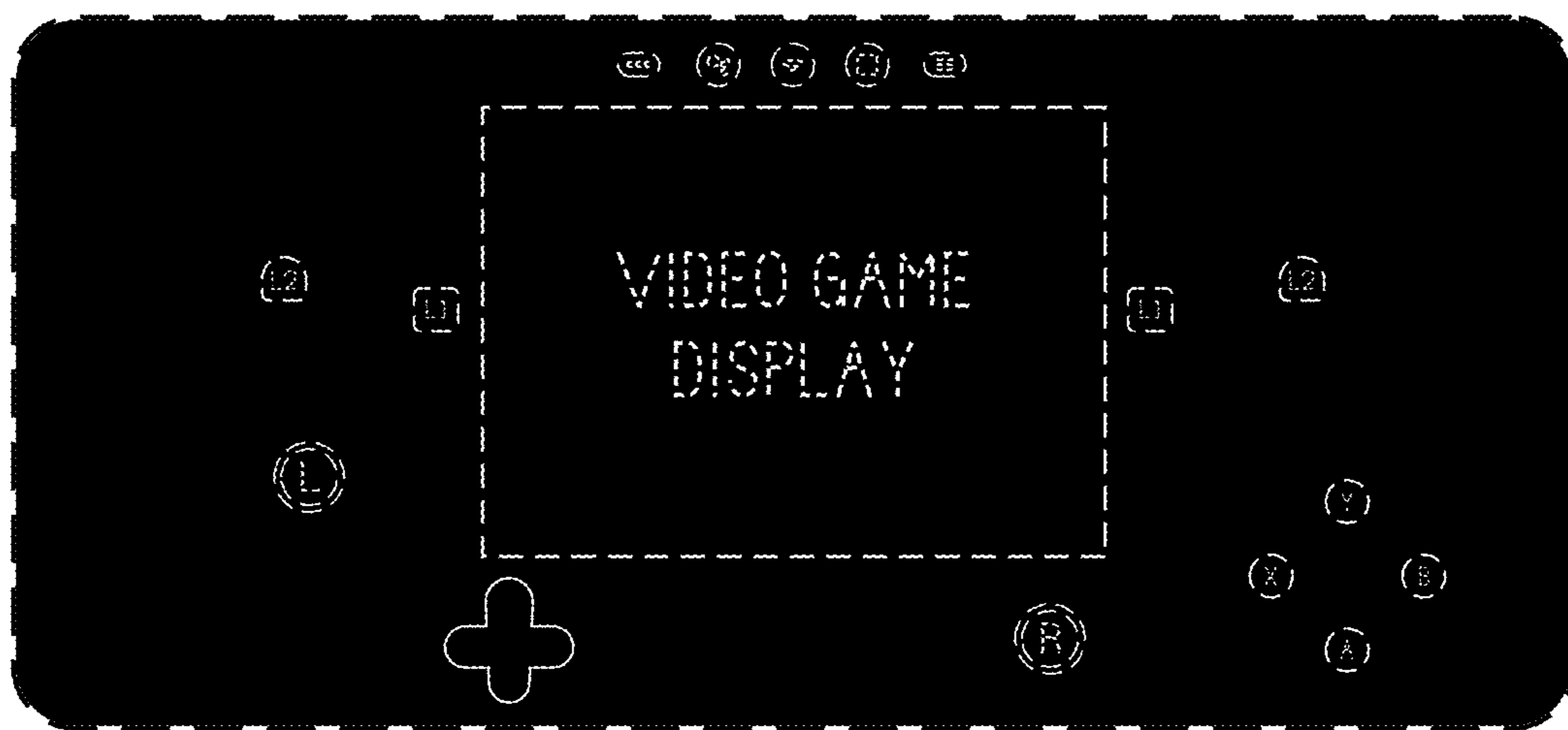

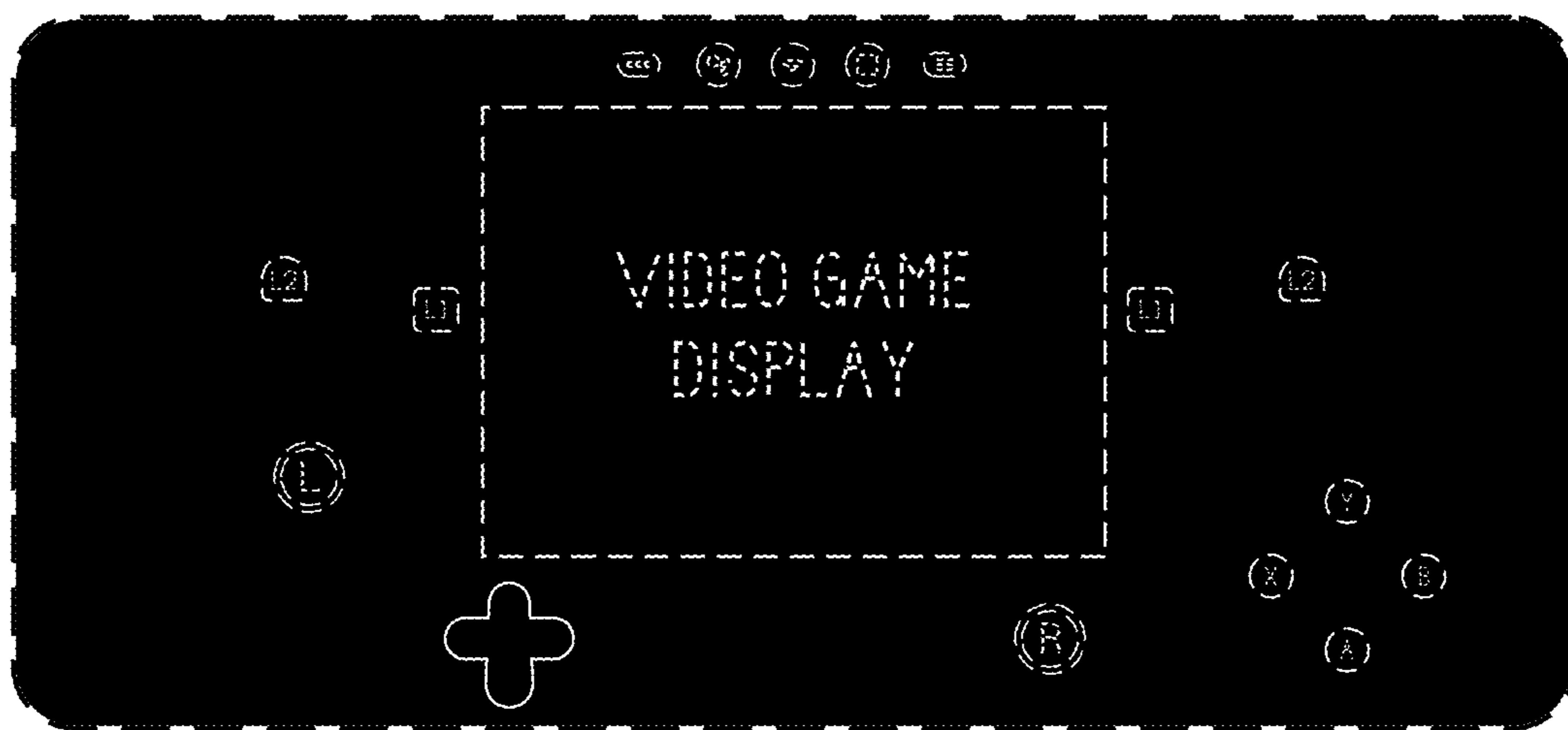
