DESCRIPTION

FIG. 15 illustrates a top view of the pen of FIG. 10.

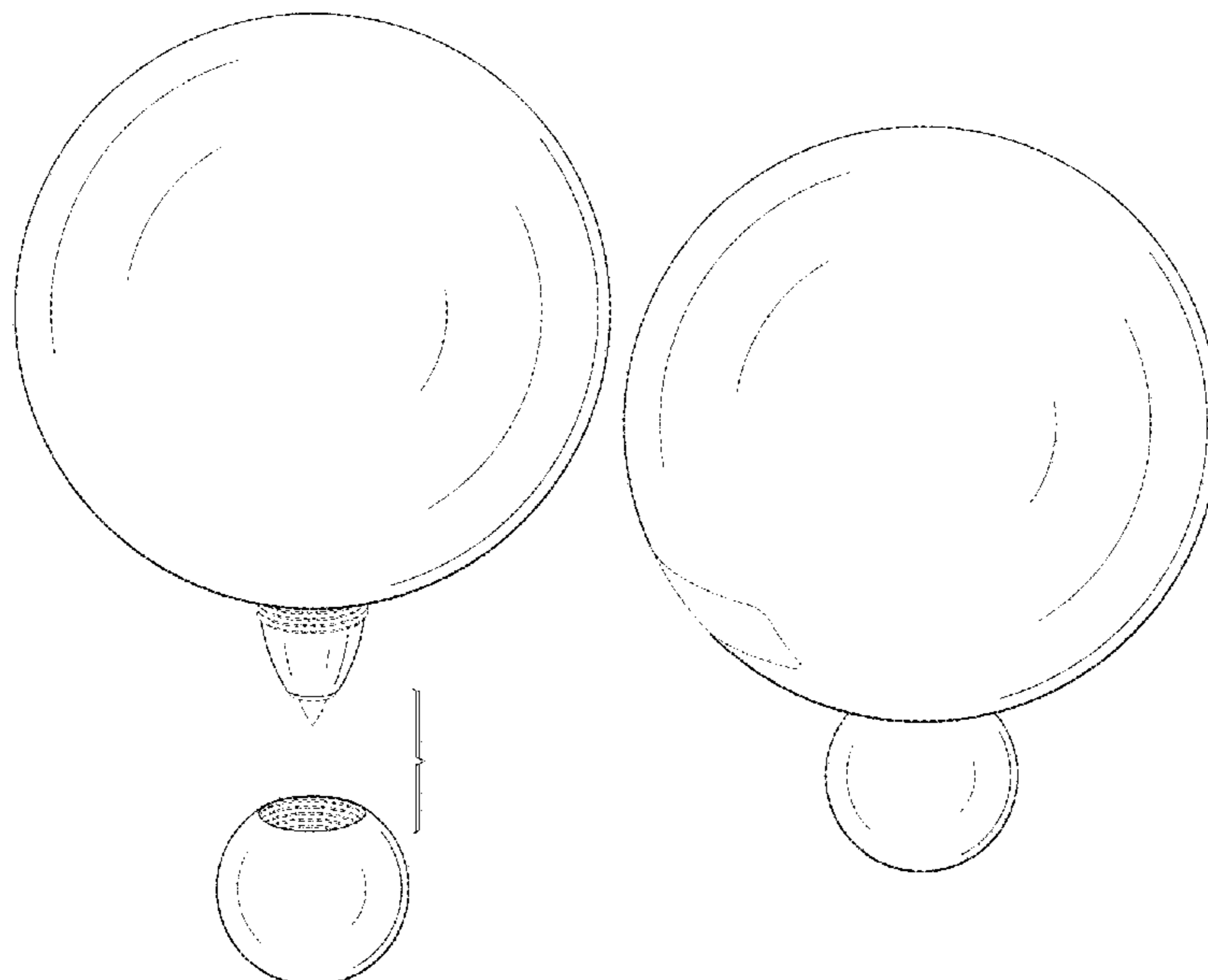
FIG. 16 illustrates a bottom view of the pen of FIG. 10.

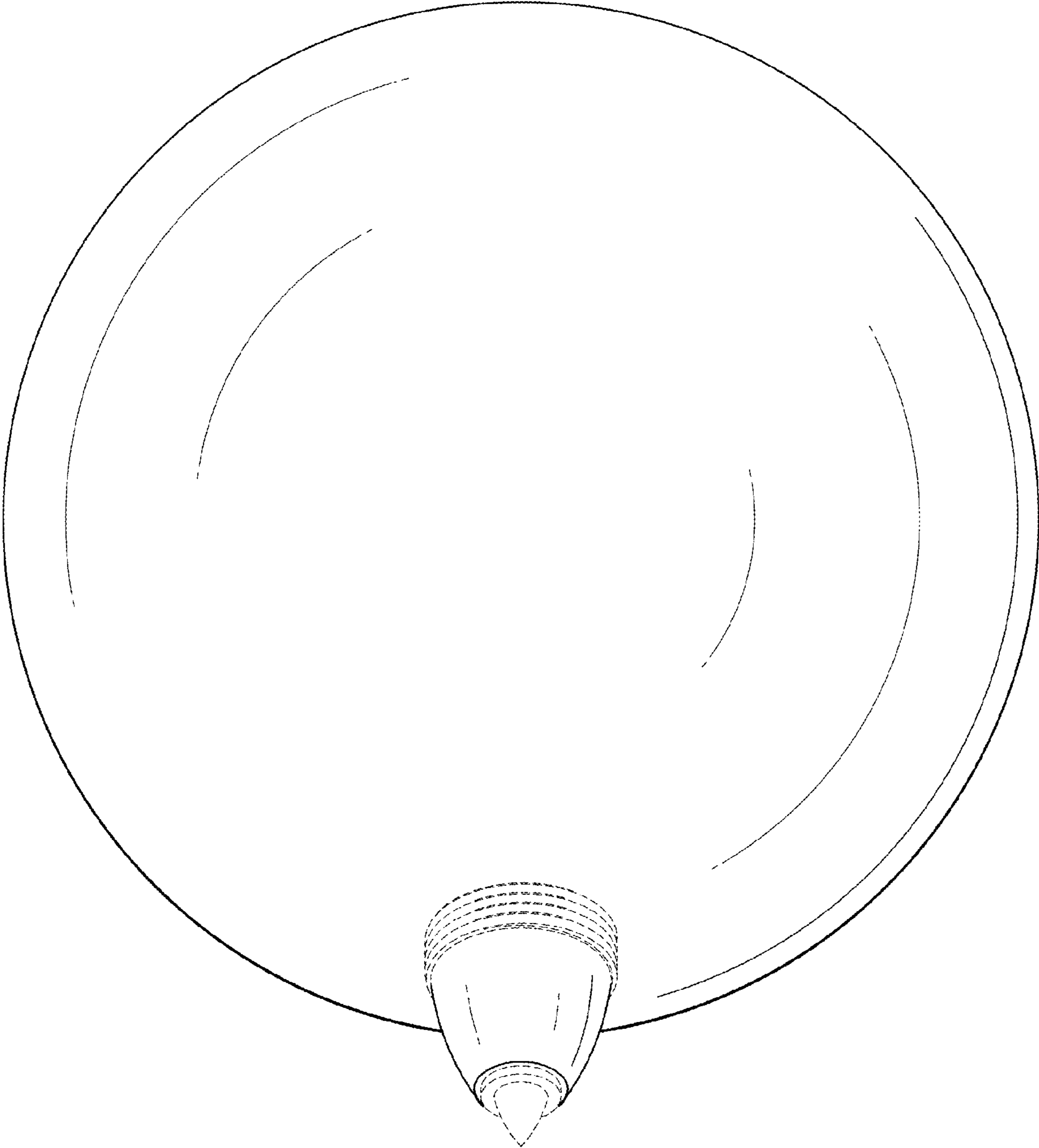

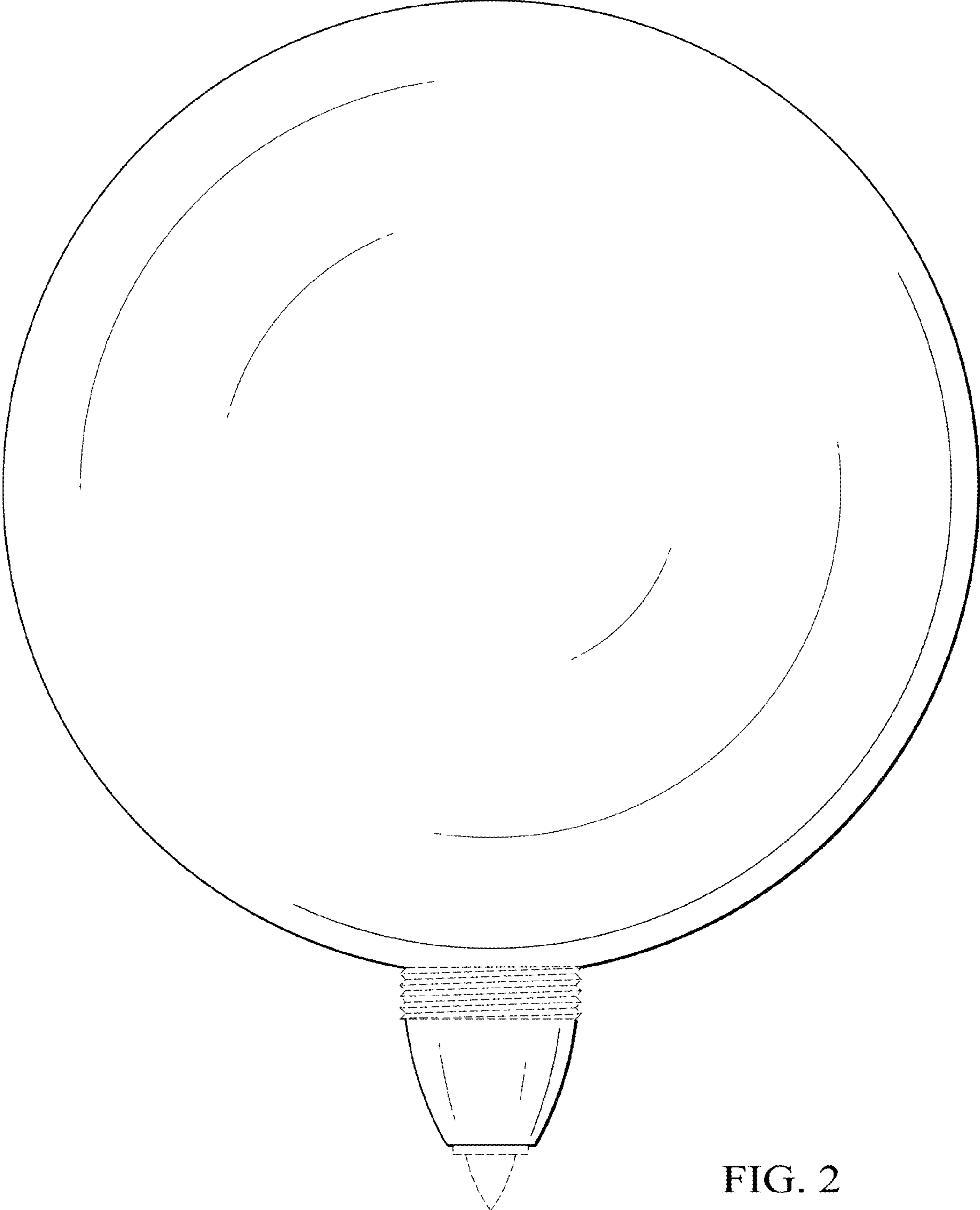

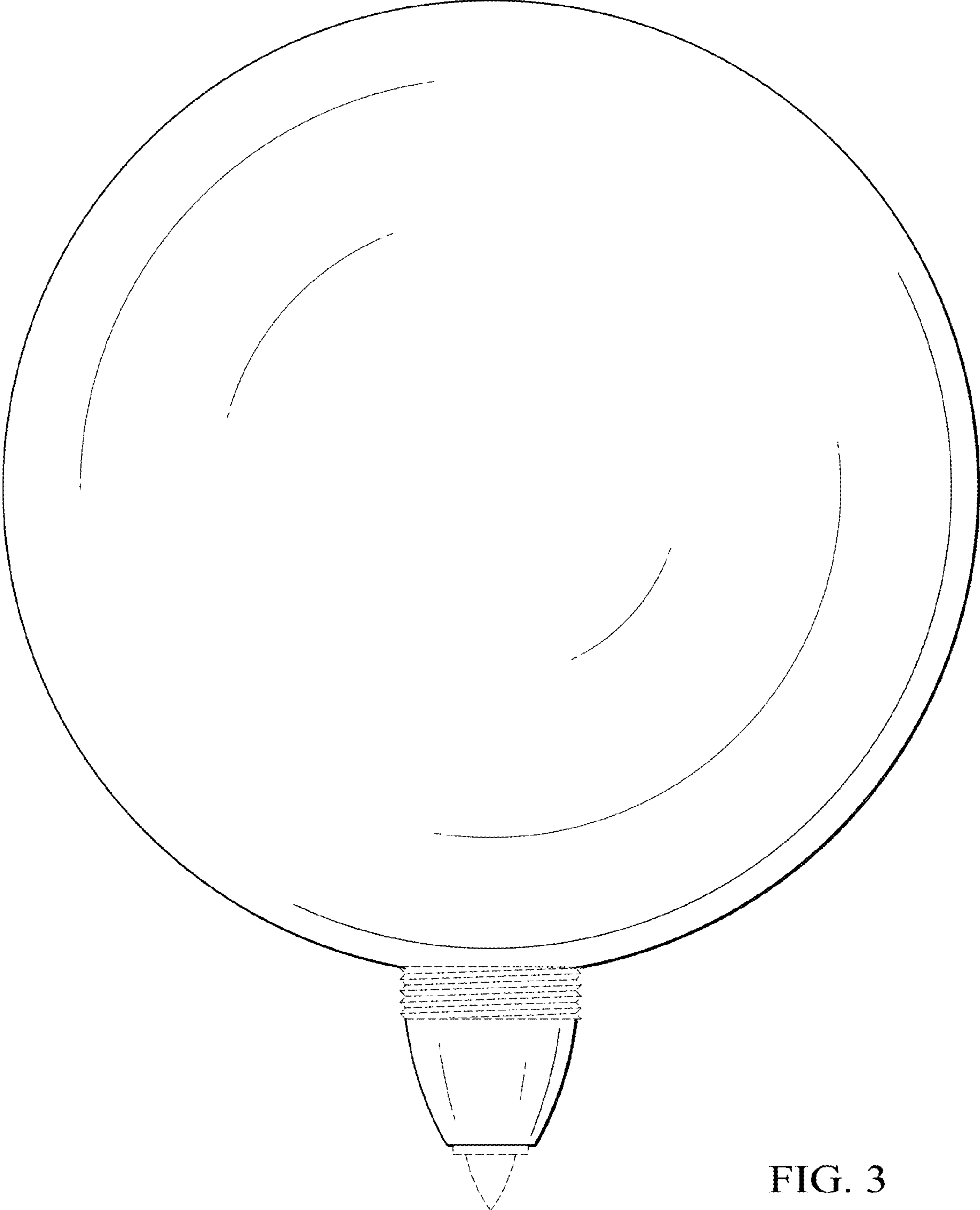

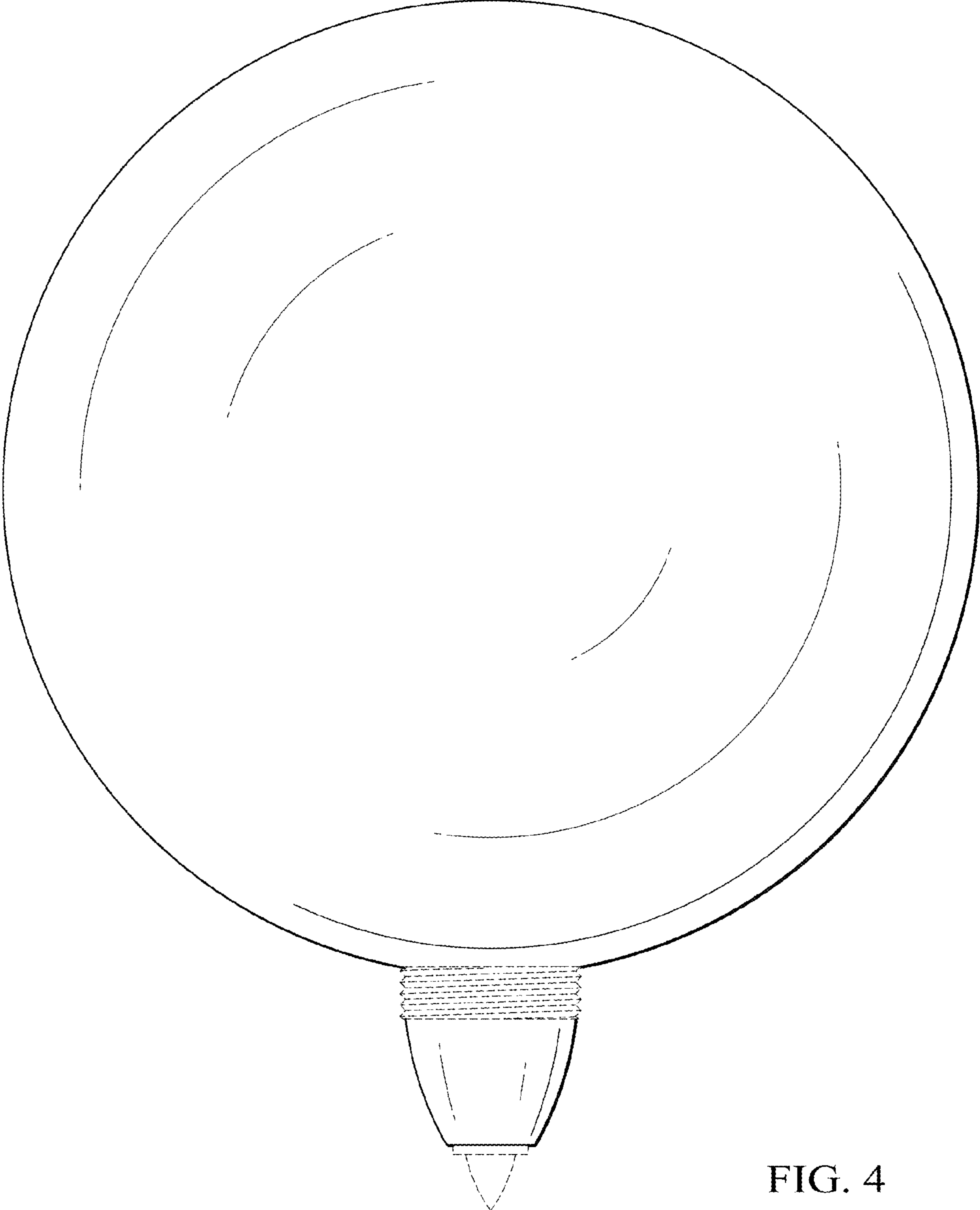

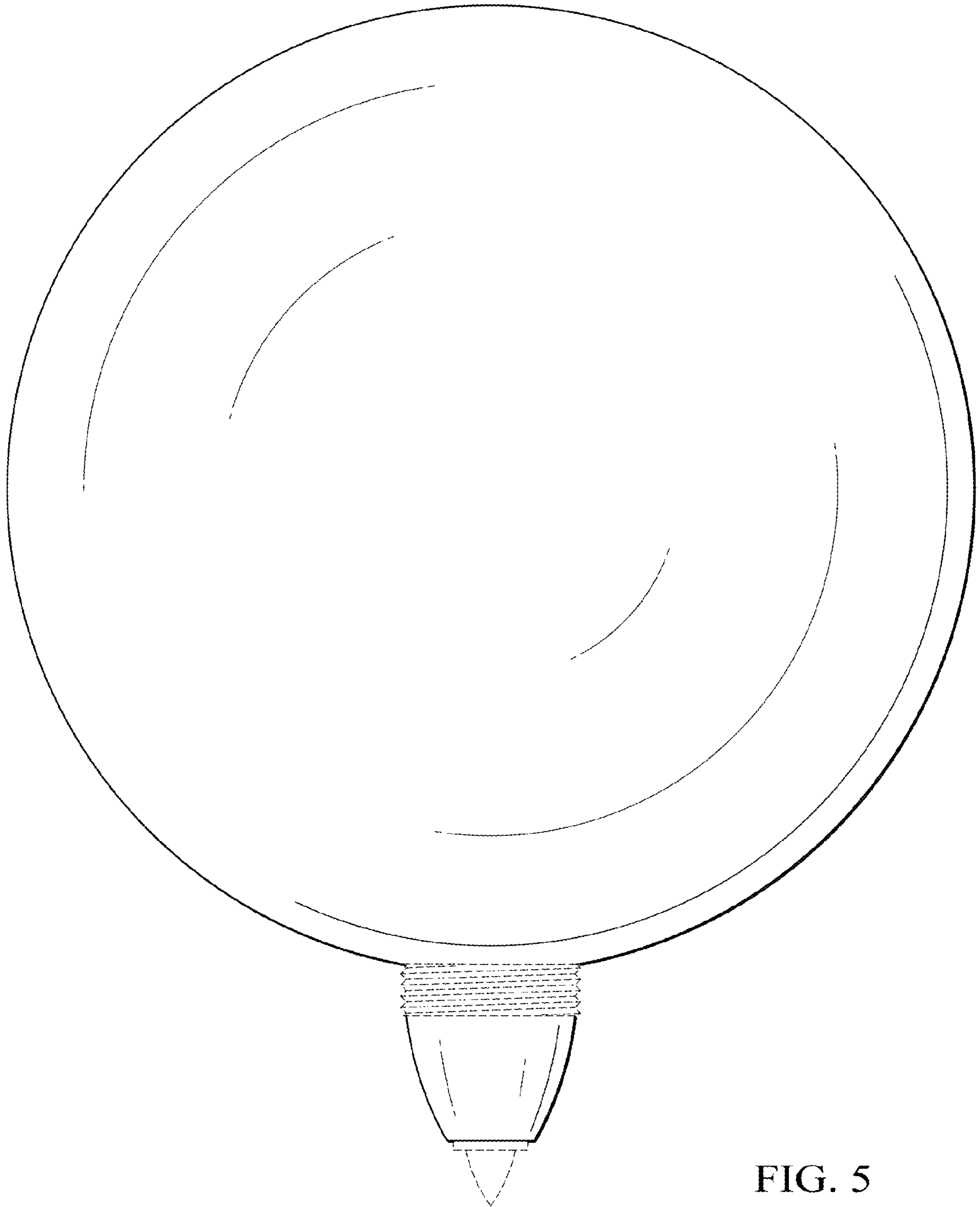

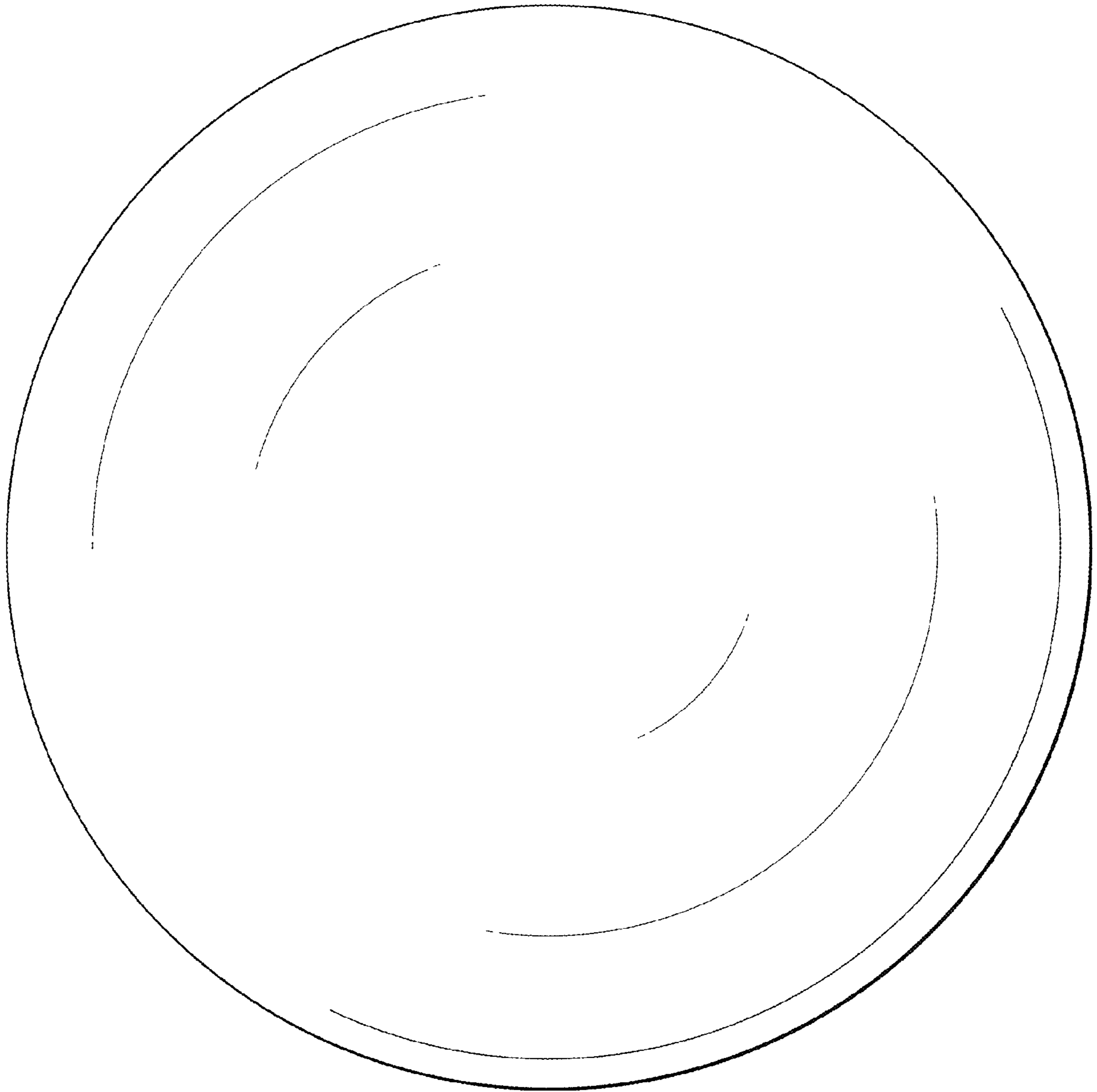

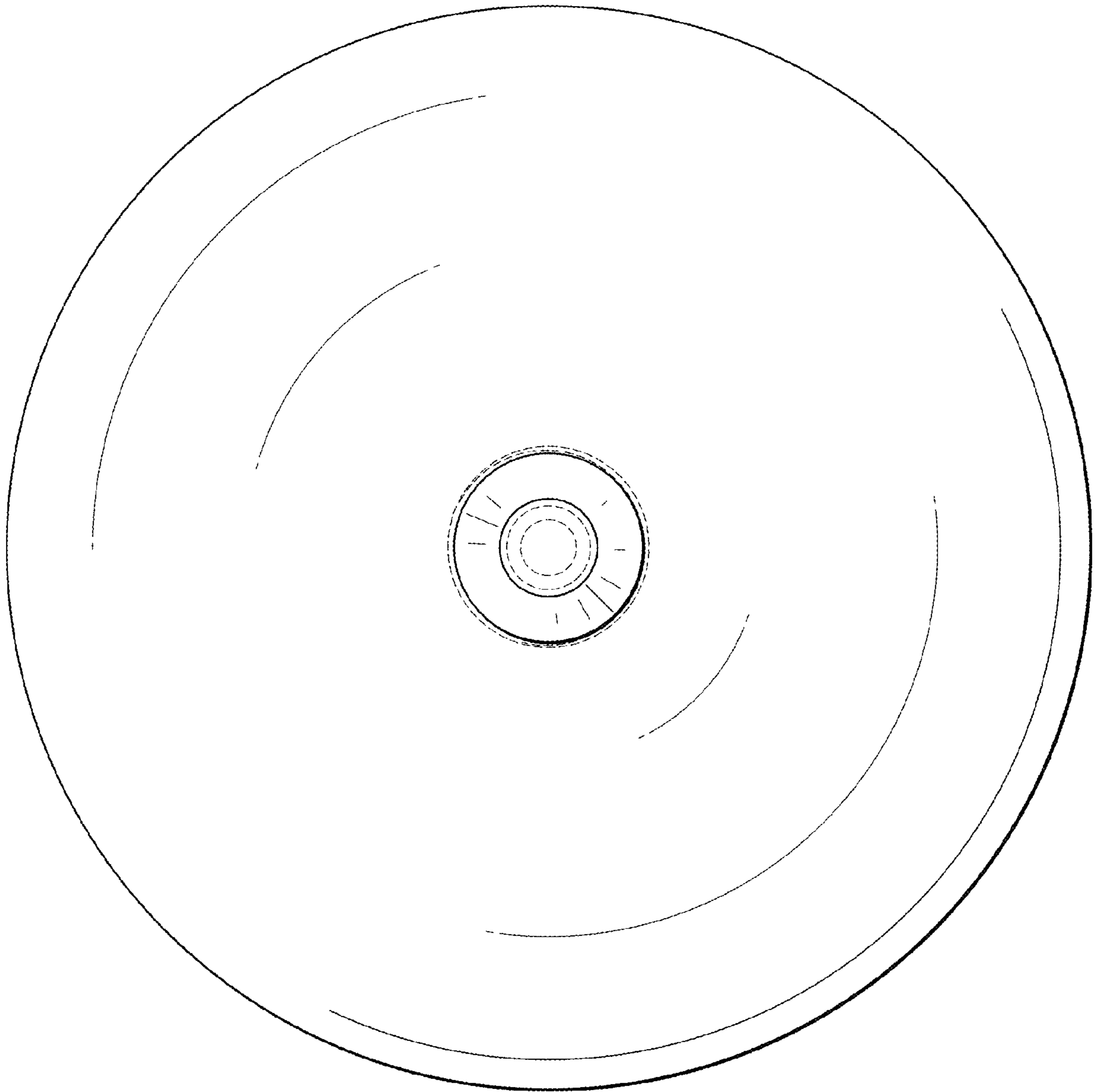

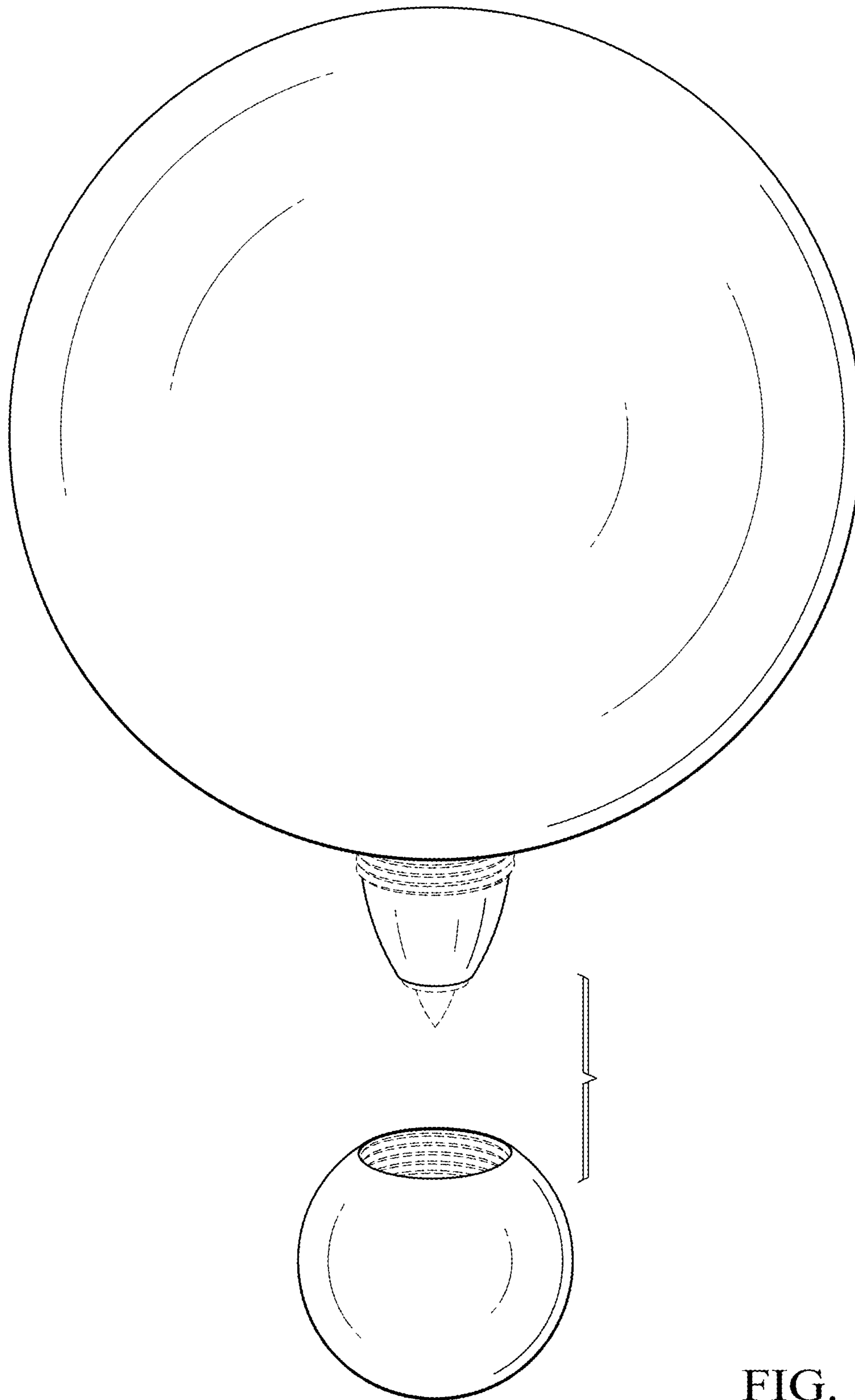

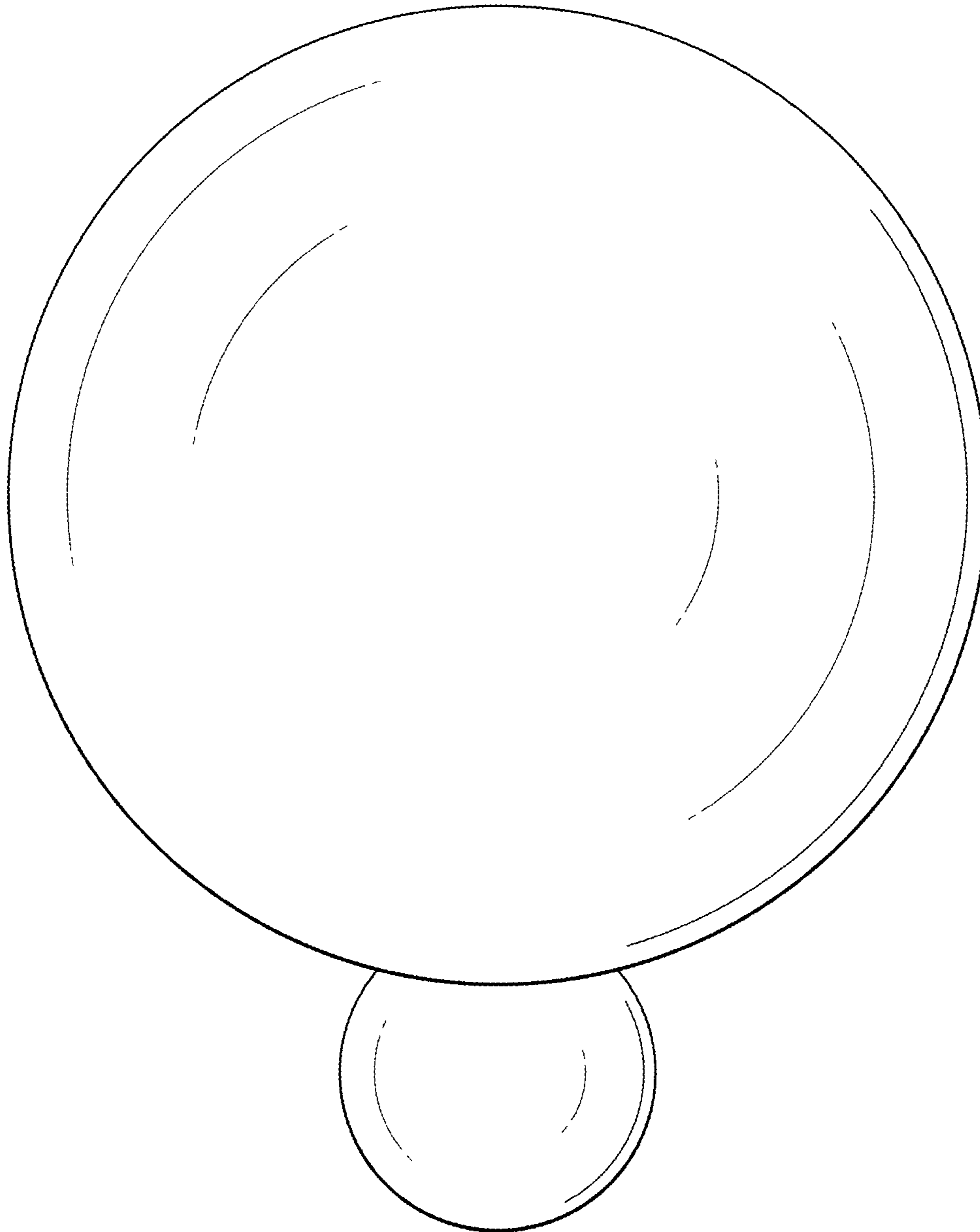

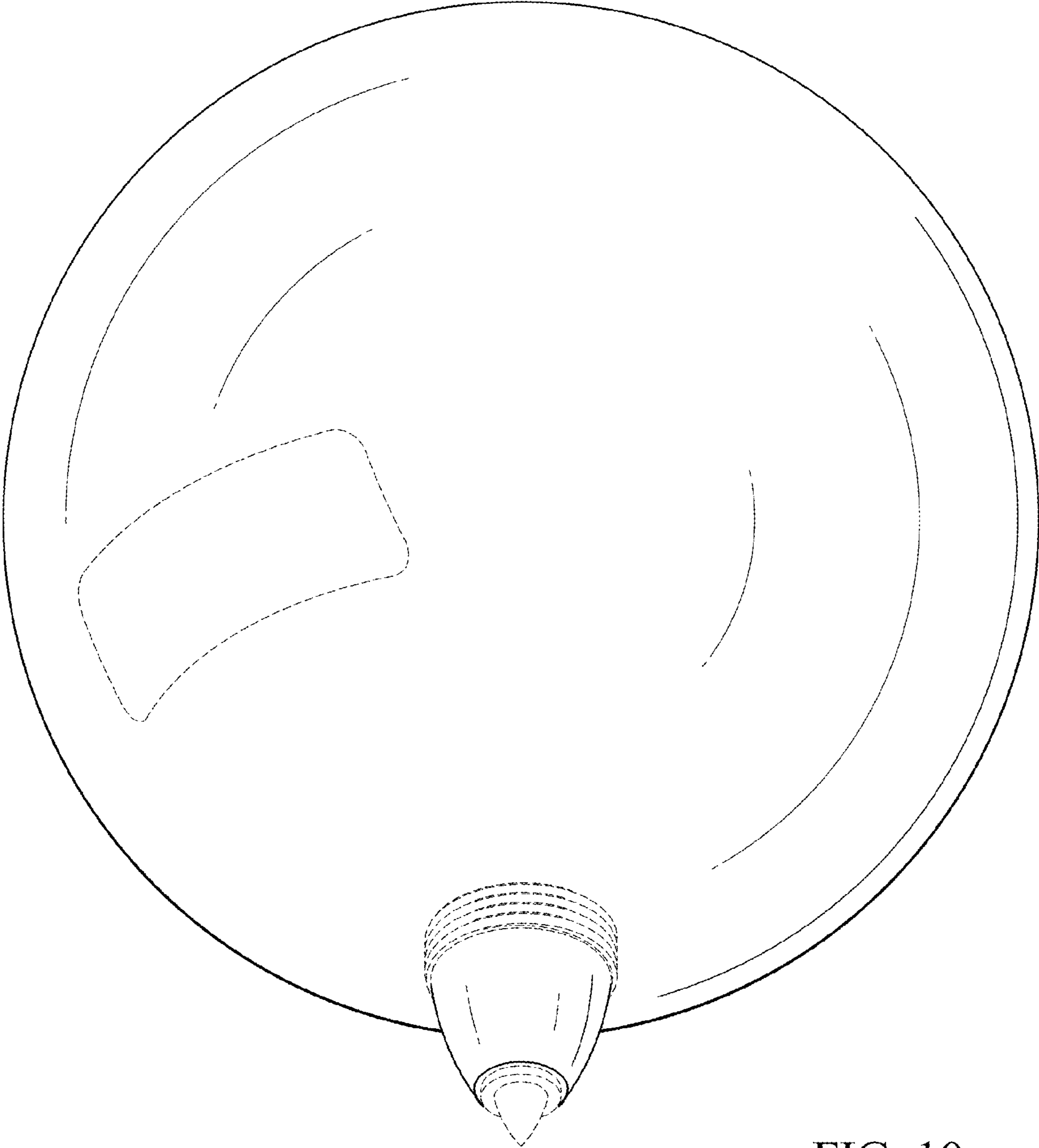

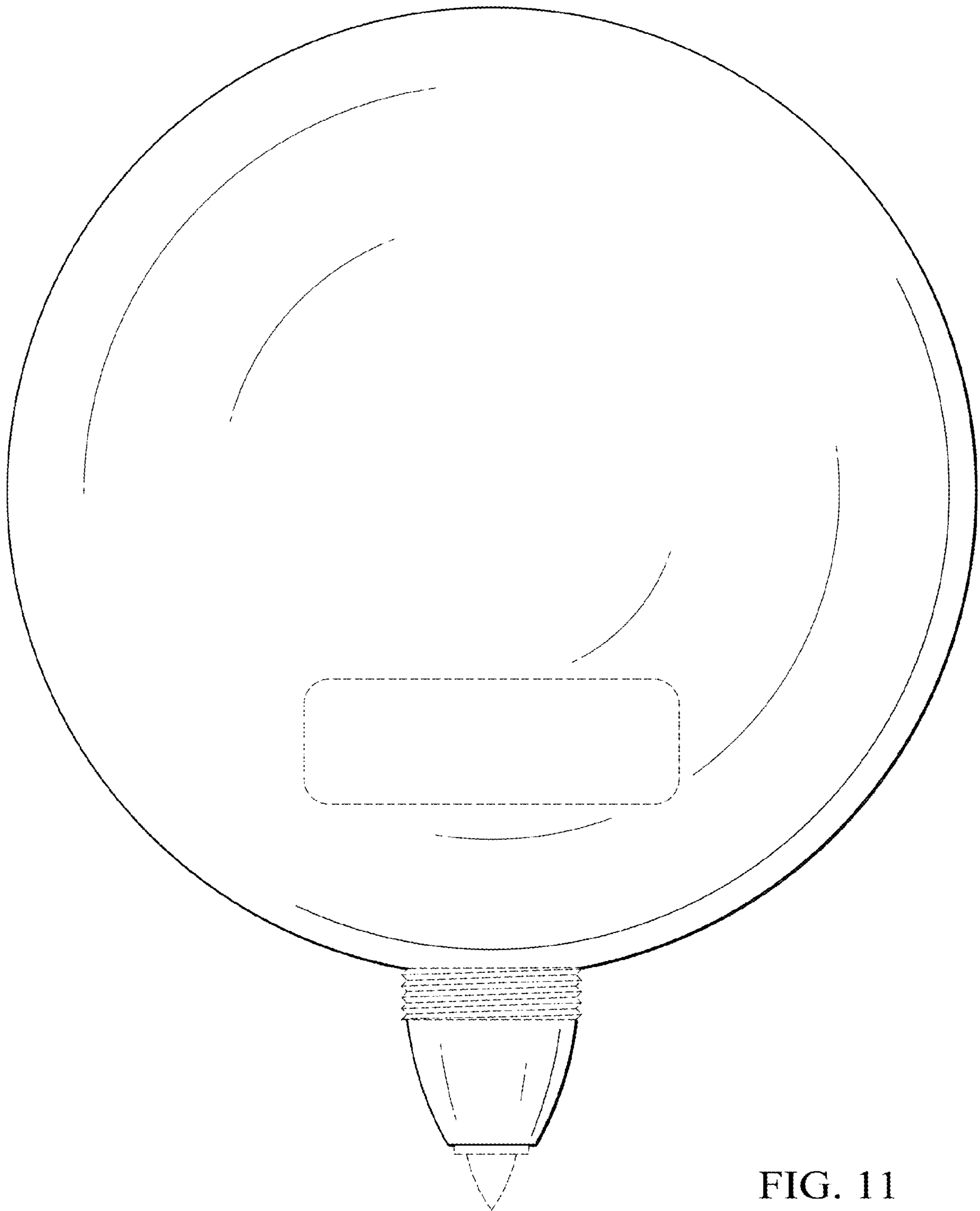

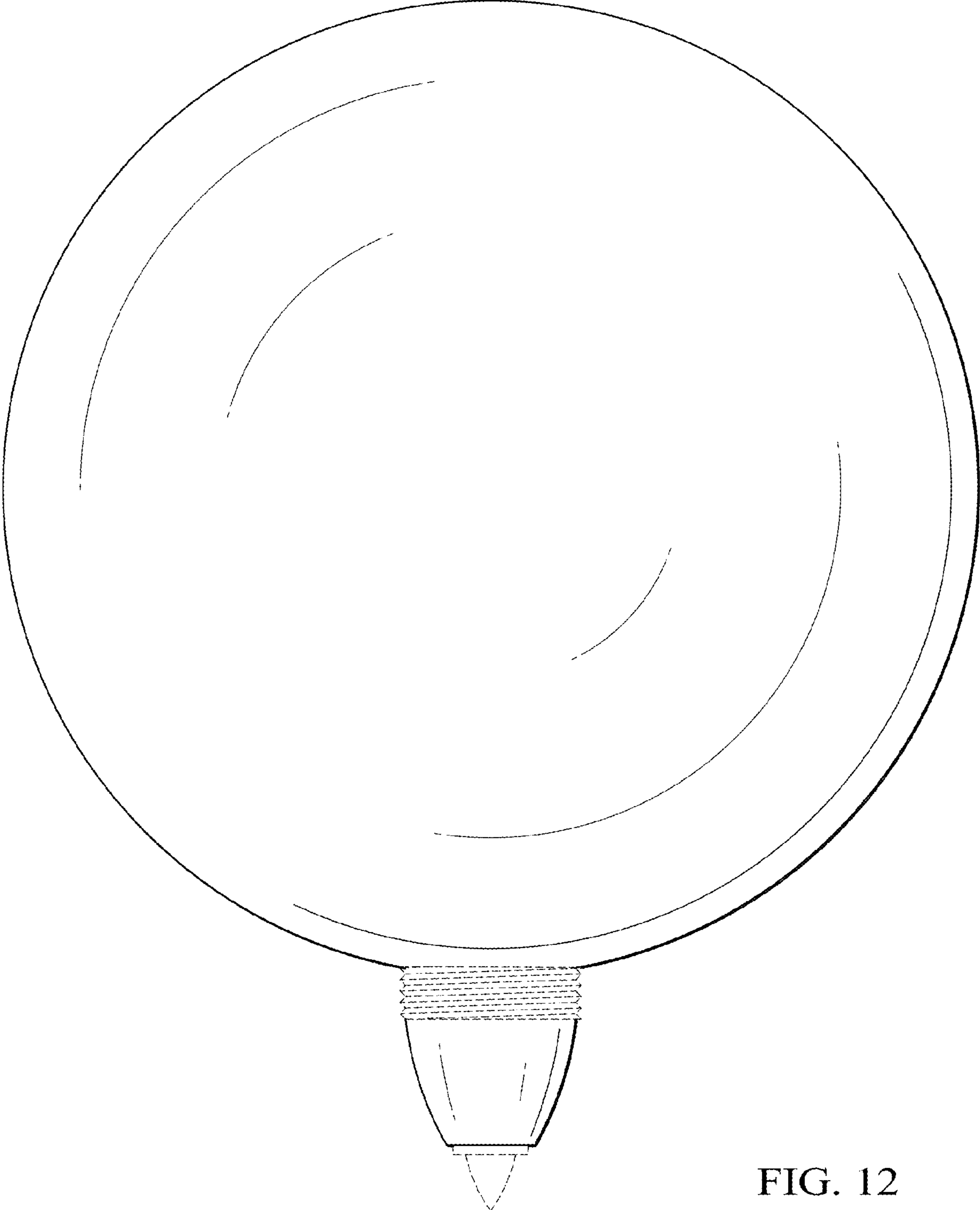

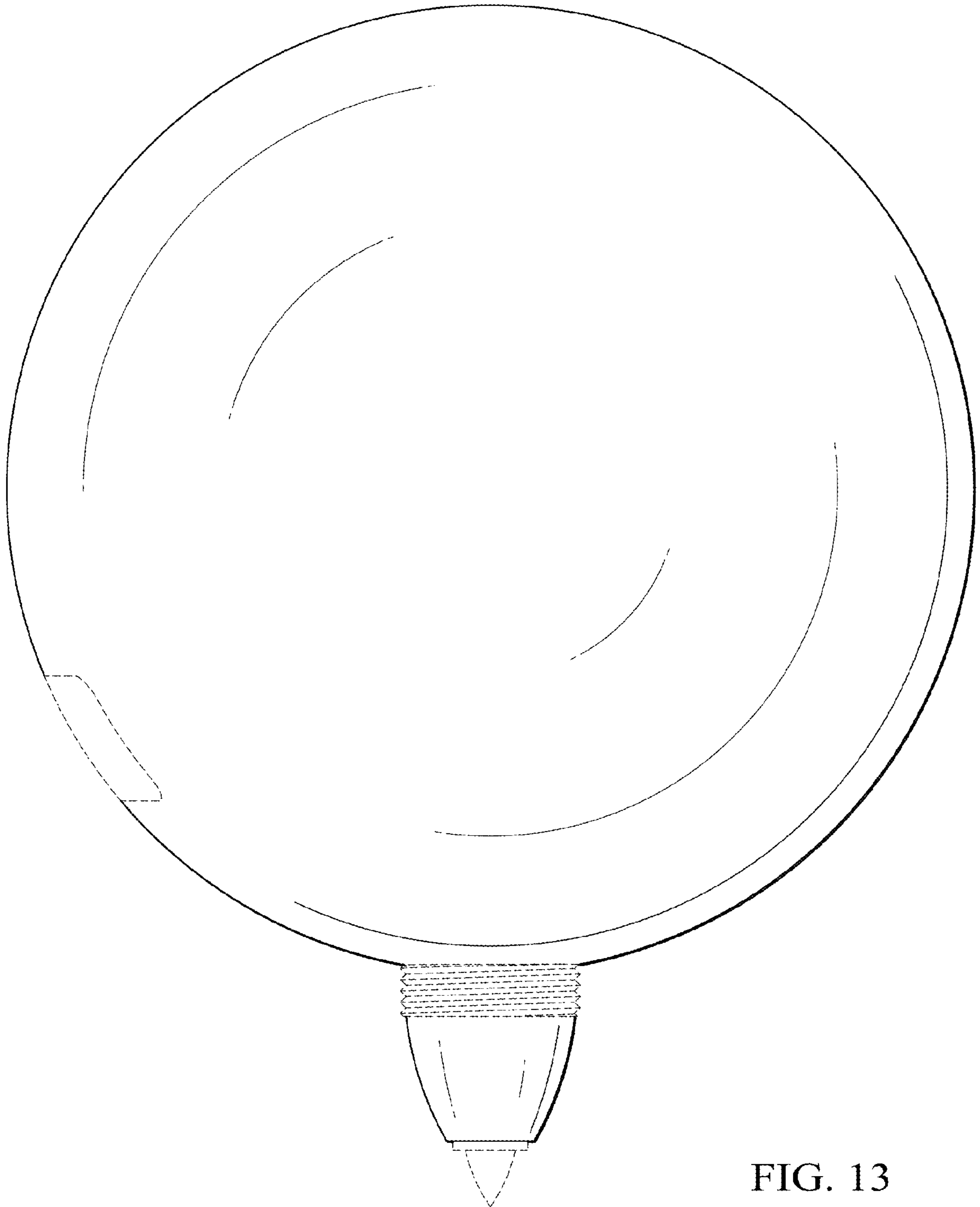

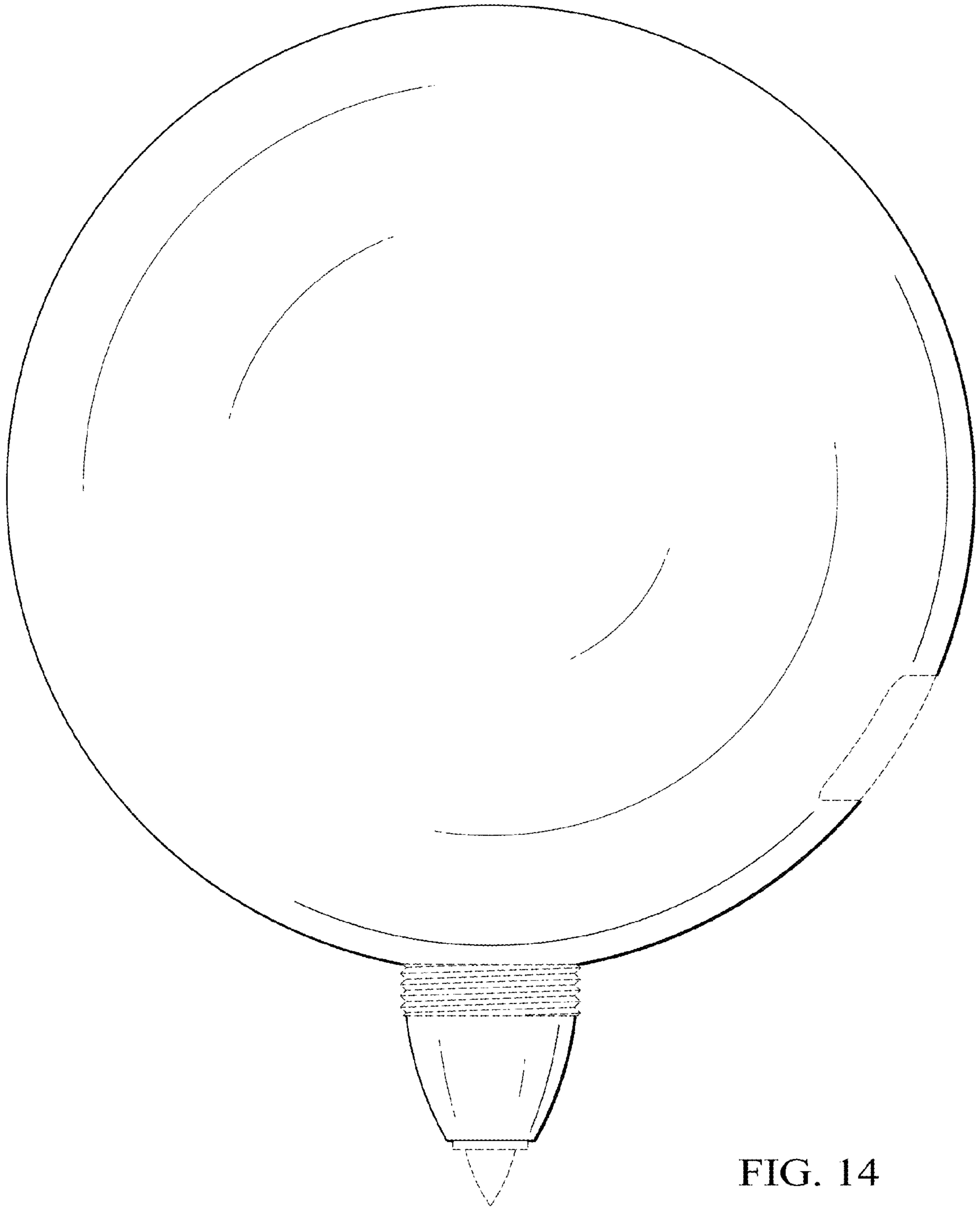

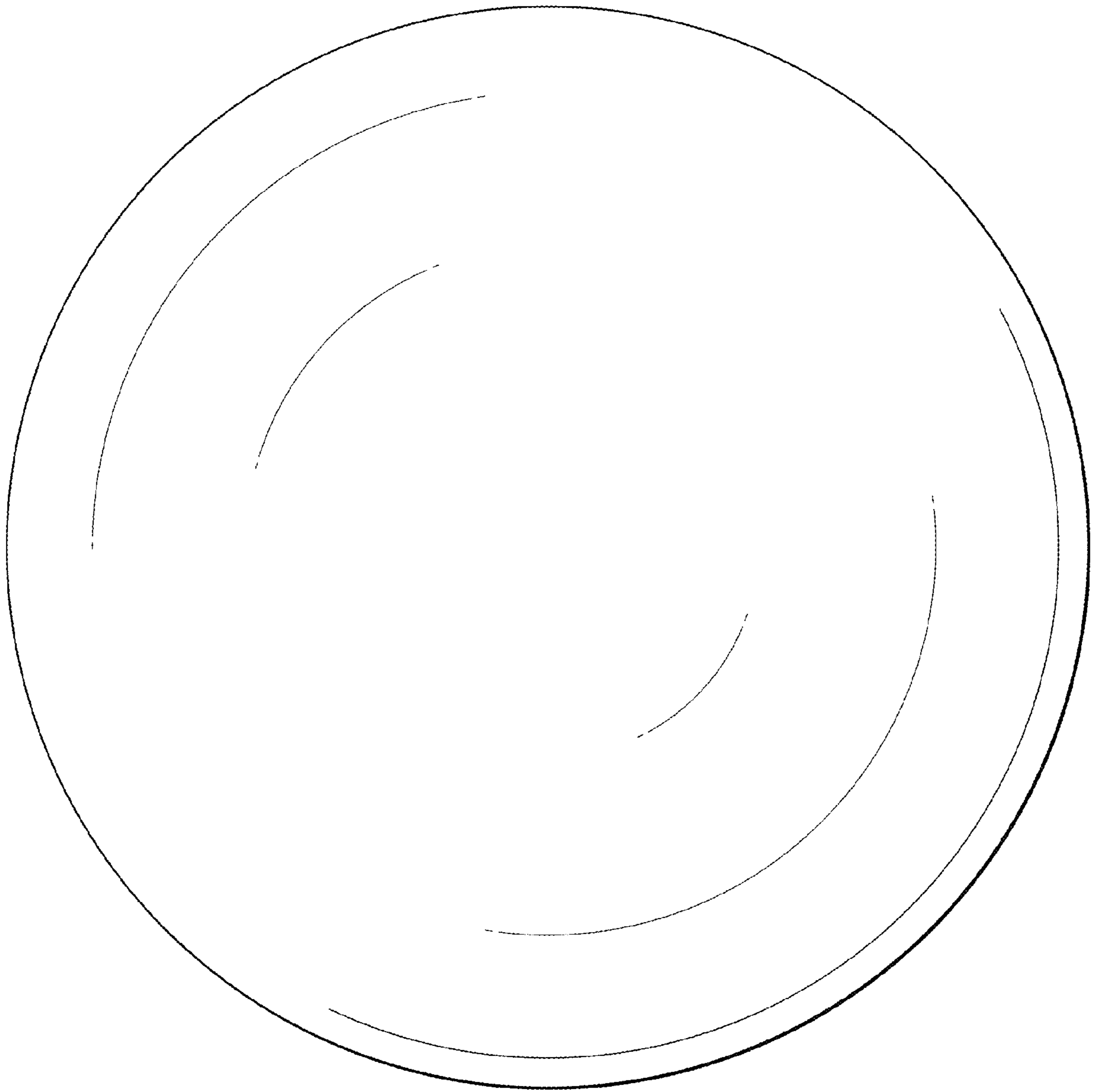

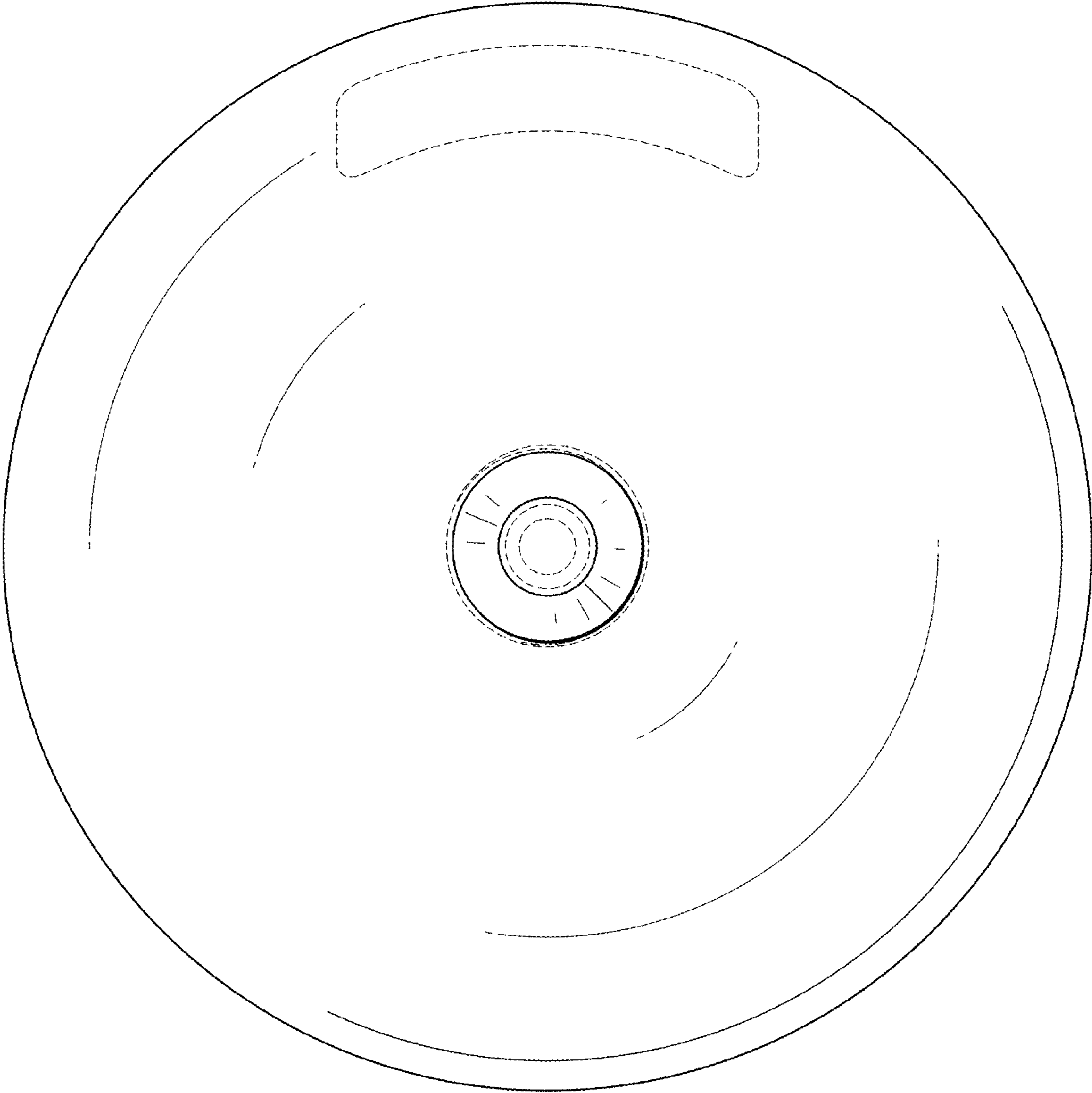

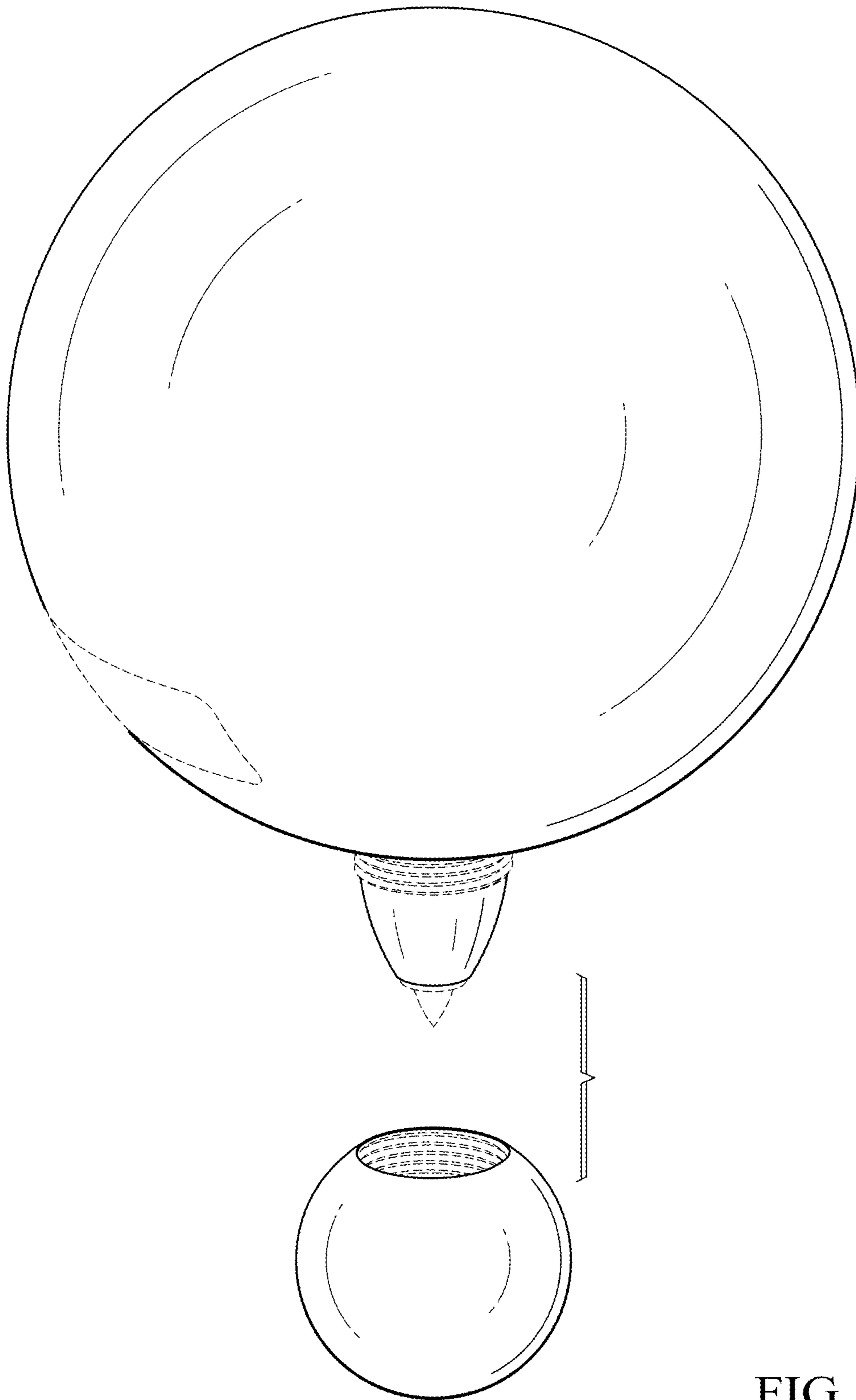

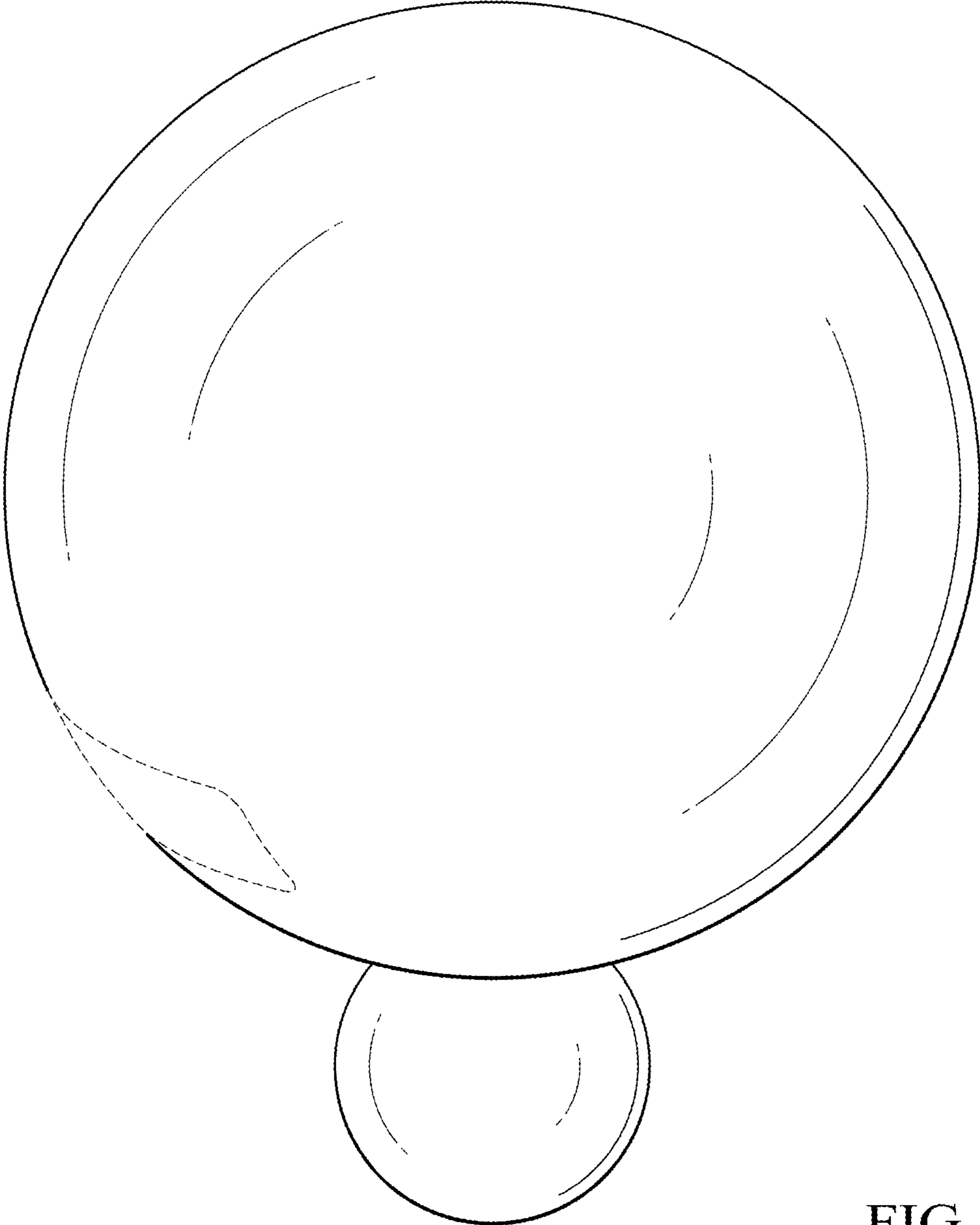
