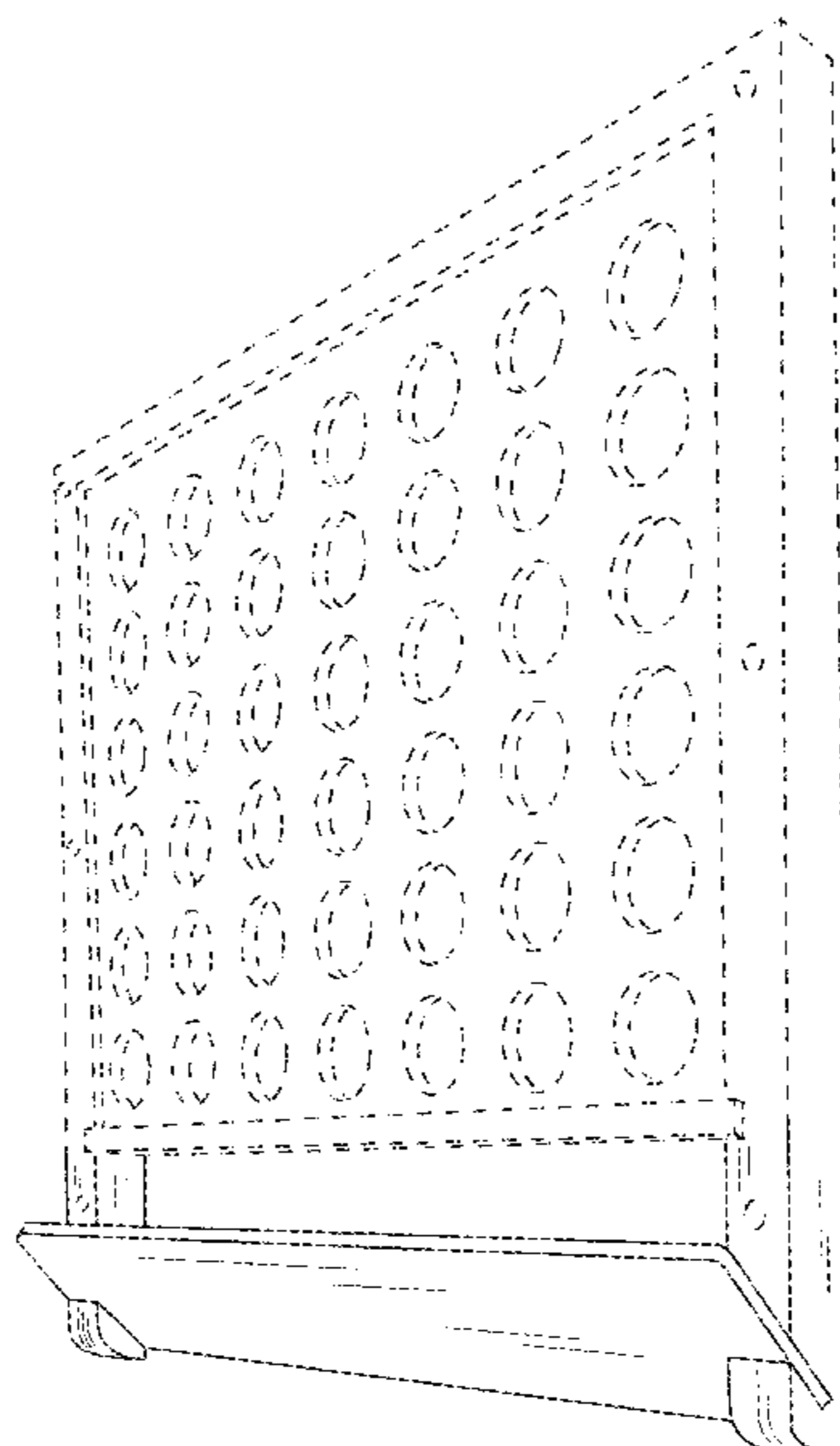
(57) **CLAIM**

The ornamental design for a catch tray, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a catch tray showing the claimed design.

FIG. 3 is a front view of the catch tray shown in FIG. 1.

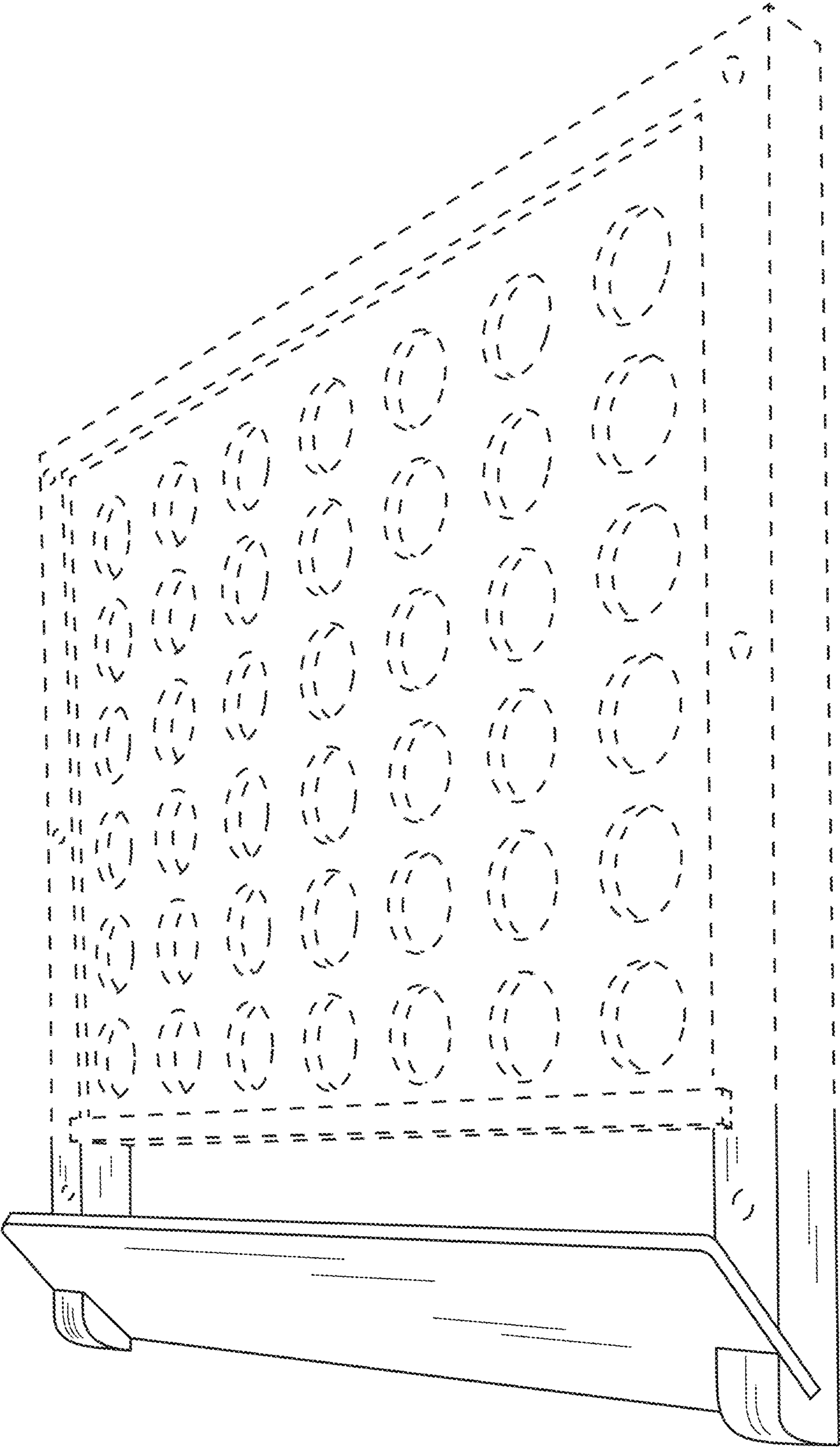

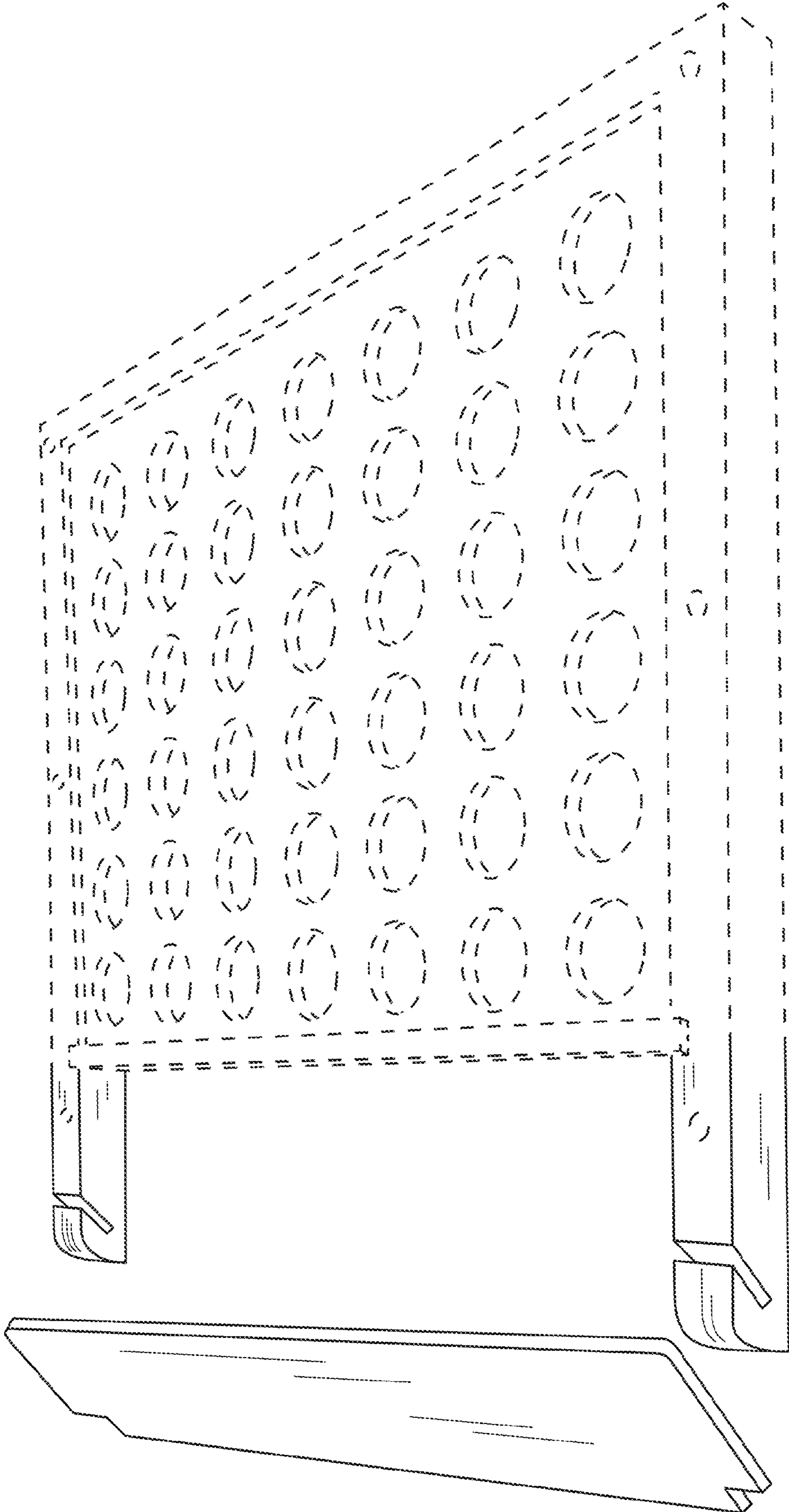

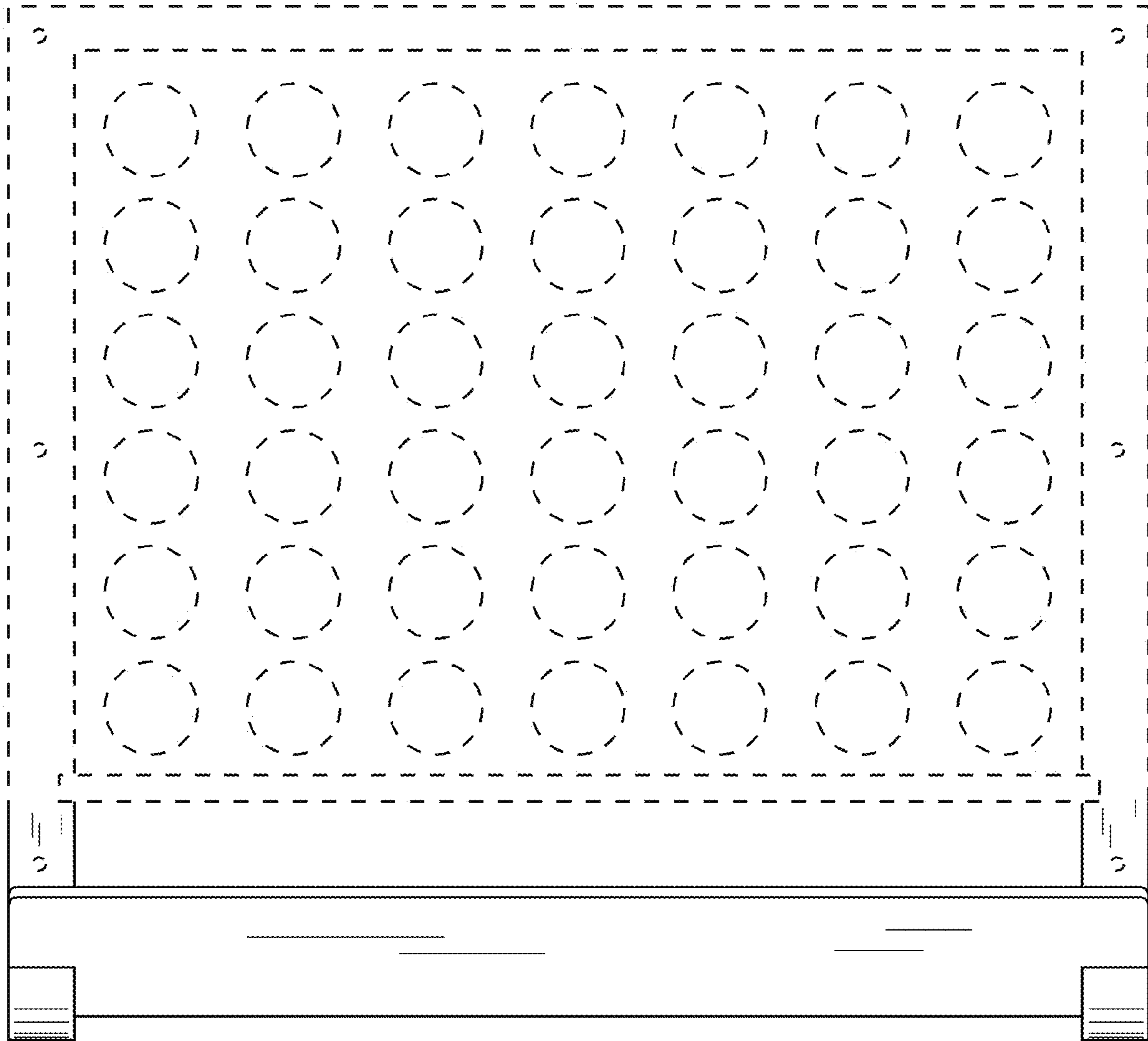

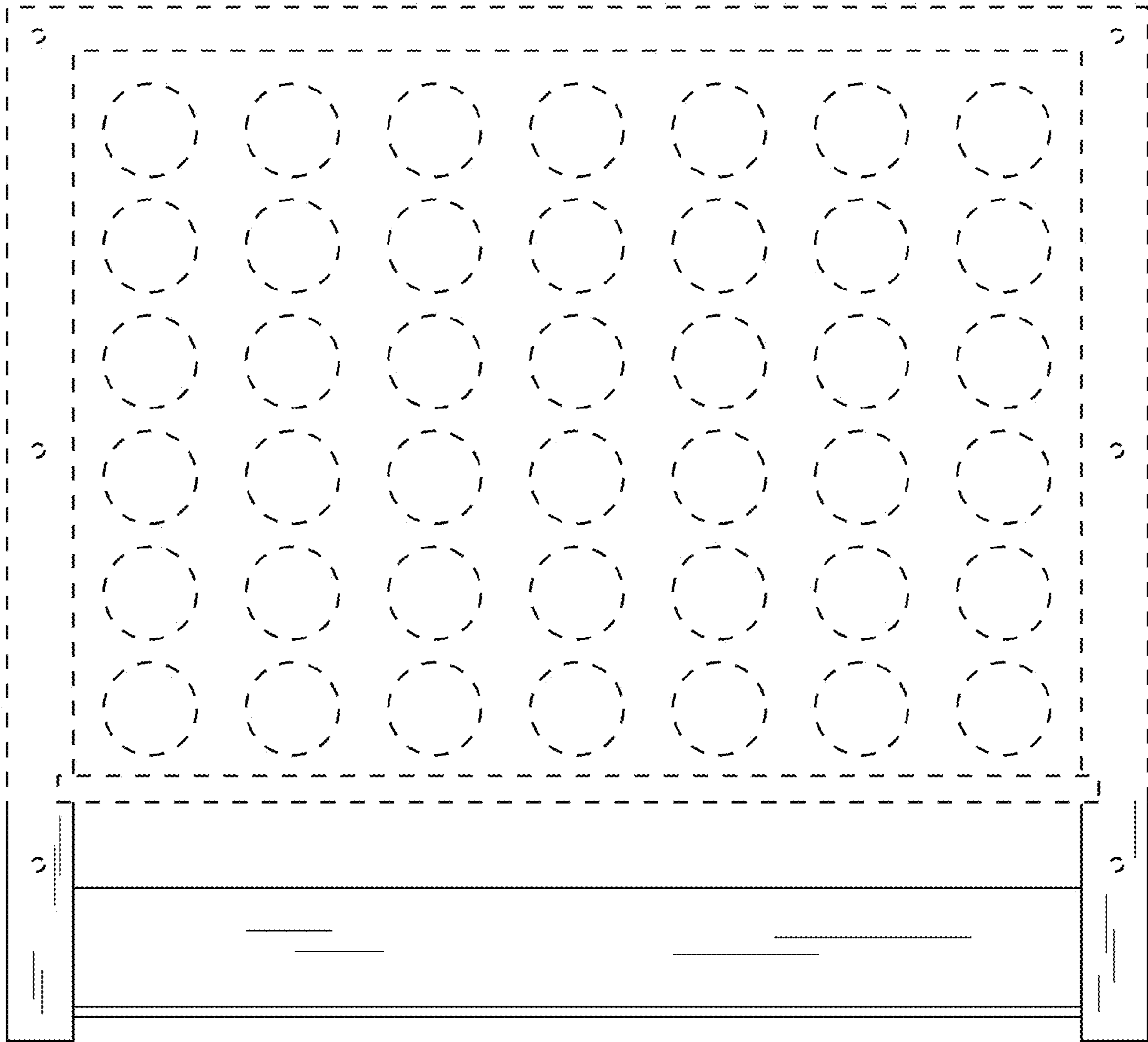

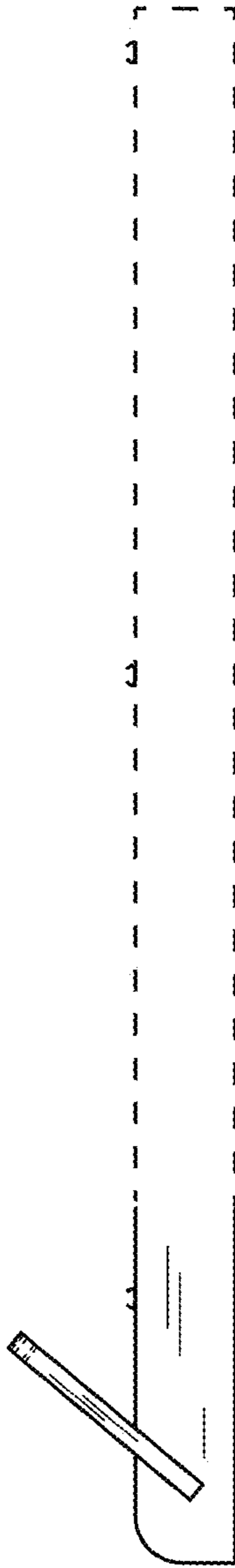

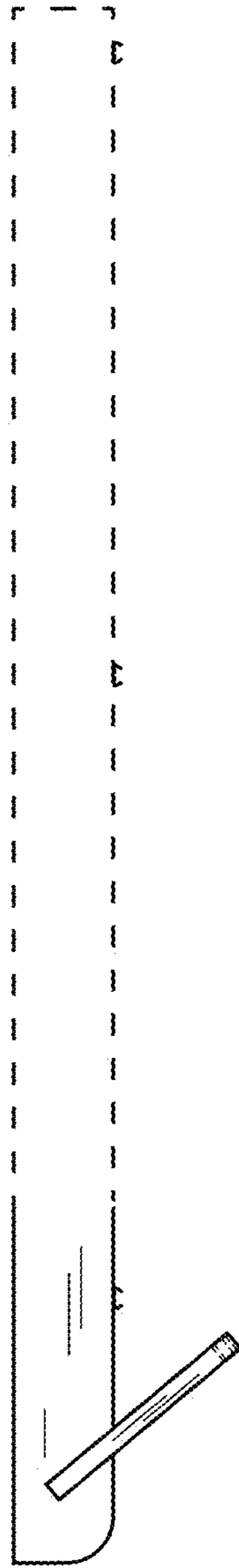

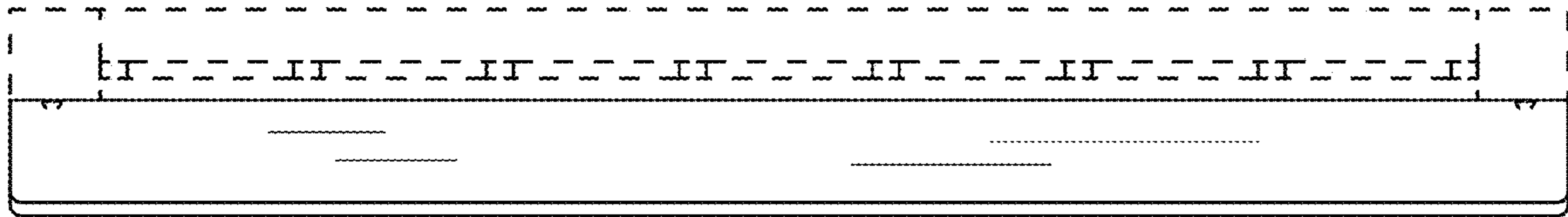

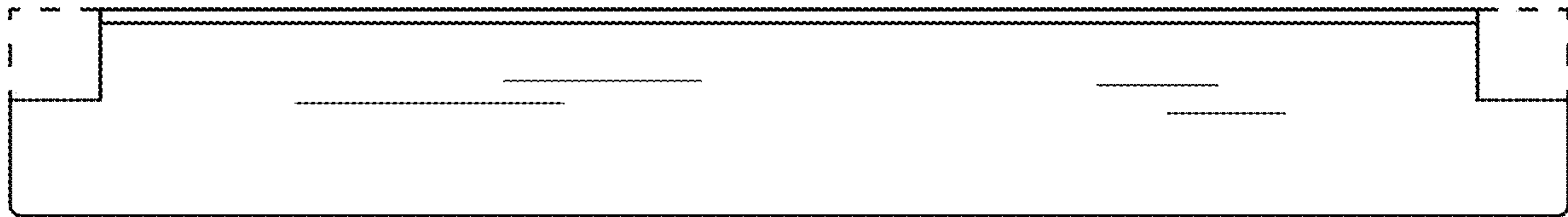
