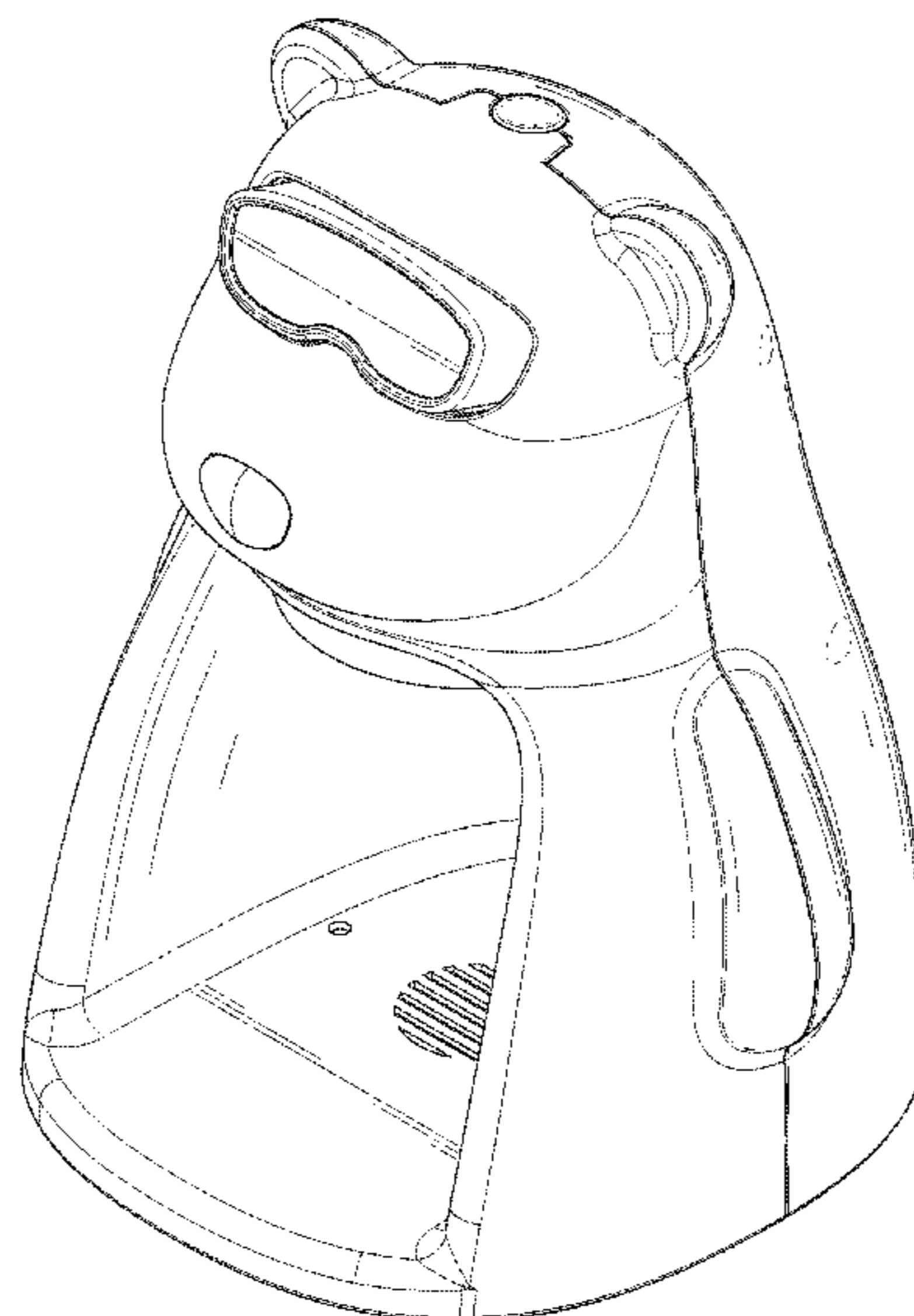
(57) **CLAIM**

The ornamental design for a coffee maker toy, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a coffee maker toy, showing my new design;

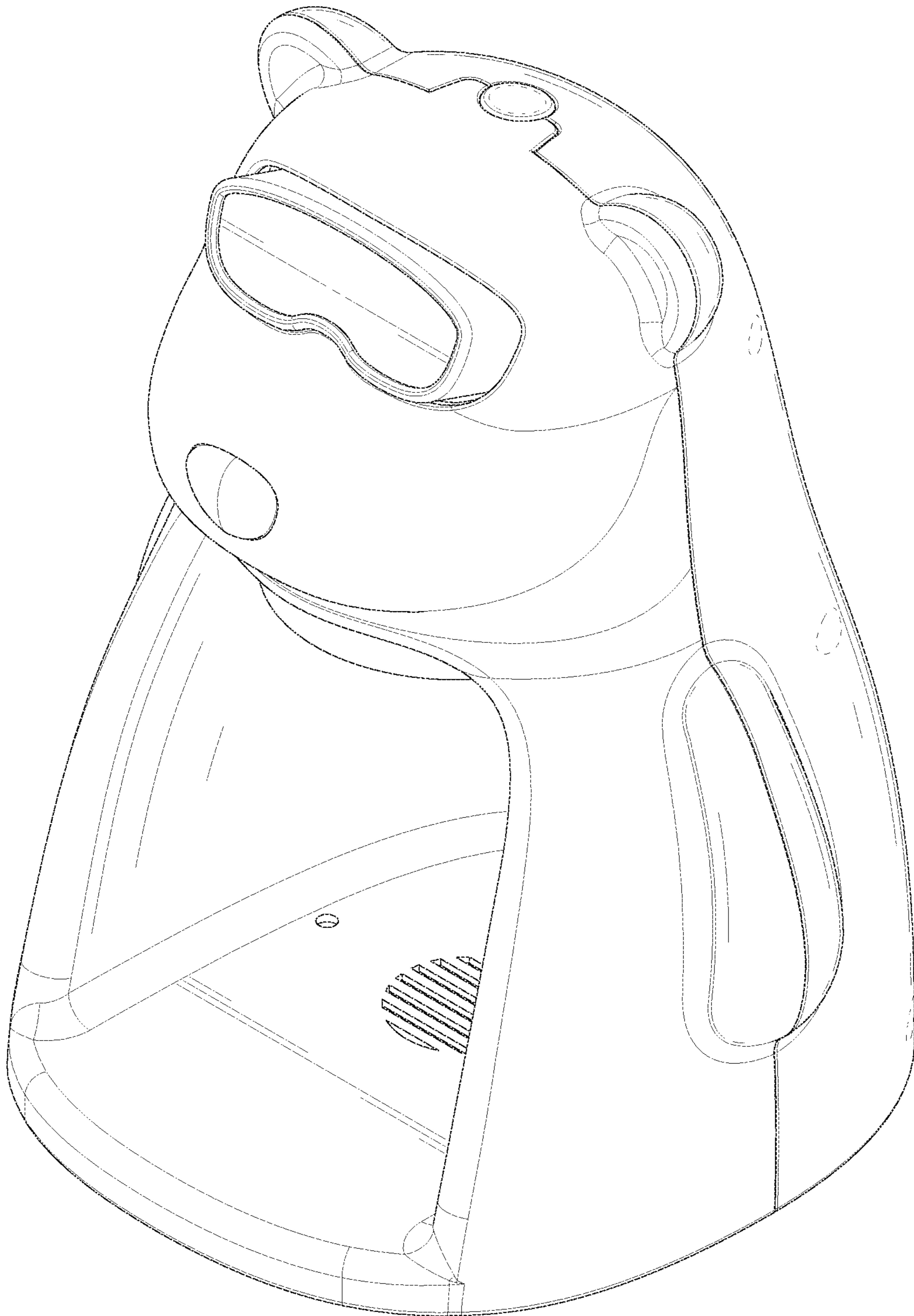

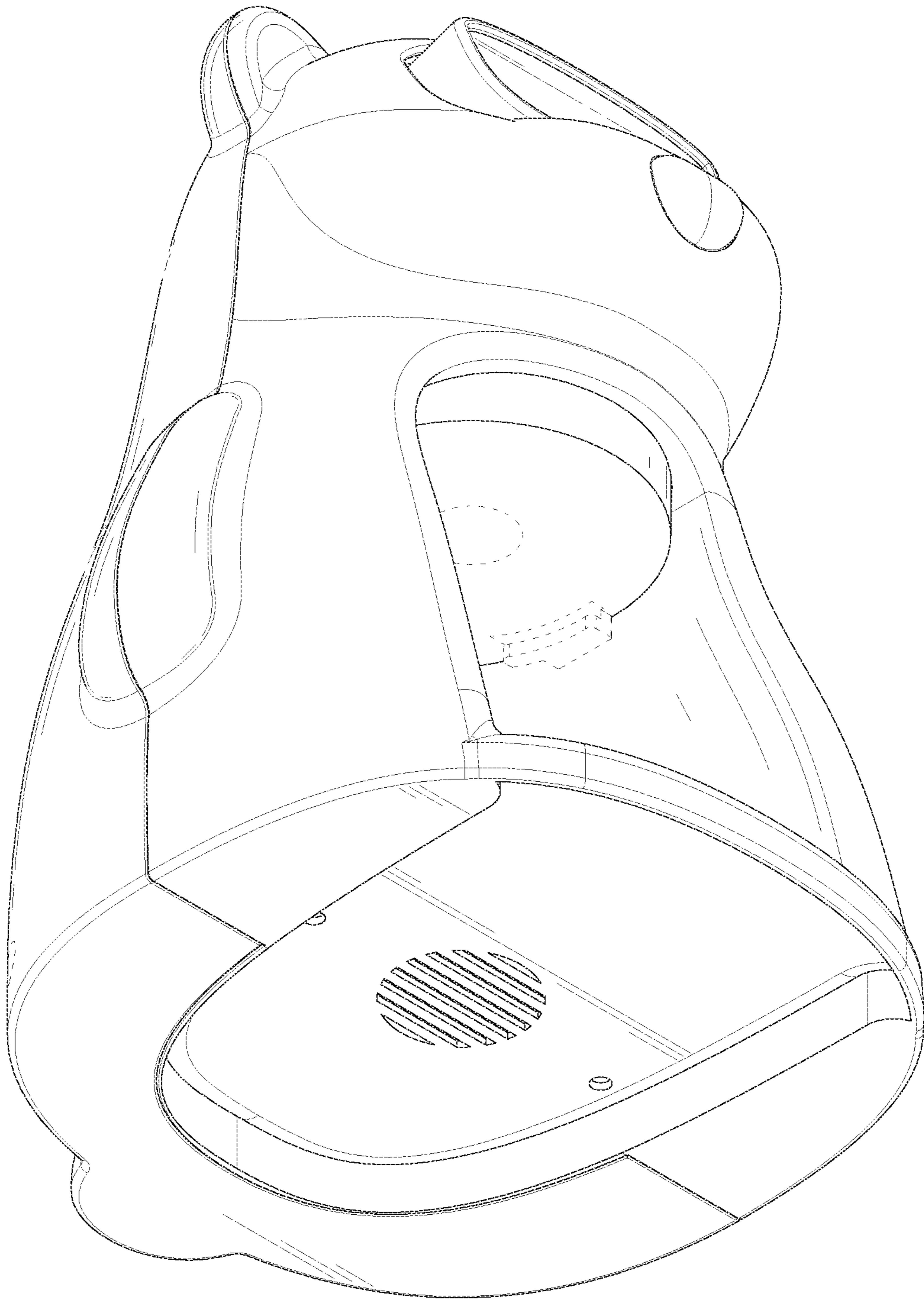

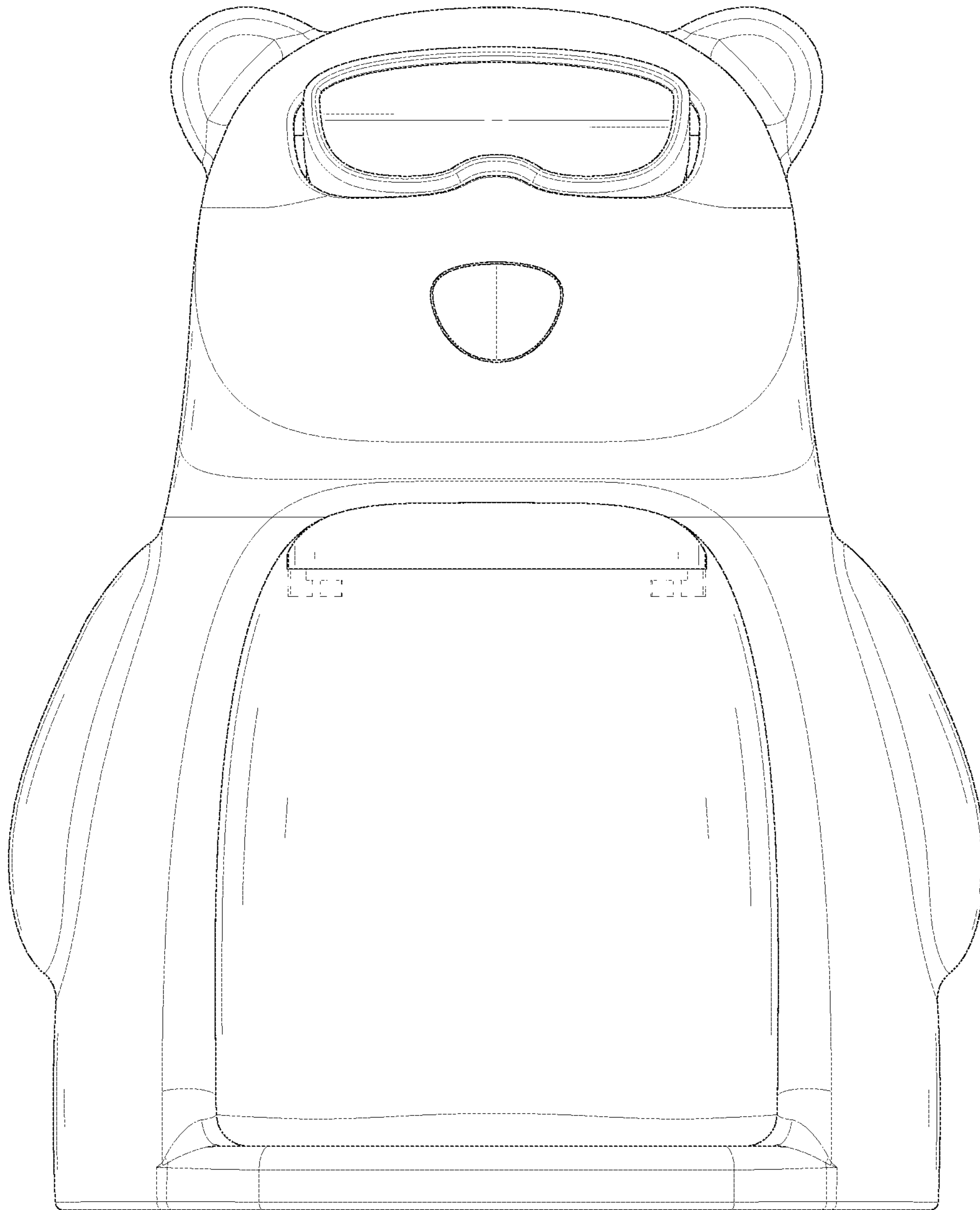

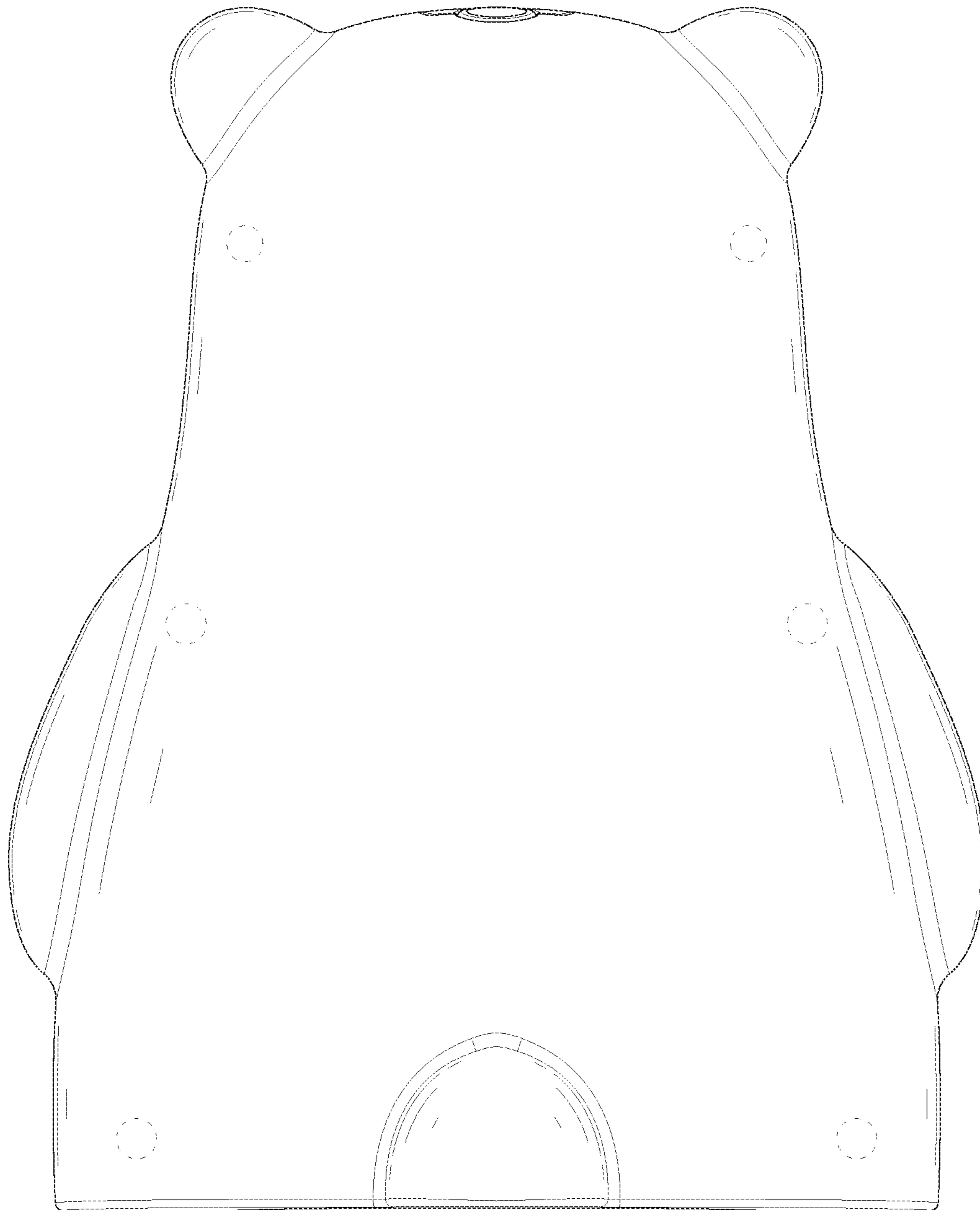

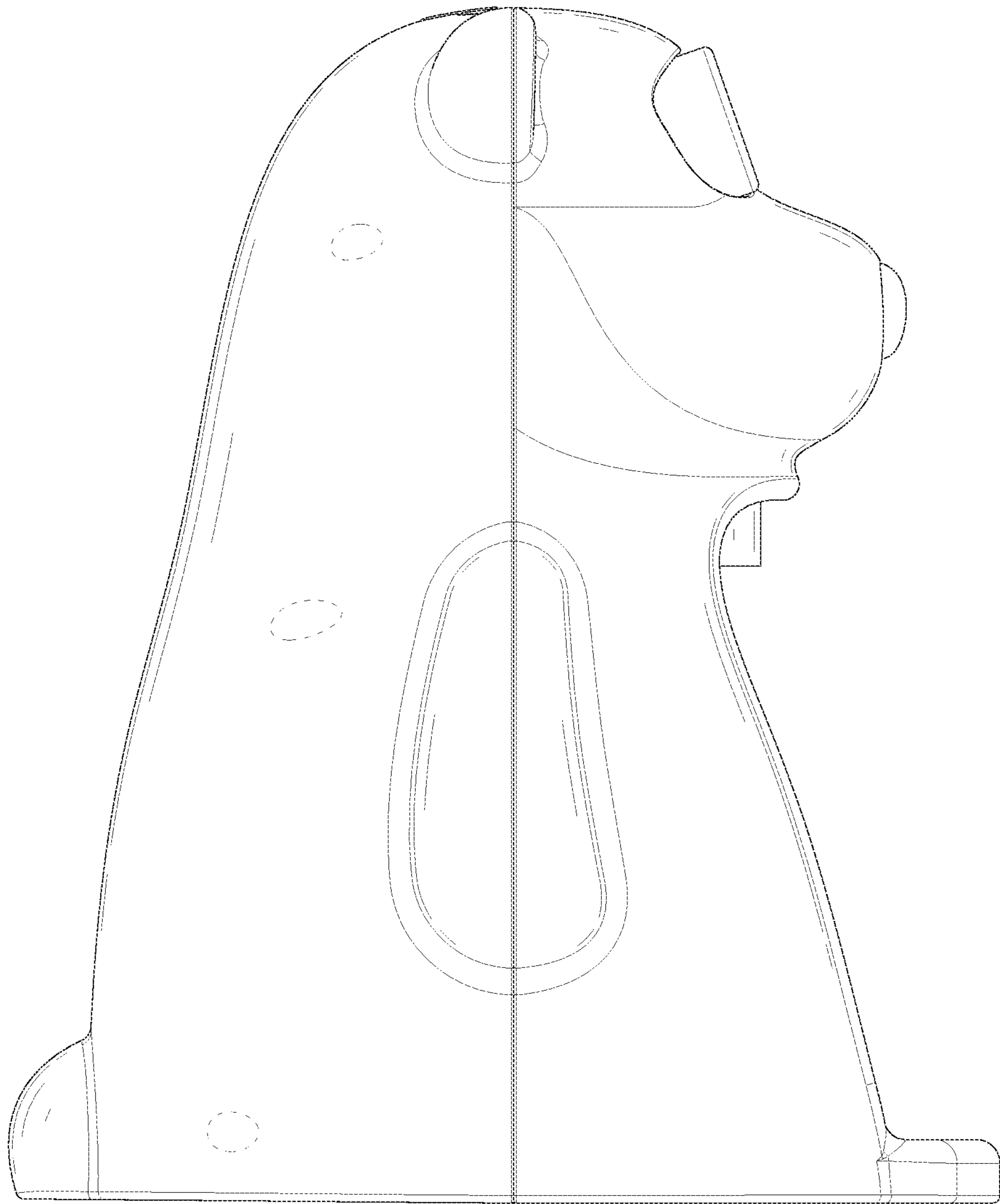

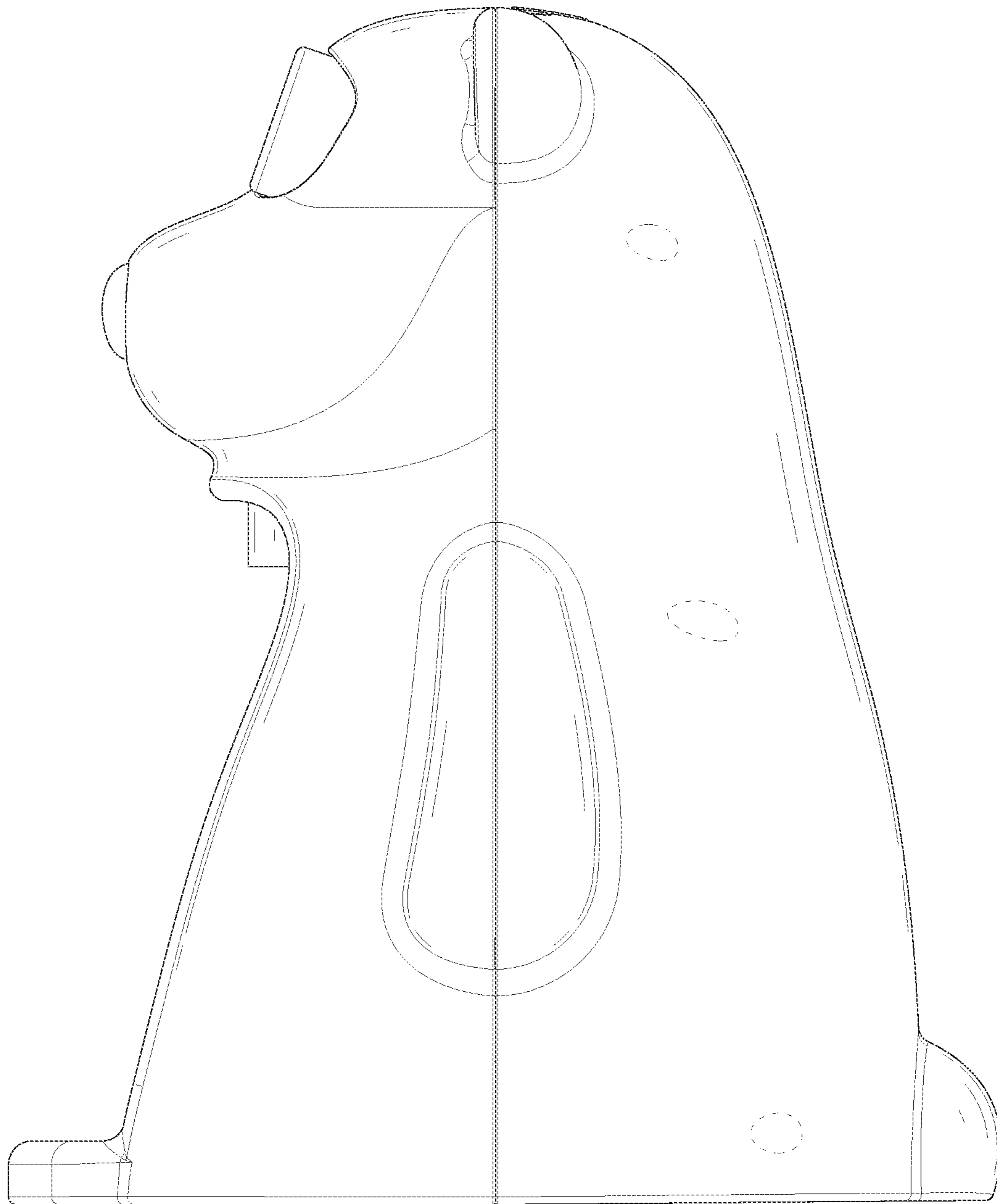

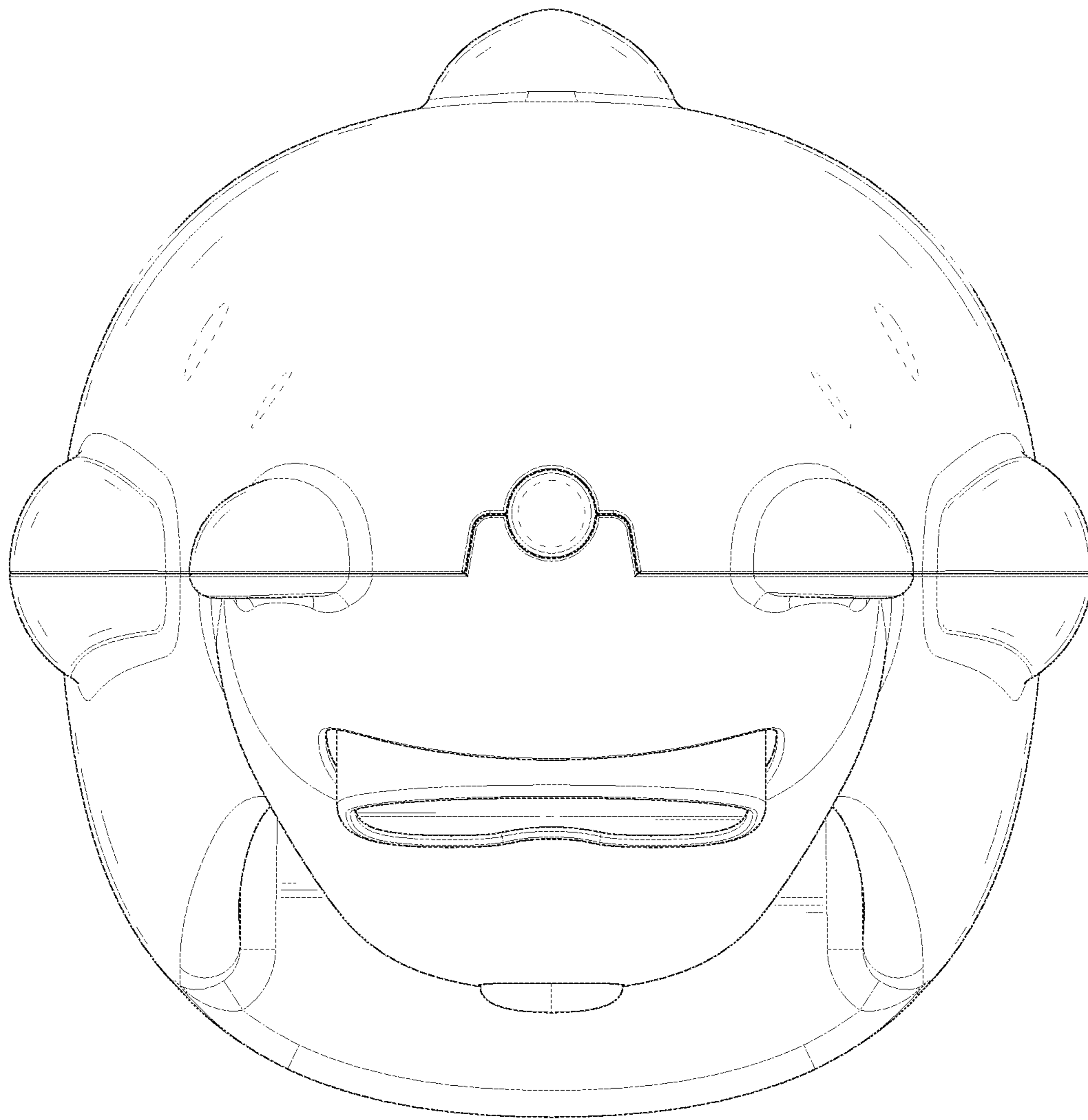

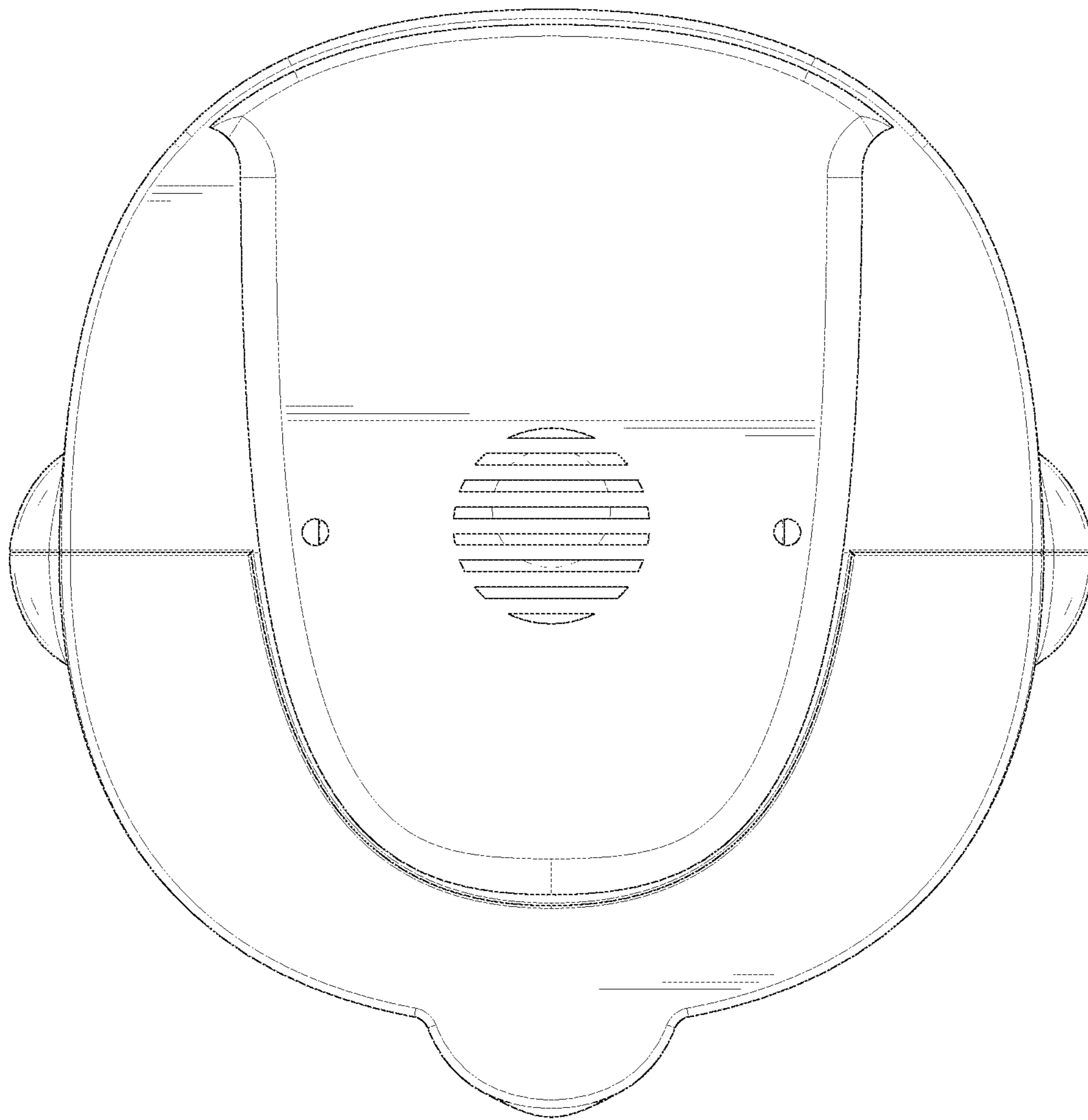
