The ornamental design for a ball for sports, as shown and described.

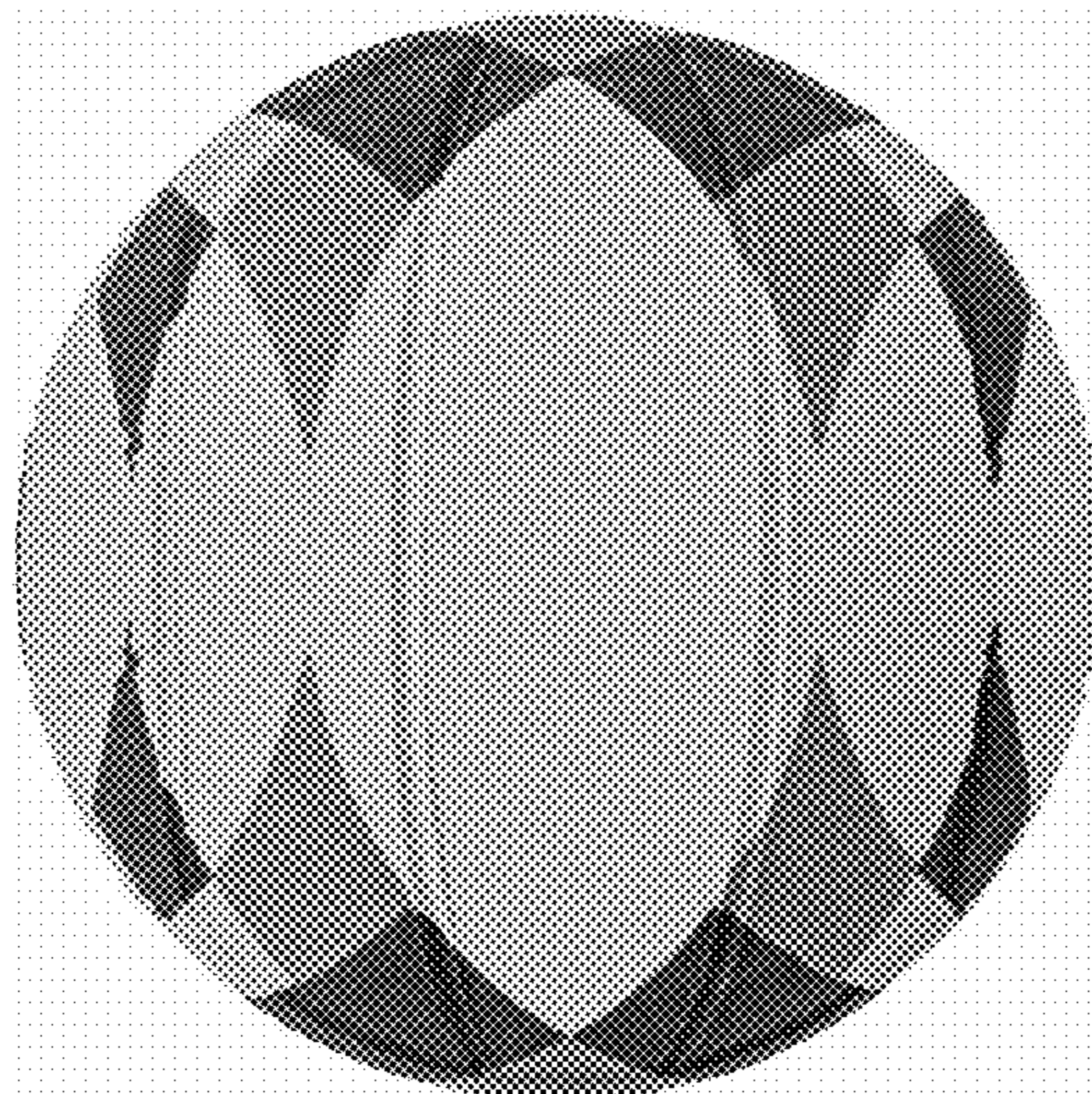
DESCRIPTION

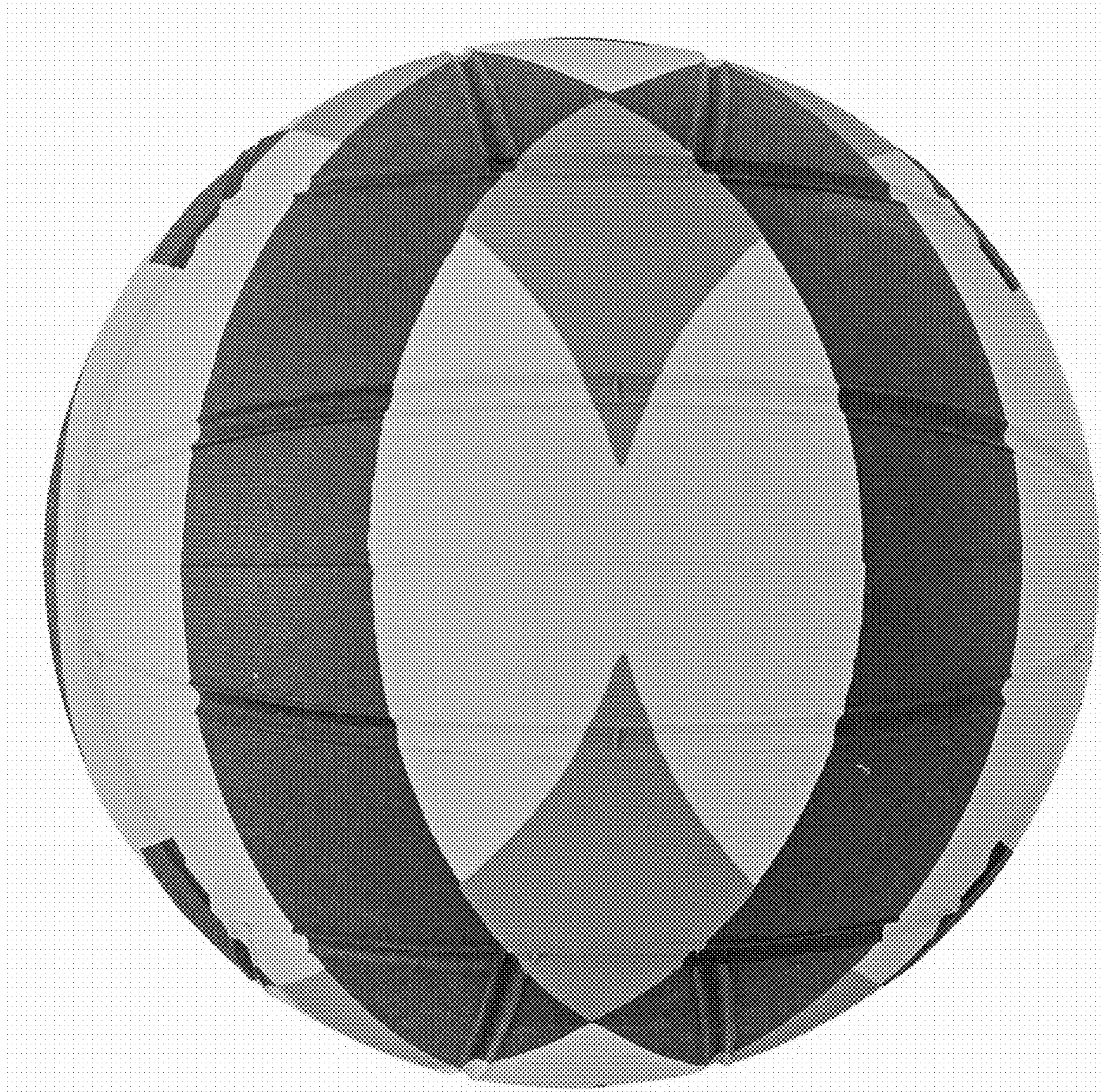

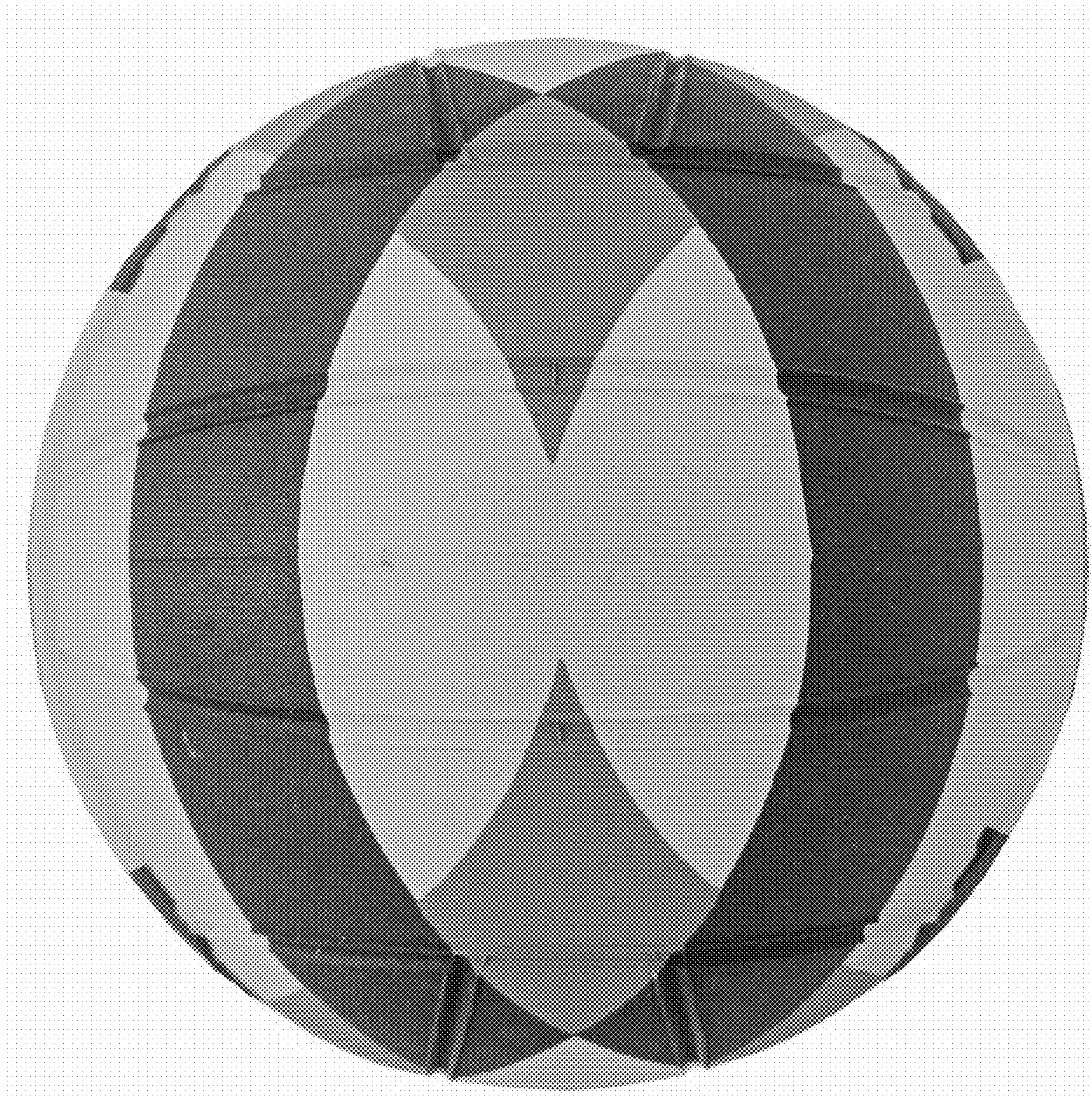

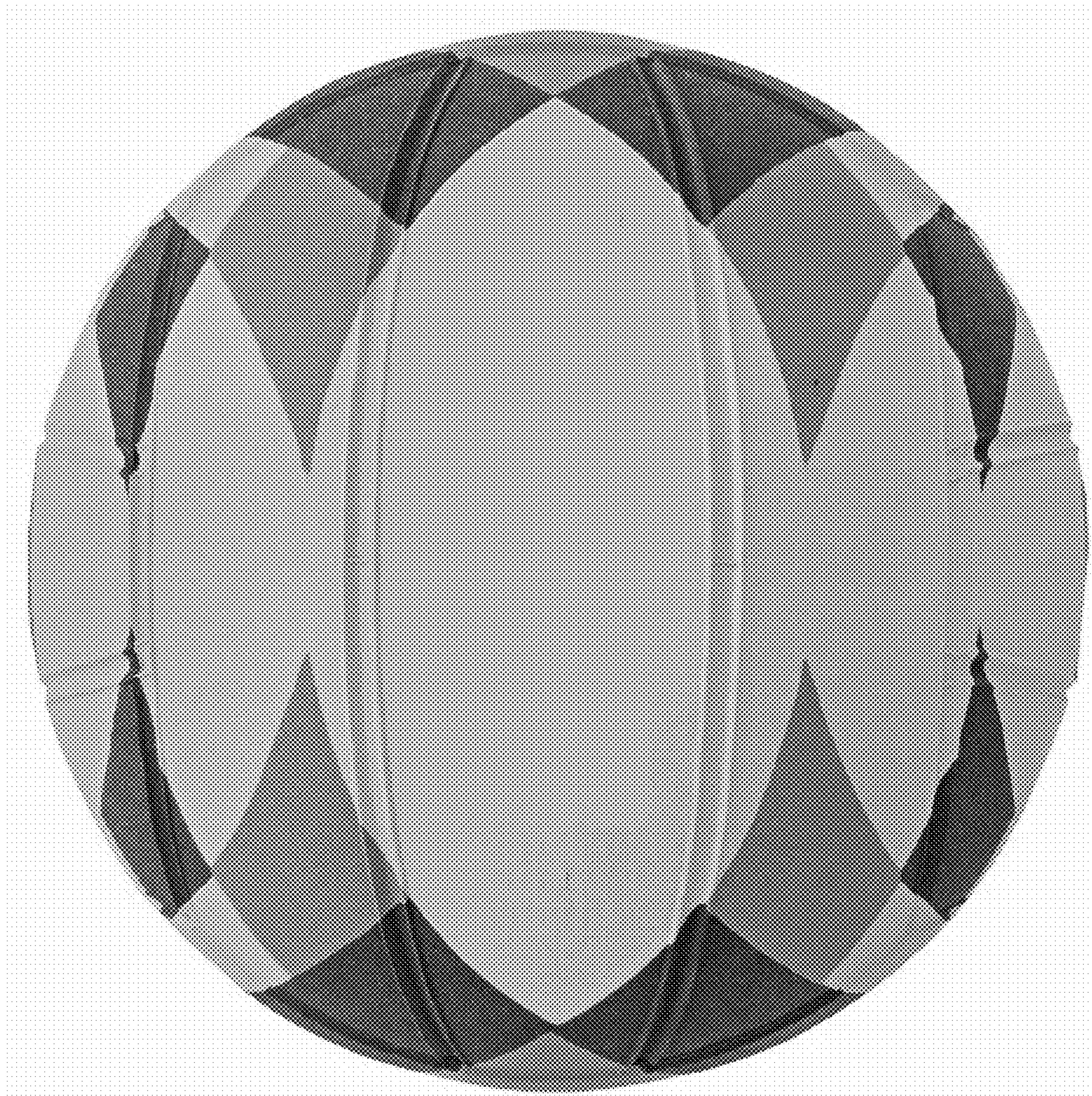
