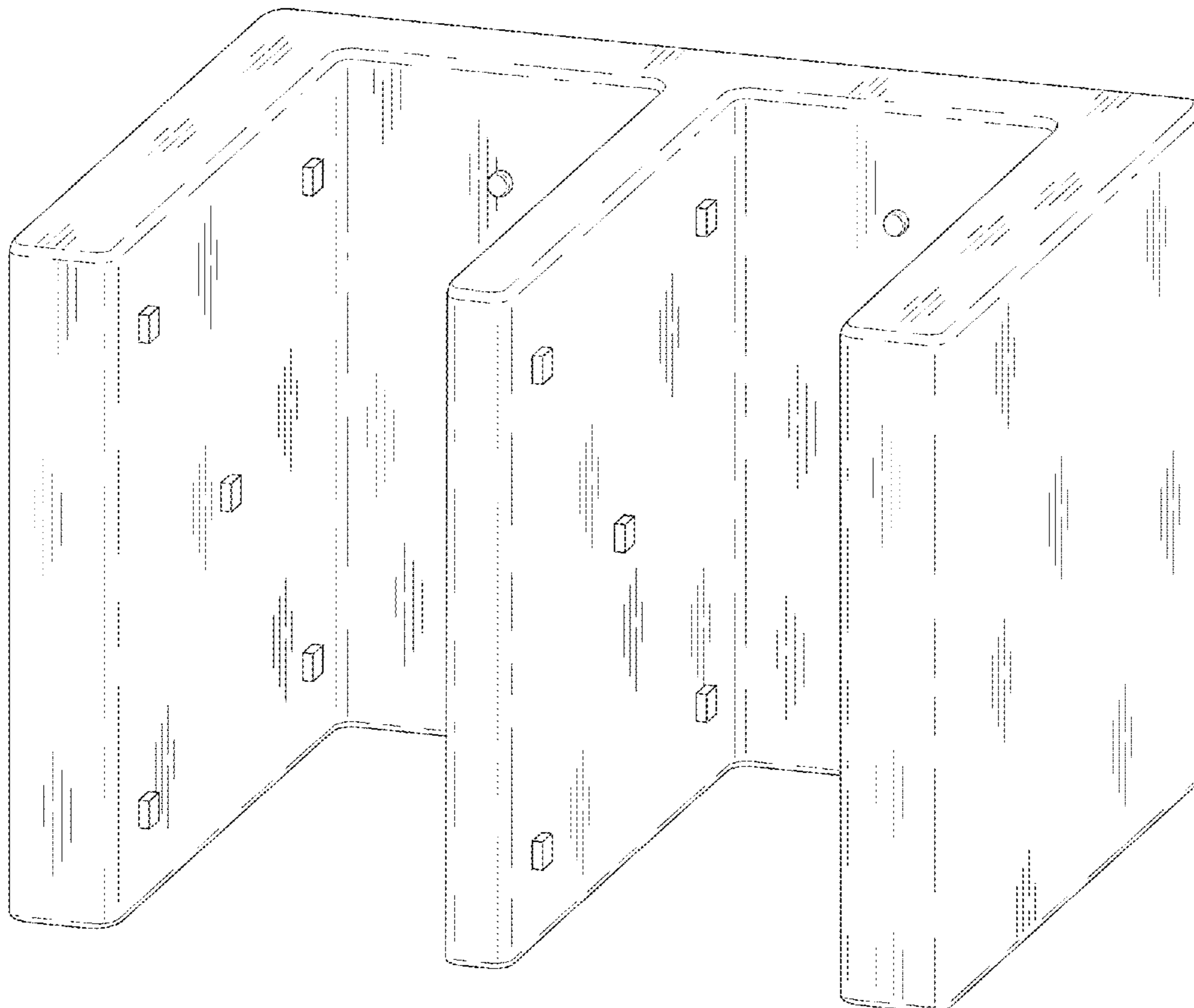
(57) **CLAIM**

The ornamental design for a public restroom hand sanitizer, as shown and described.

DESCRIPTION

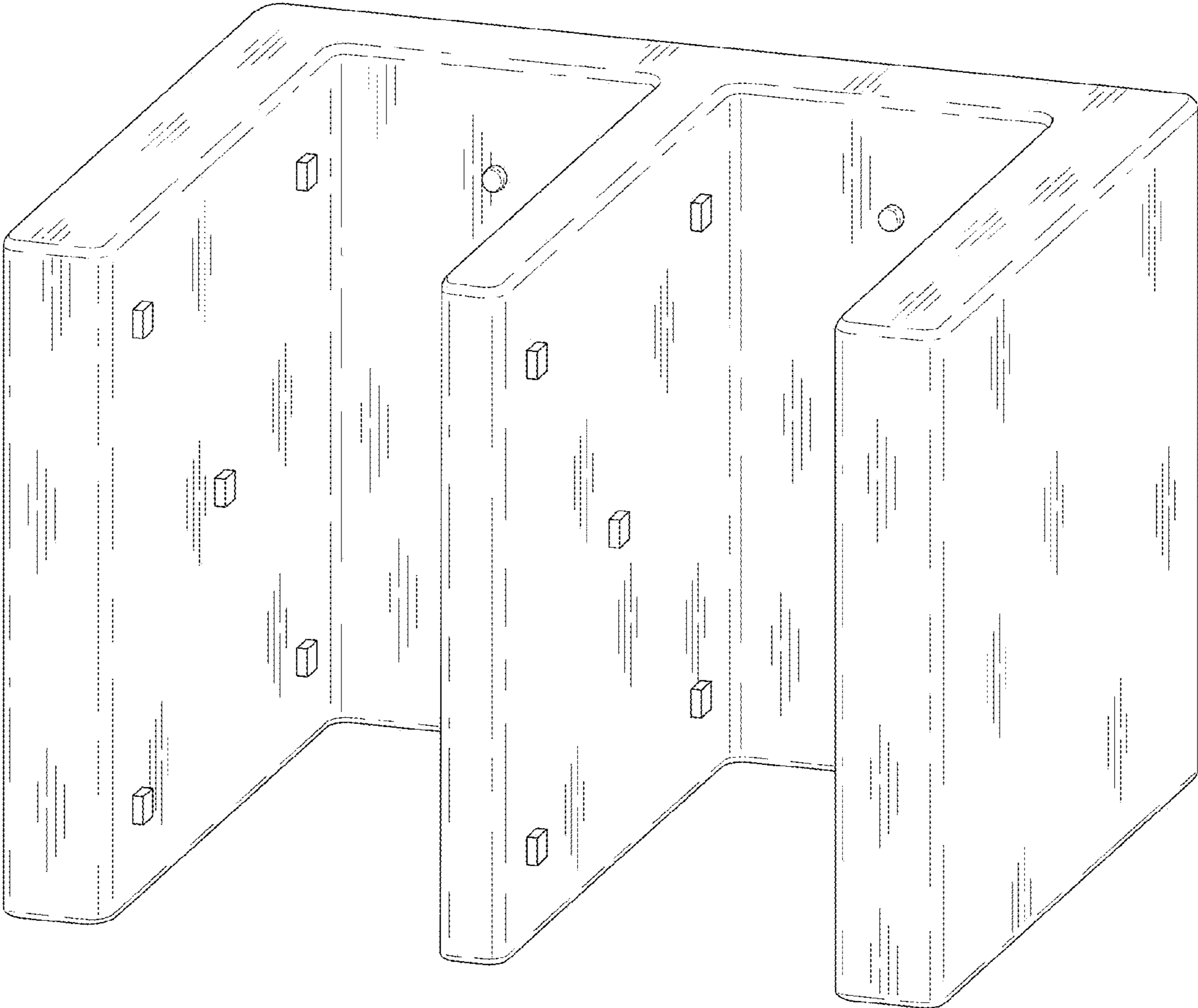

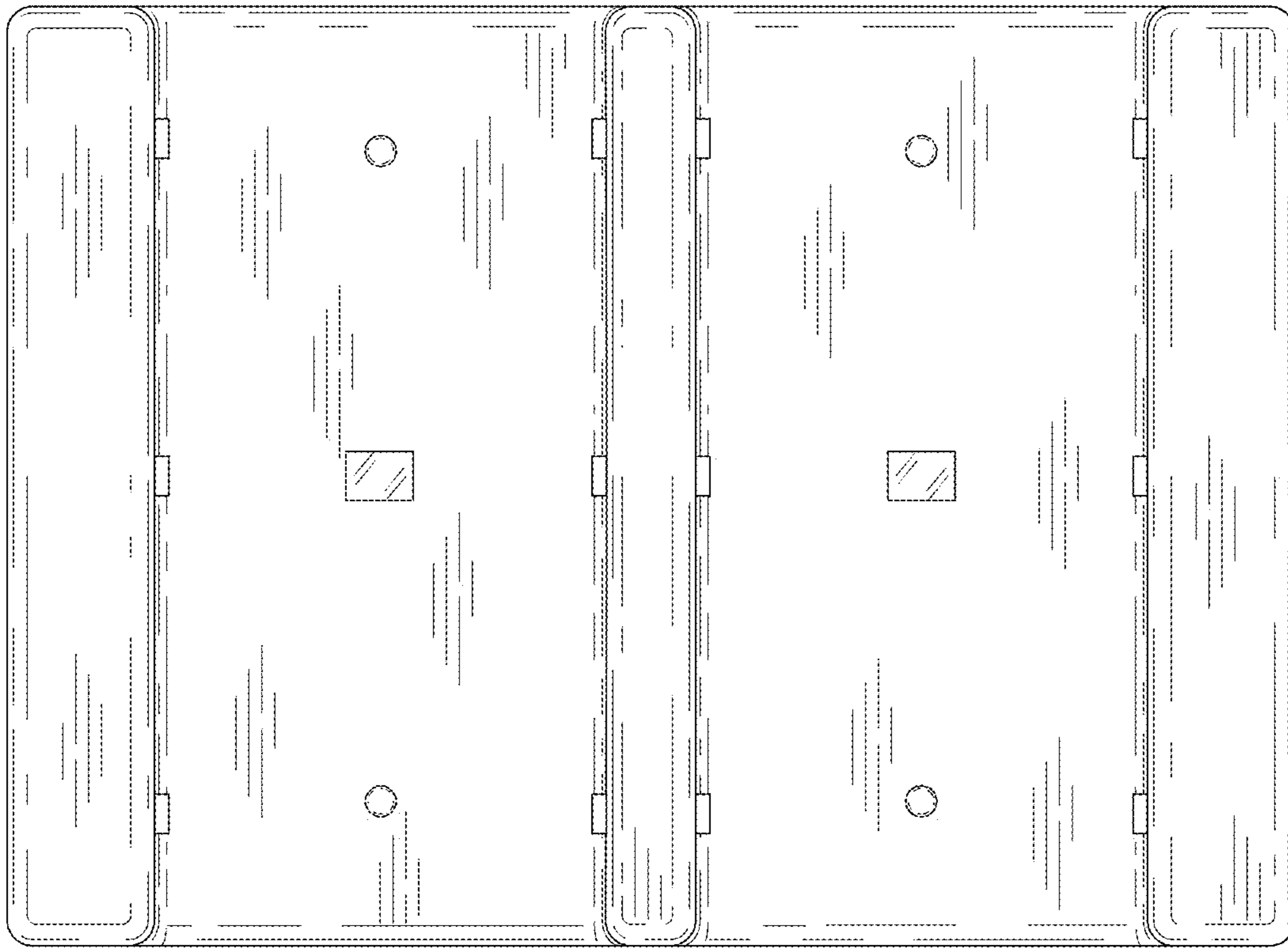

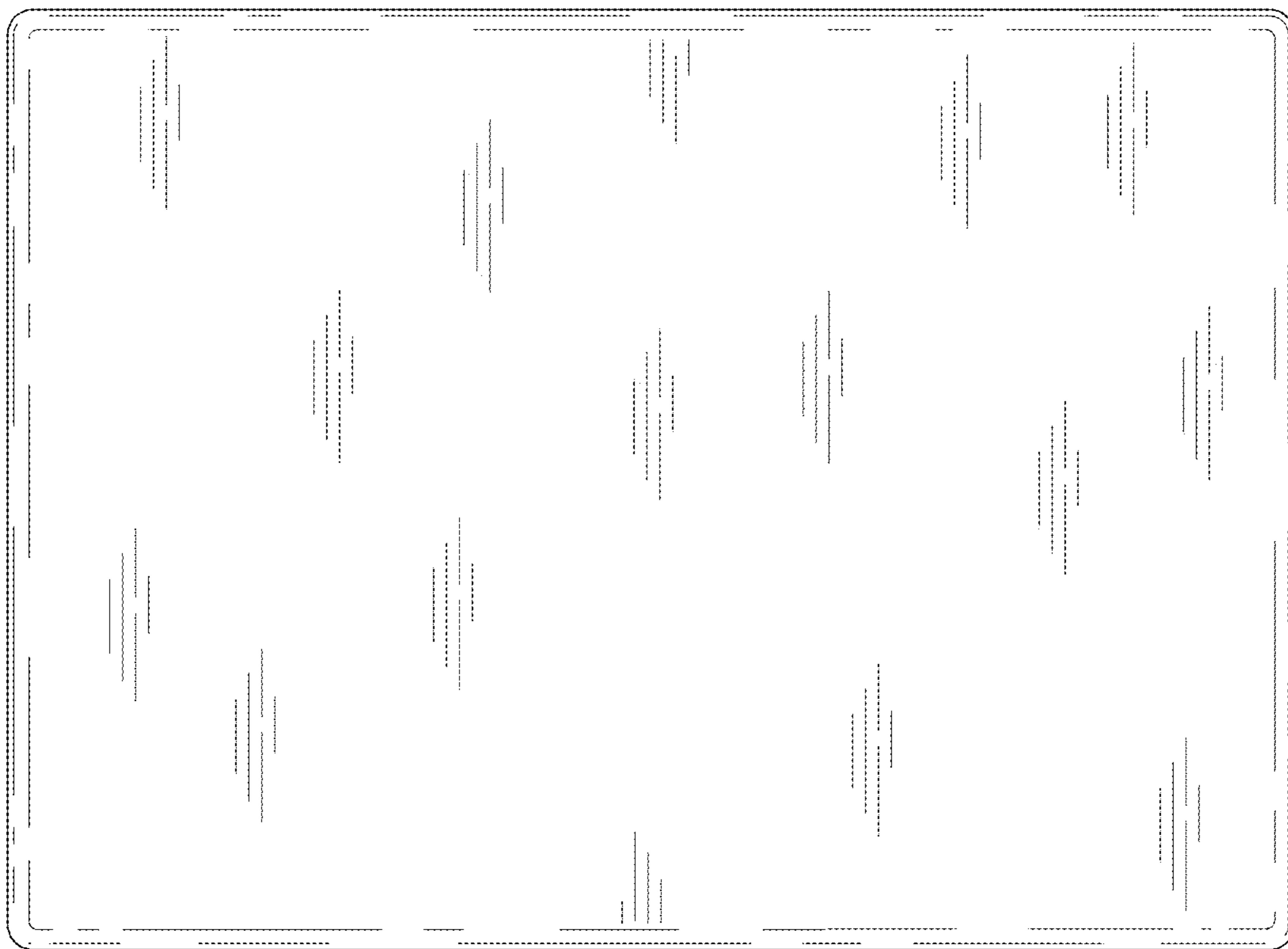

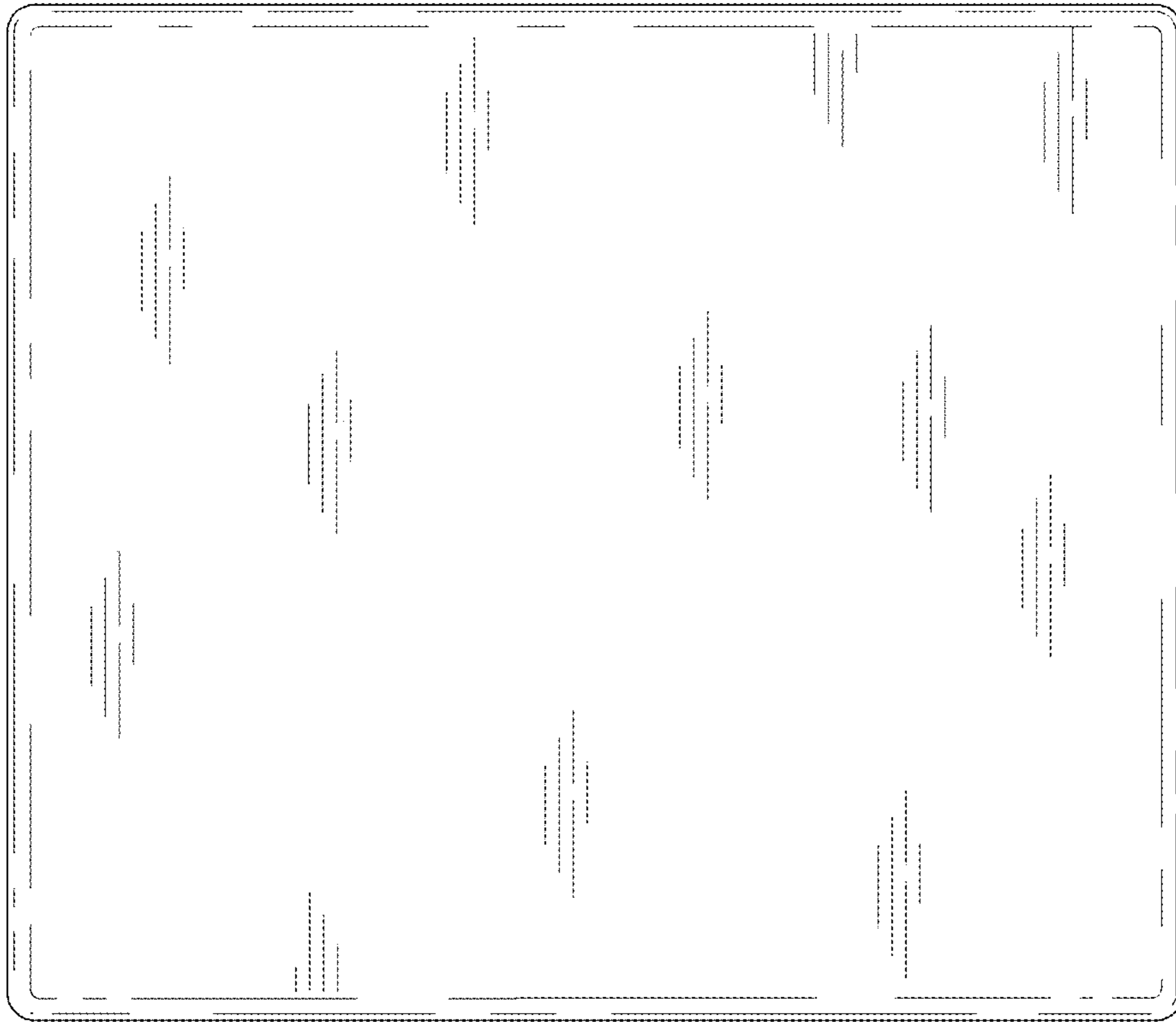

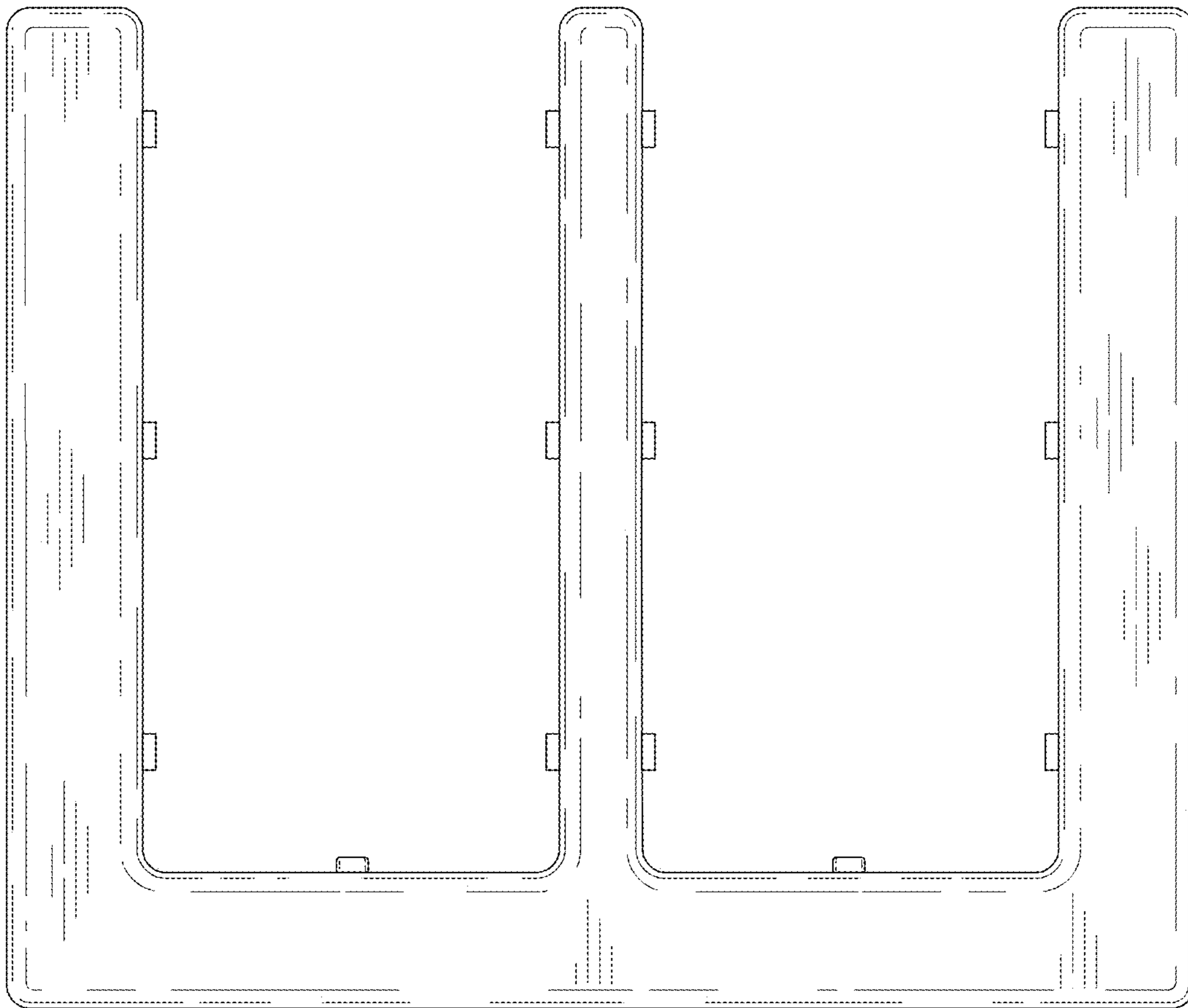

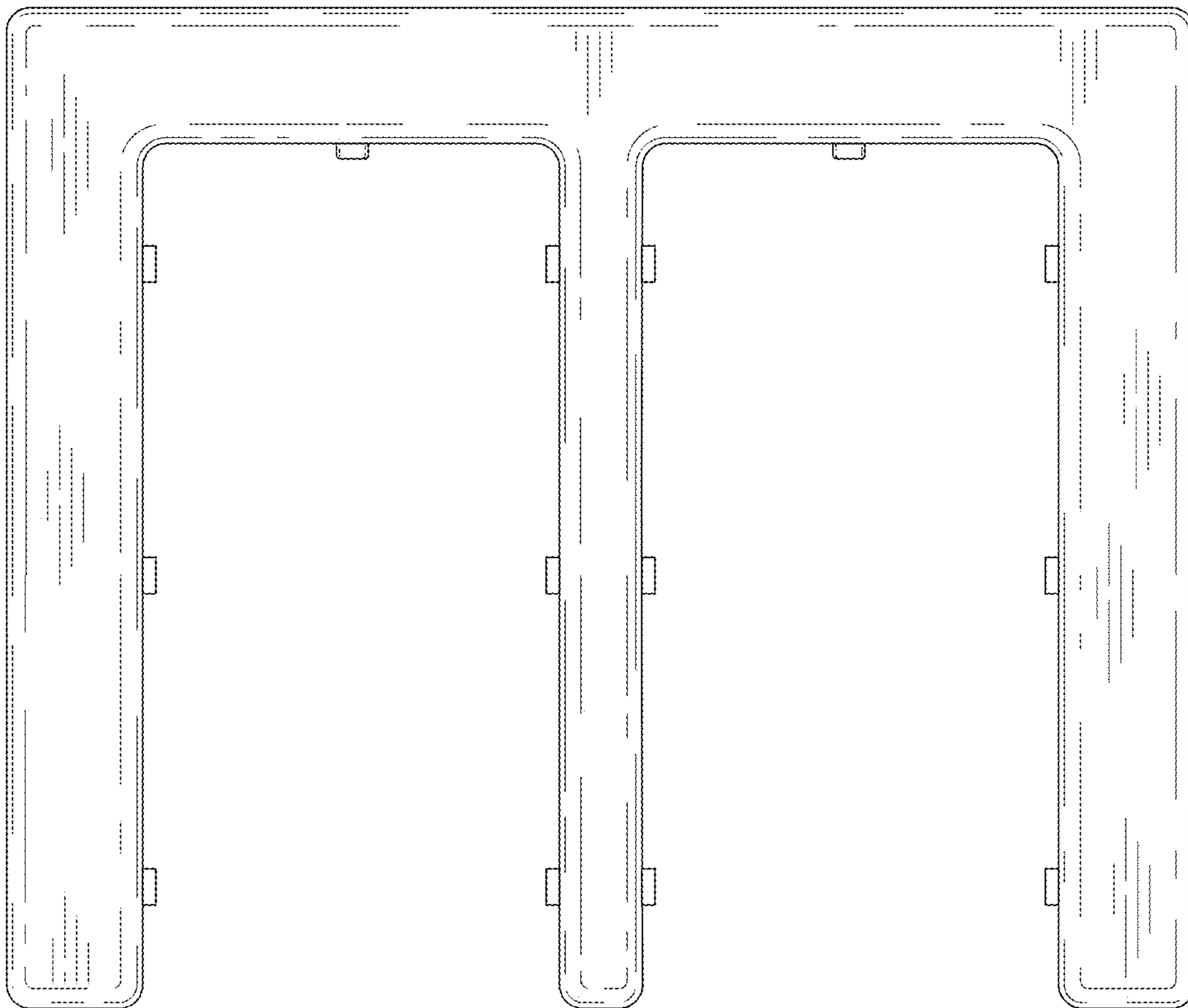
