(57) **CLAIM**

I claim, the ornamental design for a urine collector, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective of the urine collector in a closed configuration.

FIG. 2 is a bottom perspective of the urine collector of FIG. 1 in the closed configuration.

FIG. 3 is a top plan view of the urine collector of FIG. 1 in the closed configuration.

FIG. 4 is a bottom view of the urine collector of FIG. 1 in the closed configuration.

FIG. 5 is a first side elevational view of the urine collector of FIG. 1 in the closed configuration, which is a mirror image of an opposing second side thereof.

FIG. 6 is a first end elevational view of the urine collector of FIG. 1 in the closed configuration.

FIG. 7 is a second end elevational view of the urine collector of FIG. 1 in the closed configuration.

FIG. 8 is a perspective view of the urine collector of FIG. 1 in a partially open configuration.

FIG. 9 is a top view of the urine collector of FIG. 1 in an open configuration.

FIG. 10 is a bottom view of the urine collector of FIG. 9 in the open configuration.

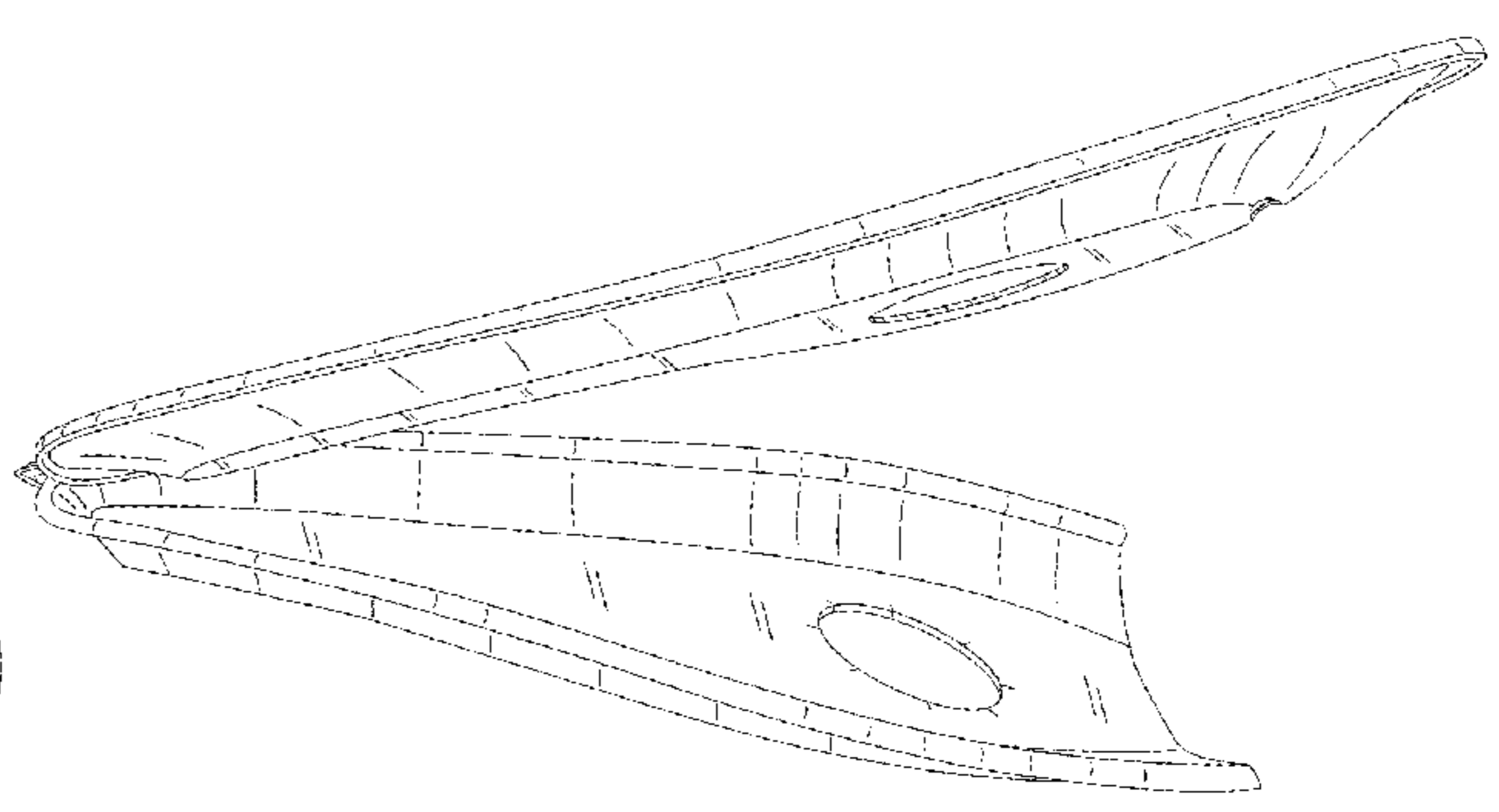
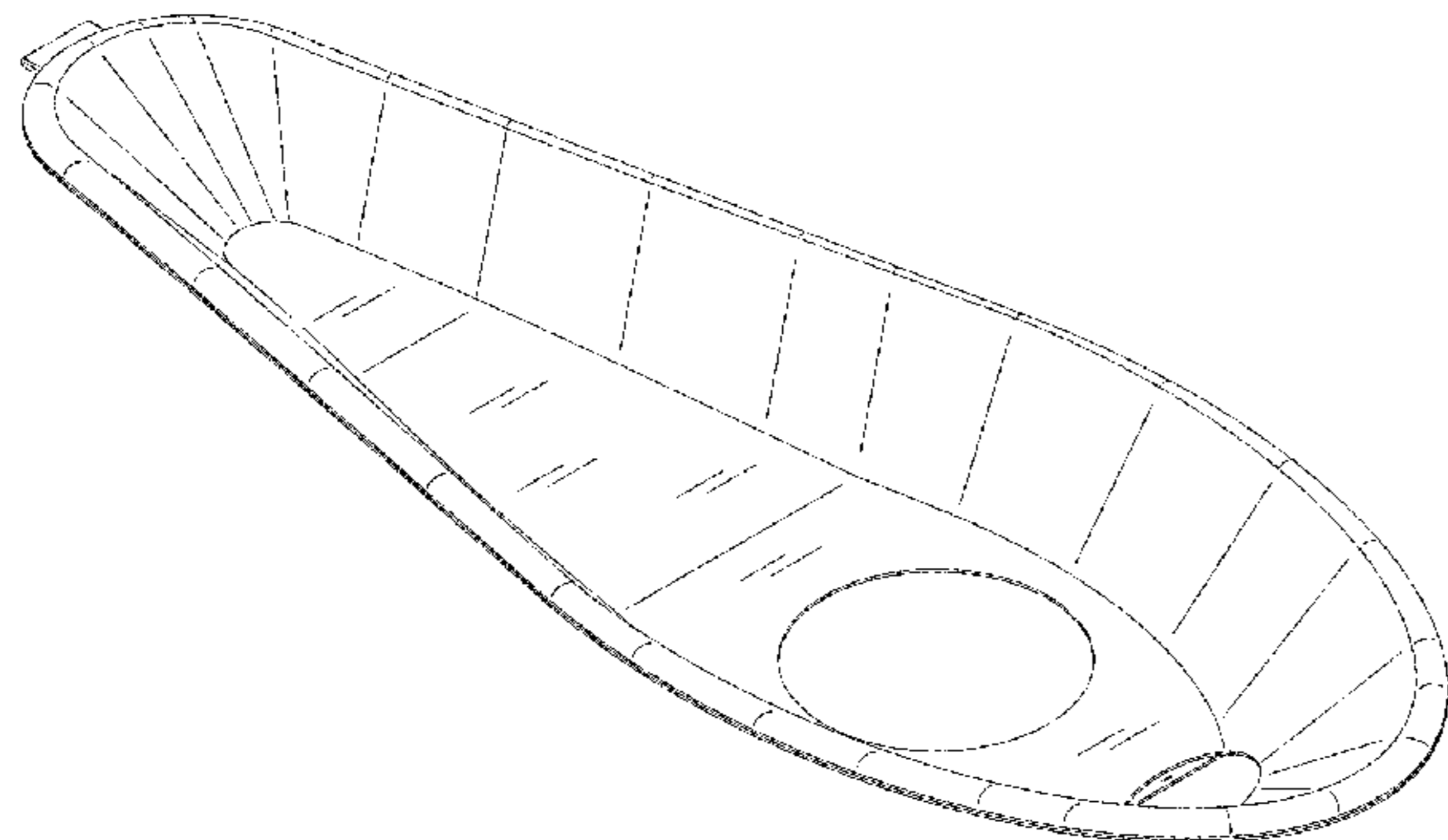
FIG. 11 is an elevational view of the first side of the urine collector of FIG. 1 in a partially open configuration, which is a mirror image of the opposing second side thereof.

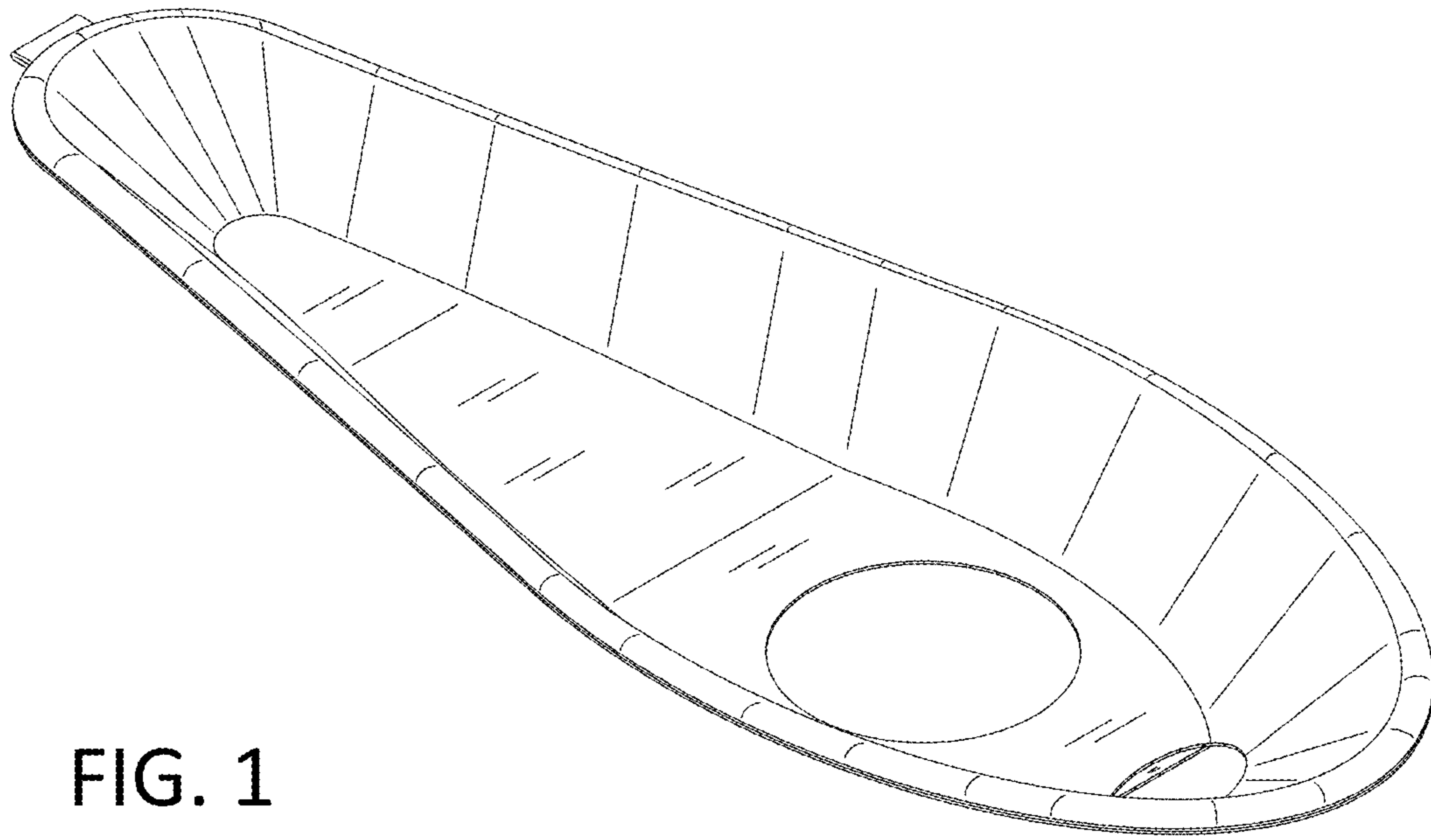

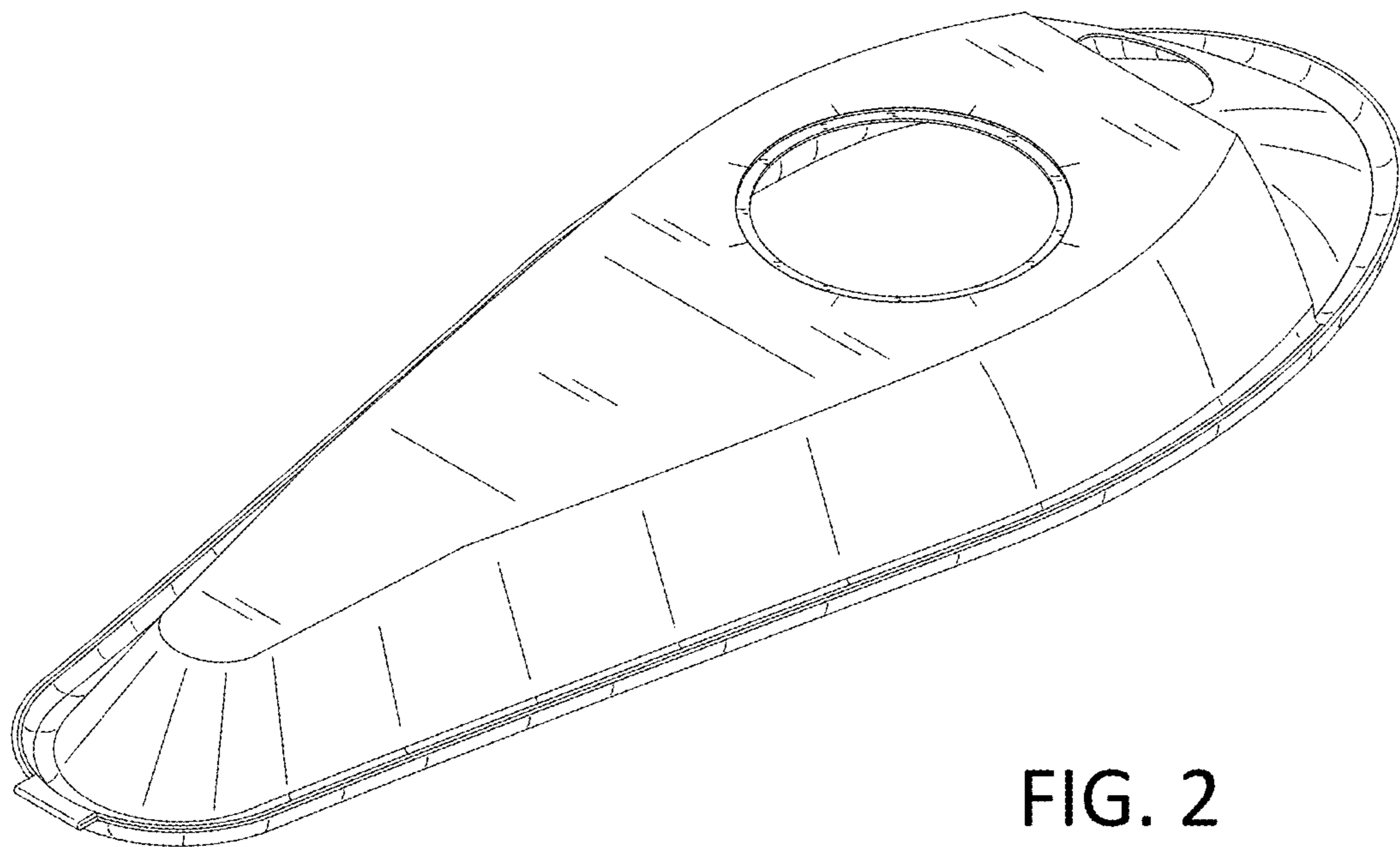

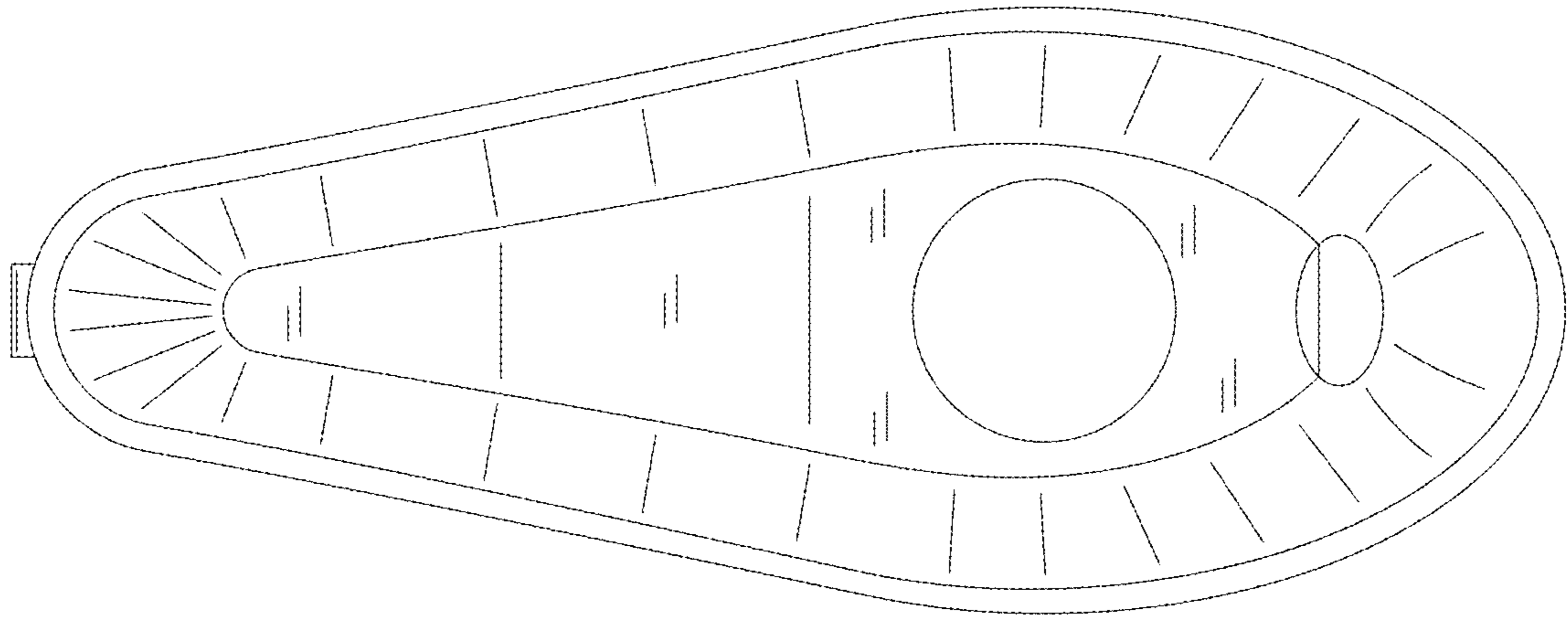

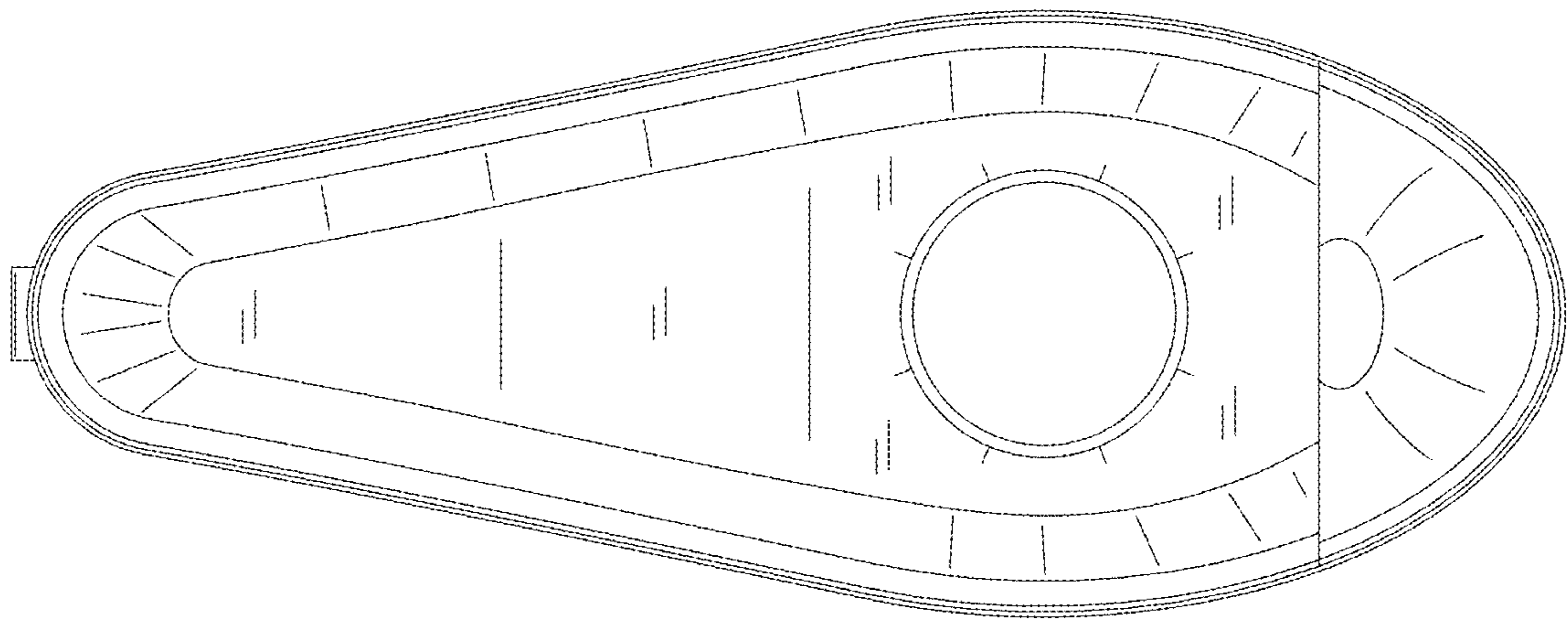

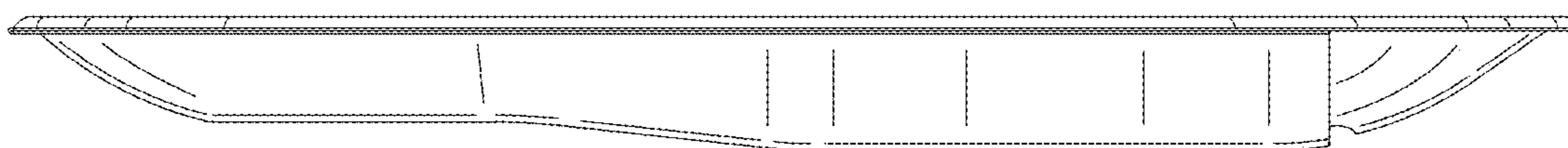

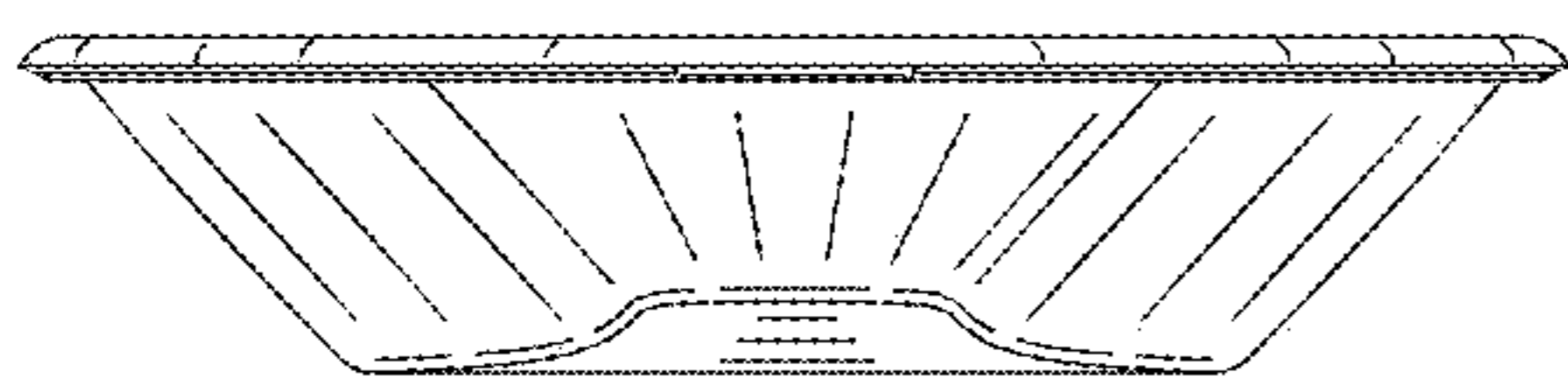

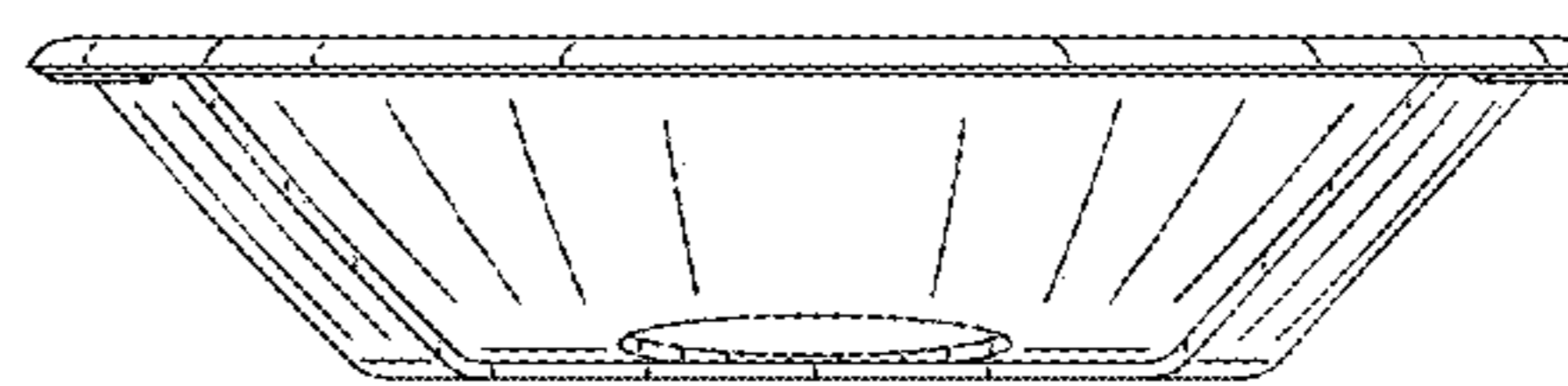

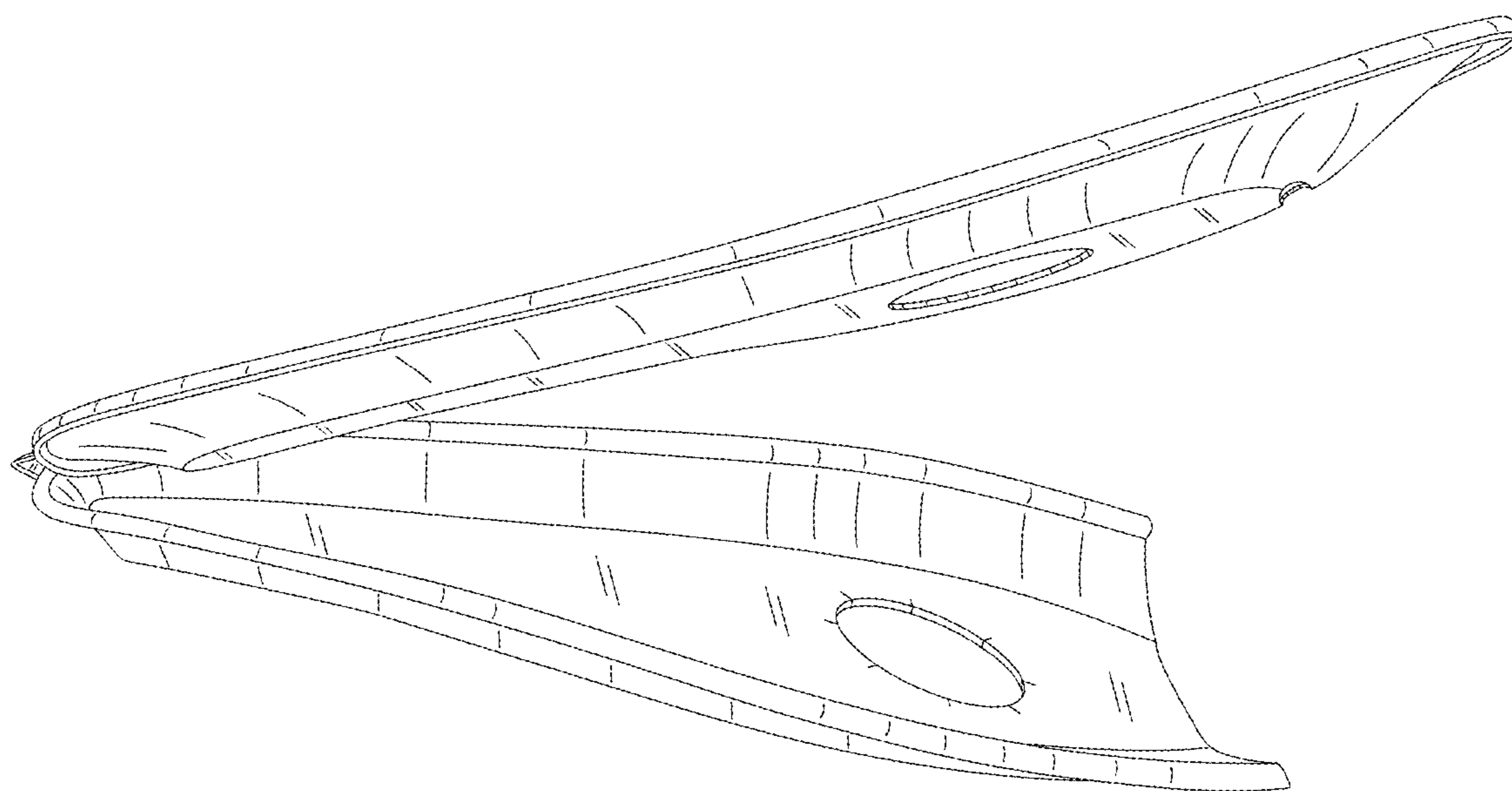

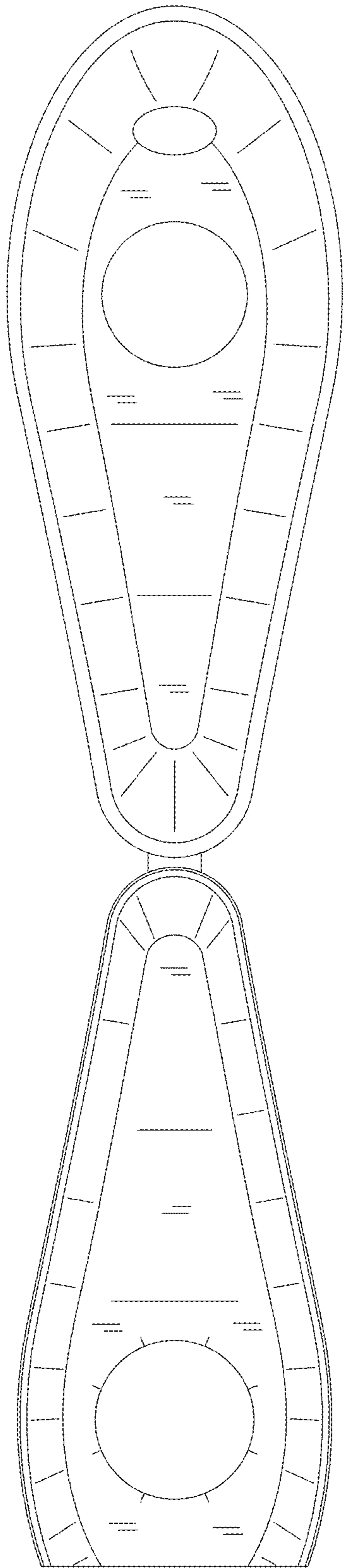

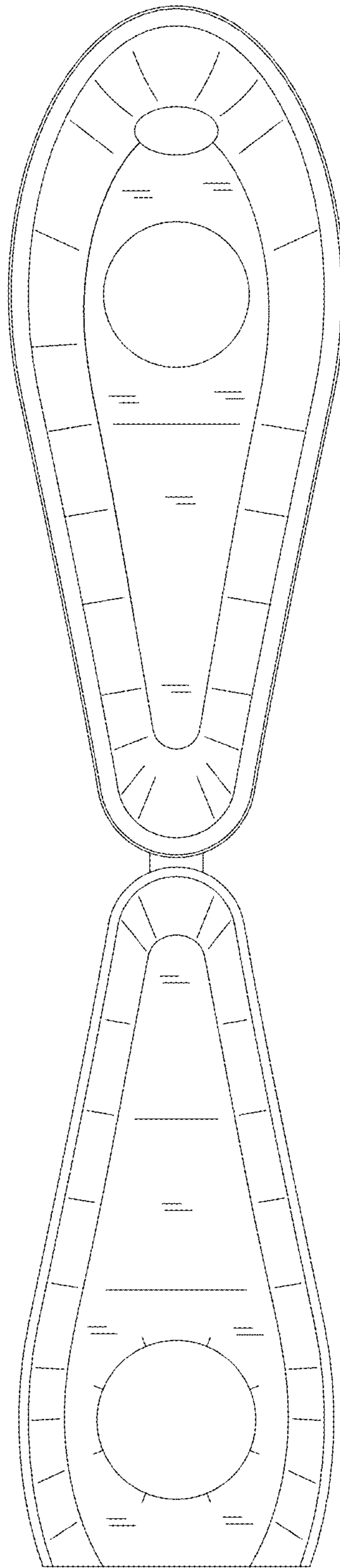

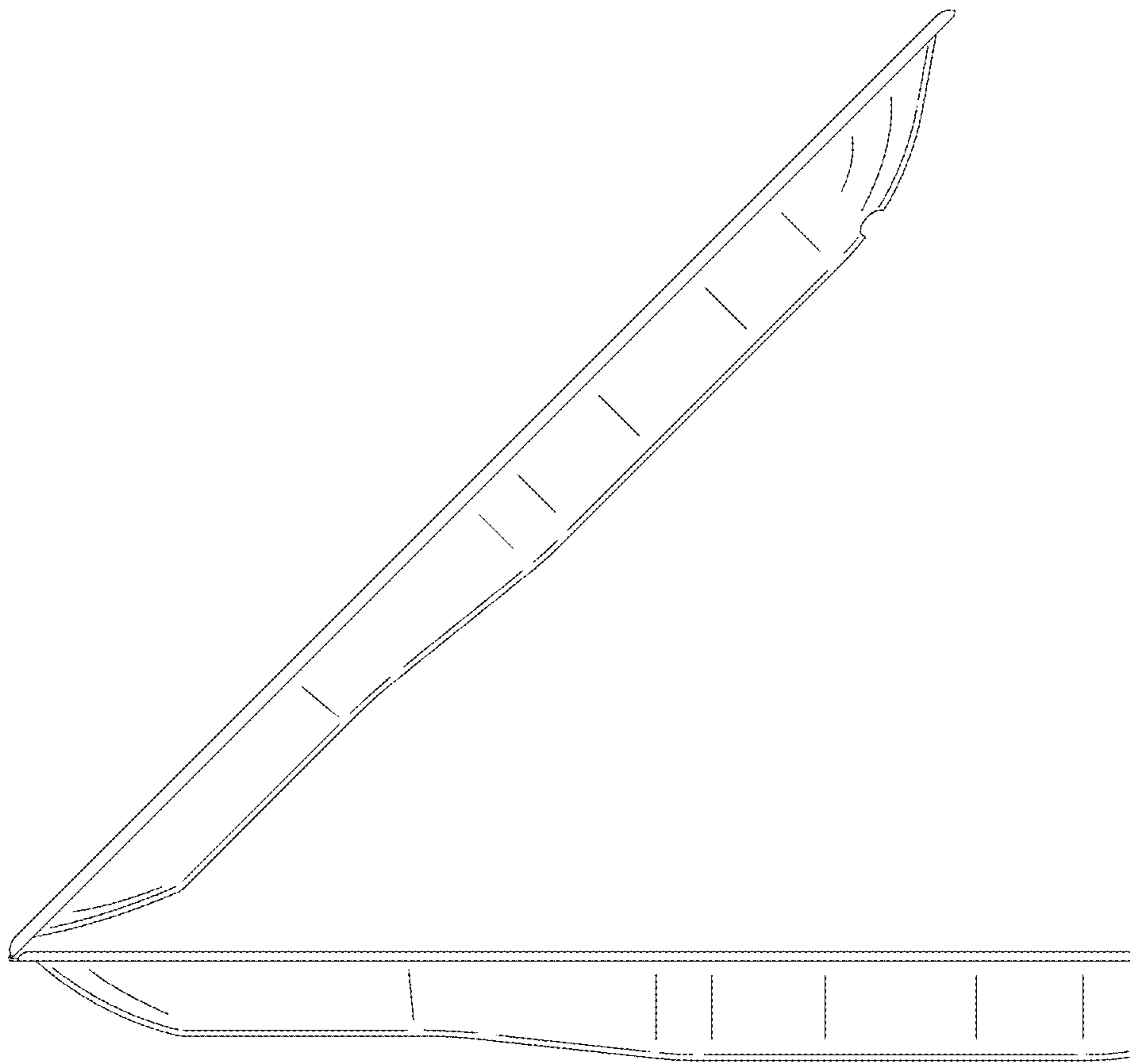

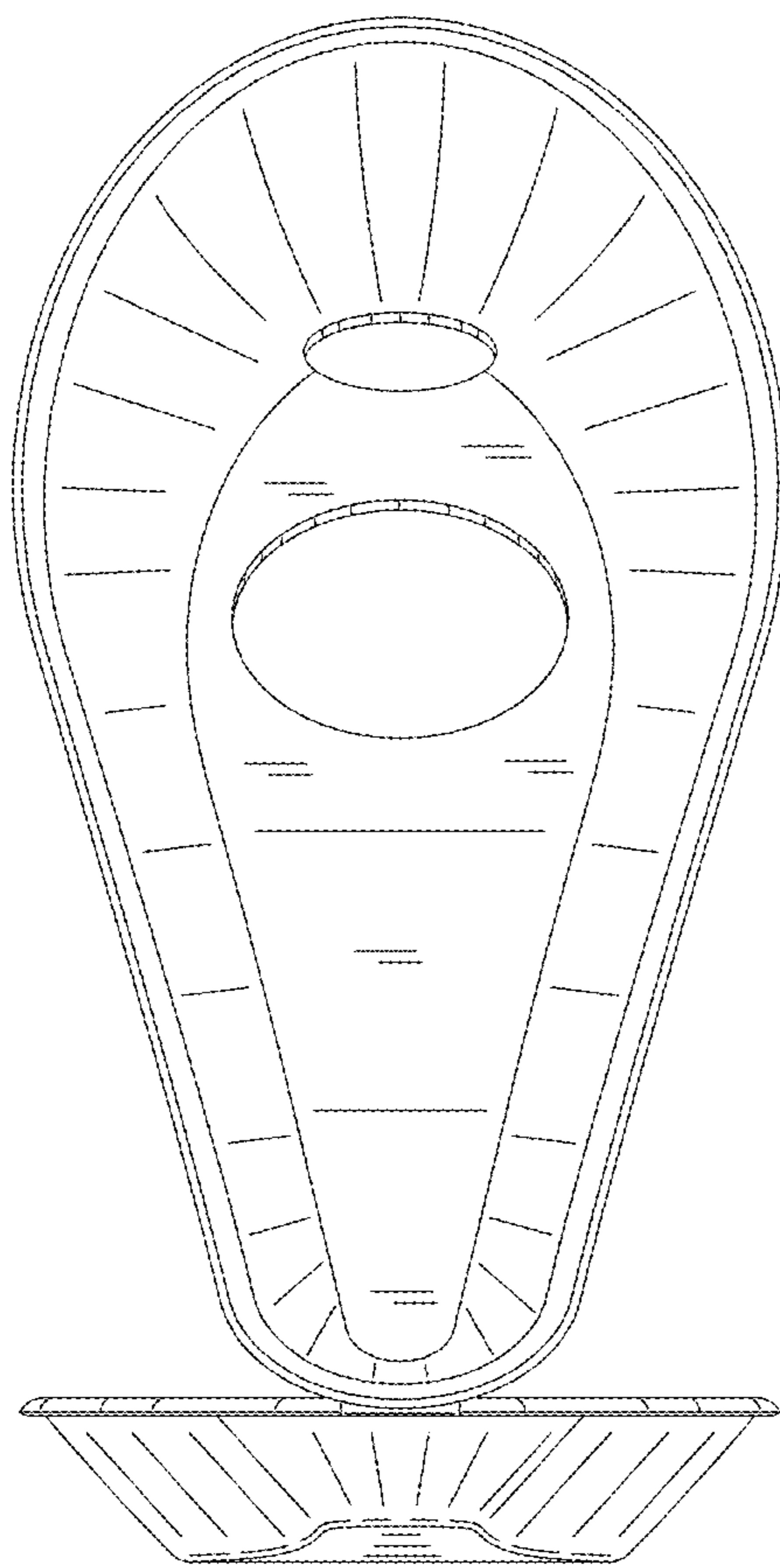

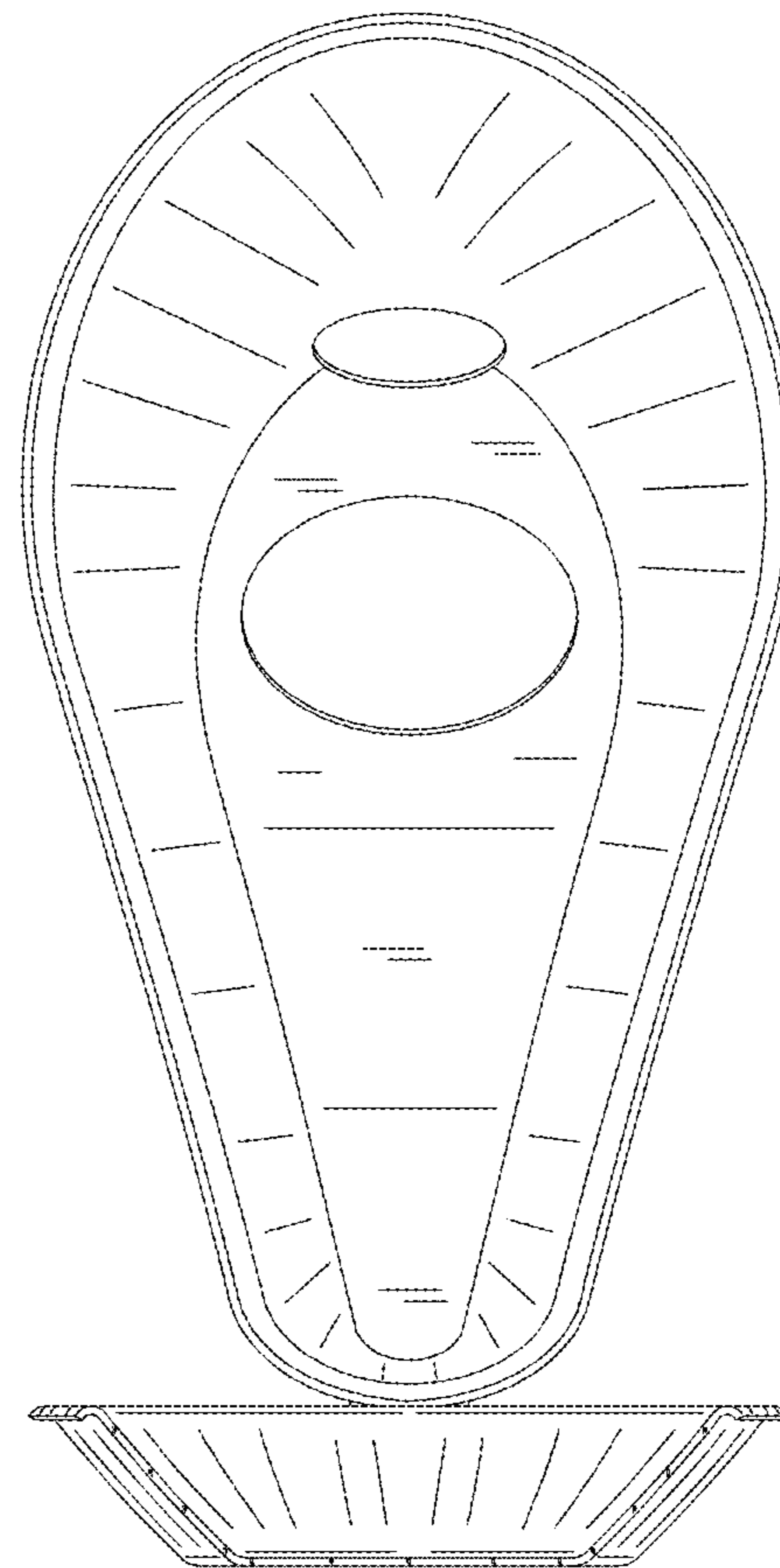
