FIG. 4 is a left side view illustrating the refuge room of FIG. 1;

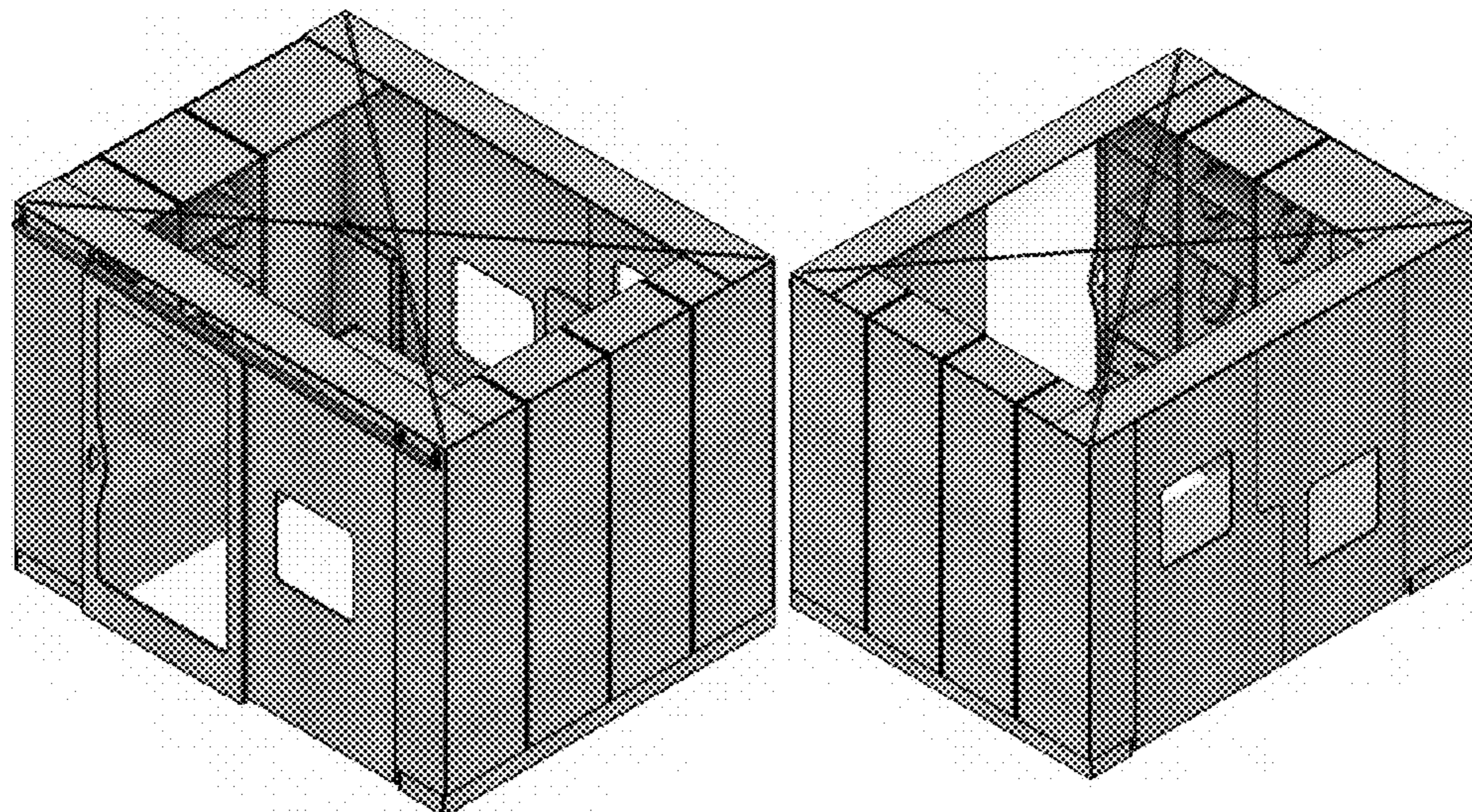
FIG. 5 is a top view illustrating the refuge room of FIG. 1;

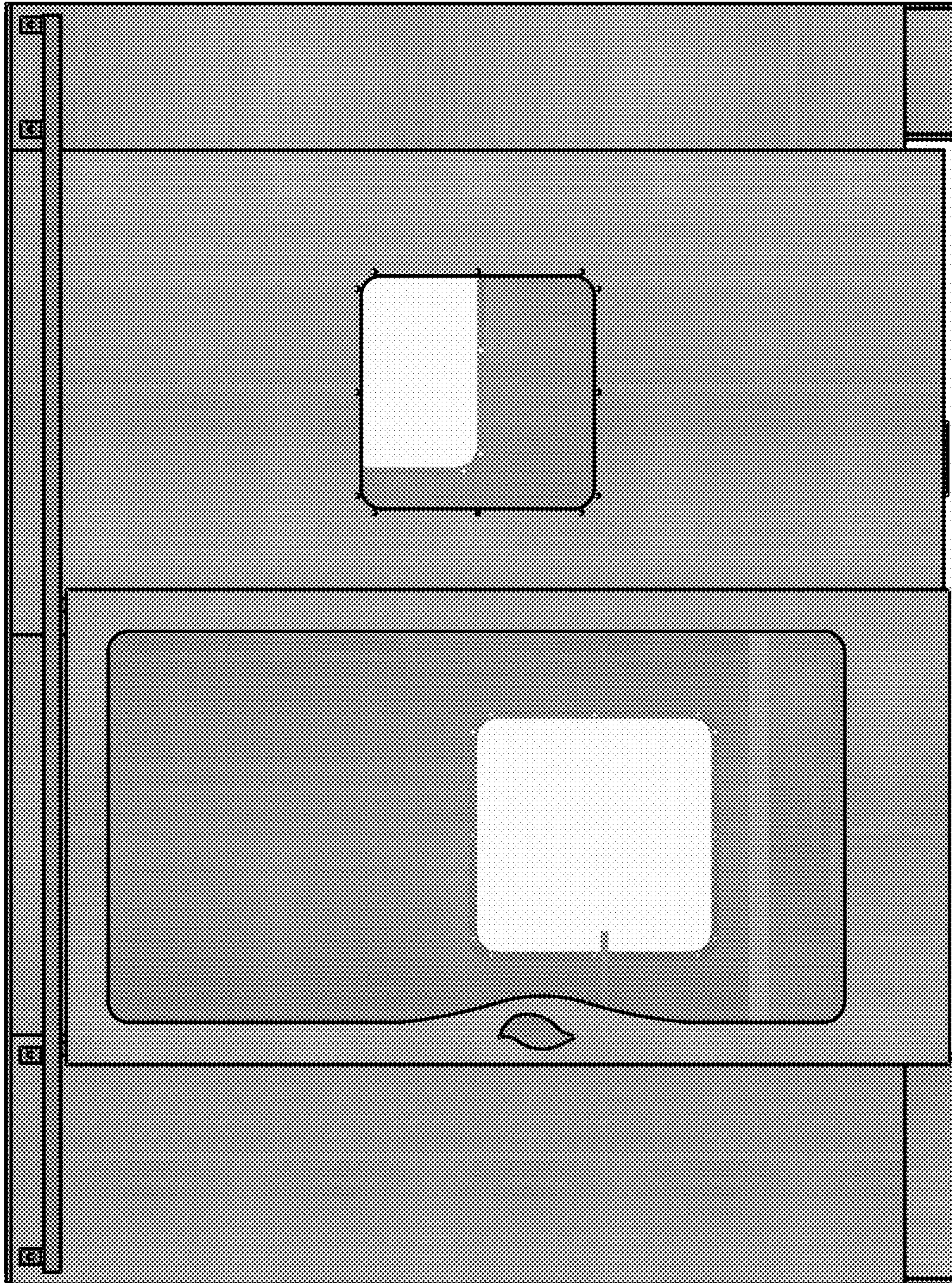

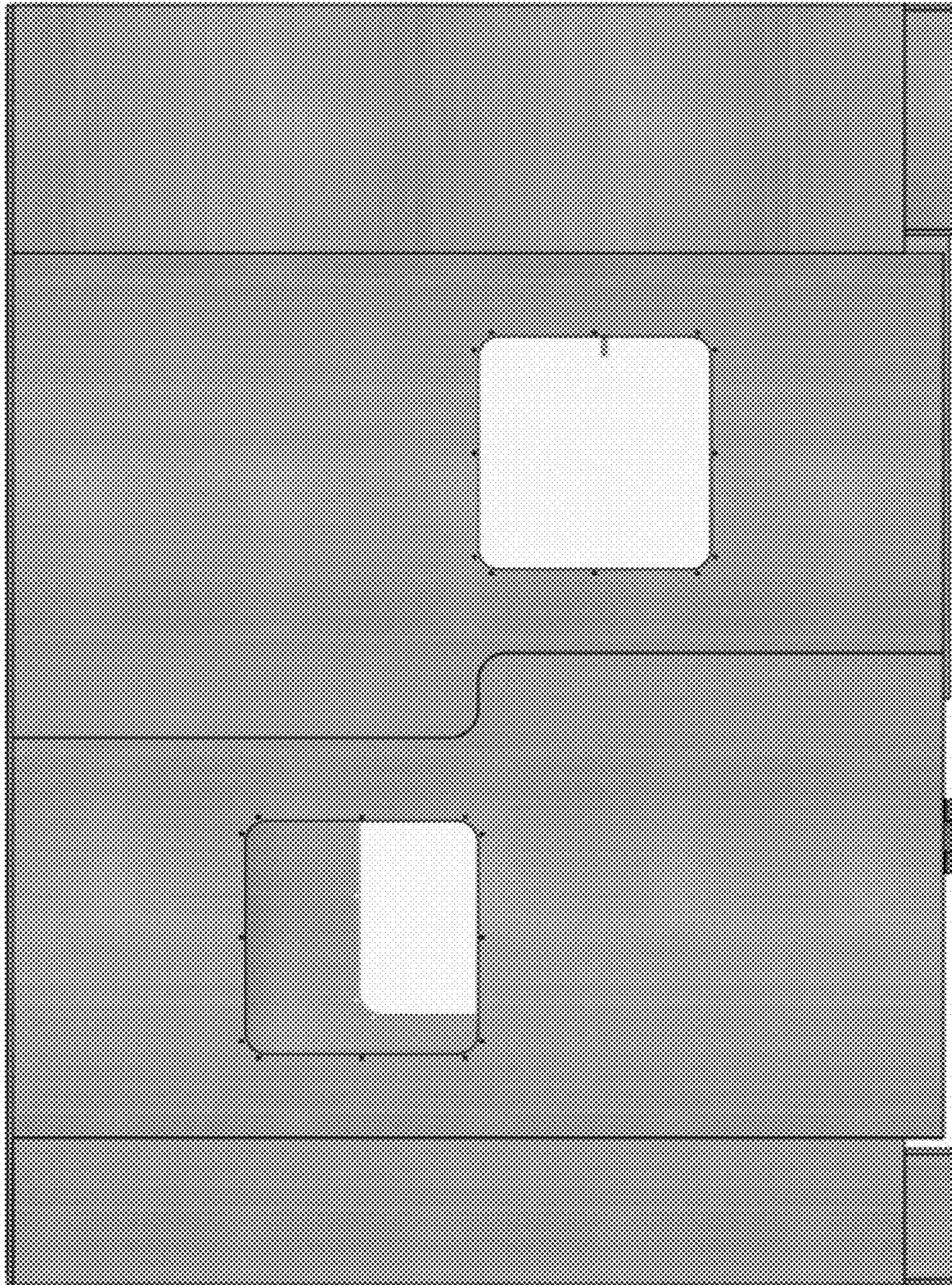

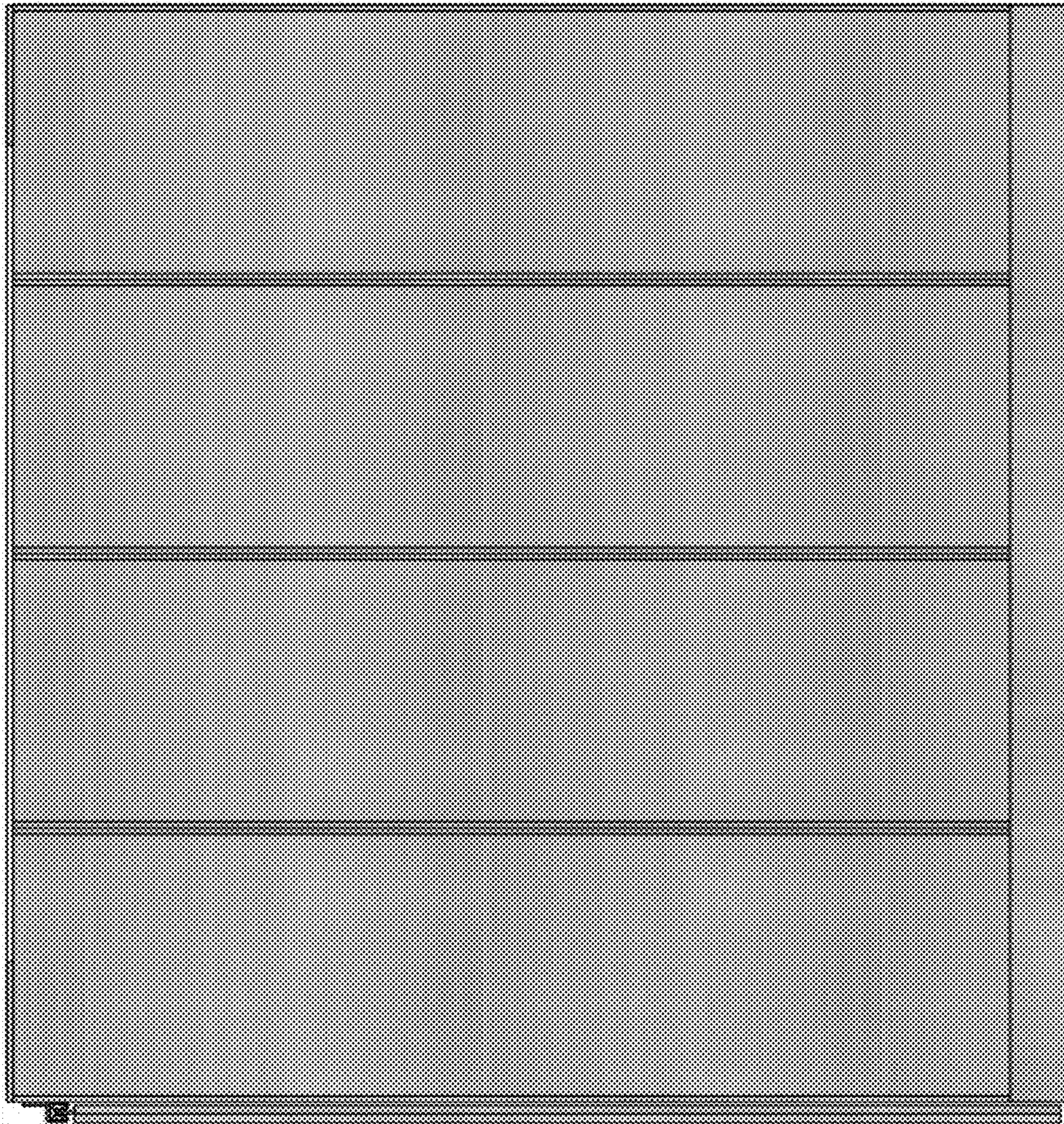

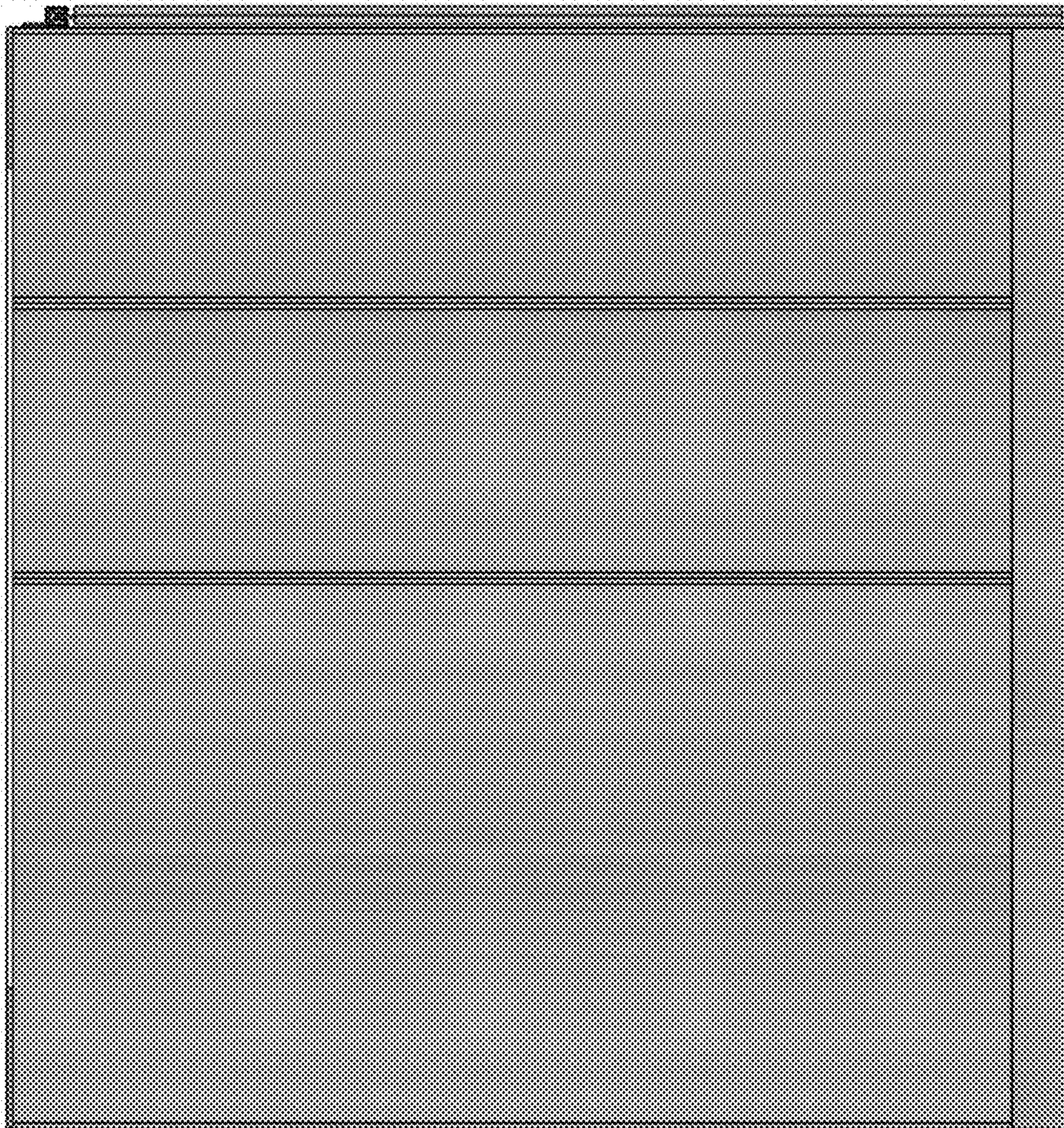

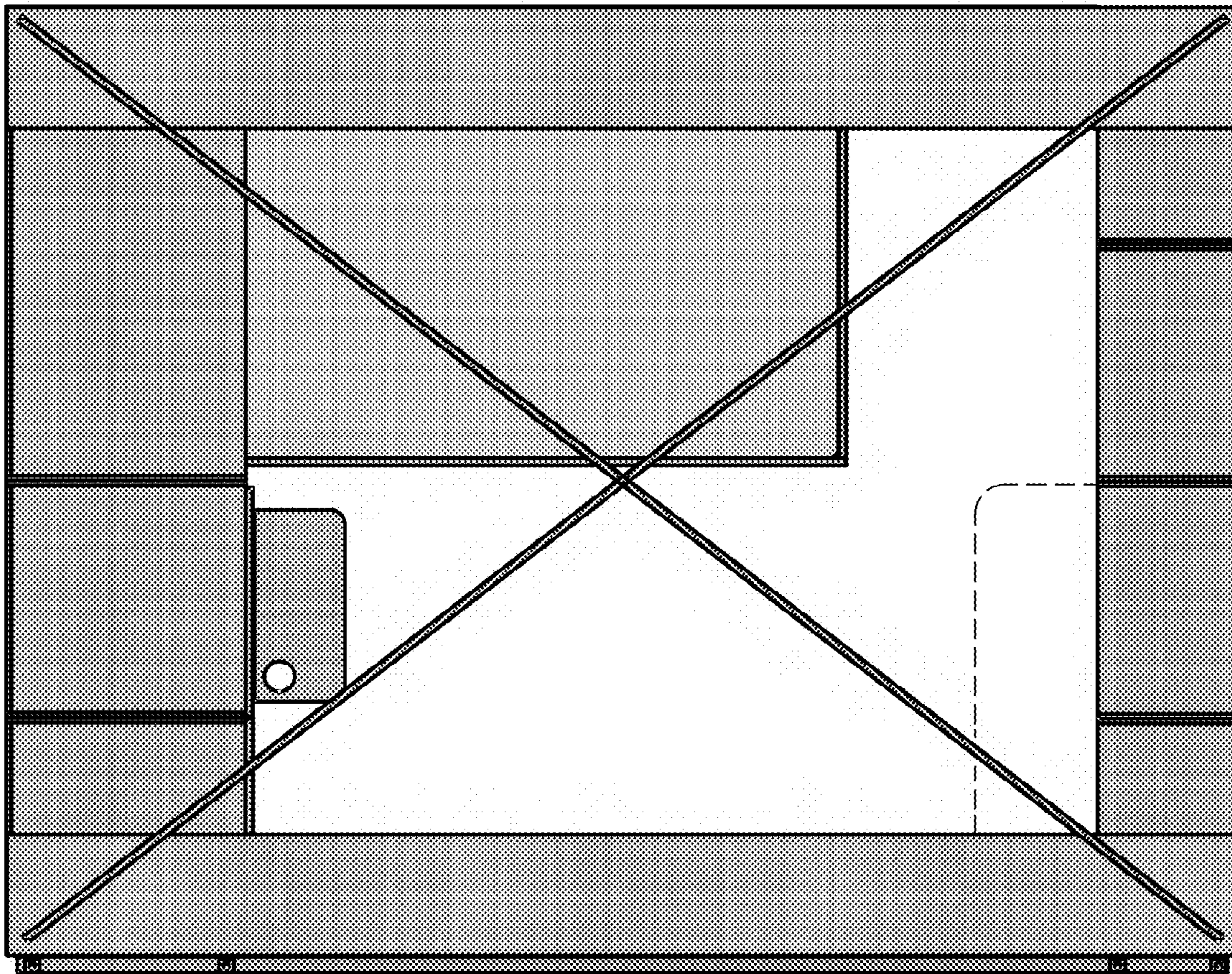

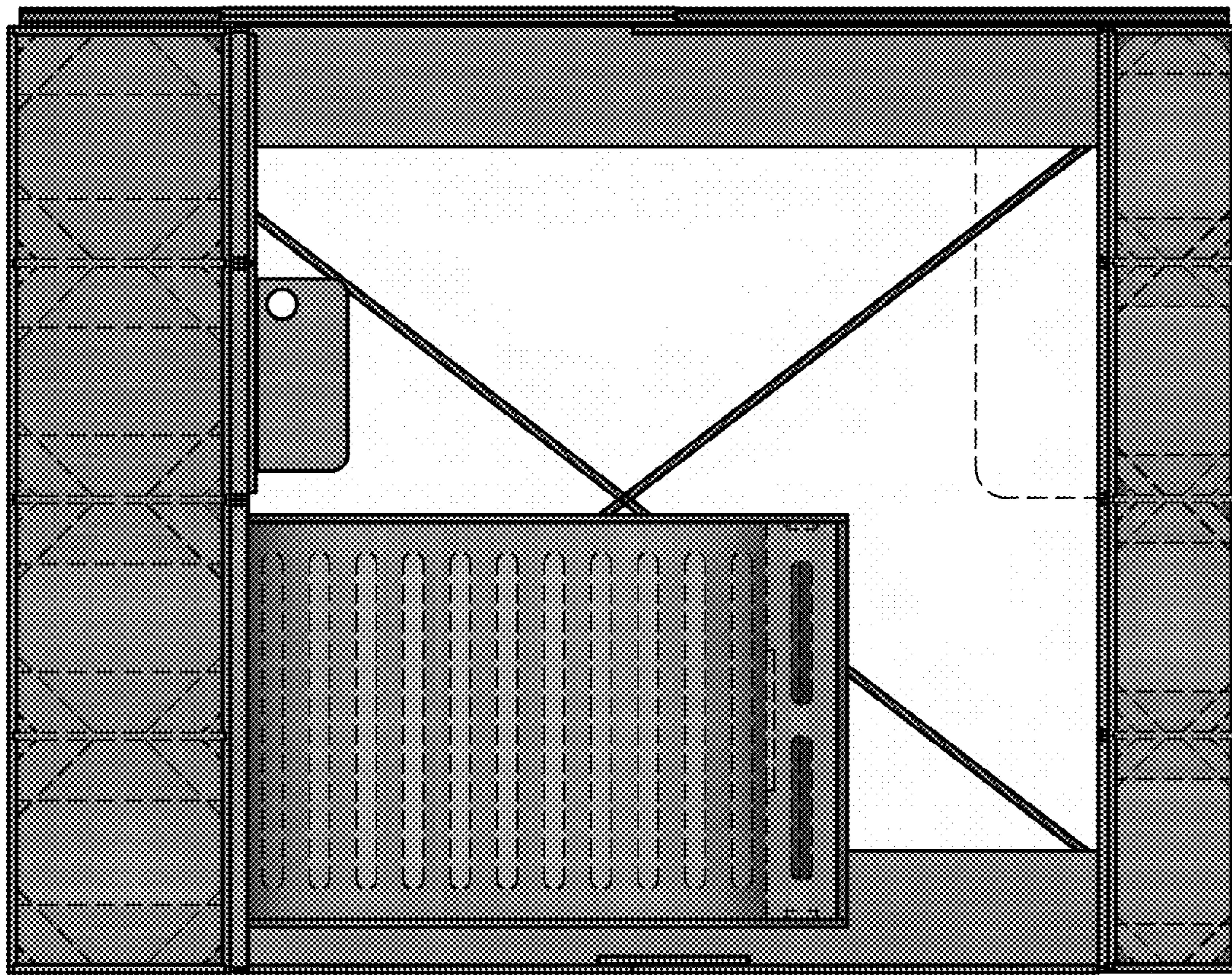

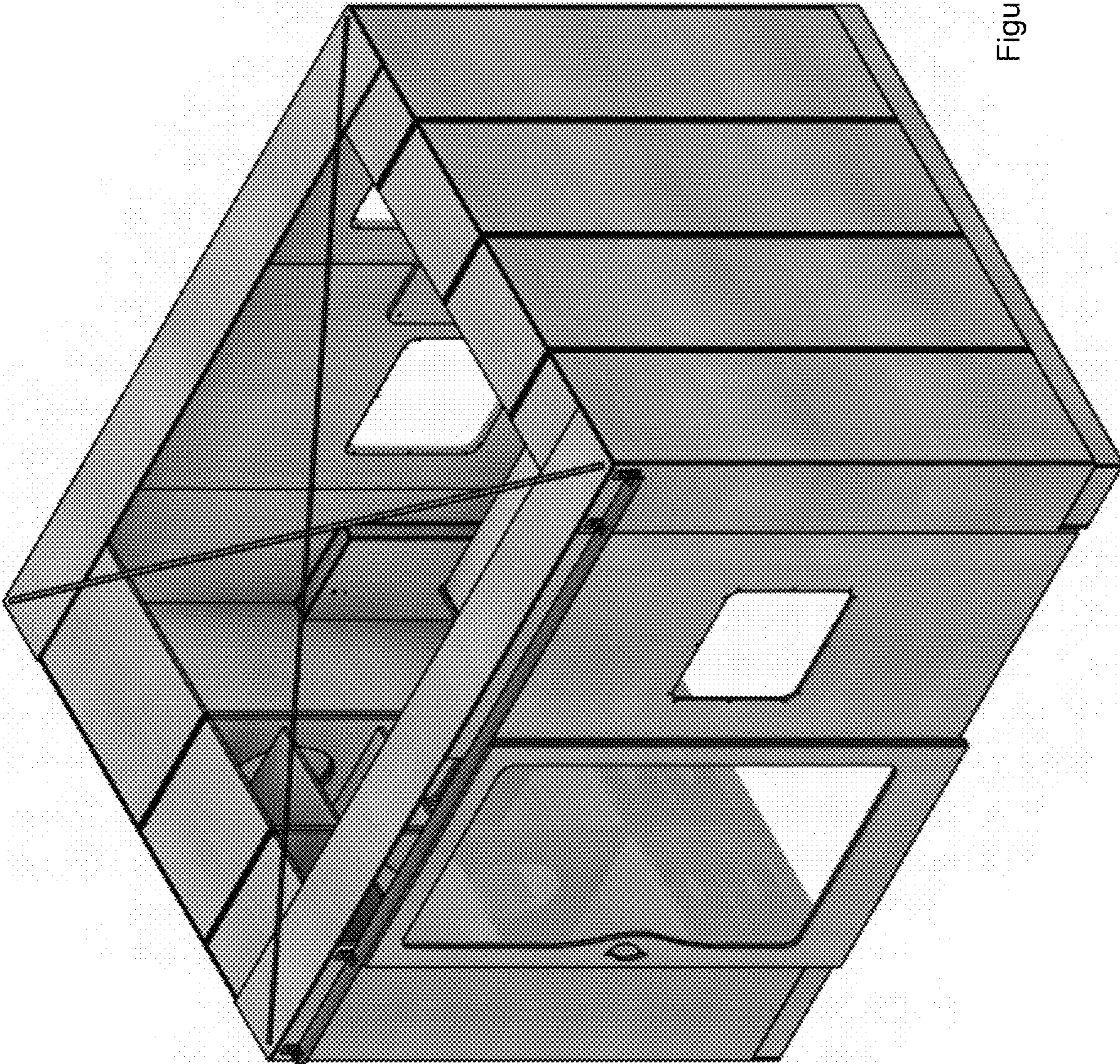

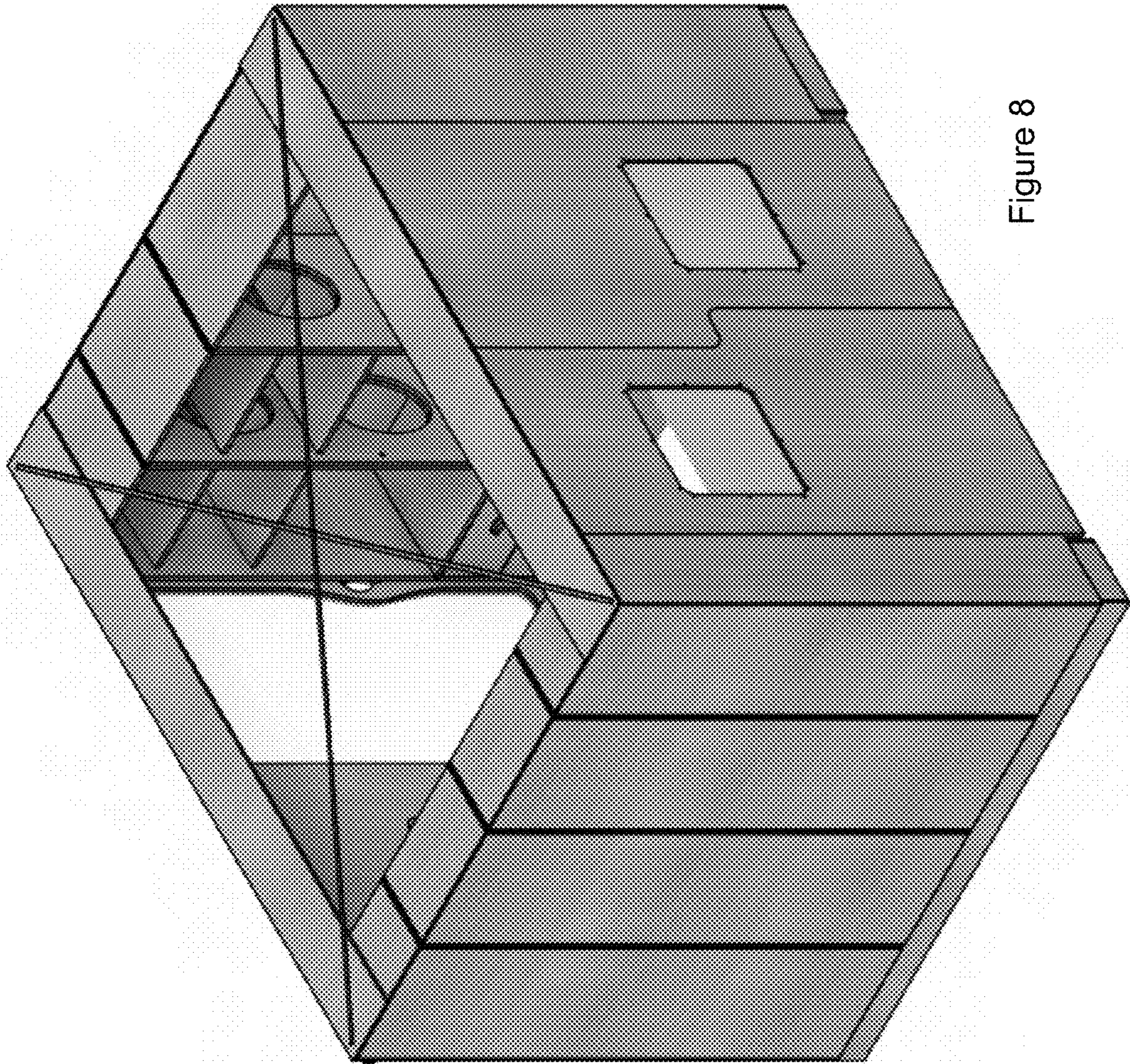
