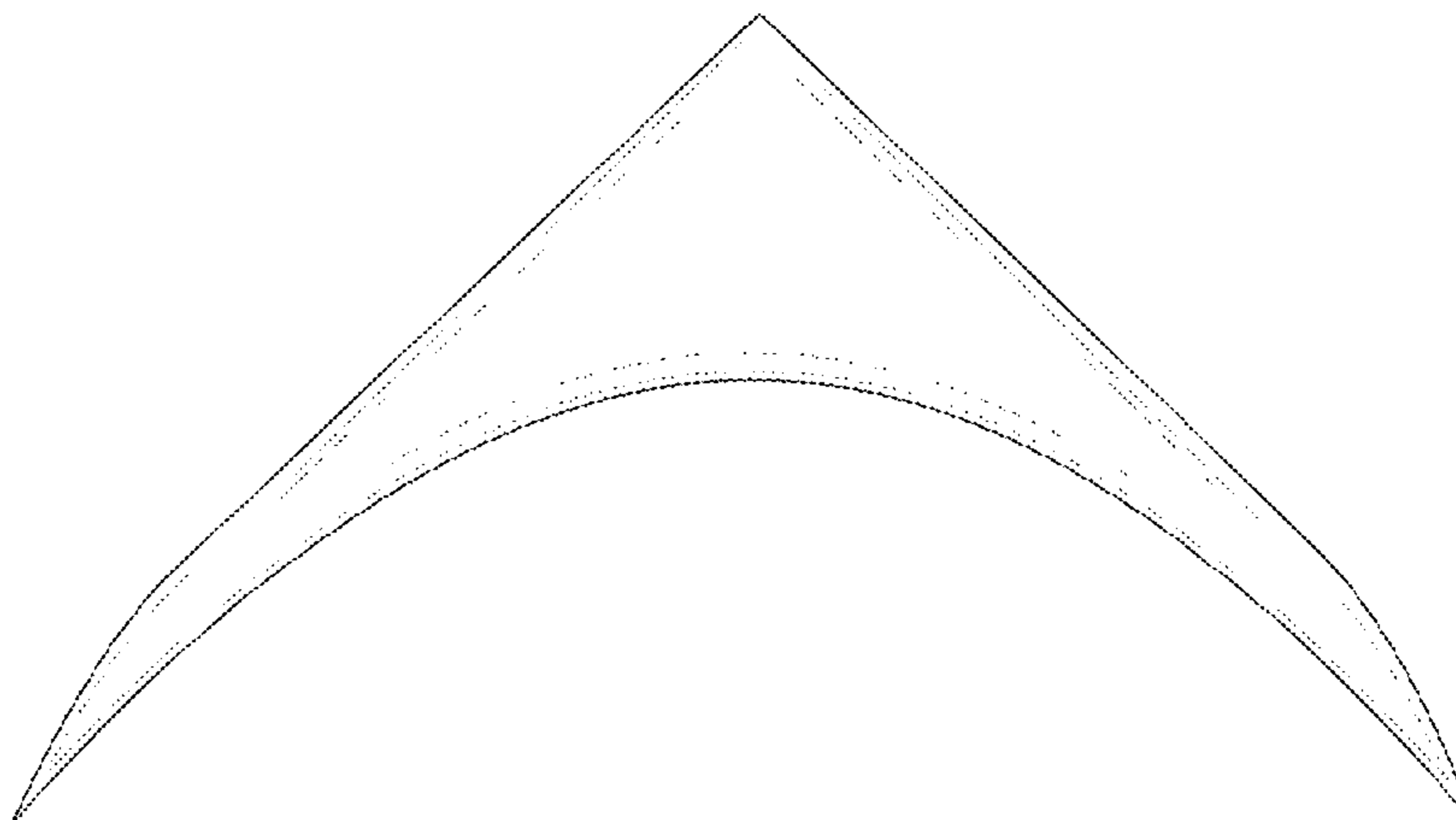
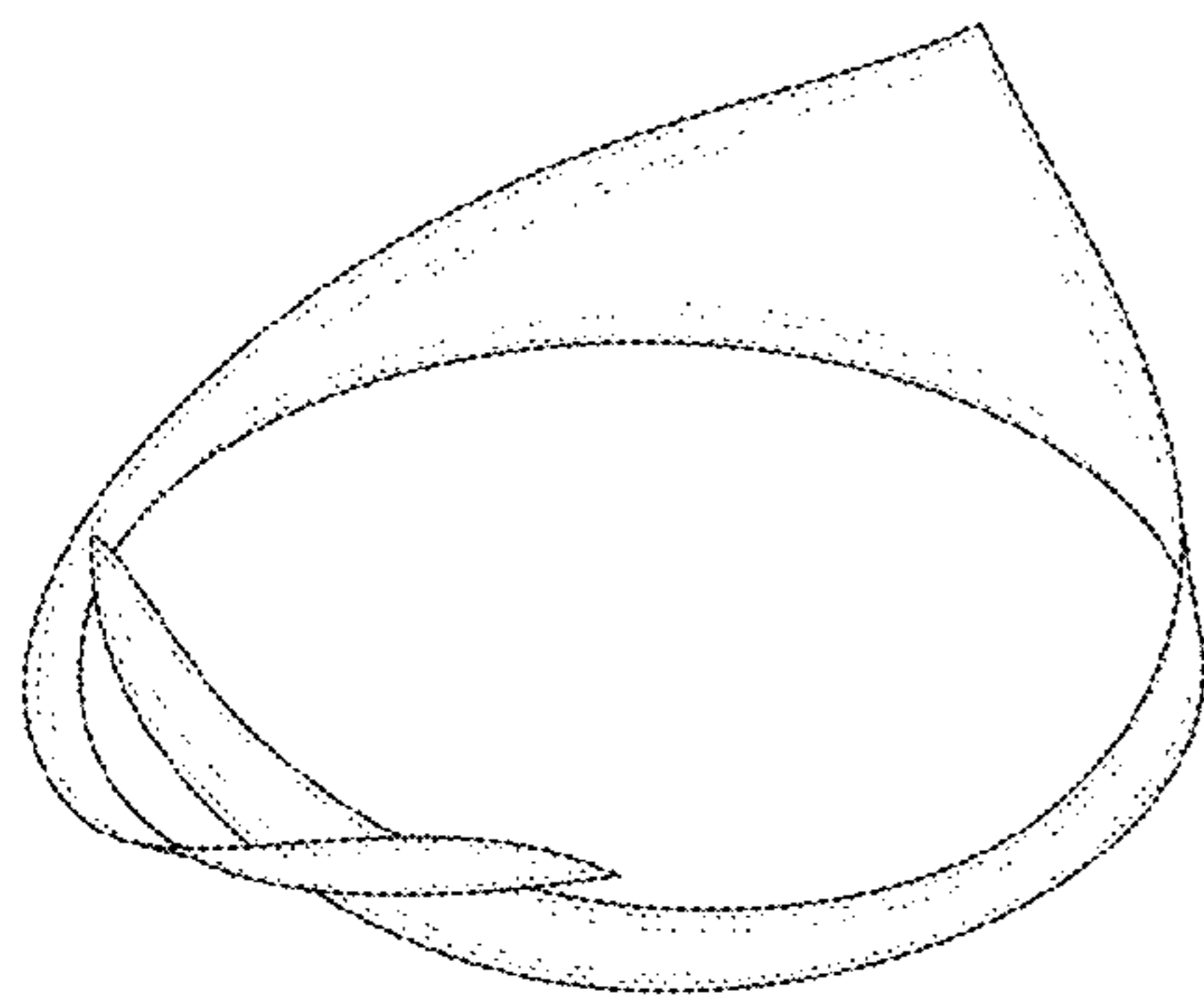
(57) **CLAIM**

The ornamental design for a dog bandana, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a dog bandana, showing my new design;
FIG. 2 is a bottom perspective view thereof;

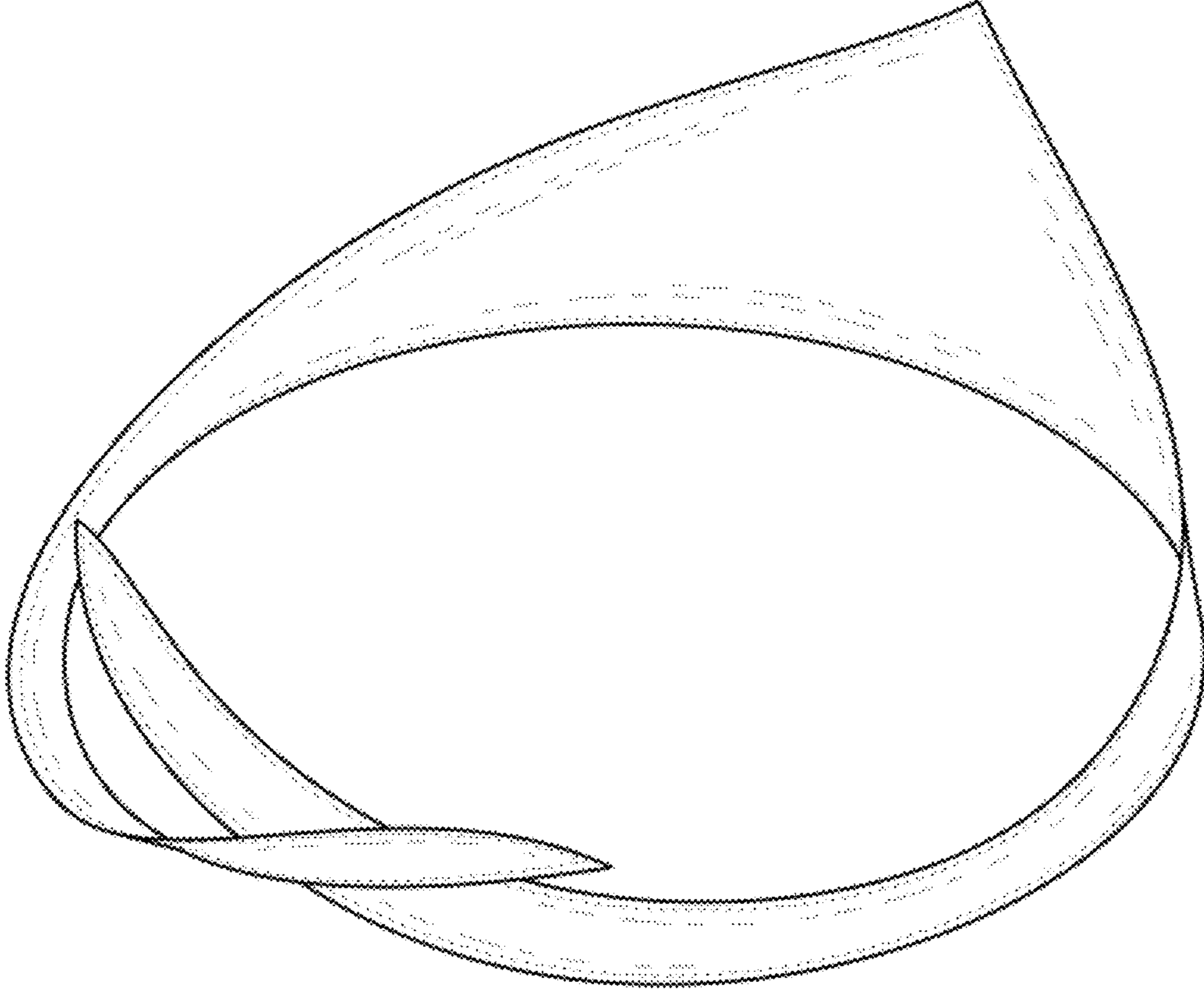

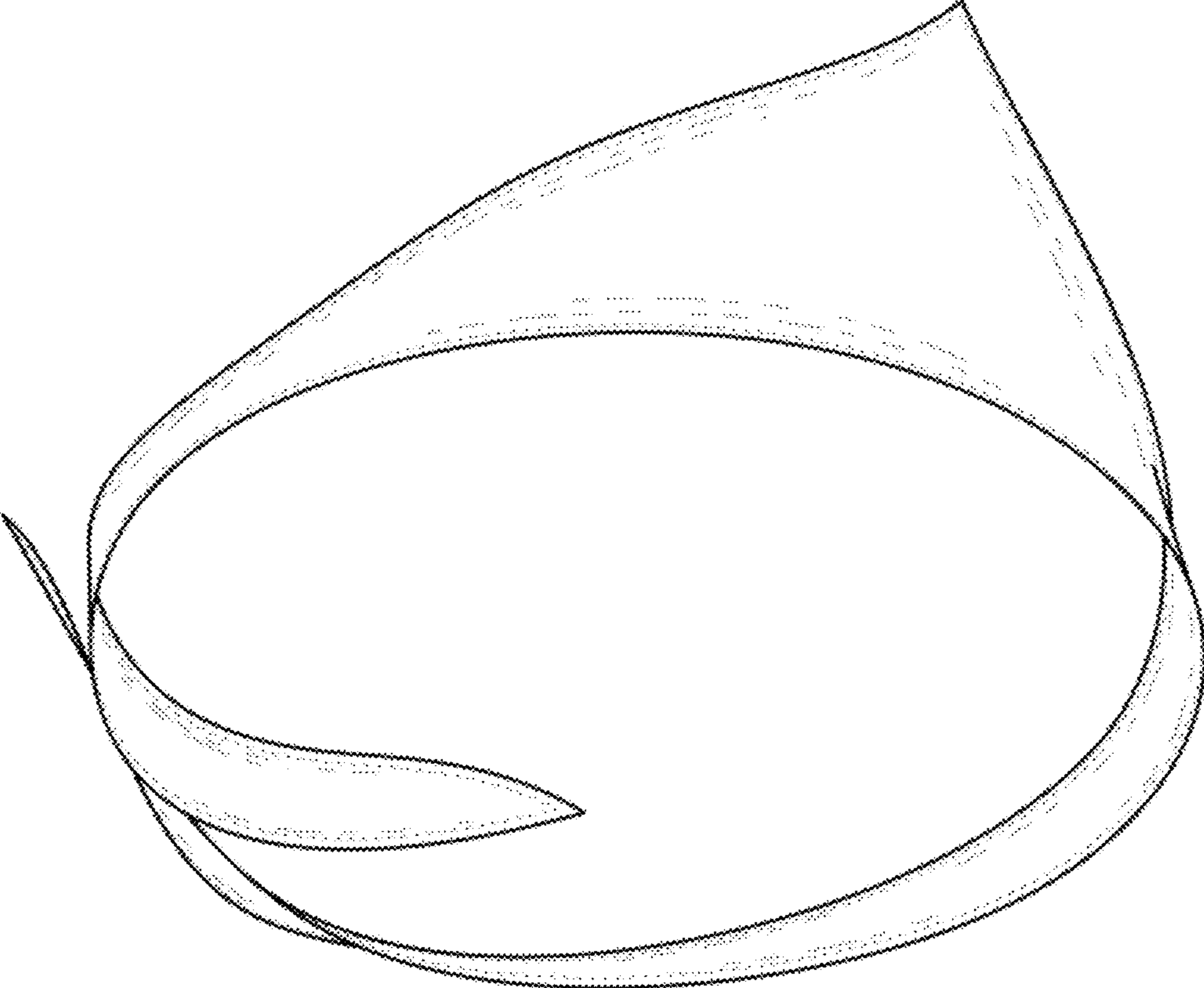

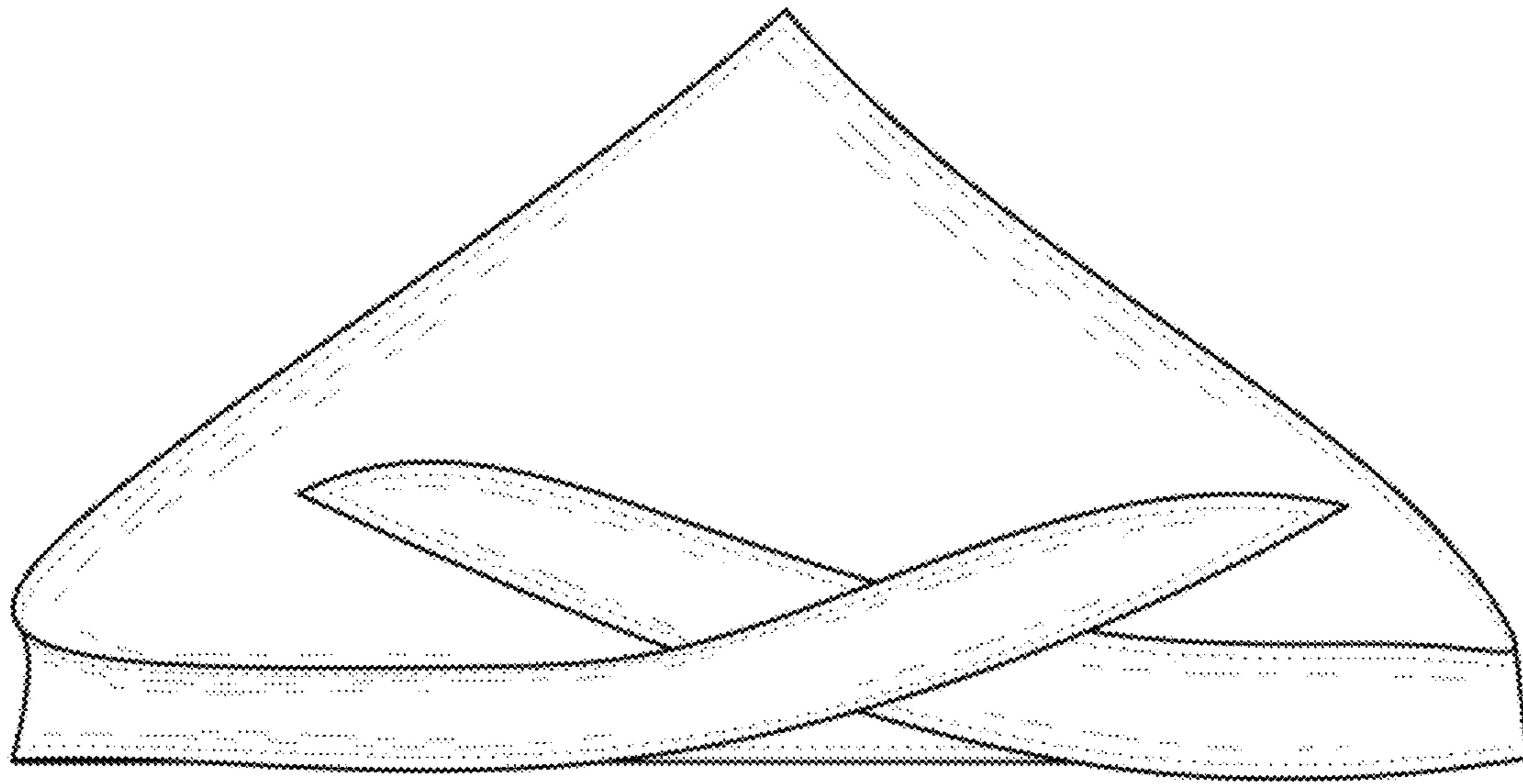

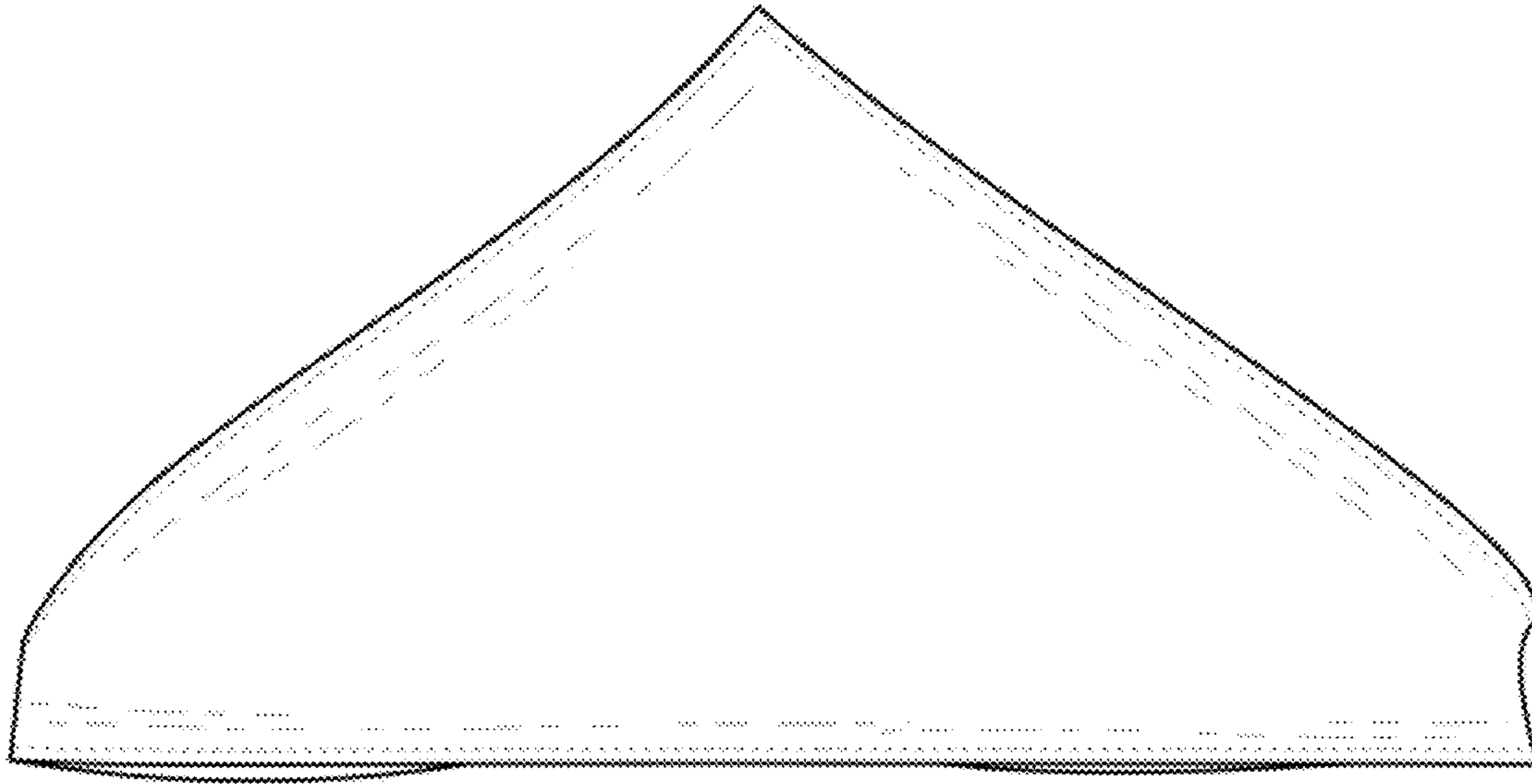

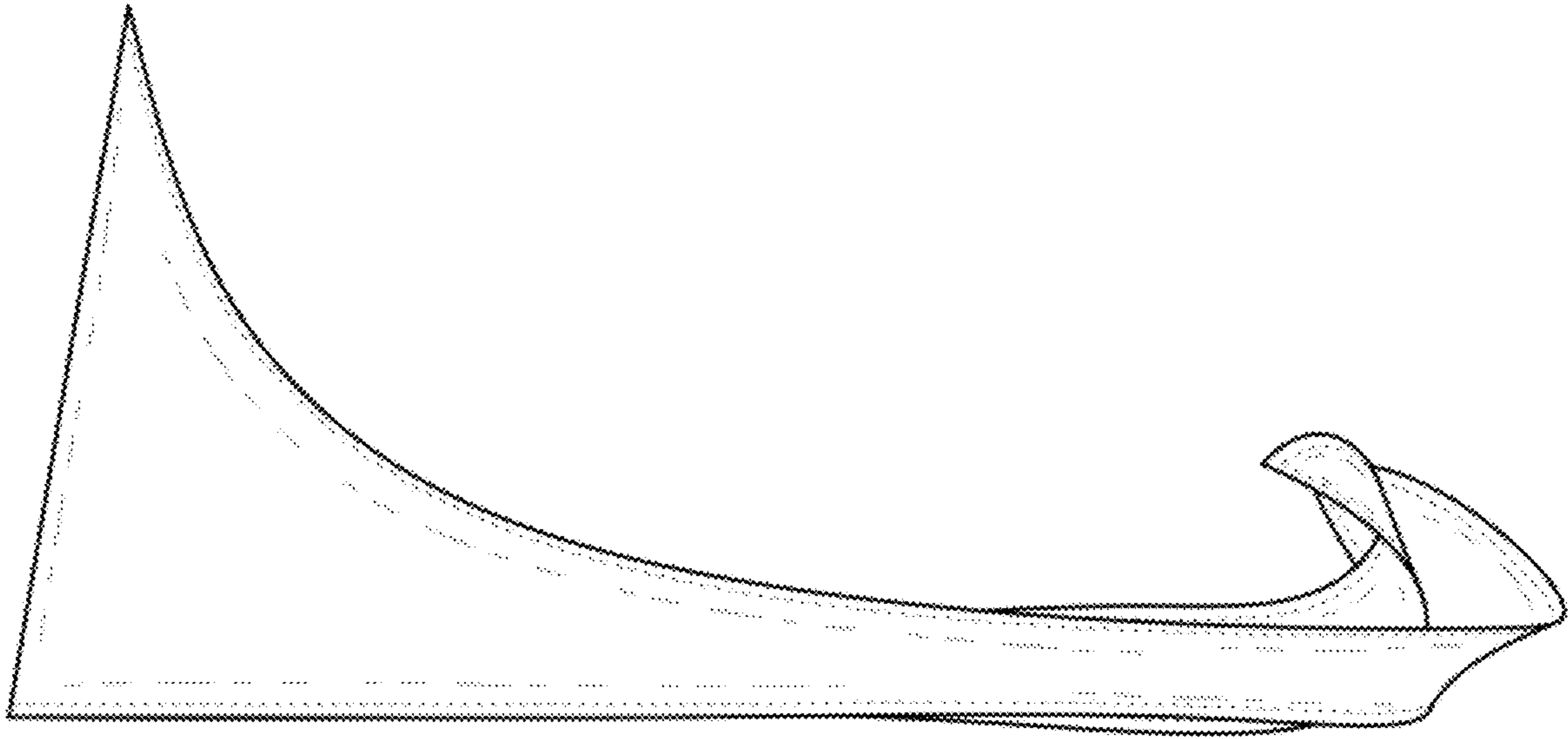

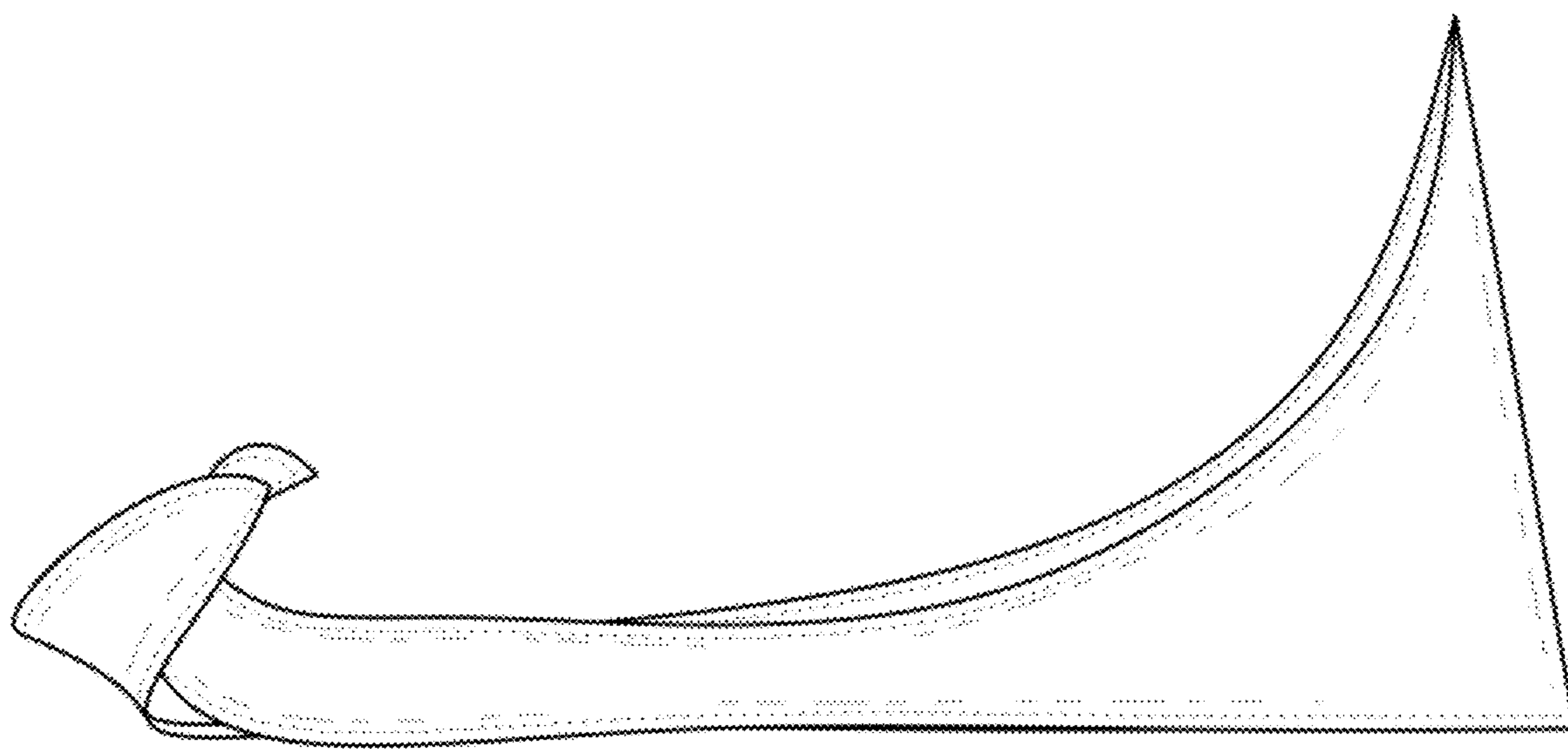

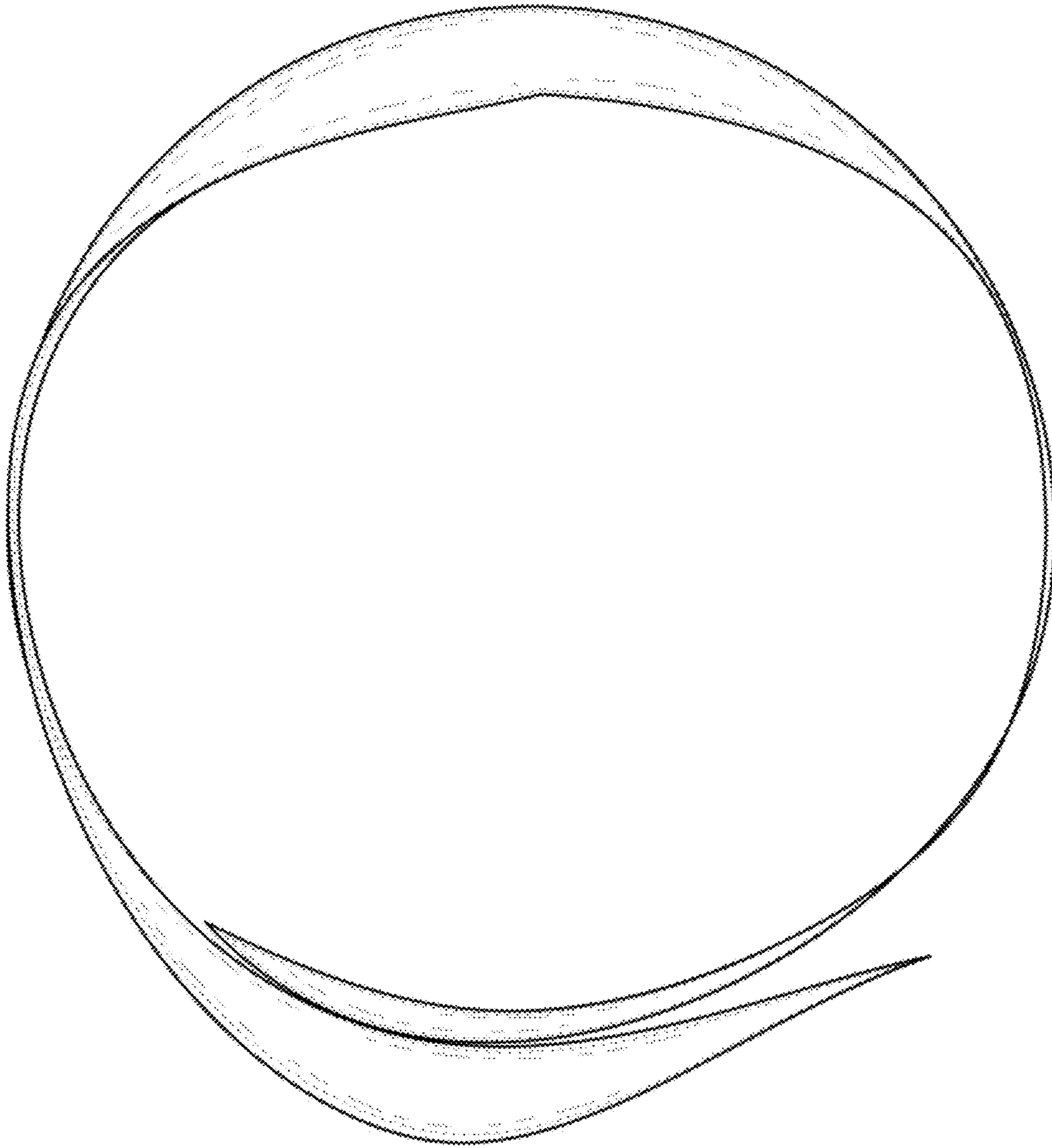

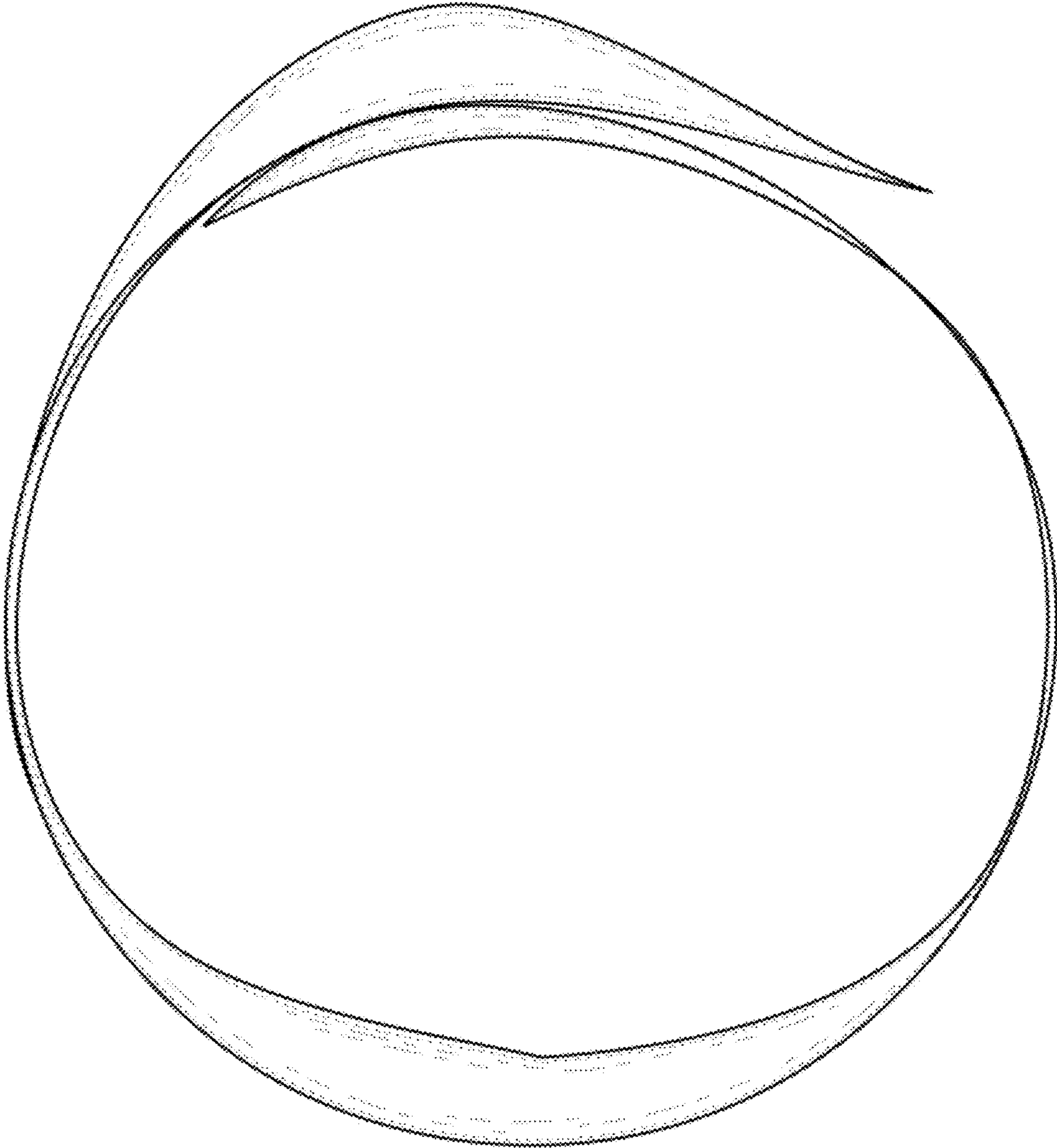

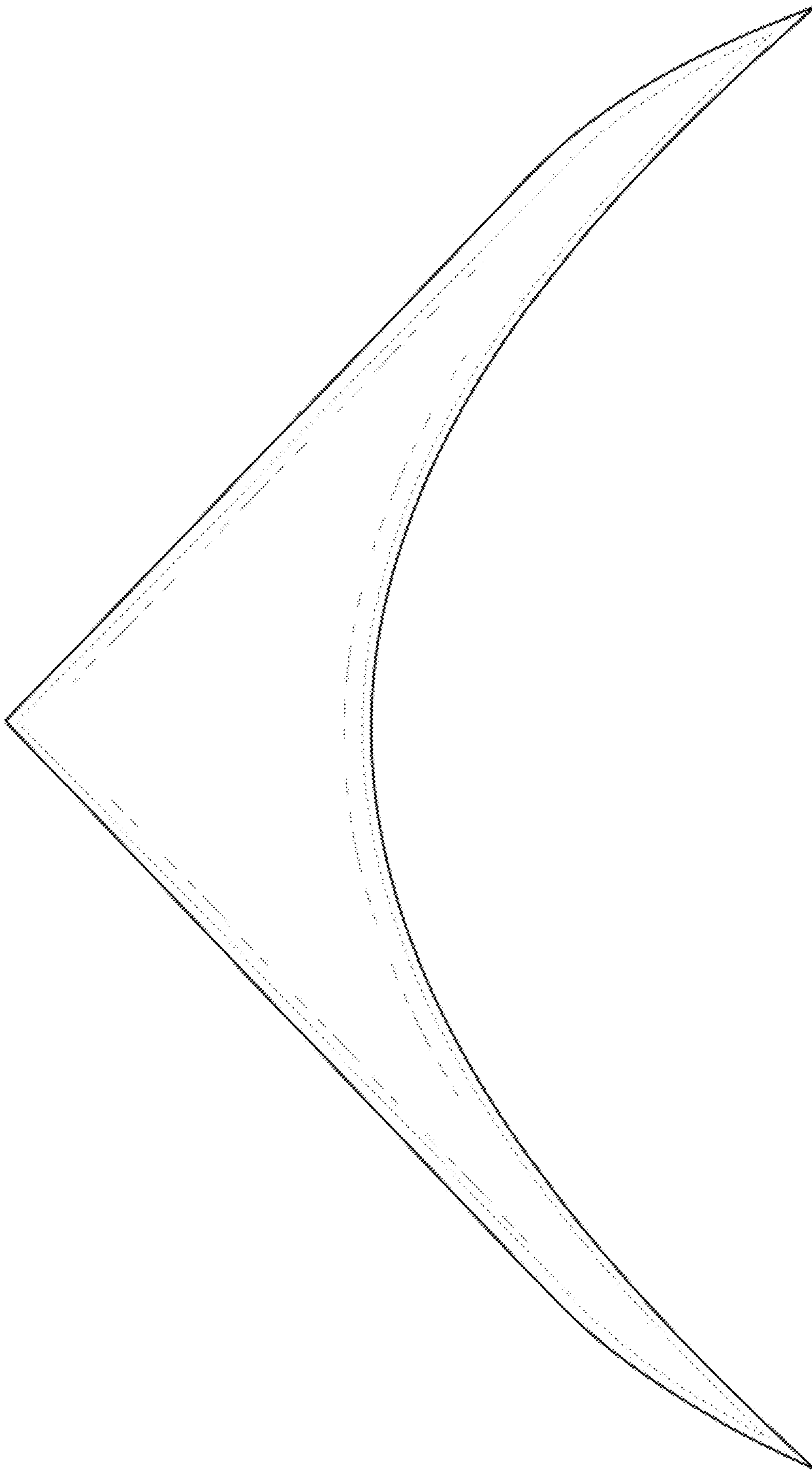
