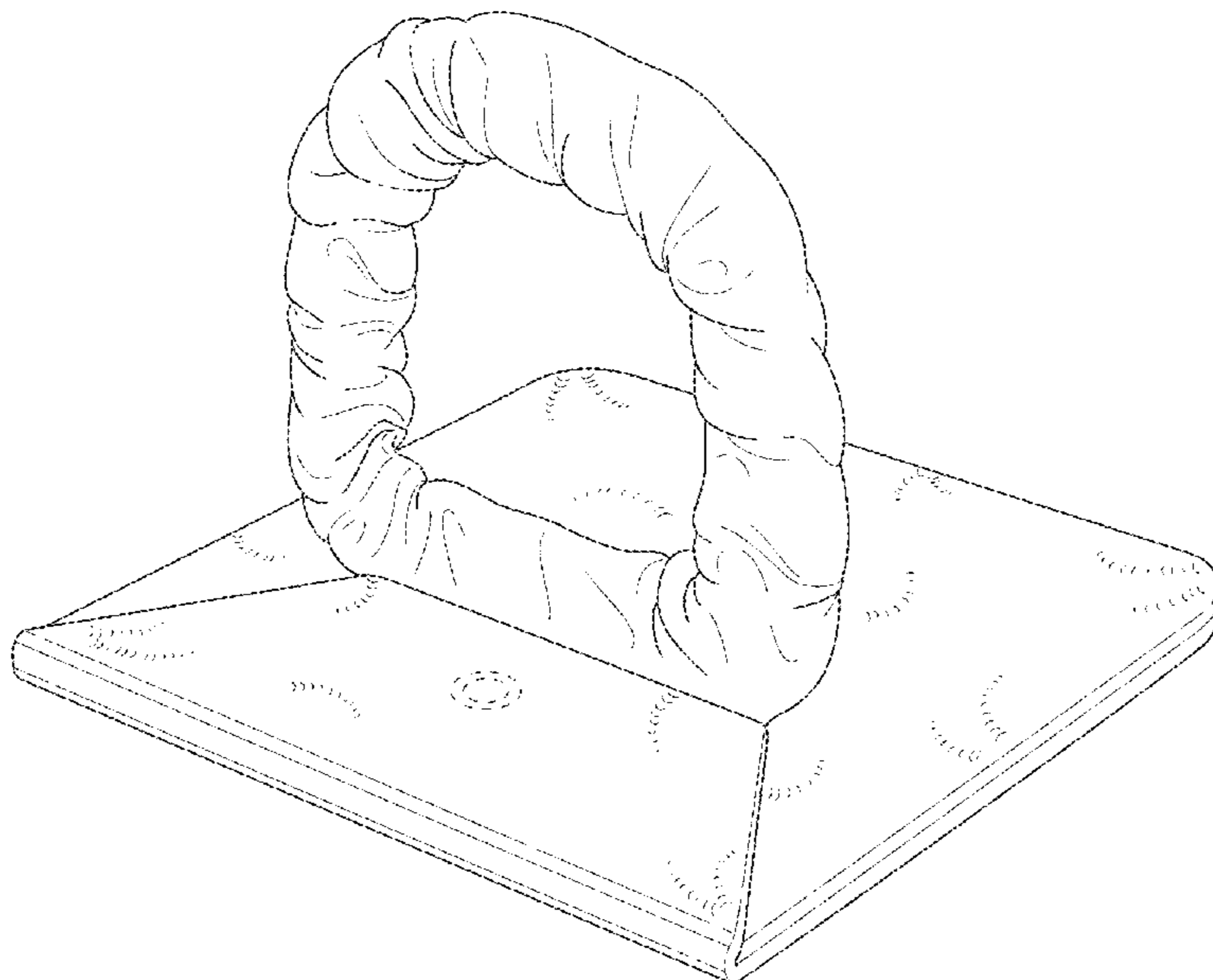

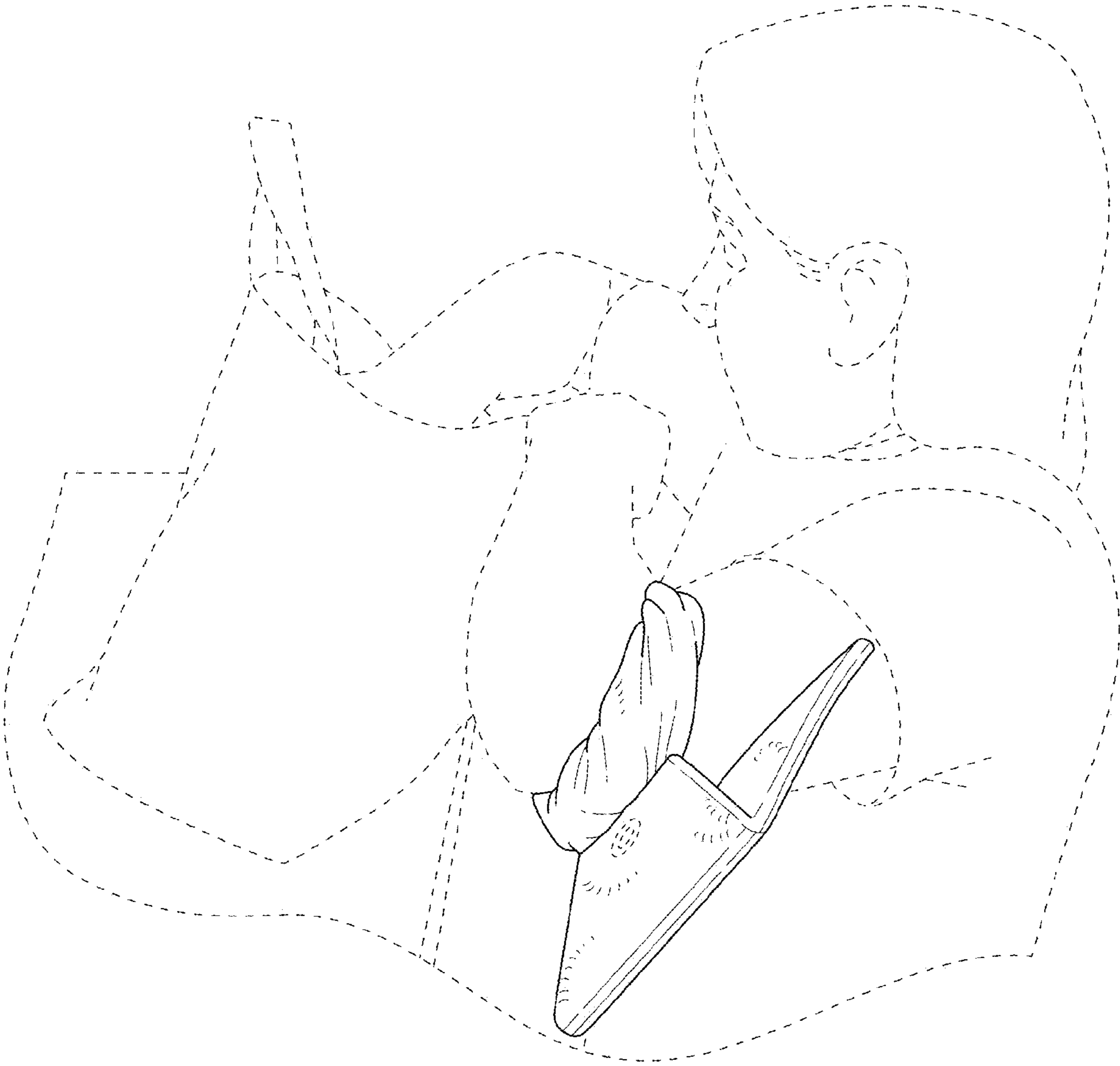
The ornamental design for an armband with pouch, as shown and described.

**DESCRIPTION**

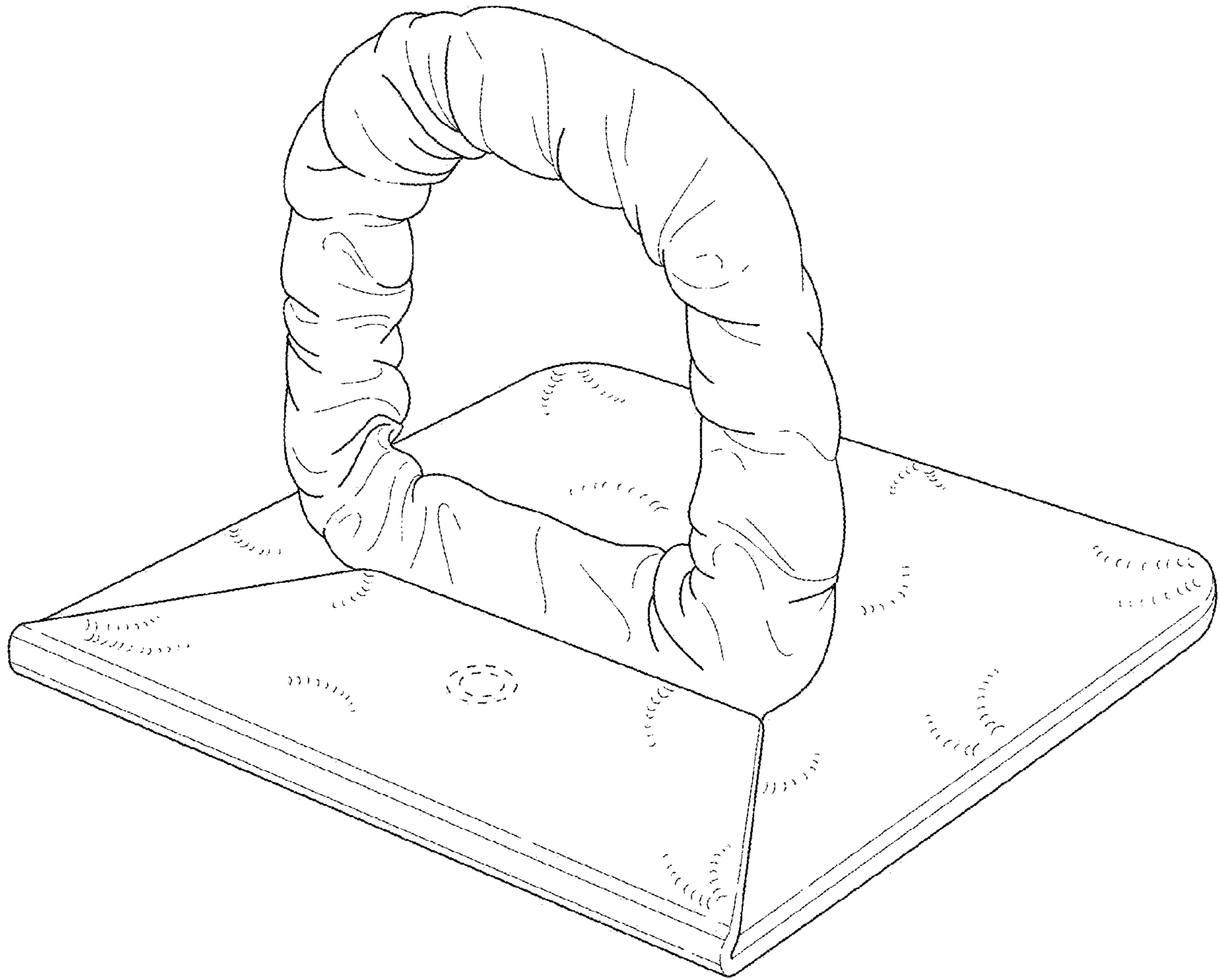

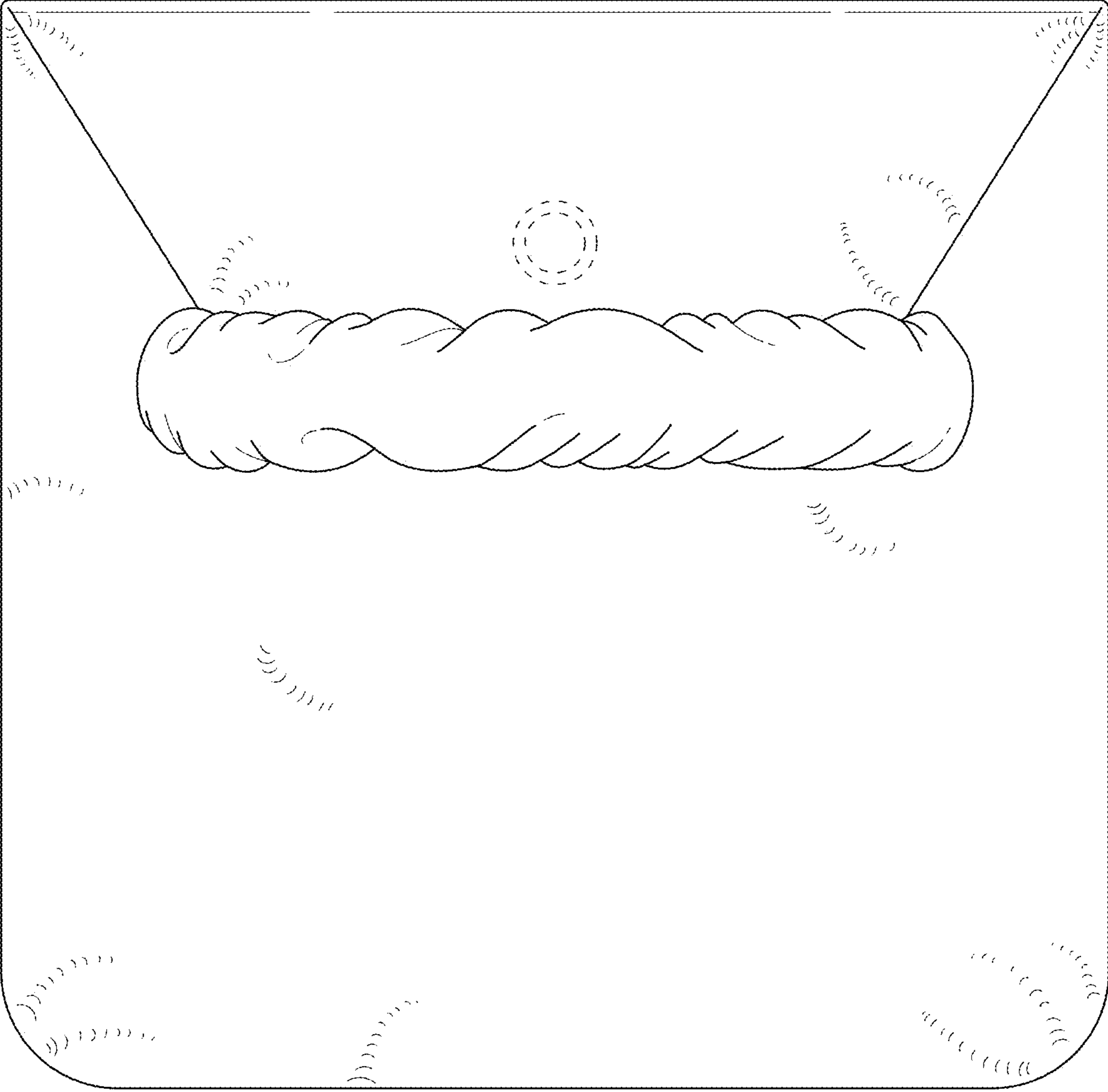

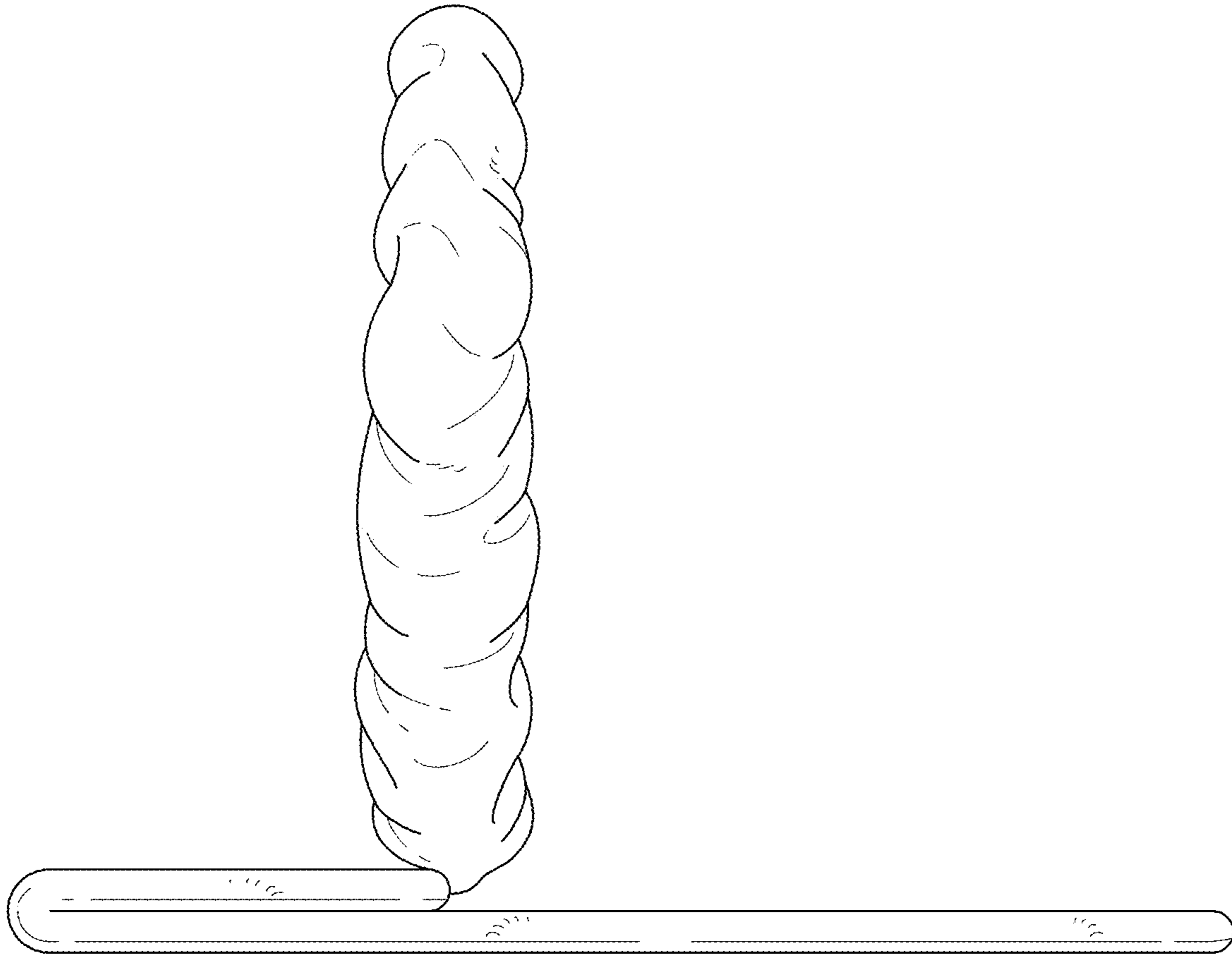

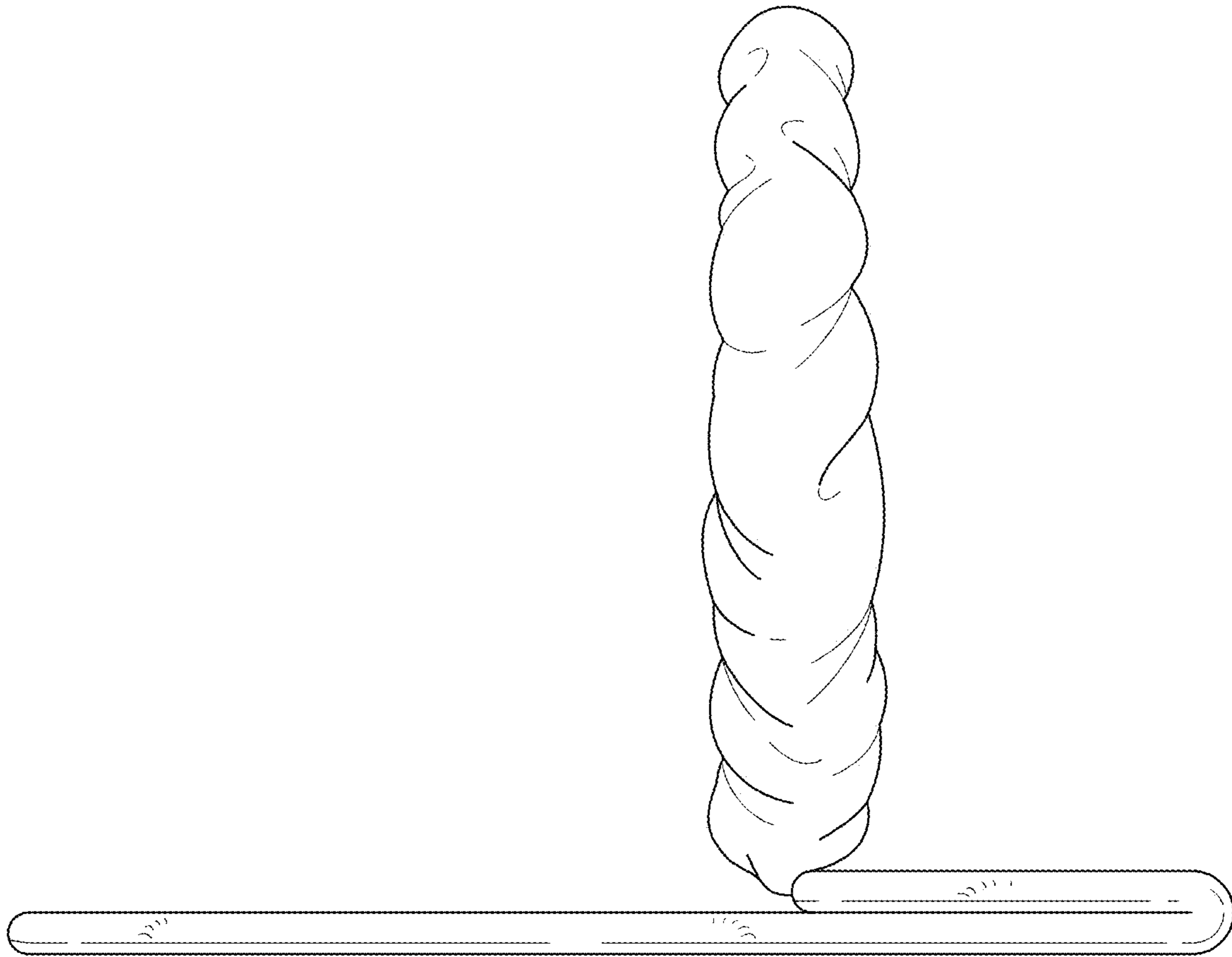

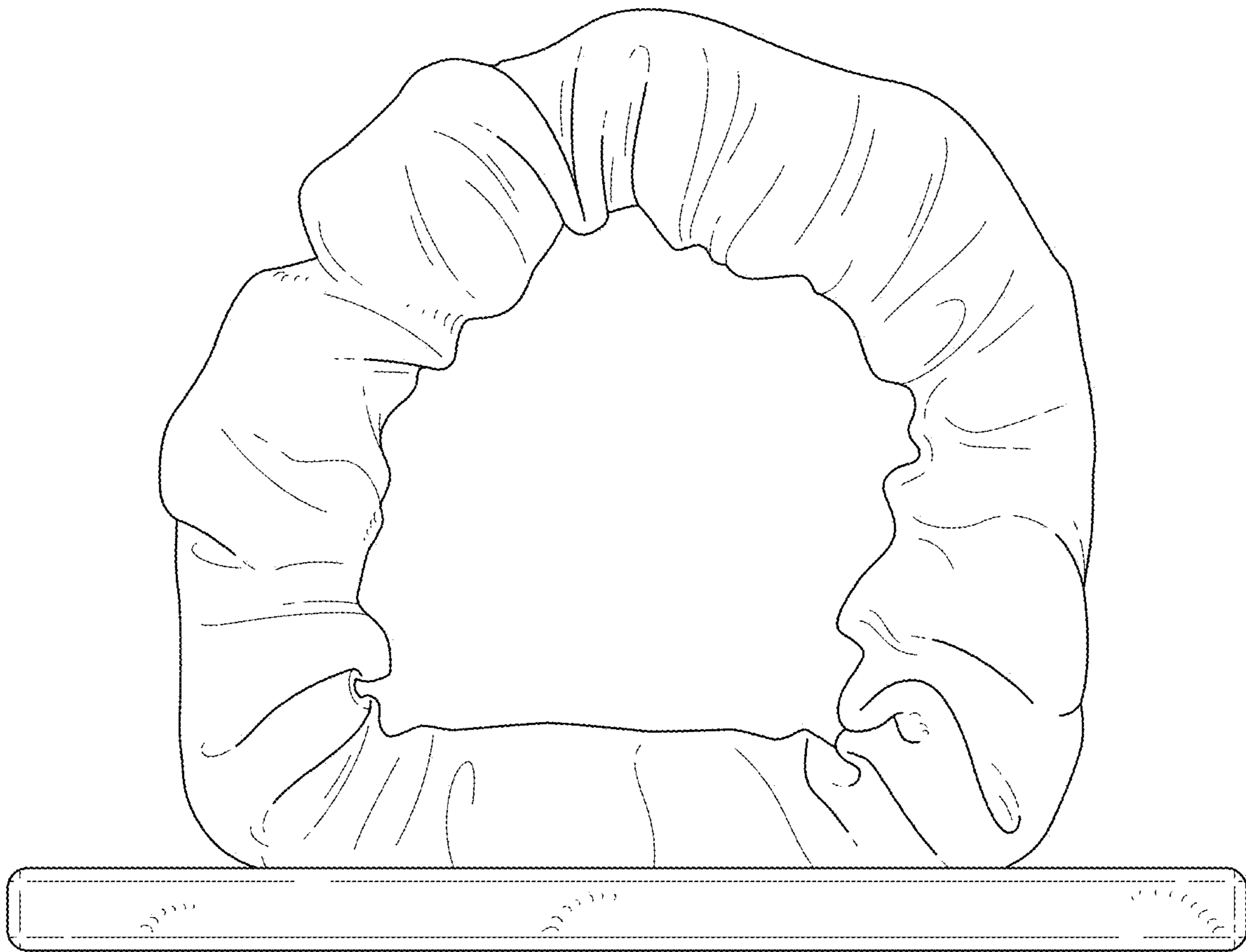

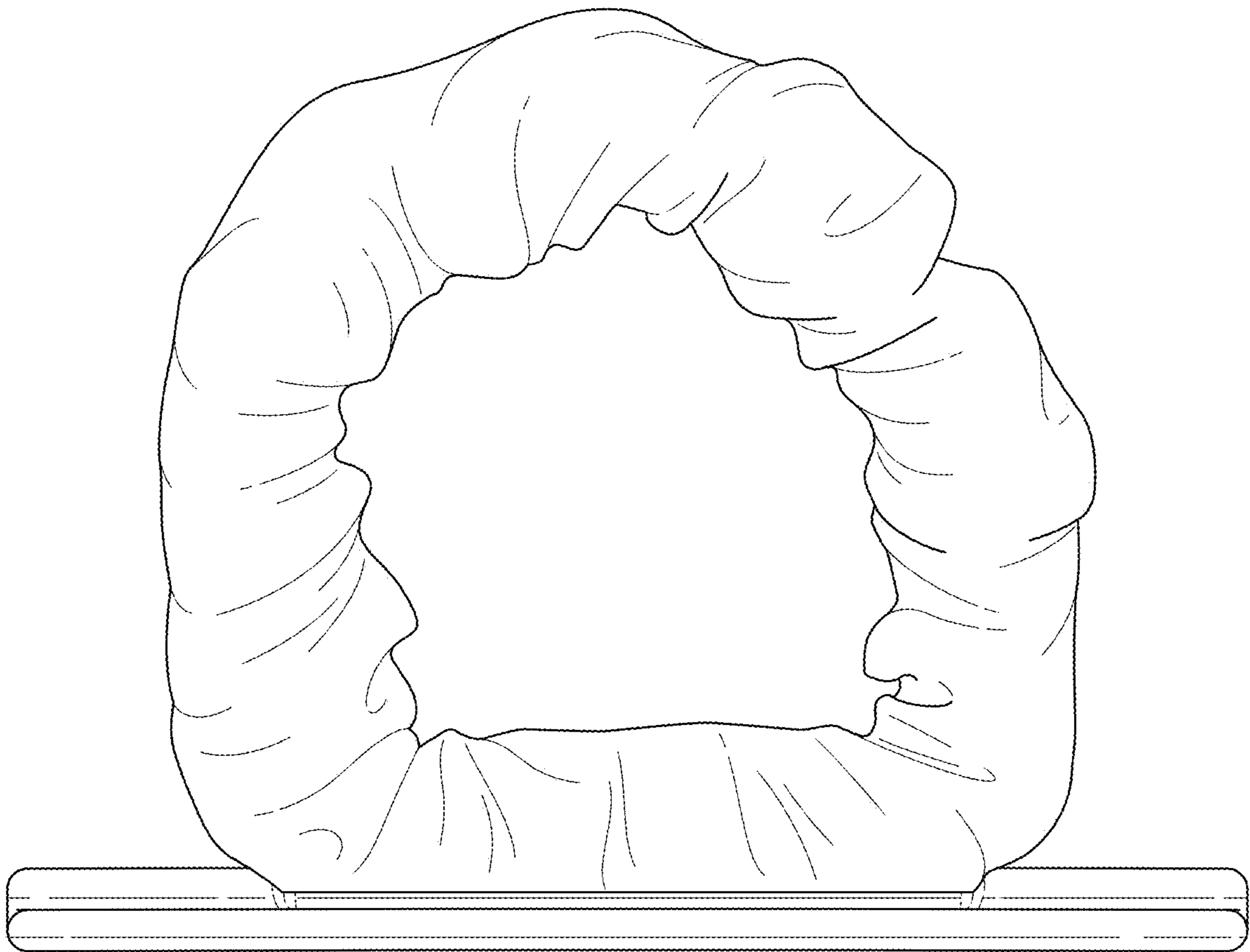

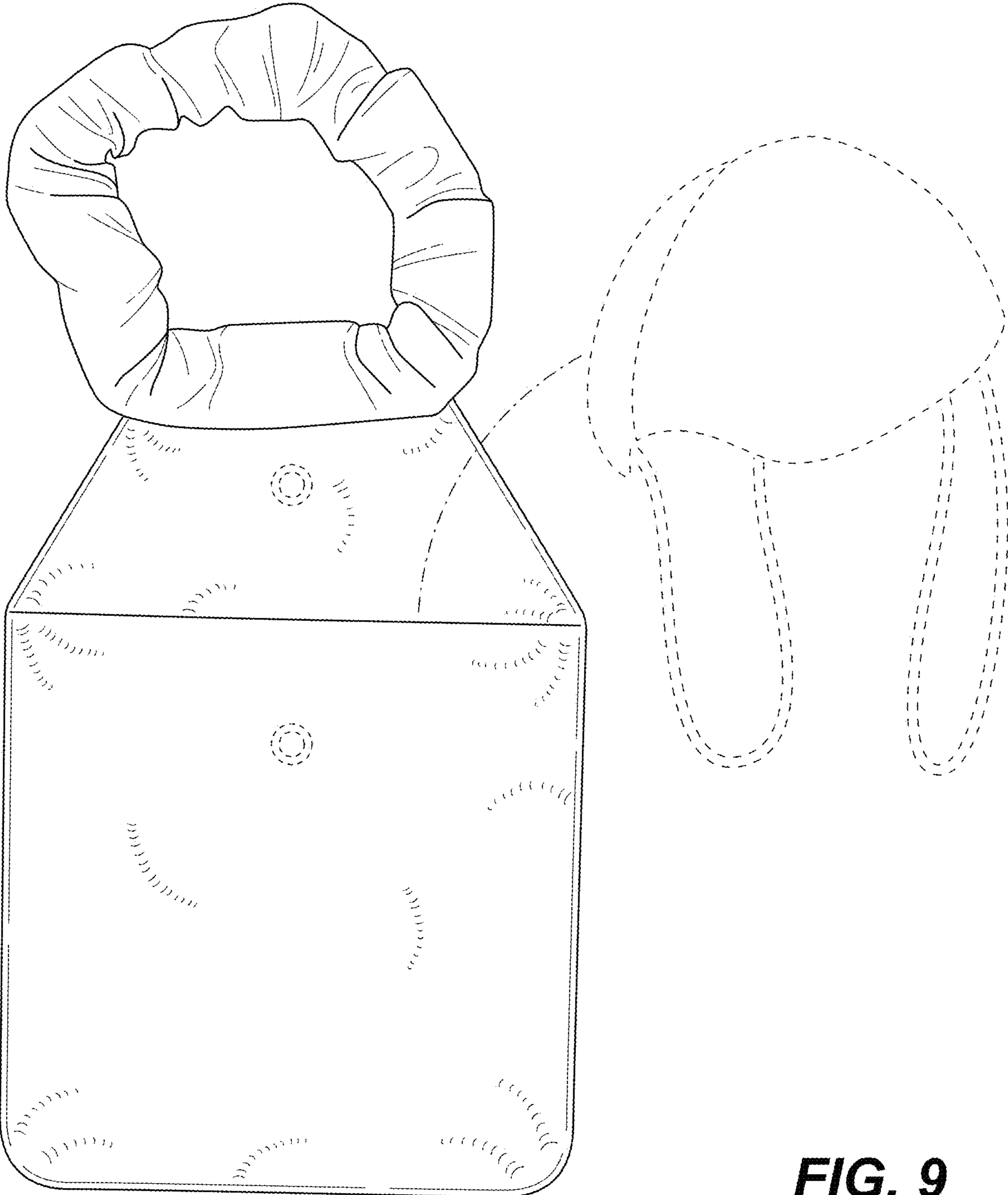
