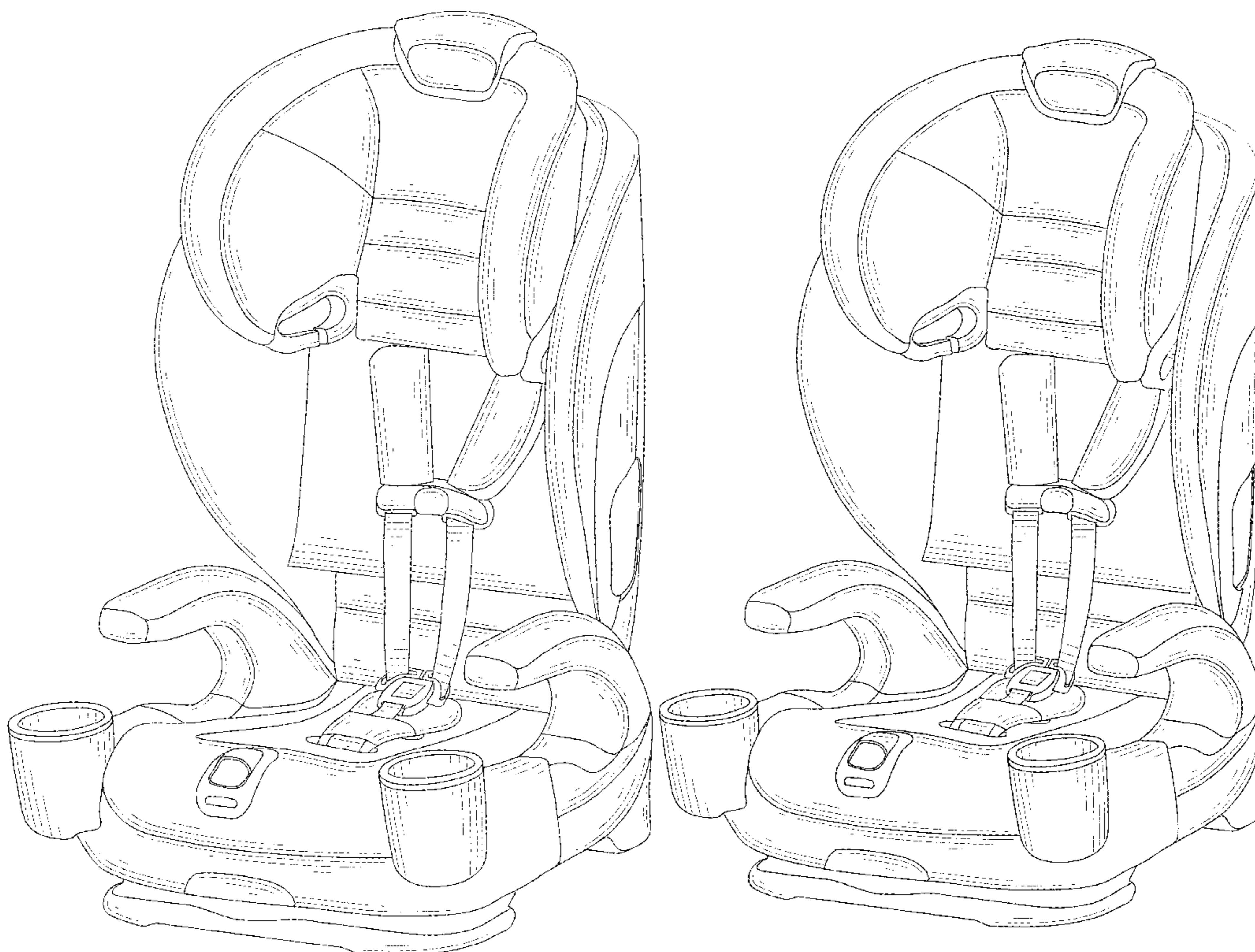
(57) **CLAIM**

The ornamental design for a safety seat, as shown and described.

DESCRIPTION

FIG. 1 is a front, right, and top perspective view of a safety seat, according to a first embodiment of our new design; FIG. 2 is a front elevation view of thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a left side view thereof; FIG. 5 is a right side view thereof; FIG. 6 is a top view thereof; FIG. 7 is a bottom view thereof; FIG. 8 is a front, right, and top perspective view of a safety seat, according to a second embodiment of our new design; FIG. 9 is a front elevation view of thereof; FIG. 10 is a rear elevation view thereof; FIG. 11 is a left side view thereof; FIG. 12 is a right side view thereof; FIG. 13 is a top view thereof; and, FIG. 14 is a bottom view thereof. 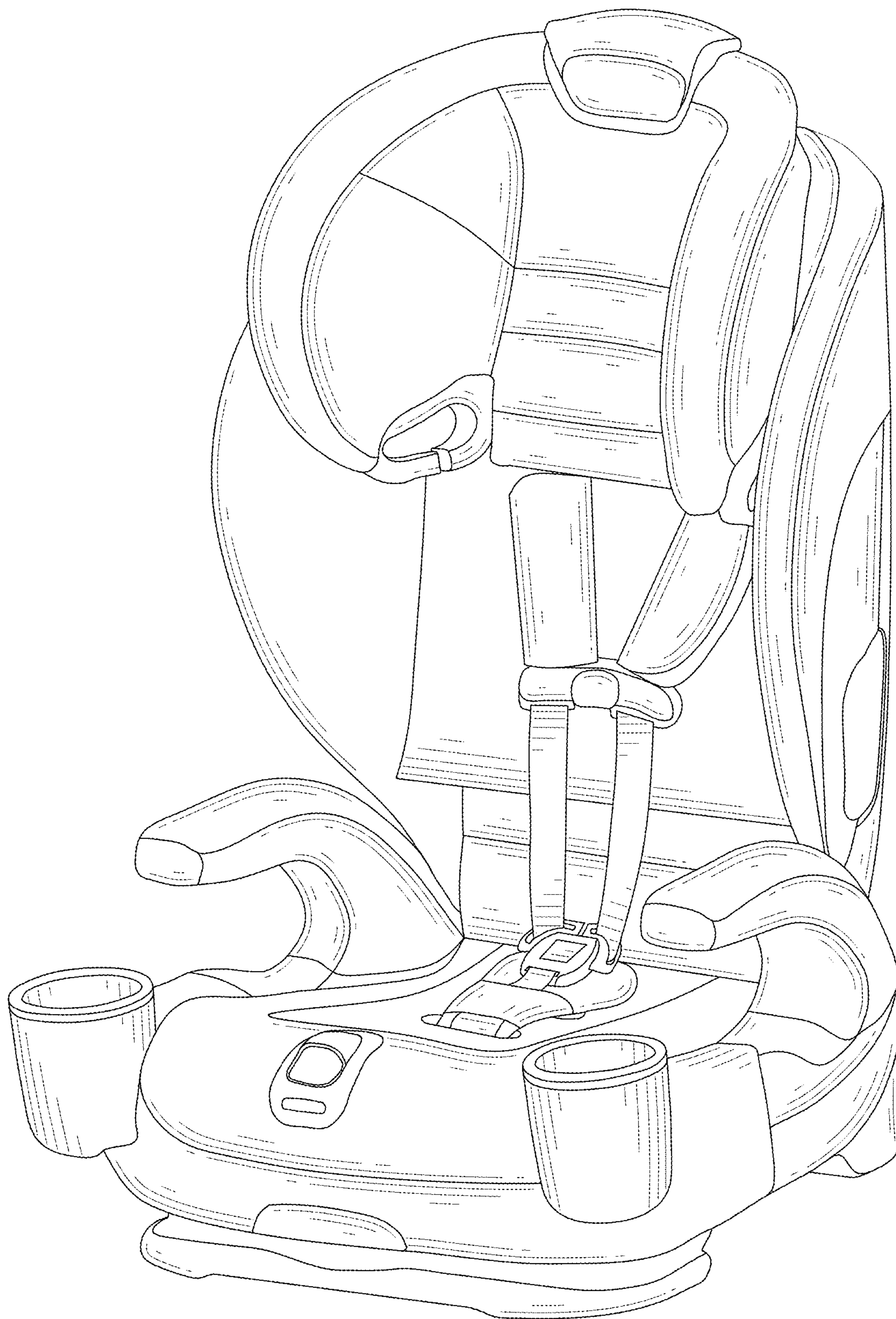

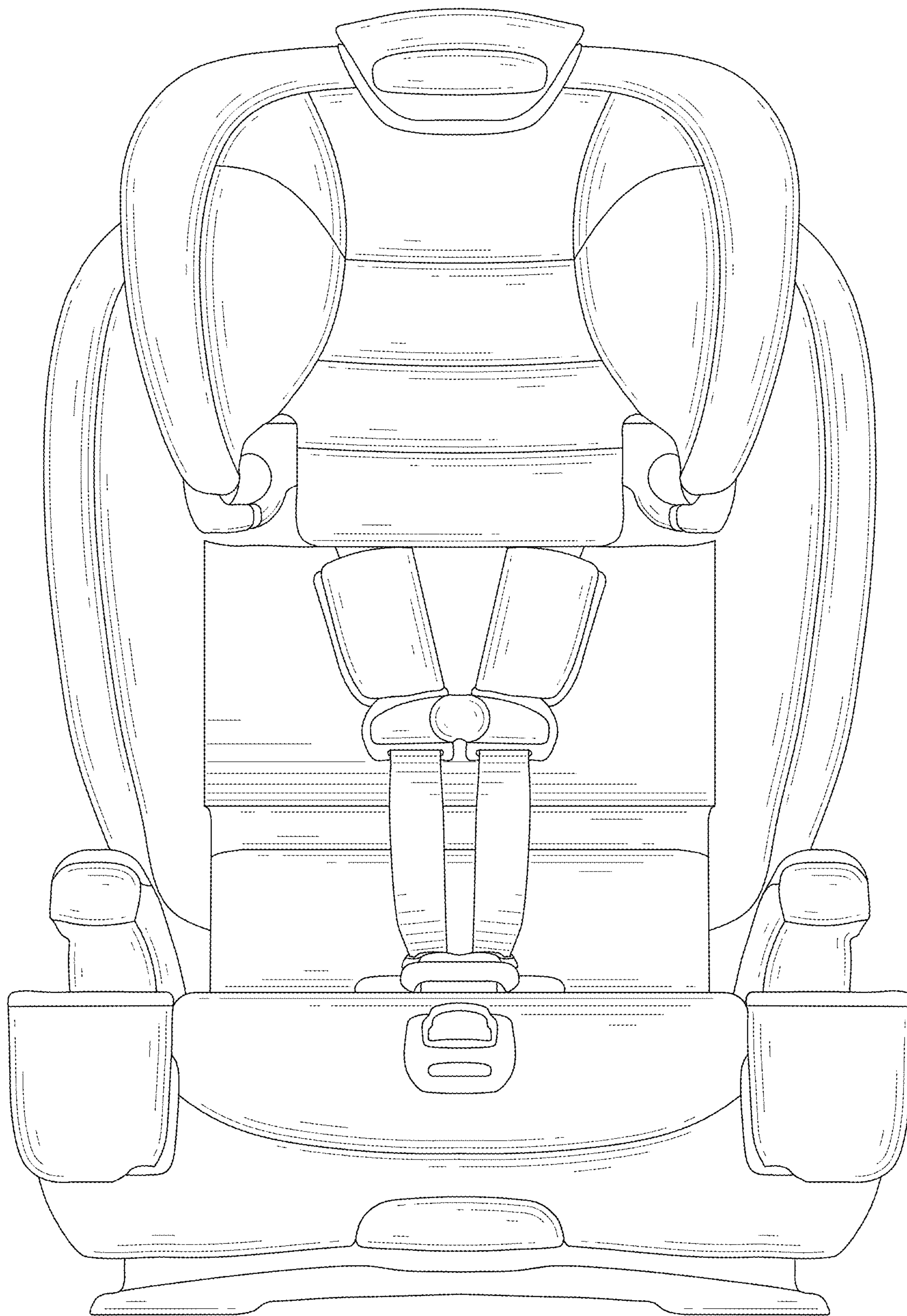

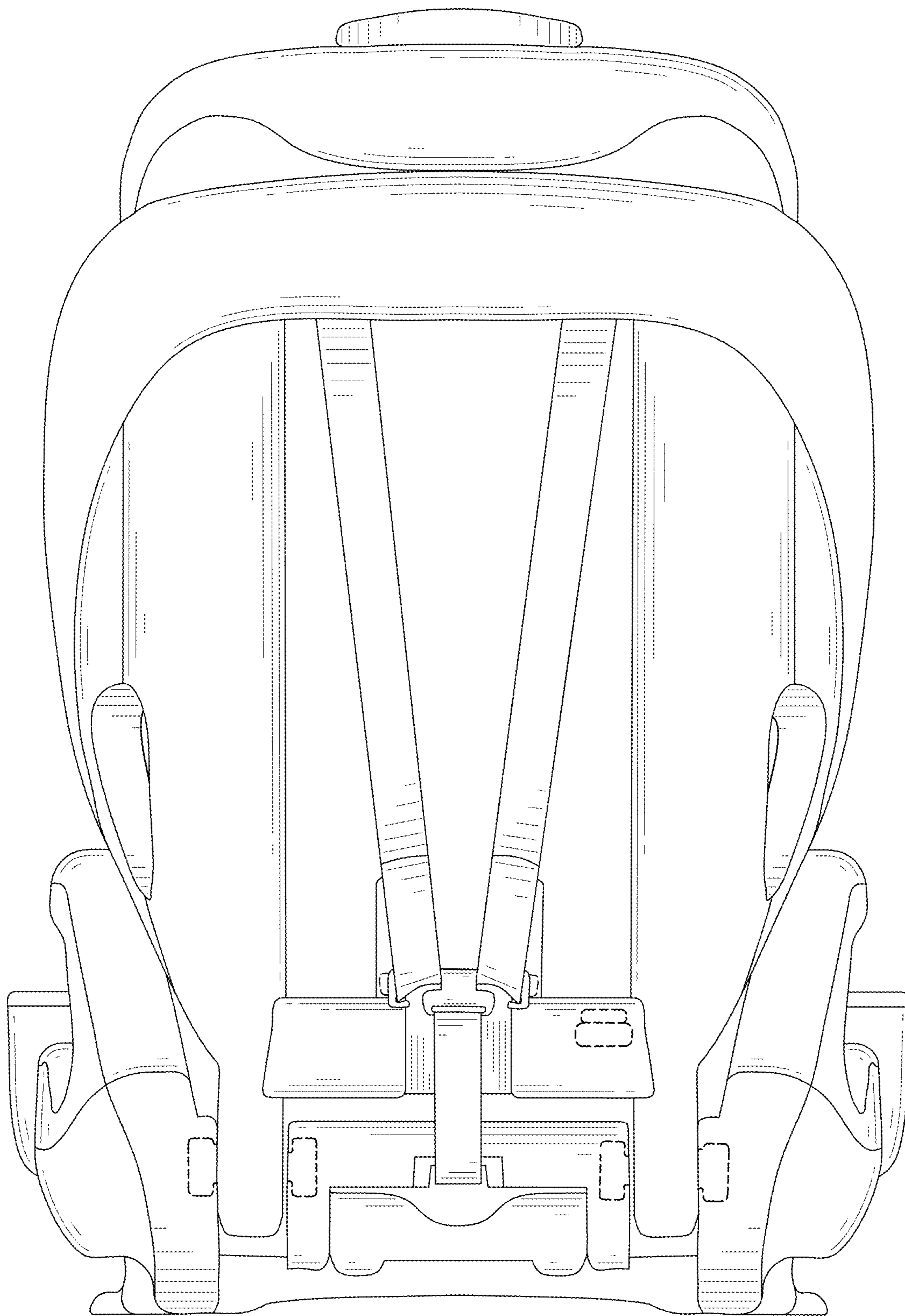

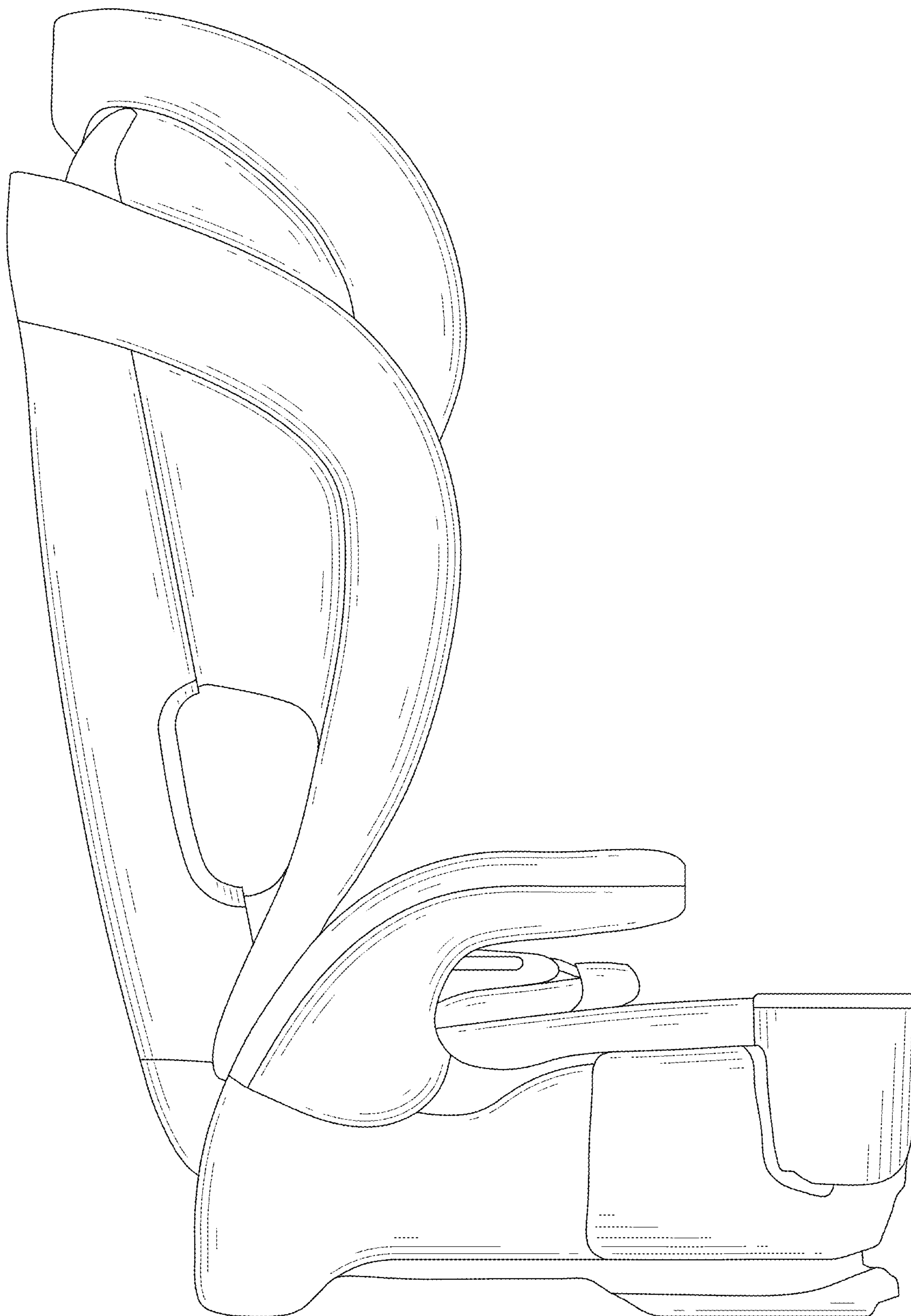

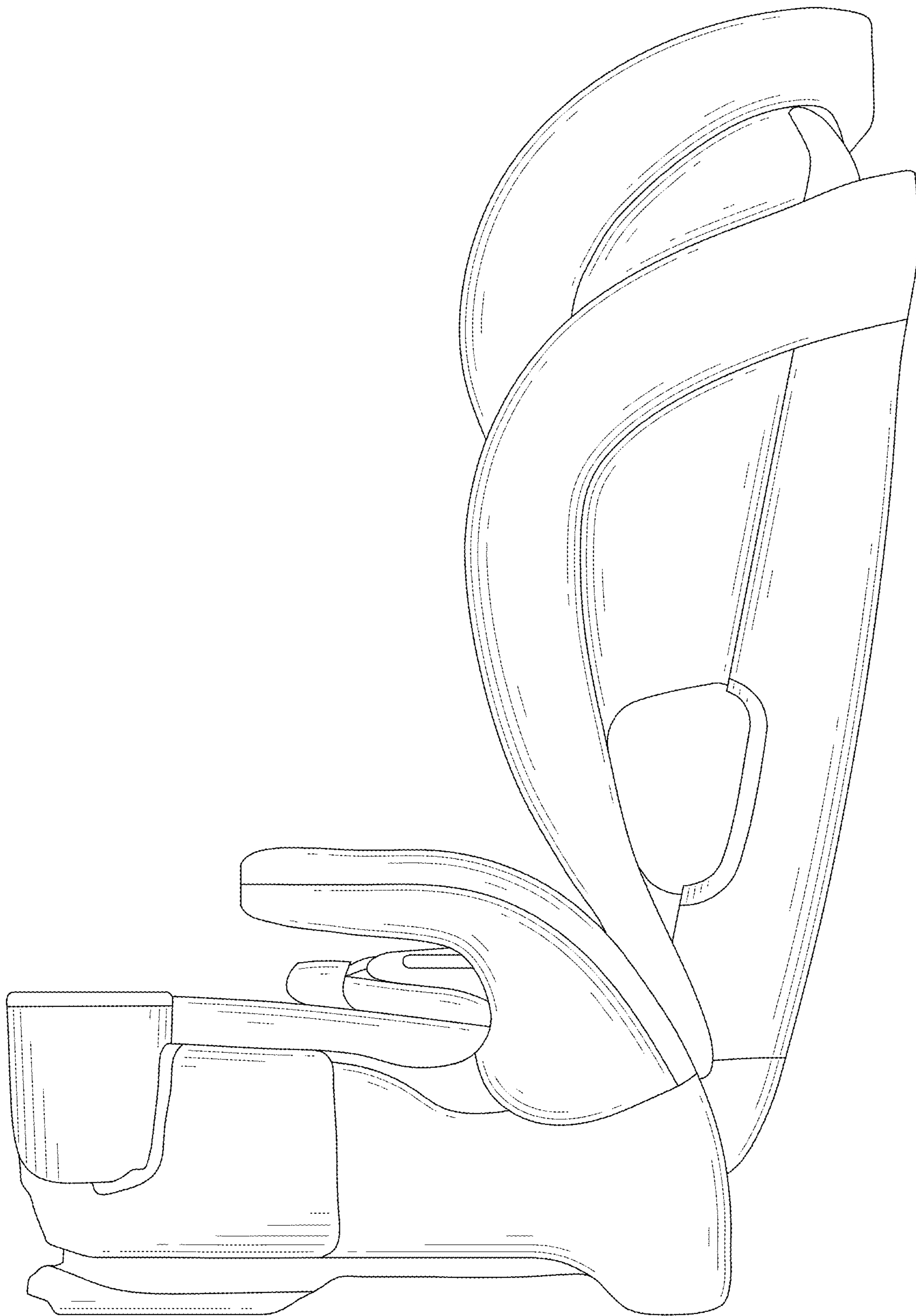

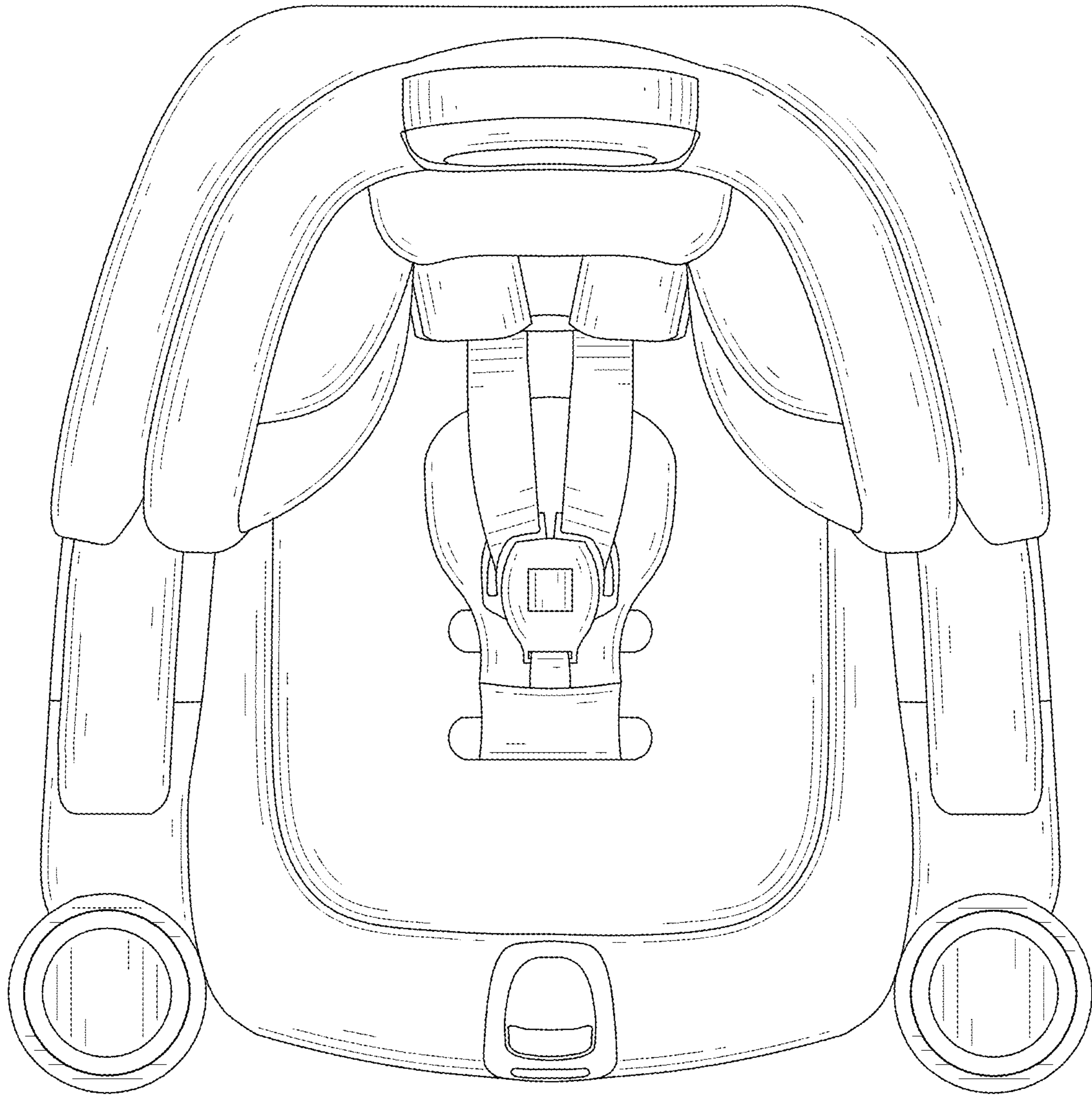

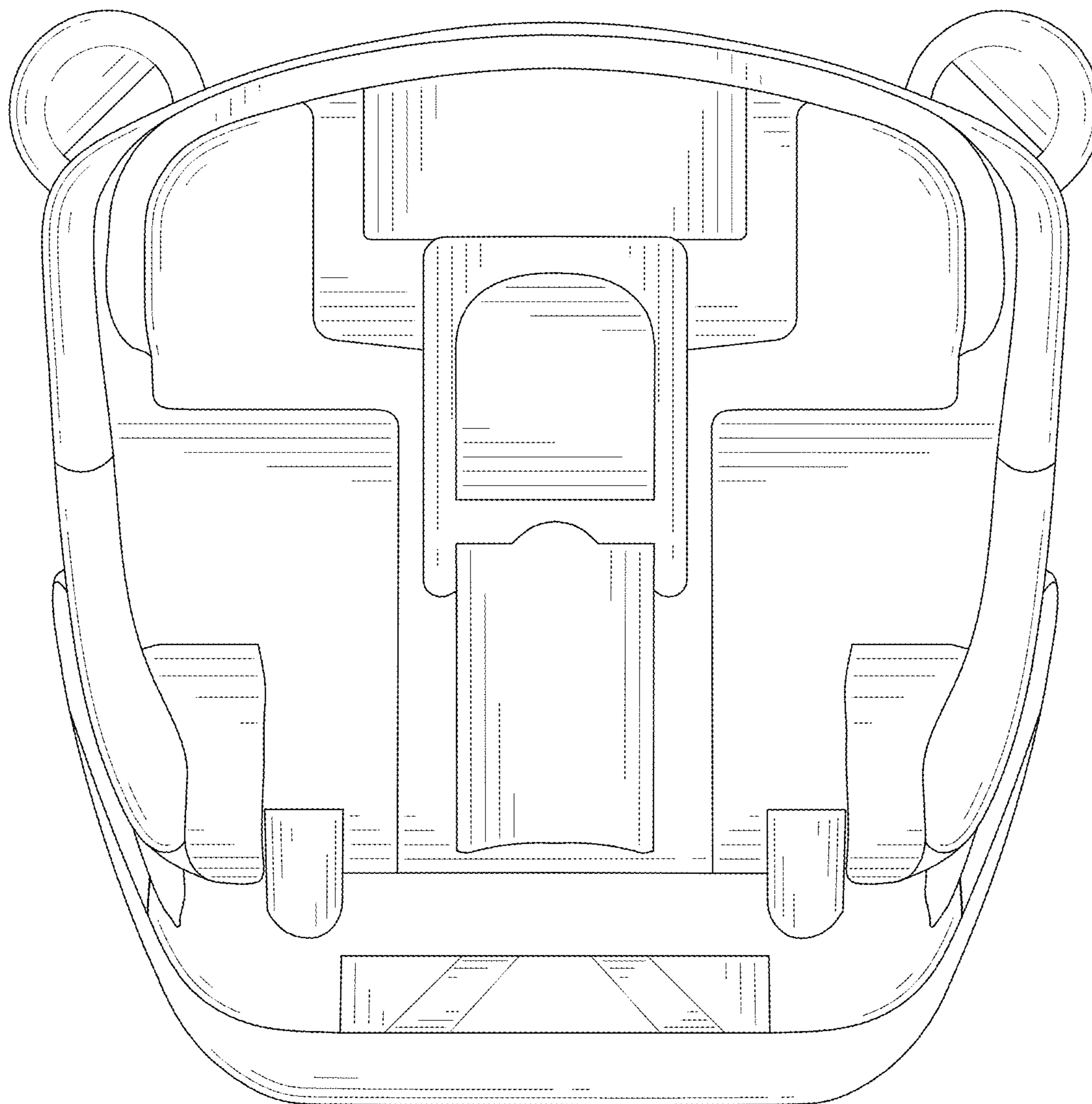

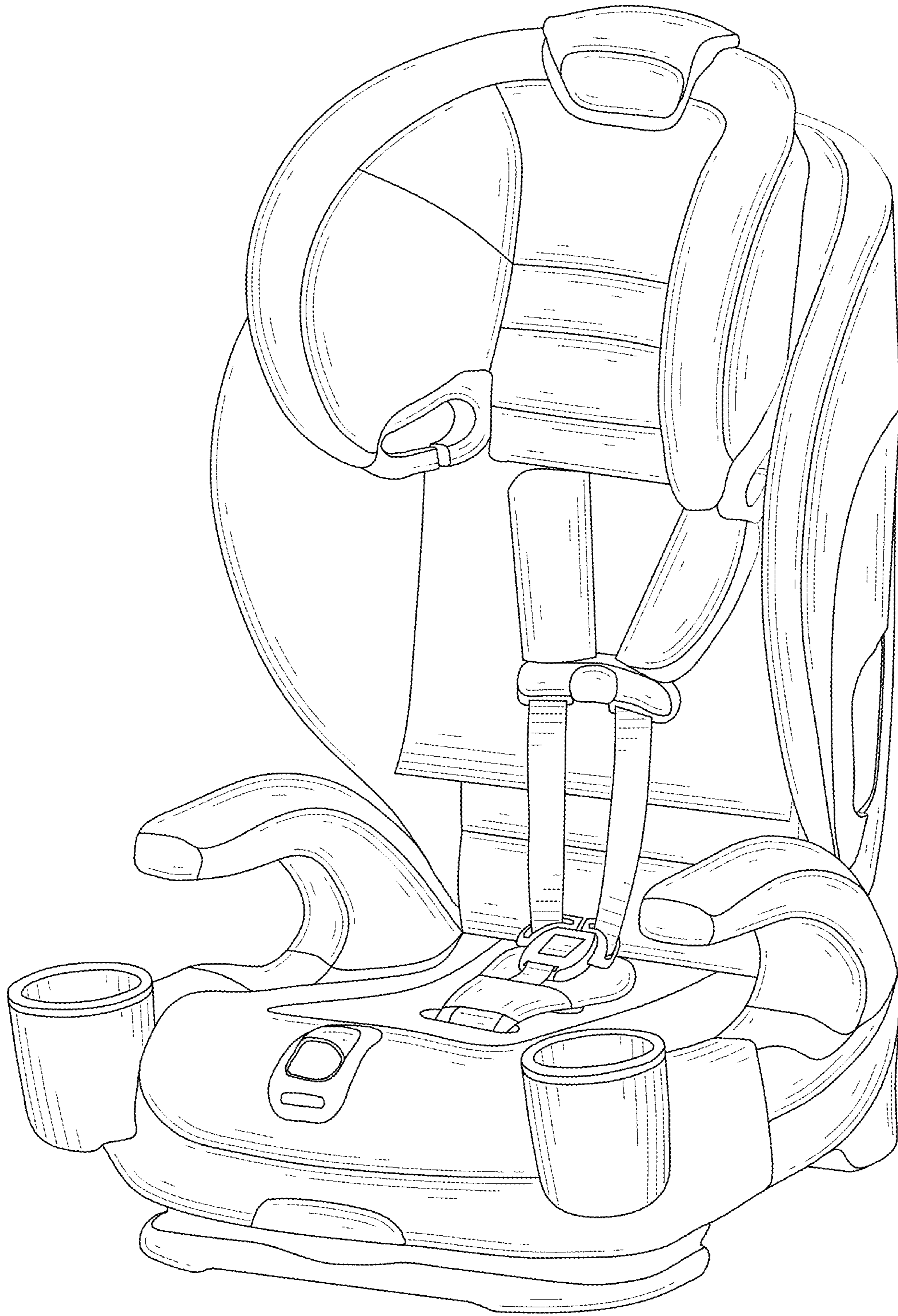

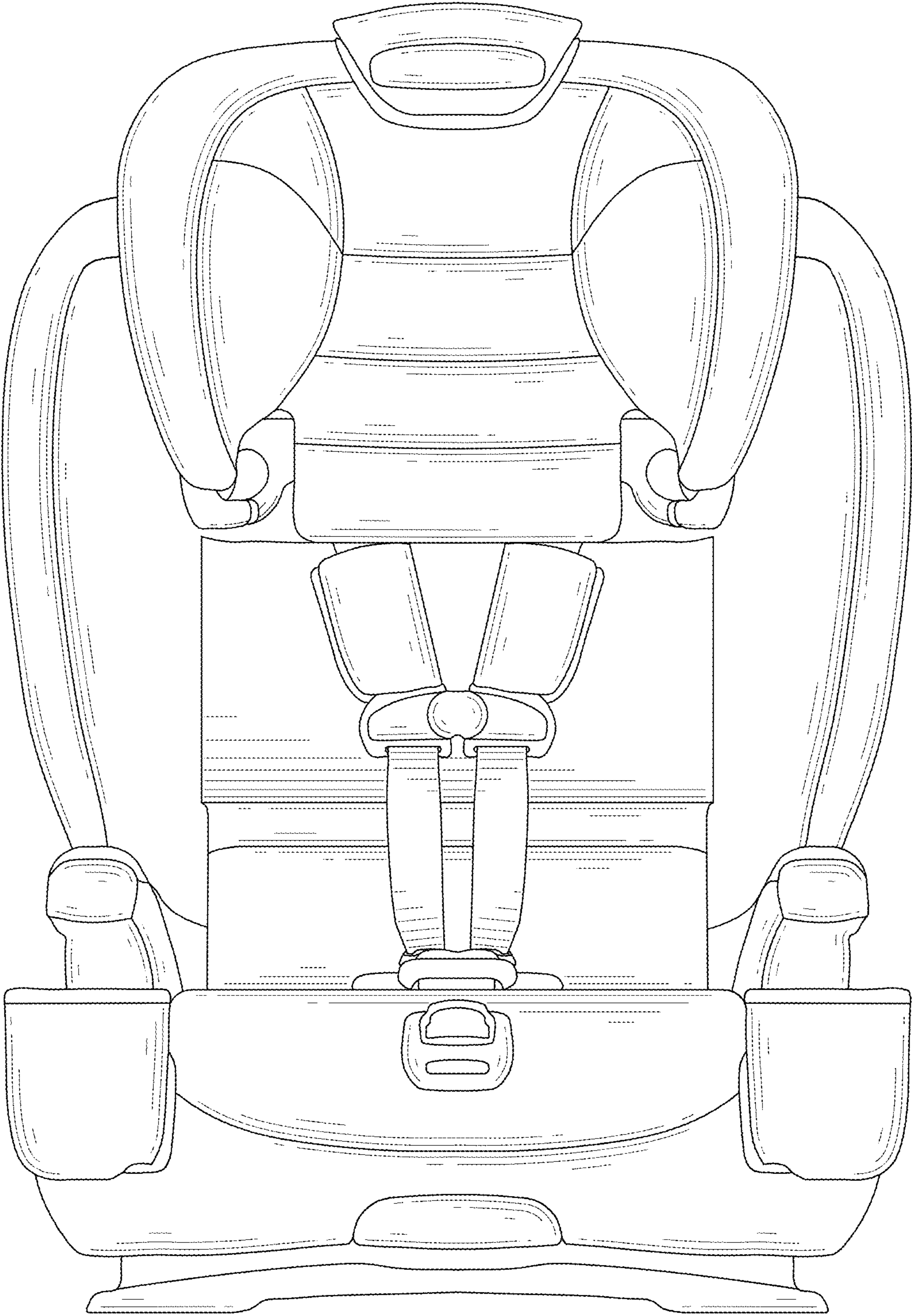

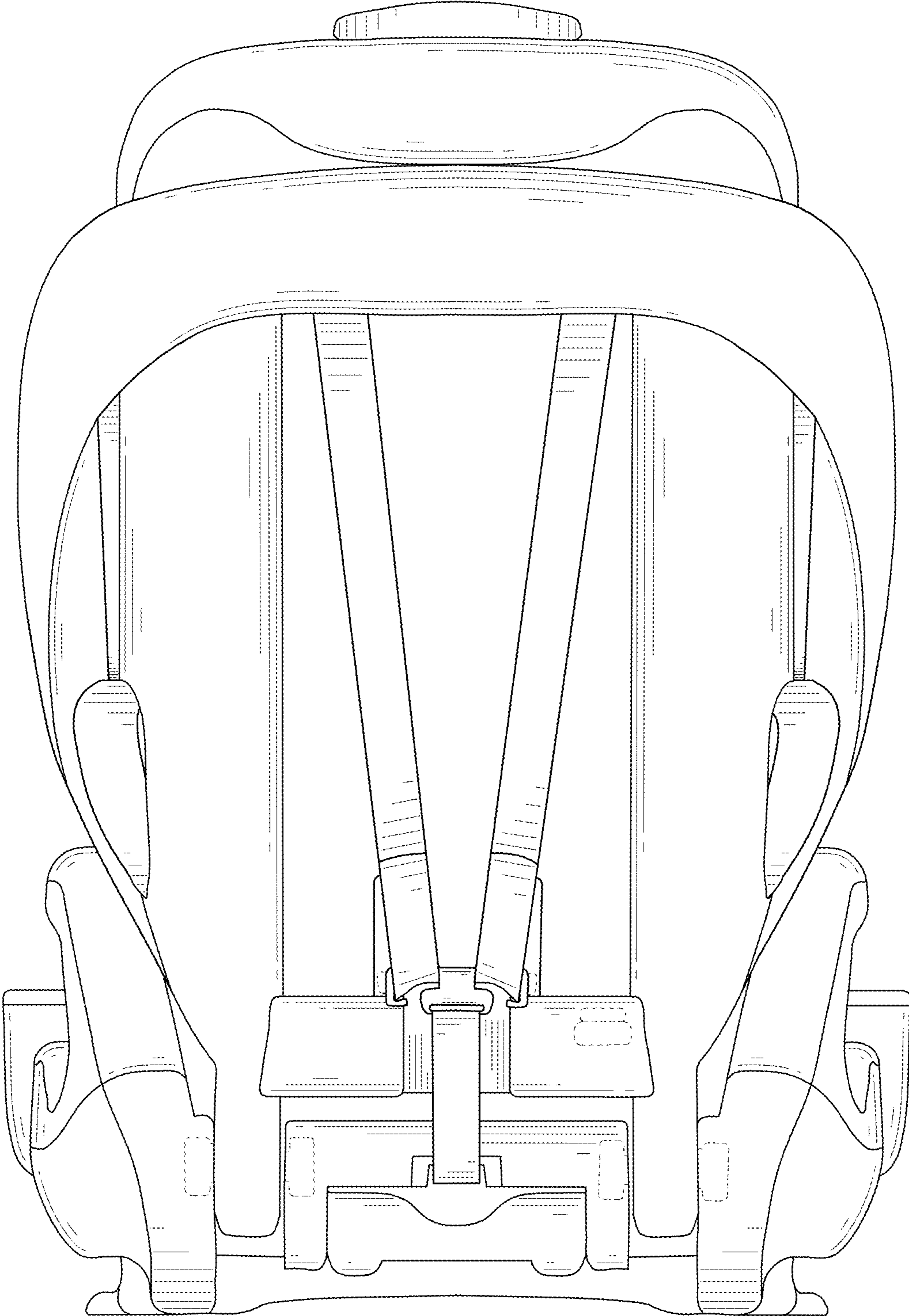

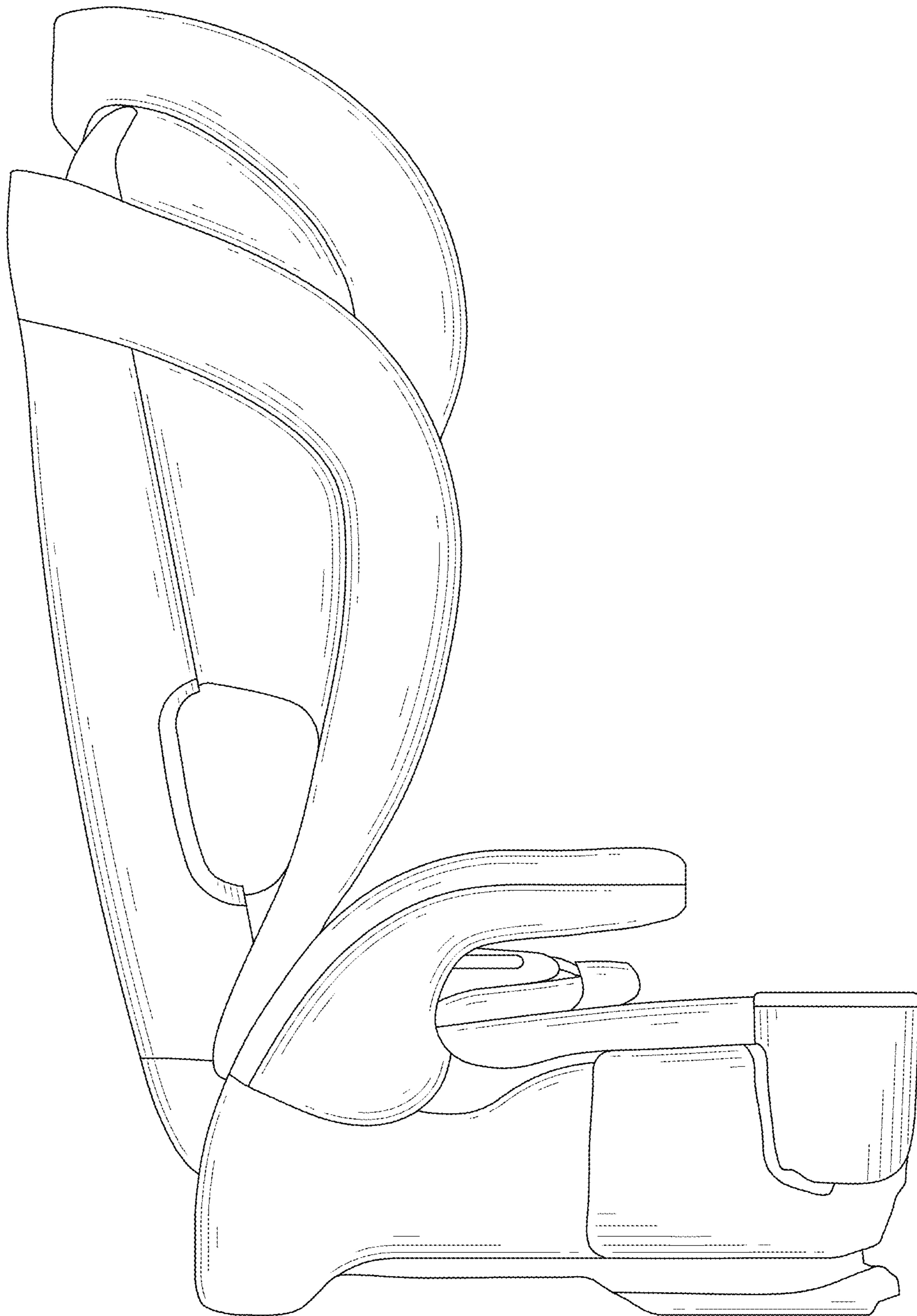

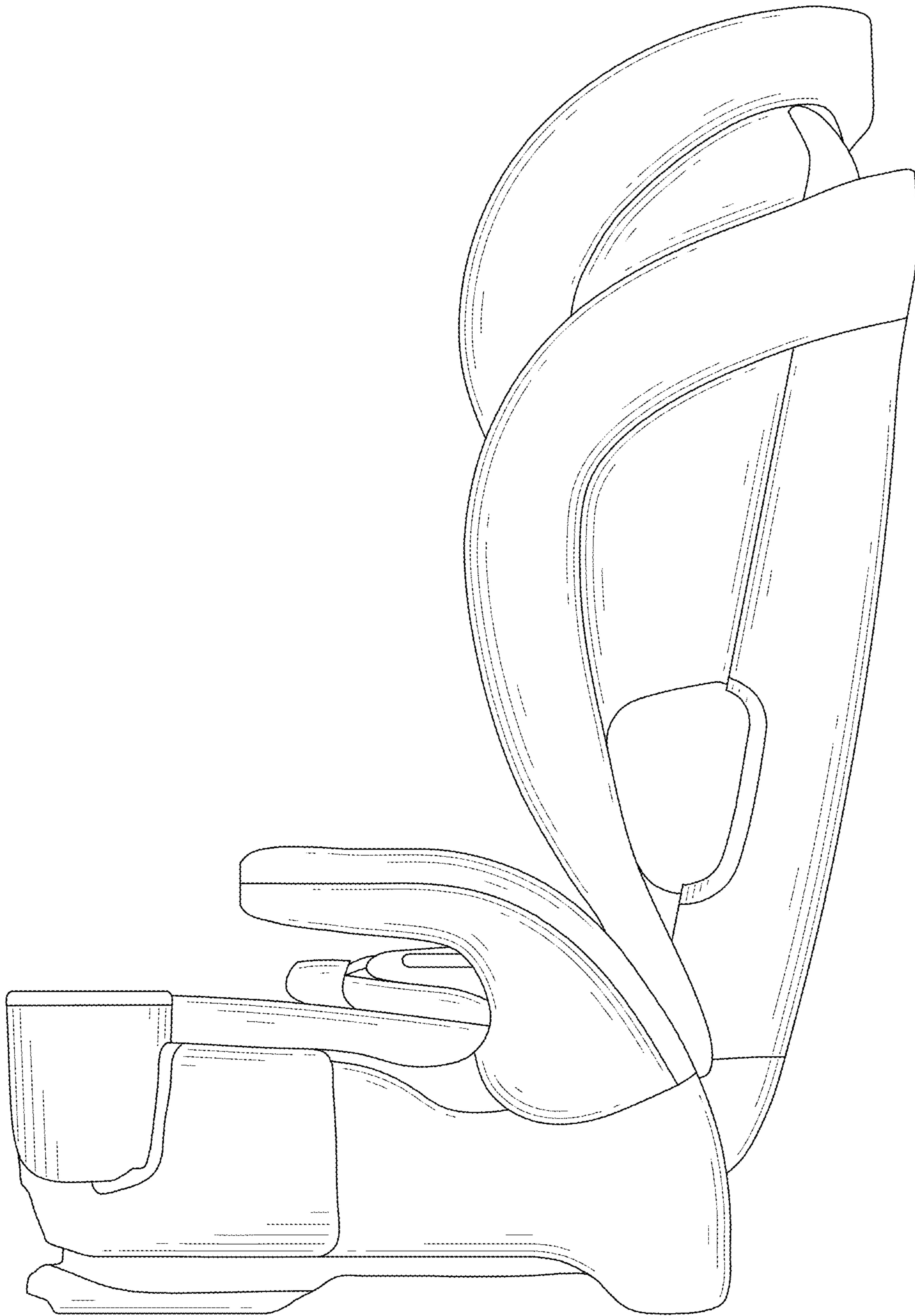

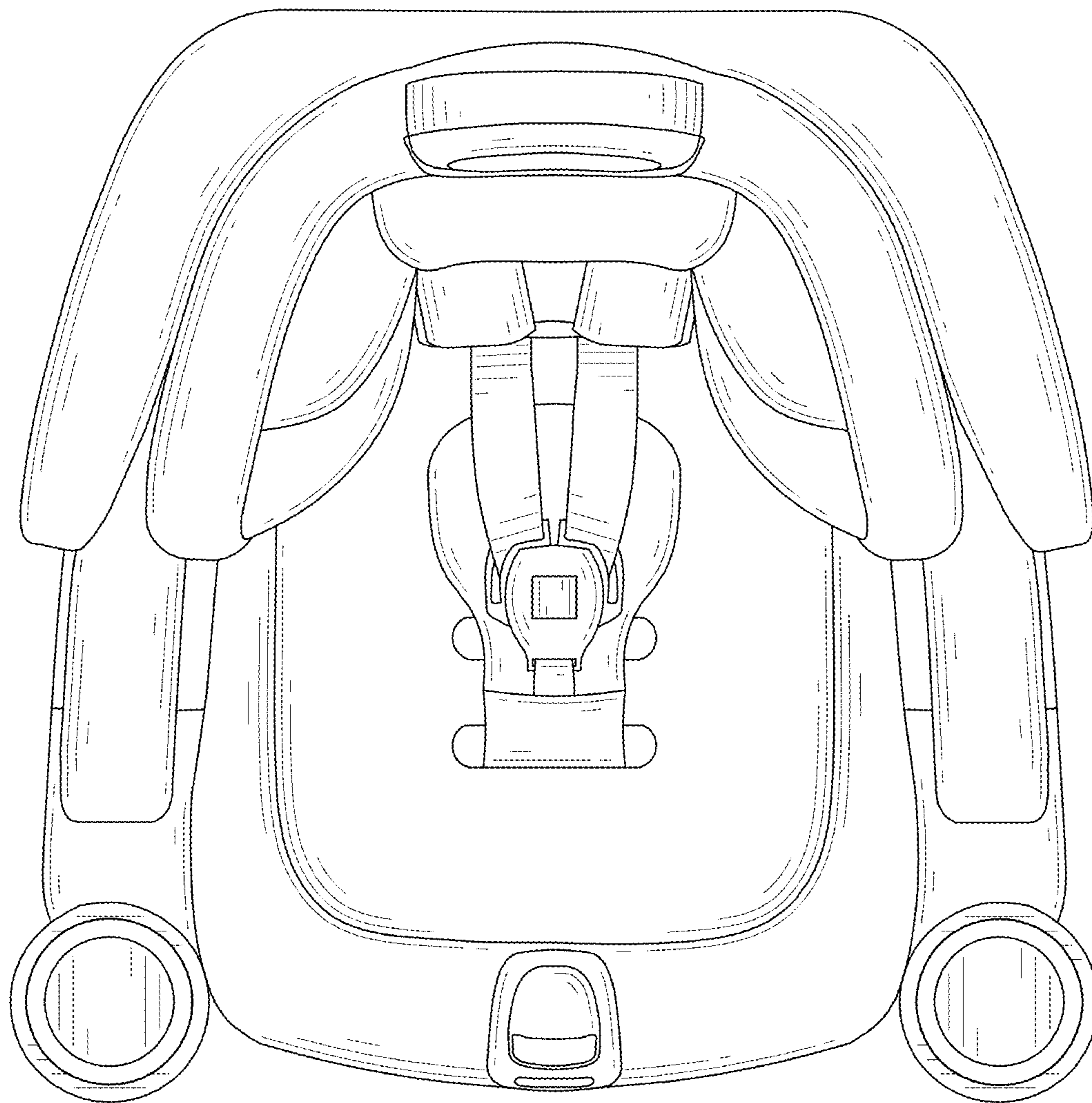

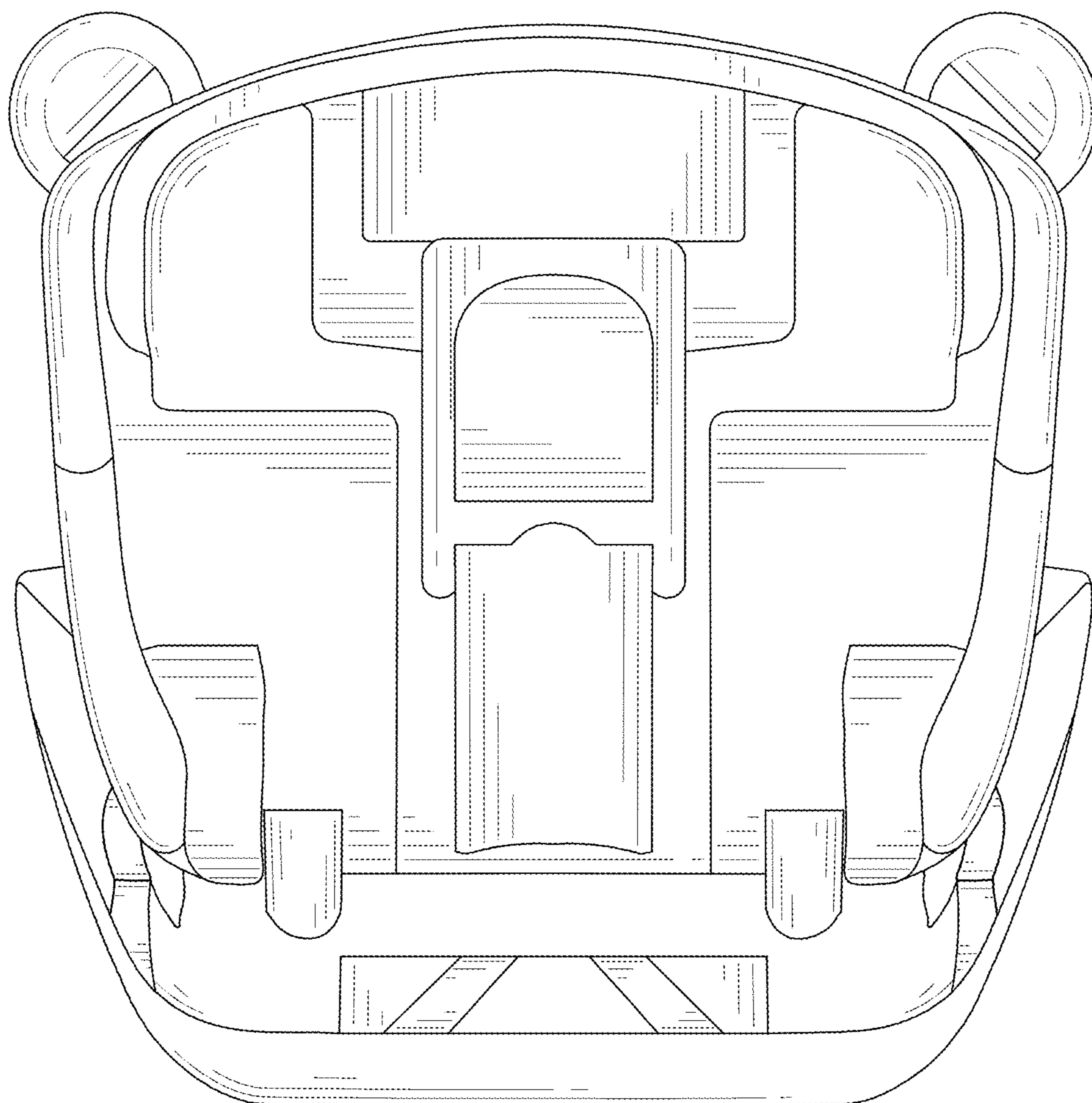
