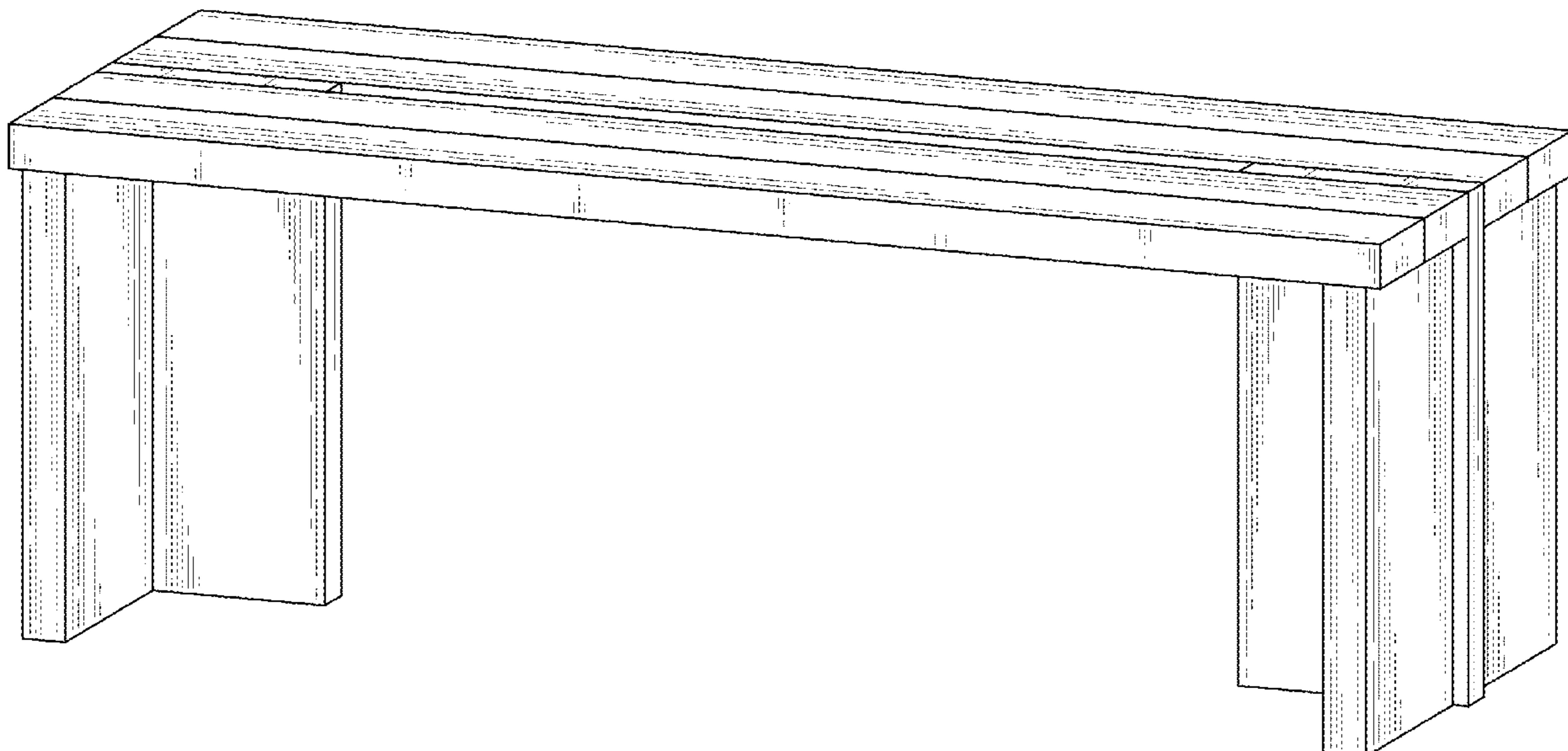
(57) **CLAIM**

The ornamental design for a bench, as shown and described.

**DESCRIPTION**

FIG. 1 is a front side perspective view of a bench in accordance with the present invention; FIG. 2 is a front side view thereof, a rear side view being a mirror image thereof; FIG. 3 is a right side view thereof, a left side view being a mirror image thereof; FIG. 4 is a bottom view thereof; FIG. 5 is a top view thereof; and, FIG. 6 is a bottom side perspective view thereof. The broken lines of the Figures depict environmental subject matter and form no part of the claimed design.

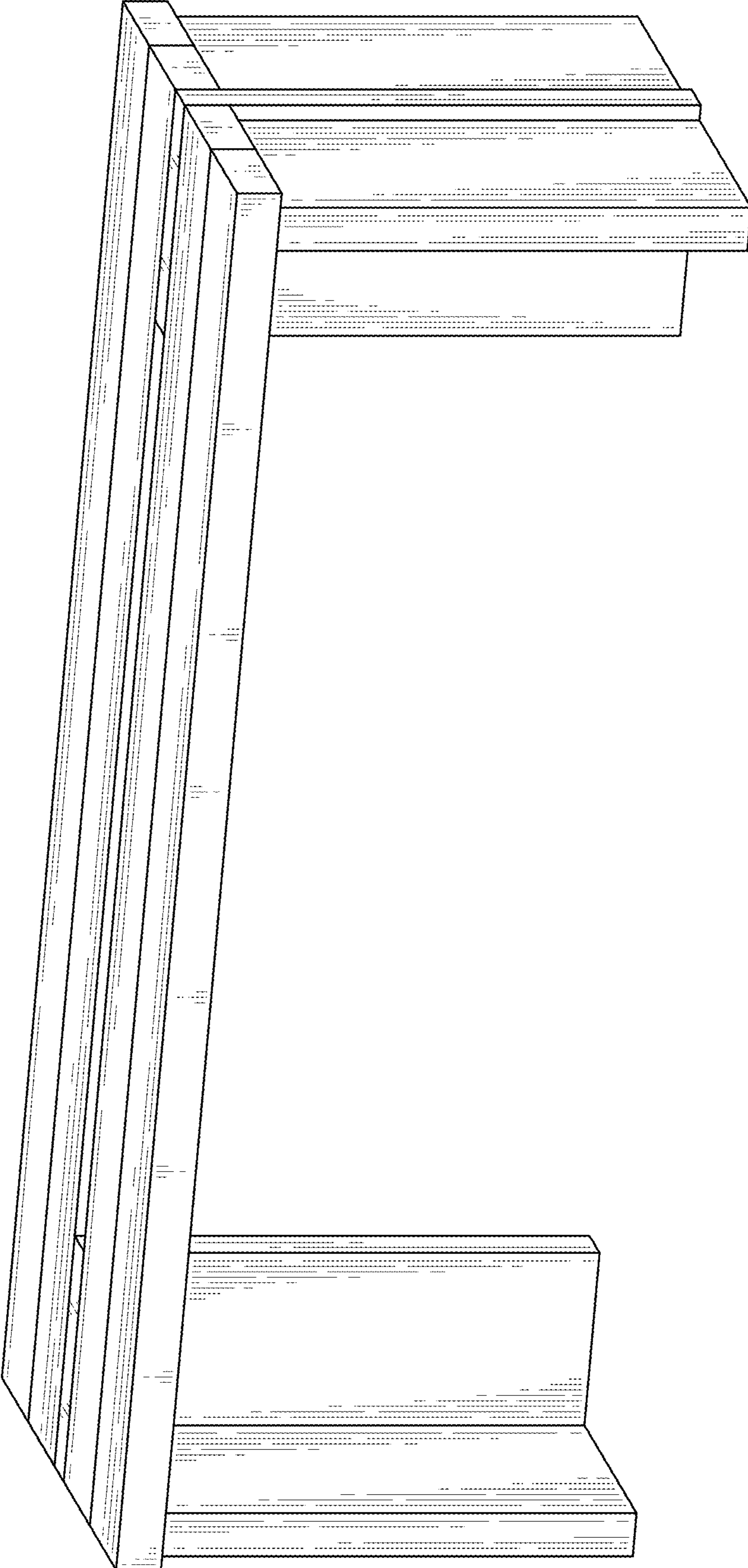

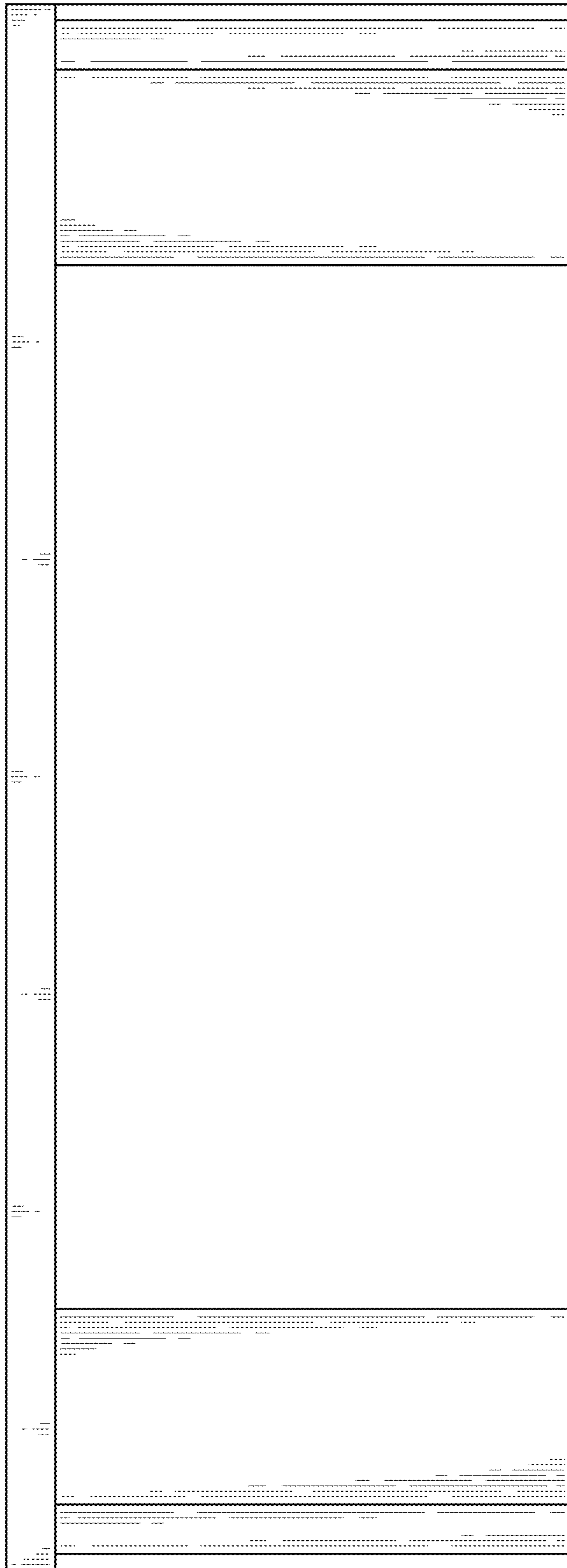

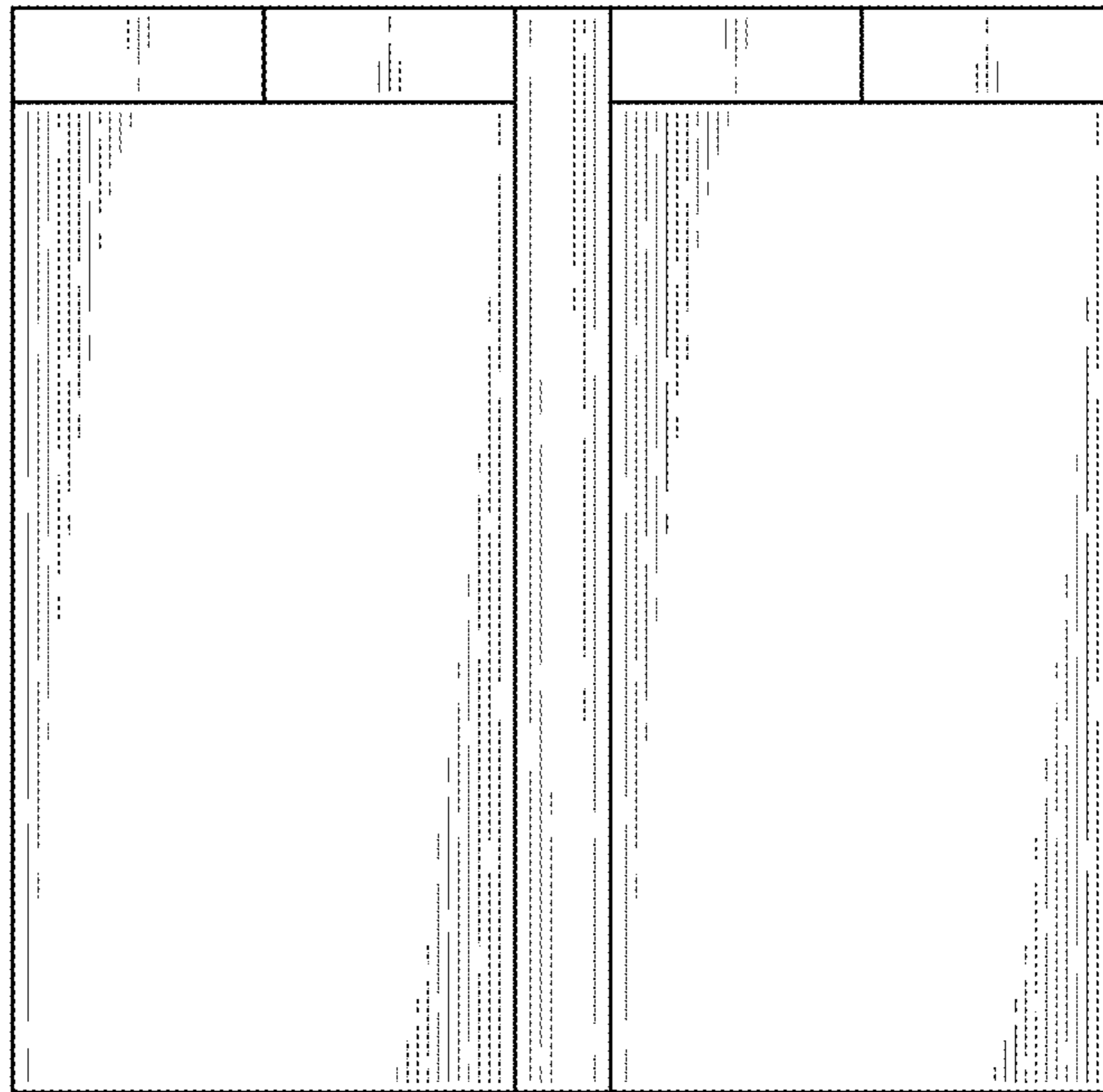

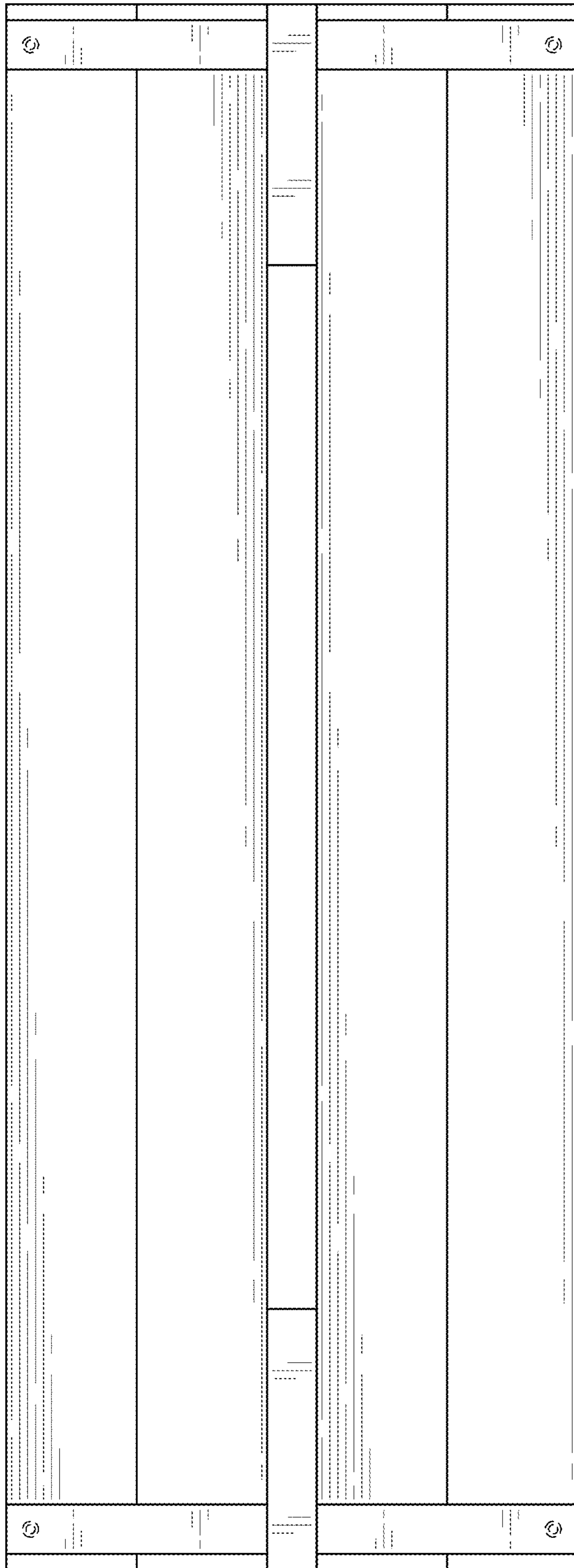

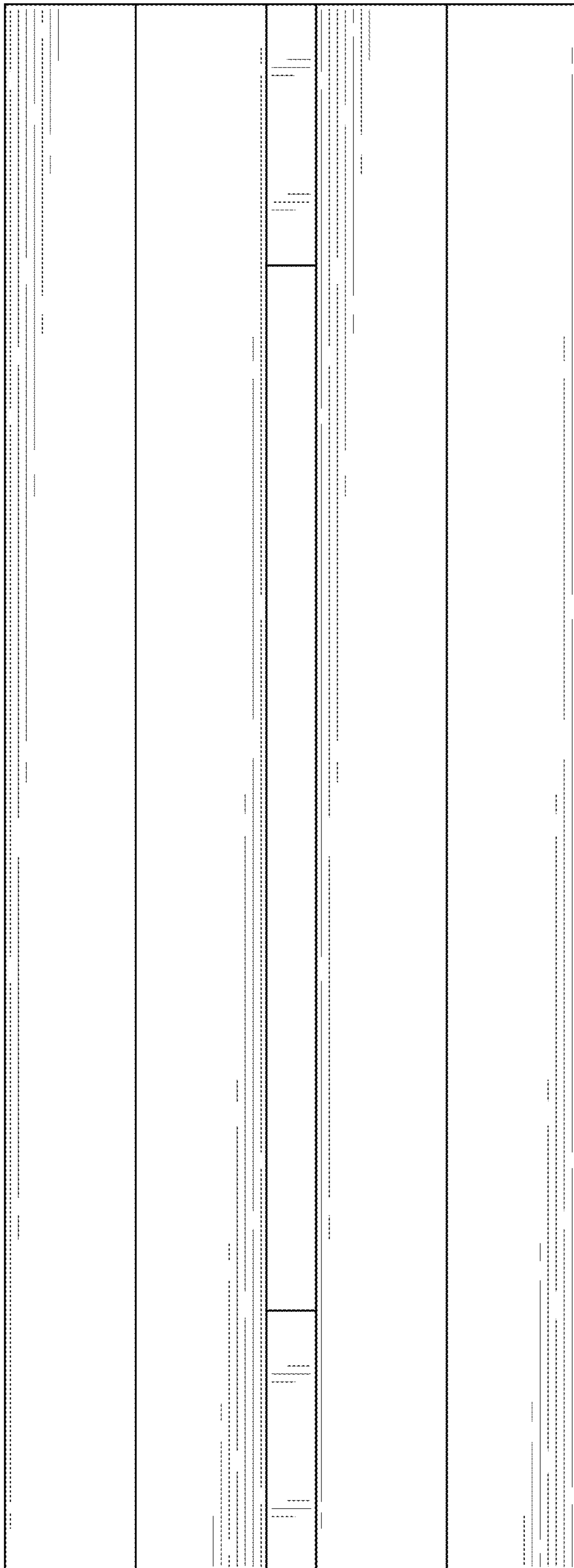

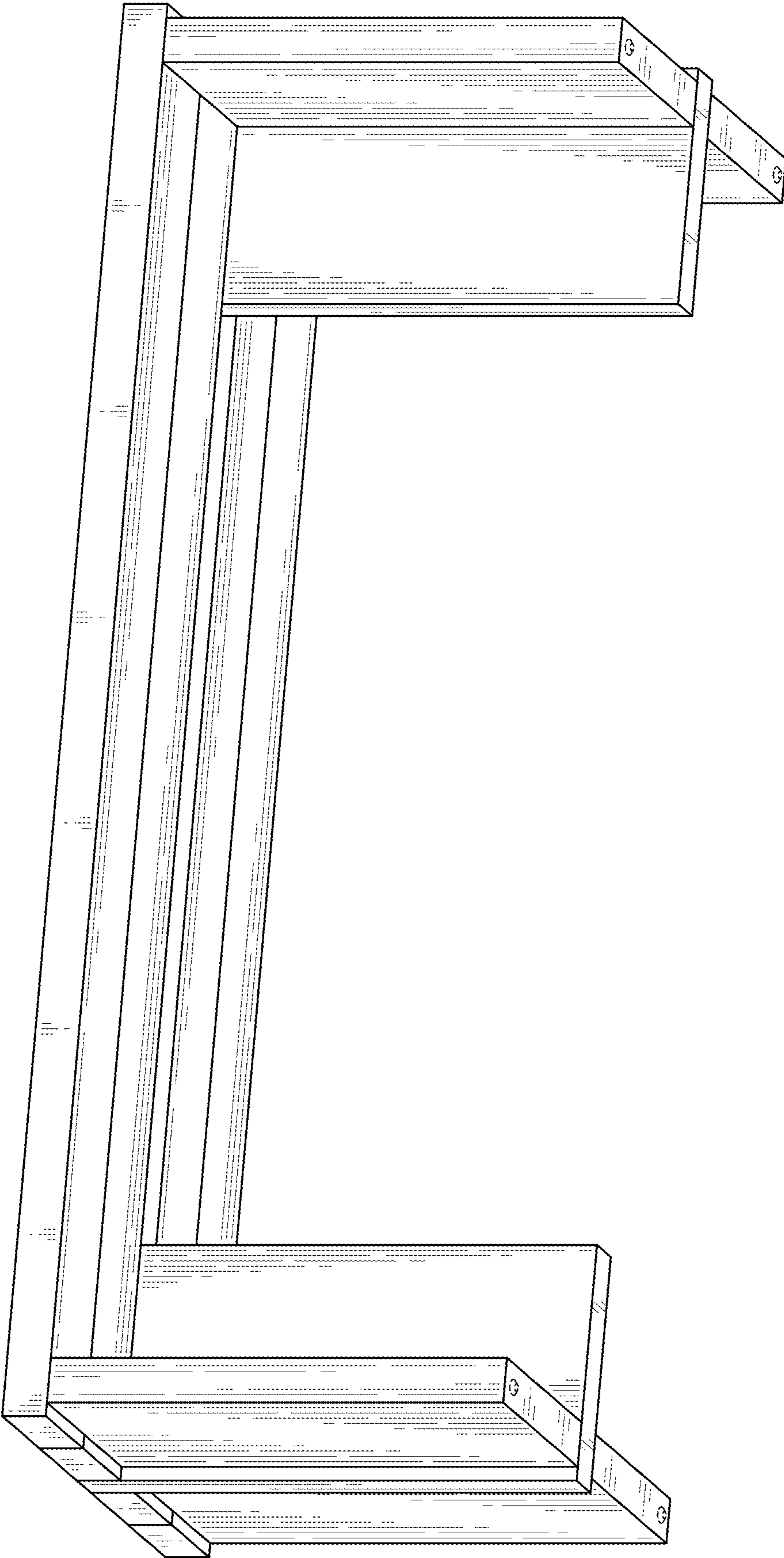
