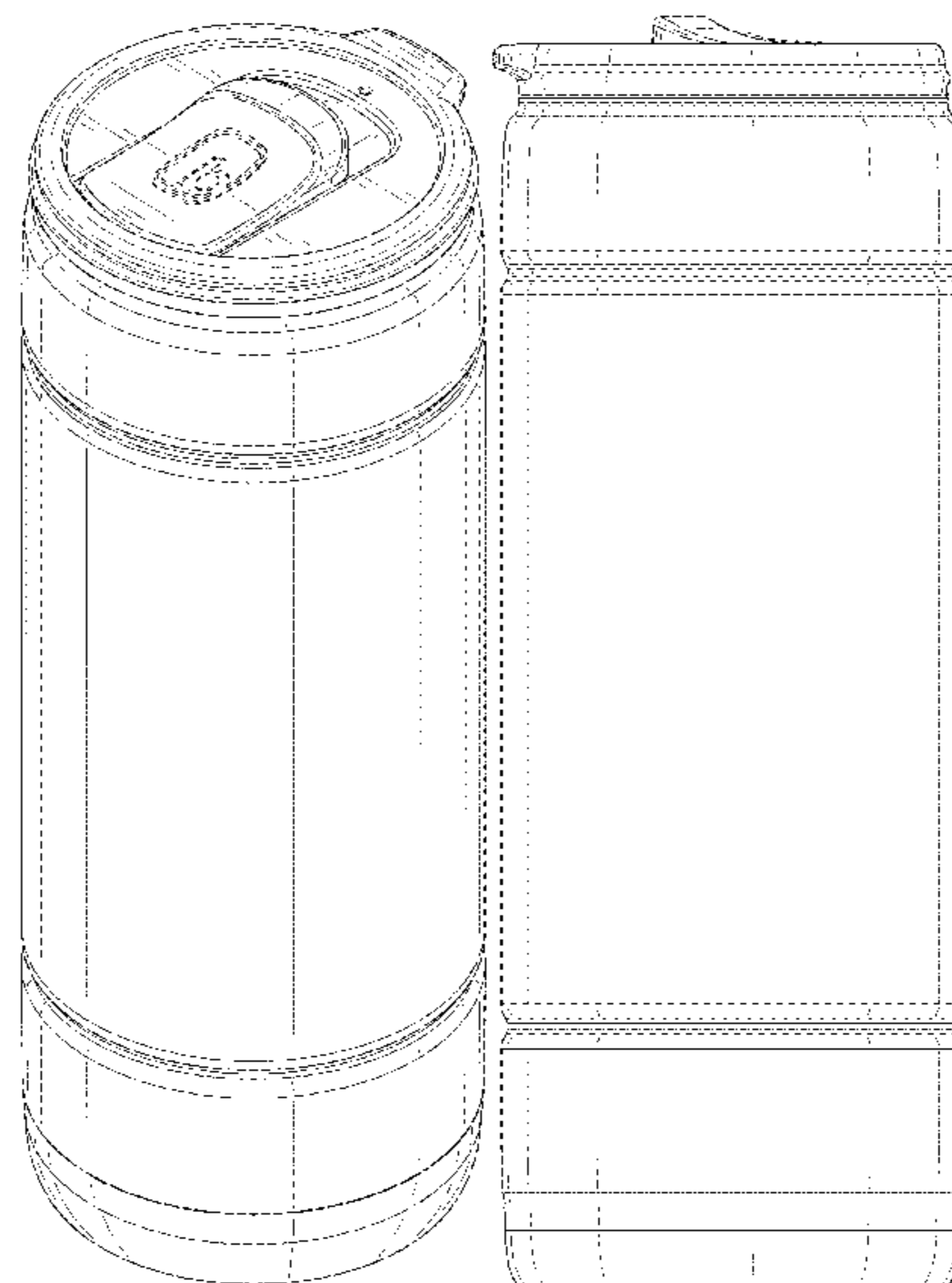
(57) **CLAIM**

The ornamental design for a beverage container, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a beverage container with lid in closed position;

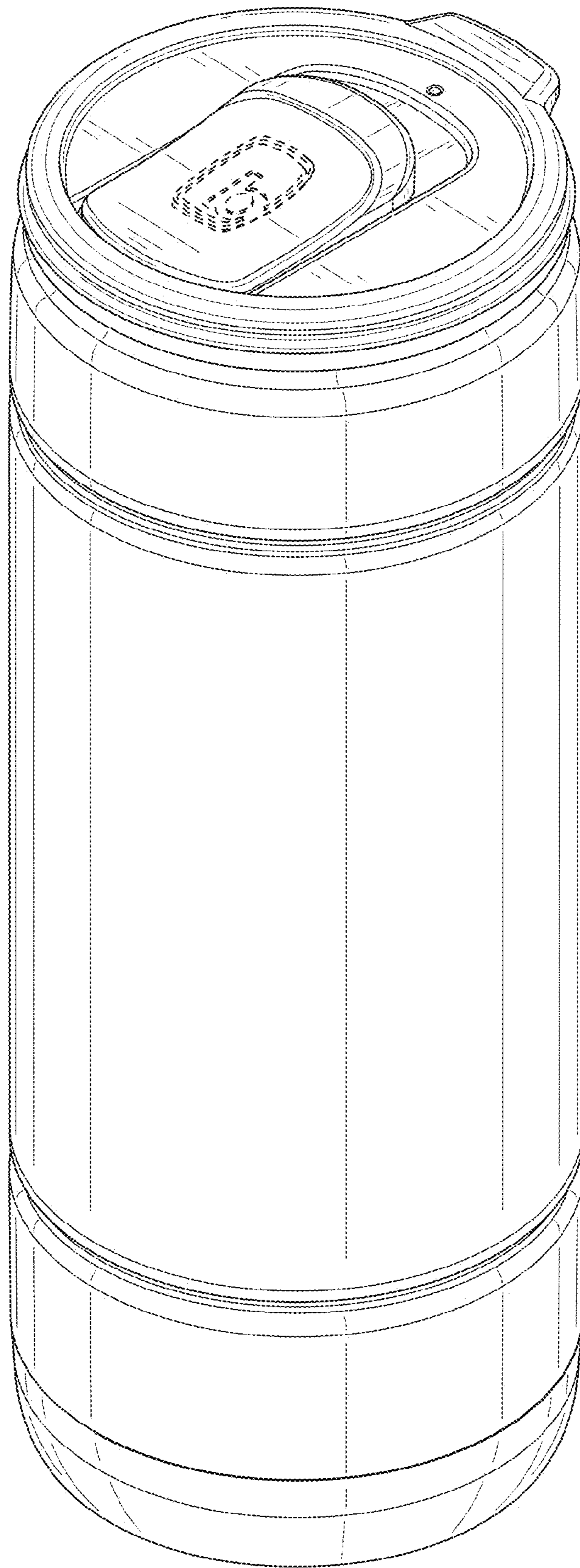

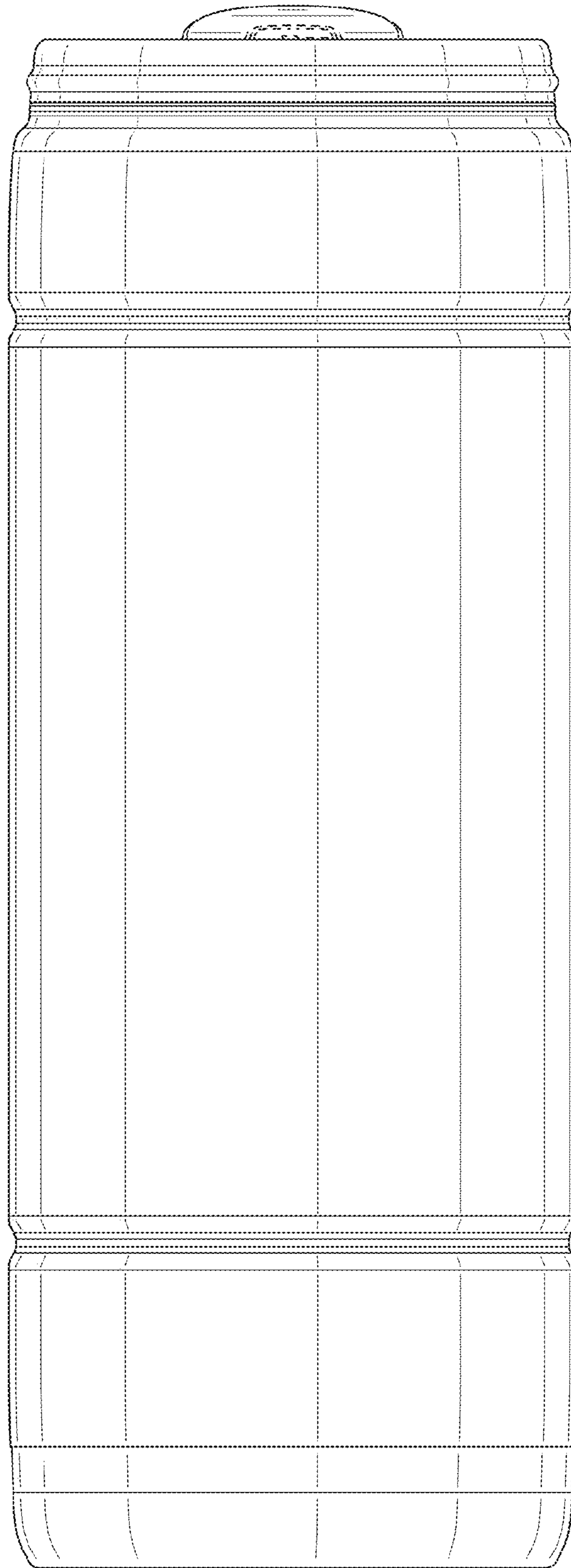

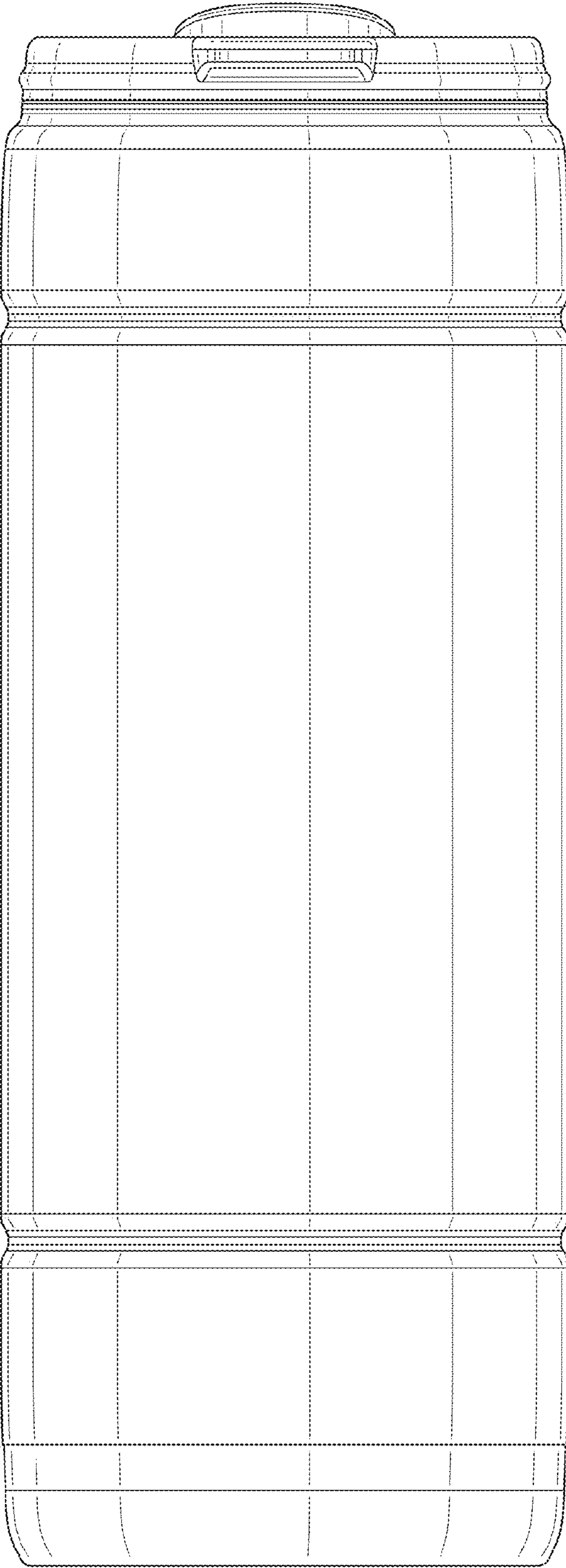

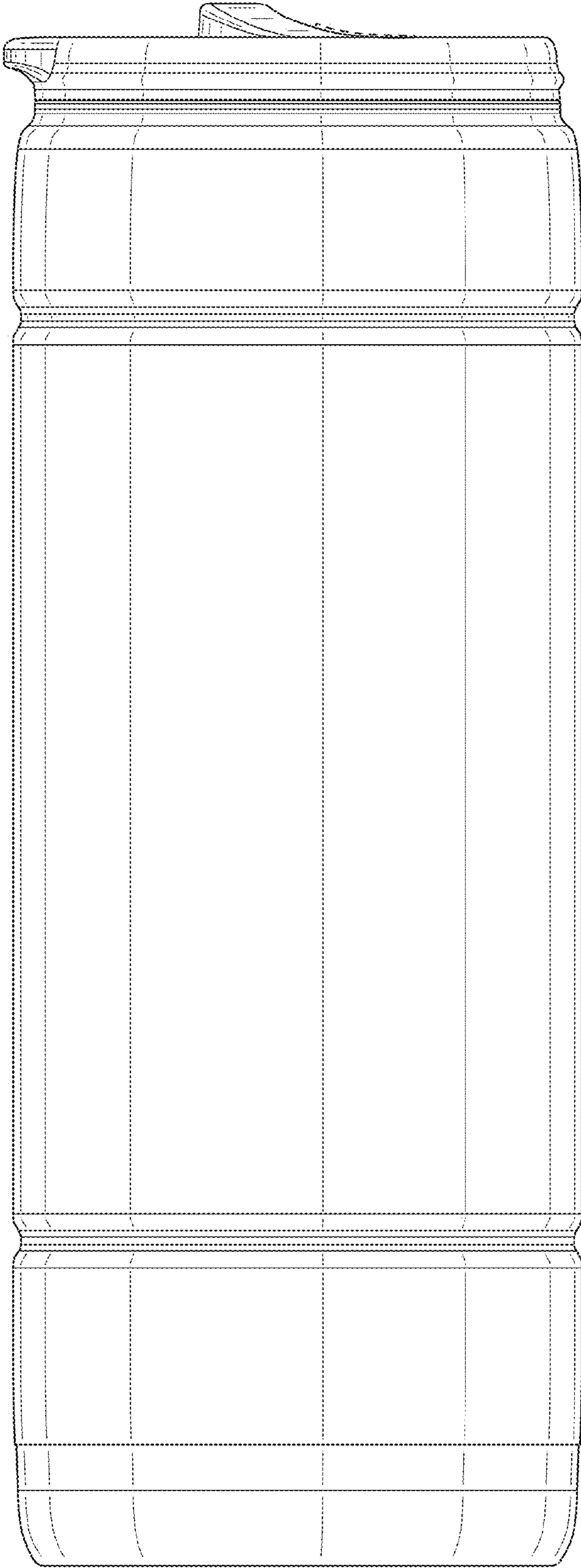

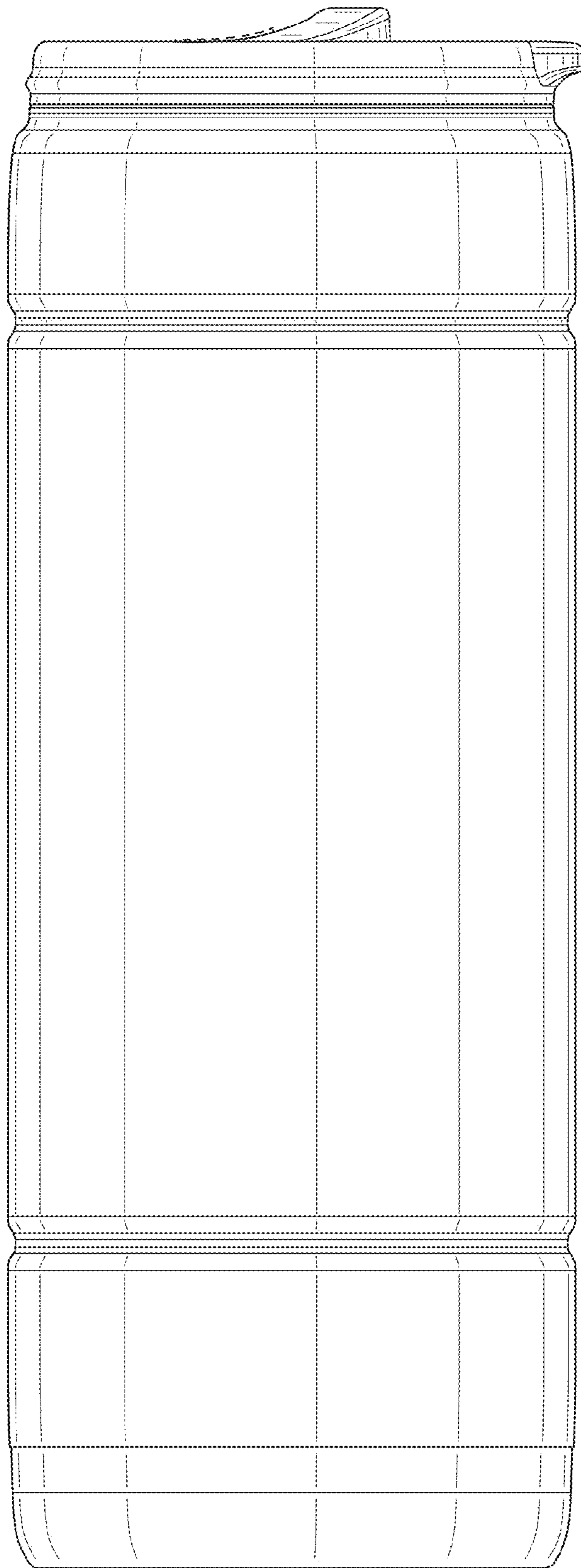

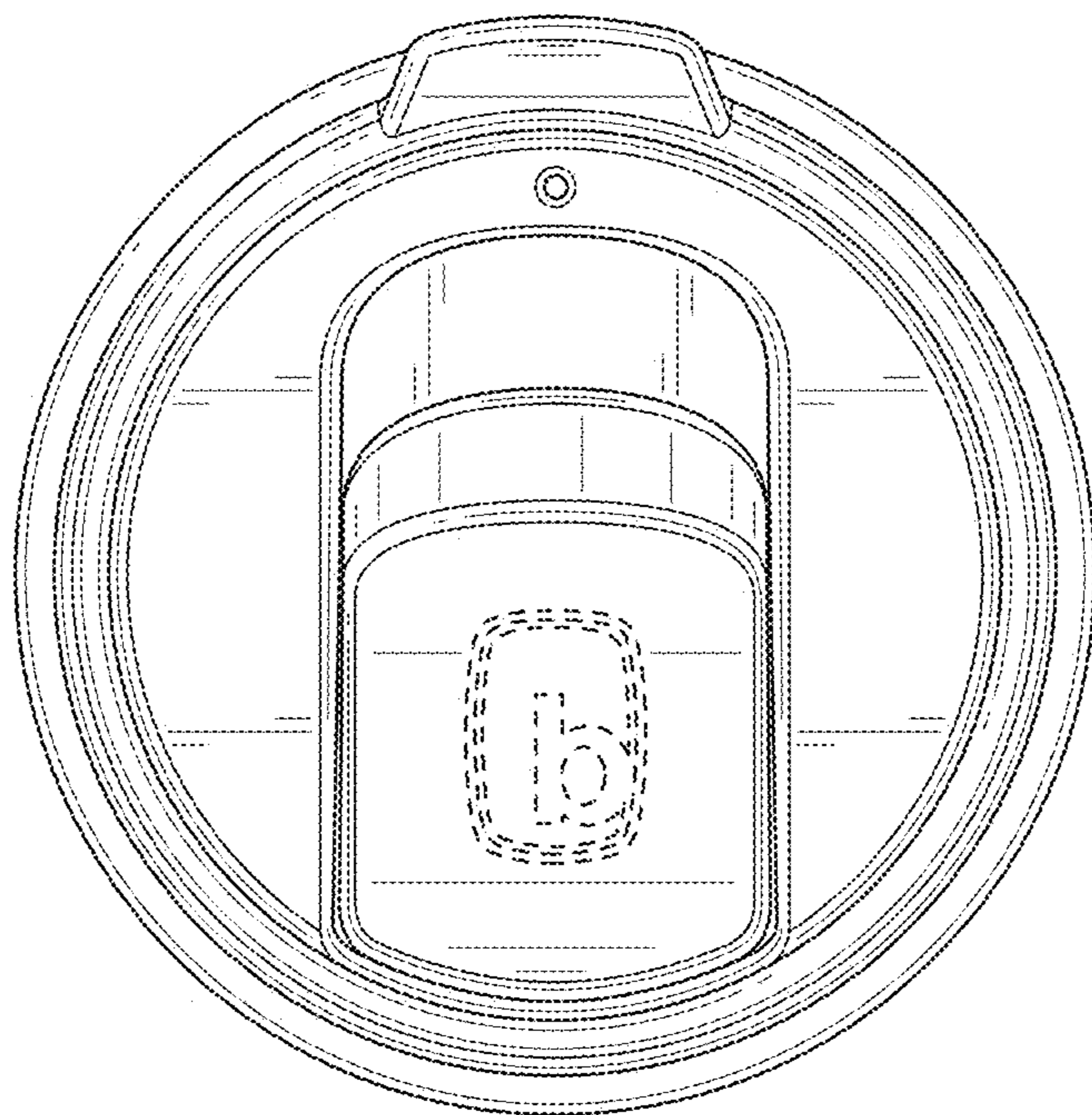

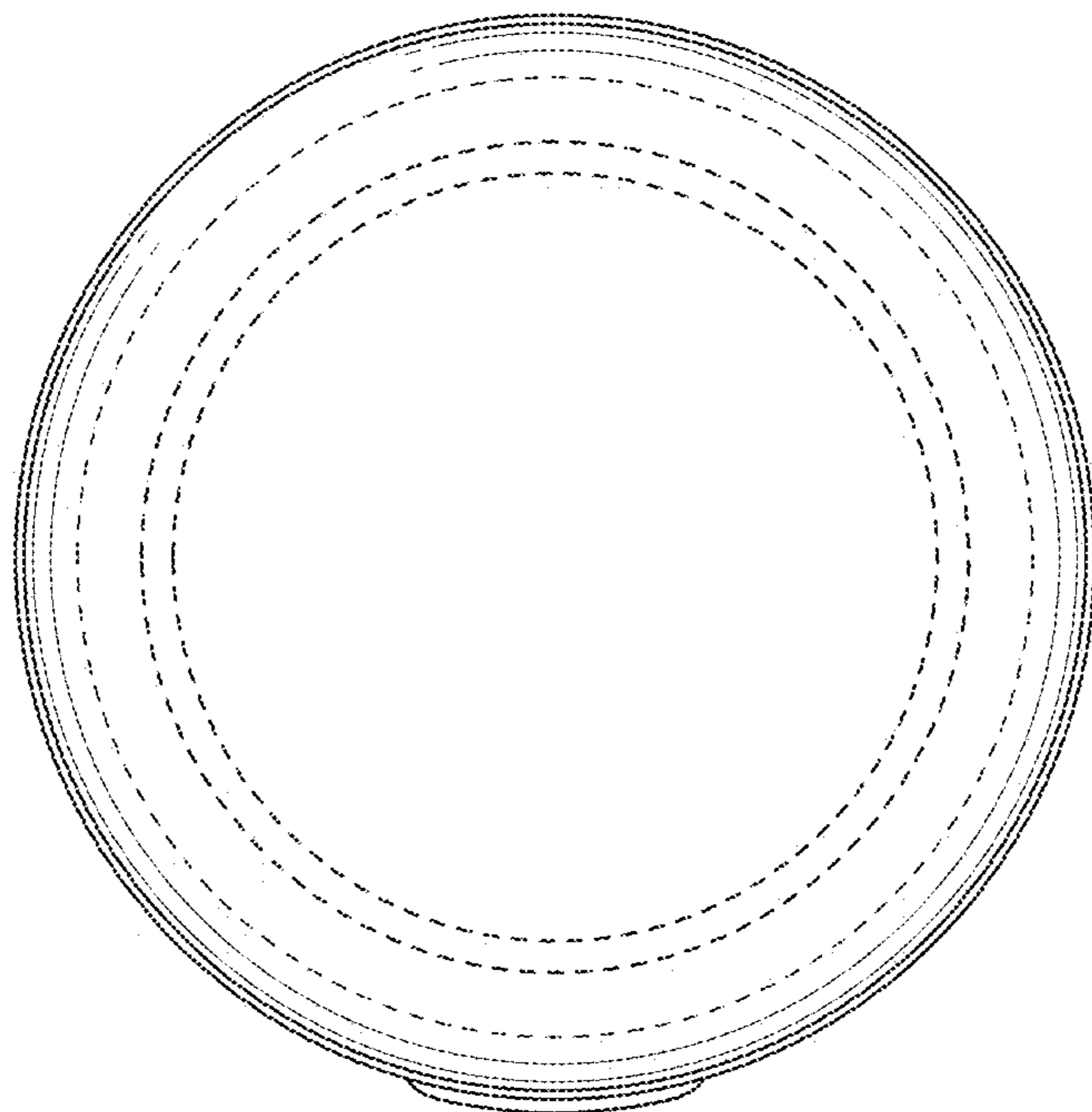

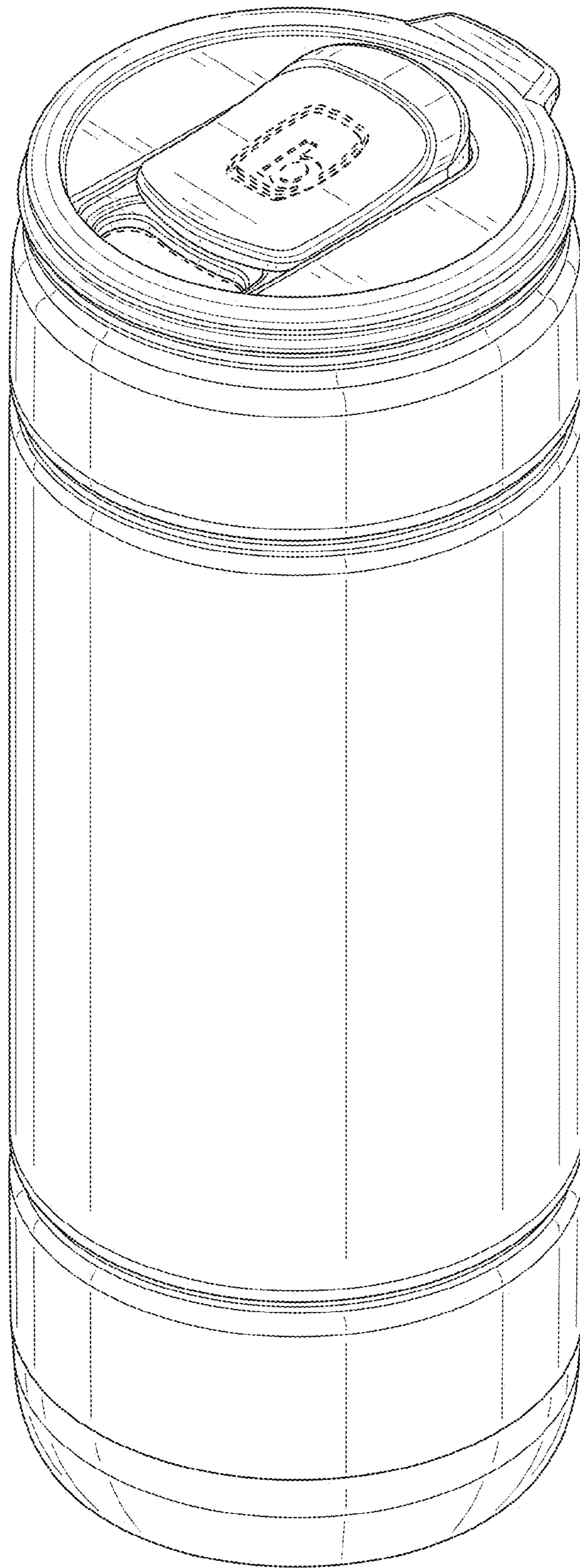

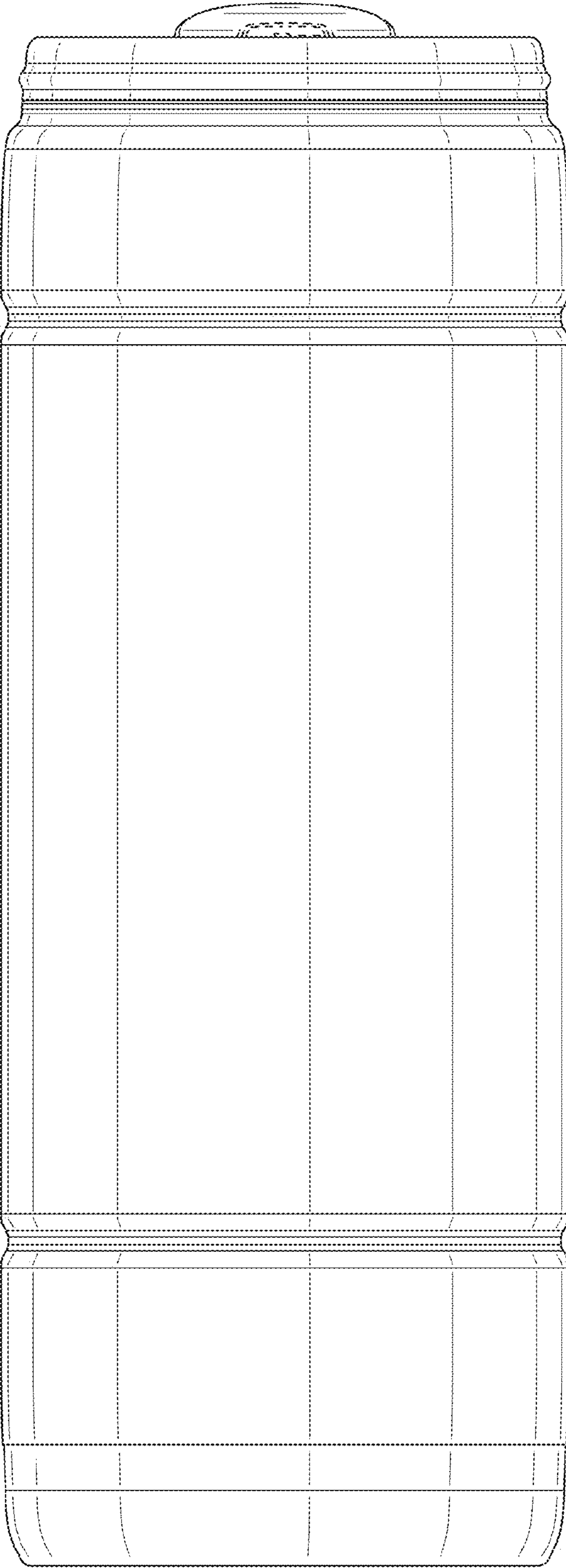

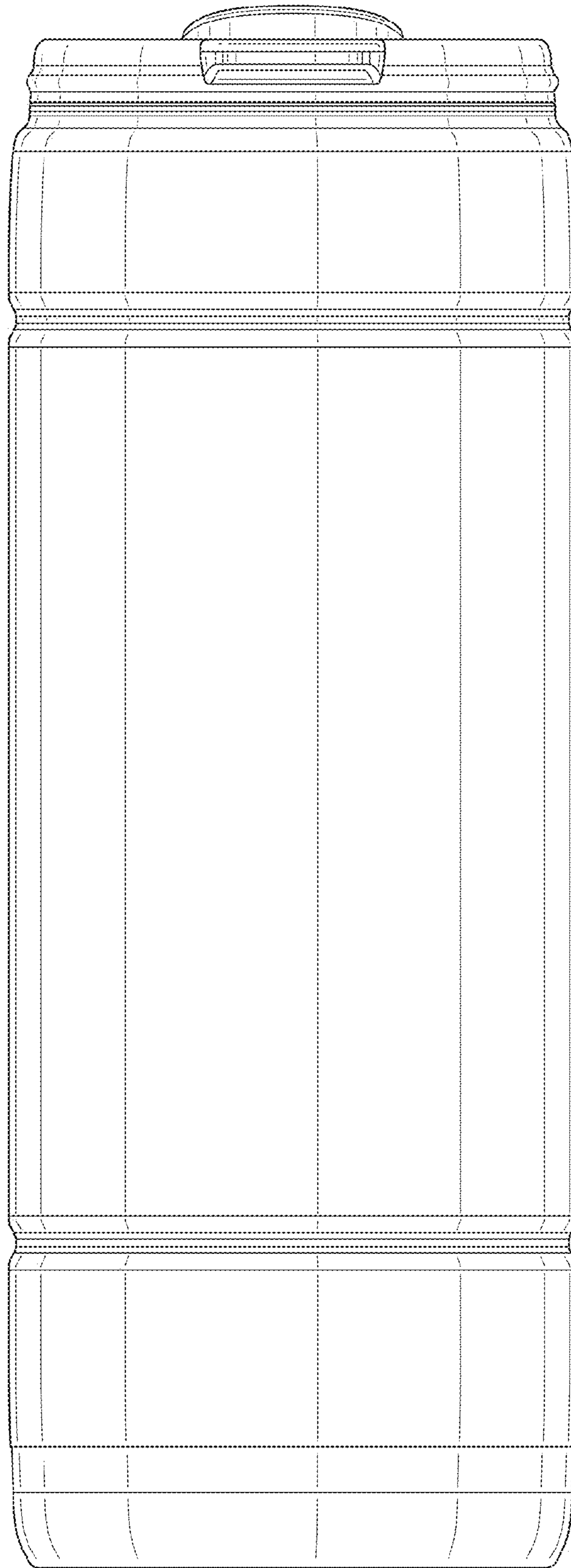

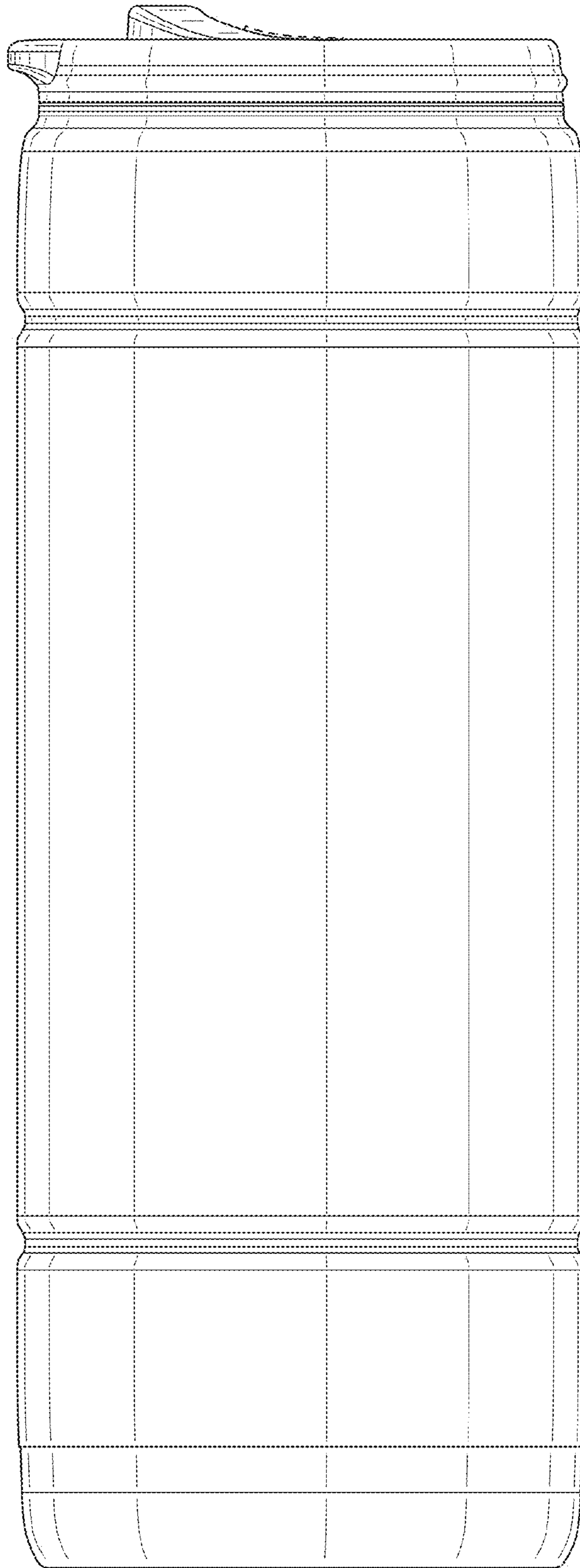

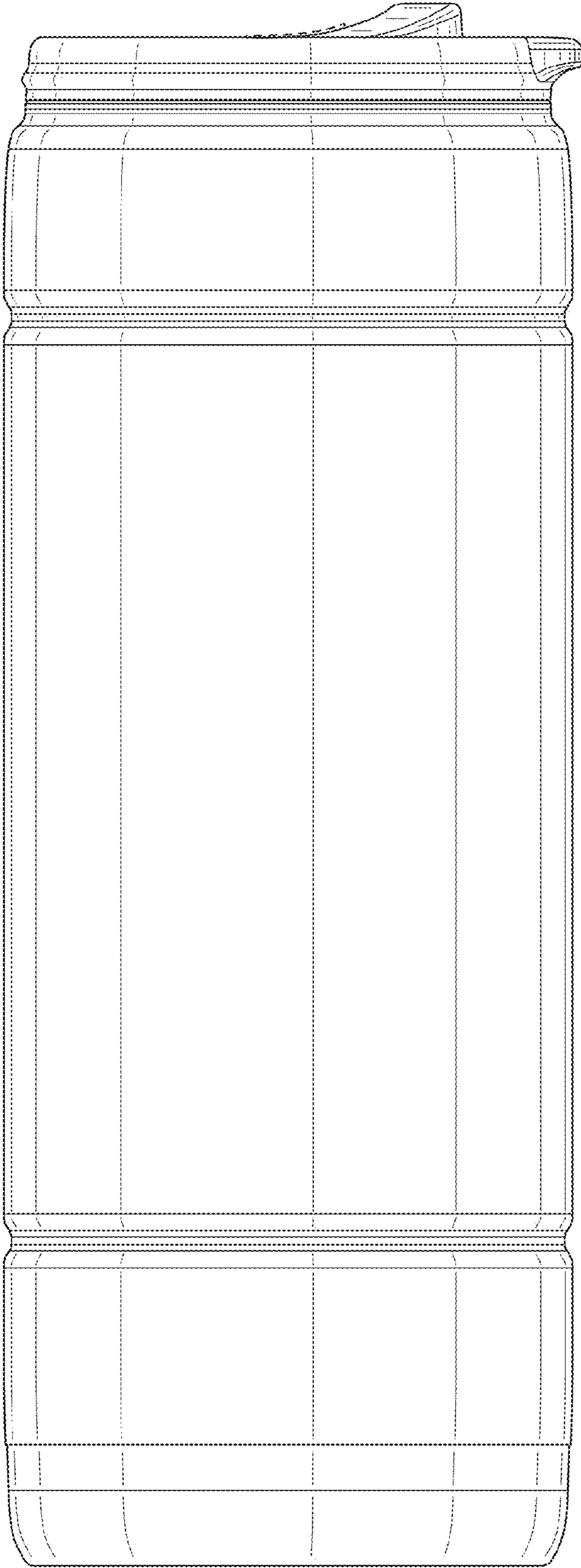

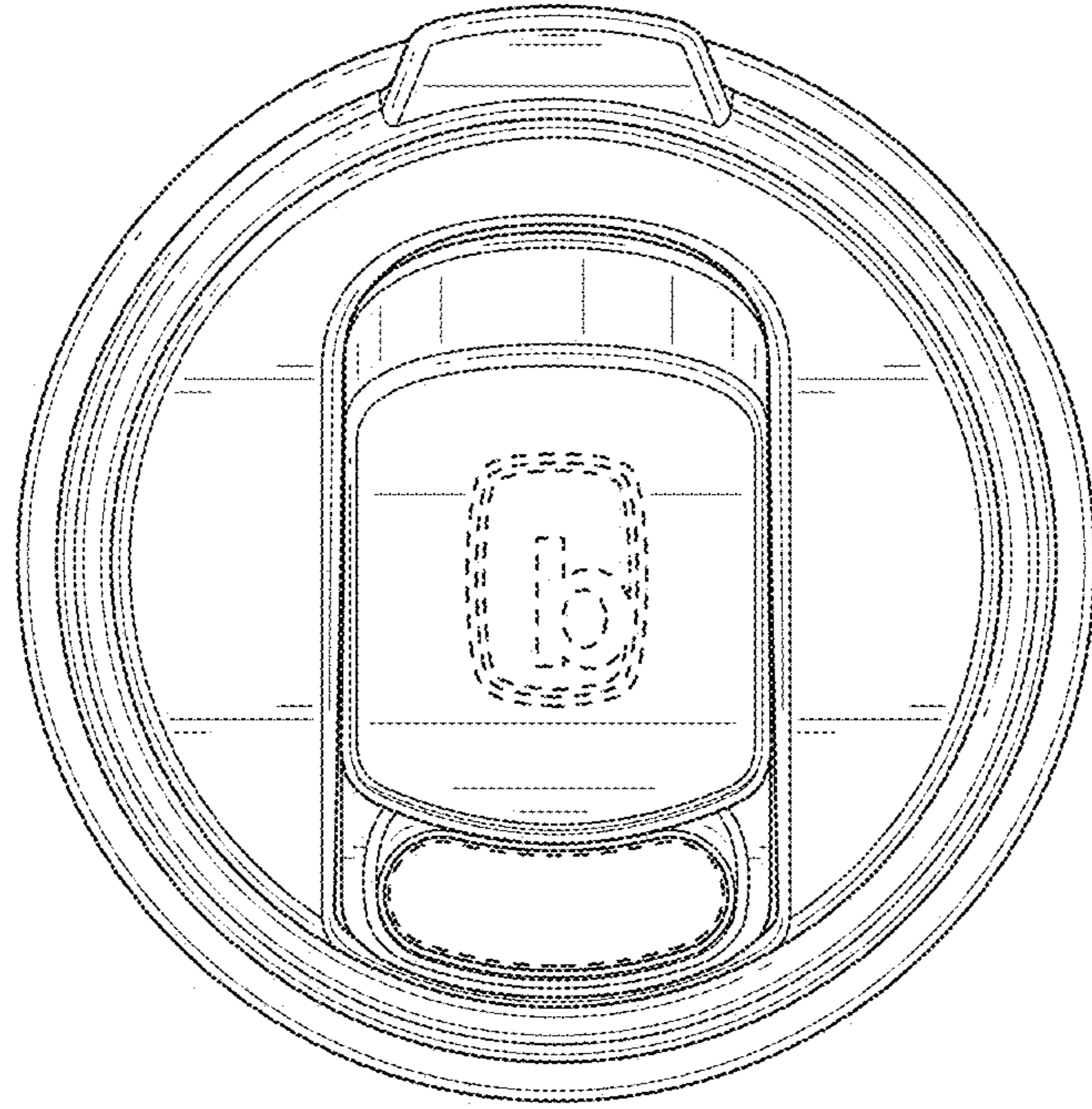

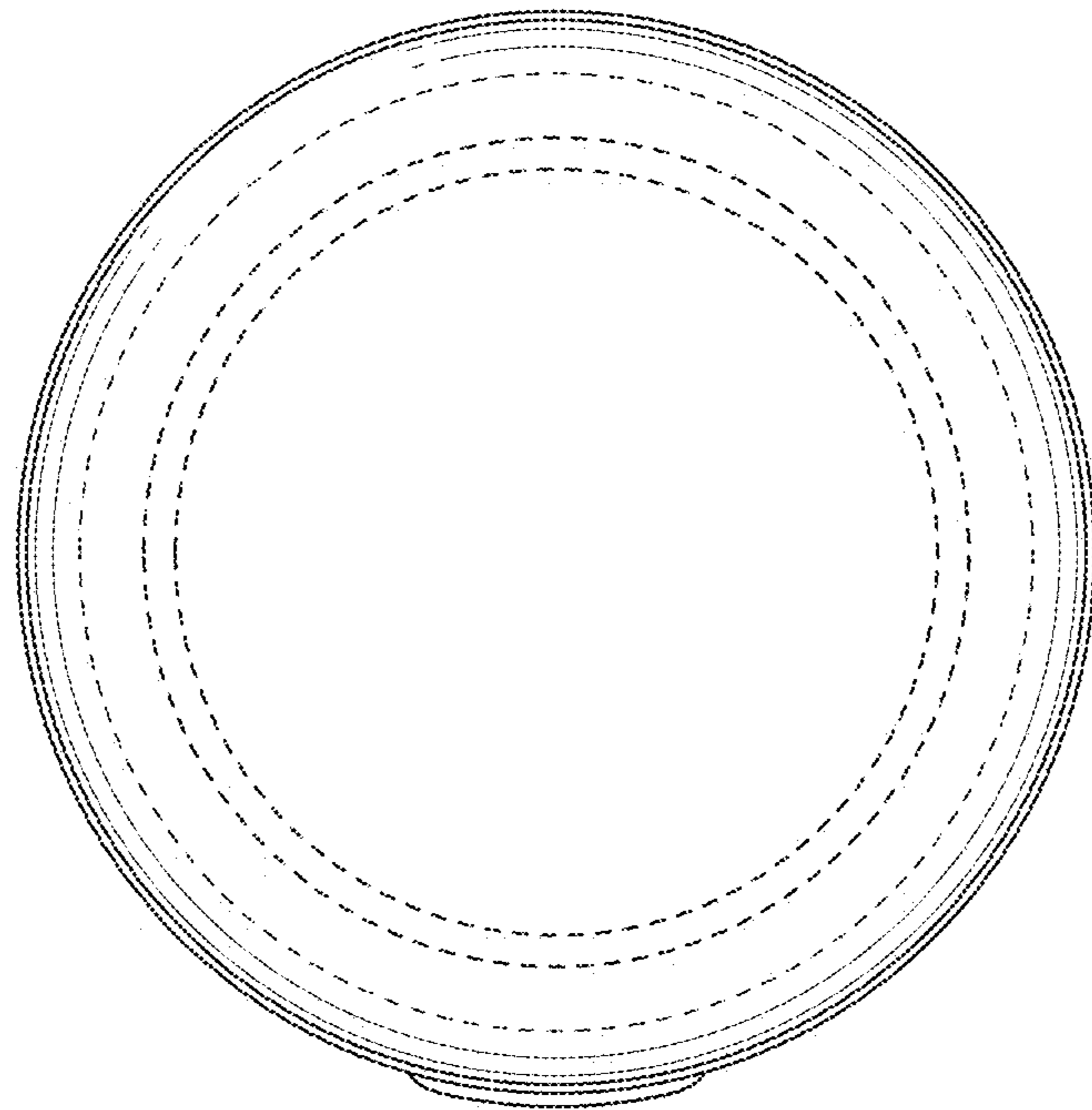
