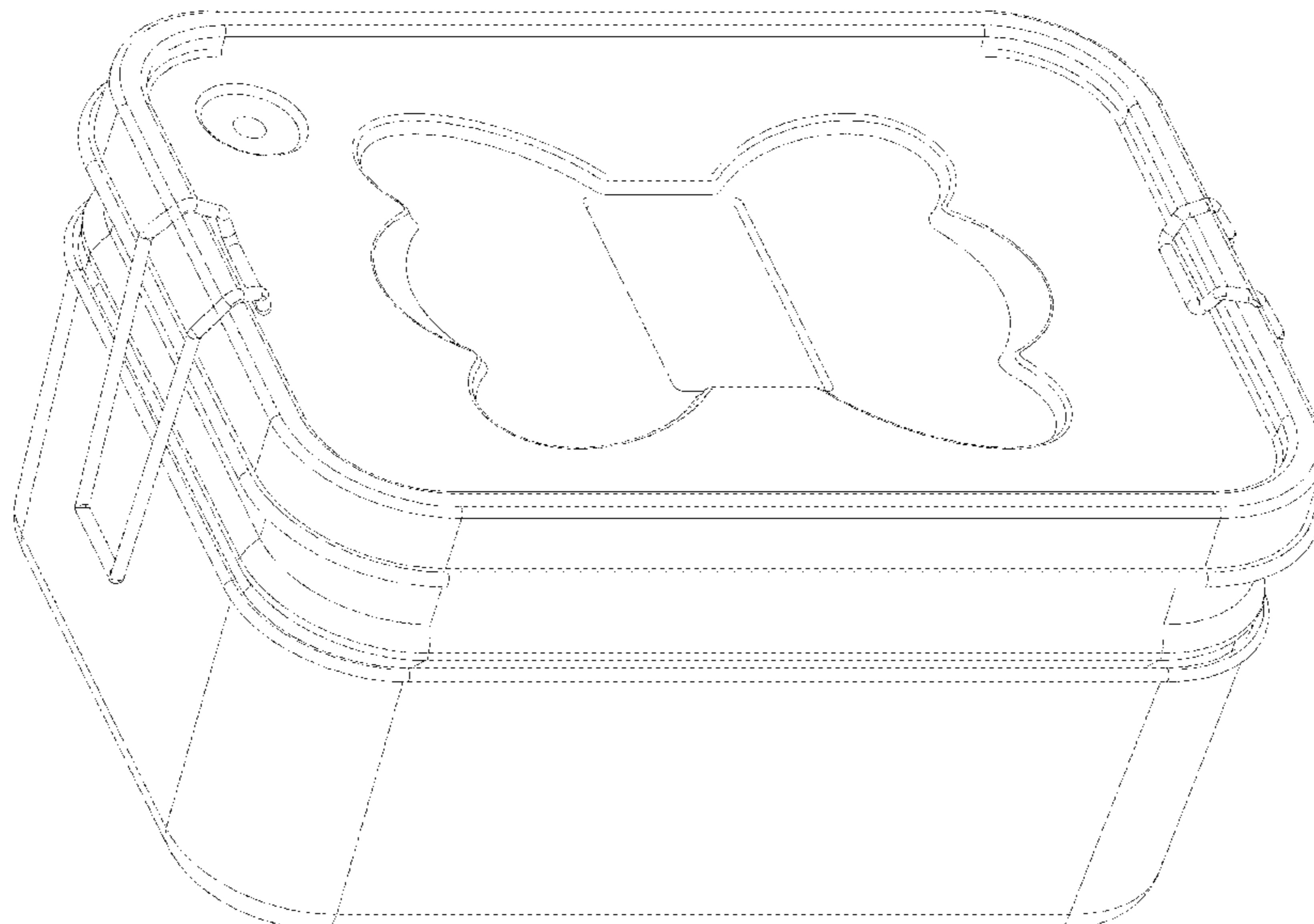

DESCRIPTION

FIG. 1 is a top, front, left side perspective view of a multifunction lunchbox showing my new design; FIG. 2 is a bottom, rear, right side perspective view thereof; FIG. 3 is a front elevation view thereof, the rear elevation view being a mirror image of the front elevation view; FIG. 4 is an enlarged left side elevation view thereof, the right side elevation view being a mirror image of the enlarged left side elevation view; FIG. 5 is a top plan view thereof; and, FIG. 6 is a bottom plan view thereof.

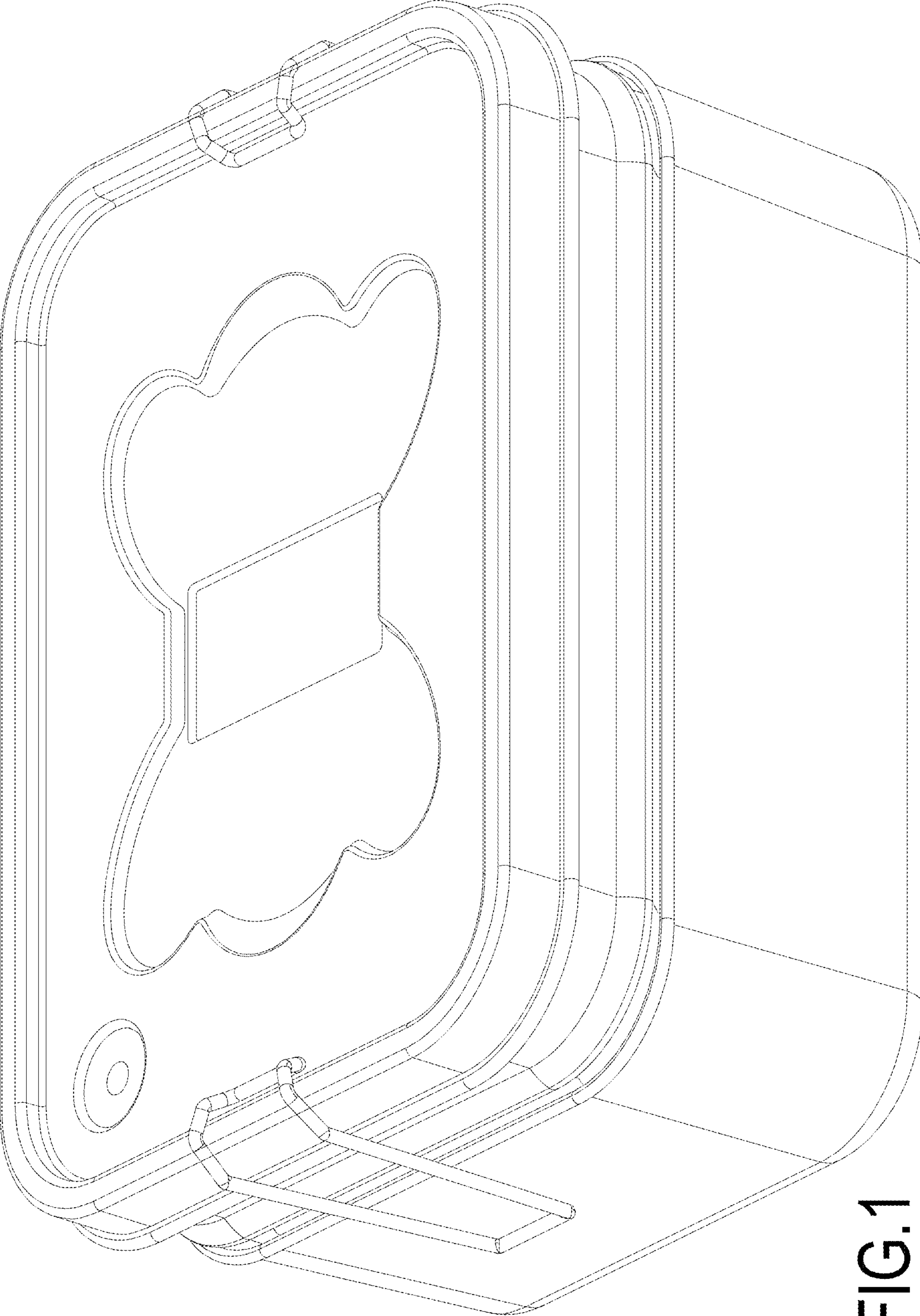

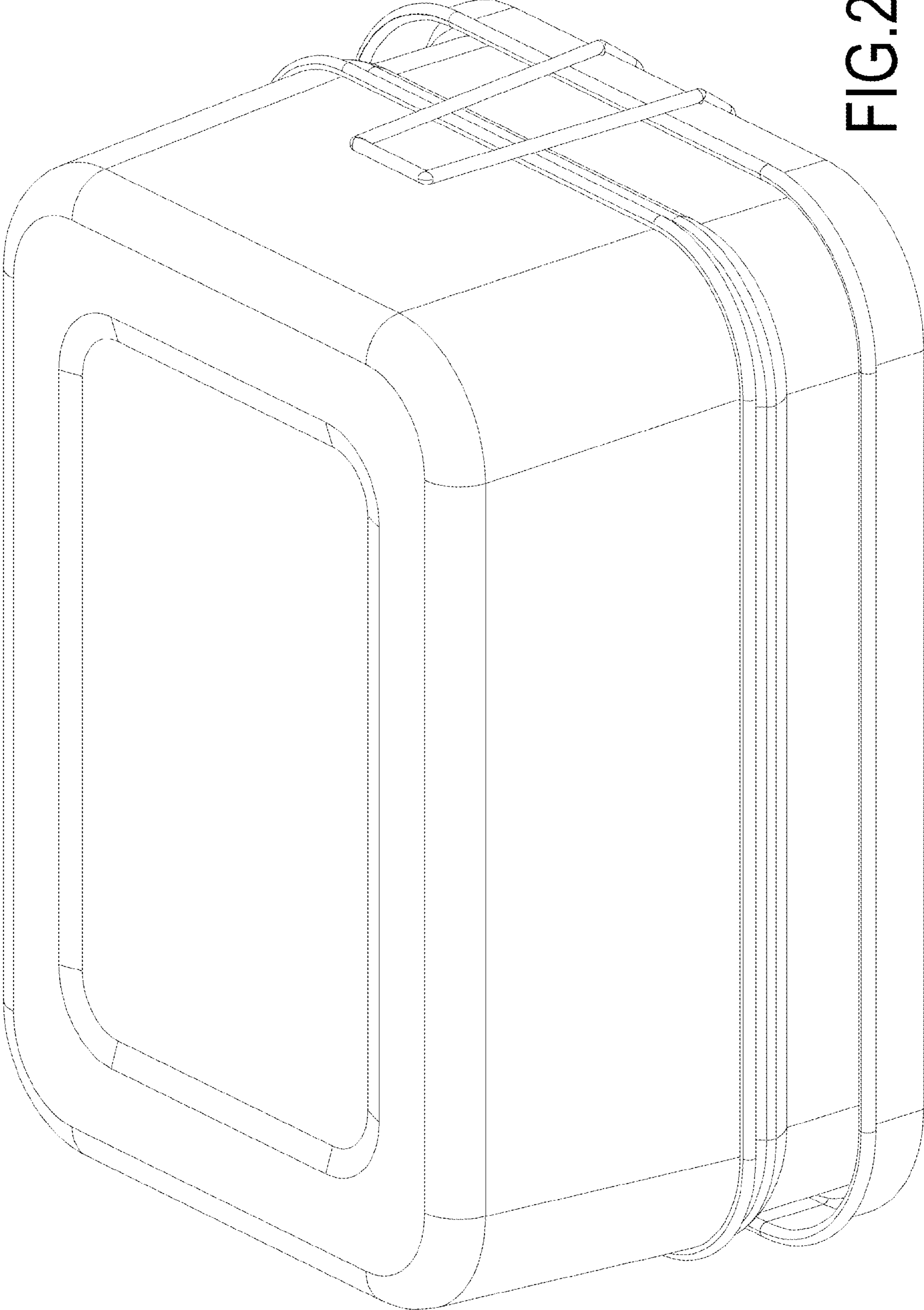

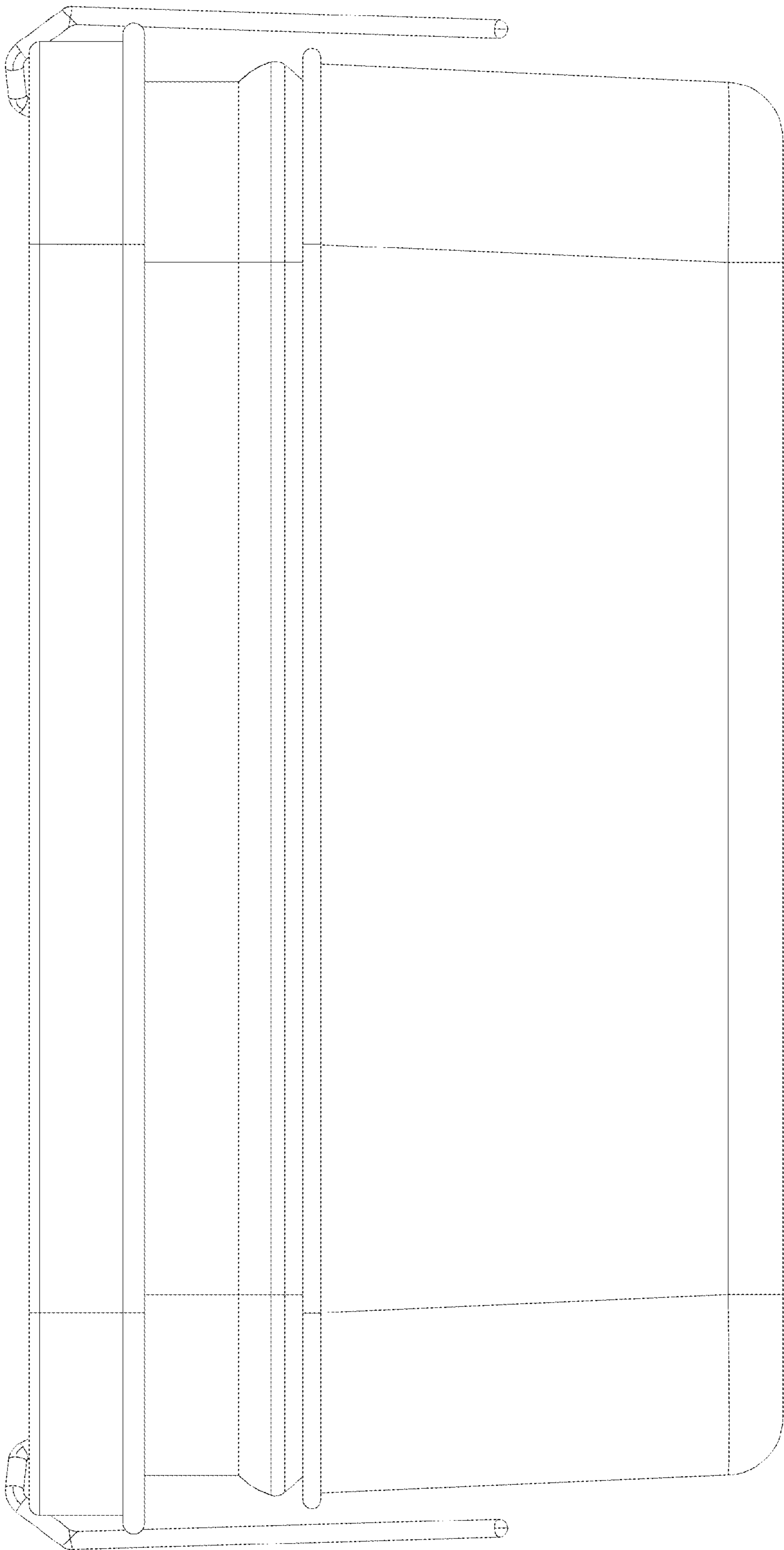

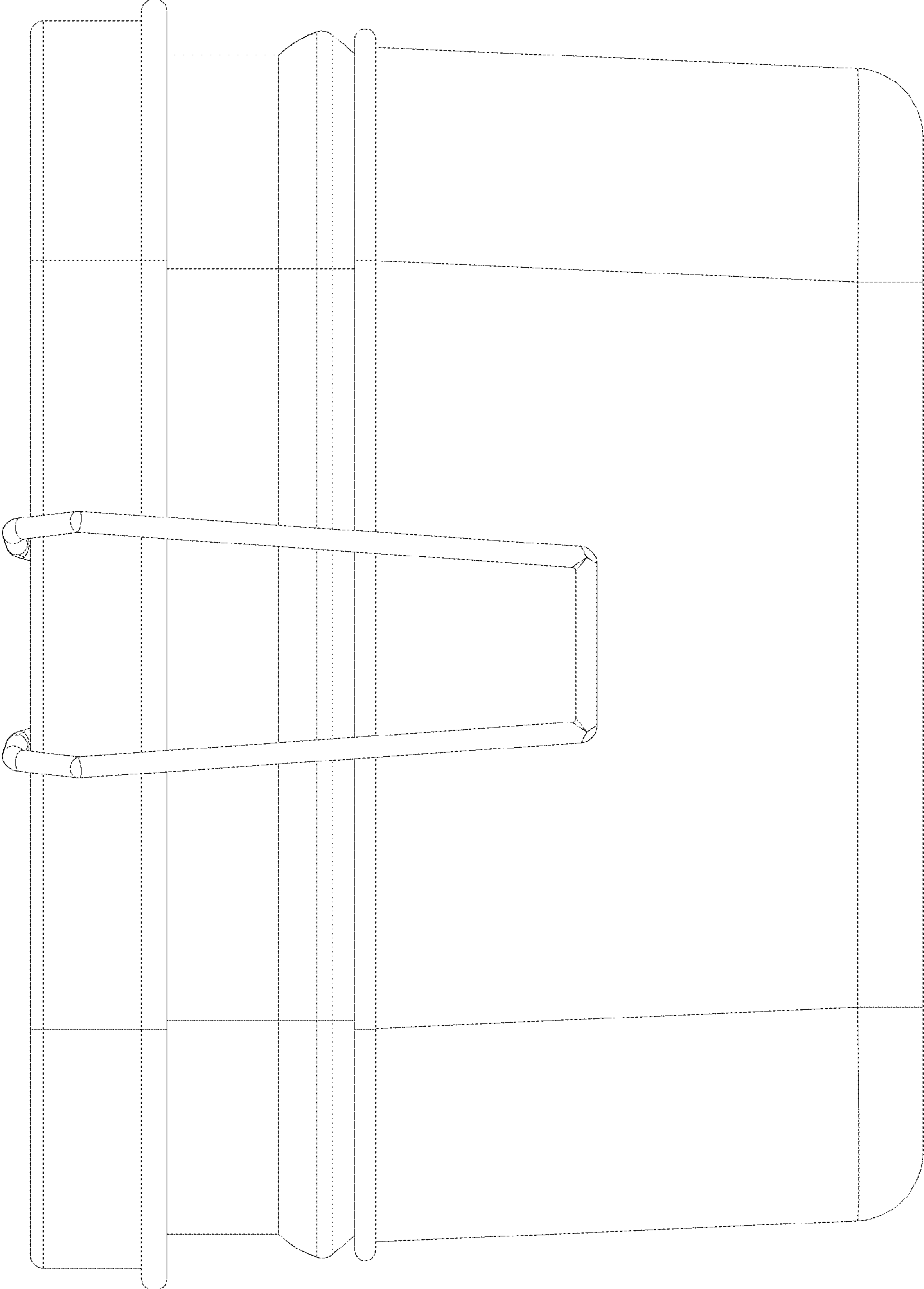

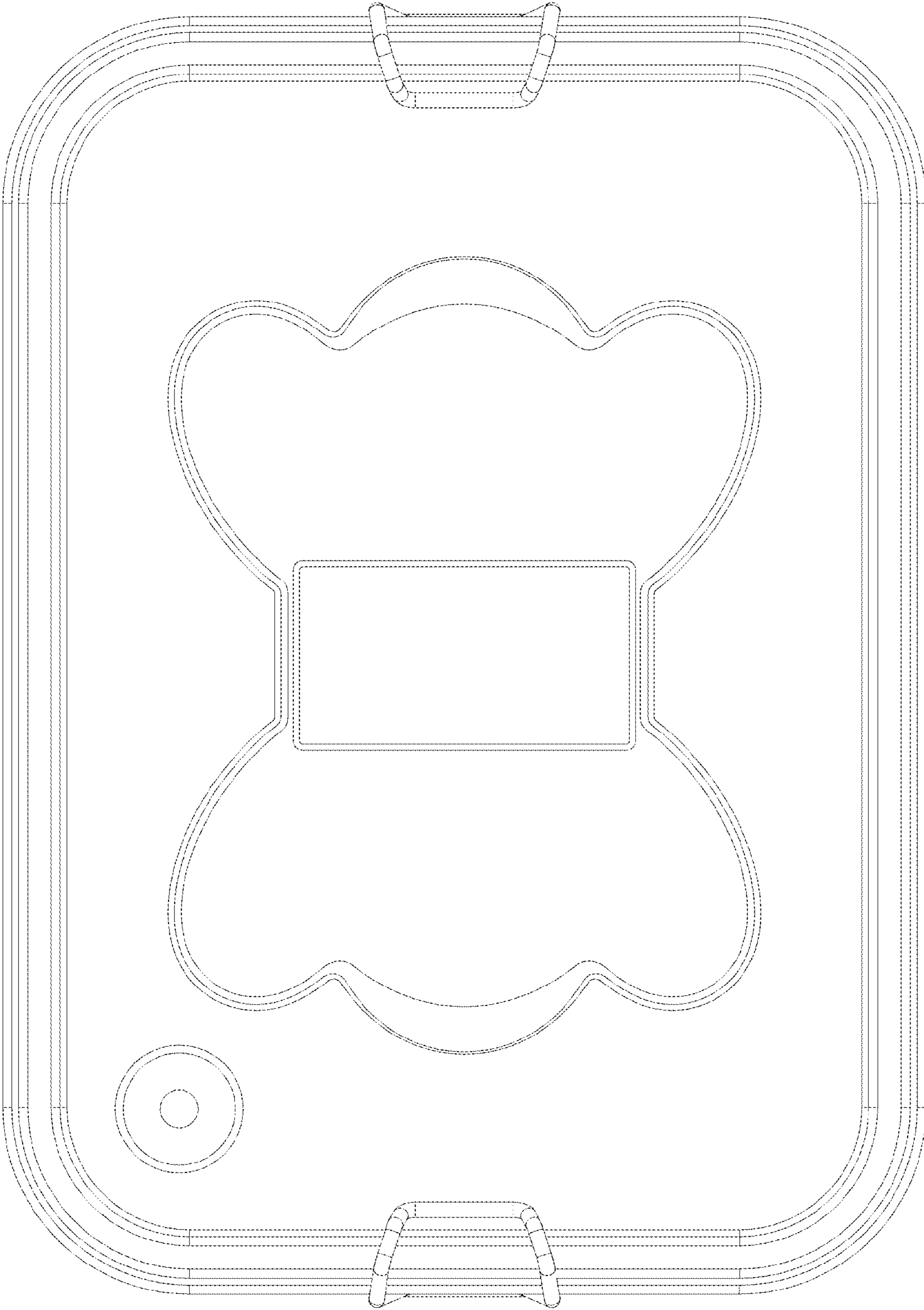

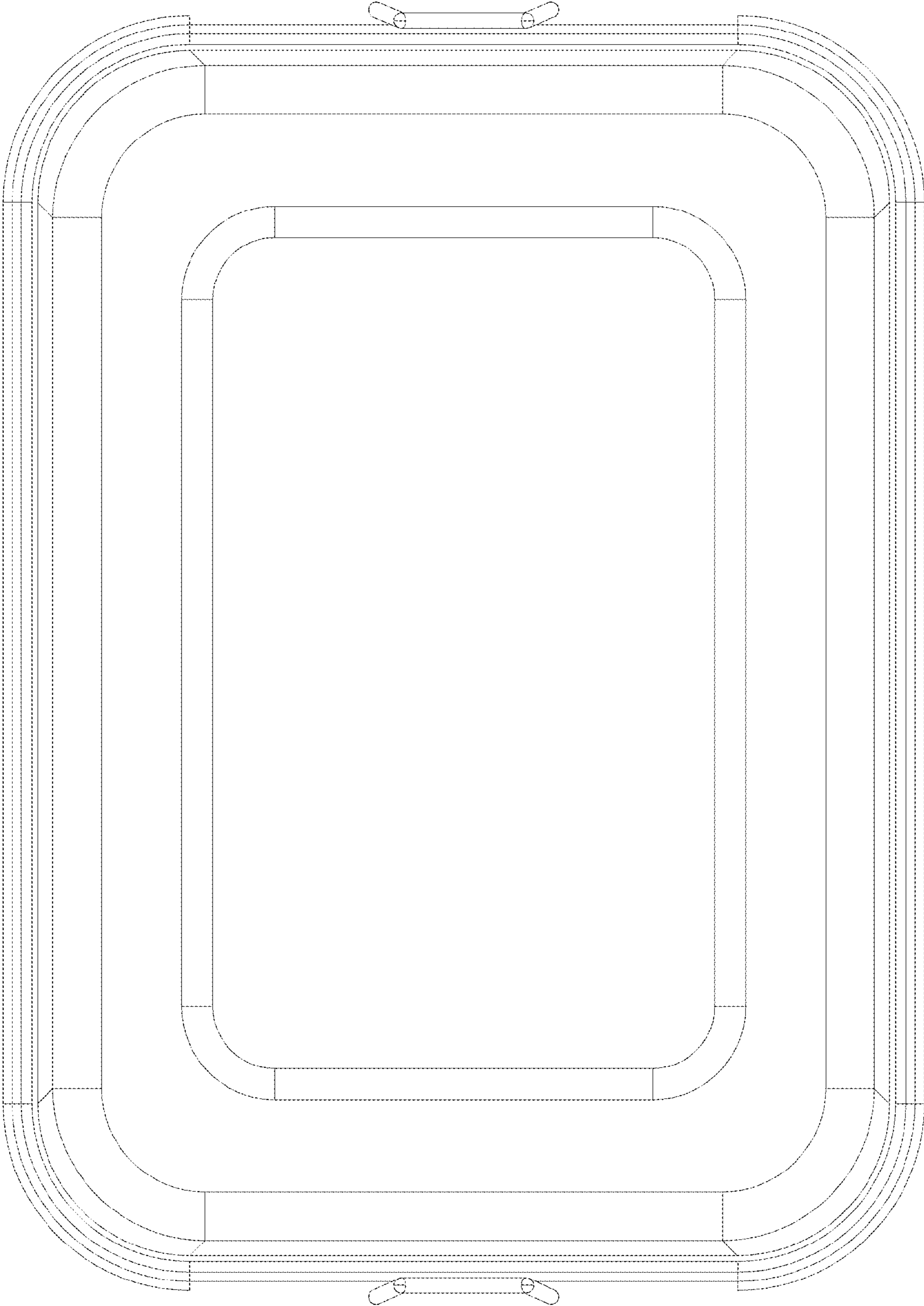
