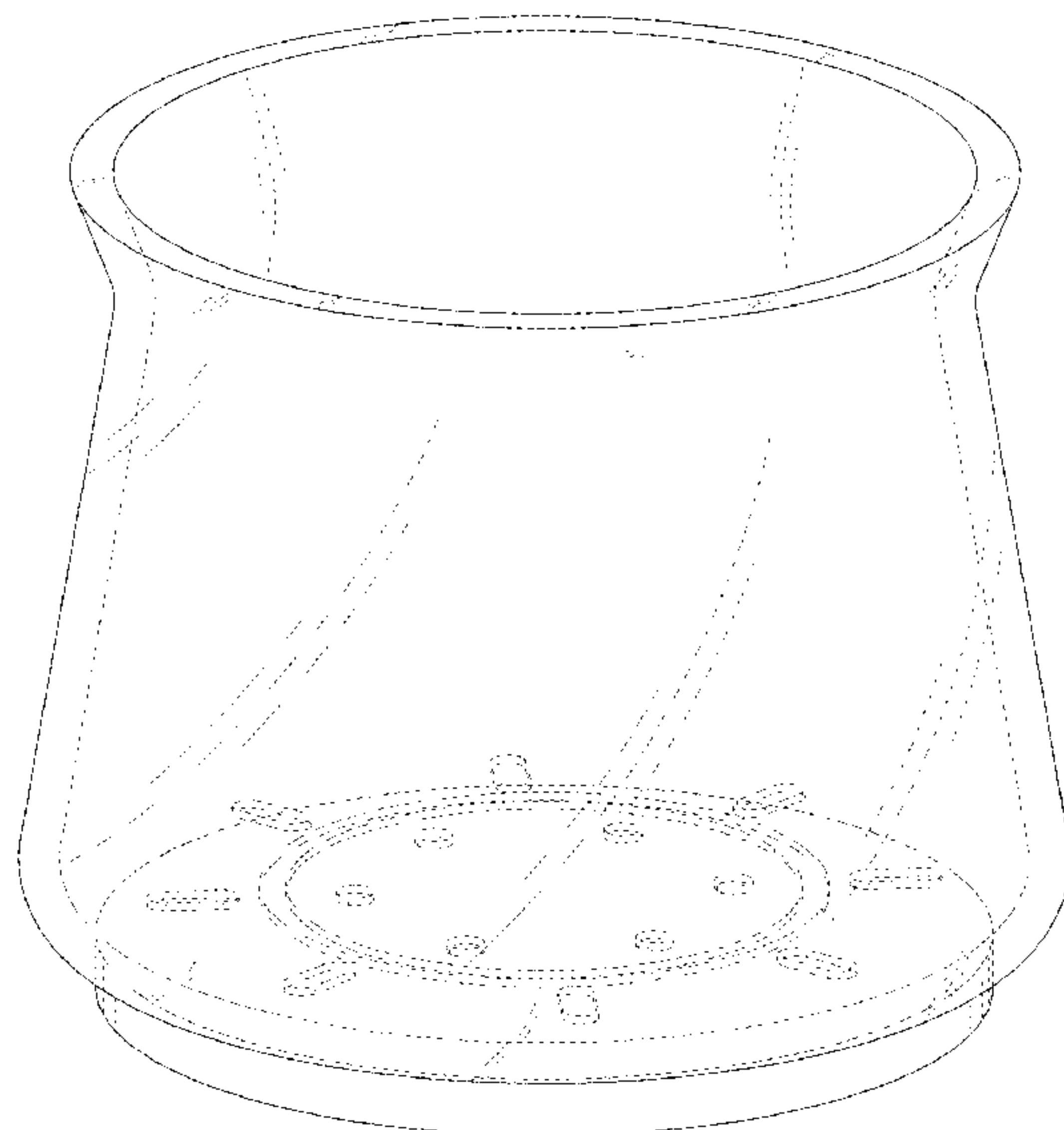

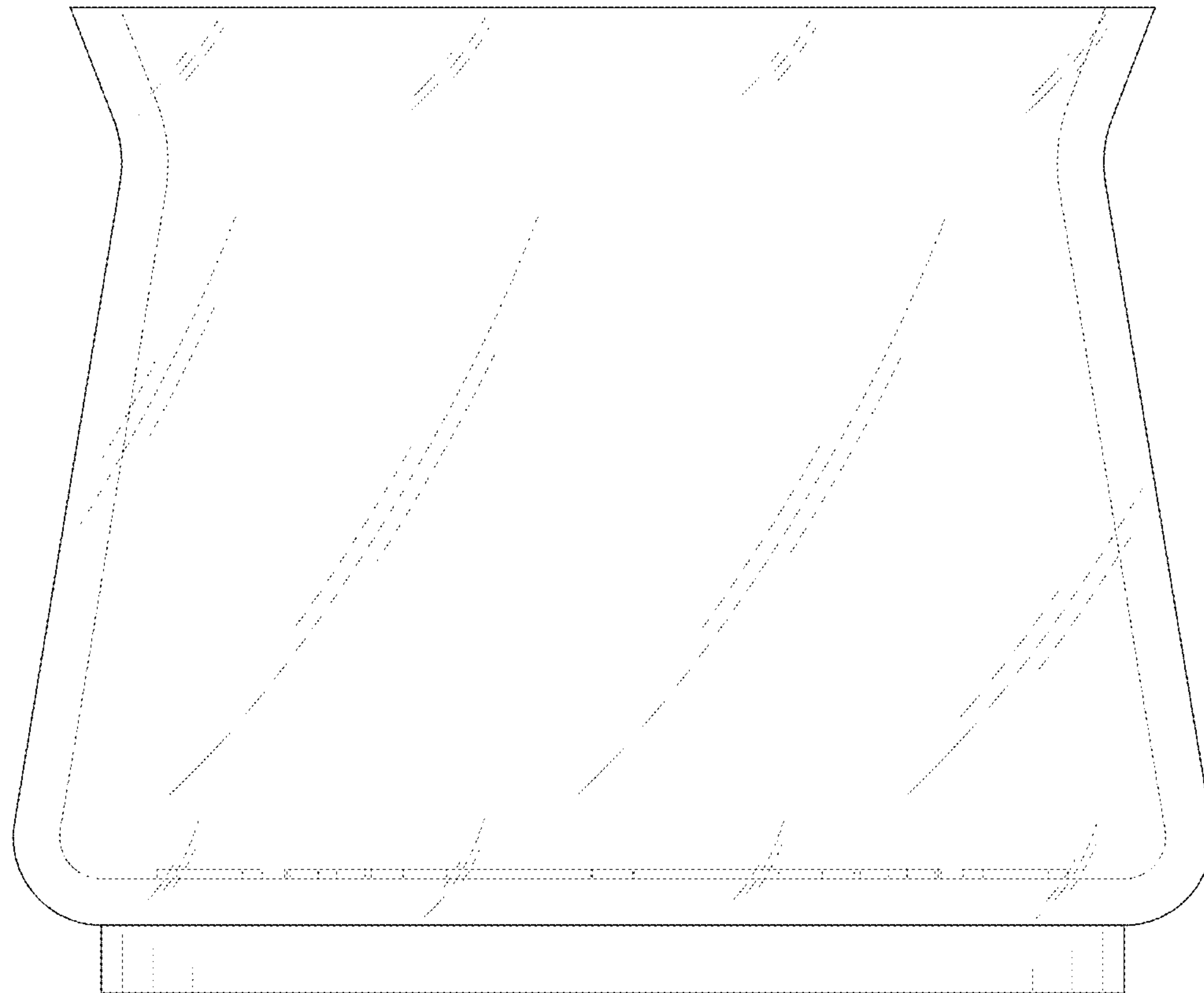
The ornamental design for a chair leg cover, as shown and described.

**DESCRIPTION**

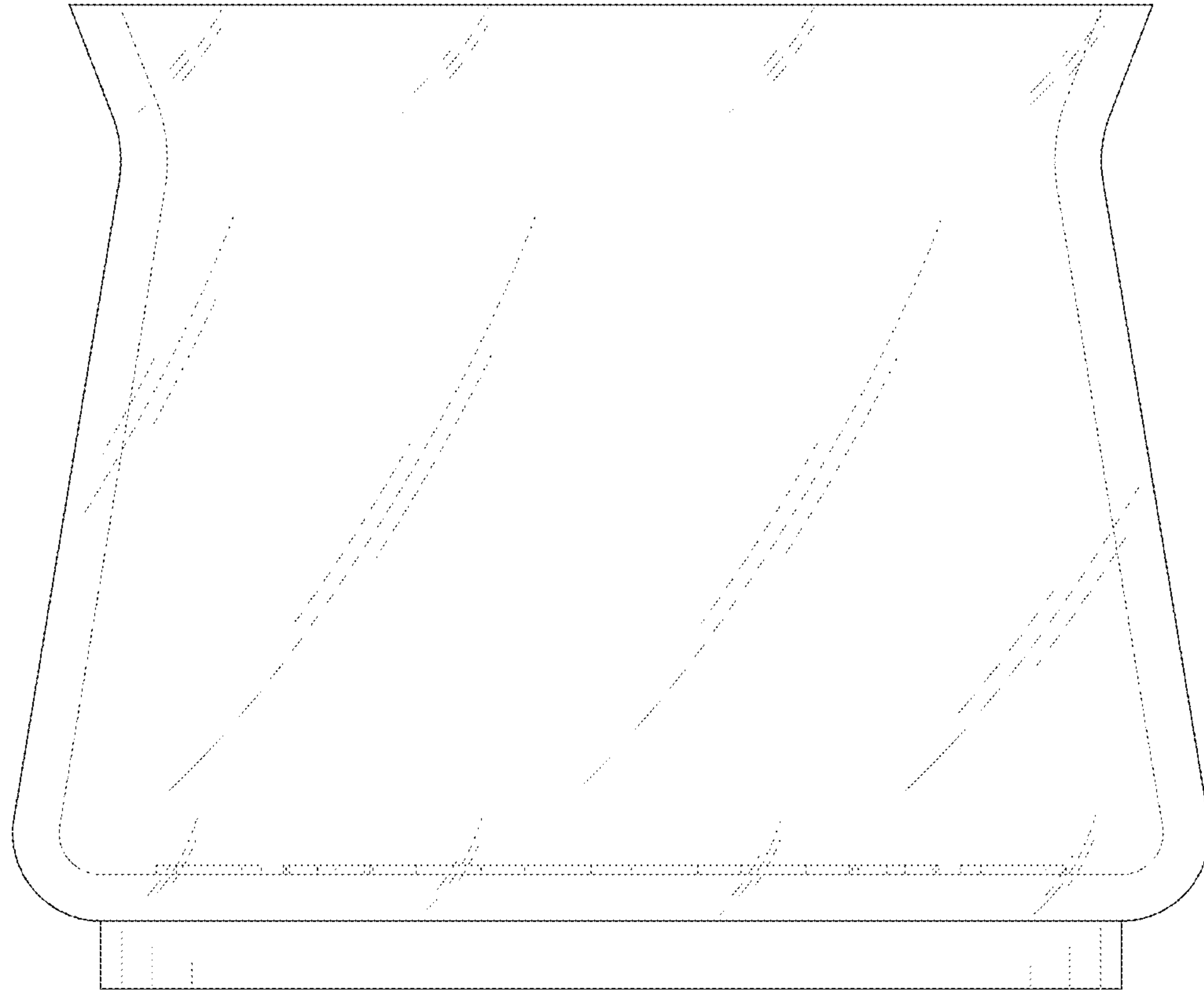
FIG. 1 is a front elevational view of a chair leg cover showing my new design;

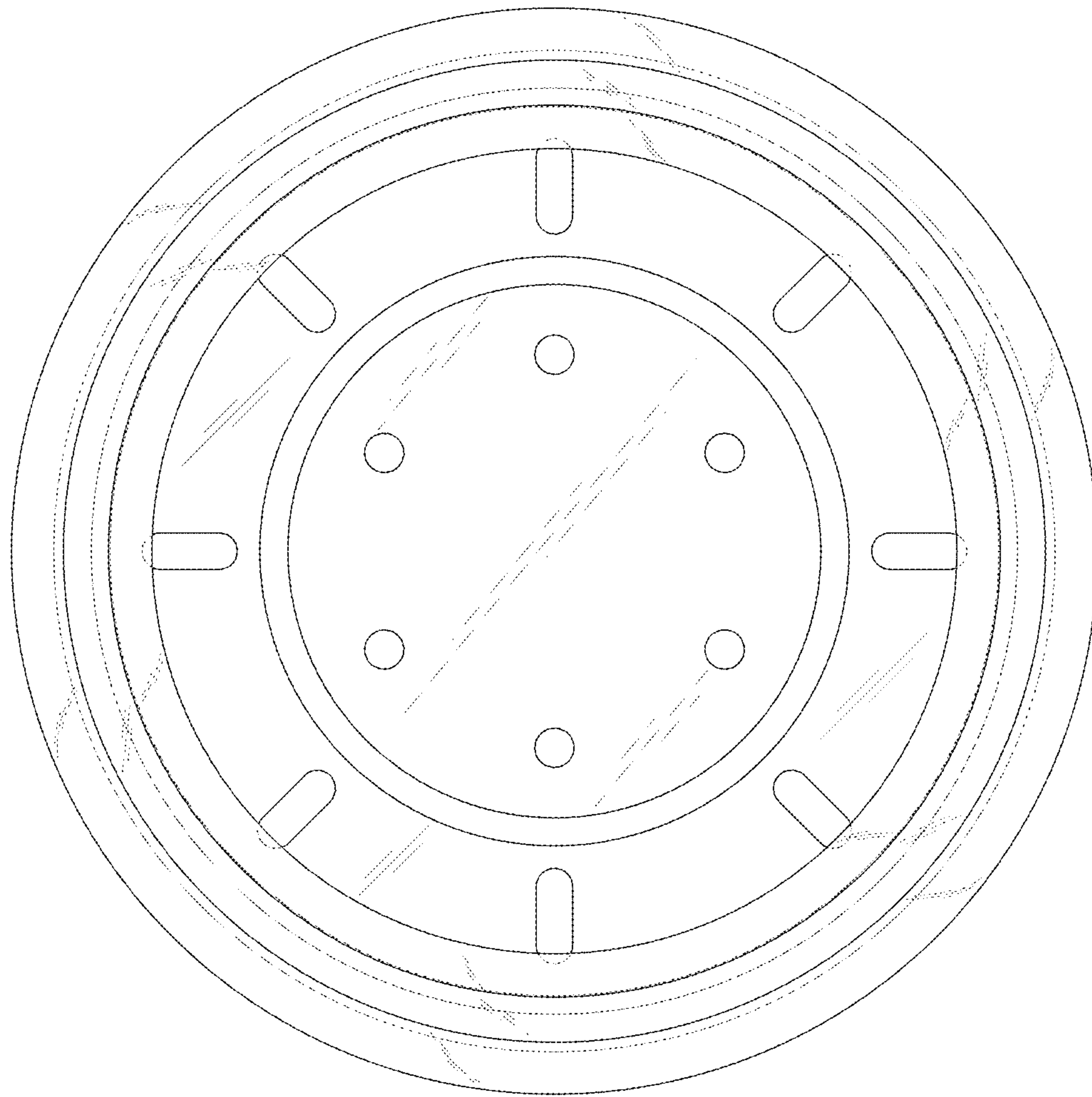




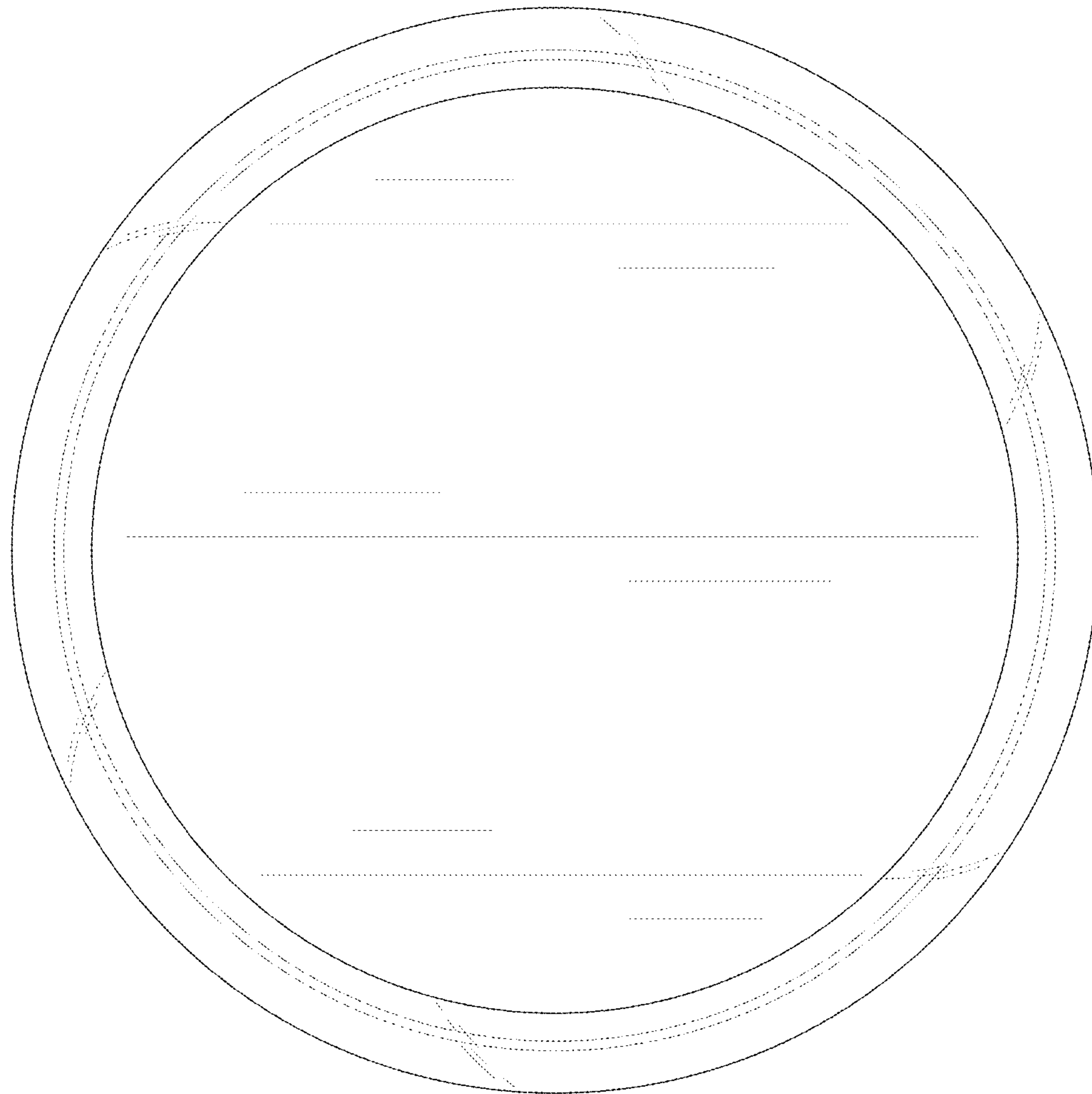

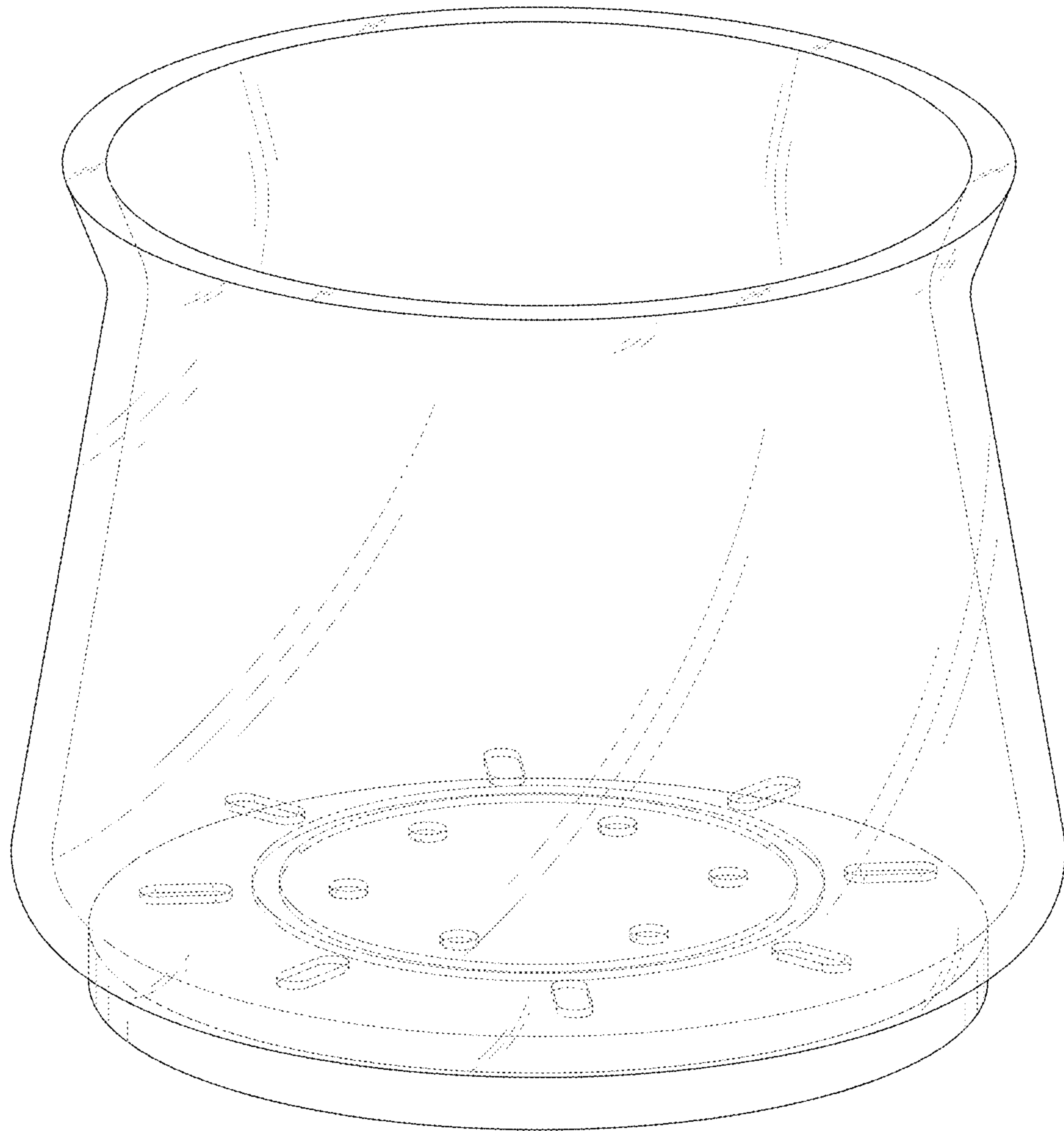
