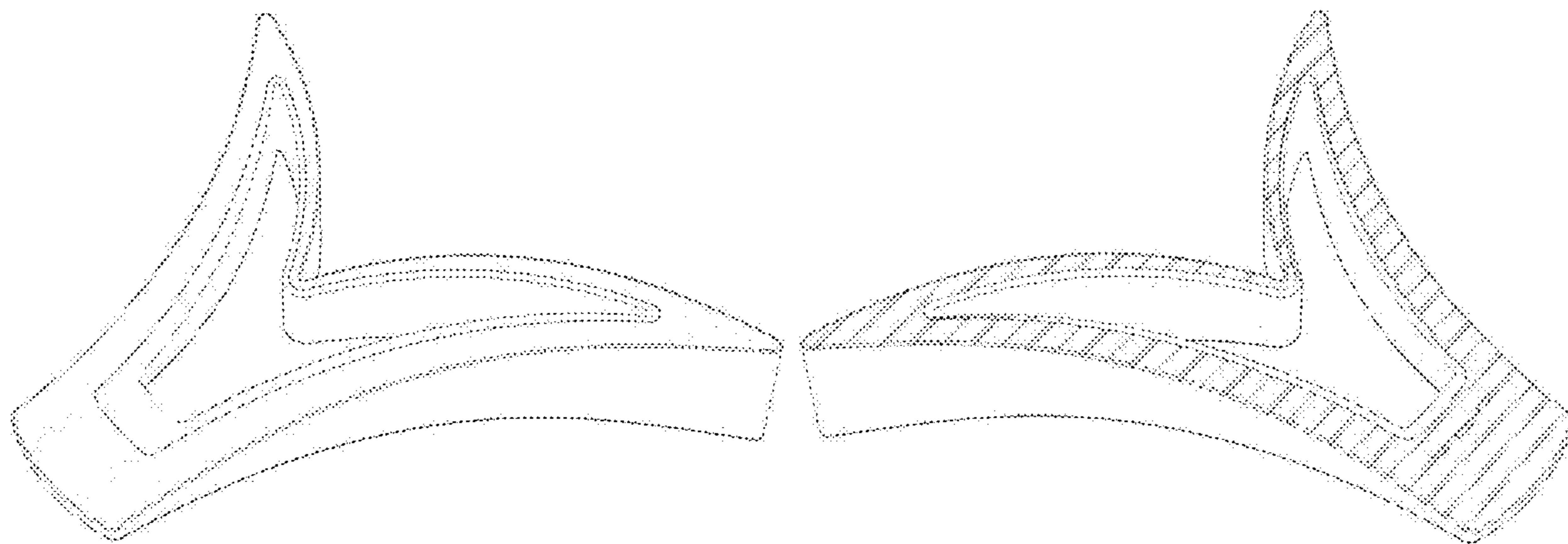
The ornamental design for a door and window stopper, as shown and described.

DESCRIPTION

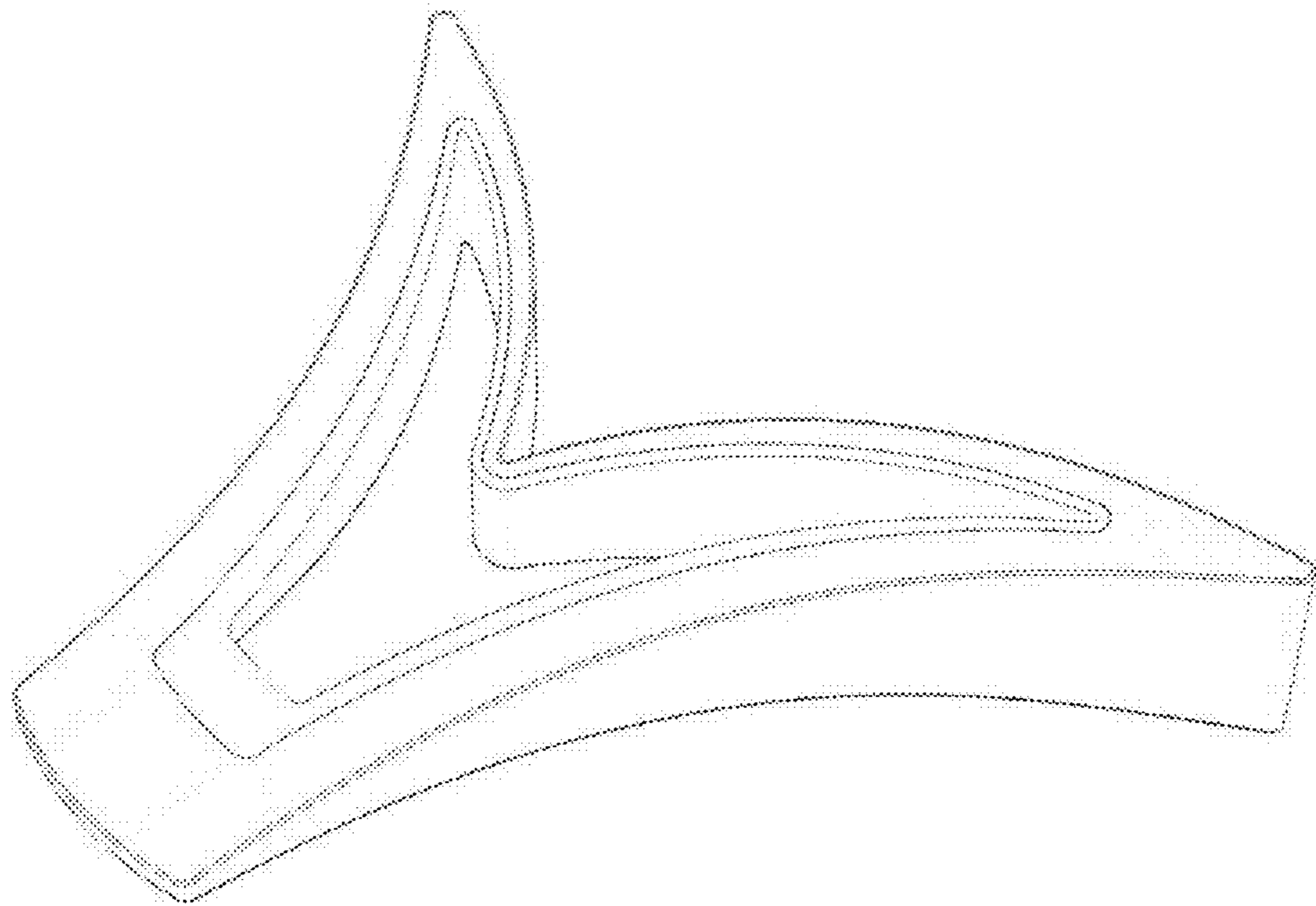
- 1. Door and window stopper
- 1.1 : Top perspective
- 1.2 : Bottom perspective
- 1.3 : Top
- 1.4 : Bottom
- 1.5 : Front
- 1.6 : Back

The design concerns the visual features of a door and window stopper as shown in the enclosed drawings, in which: fig. 1.1 is a top perspective view (right side of the view) of the design; fig. 1.2 is a bottom perspective view (left side of the view) of the design; fig. 1.3 is a top elevational view of the design; fig. 1.4 is a bottom elevational view of the design; fig. 1.5 is a front plan view of the design, and; fig. 1.6 is a back plan view of the design.

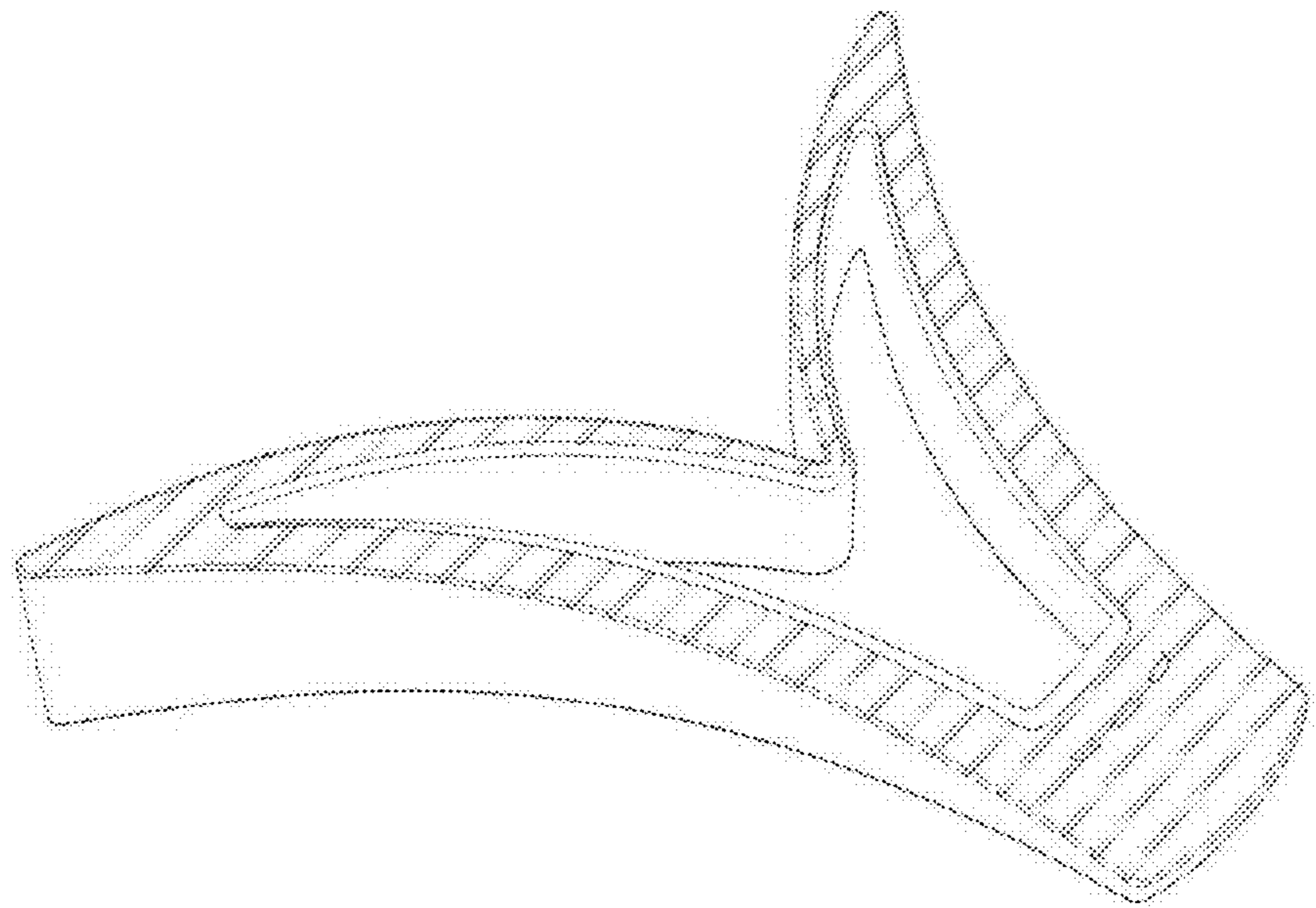

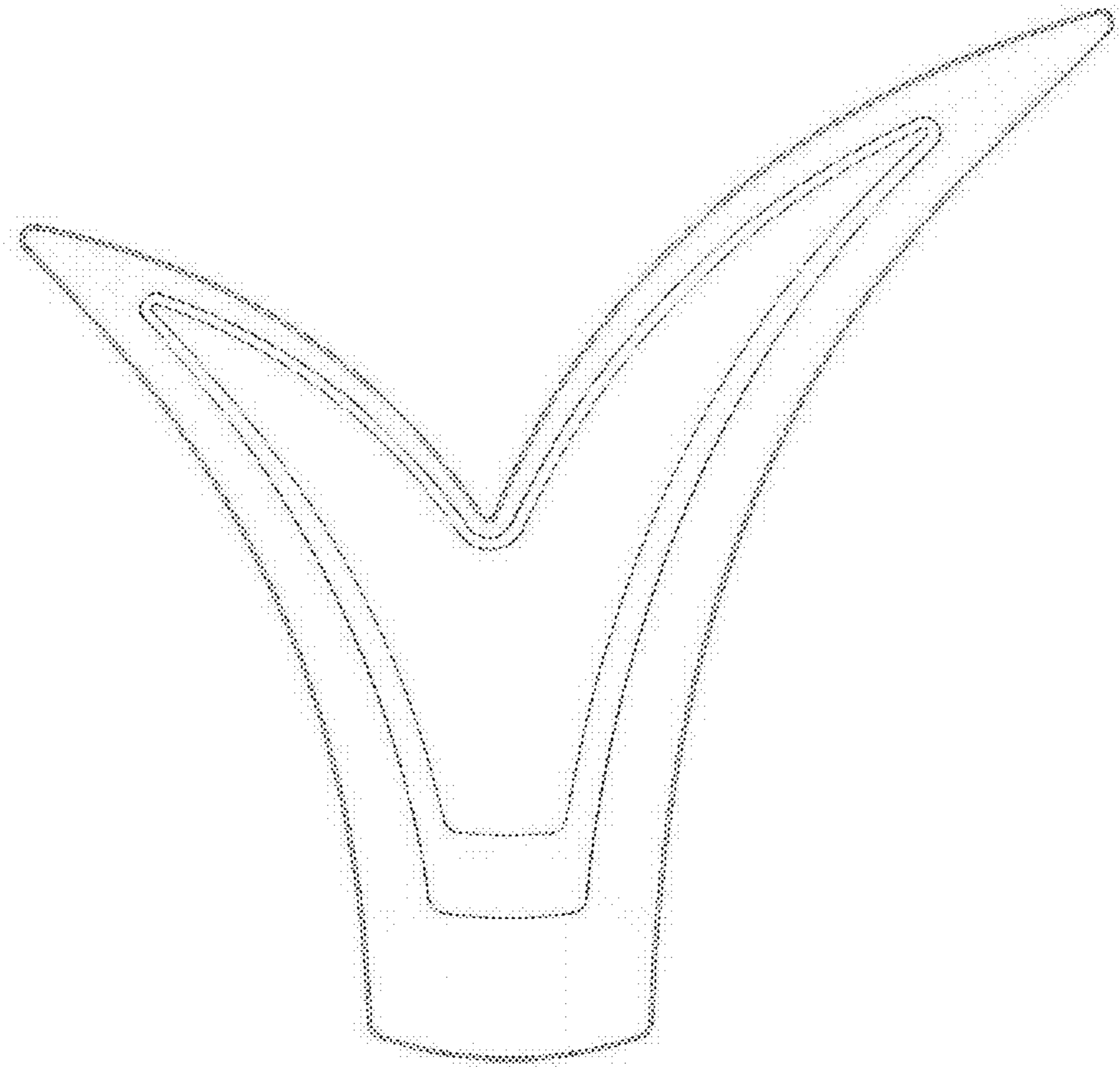

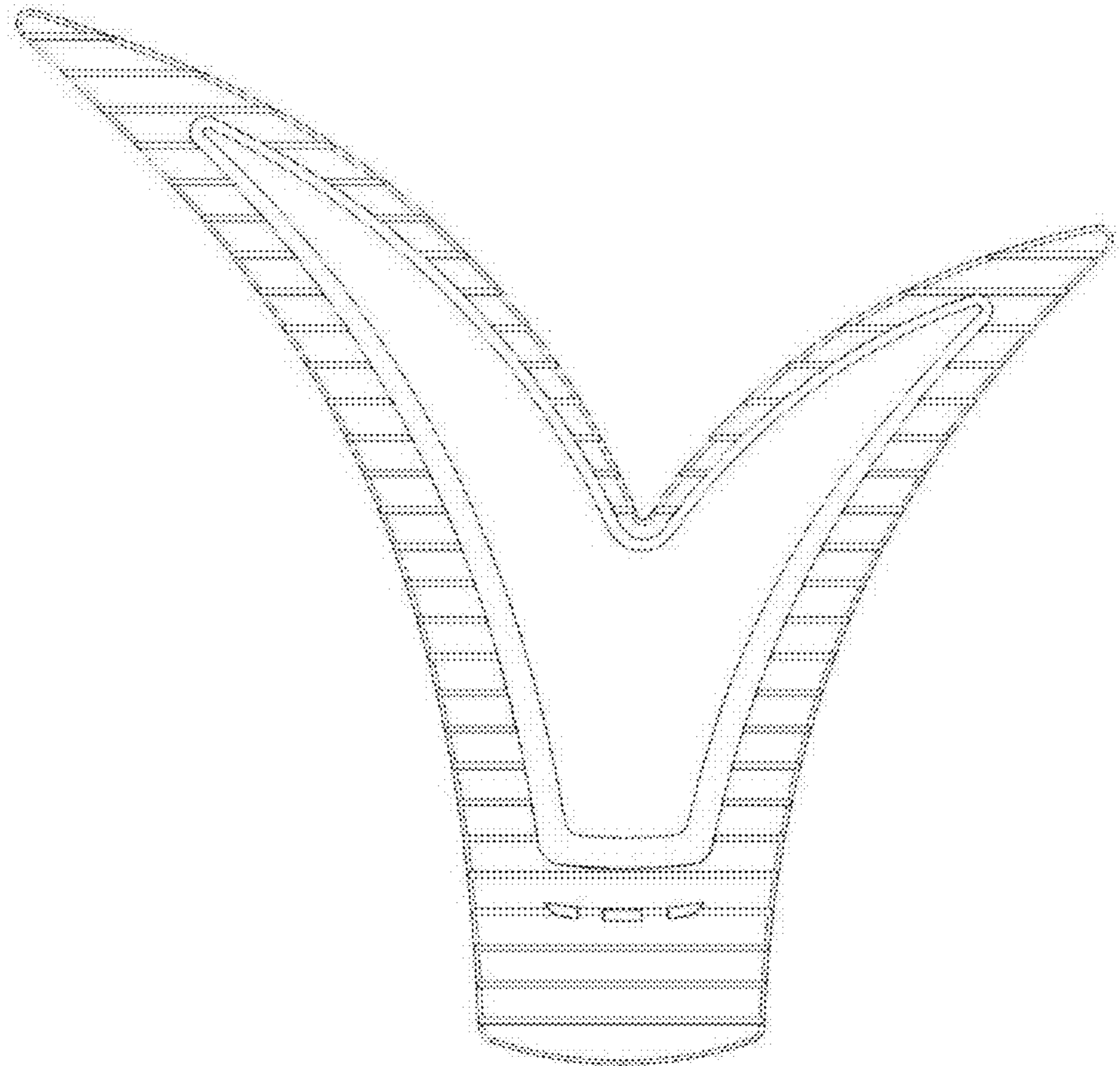

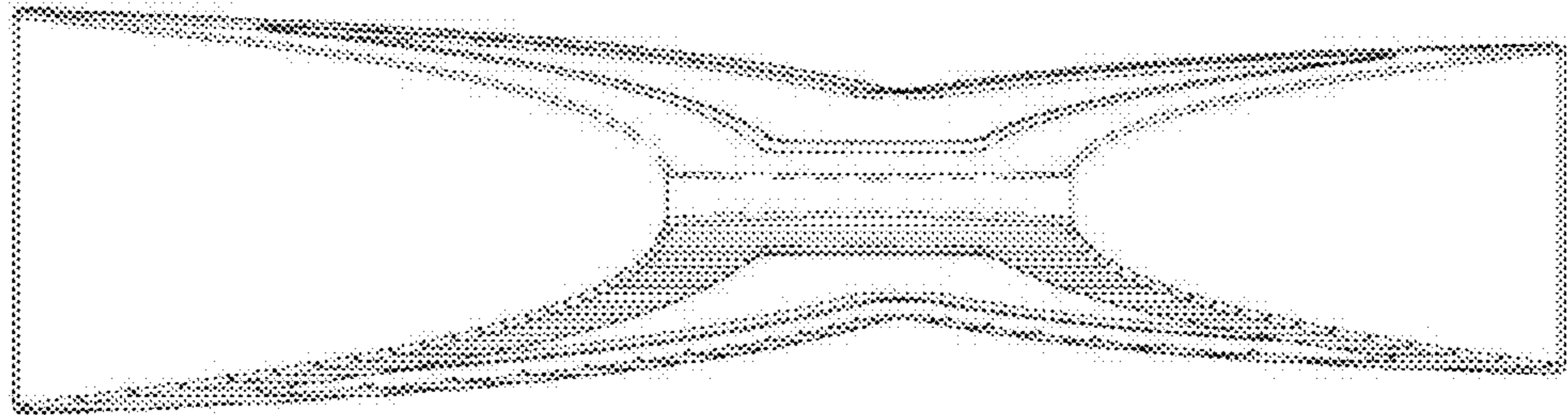
