The ornamental design for a seasoning pod holder, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a seasoning pod holder, showing our new design in a closed position;

FIG. 2 is a top plan view thereof;

FIG. 3 is a bottom plan view thereof;

FIG. 4 is a left side elevation view thereof;

FIG. 5 is a right side elevation view thereof;

FIG. 6 is a front elevation view thereof;

FIG. 7 is a rear elevation view thereof;

FIG. 8 is a top plan view of the seasoning pod holder in an open position;


FIG. 9 is a perspective view thereof;






















