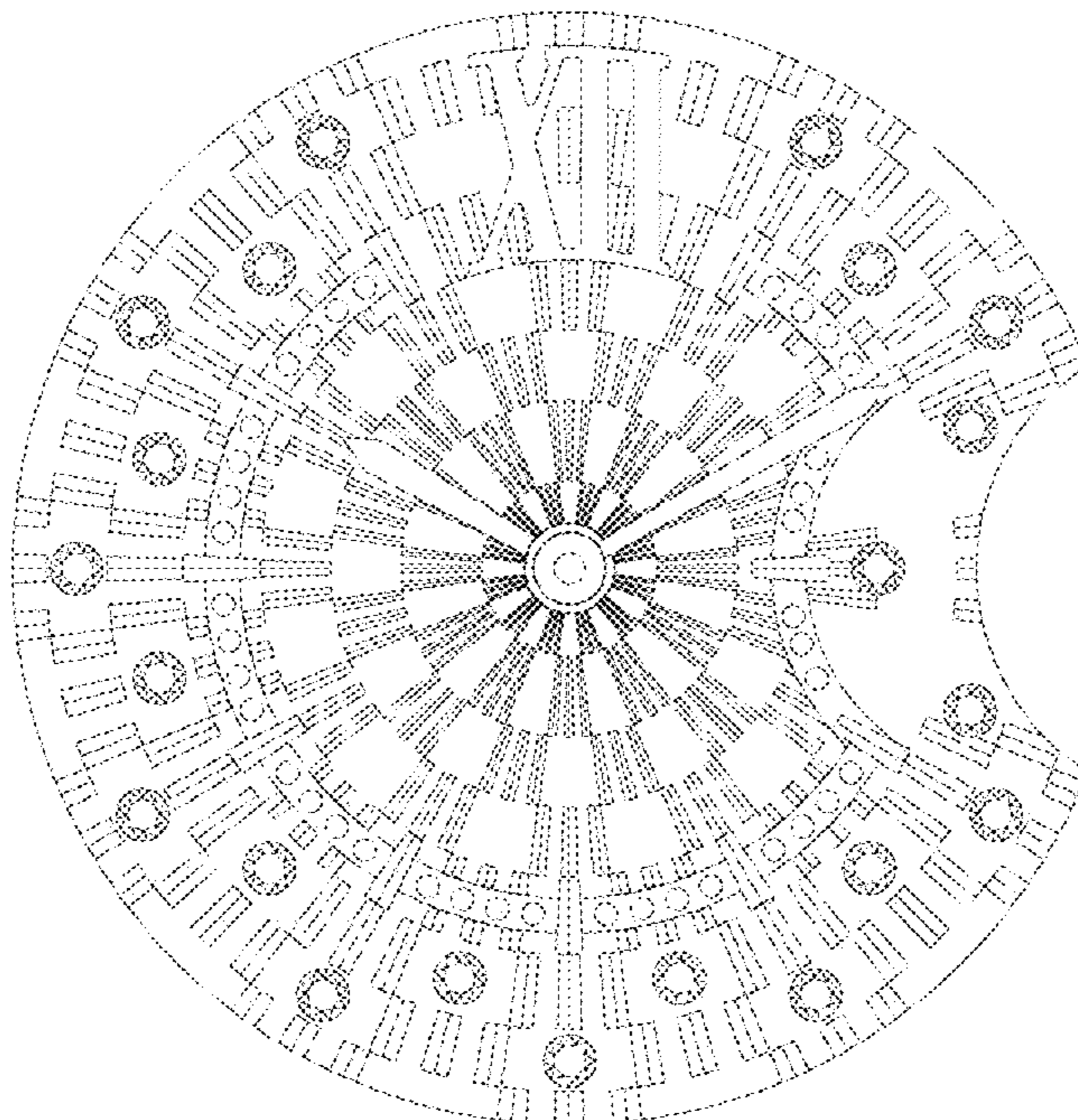

The ornamental design for a watch dial, as shown and described.

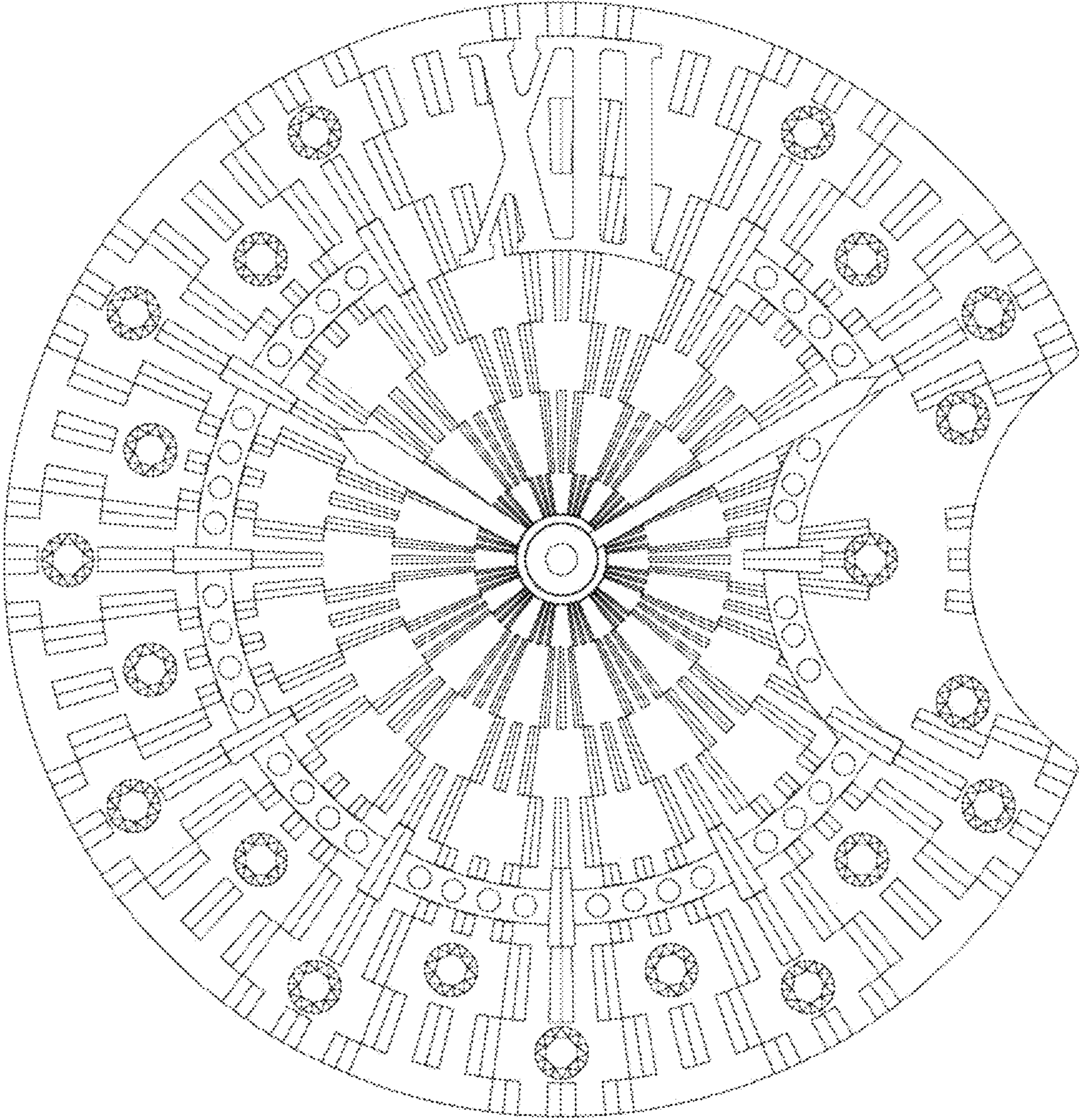
DESCRIPTION

1.8 is a rear perspective view thereof.

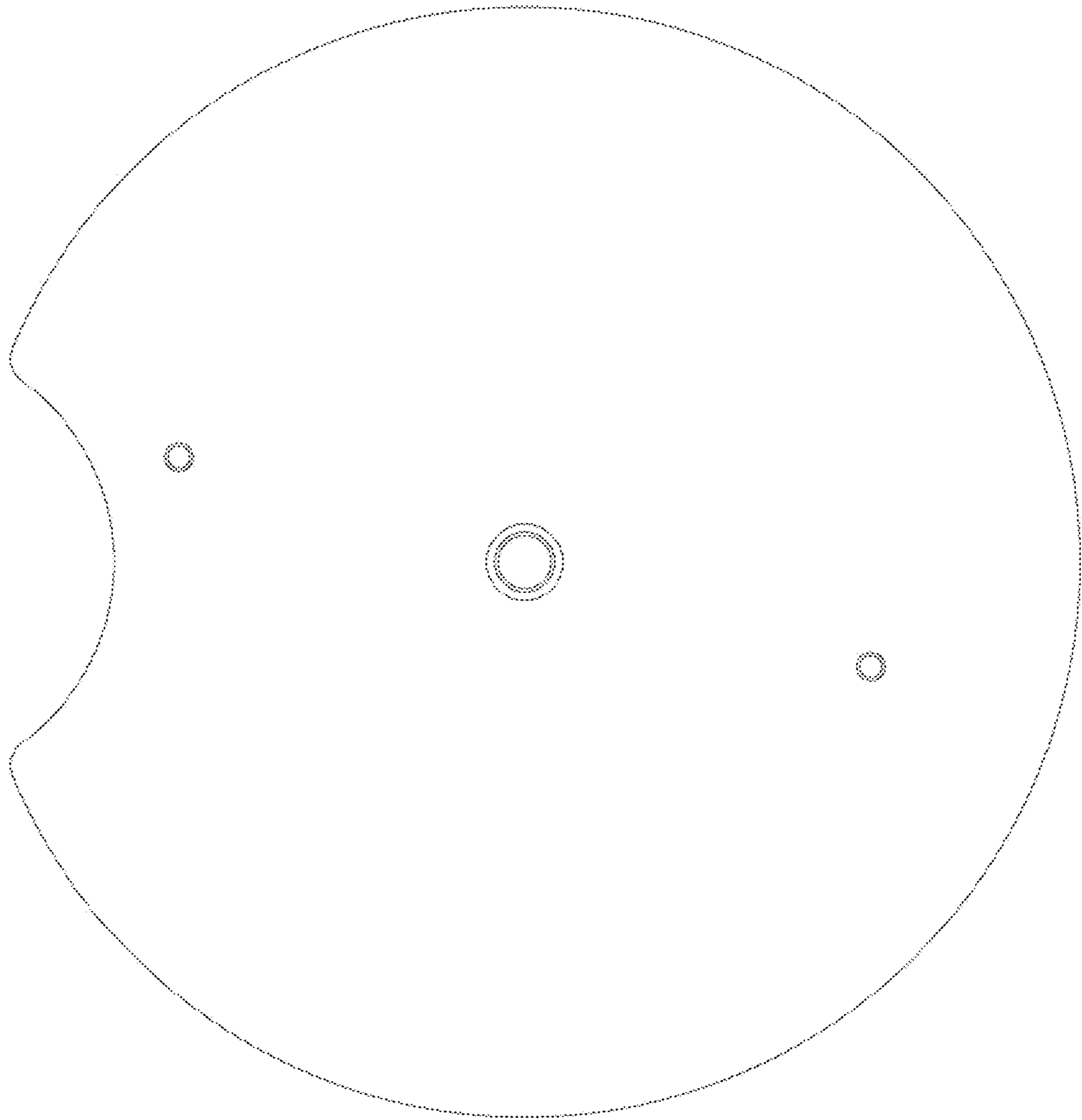

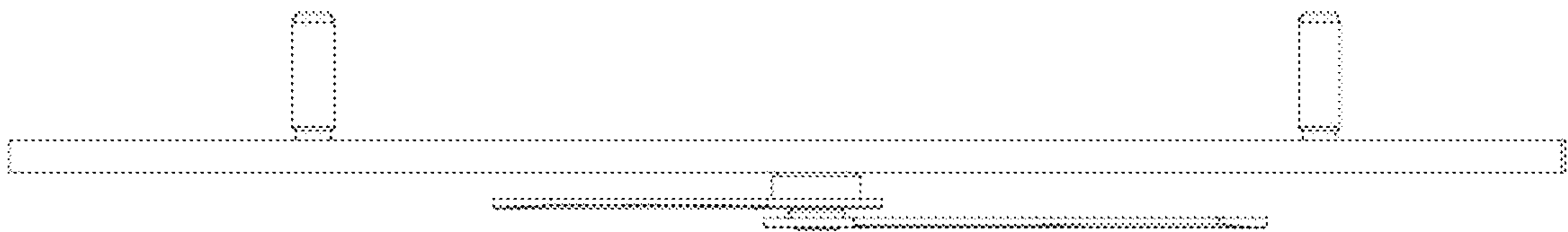

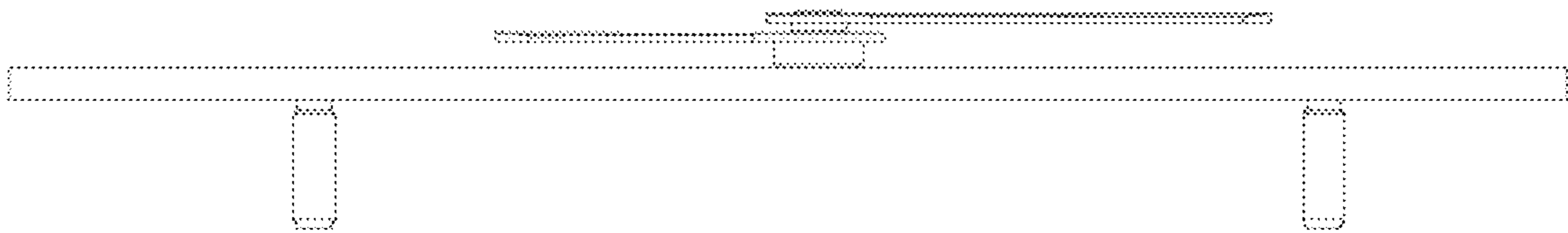

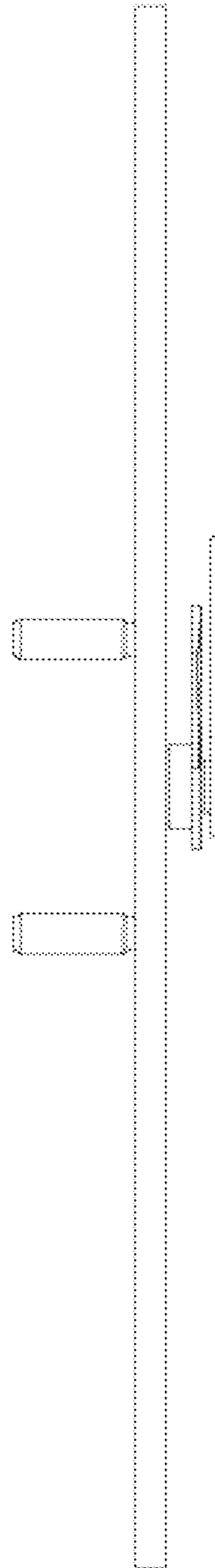

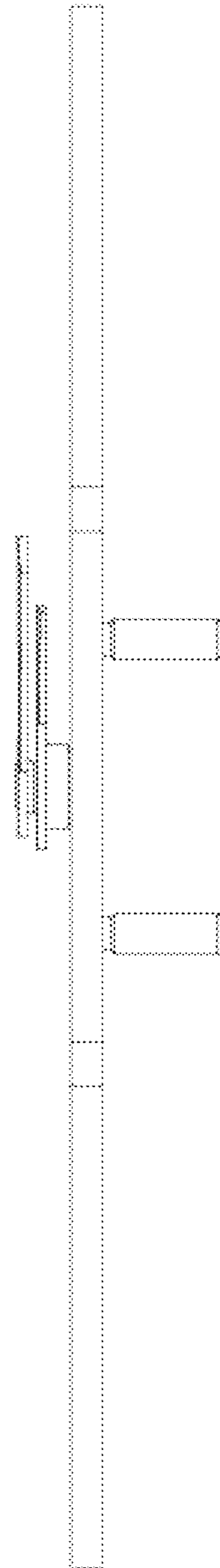

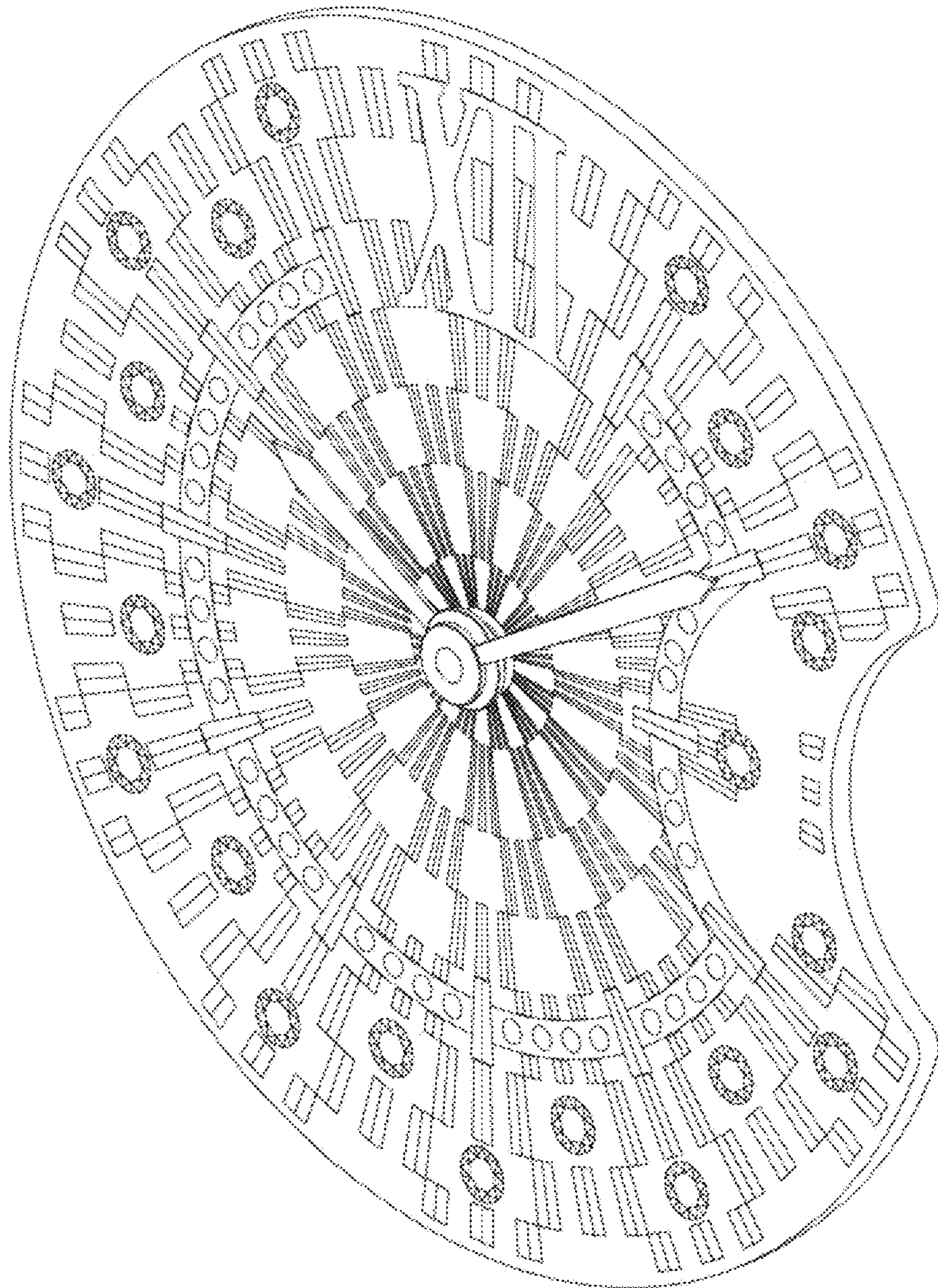
