(57) **CLAIM**

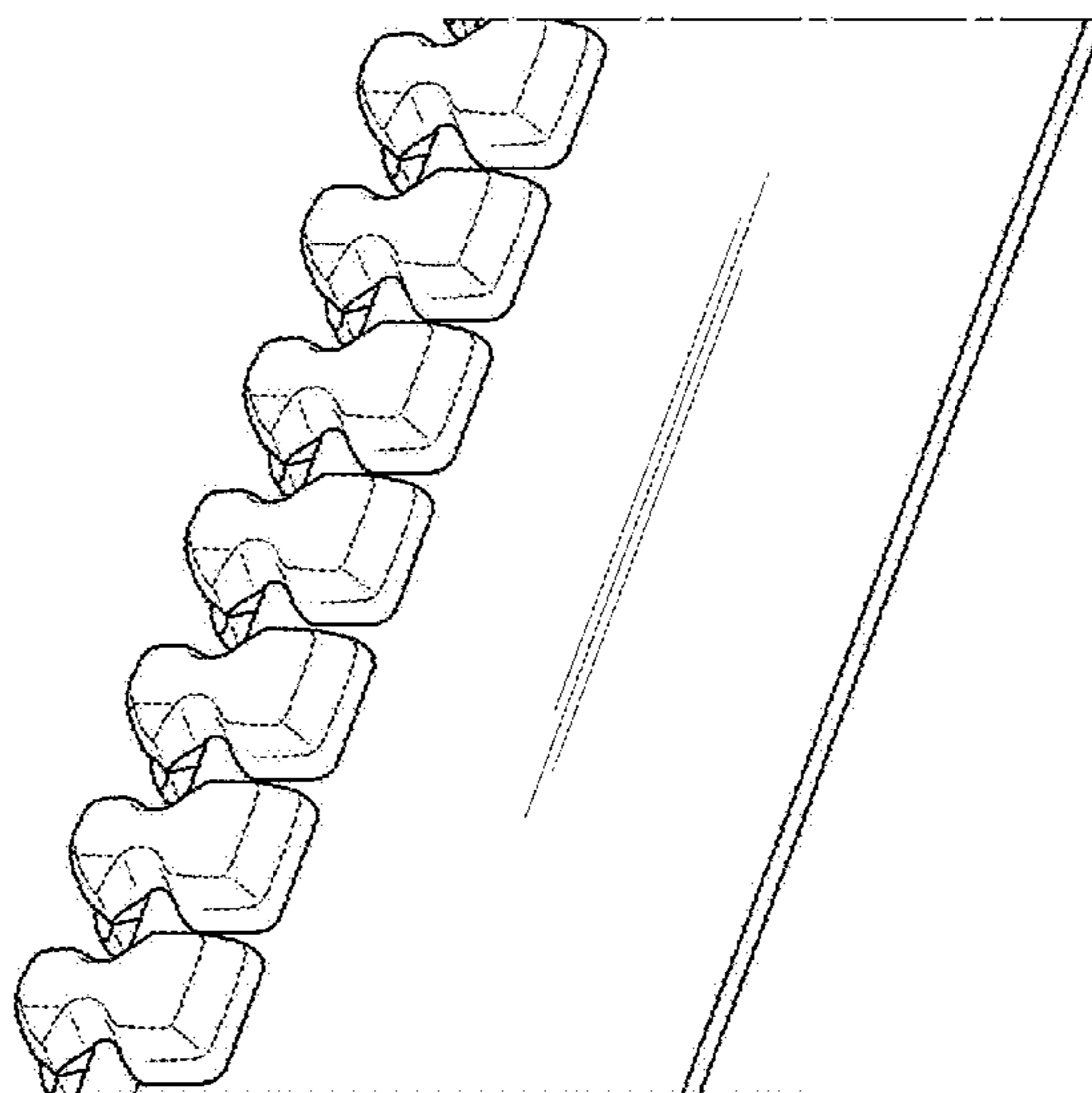
The ornamental design for a chain for slide fastener, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a chain for slide fastener showing my new design;

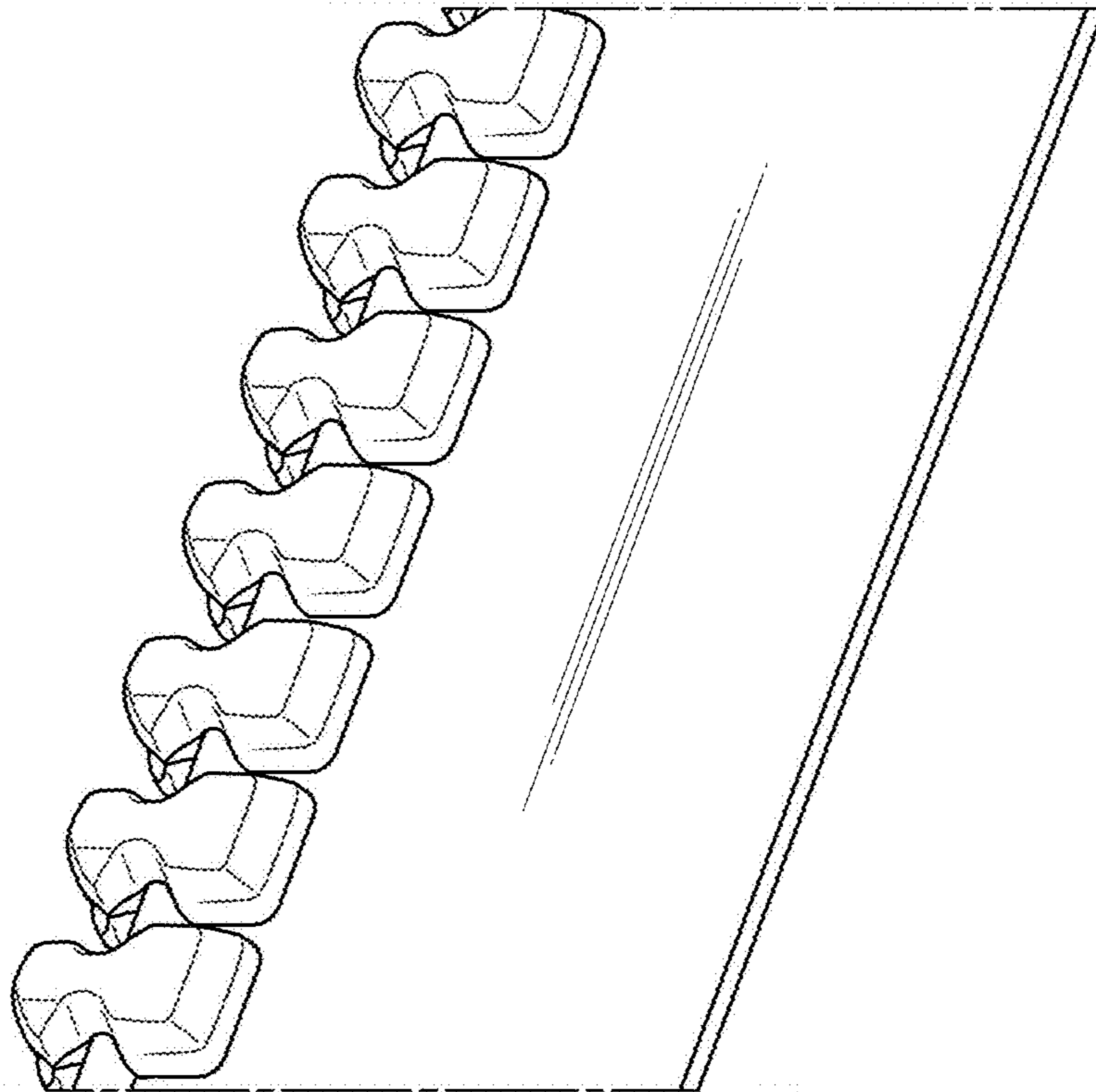

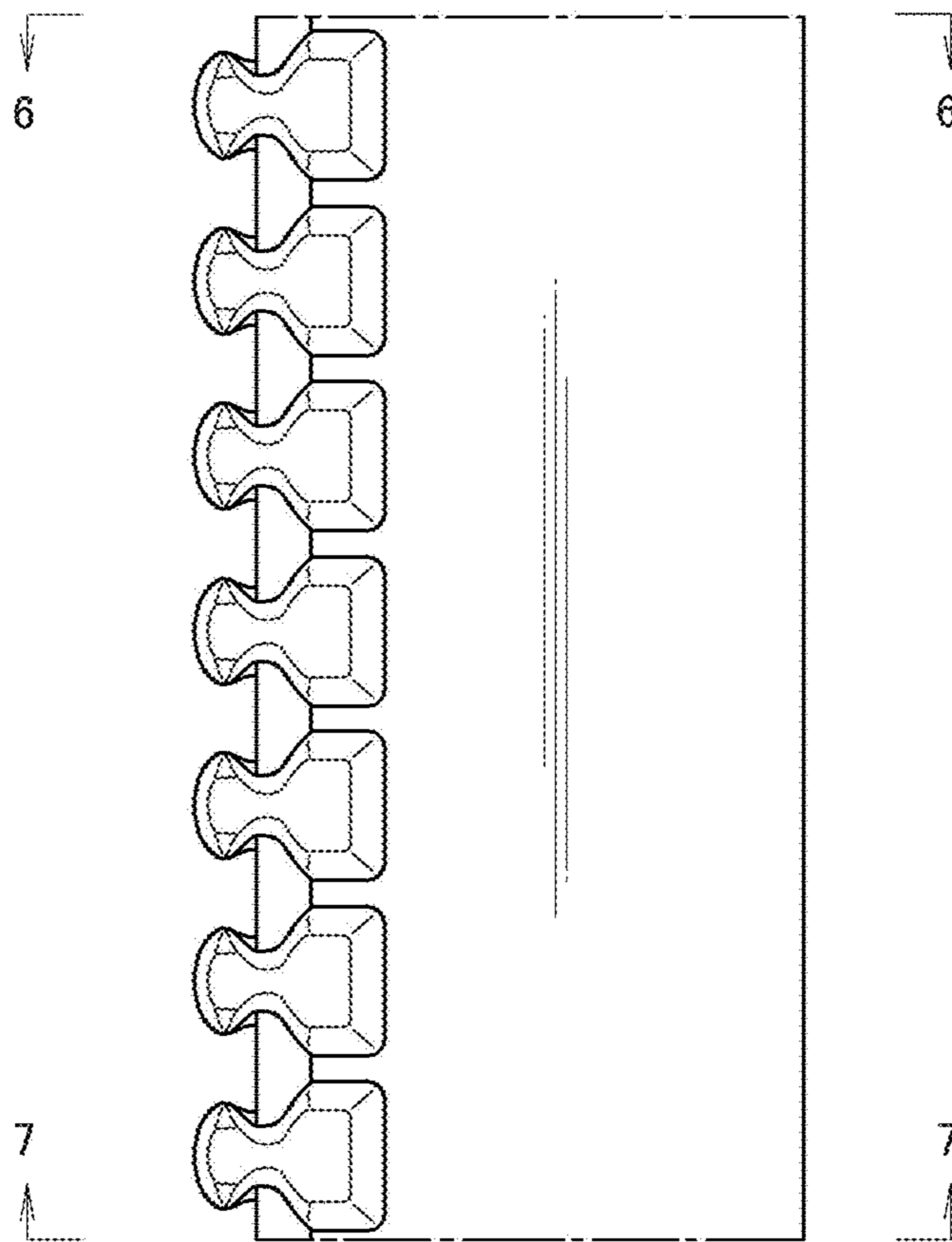

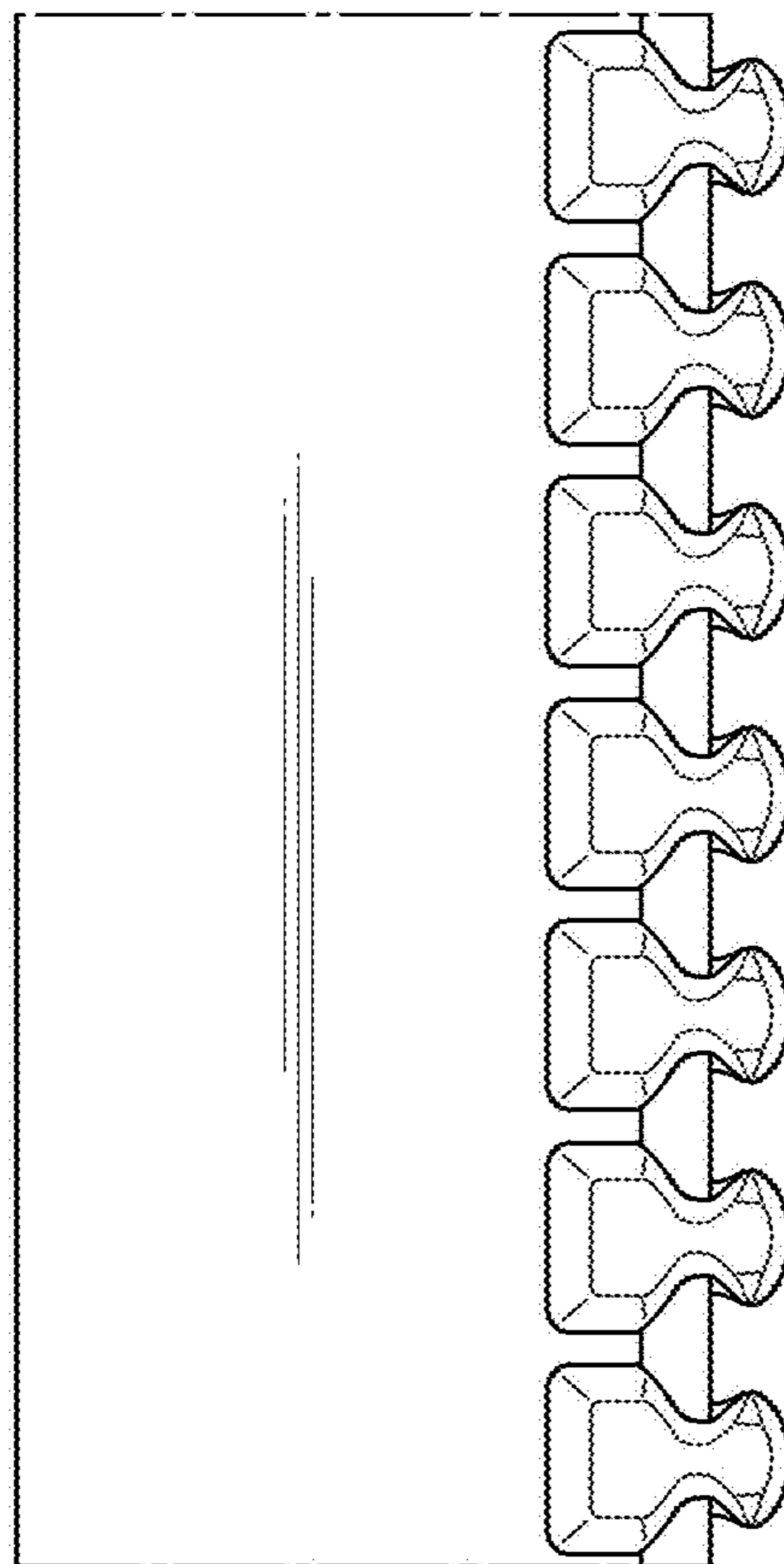

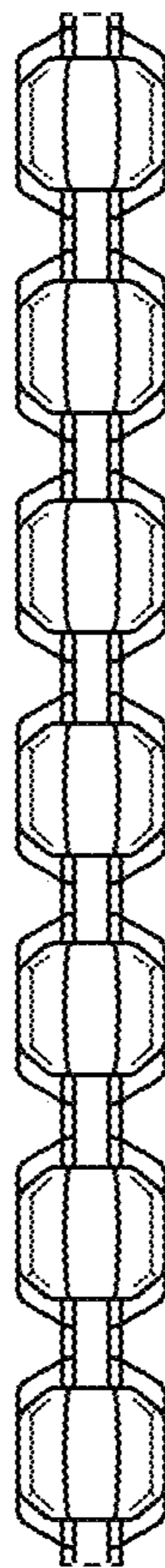

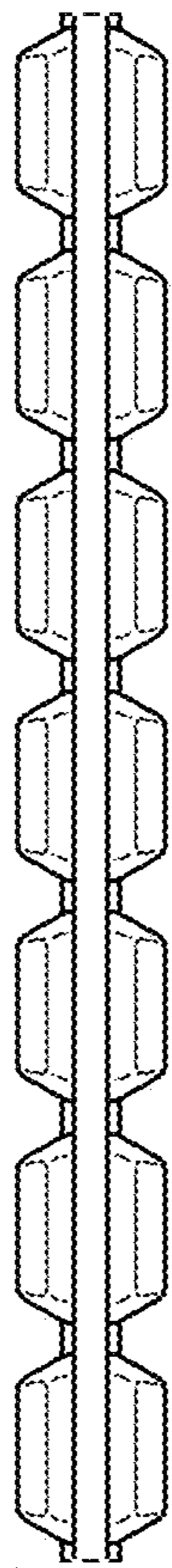

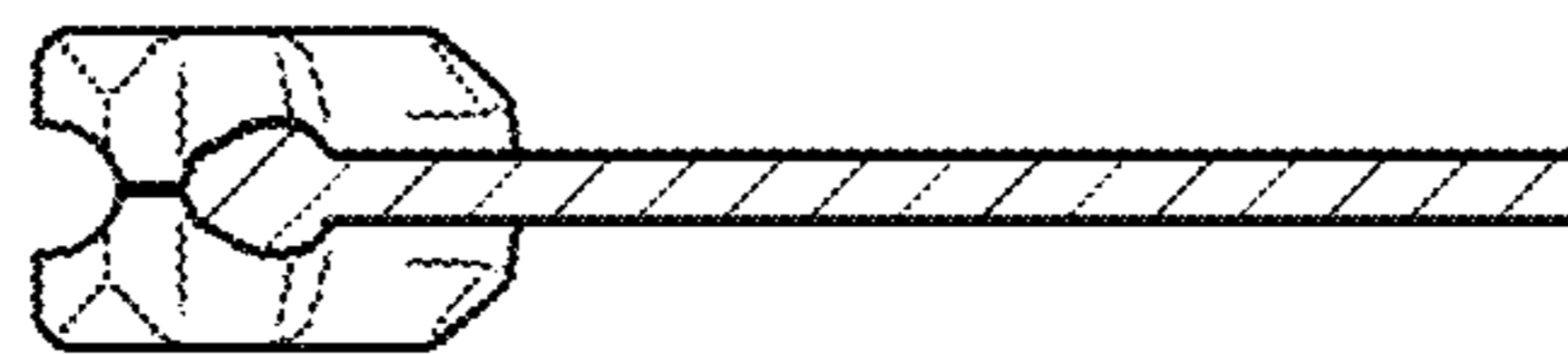
