(57) **CLAIM**

We claim the ornamental design for a passenger car, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front and right side perspective view of a passenger car showing our new design; FIG. 2 is a top, rear and left side perspective view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a rear elevational view thereof; FIG. 5 is a top plan view thereof; FIG. 6 is a left side elevational view thereof; and, FIG. 7 is a right side elevational view thereof. The bottom view of the passenger car forms no part of the claimed design.

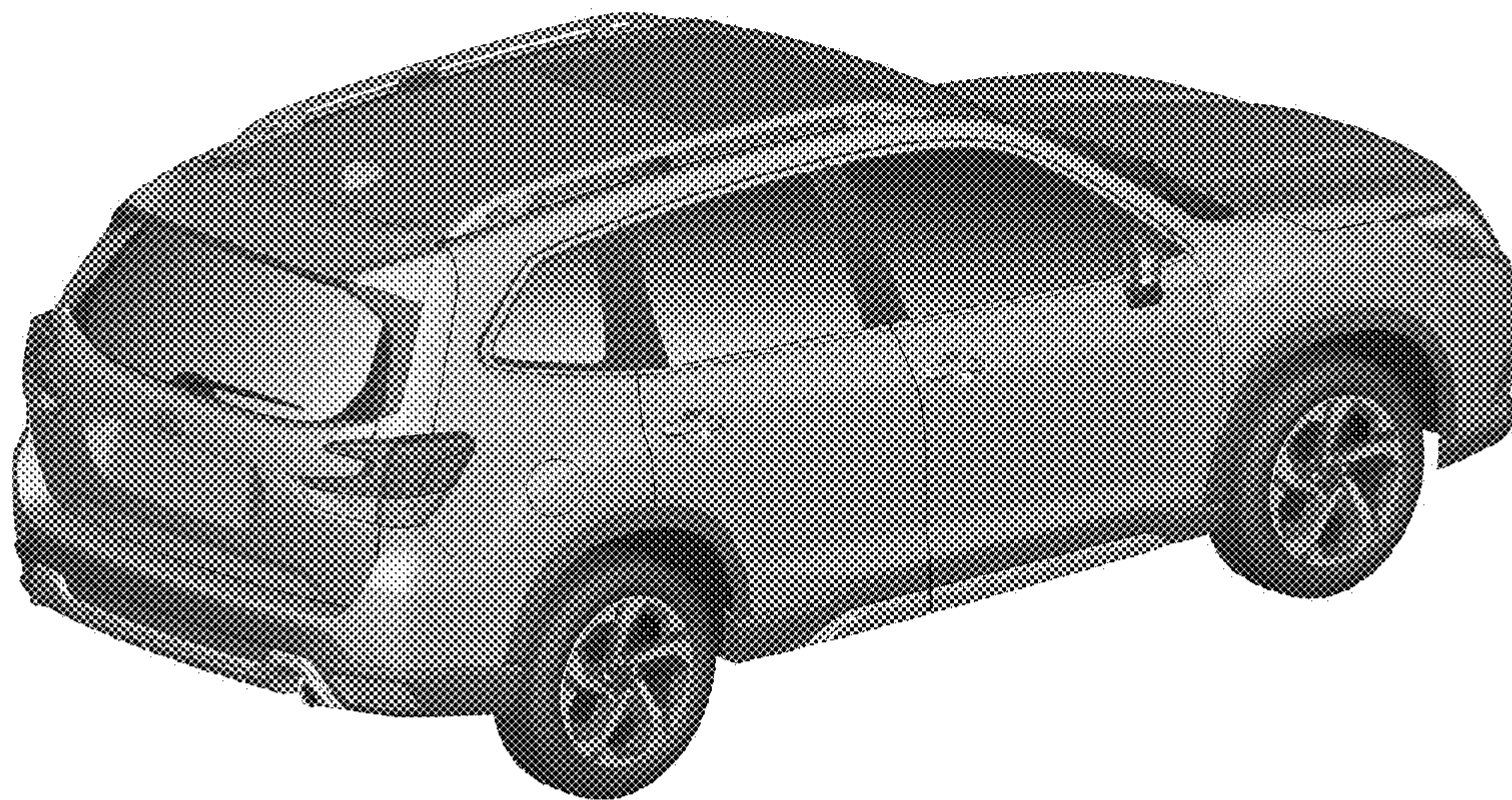

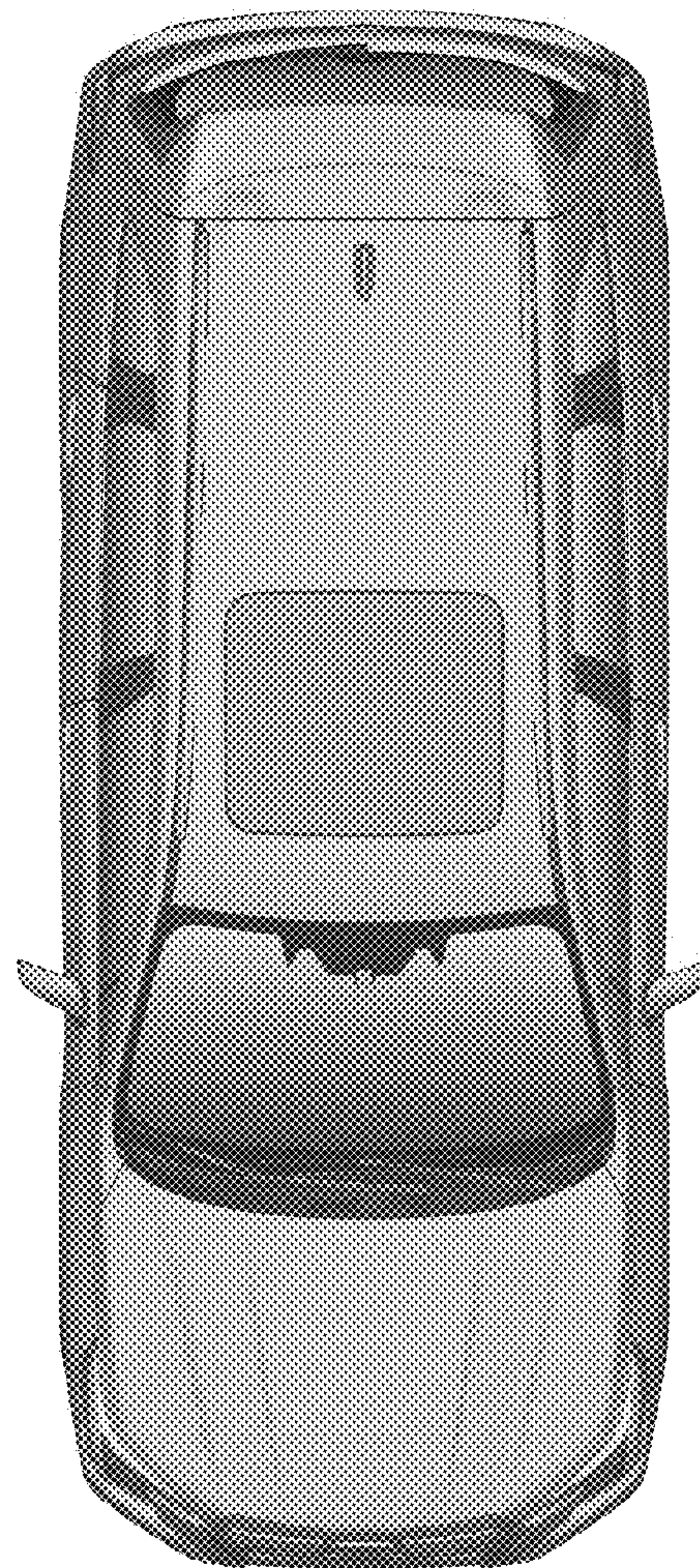

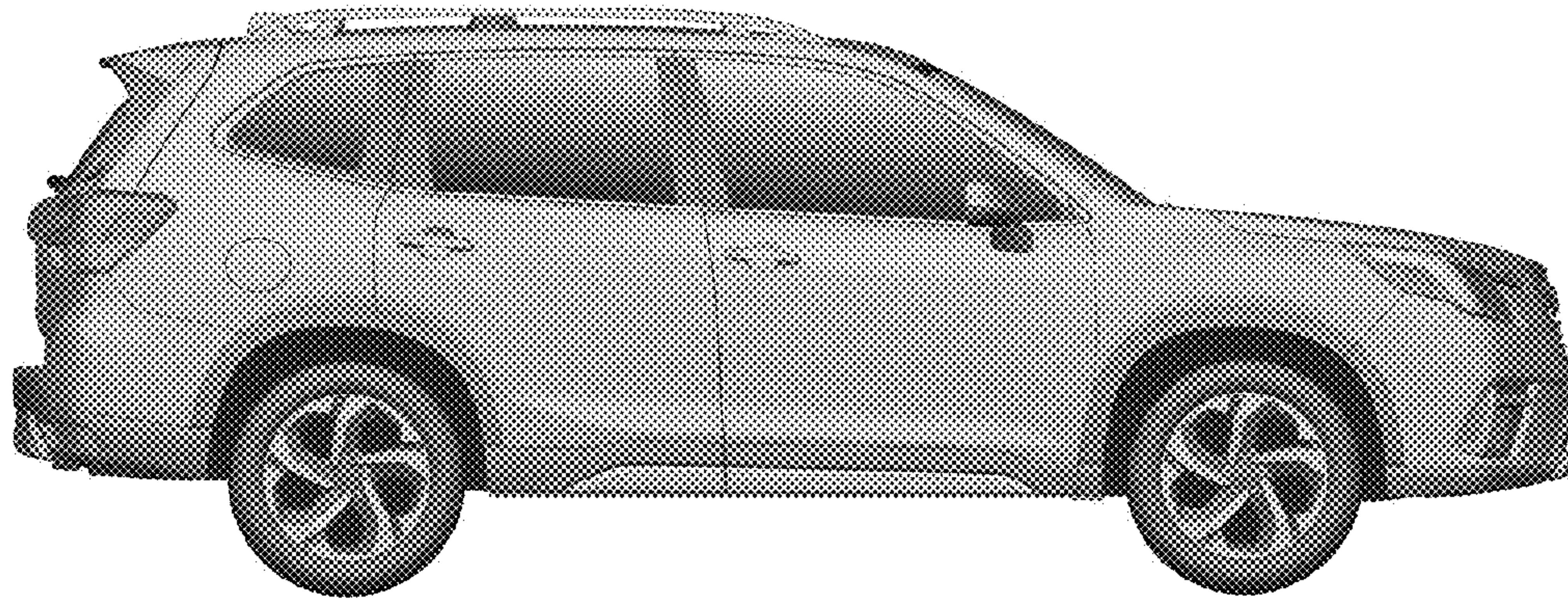
