1.4 : Left

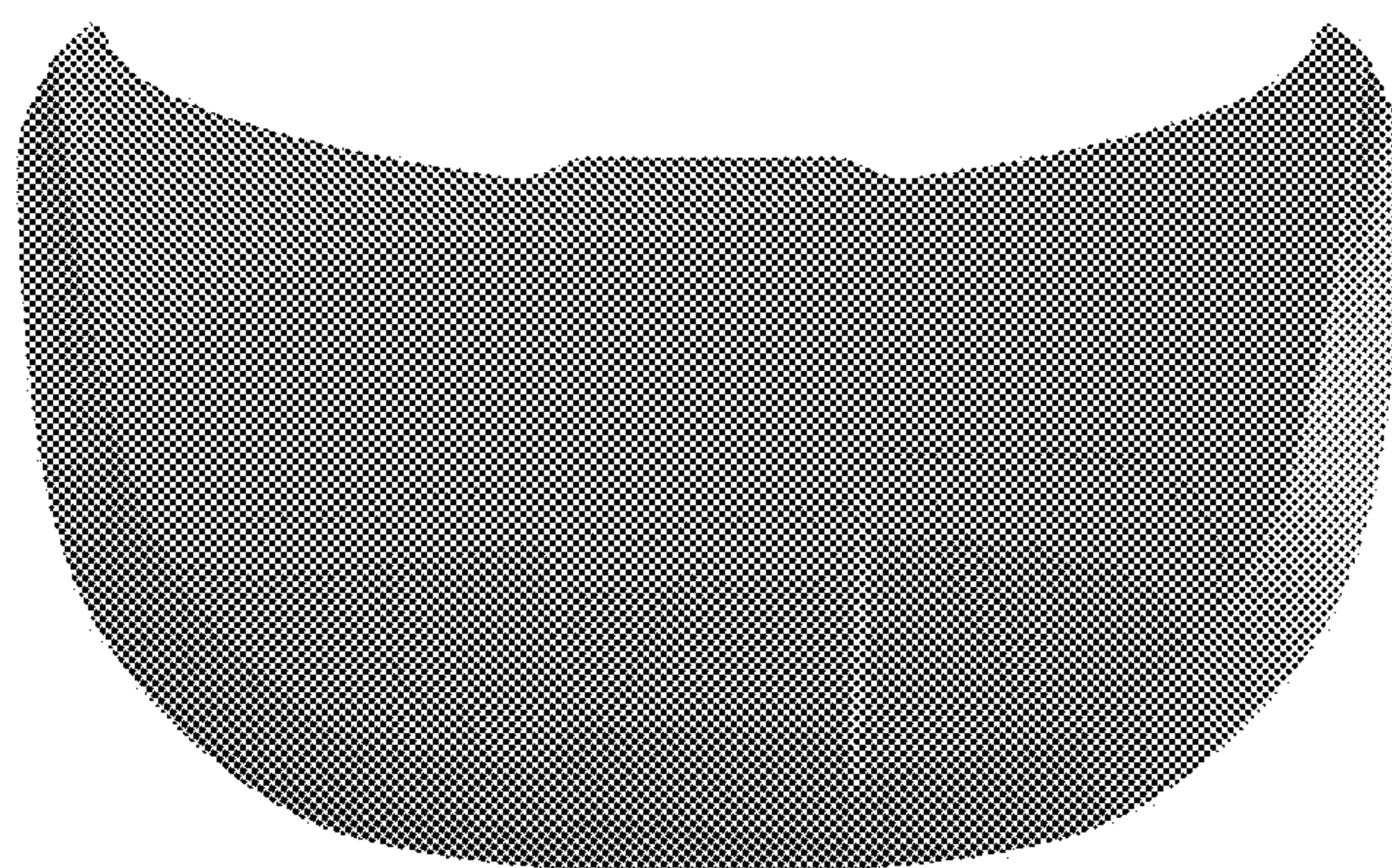
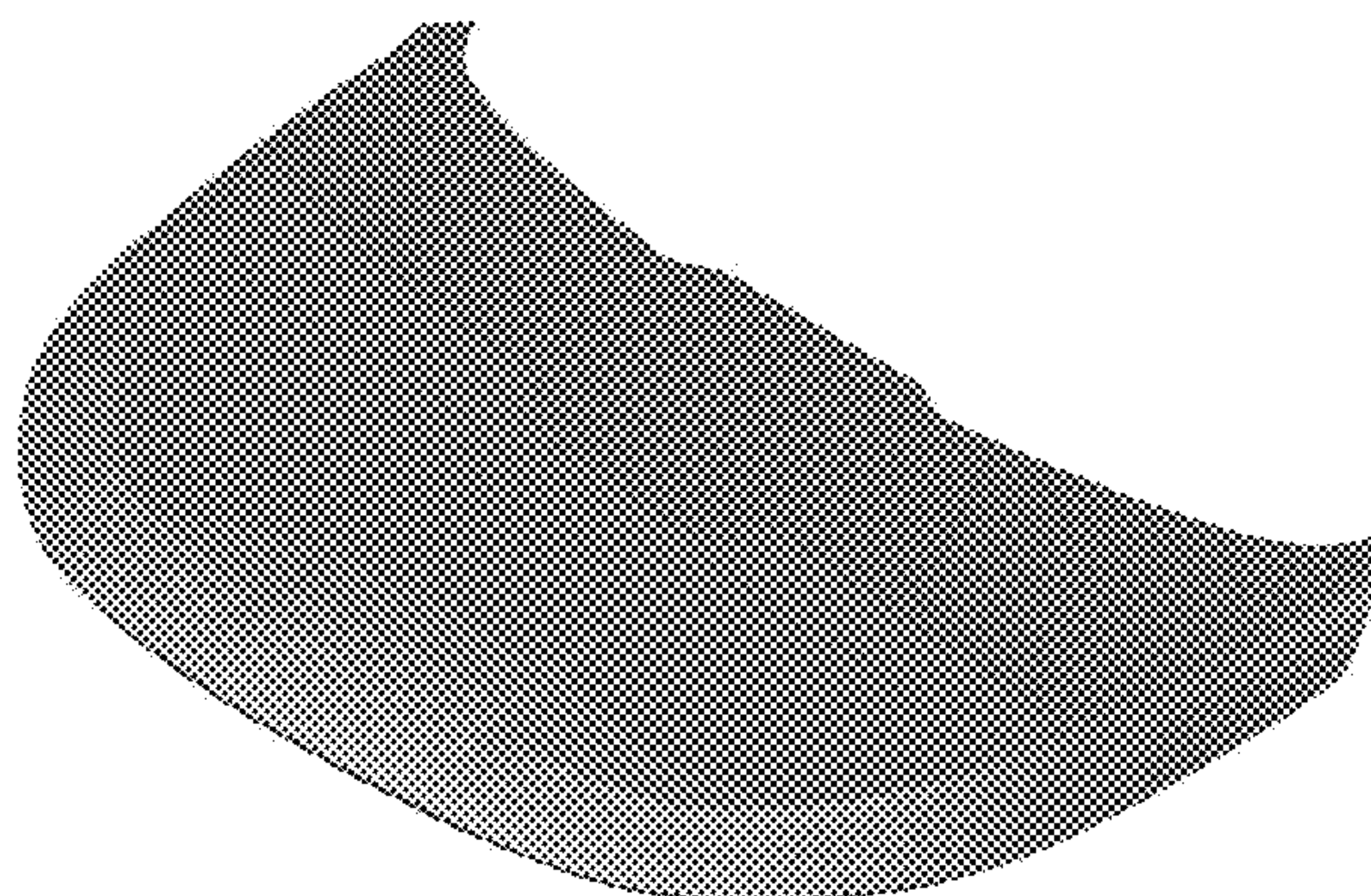

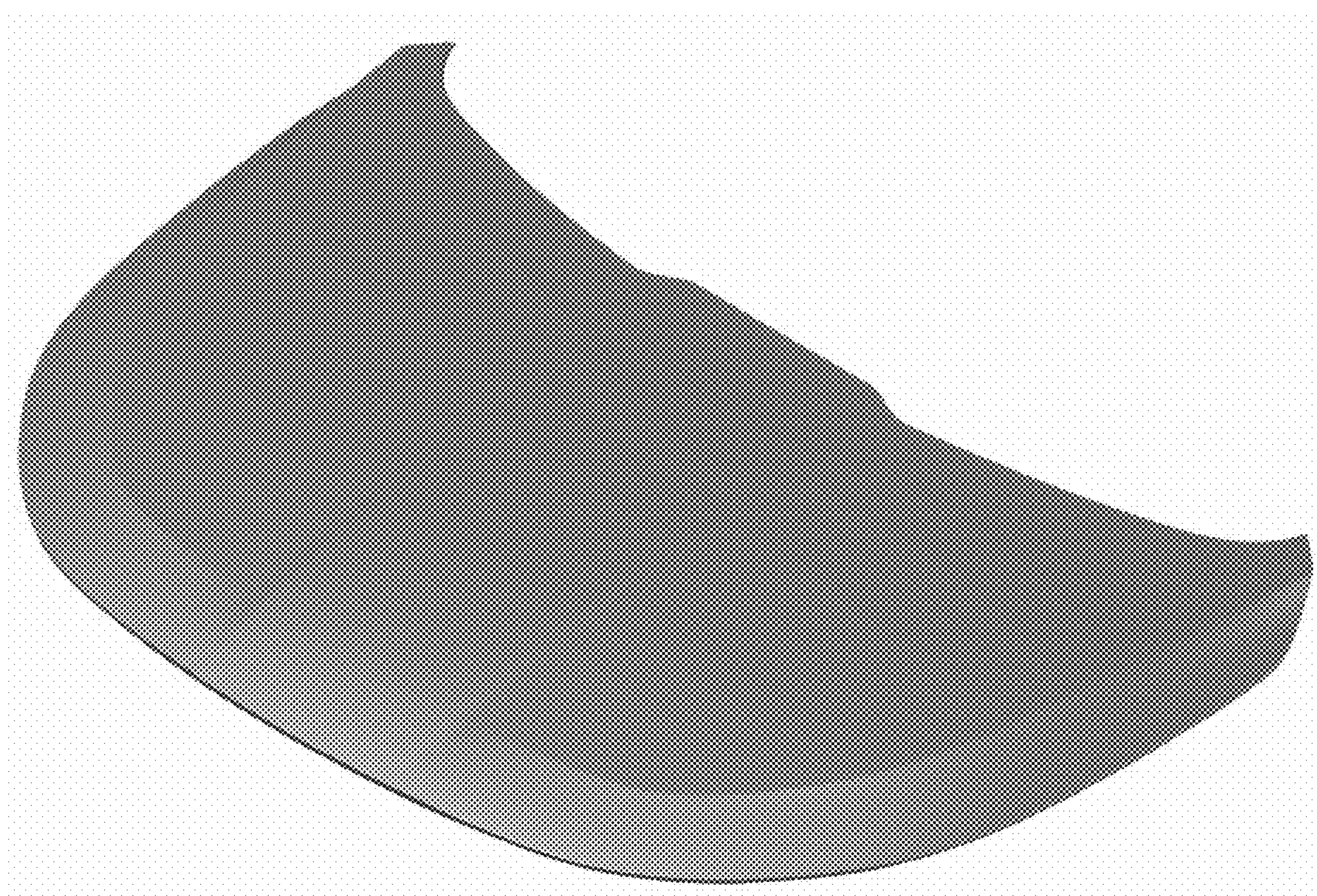

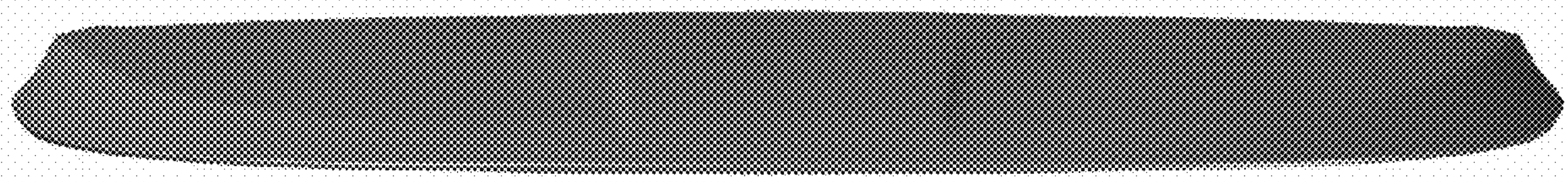

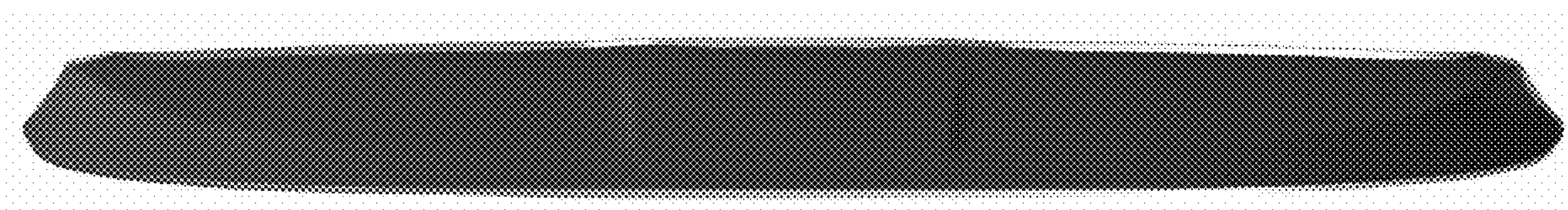

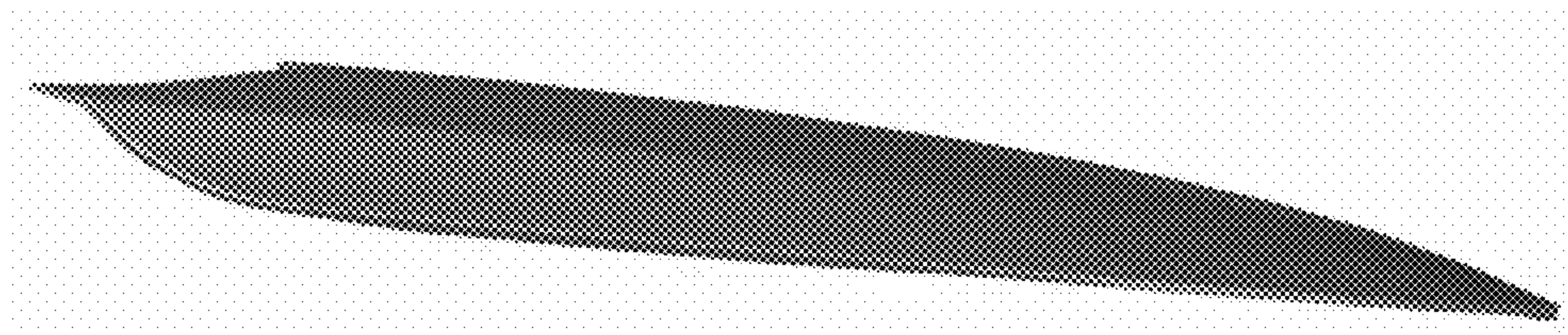

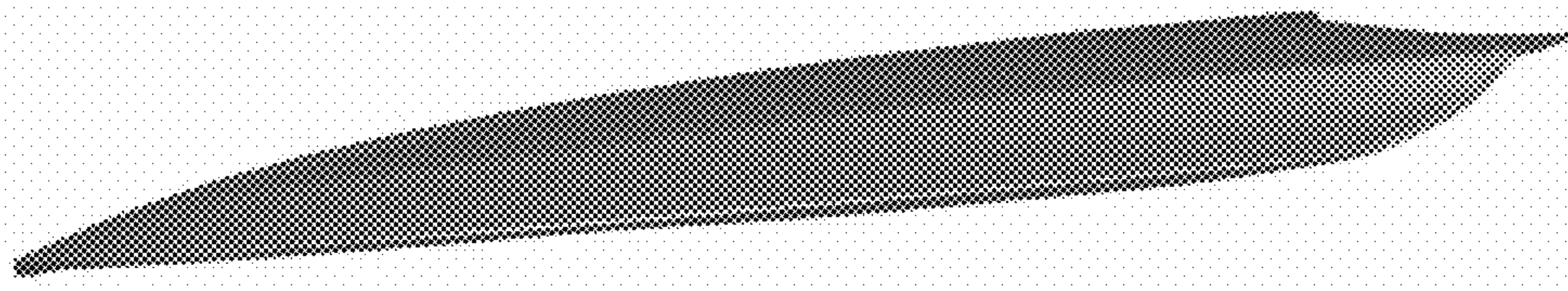

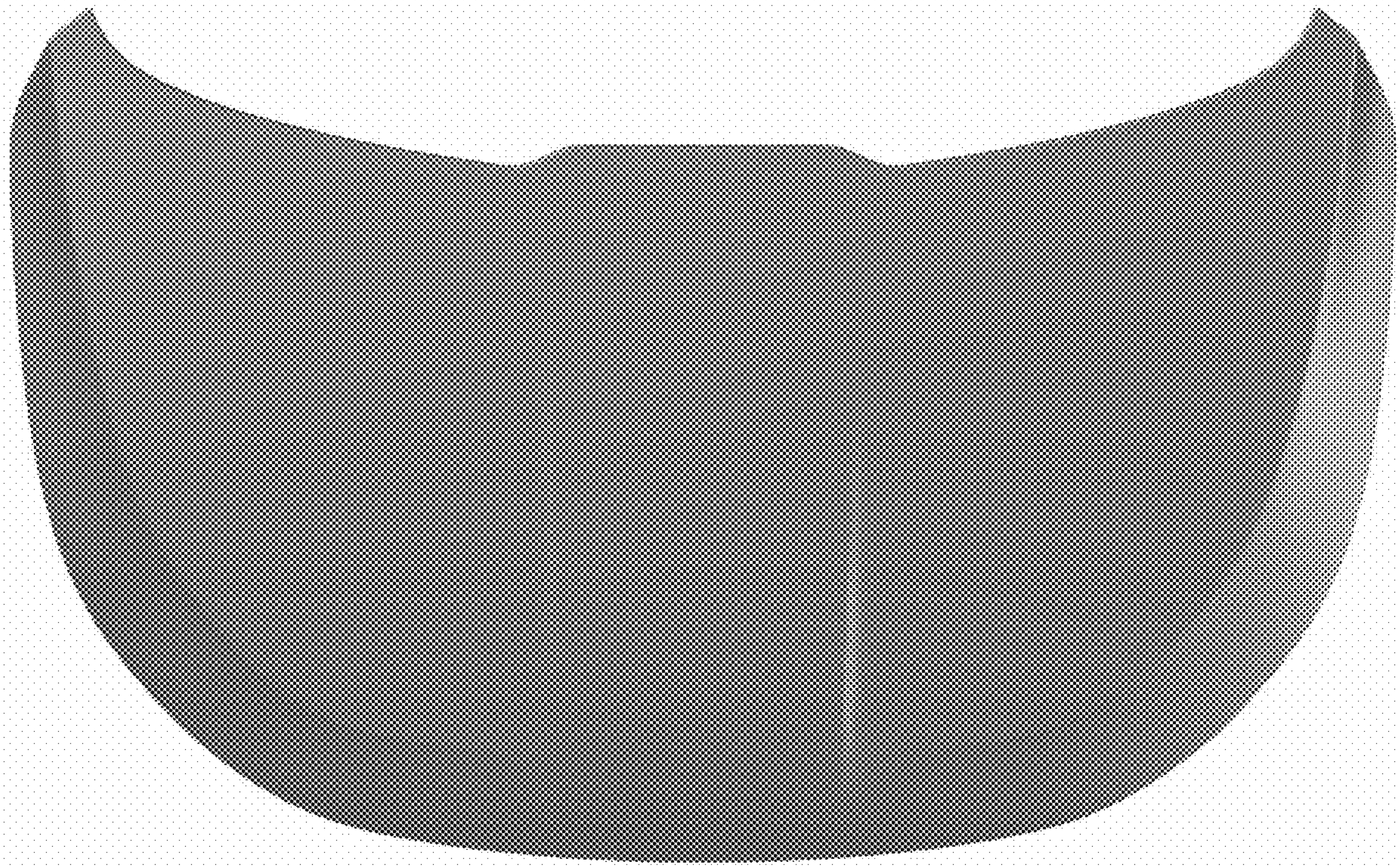
