The ornamental design for wireless earphones with charging case, as shown and described.

DESCRIPTION

FIG. 13 is a left side elevational view thereof;
FIG. 14 is a right side elevational view thereof;

FIG. 17 is a perspective view of the wireless earphones with charging case, where the wireless earphones are received in the charging case; and,

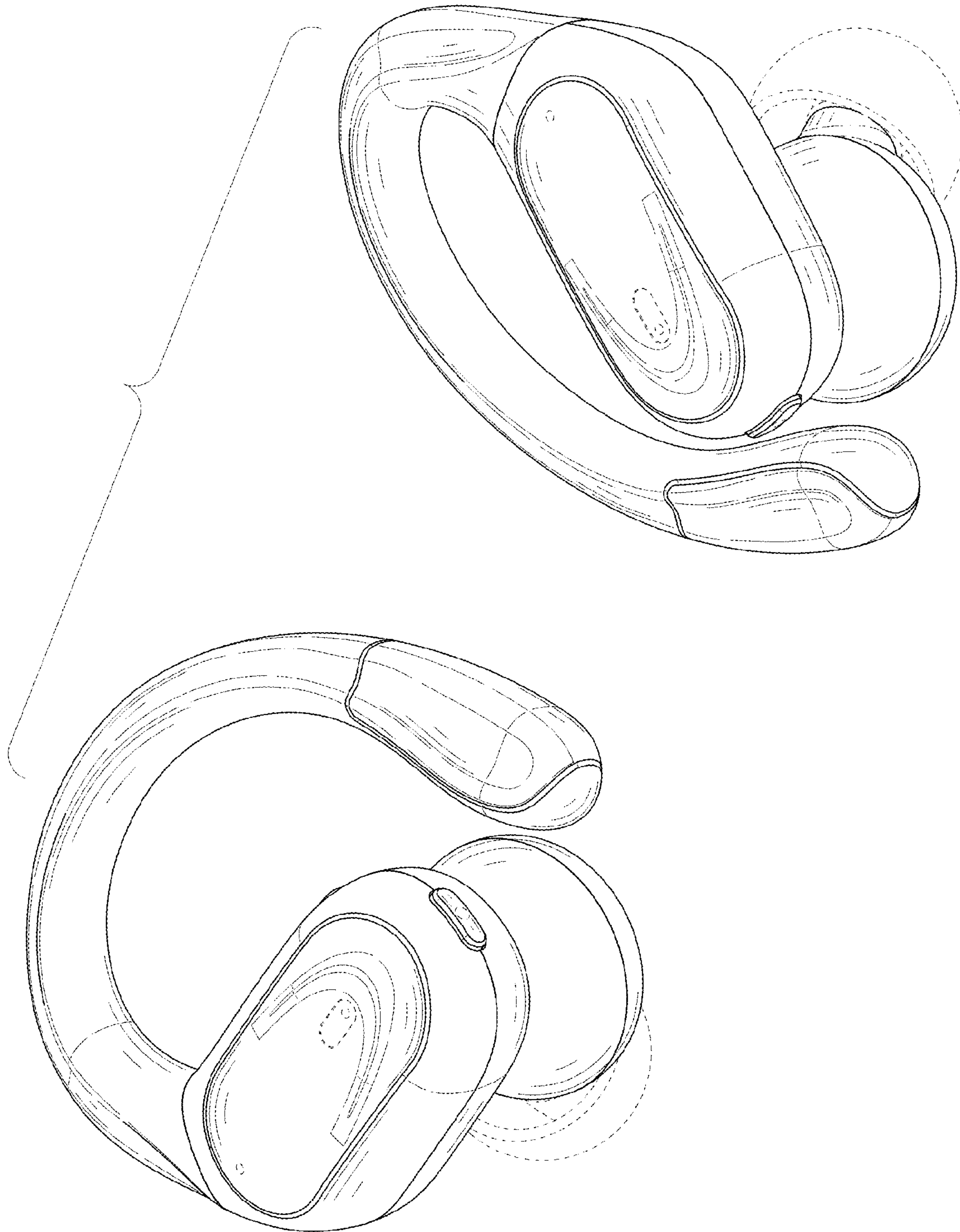

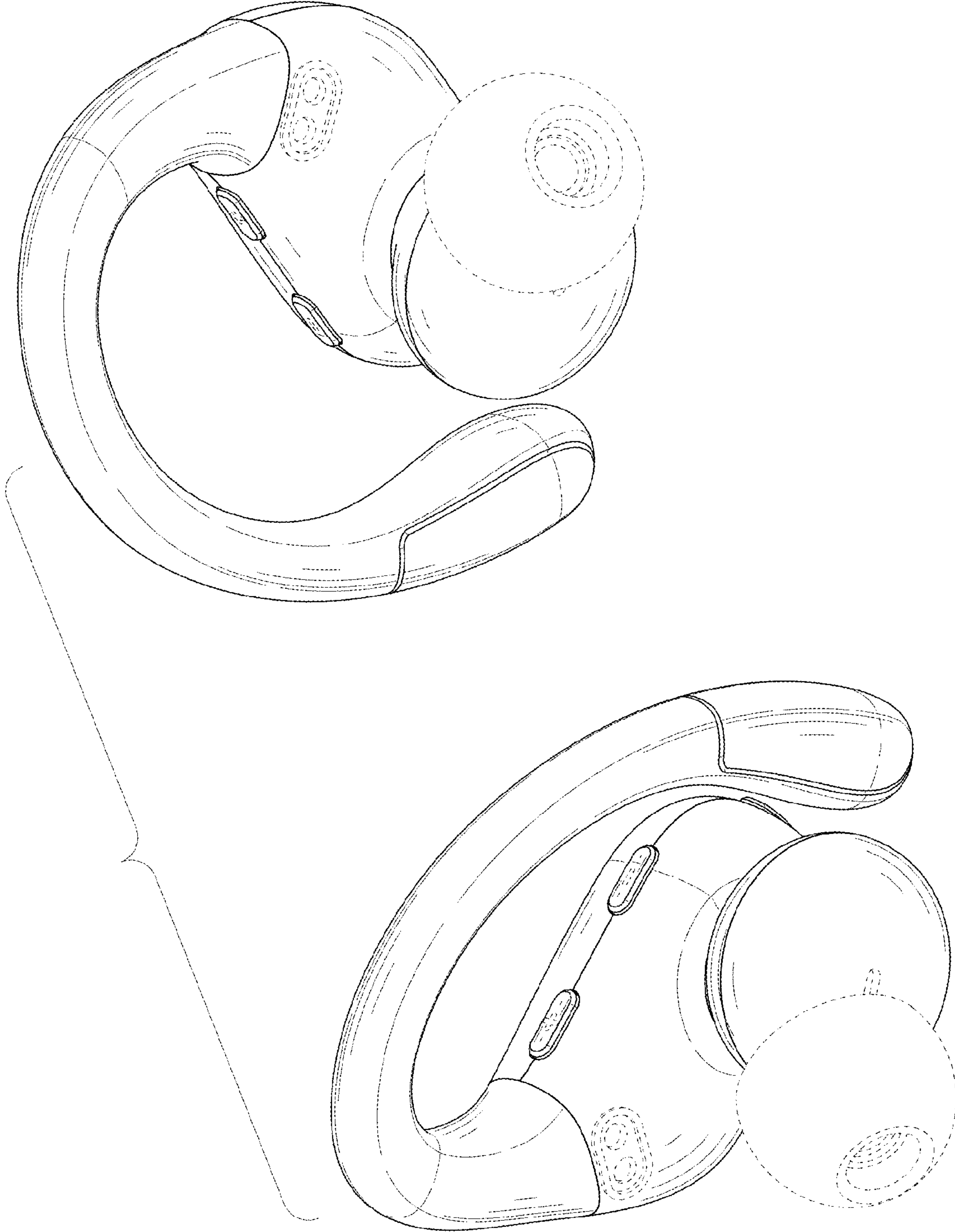

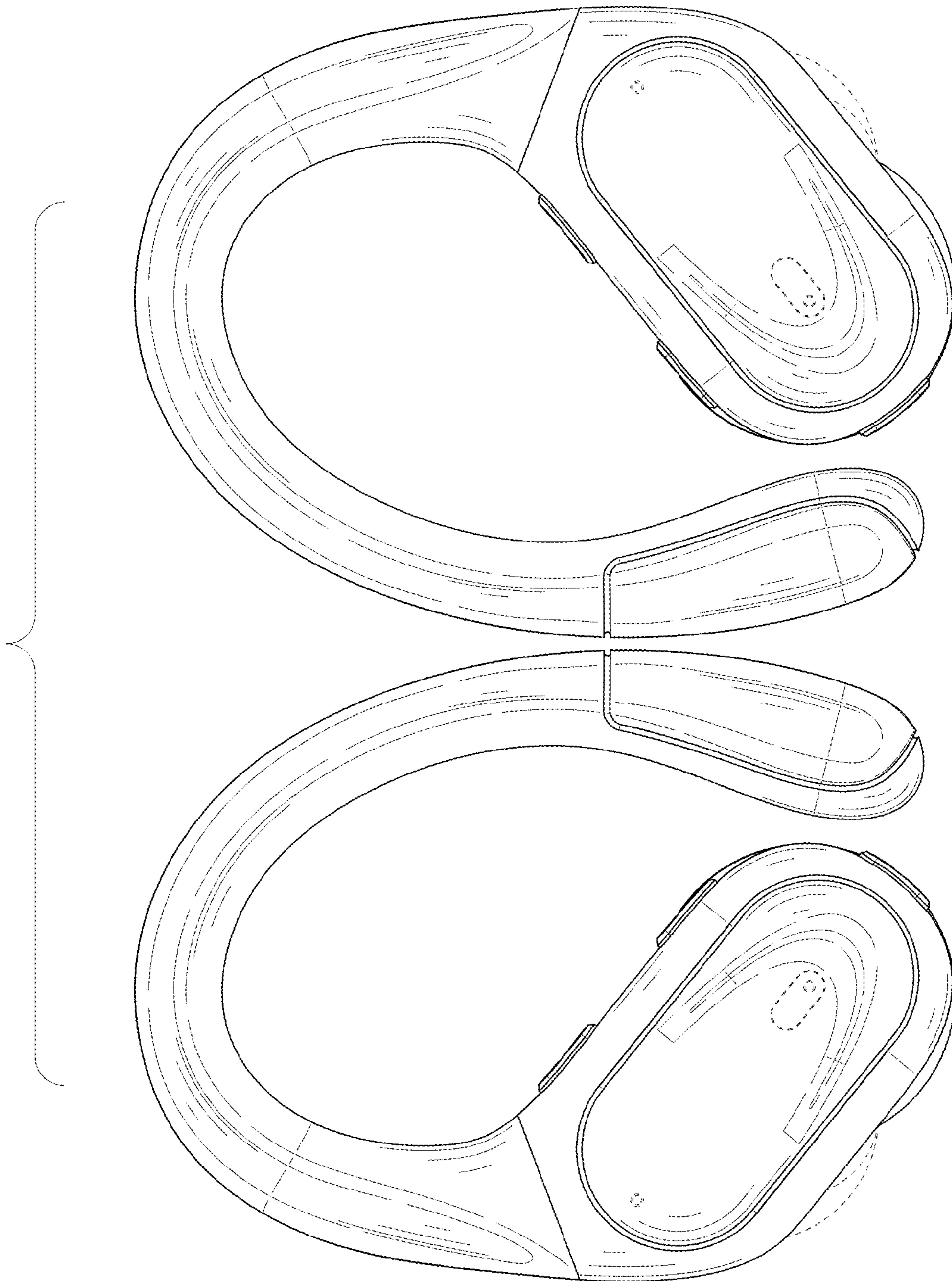

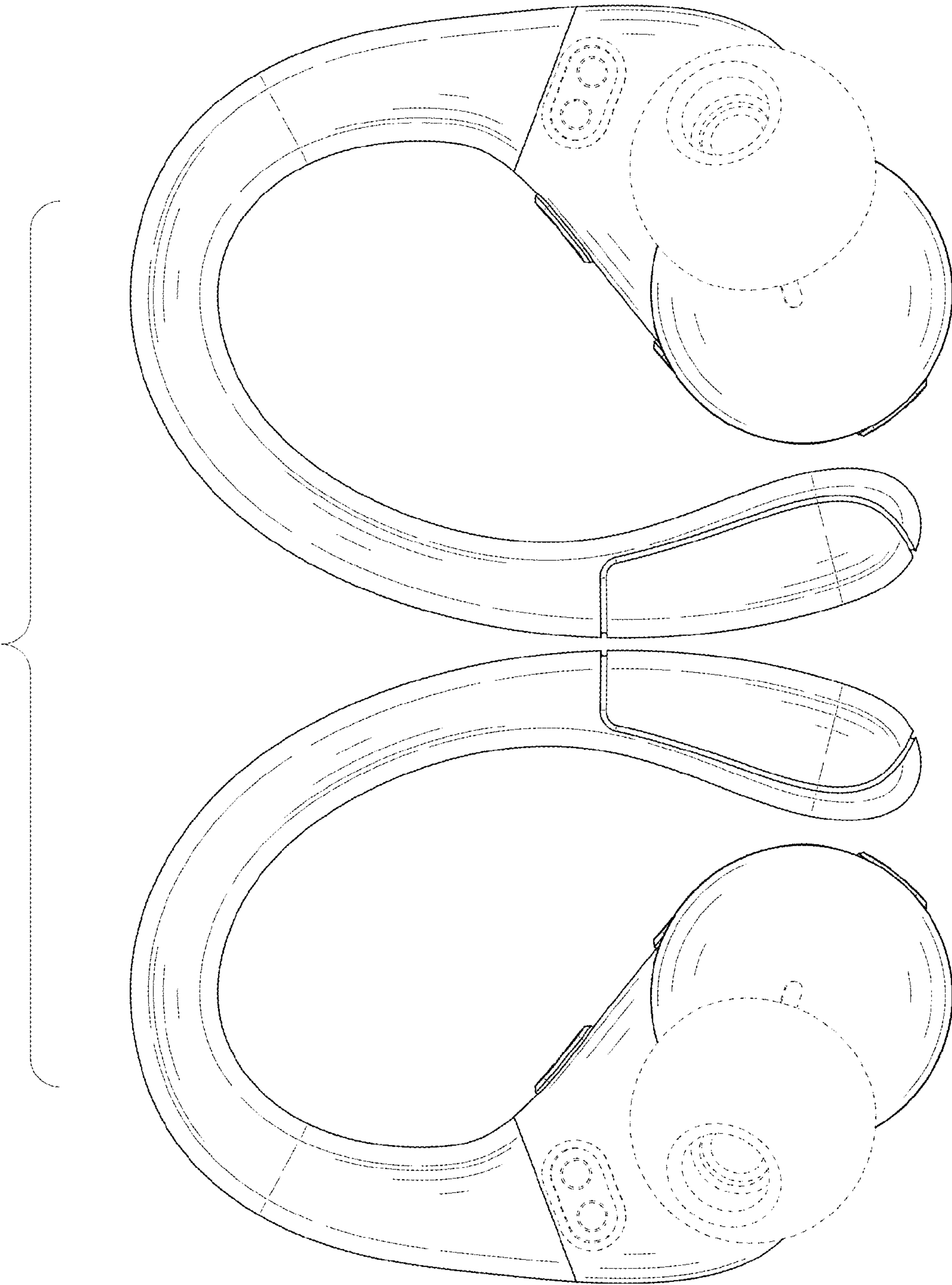

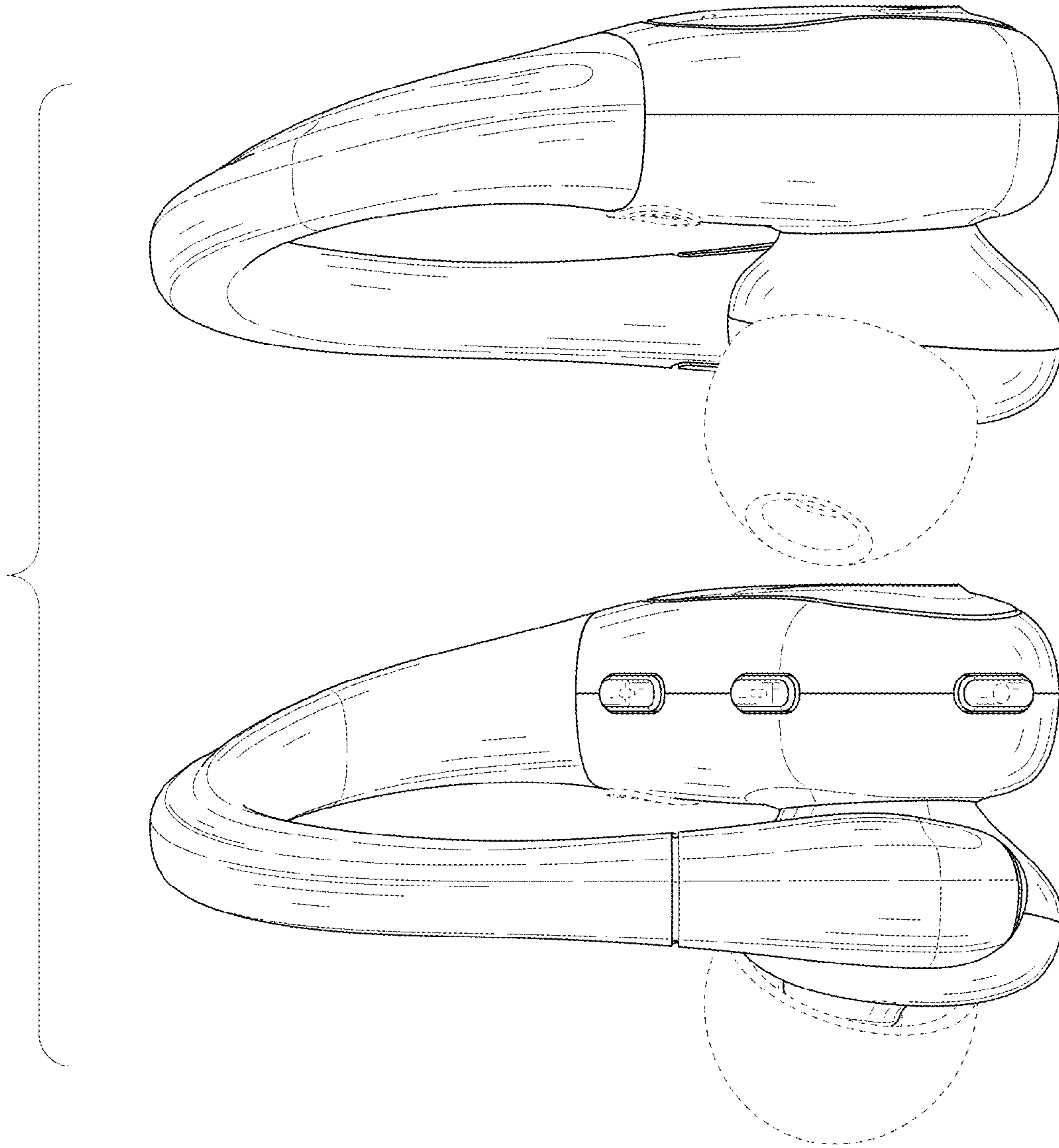

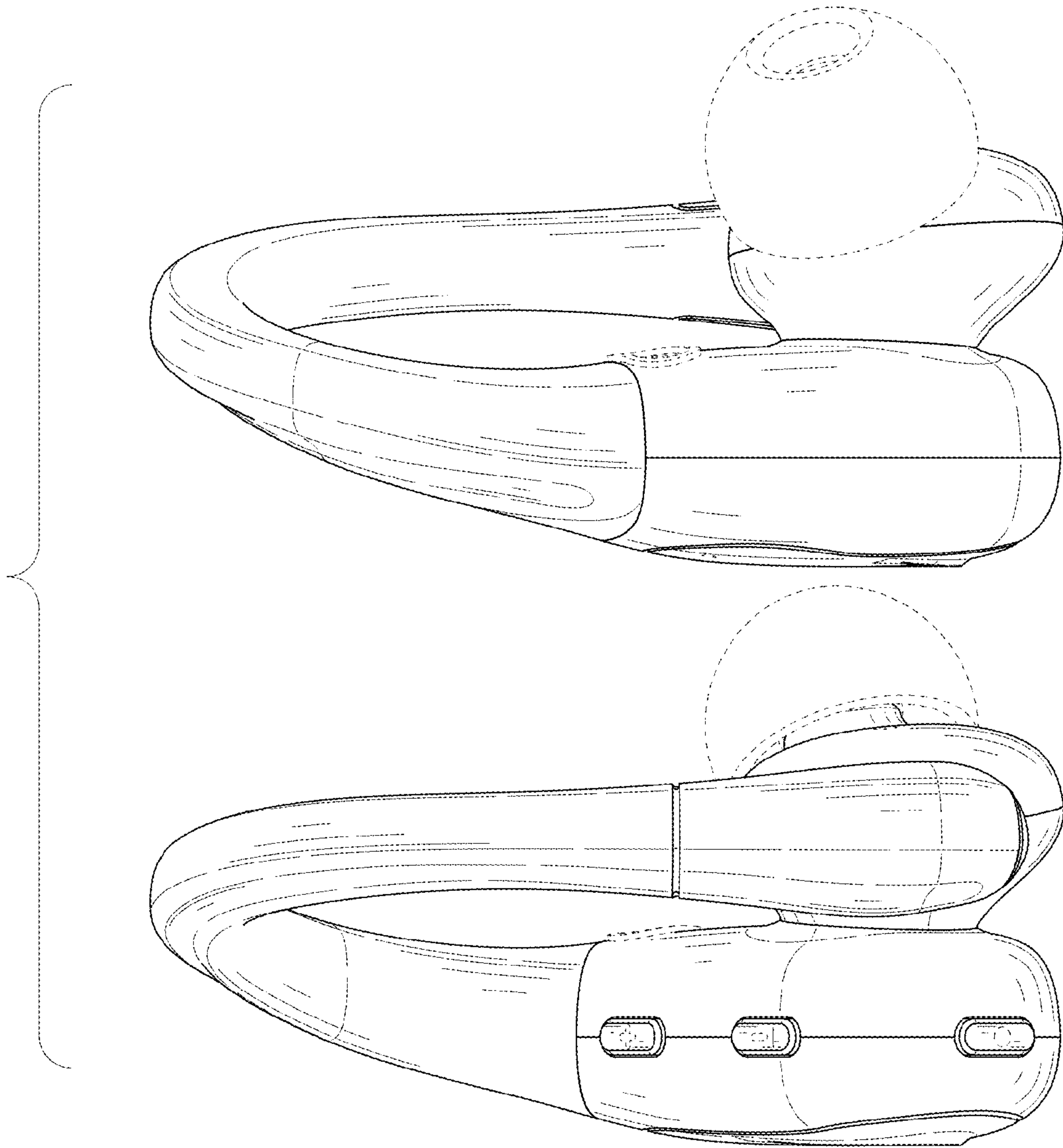

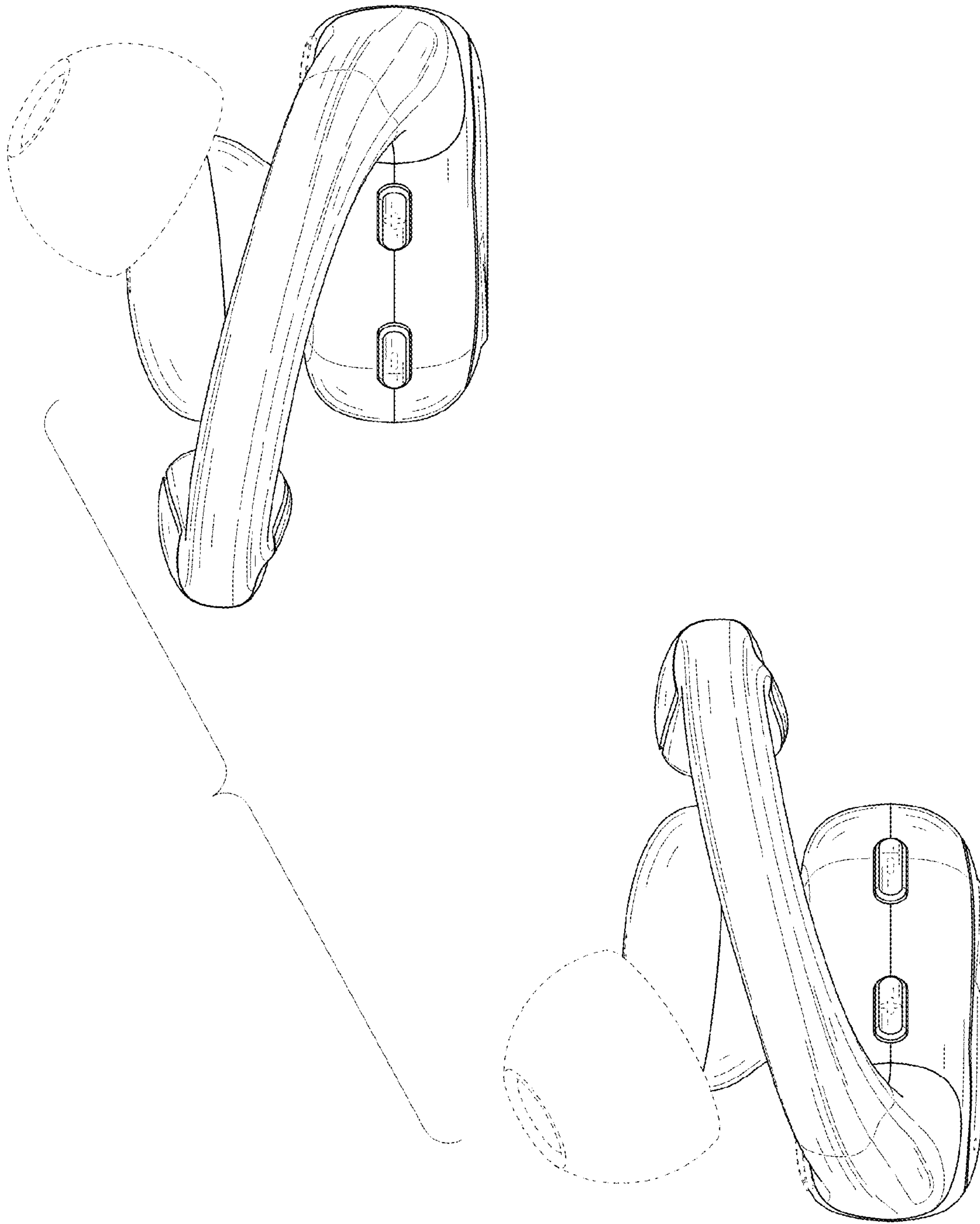

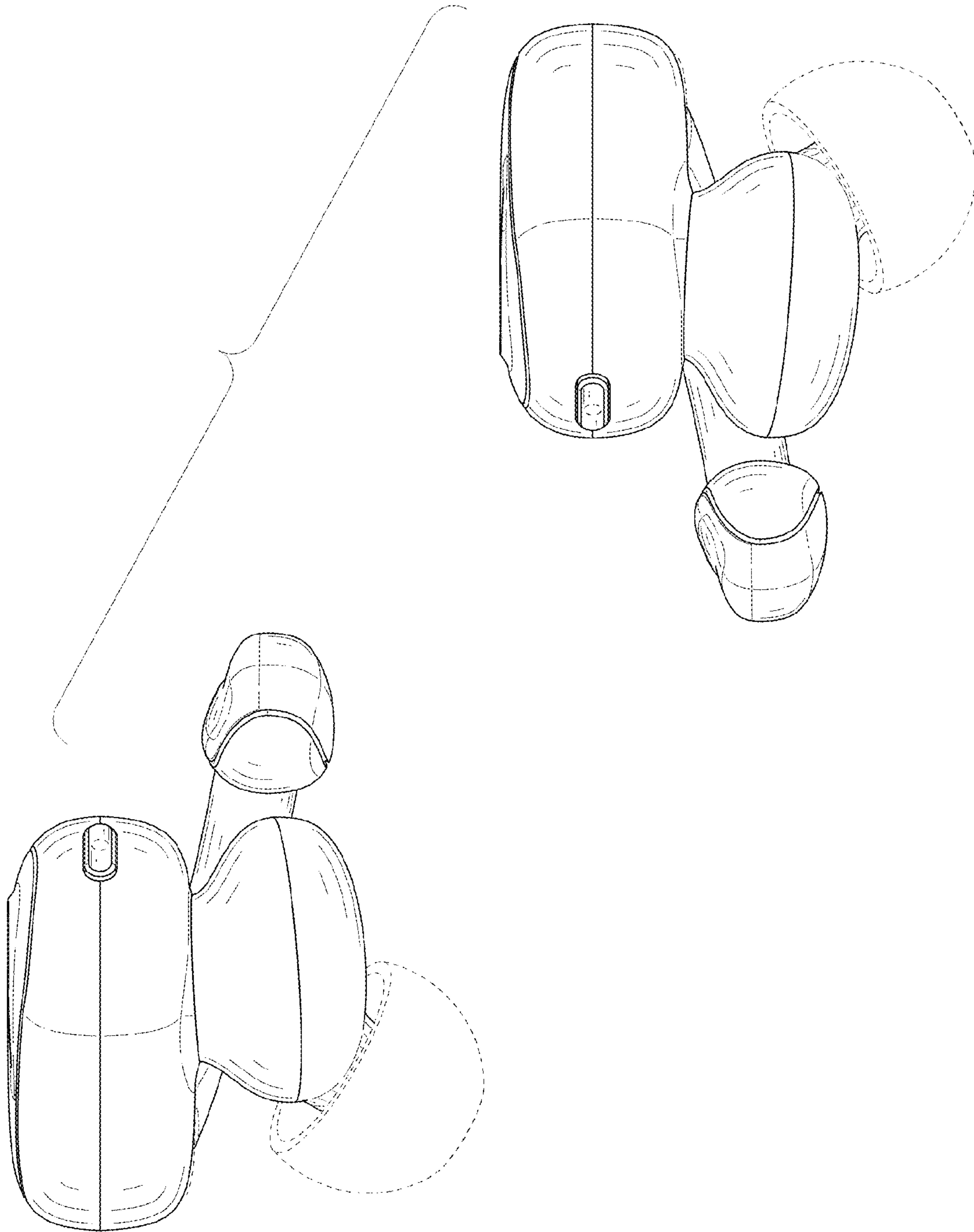

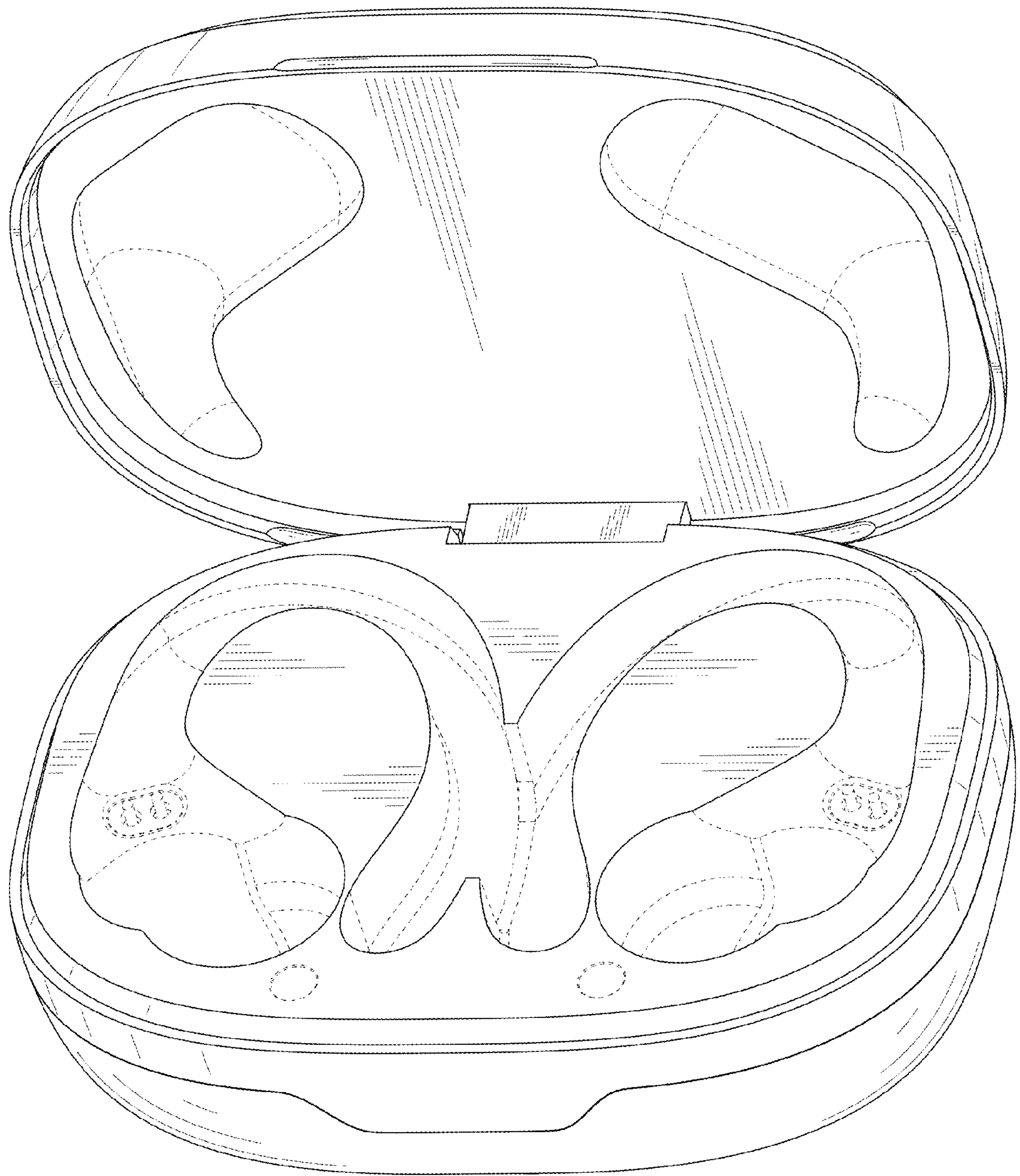

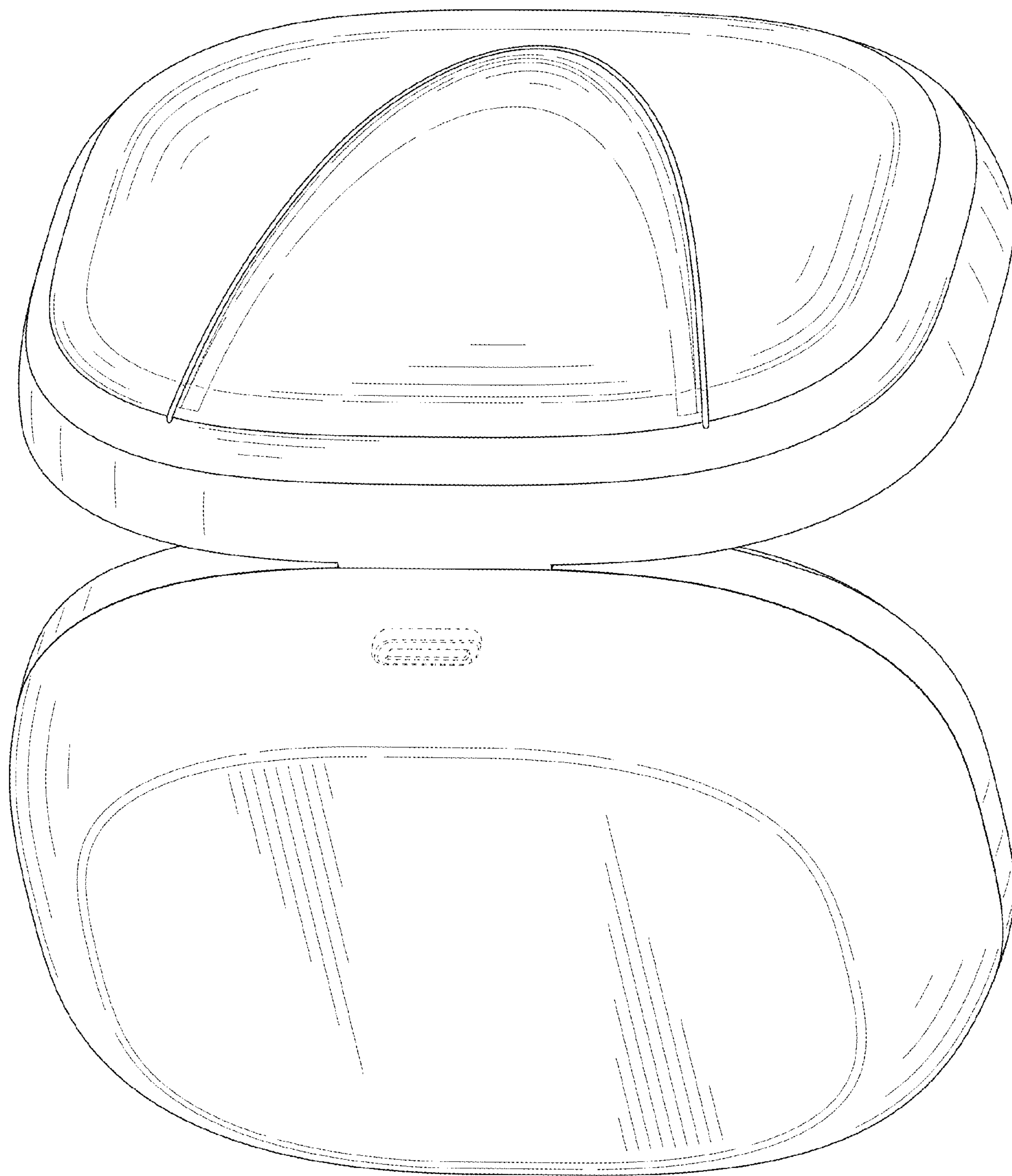

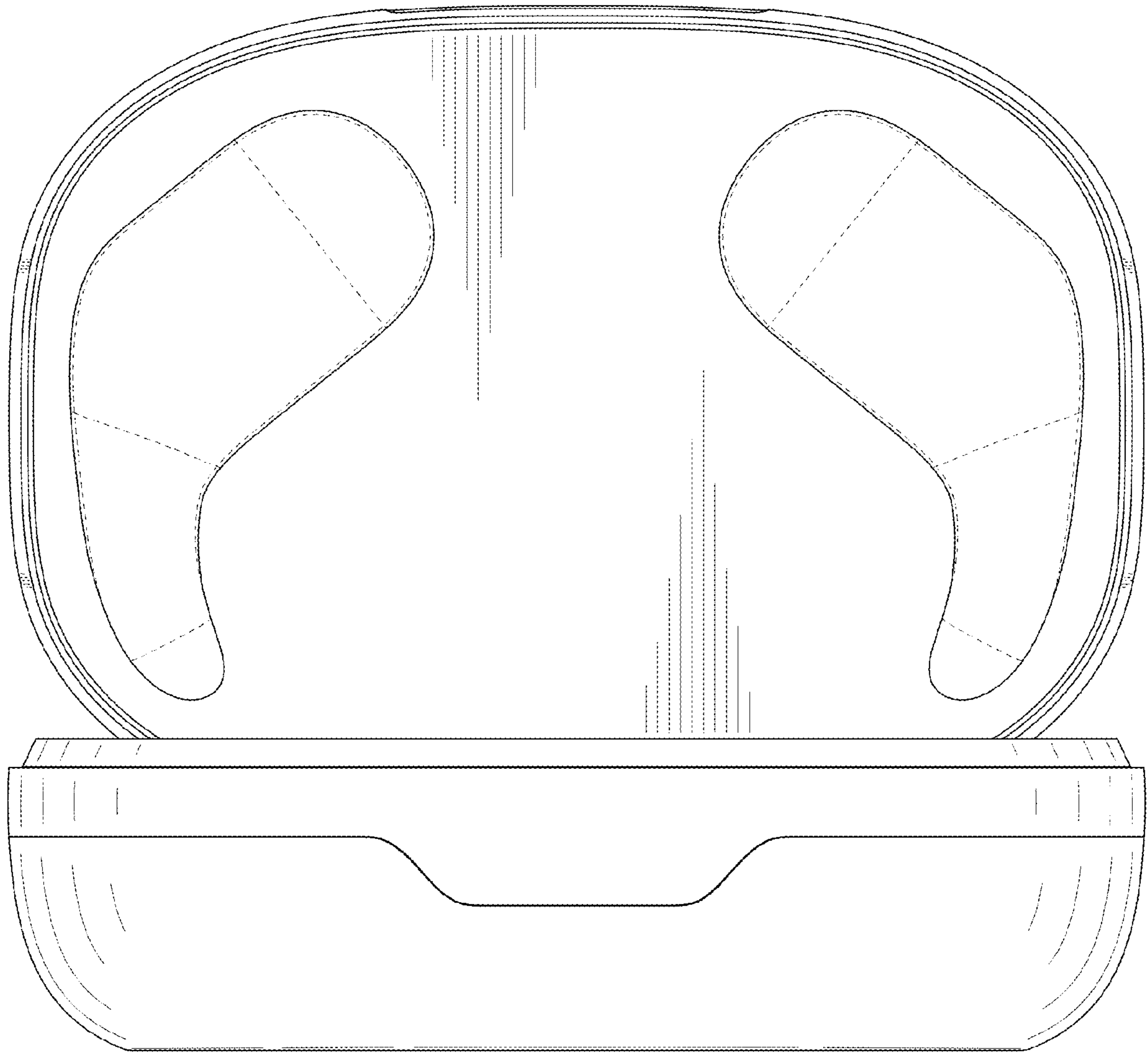

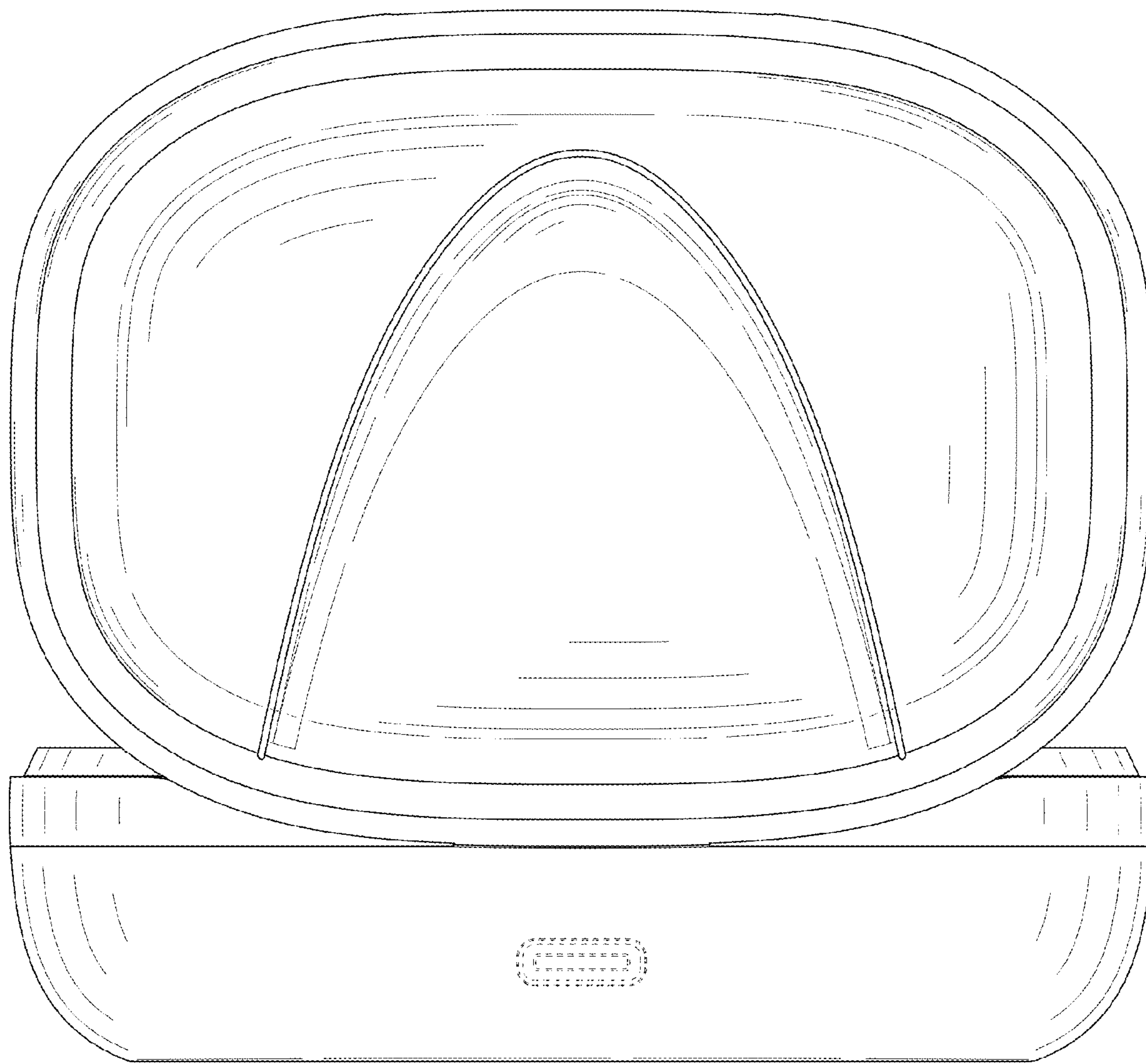

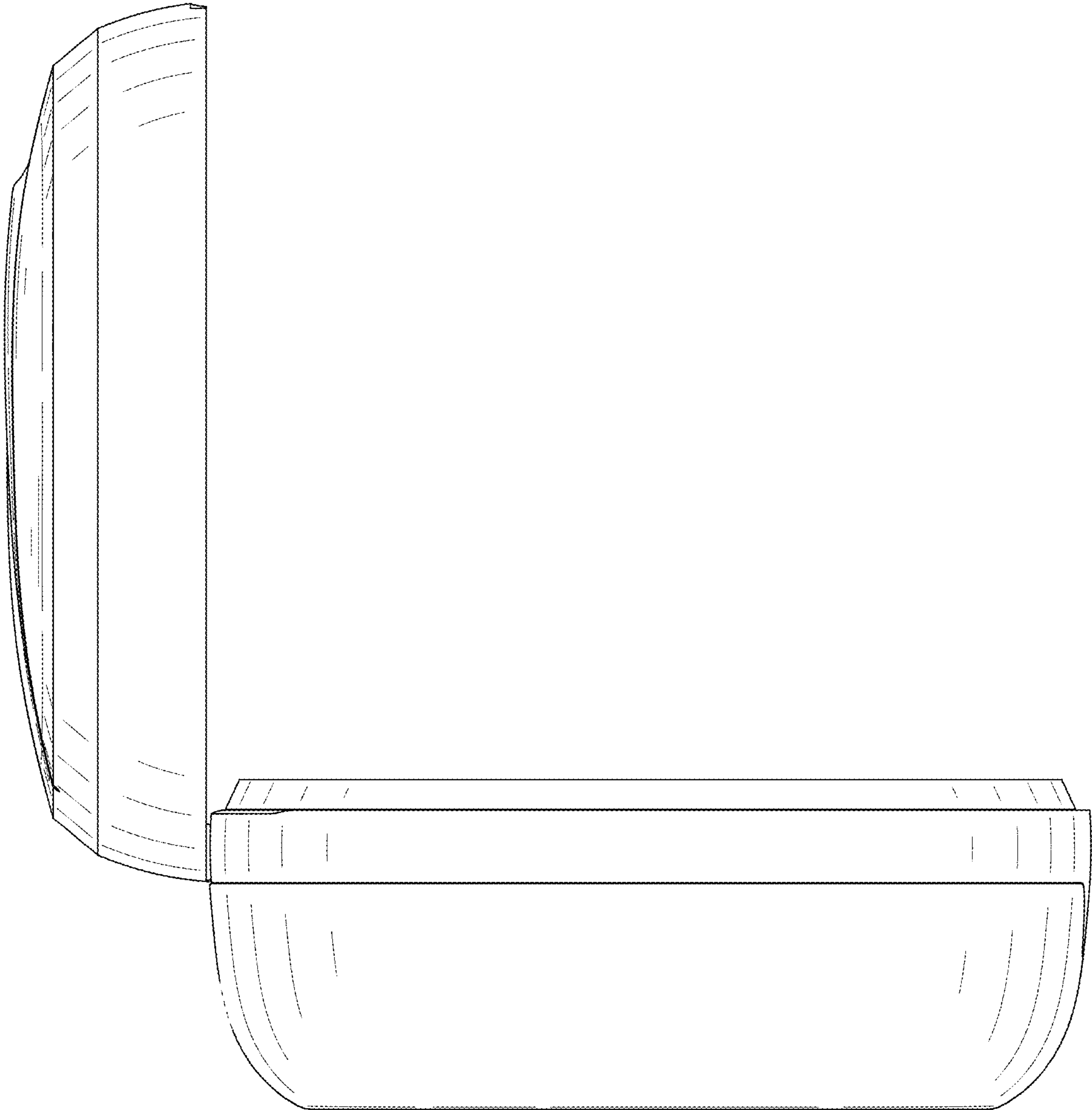

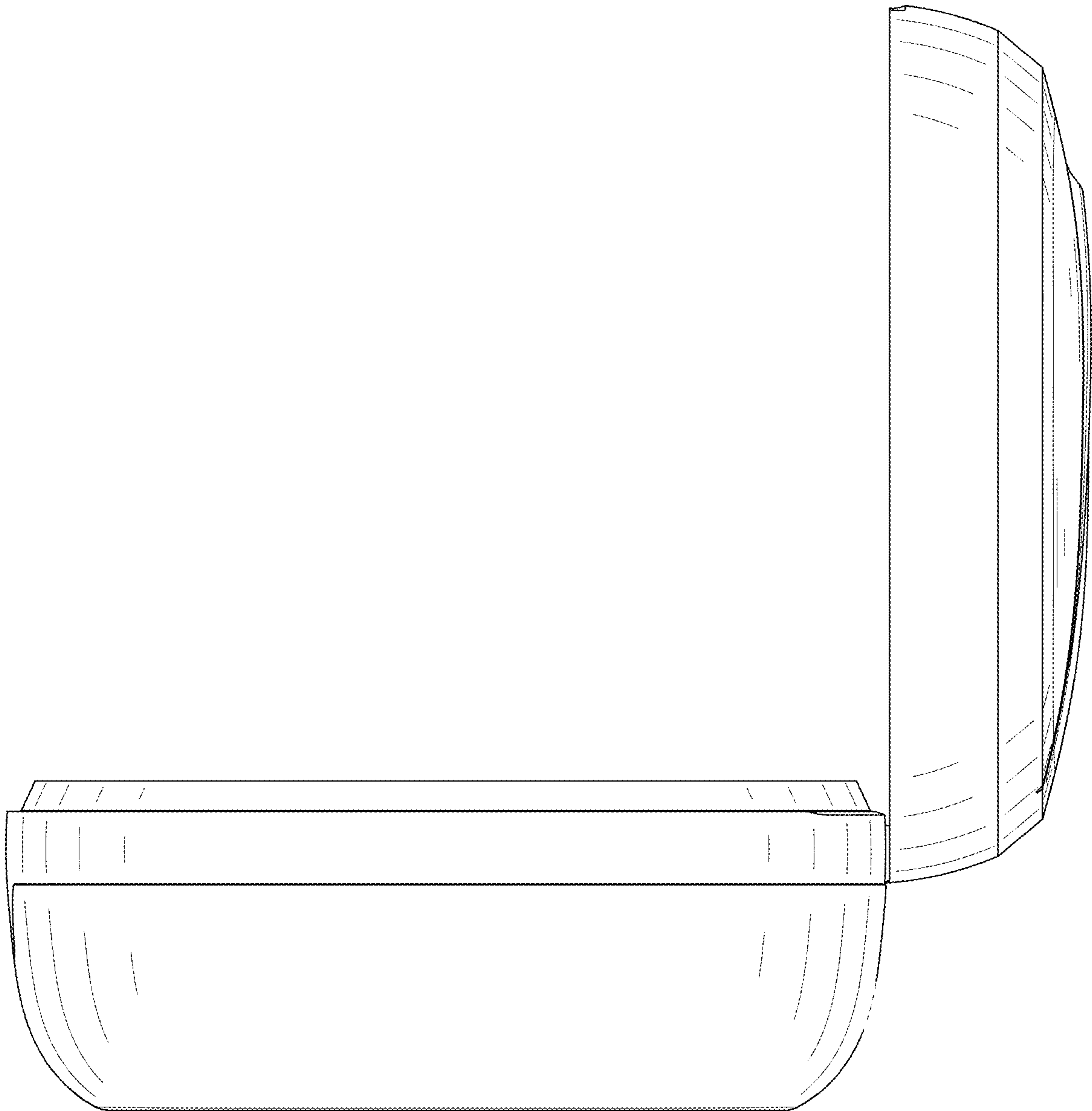

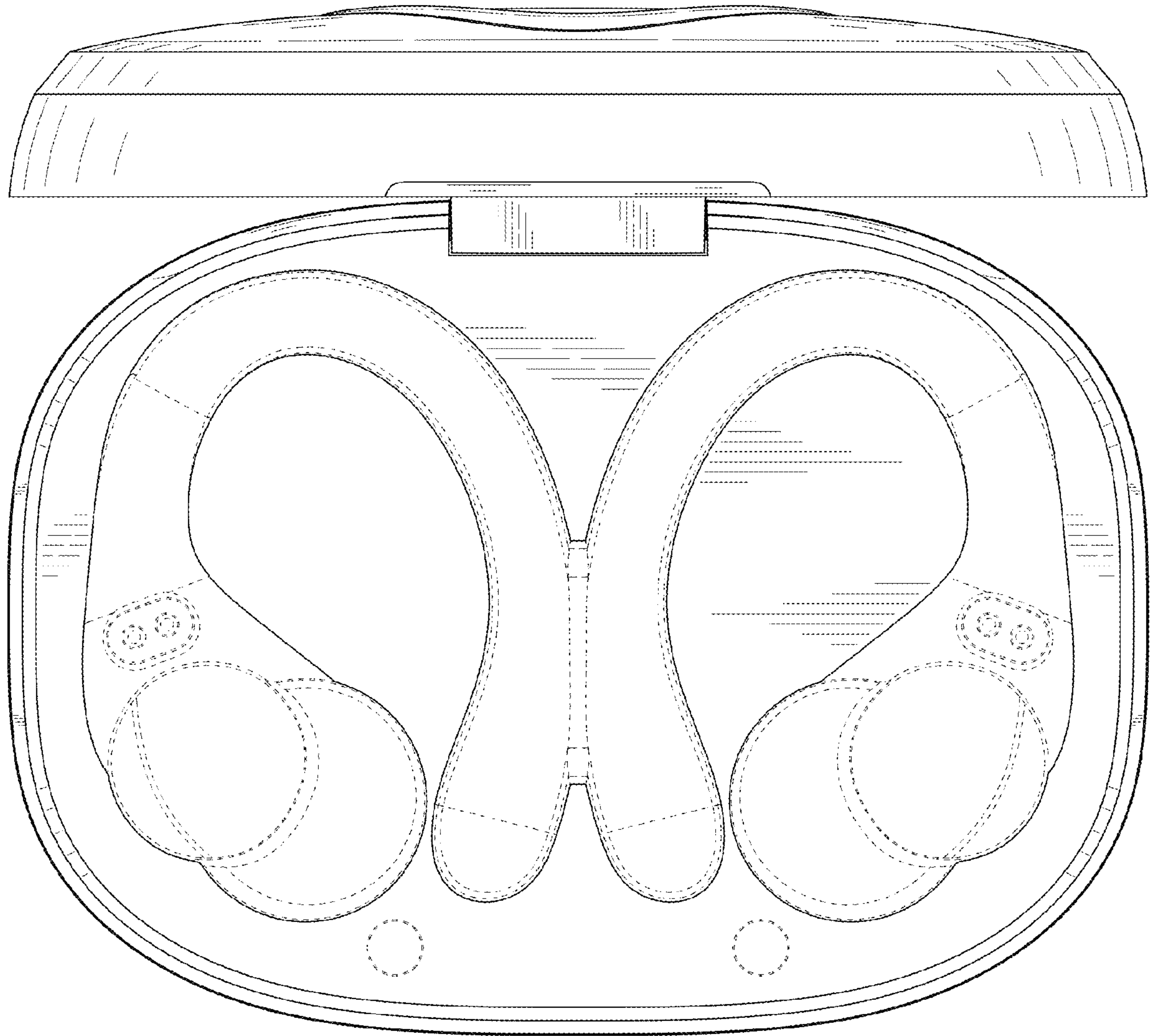

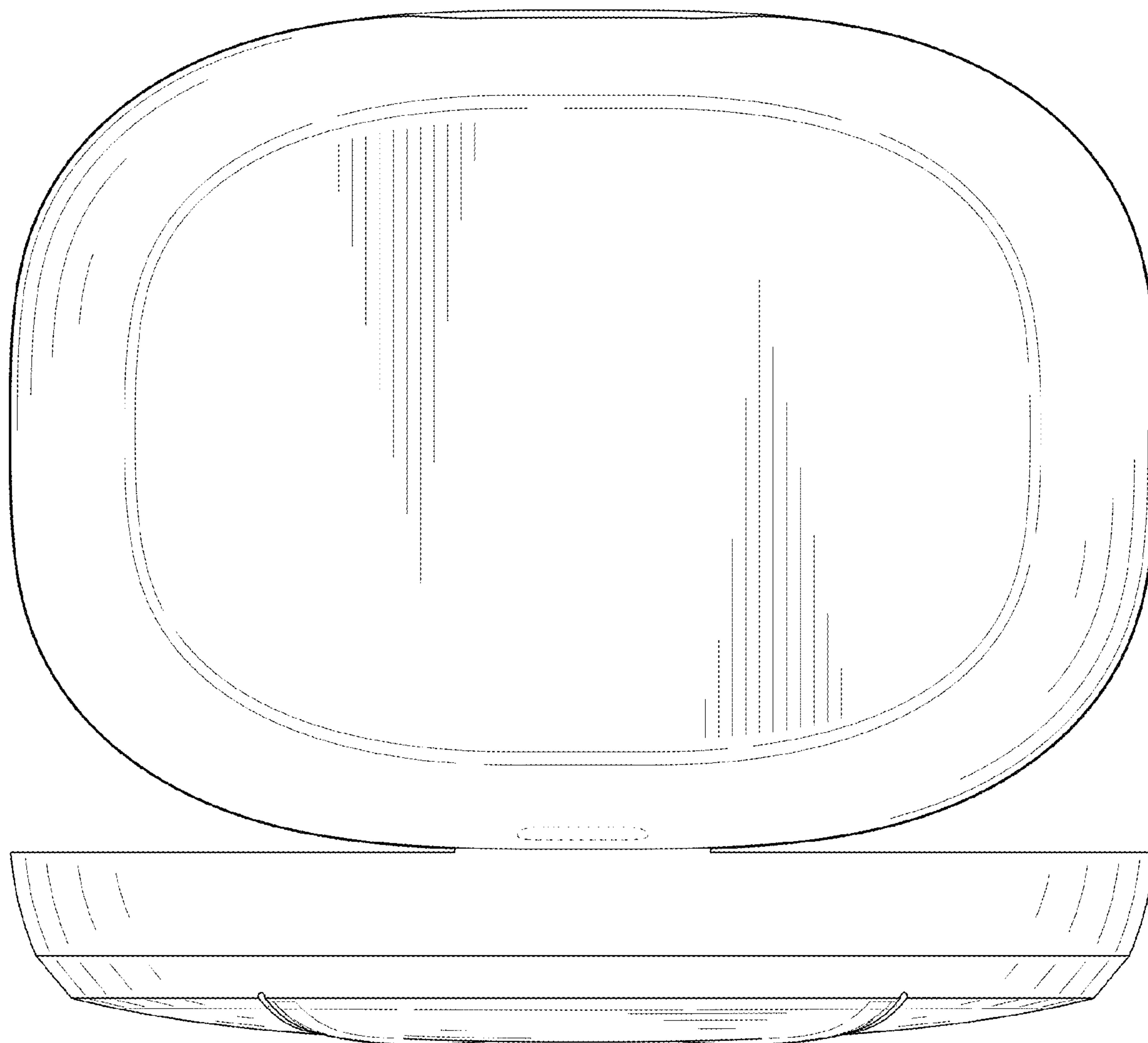

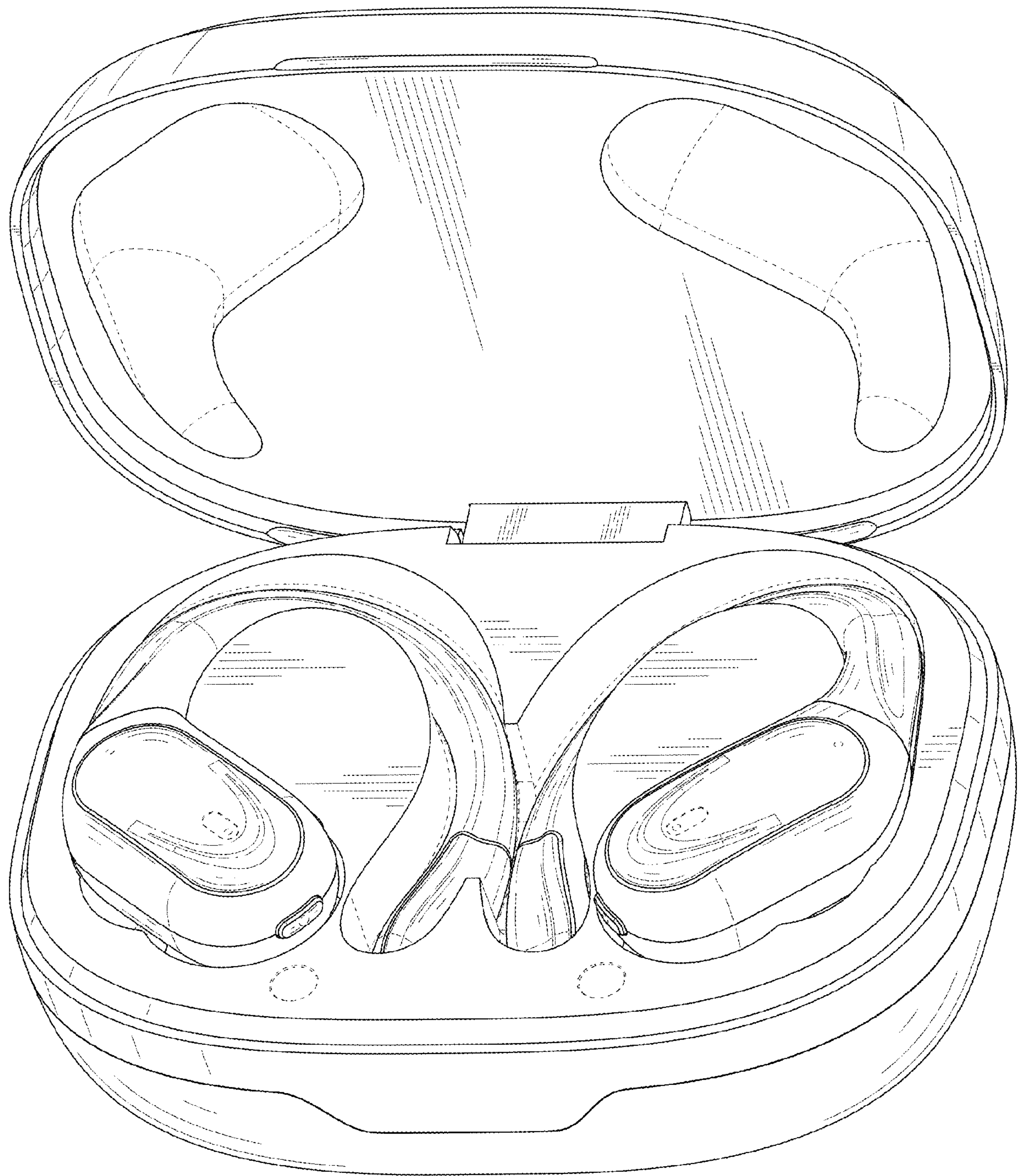

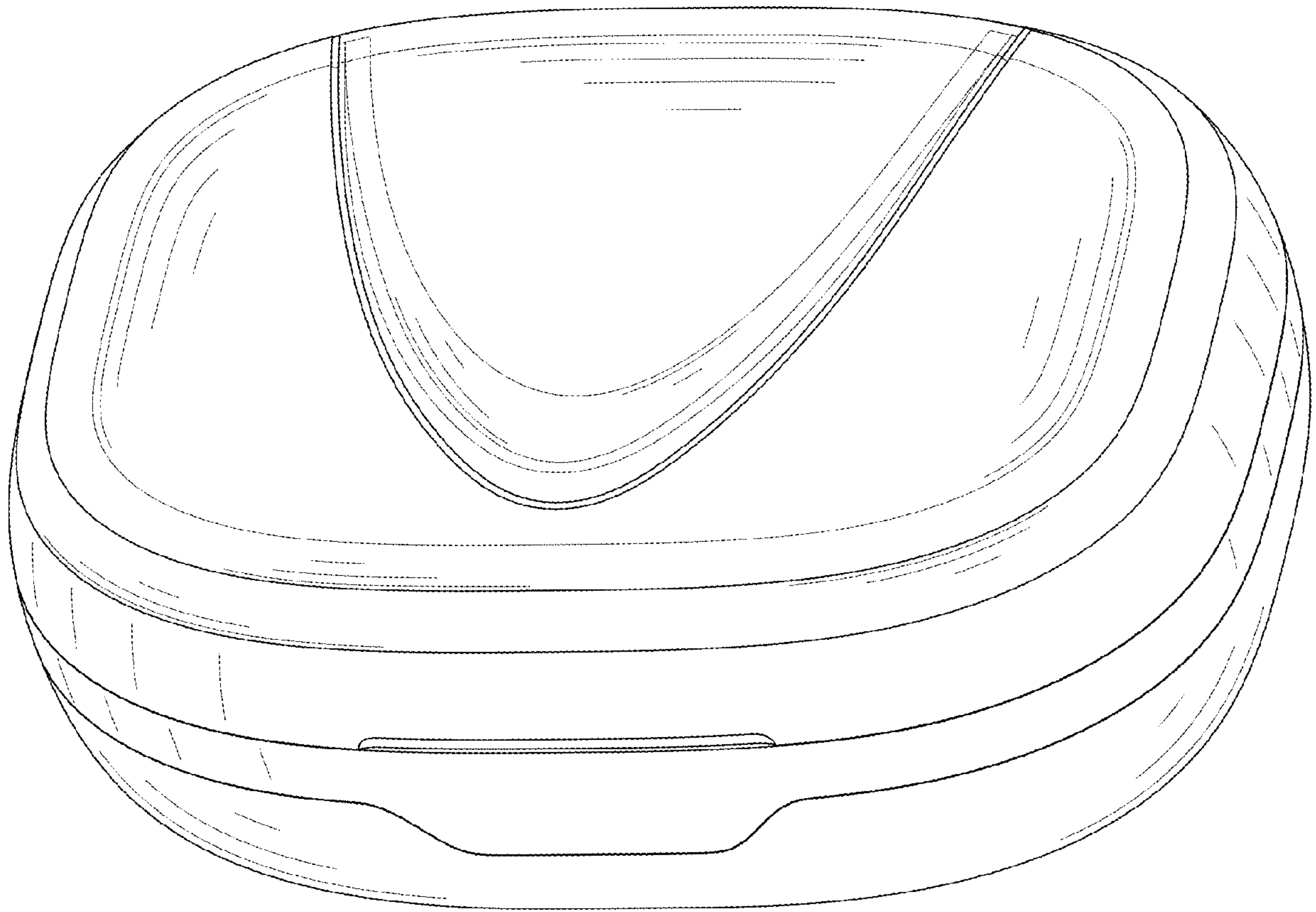
