(57) **CLAIM**

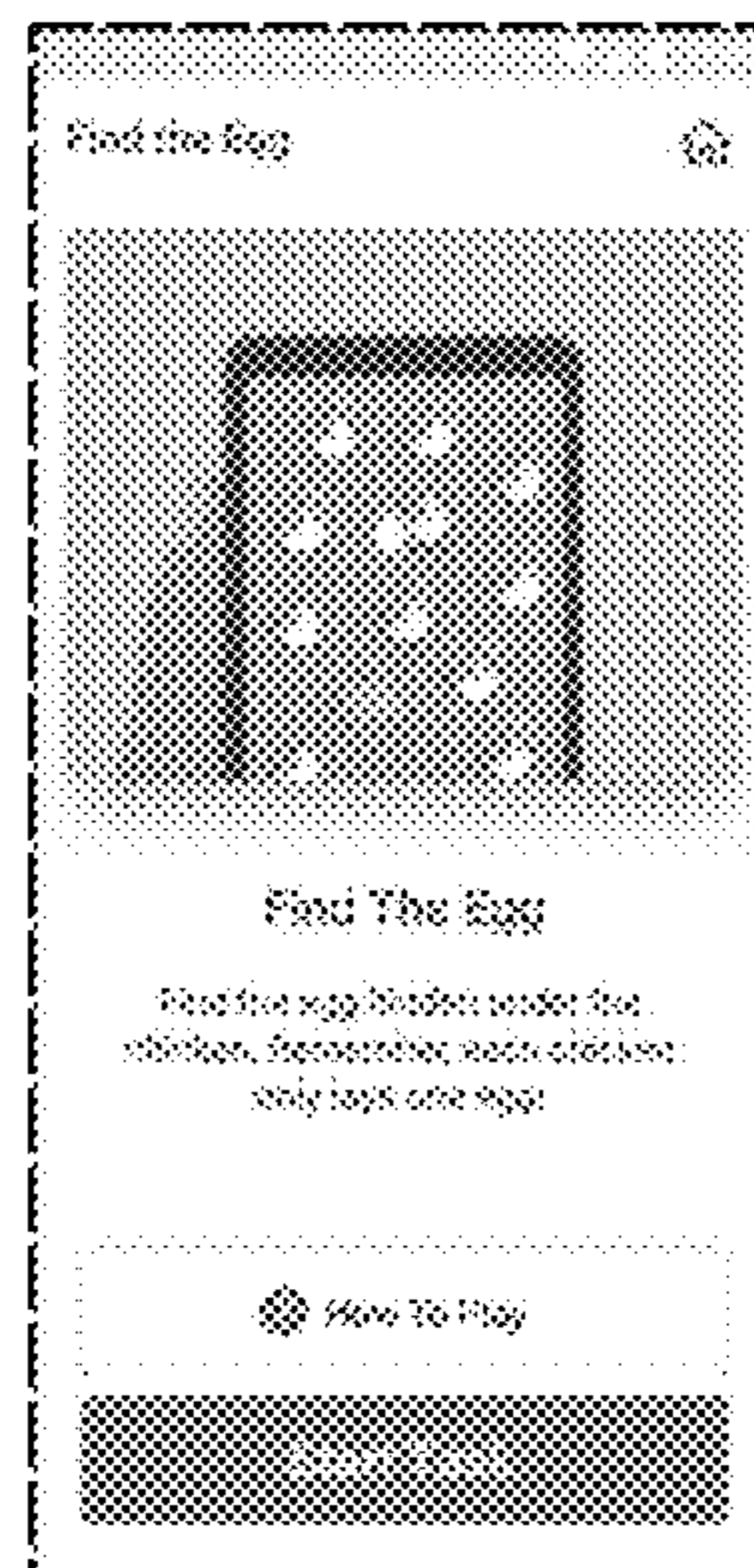
The ornamental design for a portion of a display screen with a graphical user interface, as shown and described.
