DESCRIPTION

FIG. 1 is a perspective view of the toothbar of my new
design.

FIG. 2 is a top plan view of the toothbar of FIG. 1.

FIG. 3 is a bottom plan view of the toothbar of FIG. 1.

FIG. 4 is a left side elevation view of the toothbar of FIG.
1.

FIG. 5 is a right side elevation view of the toothbar of FIG.
1.

FIG. 6 is a front end view of the toothbar of FIG. 1.

FIG. 7 is a back end view of the toothbar of FIG. 1.

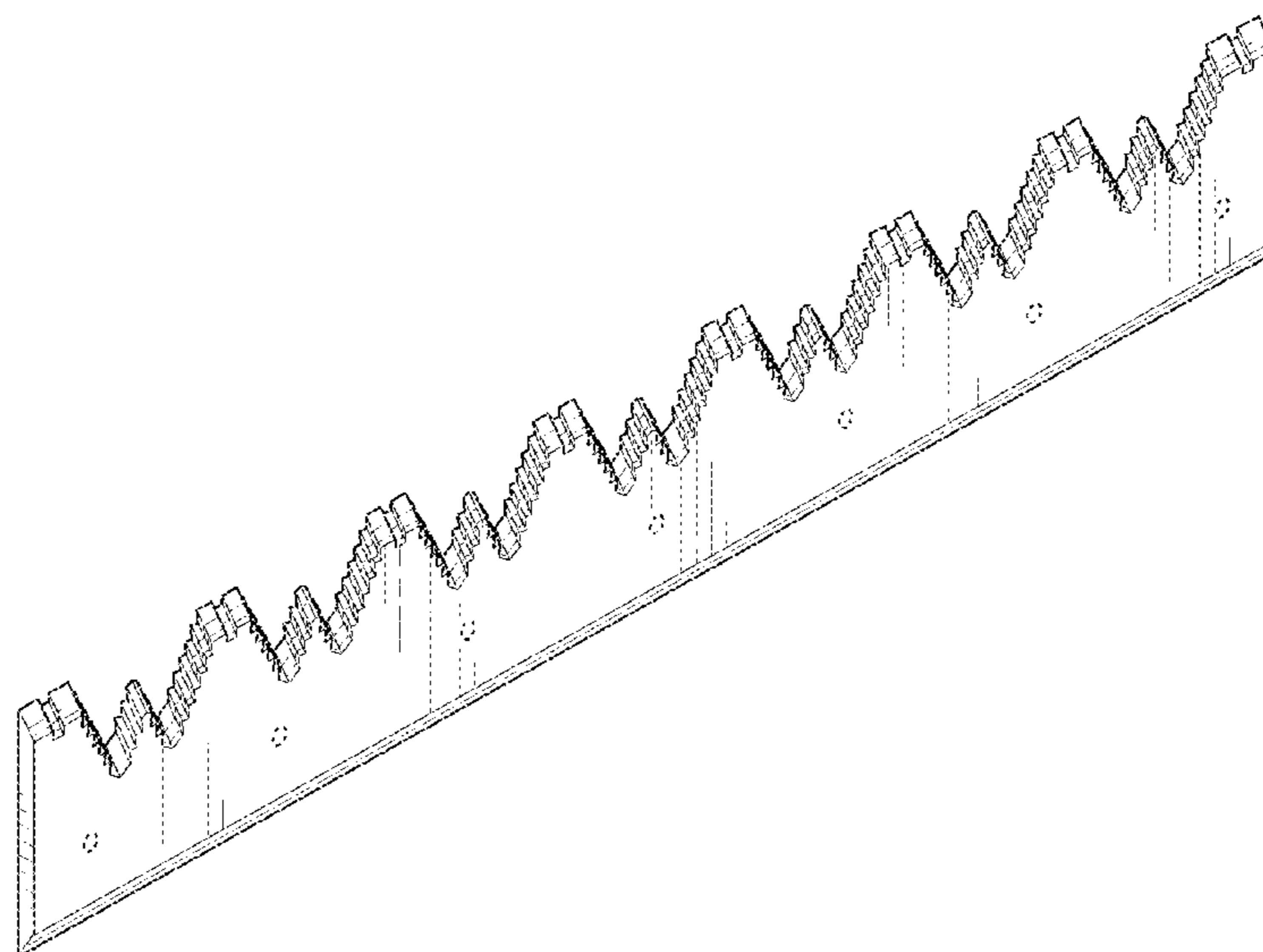
FIG. 8 shows the toothbar in a first exemplary embodiment

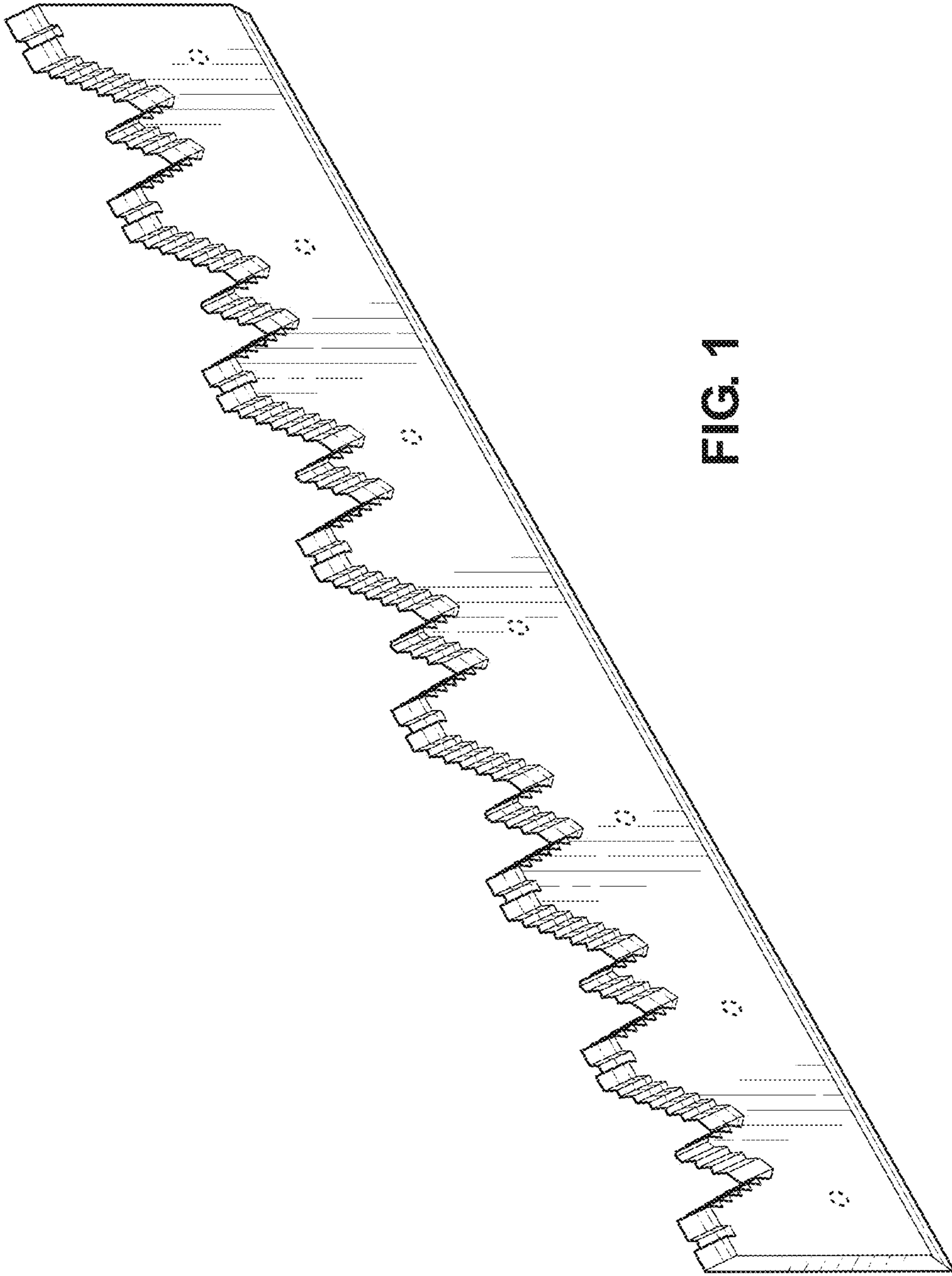

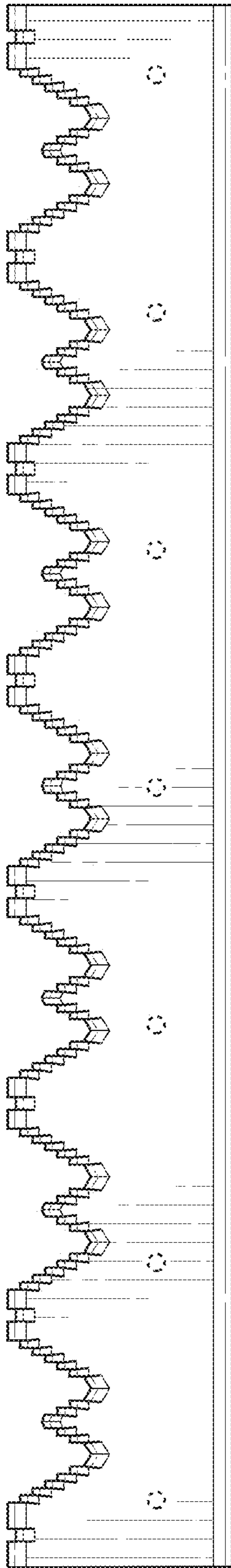

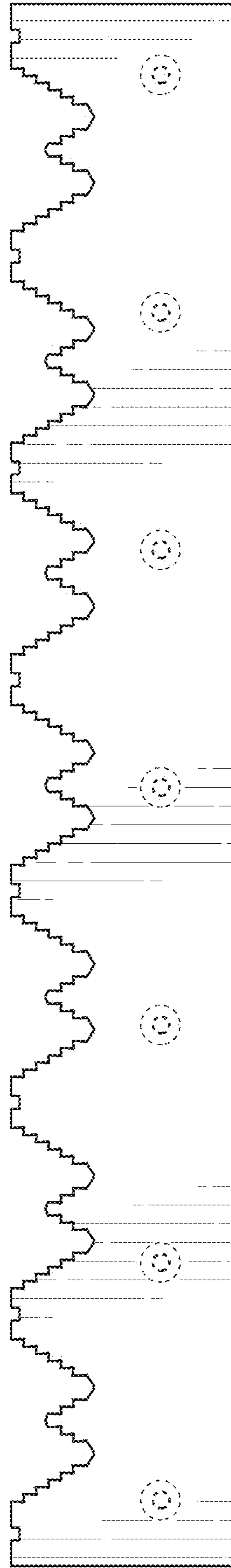

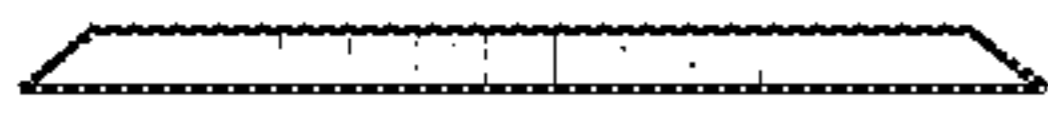

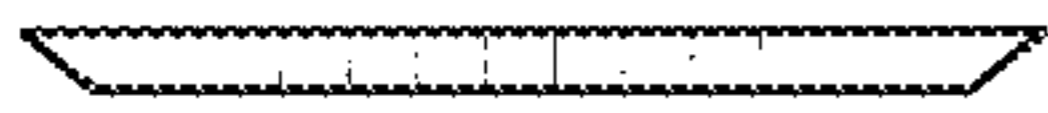

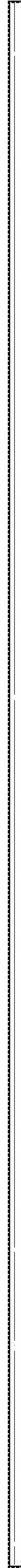

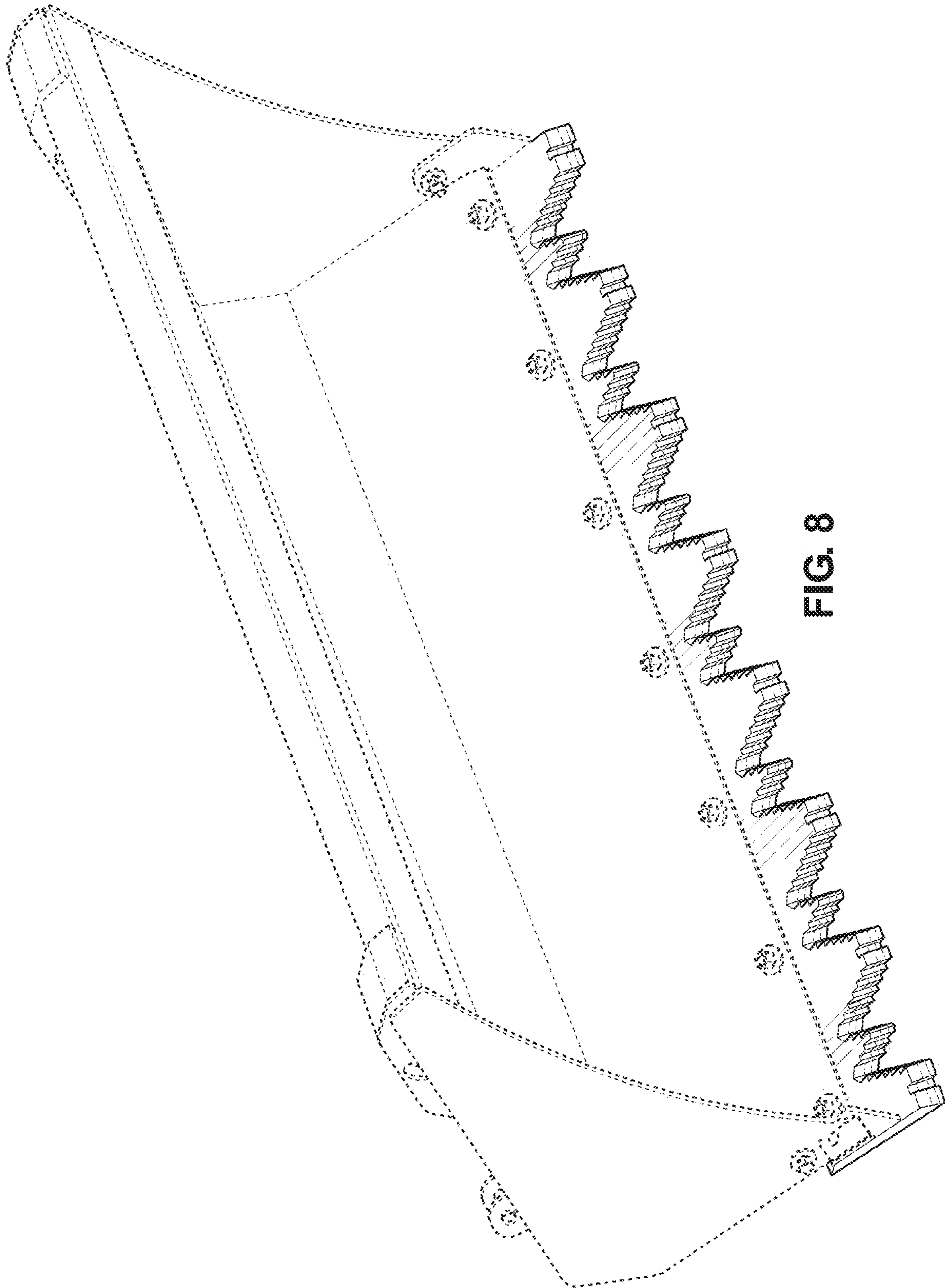
