(57) **CLAIM**

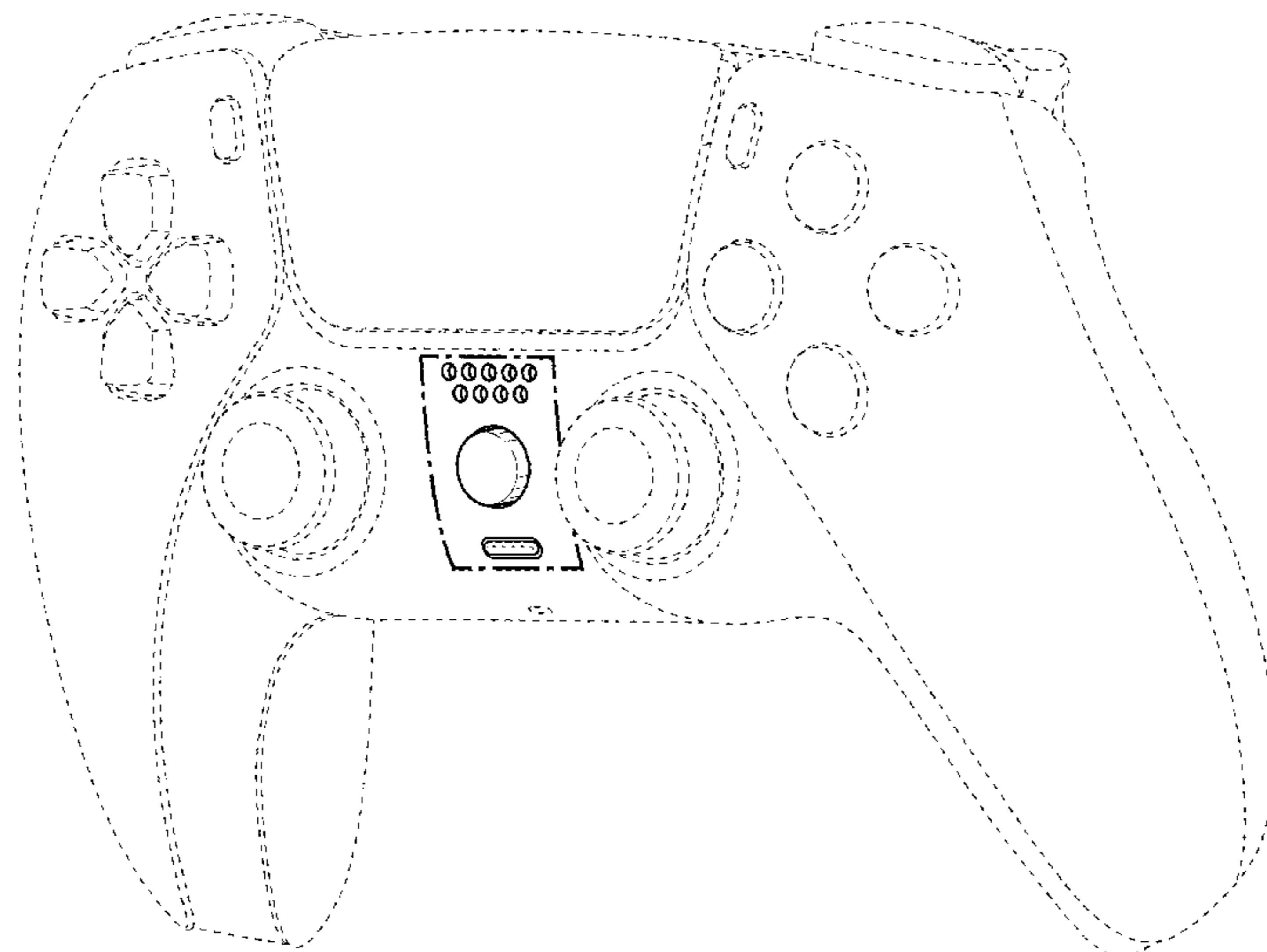
The ornamental design for a controller for electronic device, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of front and right side of a controller for electronic device showing our new design; FIG. 2 is a perspective view of rear and left side thereof; FIG. 3 is a front view thereof; FIG. 4 is a rear view thereof; FIG. 5 is a left side view thereof; FIG. 6 is a right side view thereof; FIG. 7 is a top view thereof; and, FIG. 8 is a bottom view thereof.

The short dash-dash lines depict portions of the controller for electronic device that form no part of the claimed design. The long-short dashed lines illustrate bounds of the claim and form not part of the claimed design.

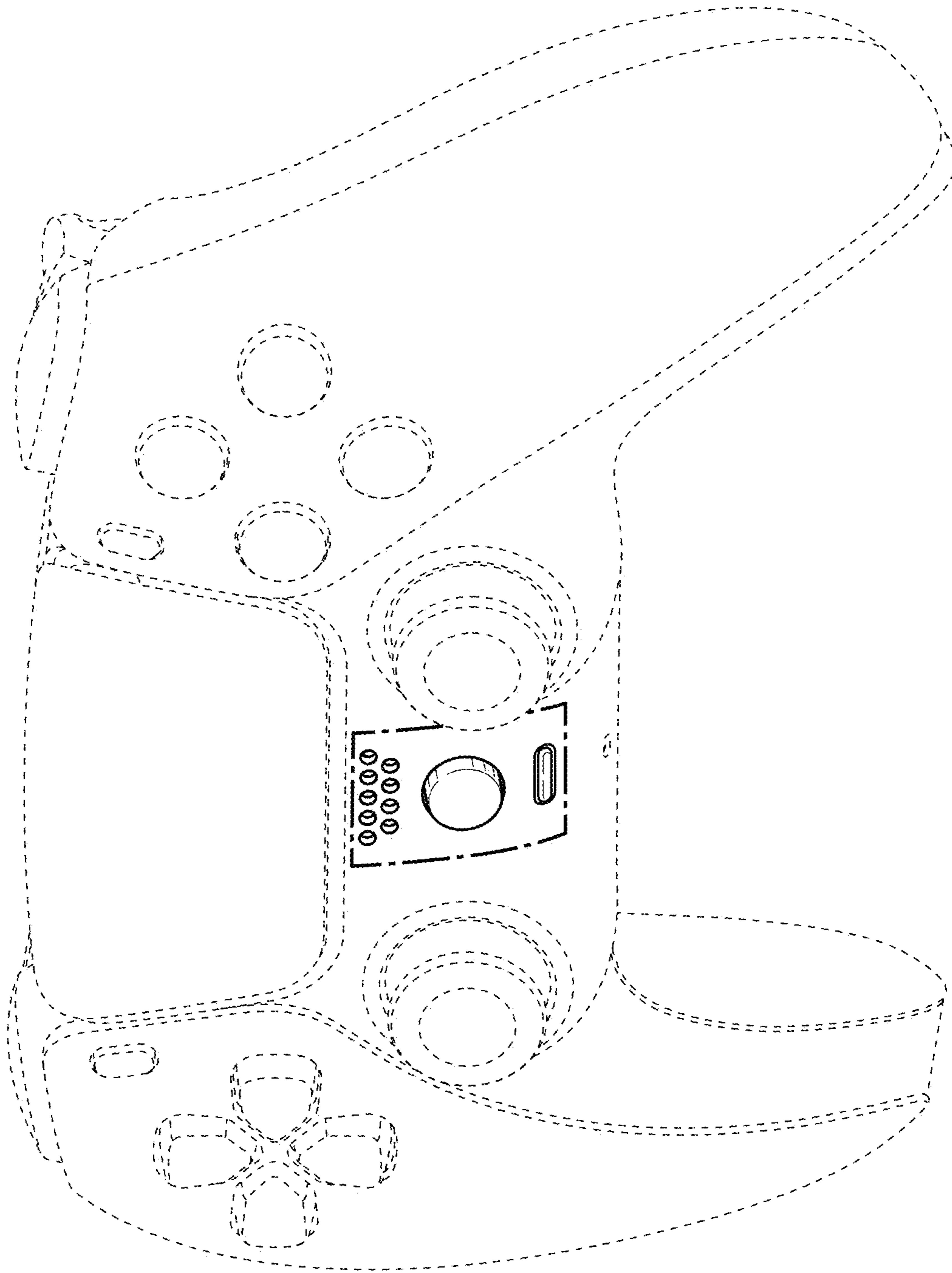

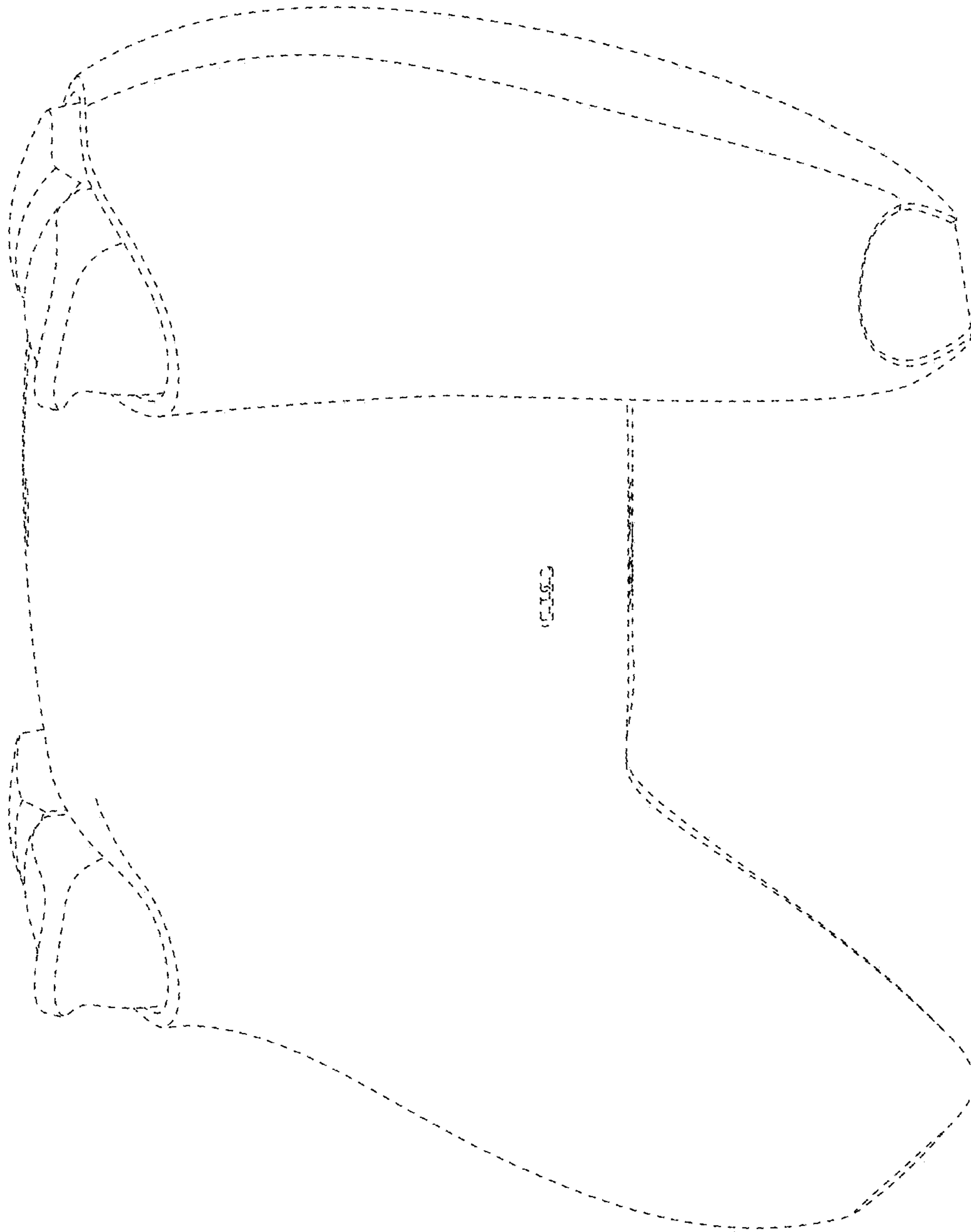

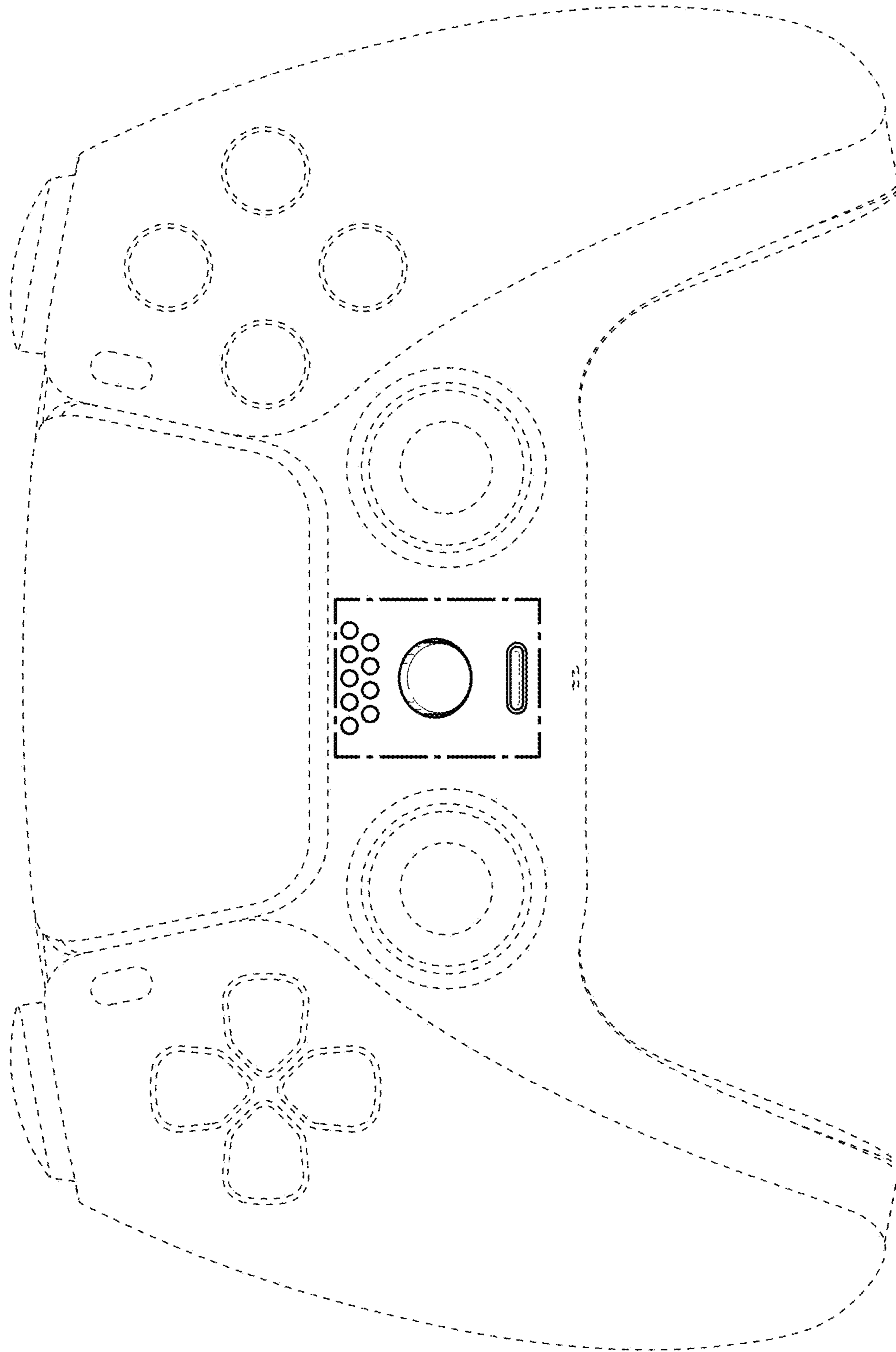
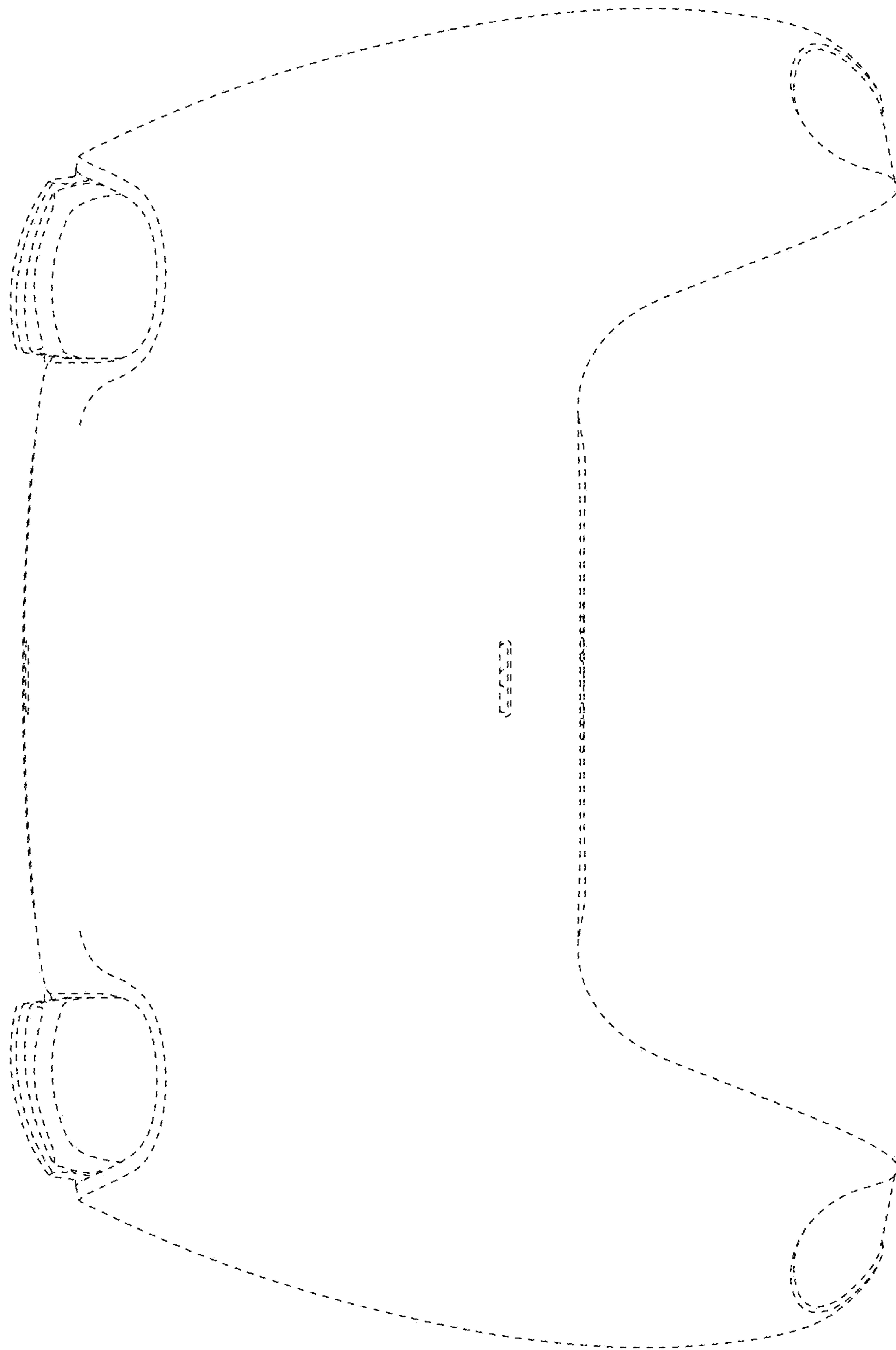

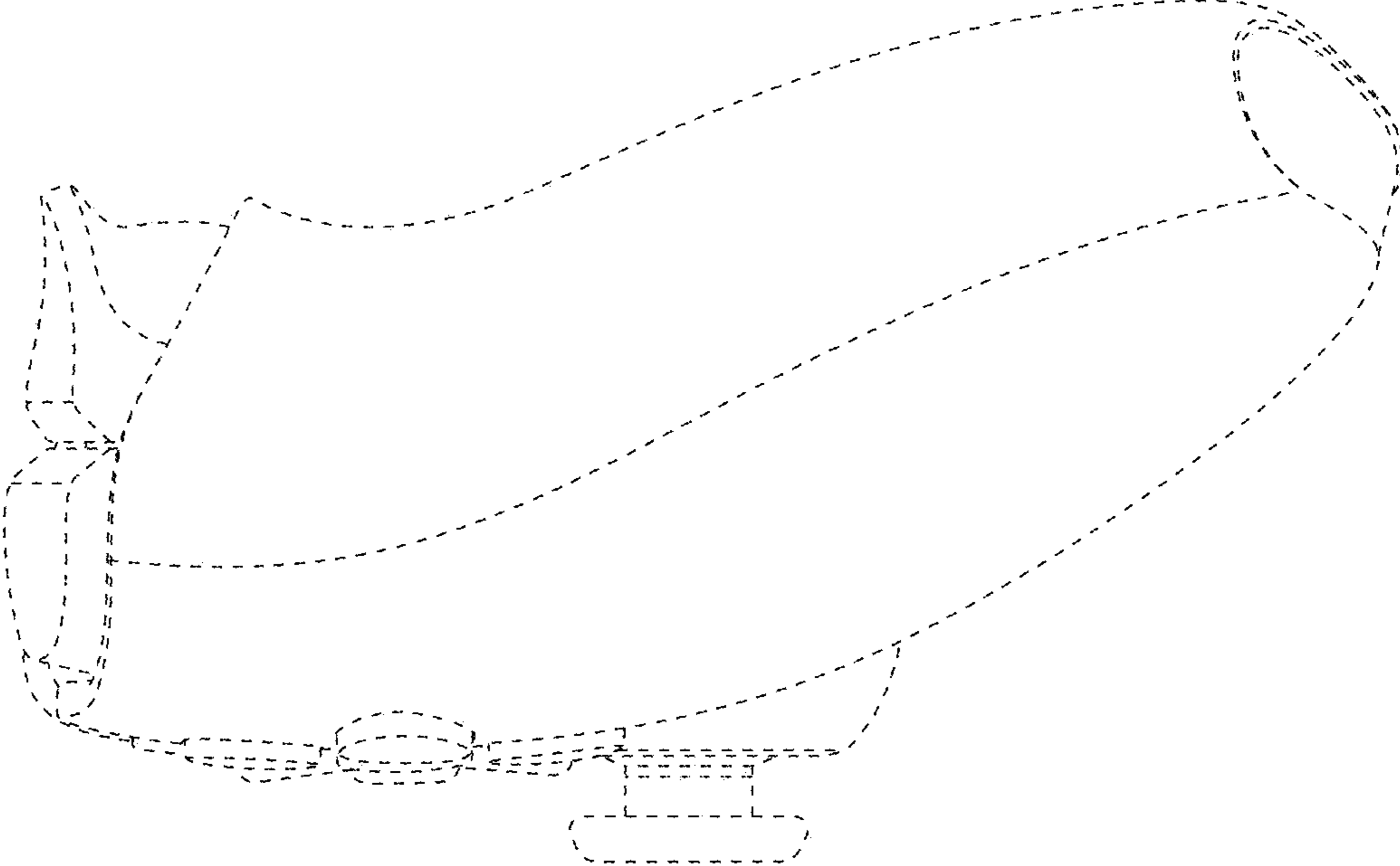

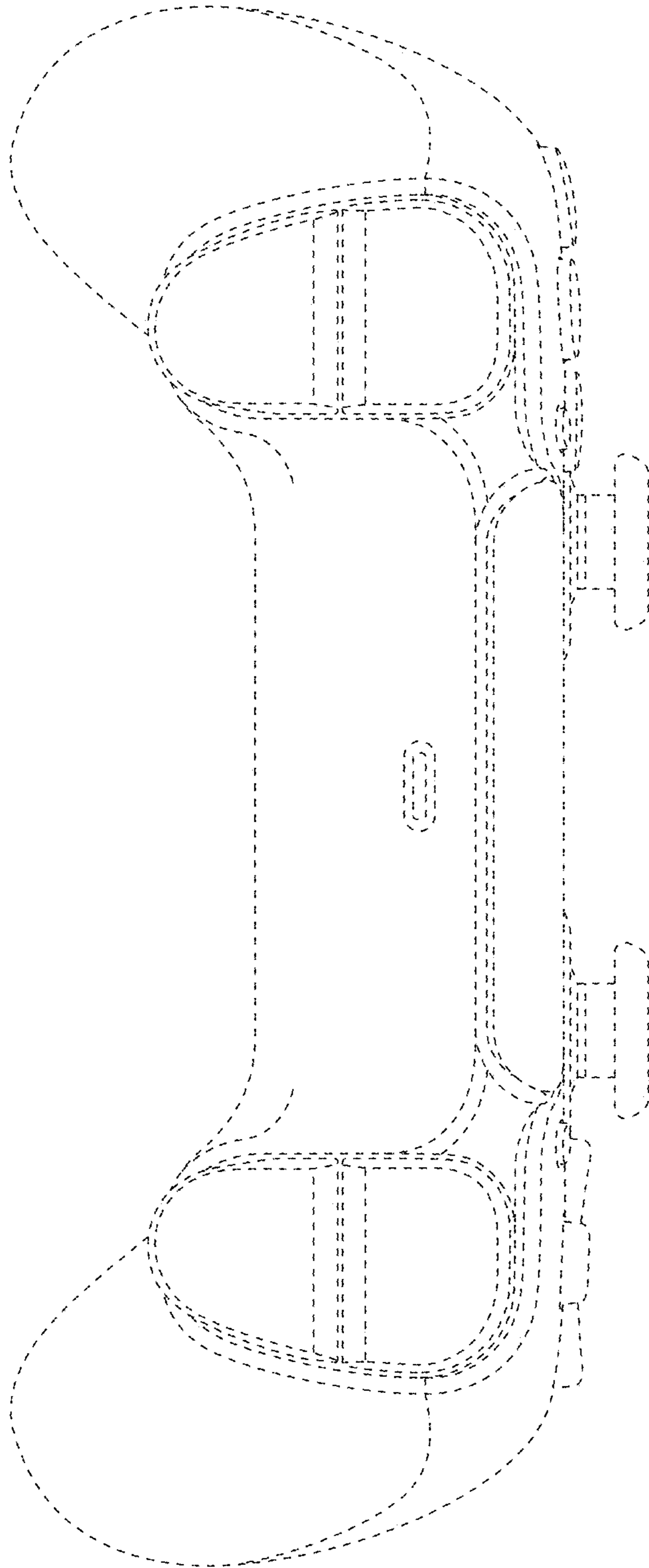

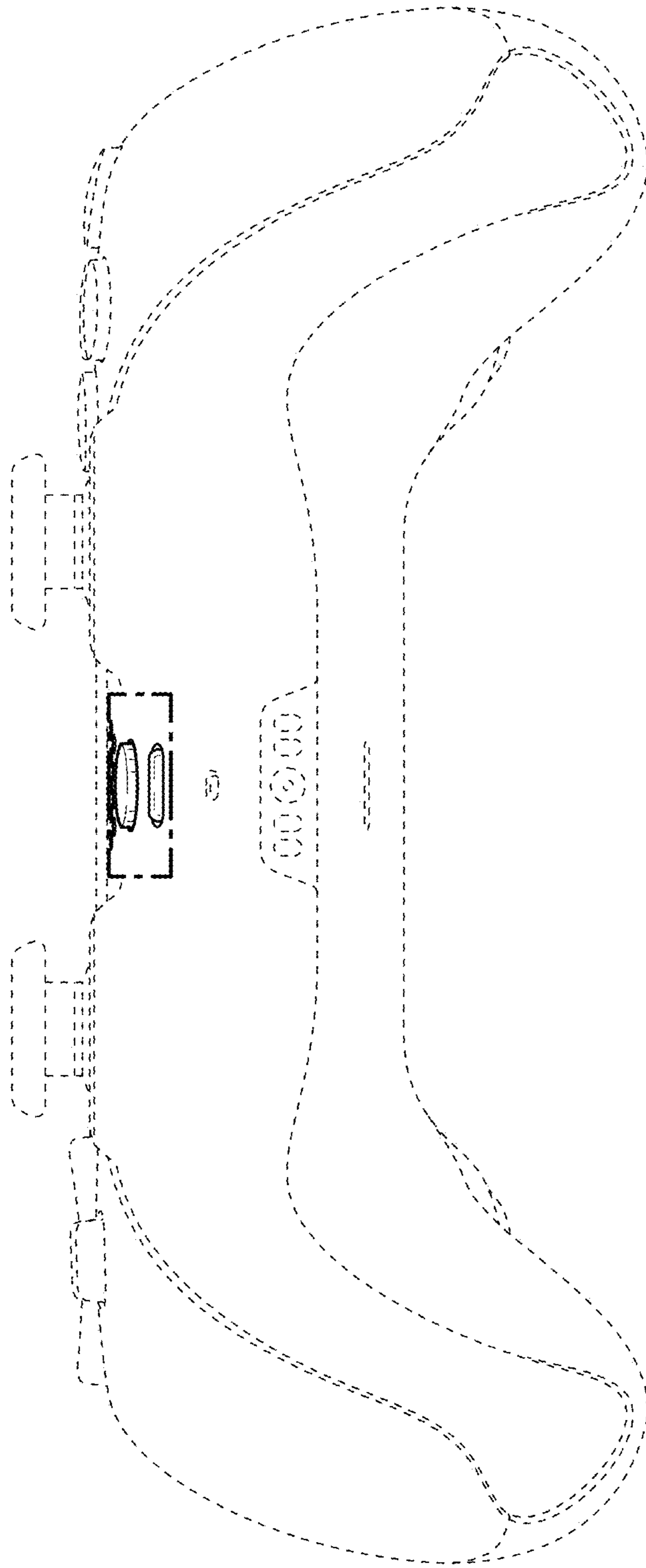
