**DESCRIPTION**

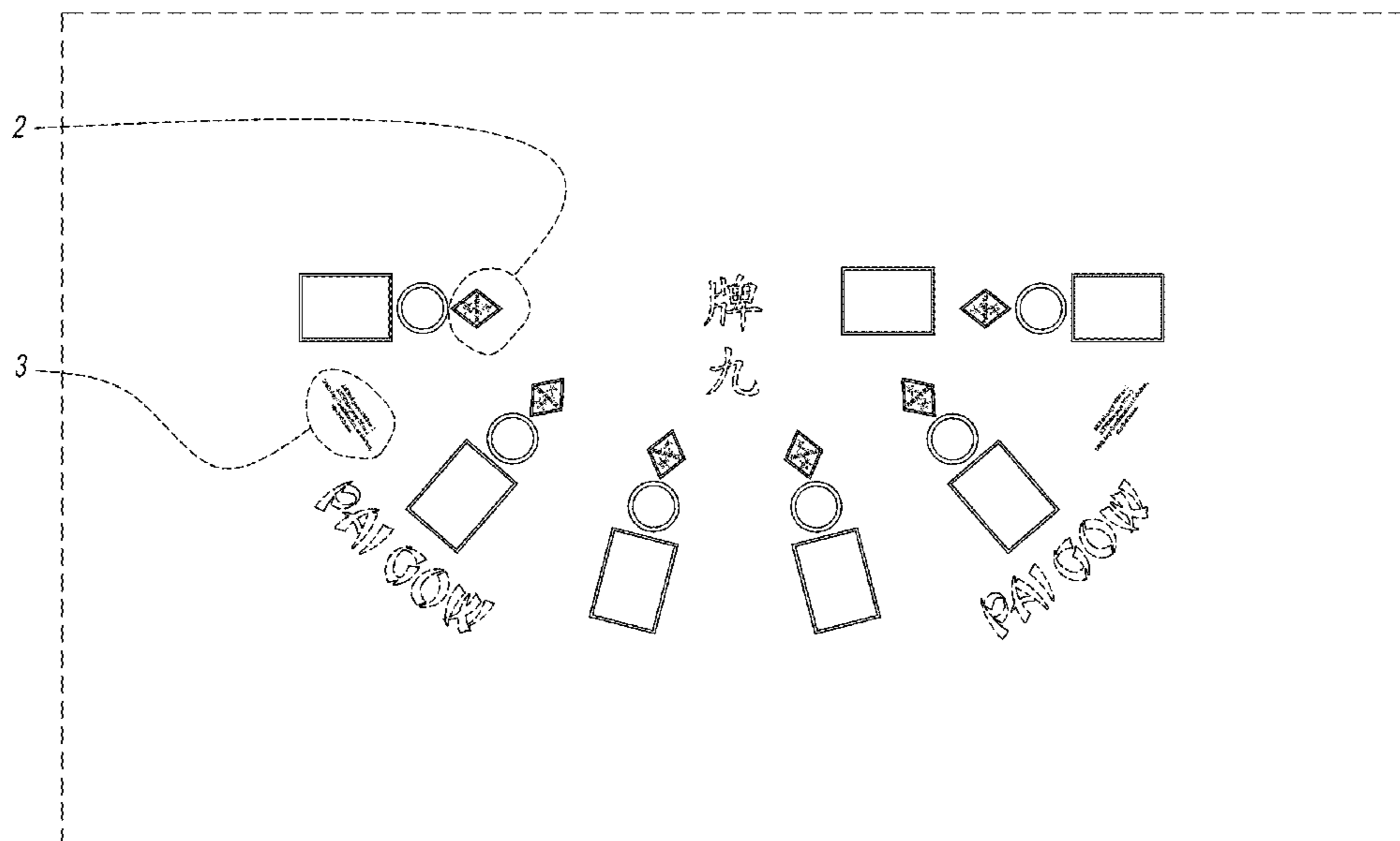
FIG. 1 is a top view of the surface pattern for a casino table in accordance with the subject disclosure;

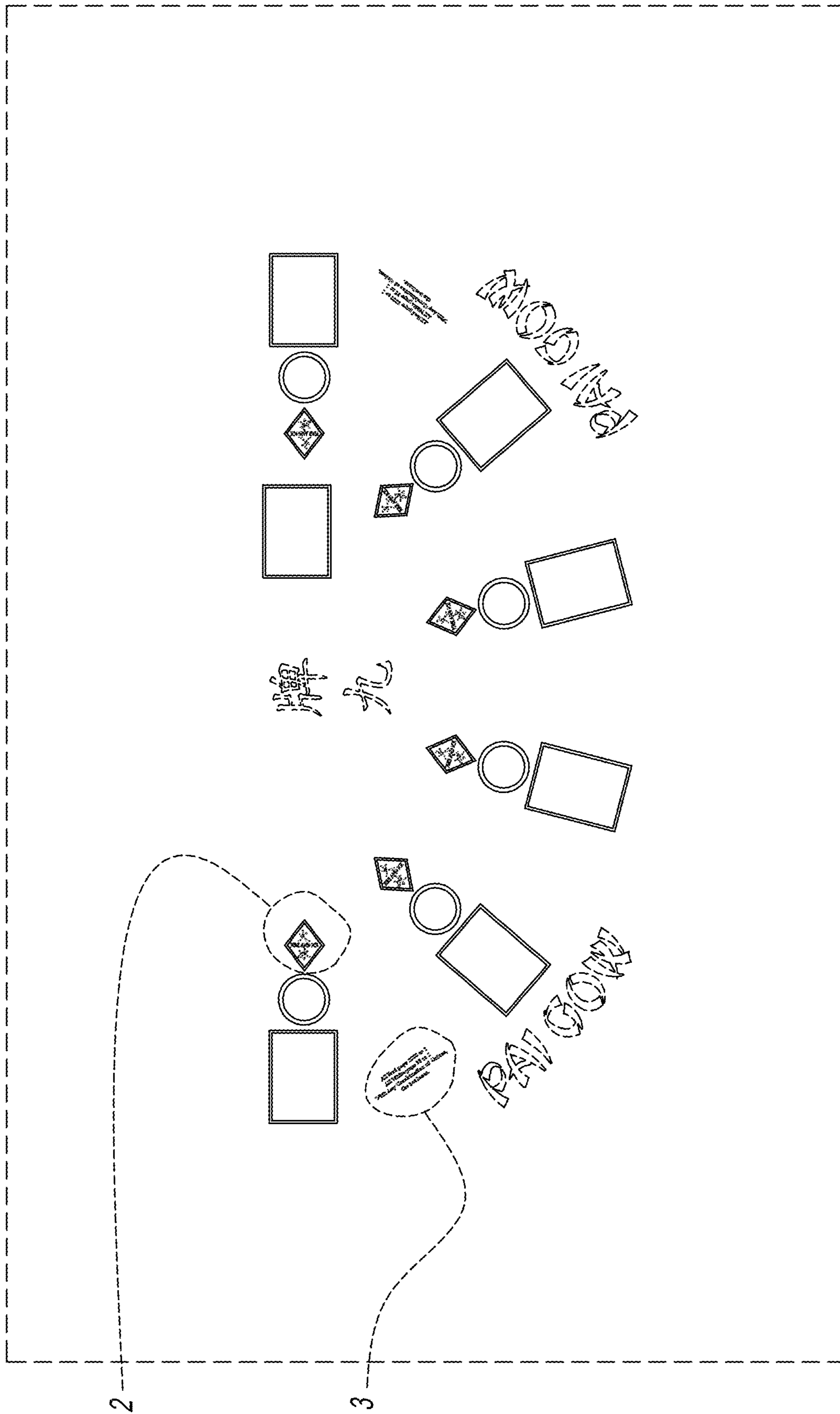

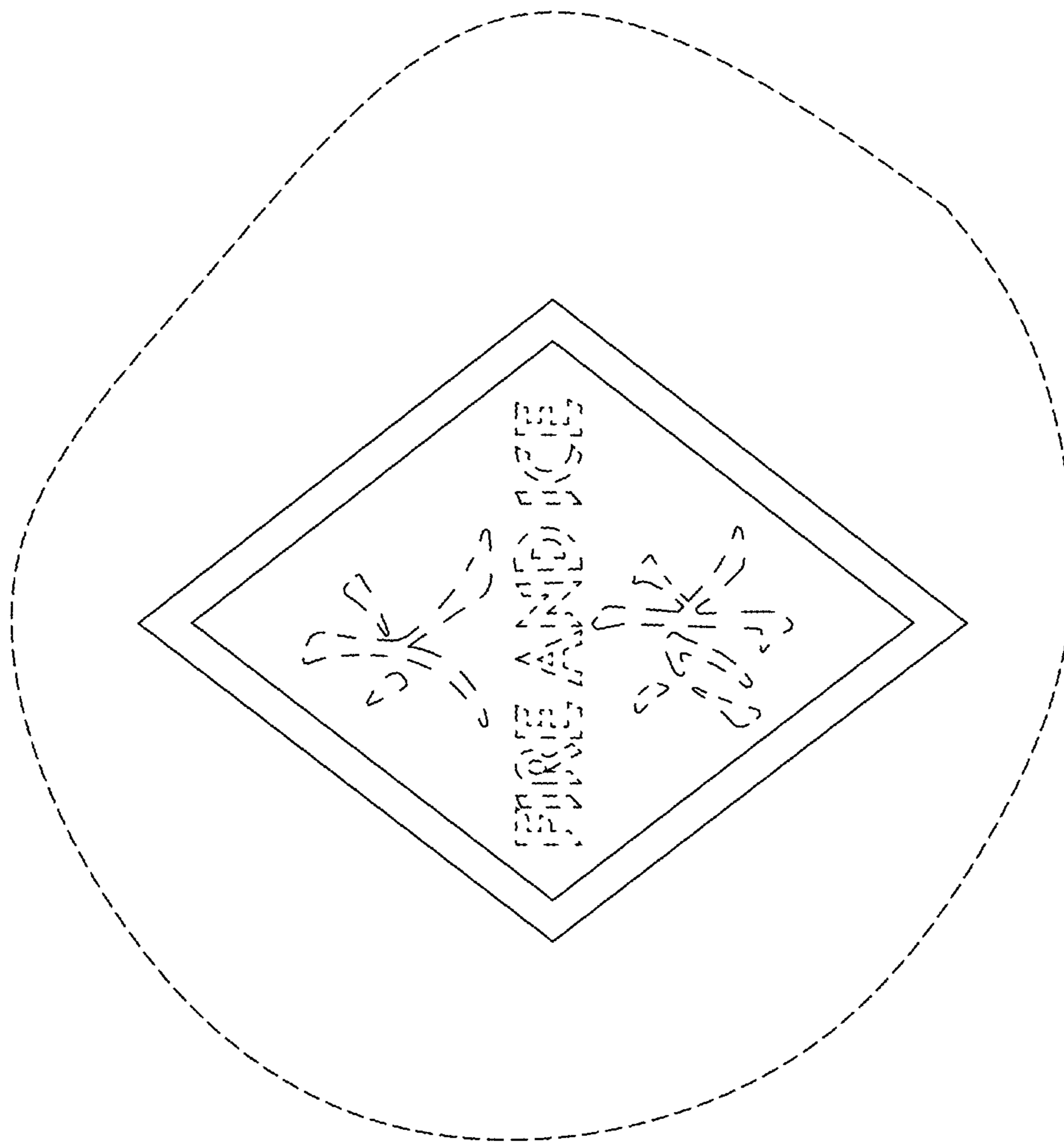
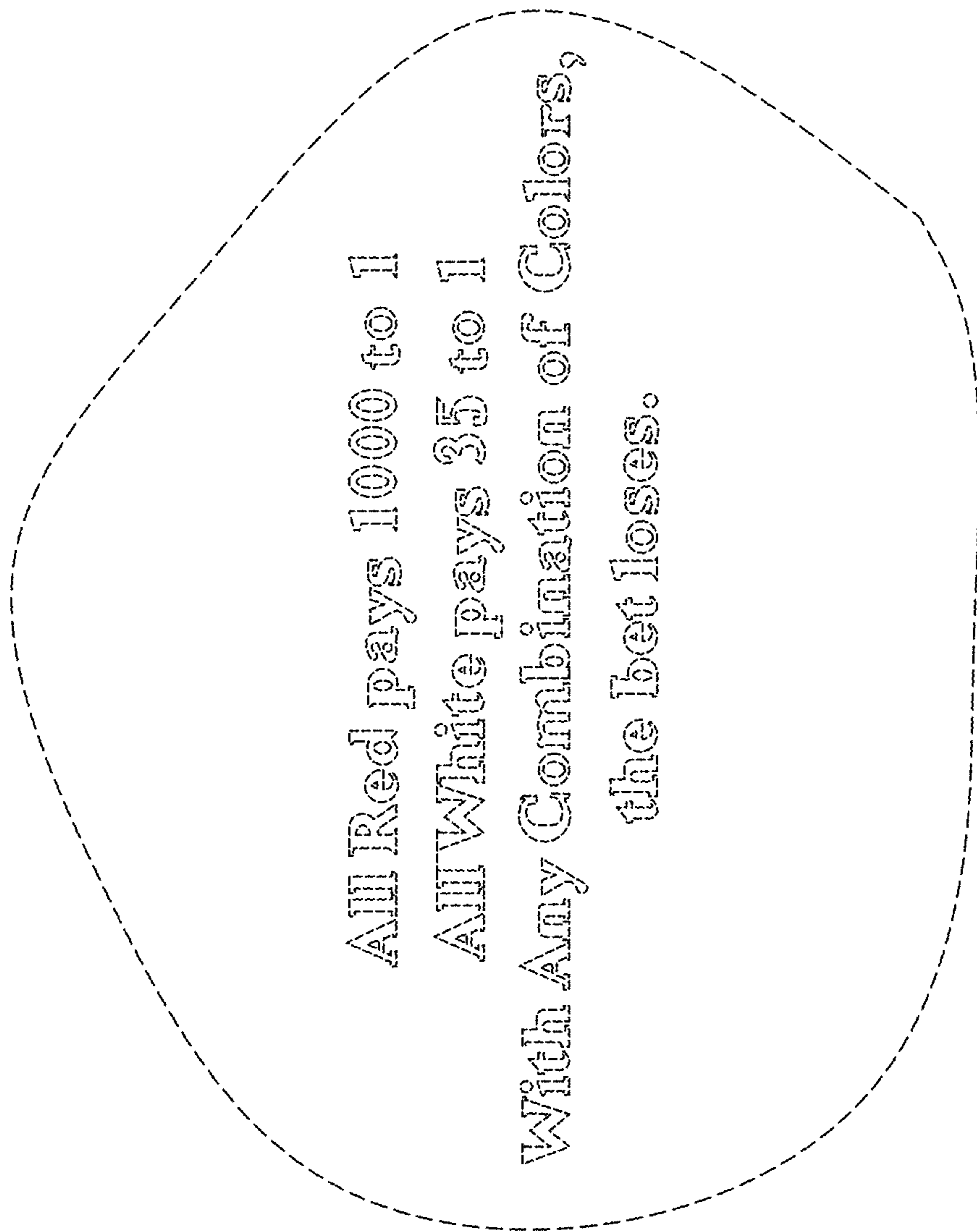
