FIG. 7 is a bottom view thereof.

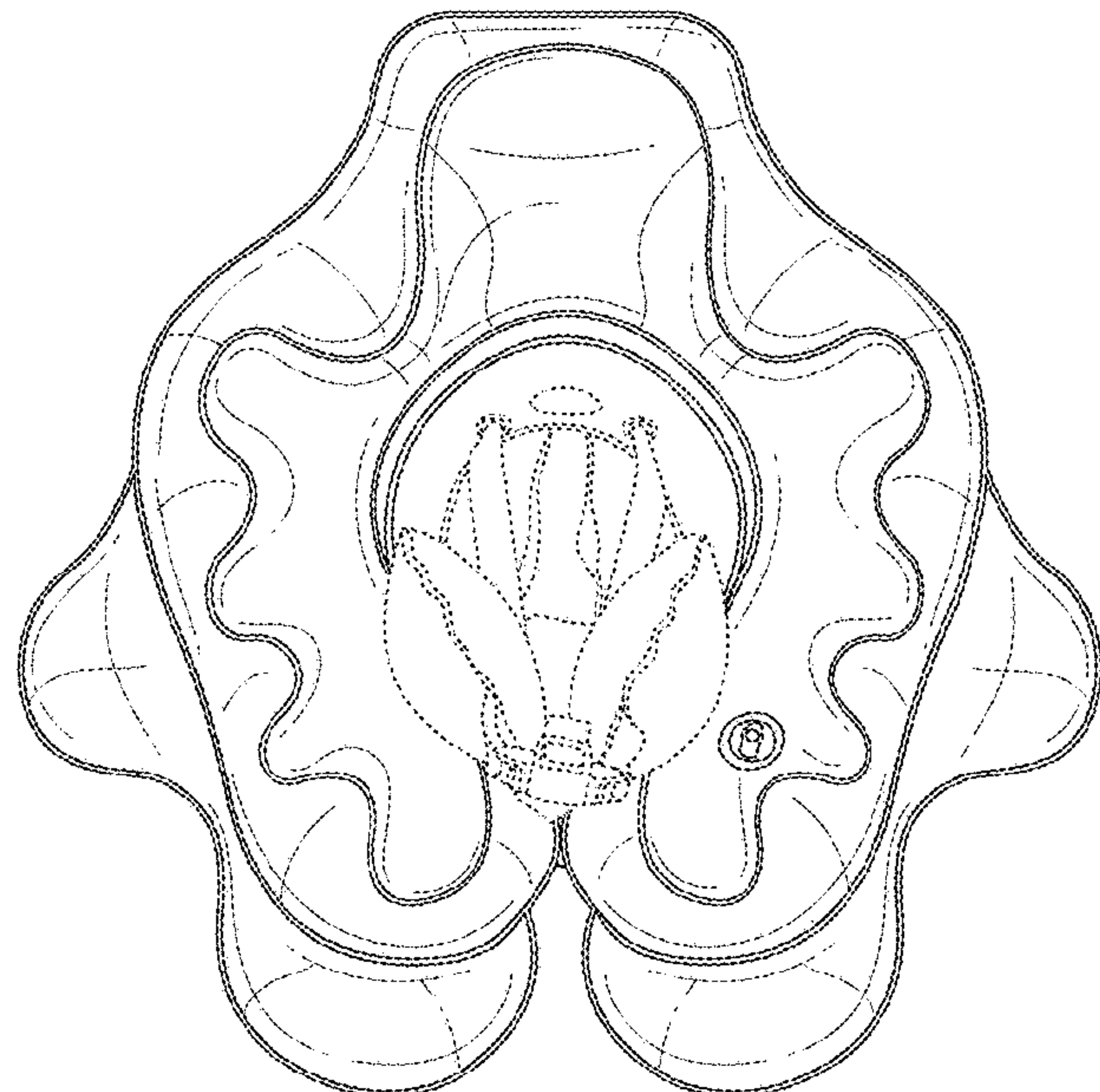
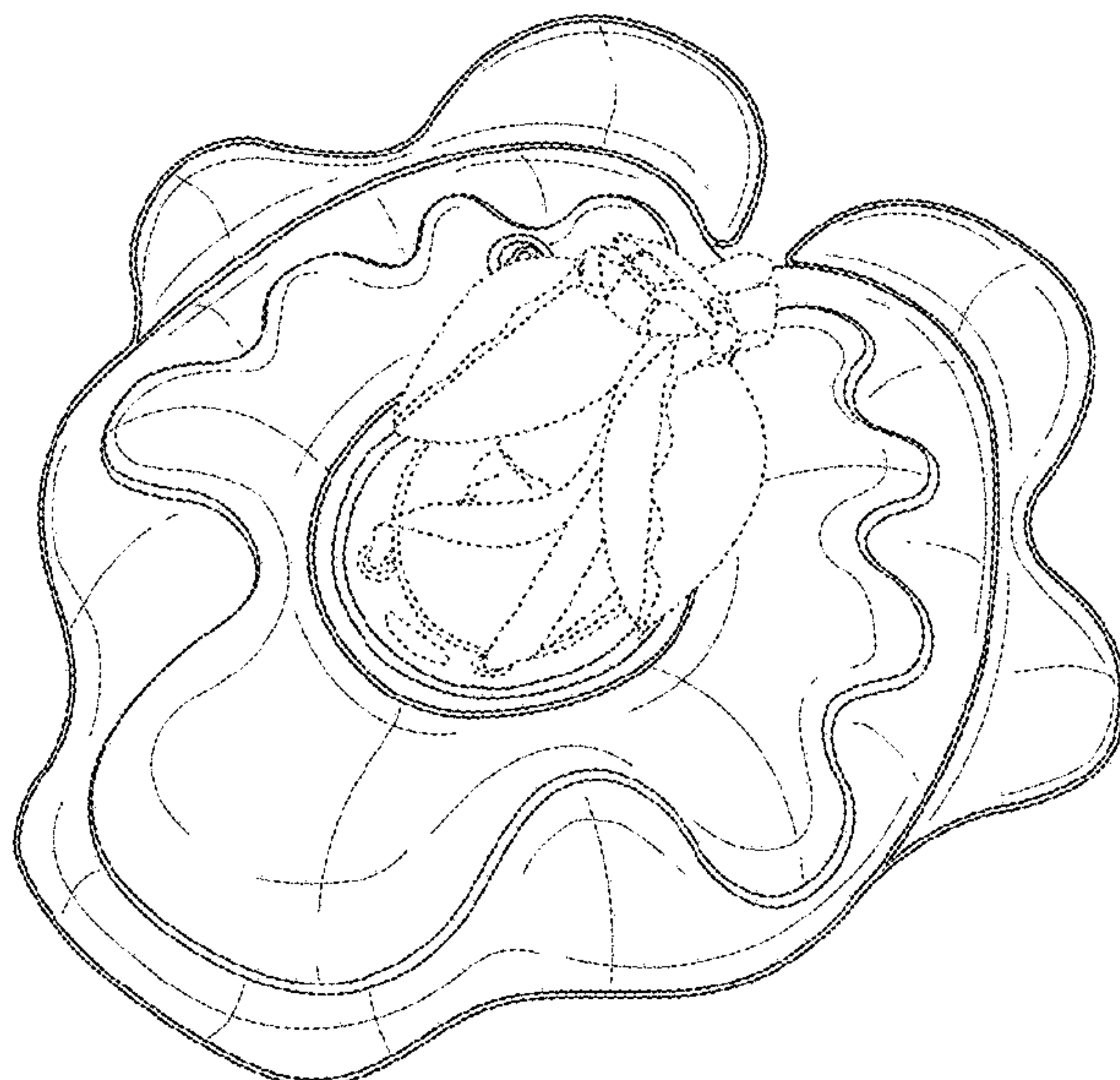
The broken lines depict portions of the inflatable swimming ring that form no part of the claimed design.

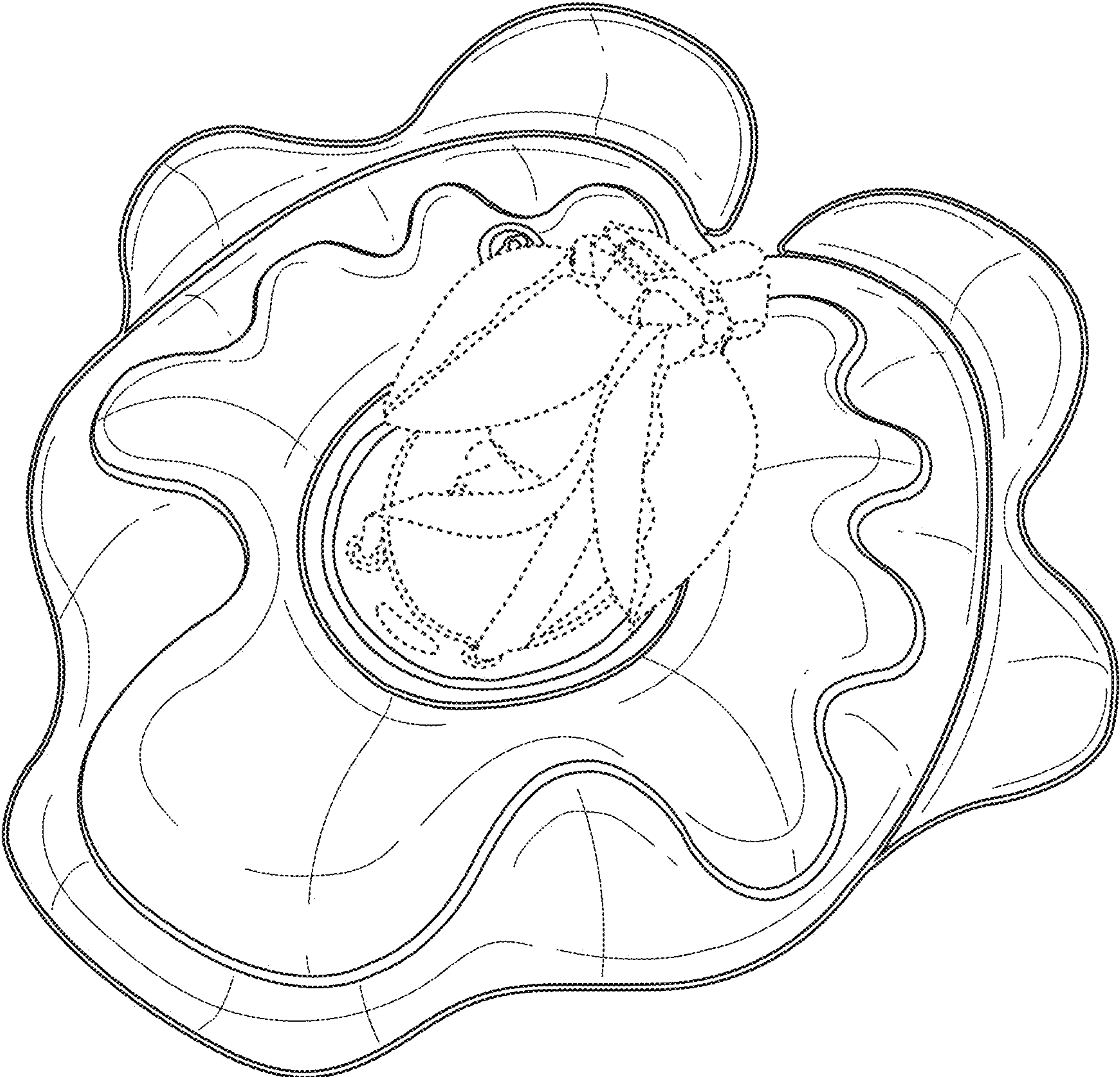

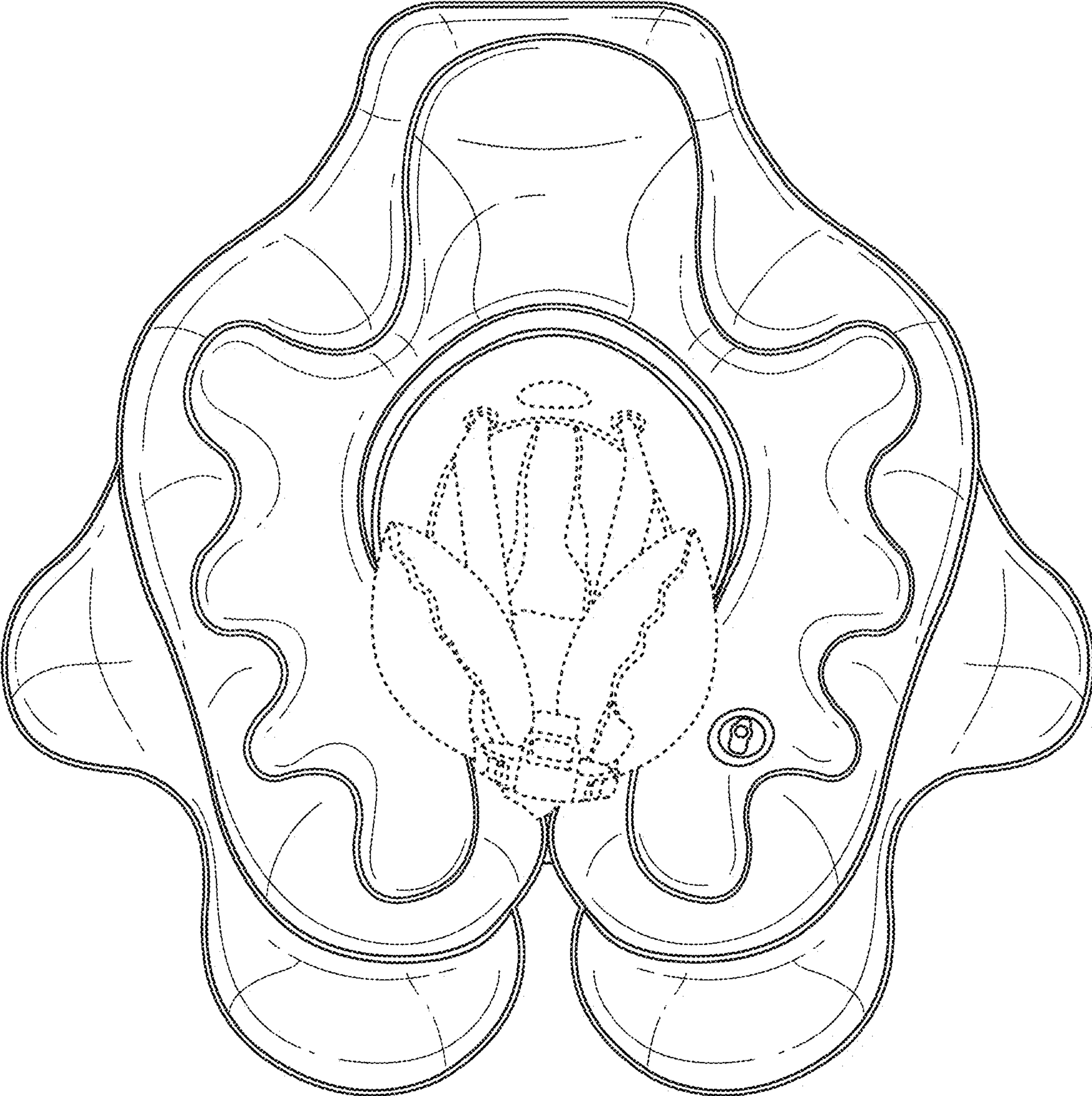

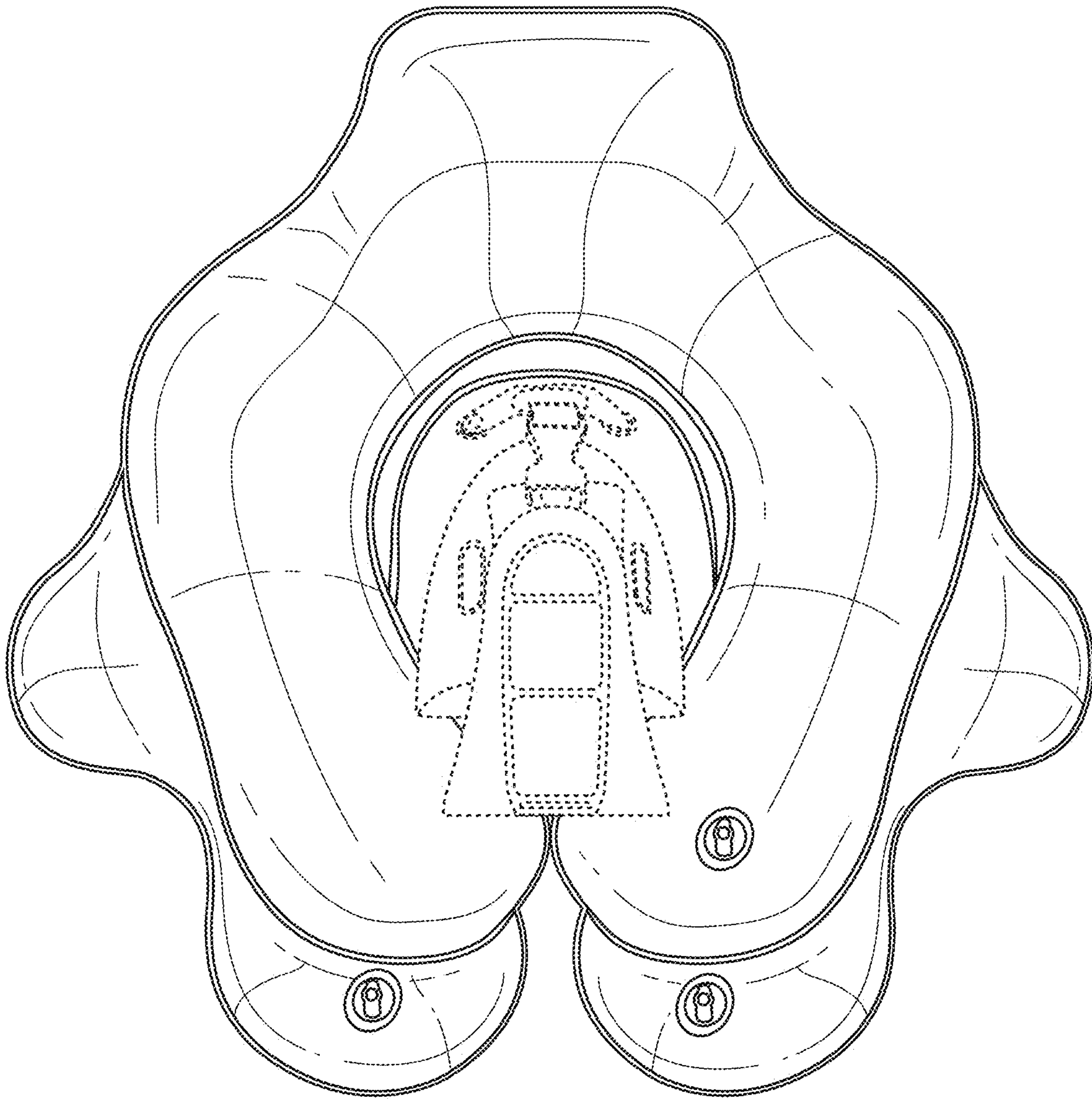

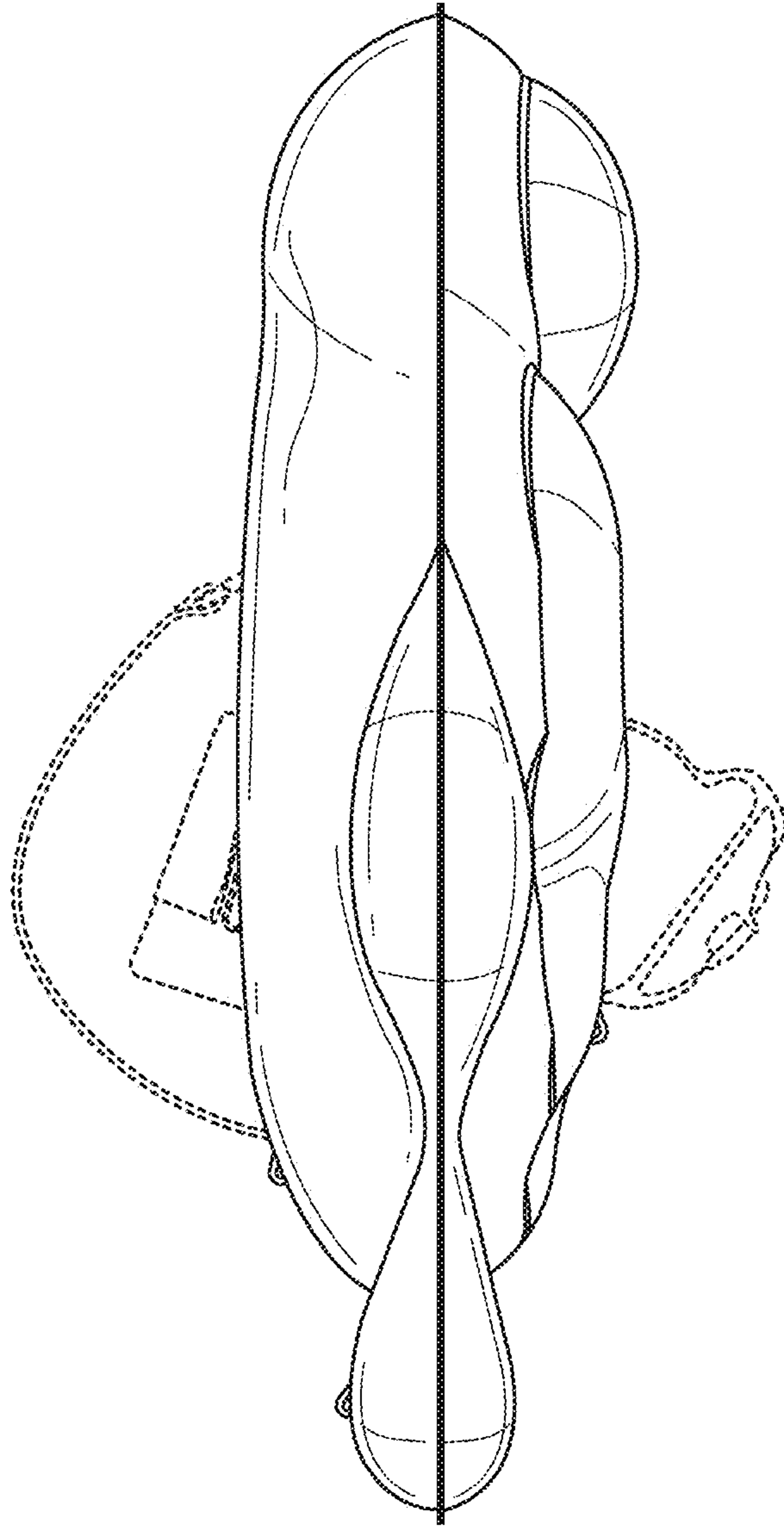

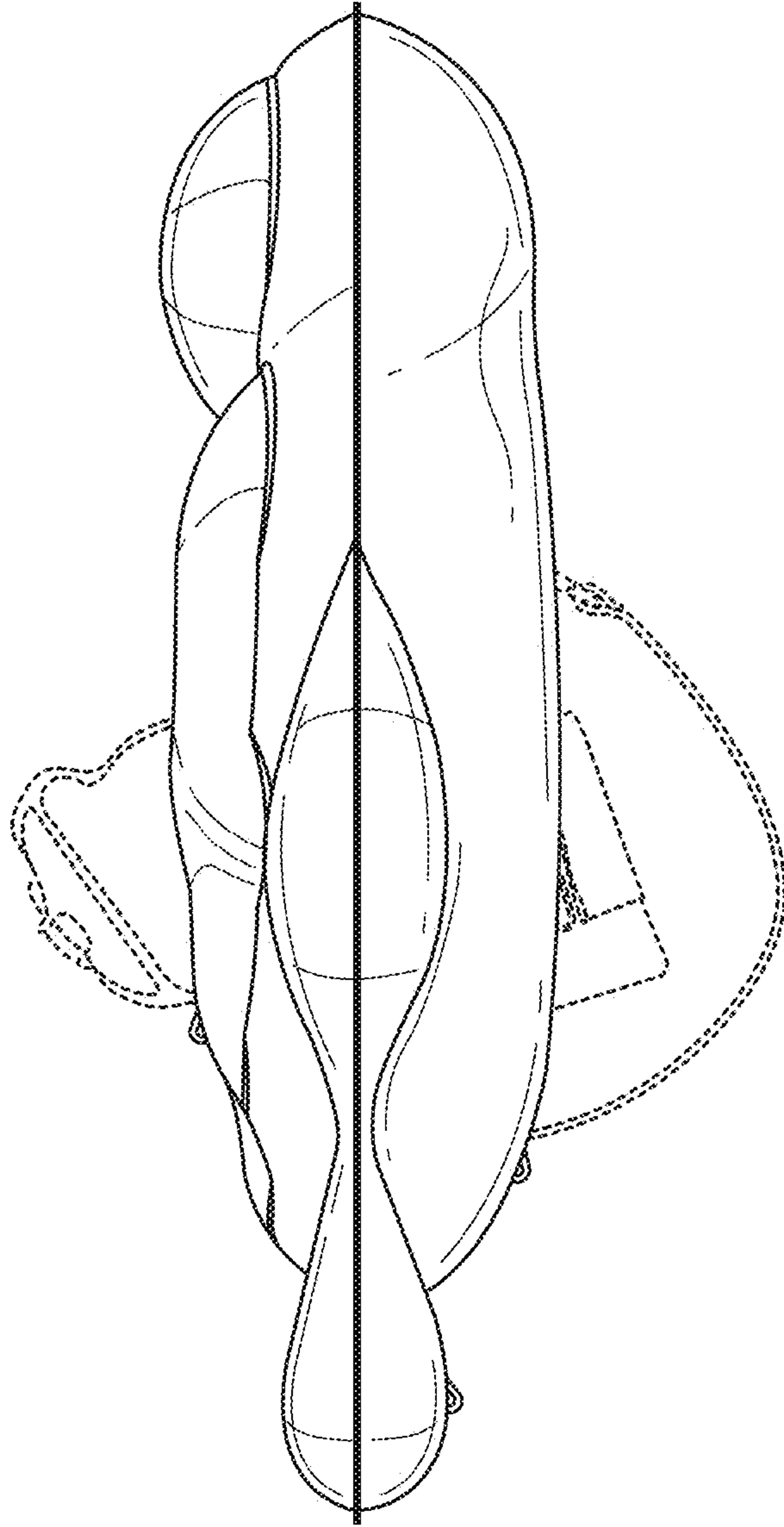

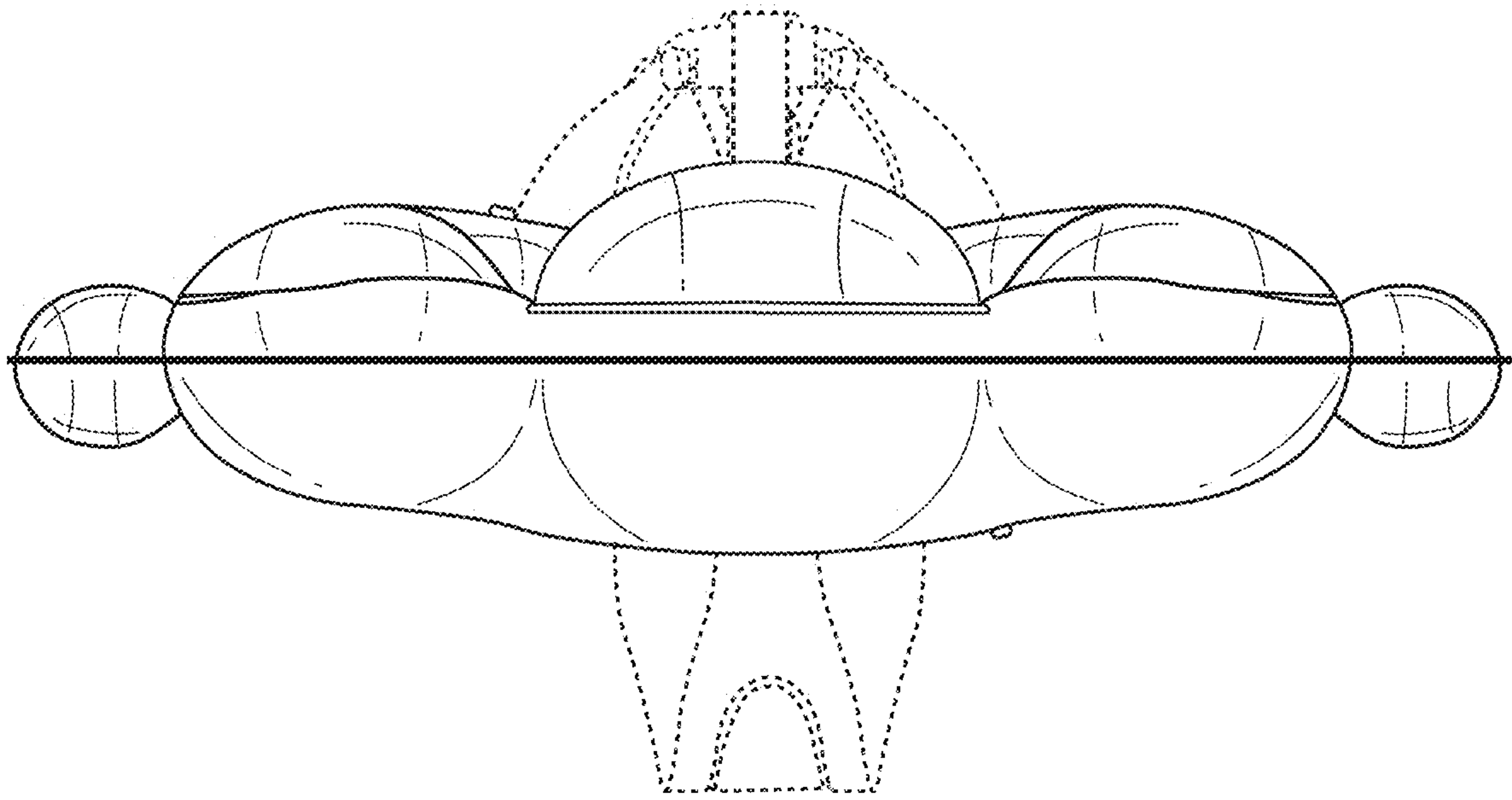

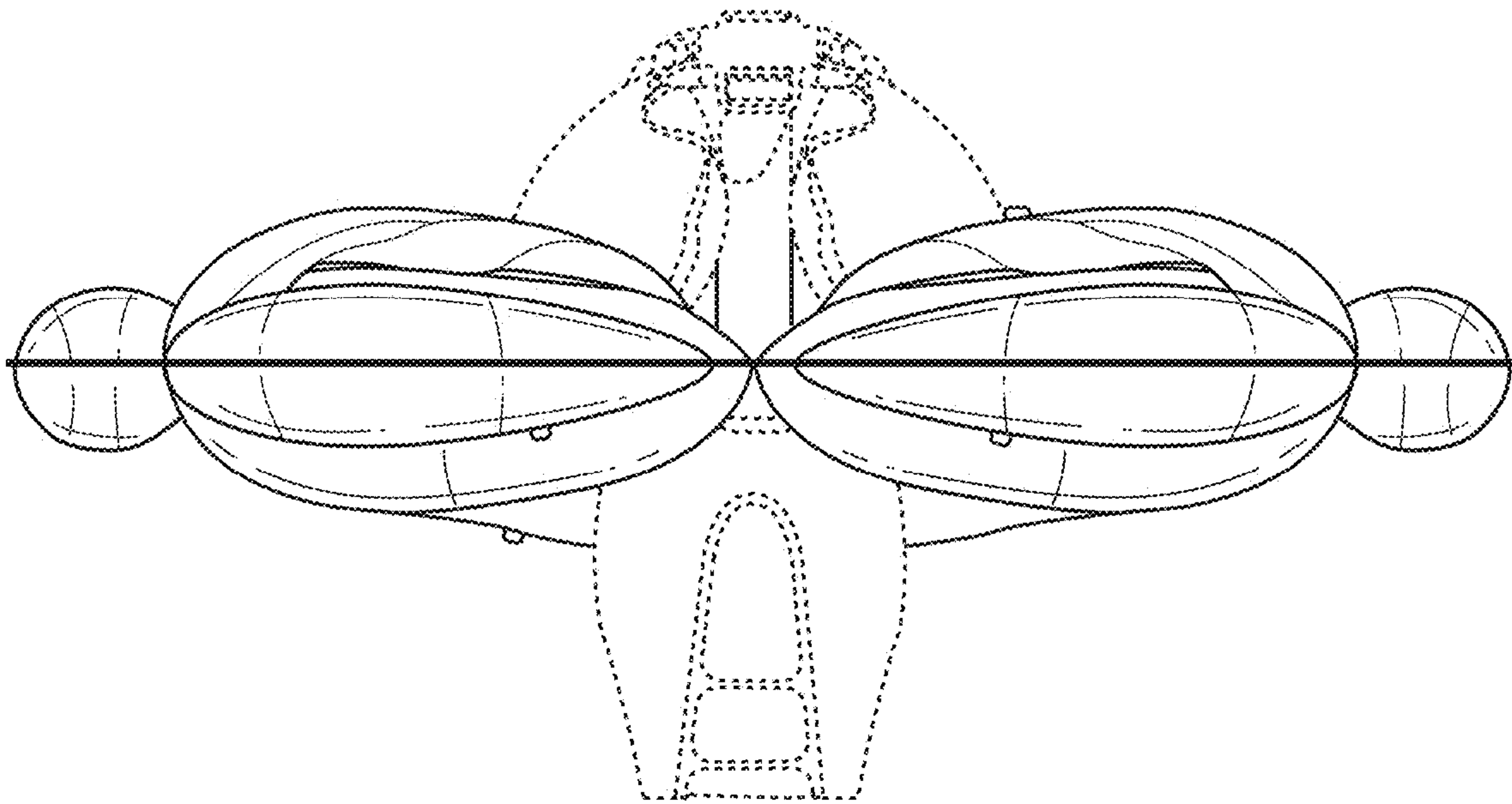
