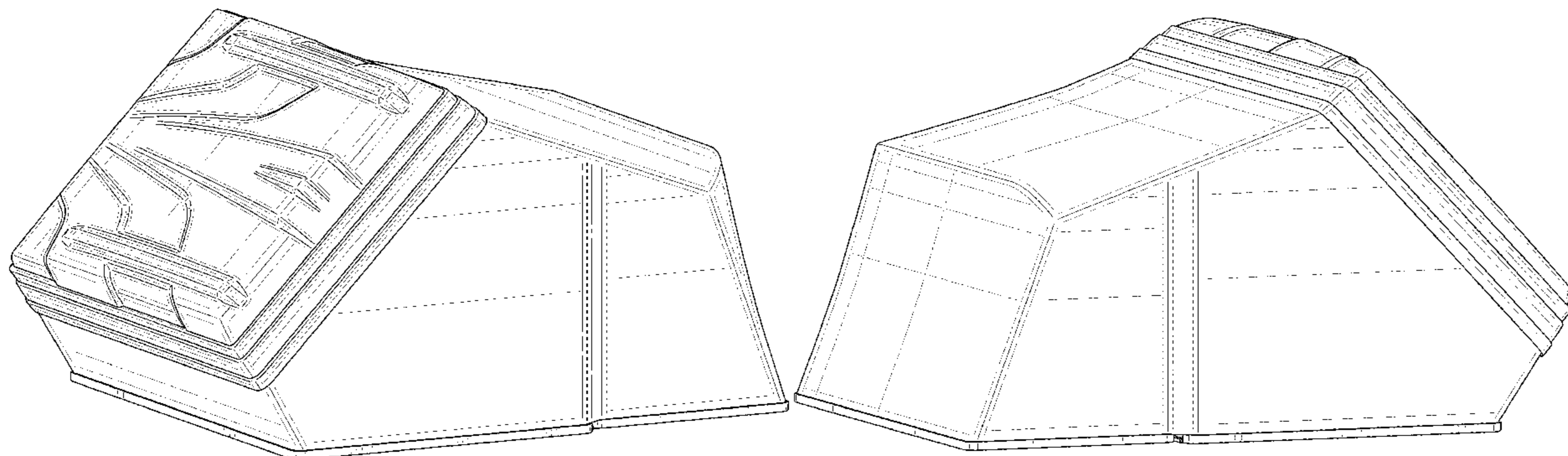

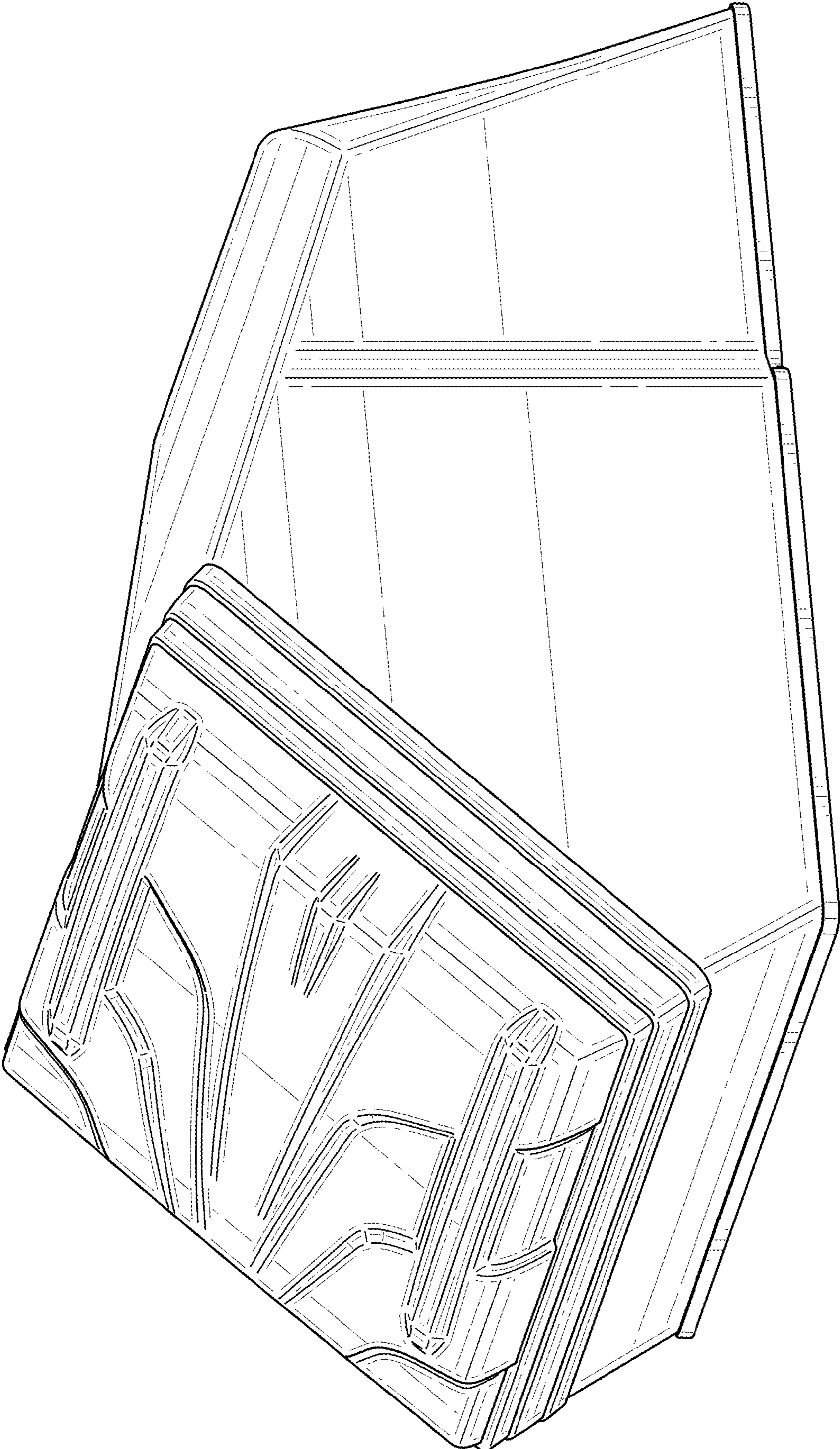
The ornamental design for a roof tent frame, as shown and described.

**DESCRIPTION**

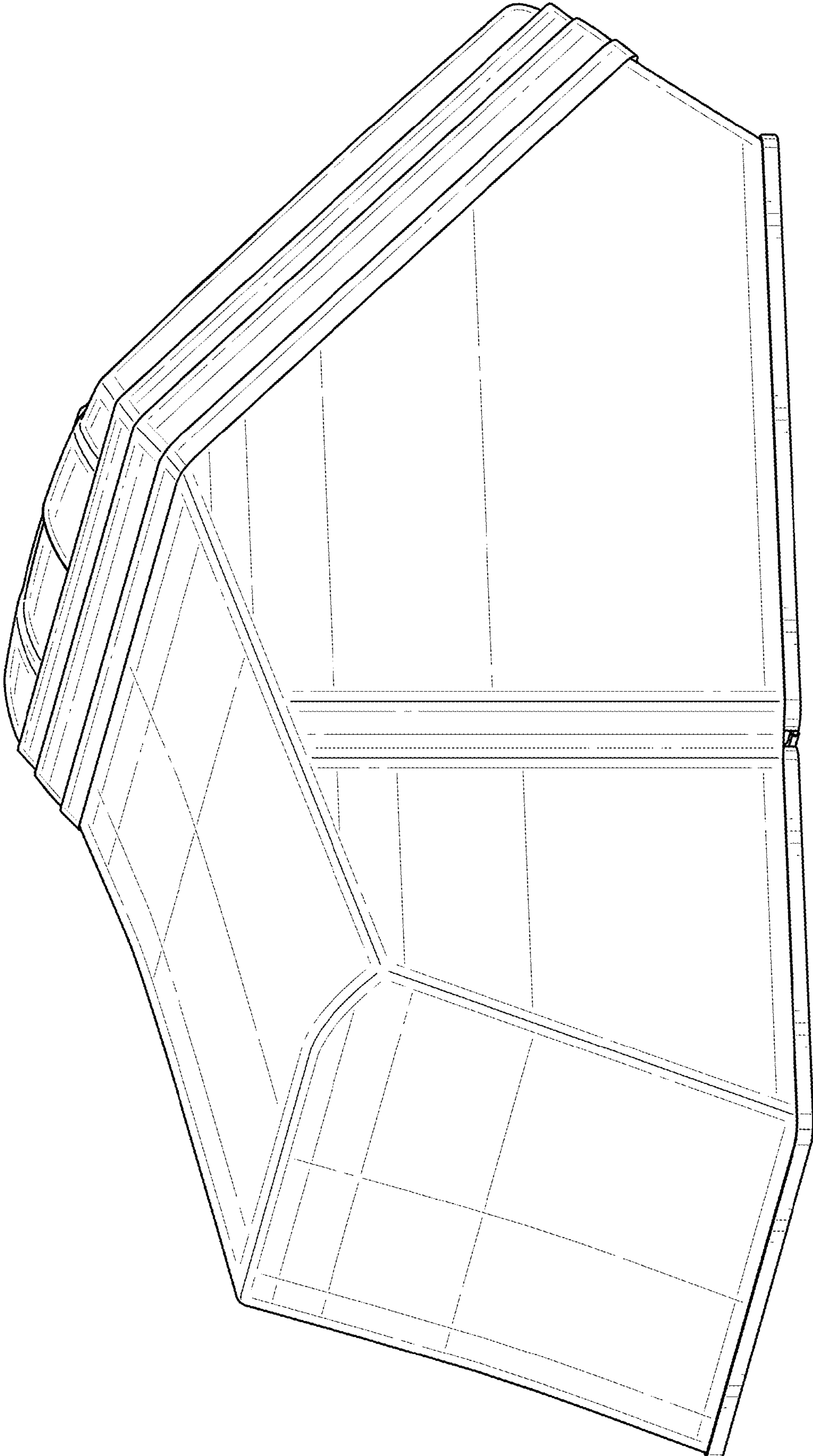
FIG. 1 is a front perspective view of a roof tent frame showing my new design;

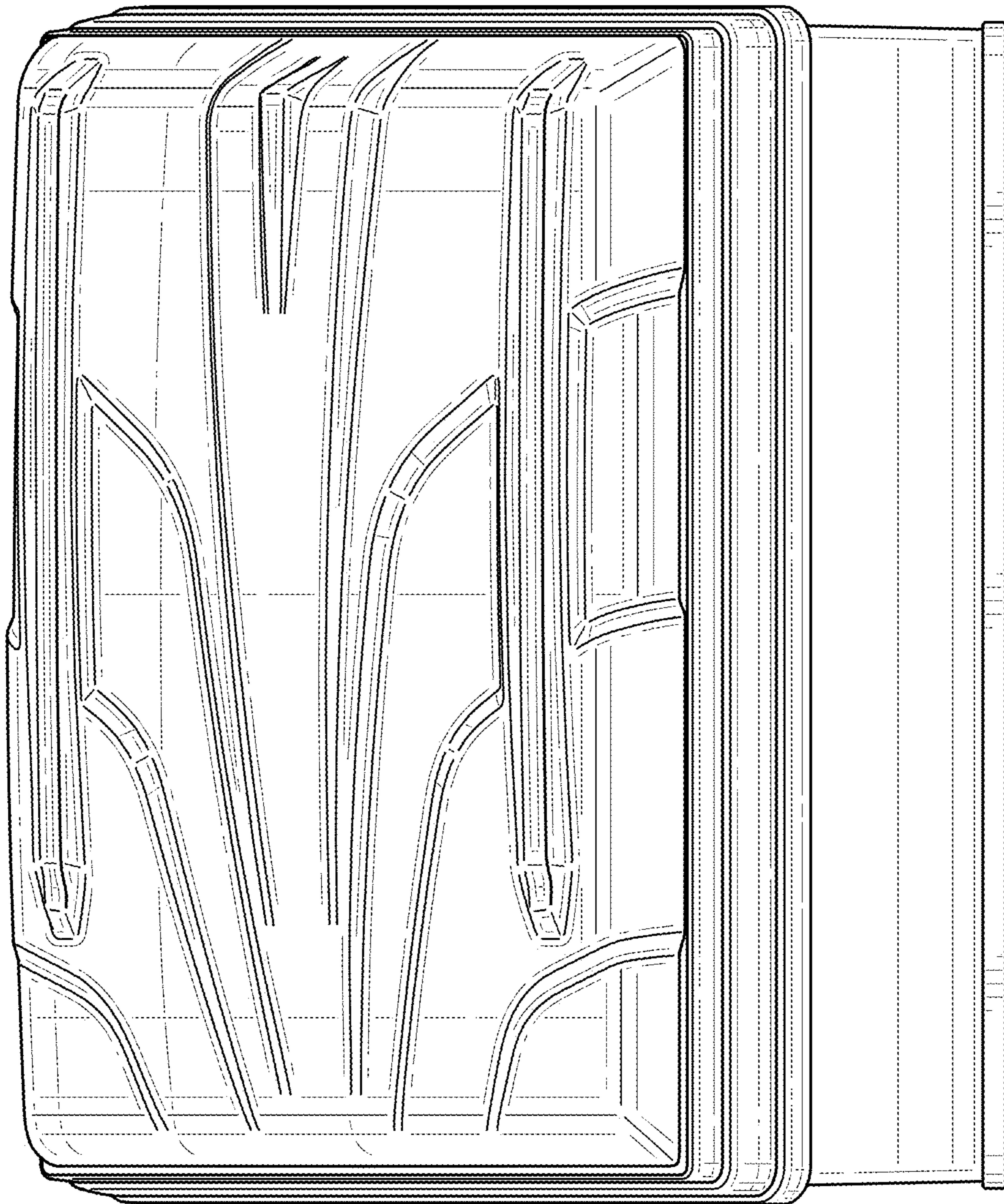




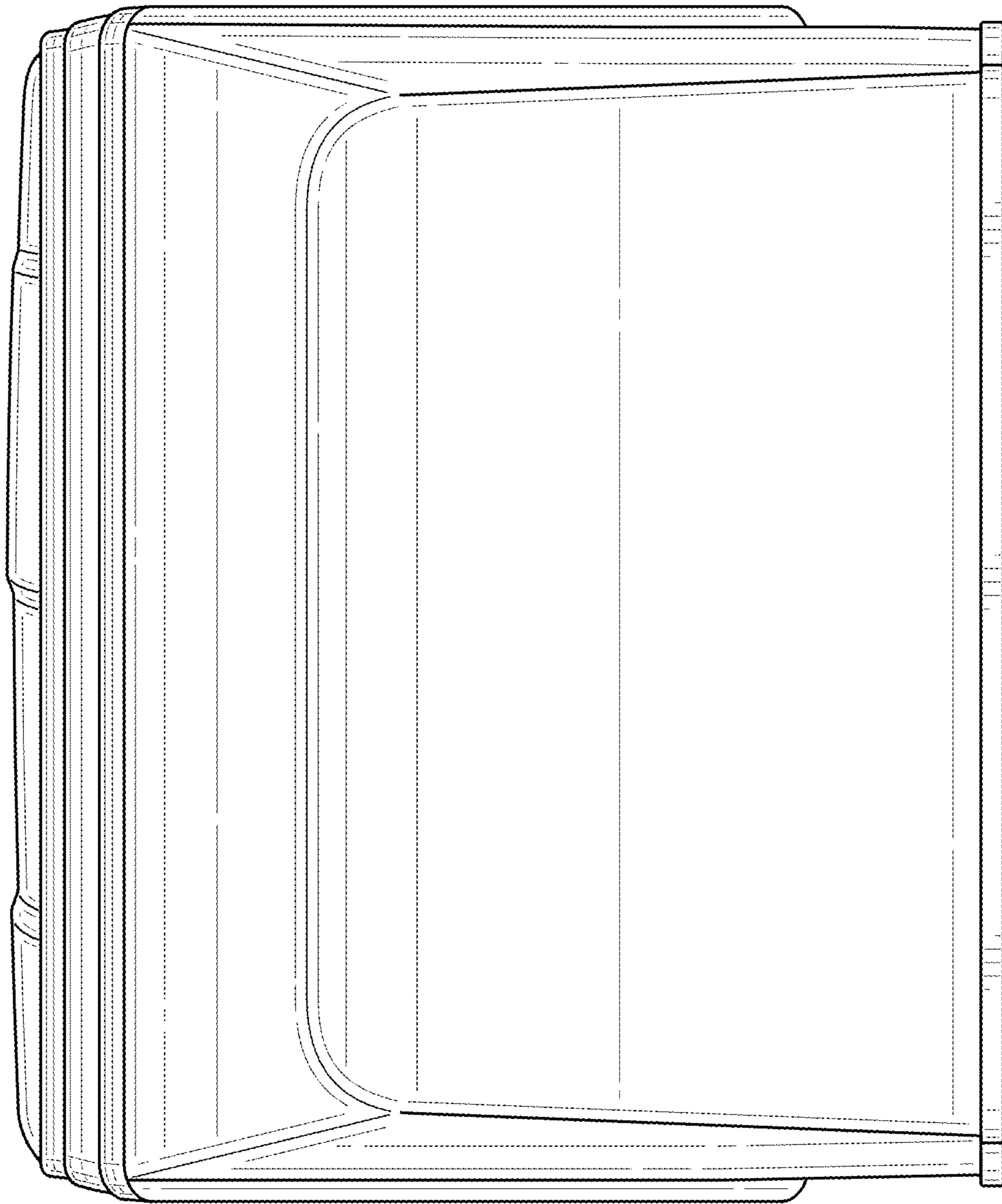

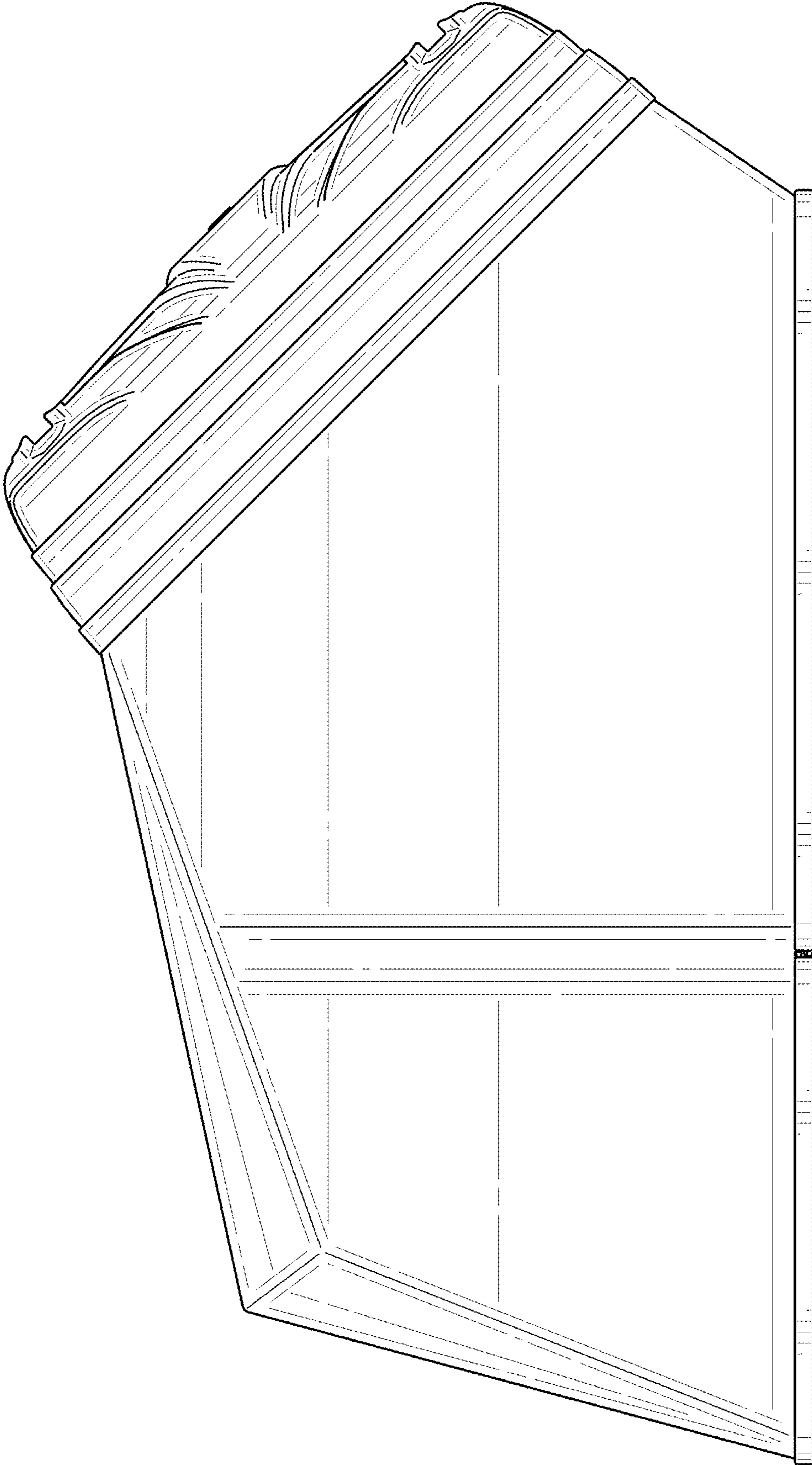

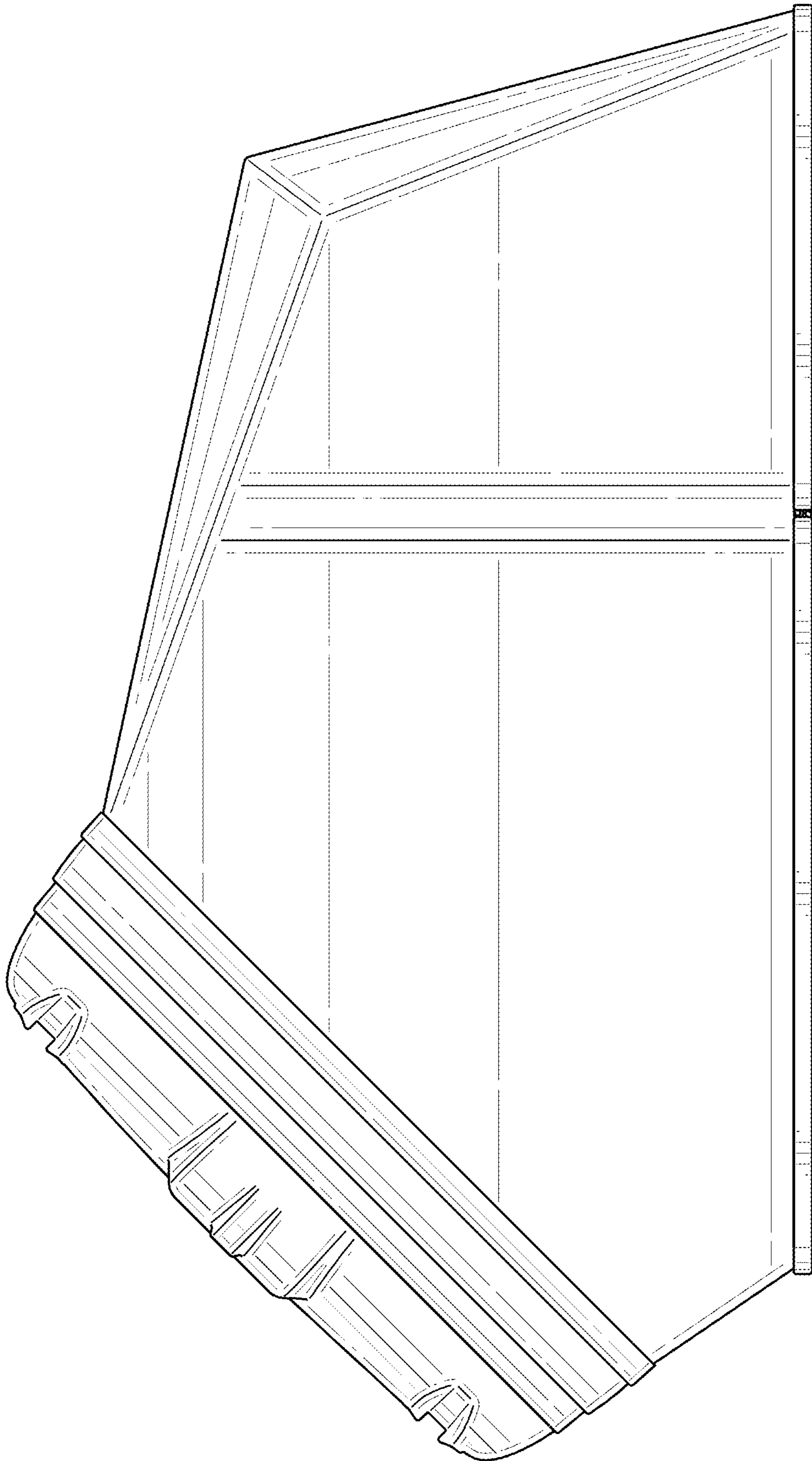

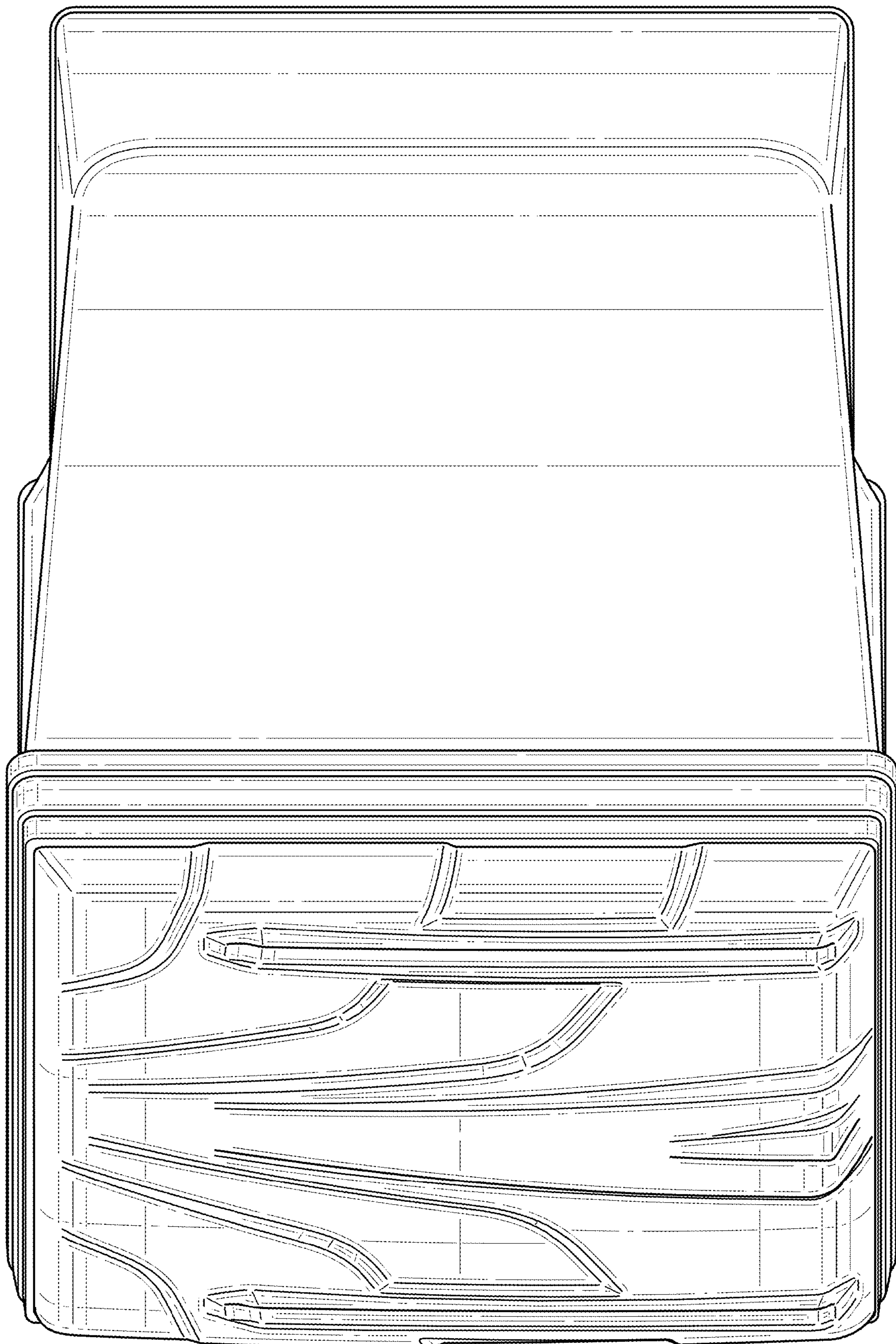

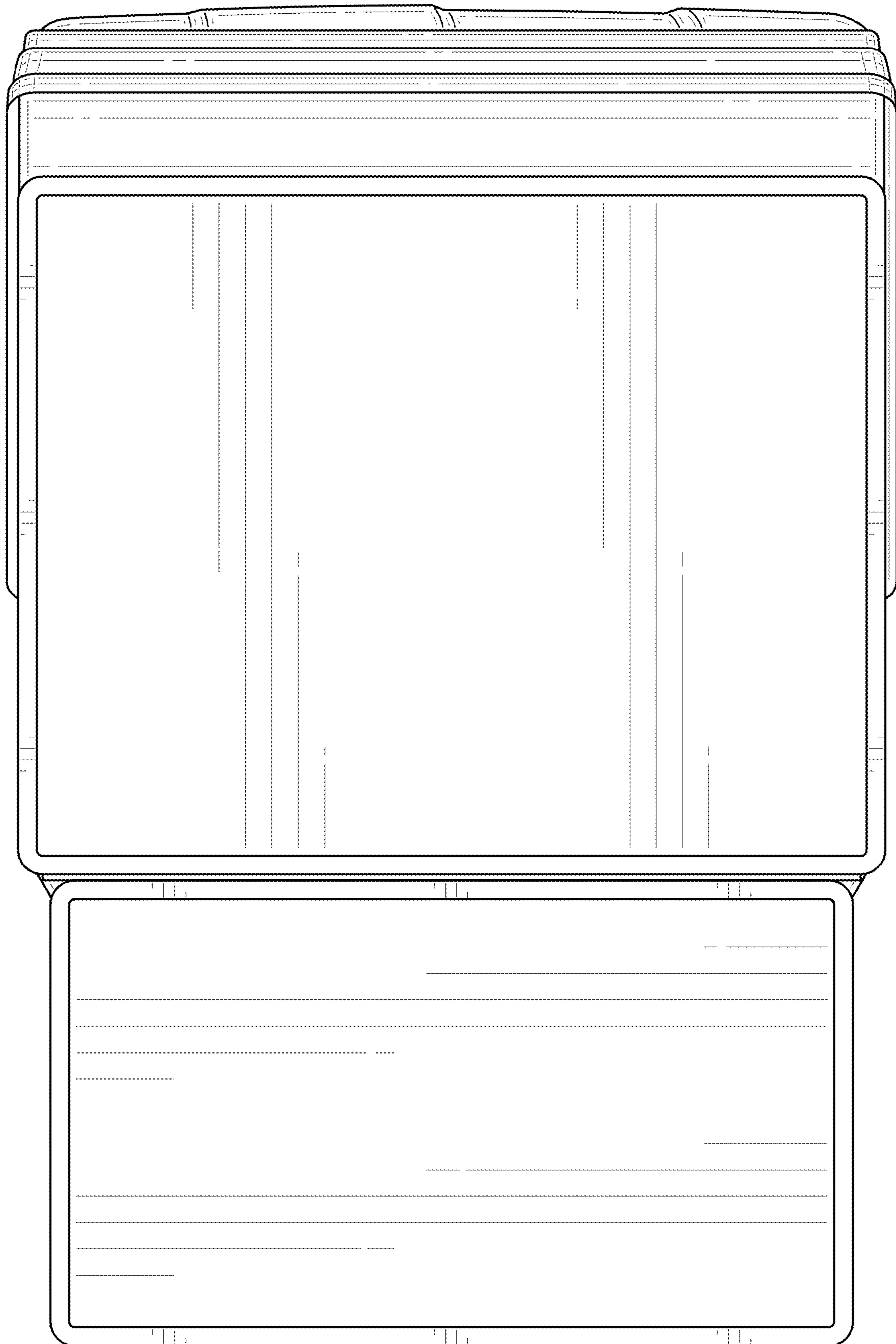

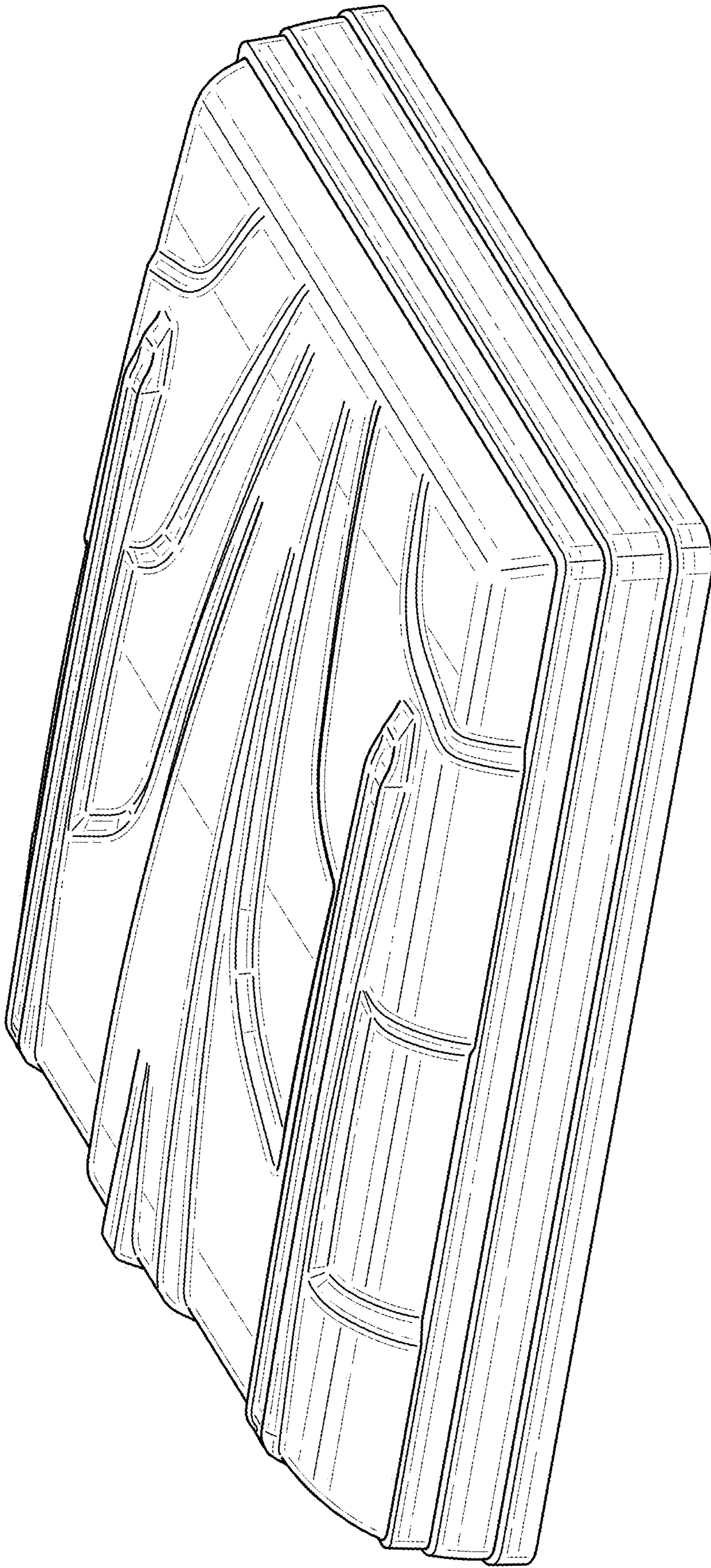
