(57) **CLAIM**

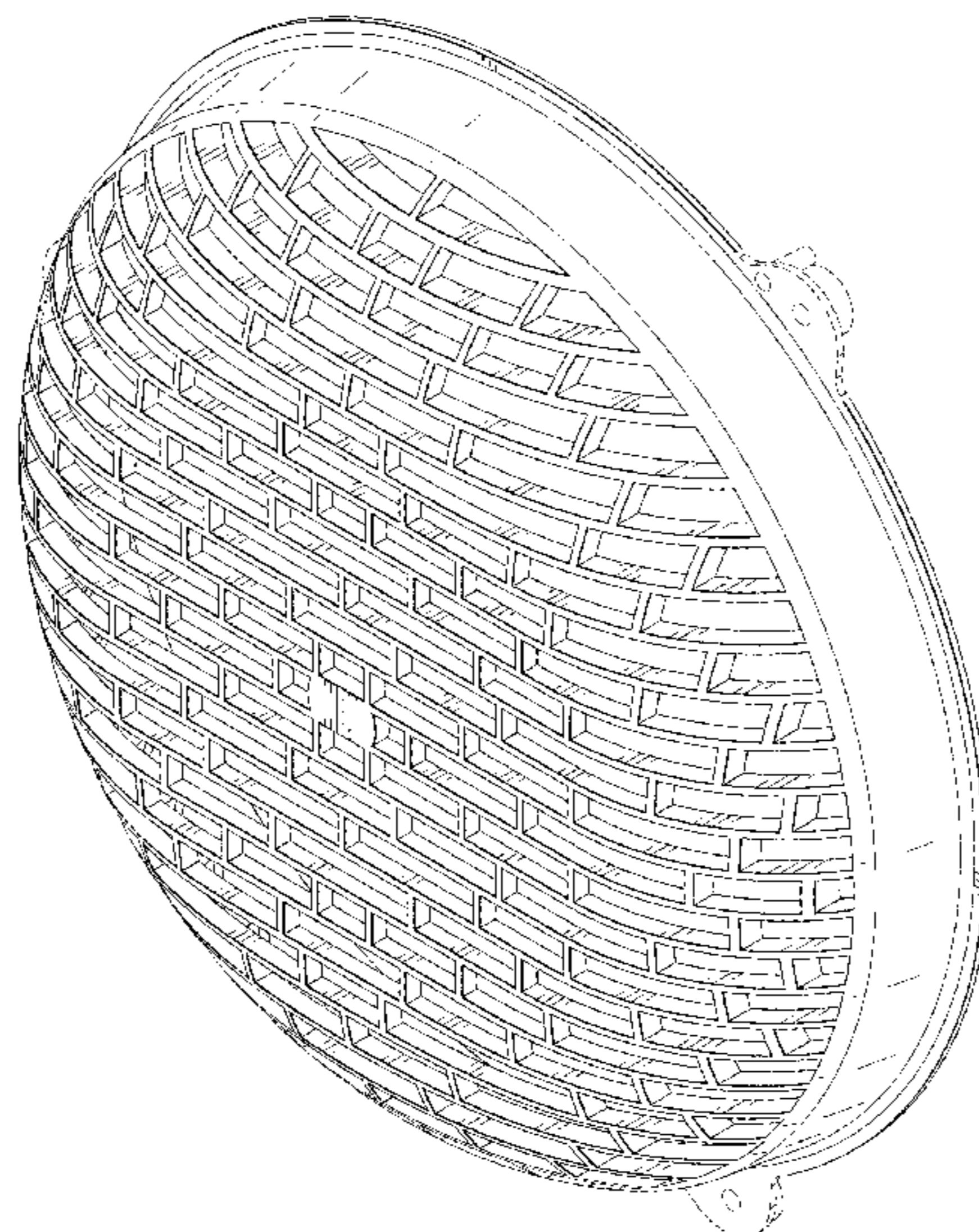
The ornamental design for a grill for a cold storage system, as shown and described.

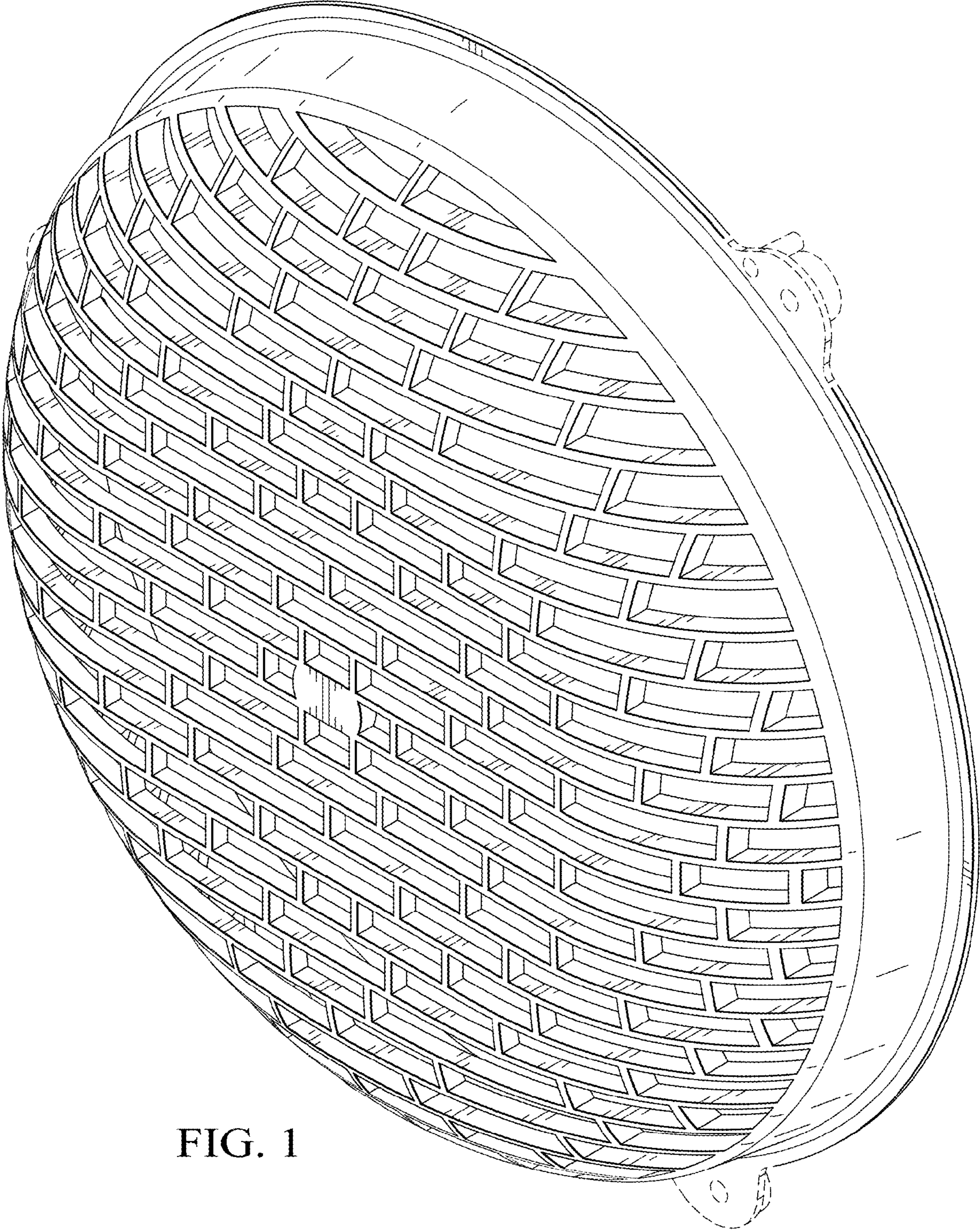

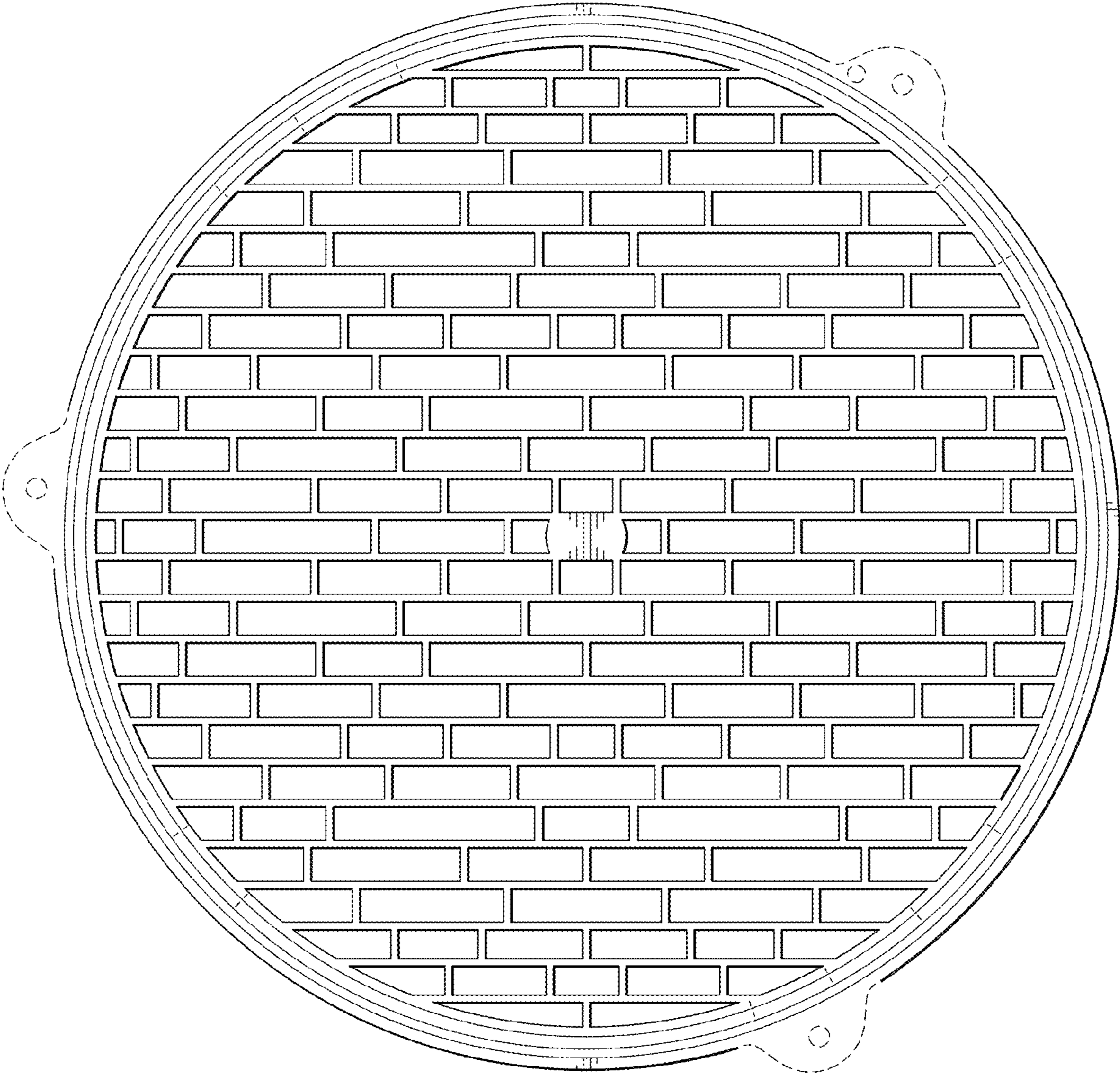

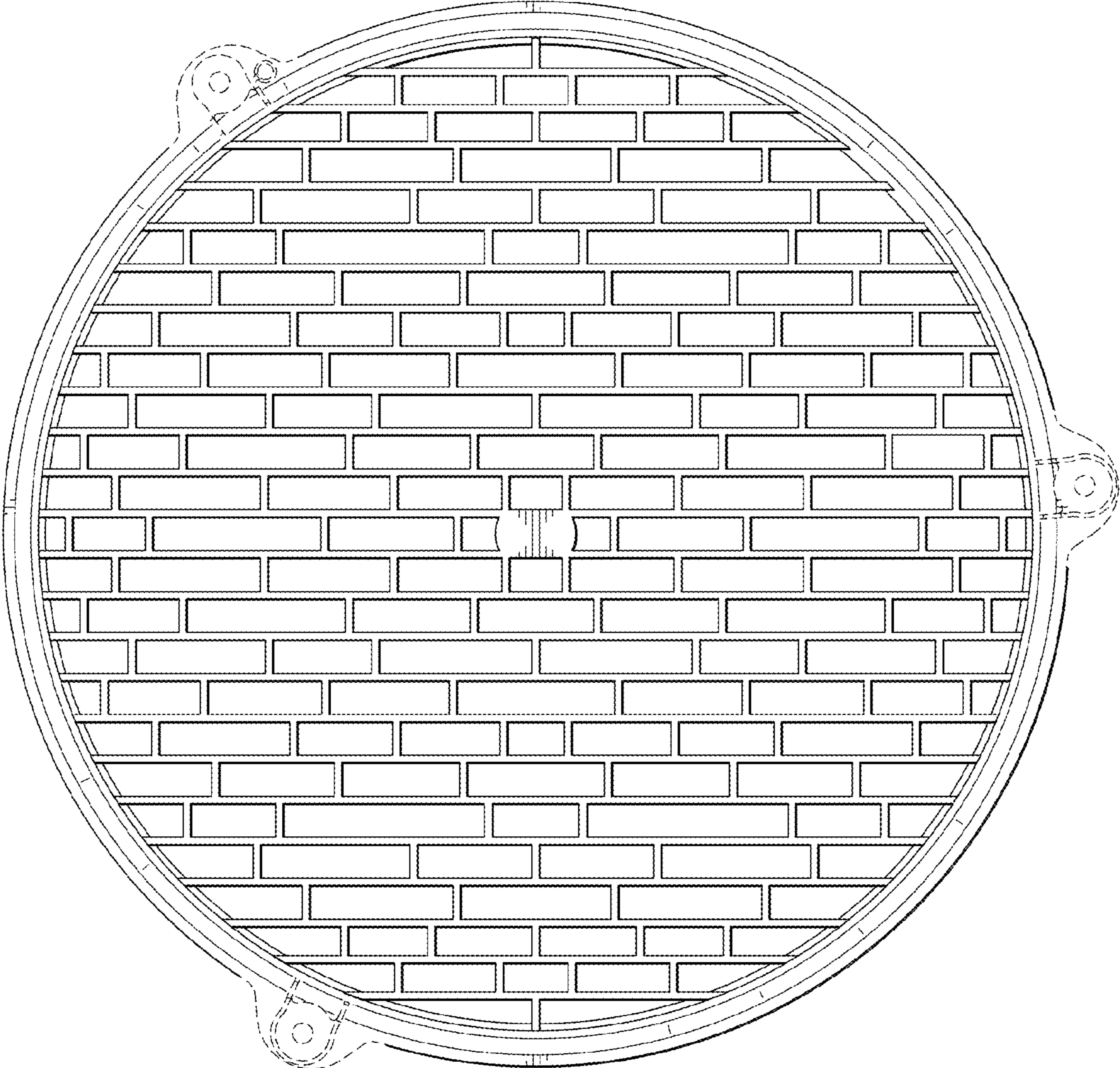

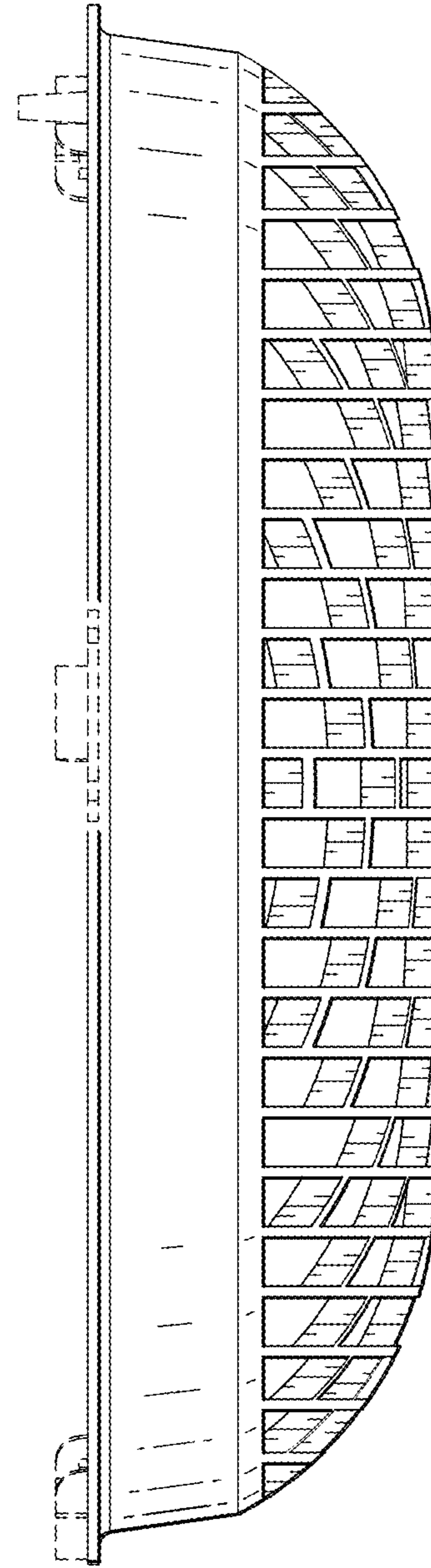

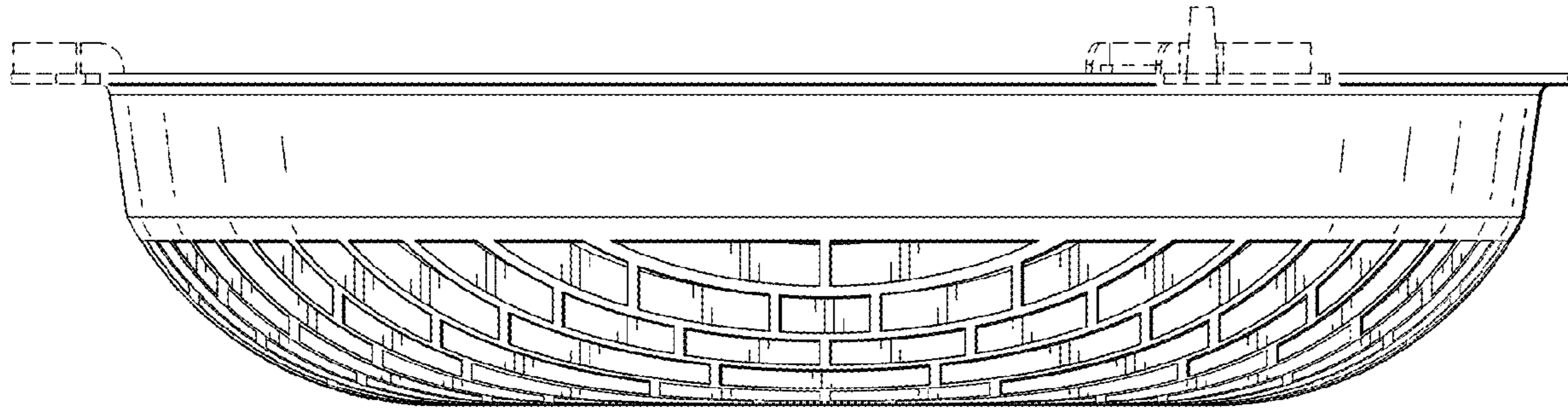

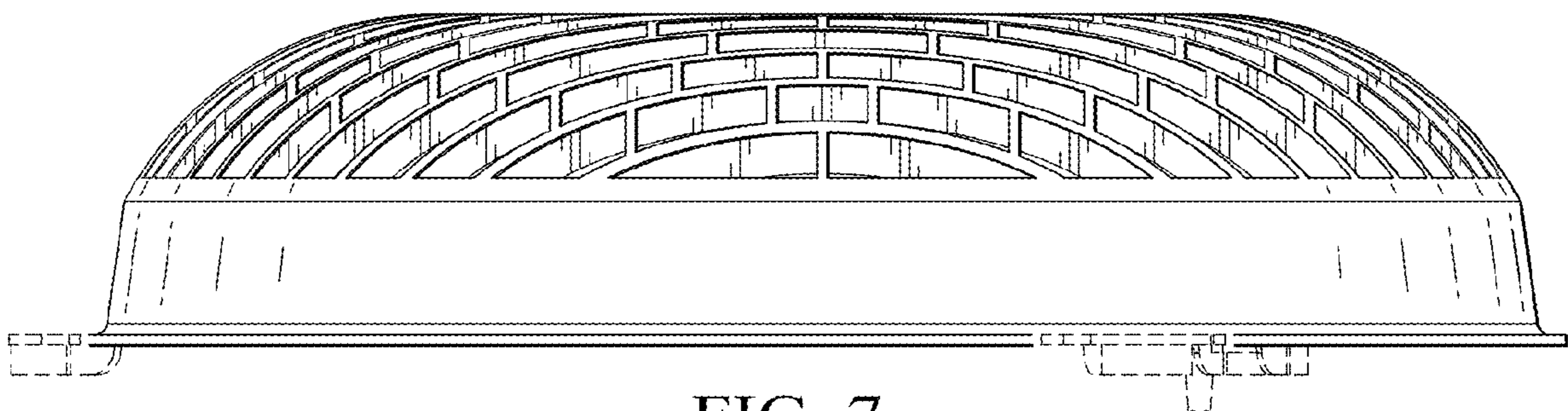
