DESCRIPTION

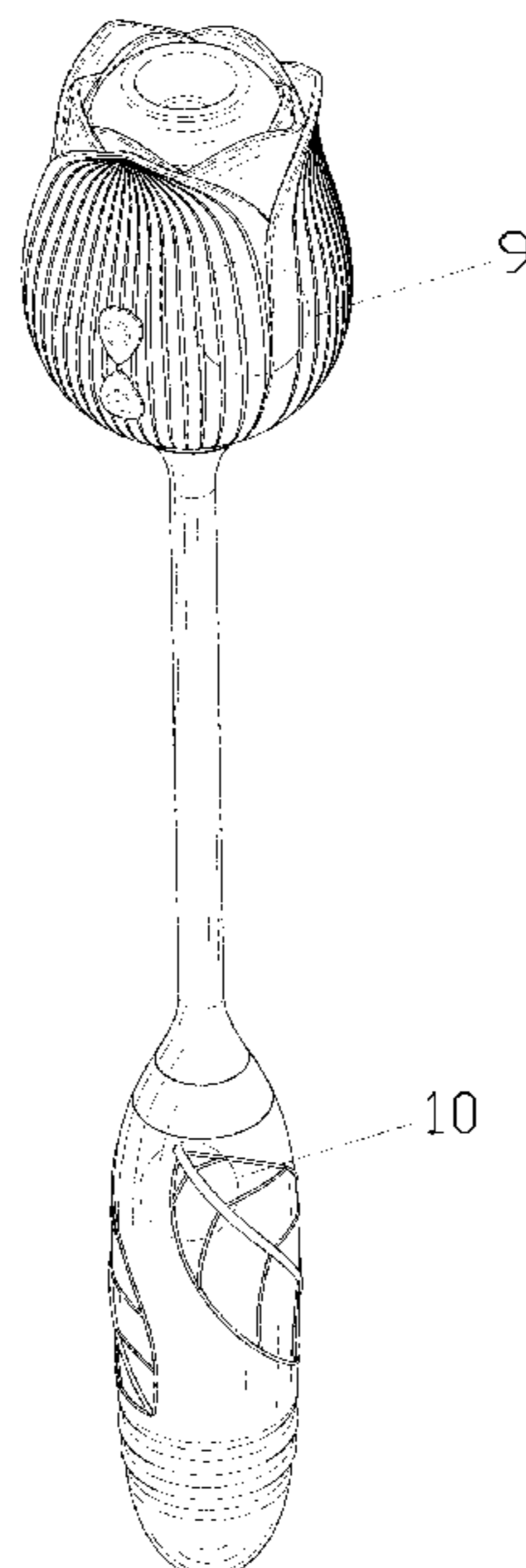
FIG. 1 is a perspective view of a sex toy showing my new design;

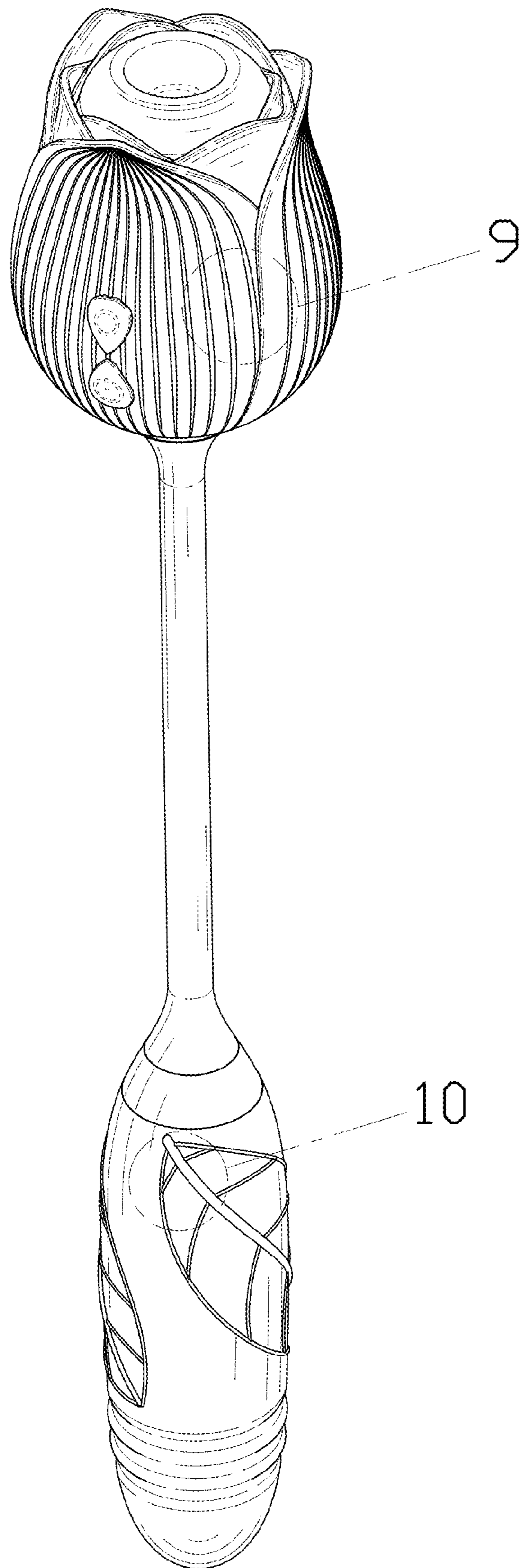

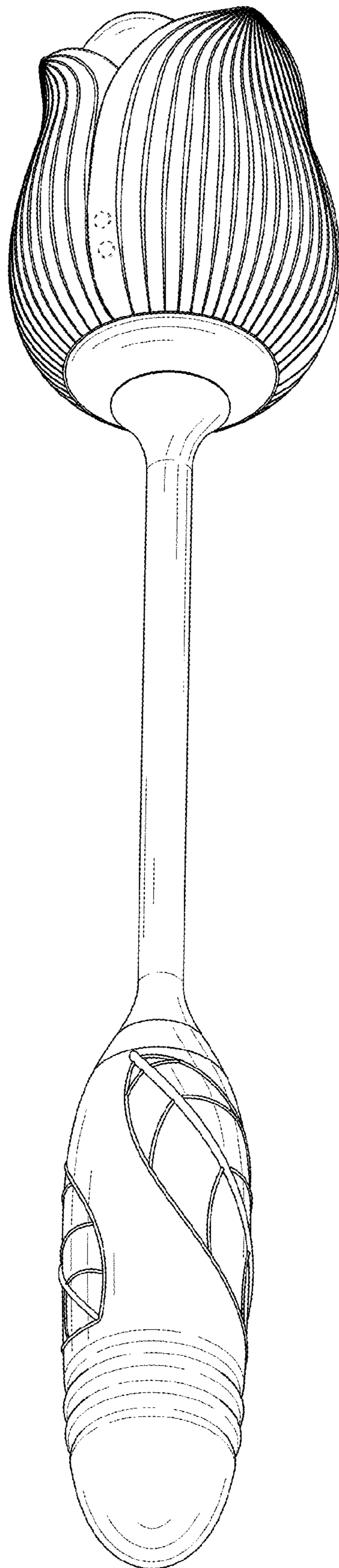

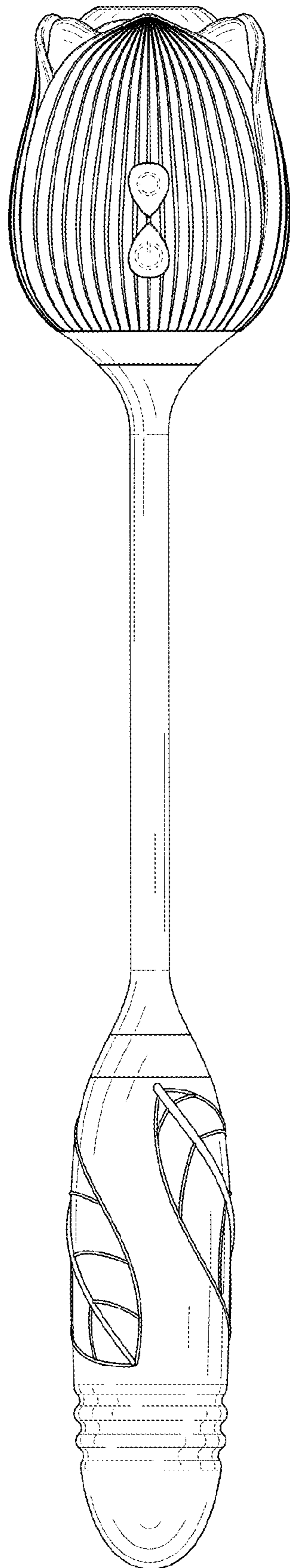

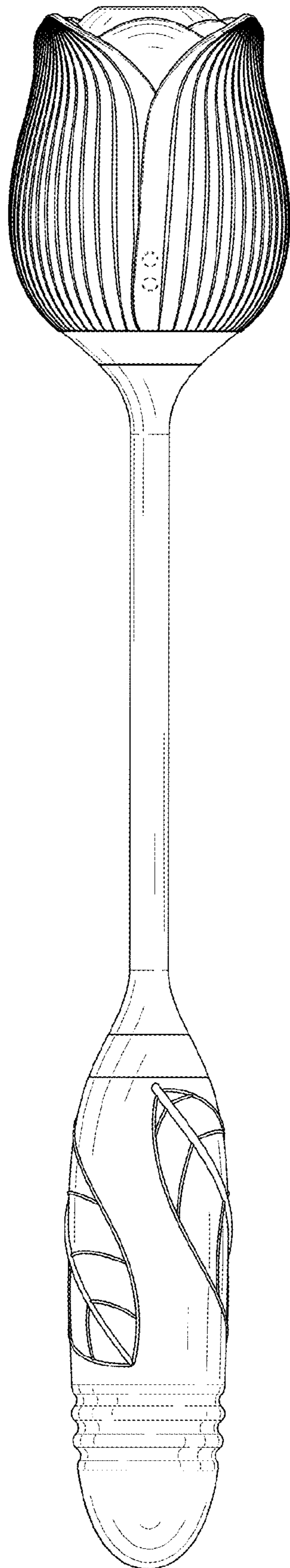

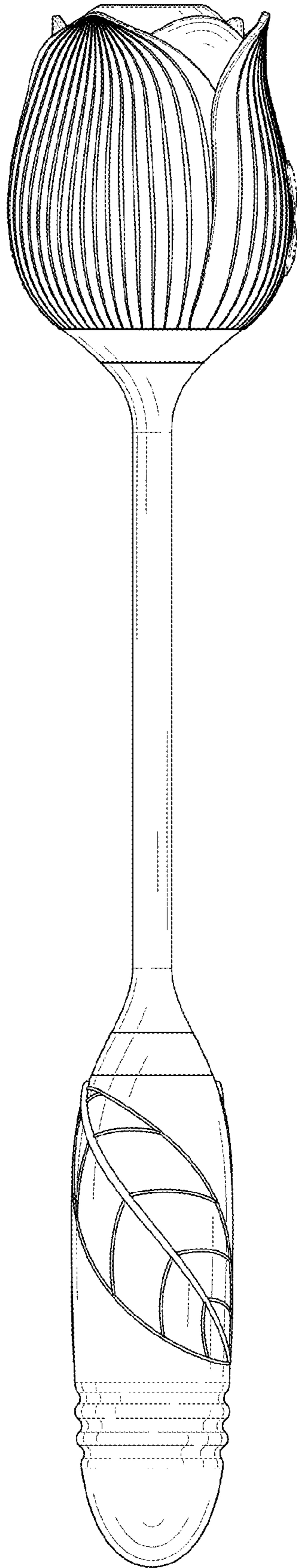

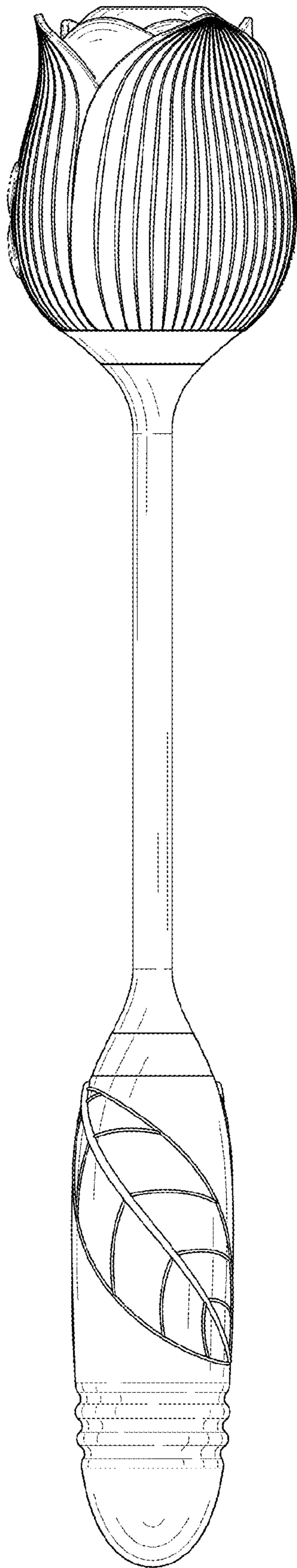

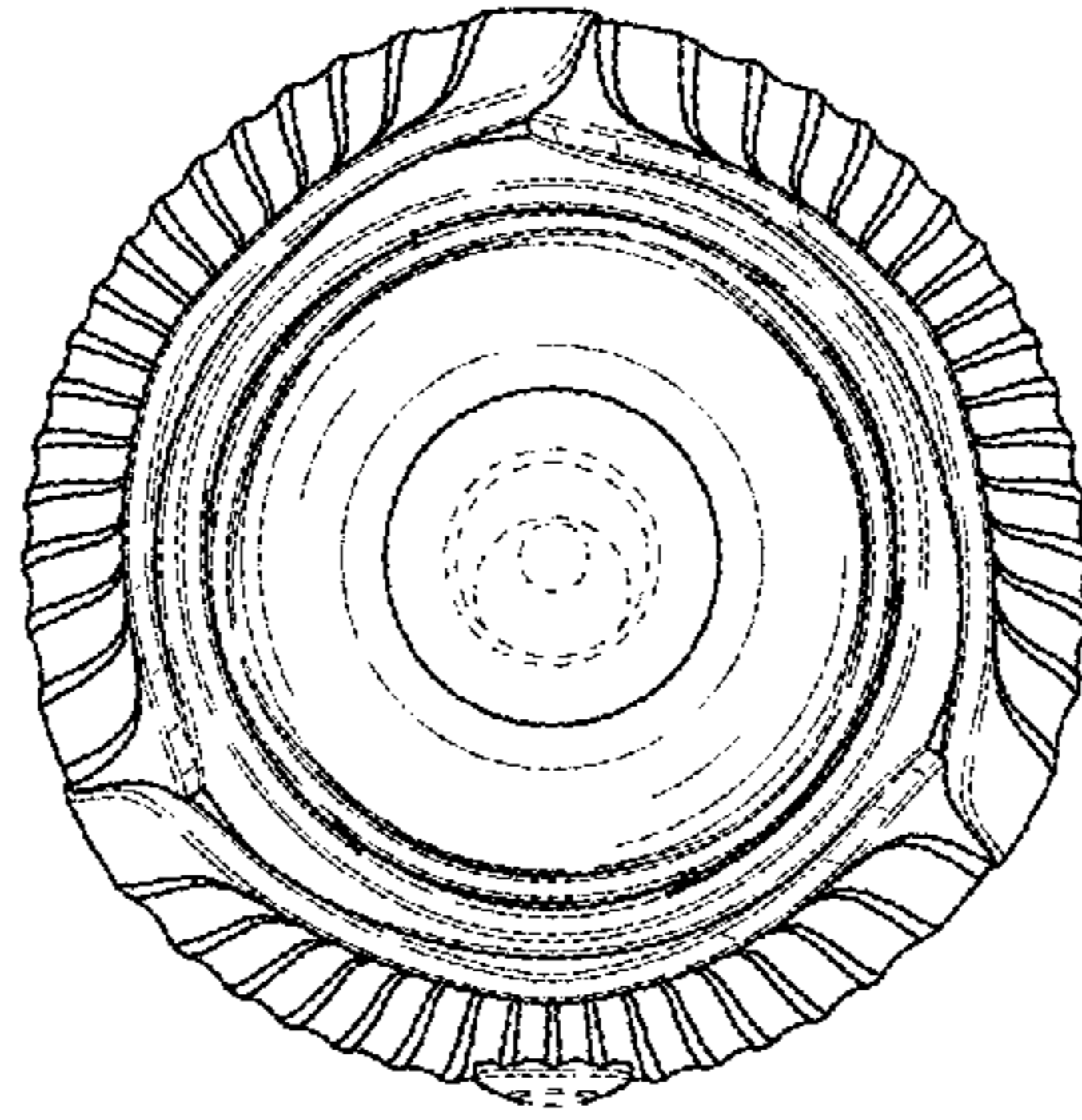

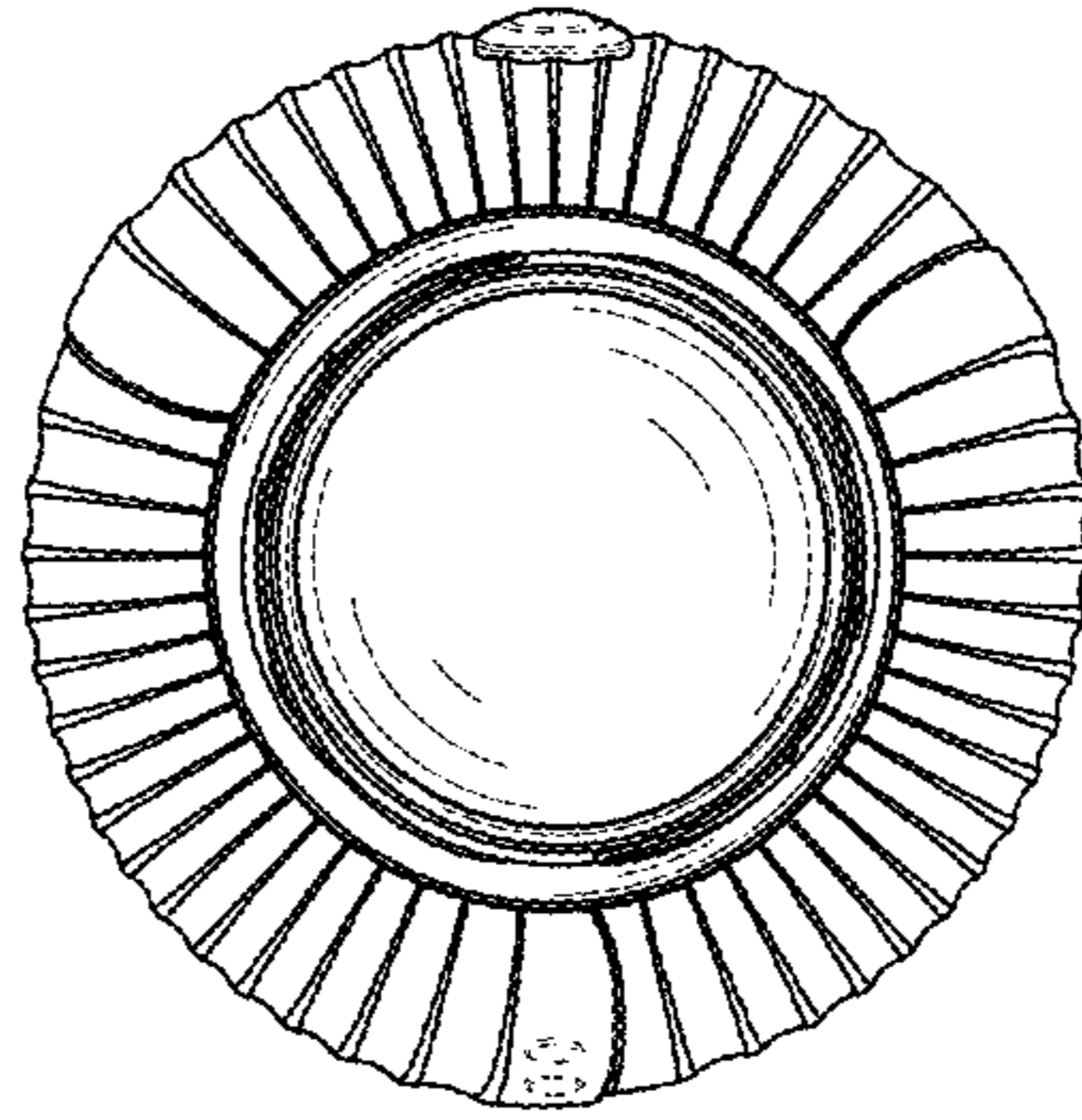

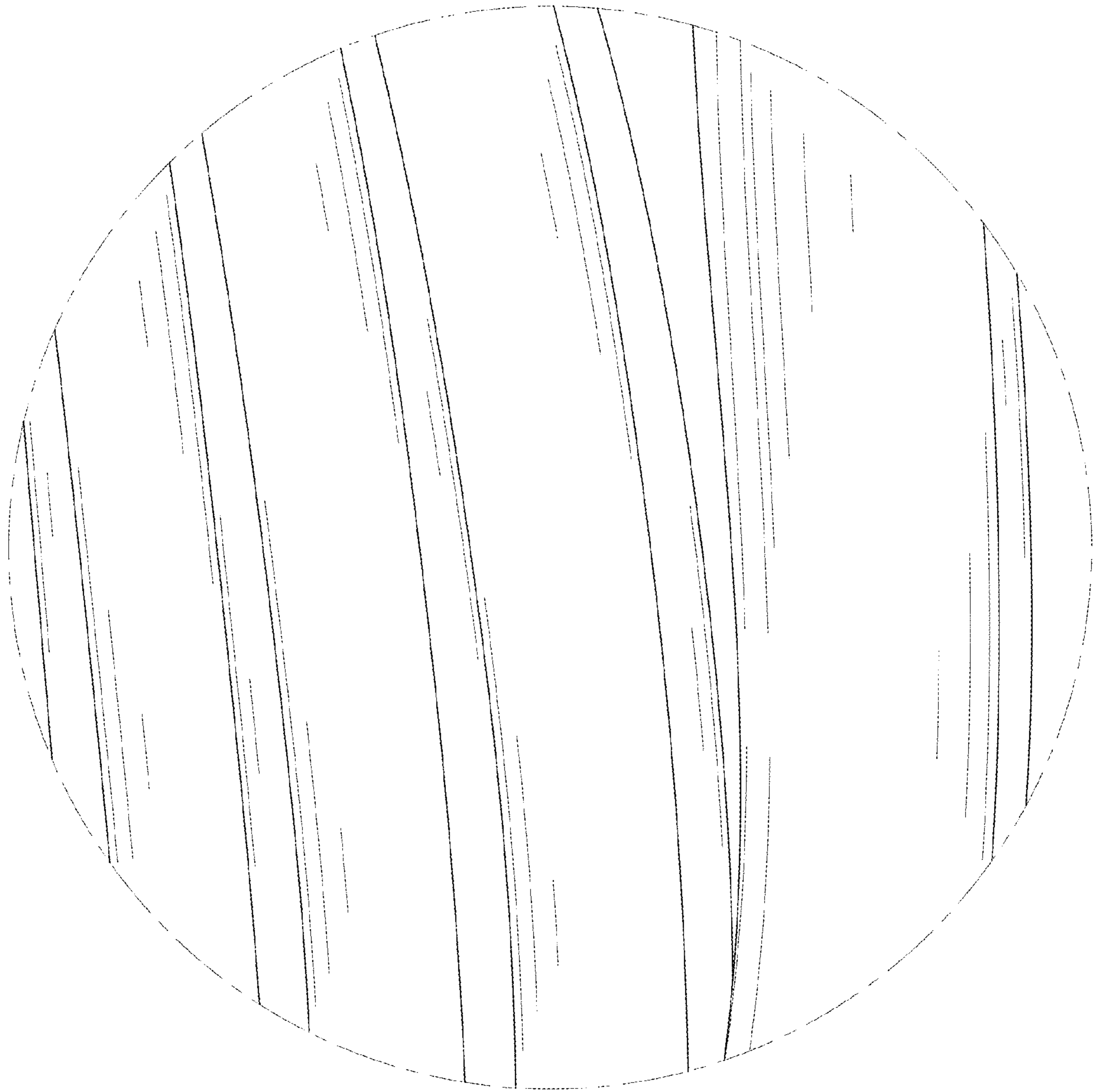

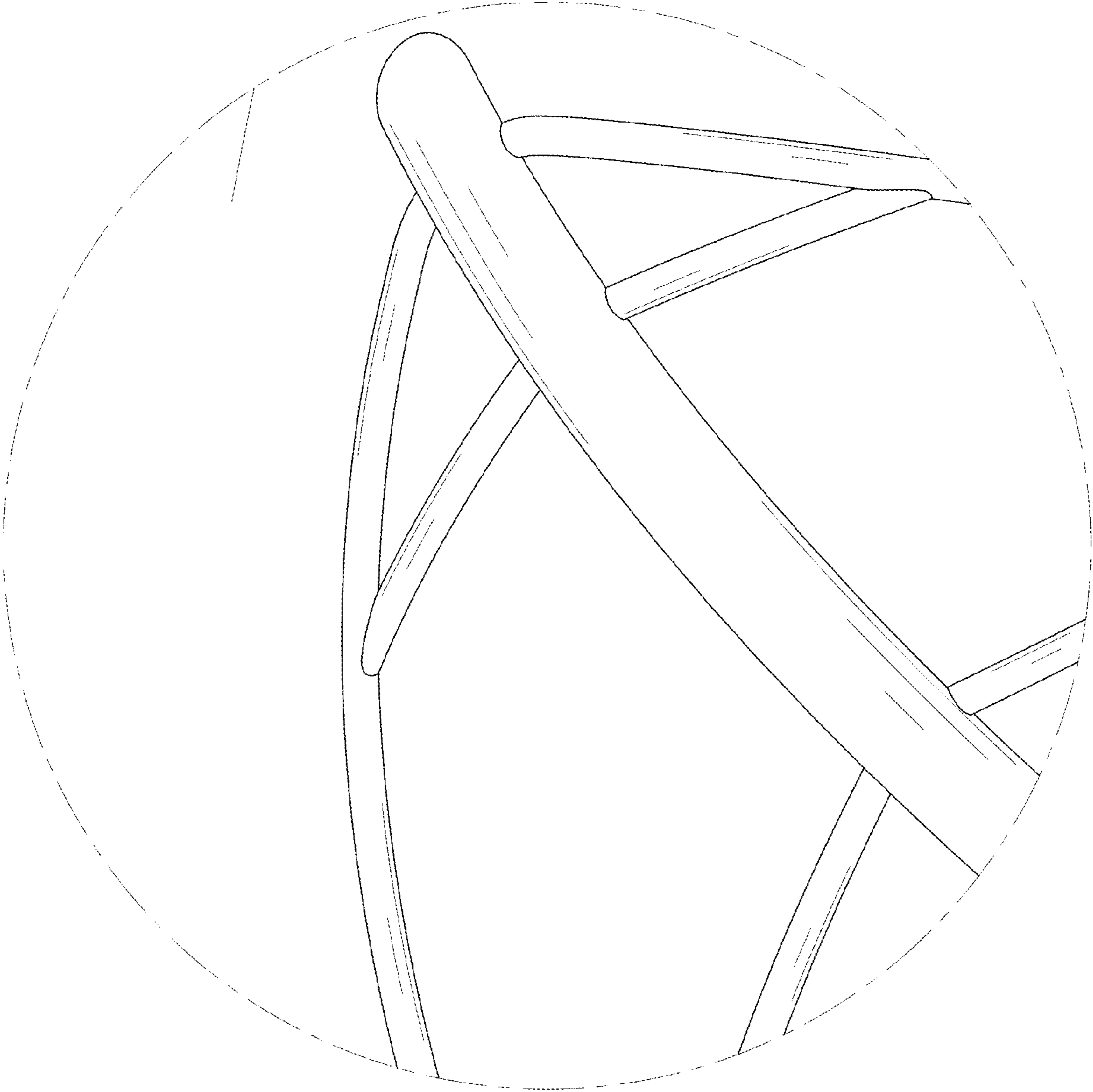
