(57) **CLAIM**

The ornamental design for a mortar and pestle, as shown and described.

DESCRIPTION

FIG. 1 is a front top perspective view of a mortar and pestle in a first configuration.

FIG. 2 is a rear bottom perspective view of the mortar and pestle as configured in FIG. 1.

FIG. 3 is a front view of the mortar and pestle as configured in FIG. 1. A rear view of the mortar and pestle as configured in FIG. 1 is the same as the front view.

FIG. 4 is a right side view of the mortar and pestle as configured in FIG. 1. A left side view of the mortar and pestle as configured in FIG. 1 is the same as the right side view.

FIG. 5 is a top view of the mortar and pestle as configured in FIG. 1.

FIG. 6 is a bottom view of the mortar and pestle as configured in FIG. 1.

FIG. 7 is a sectional view taken along line 7-7 of FIG. 3.

FIG. 8 is a sectional view taken along line 8-8 of FIG. 4.

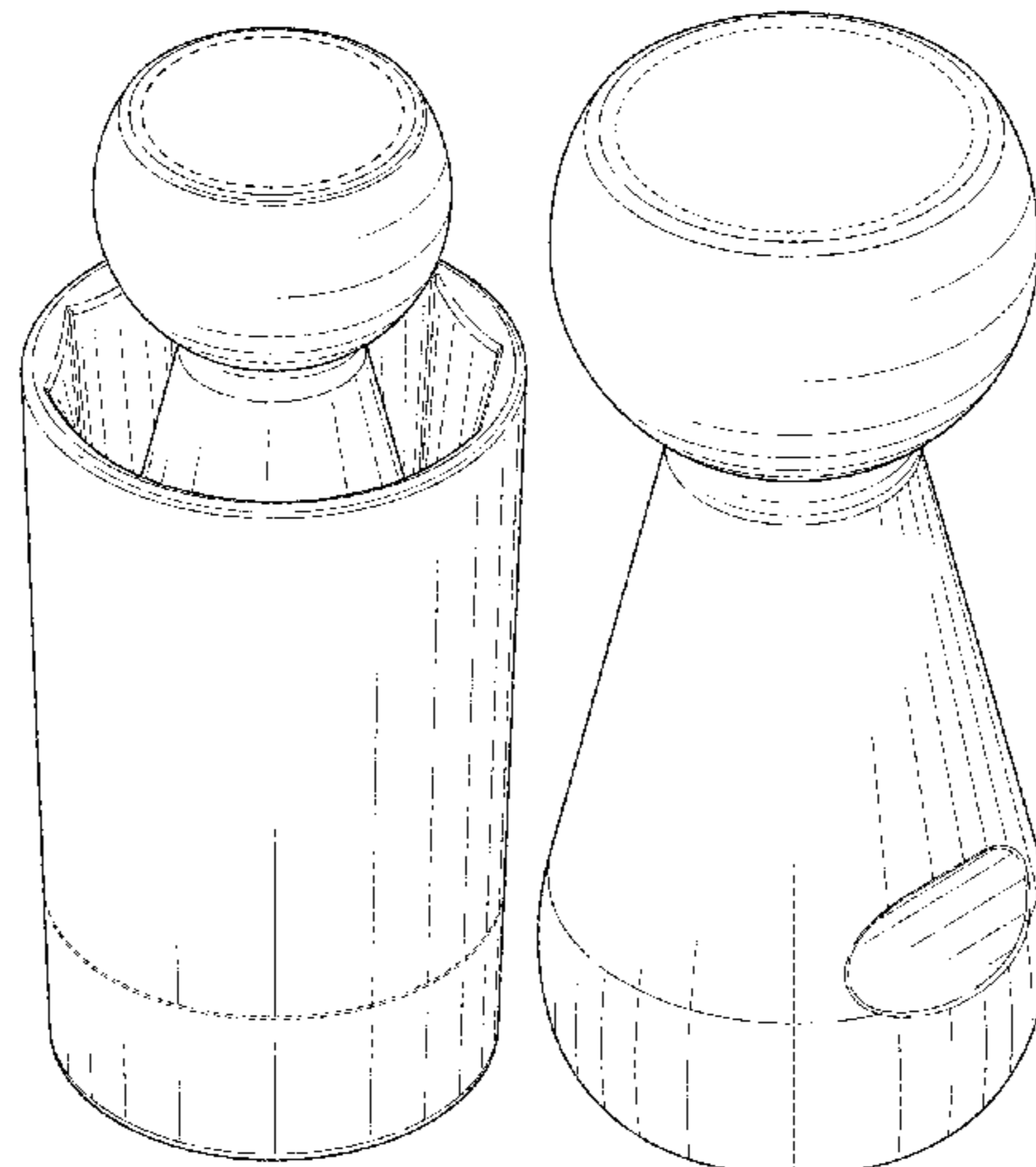


FIG. 16 is a bottom view of the mortar and pestle as configured in FIG. 10.

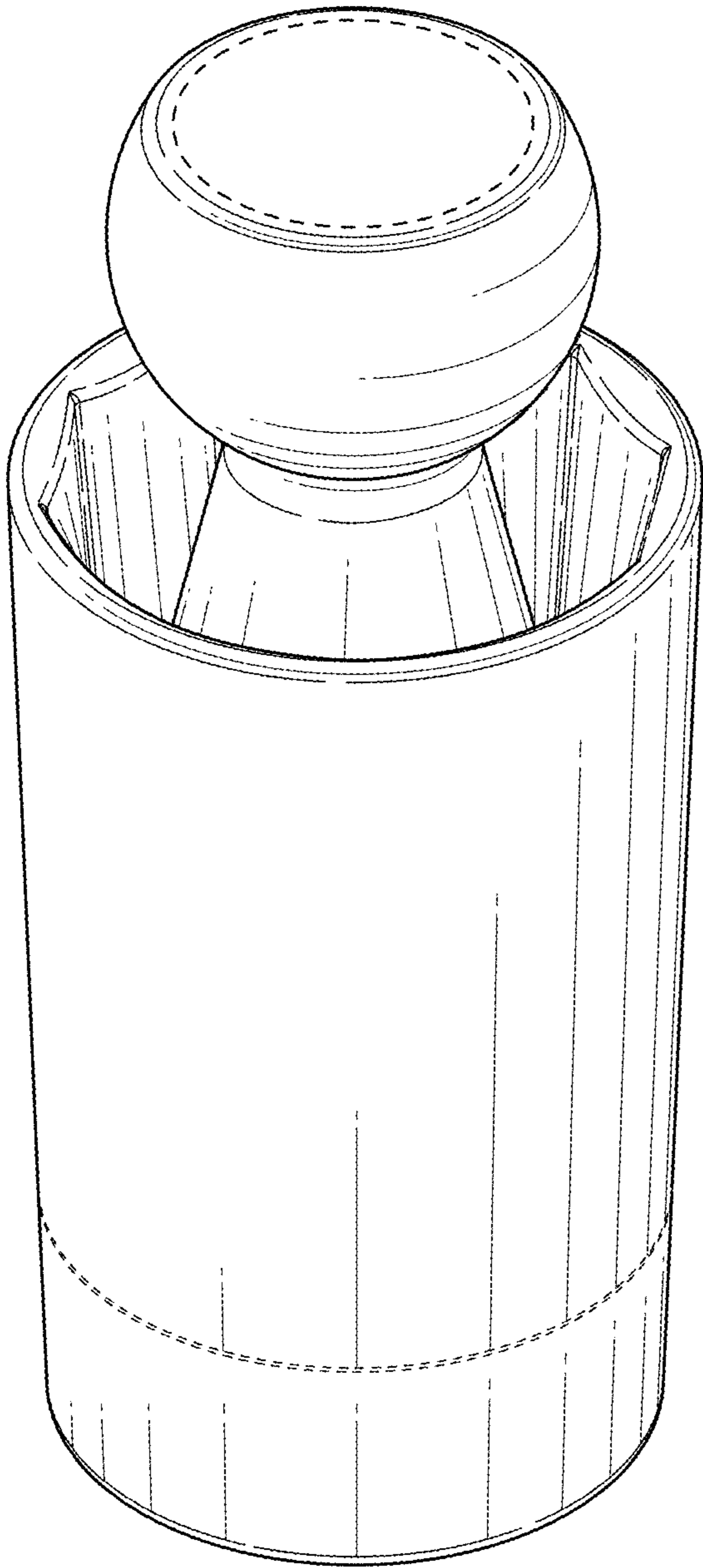

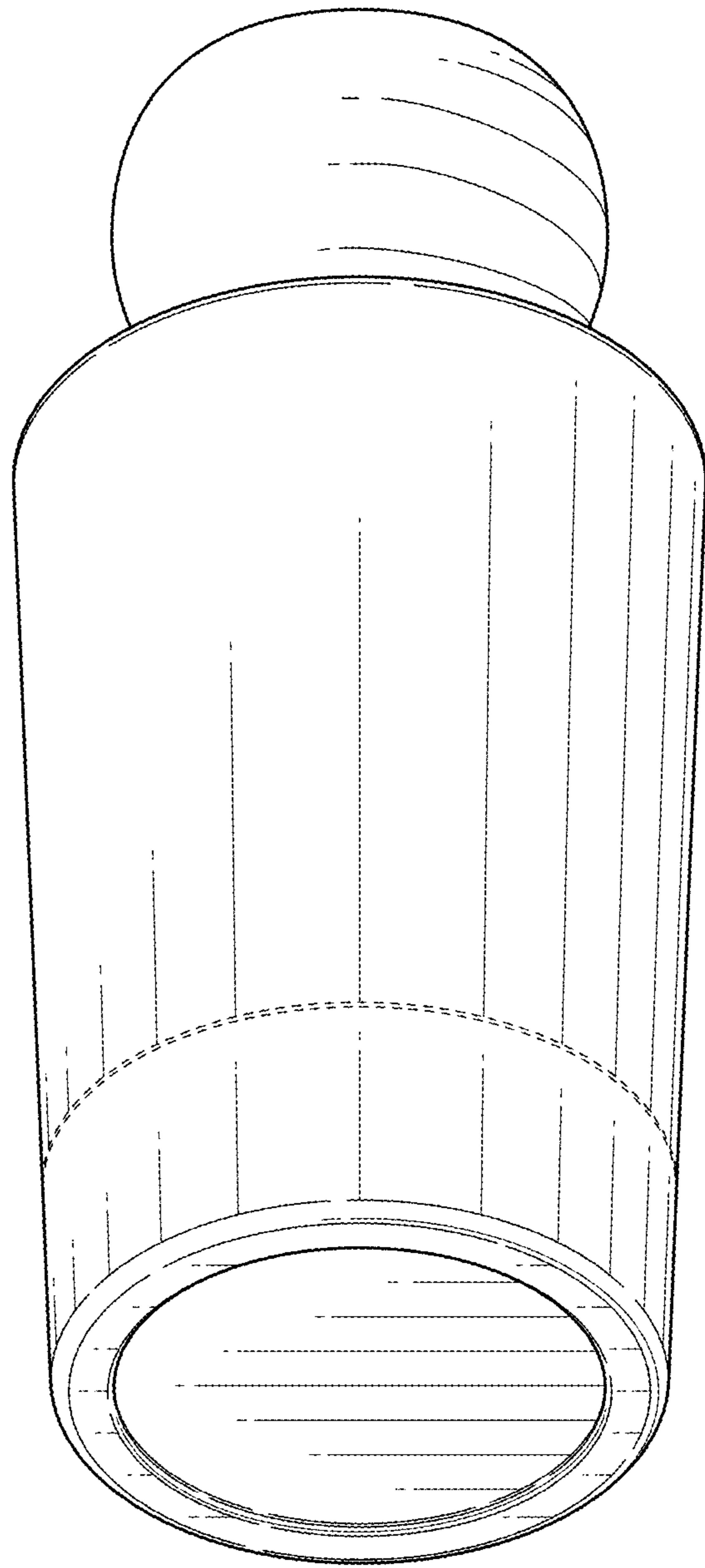

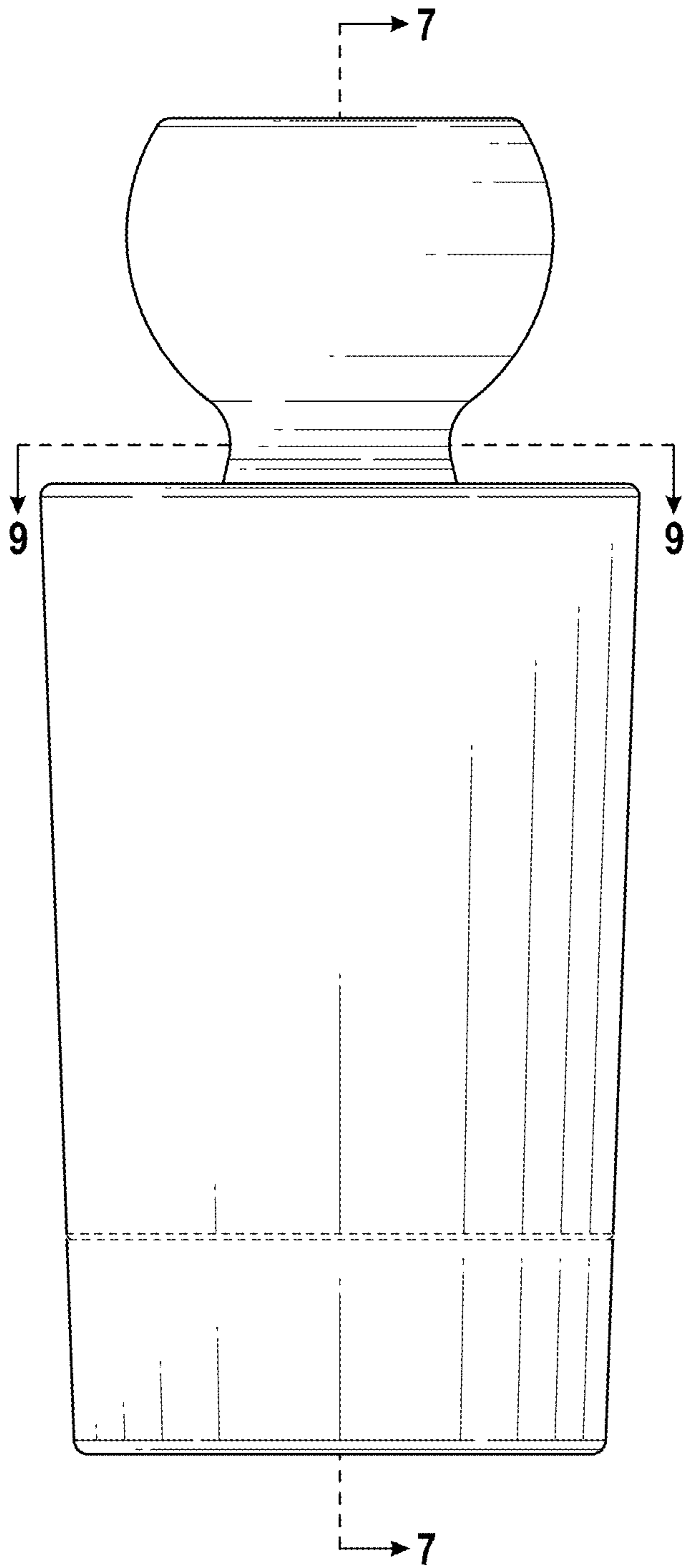

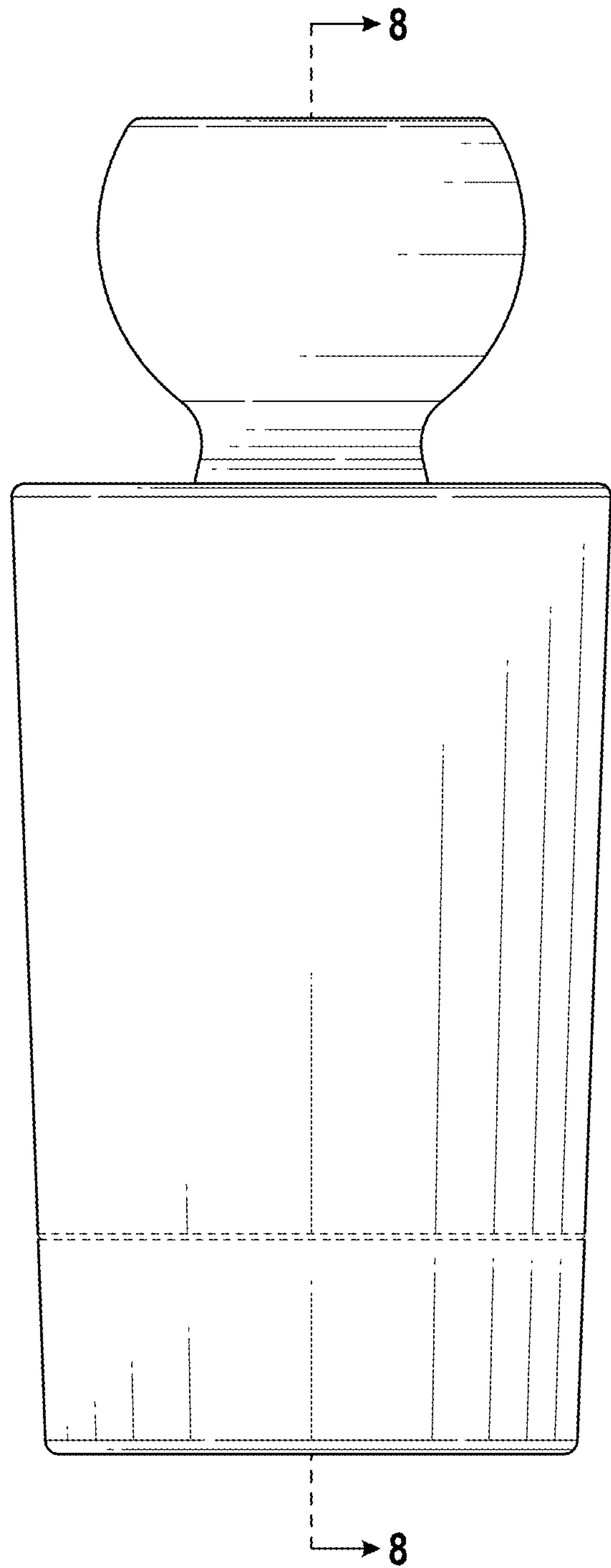

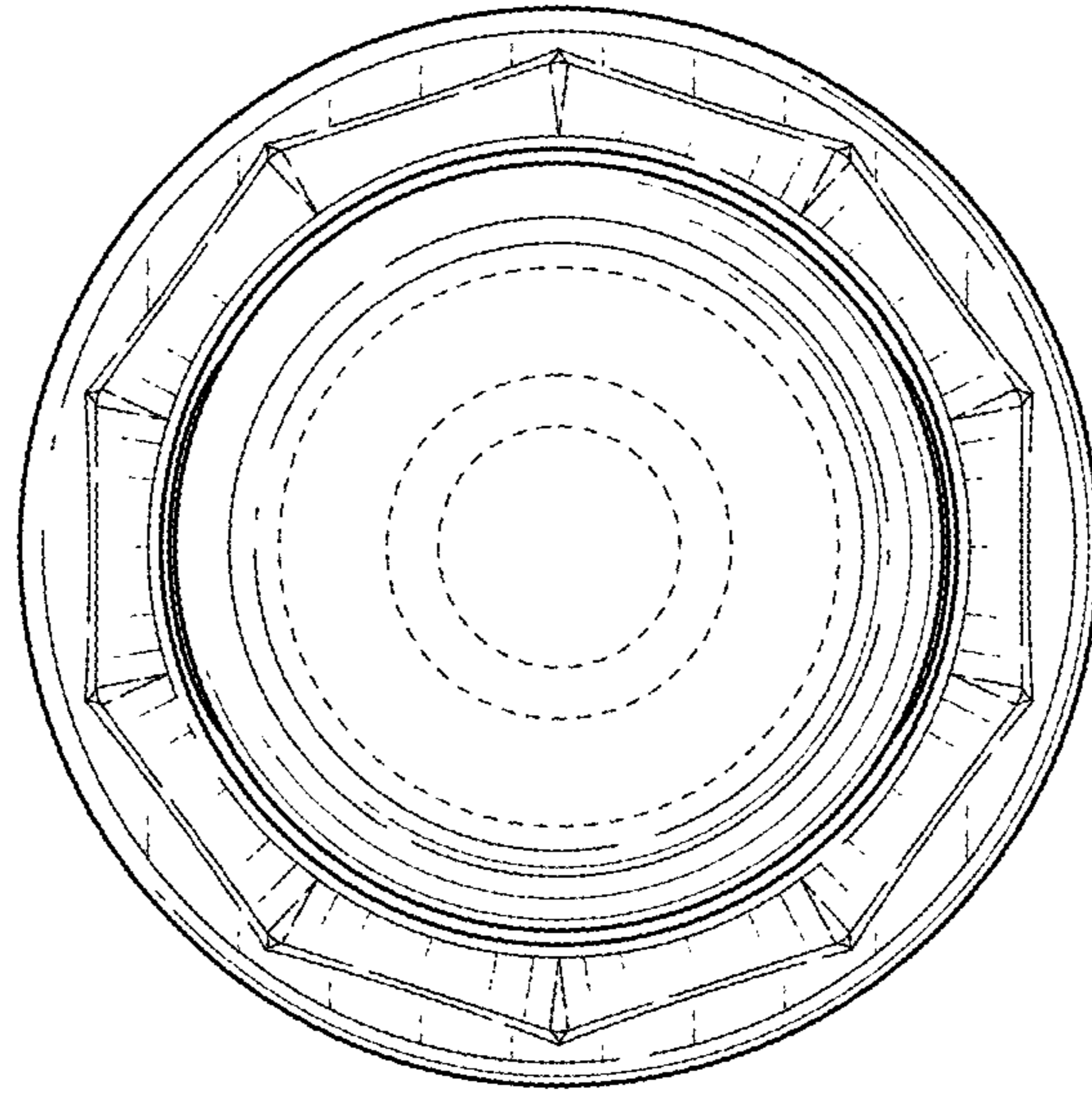

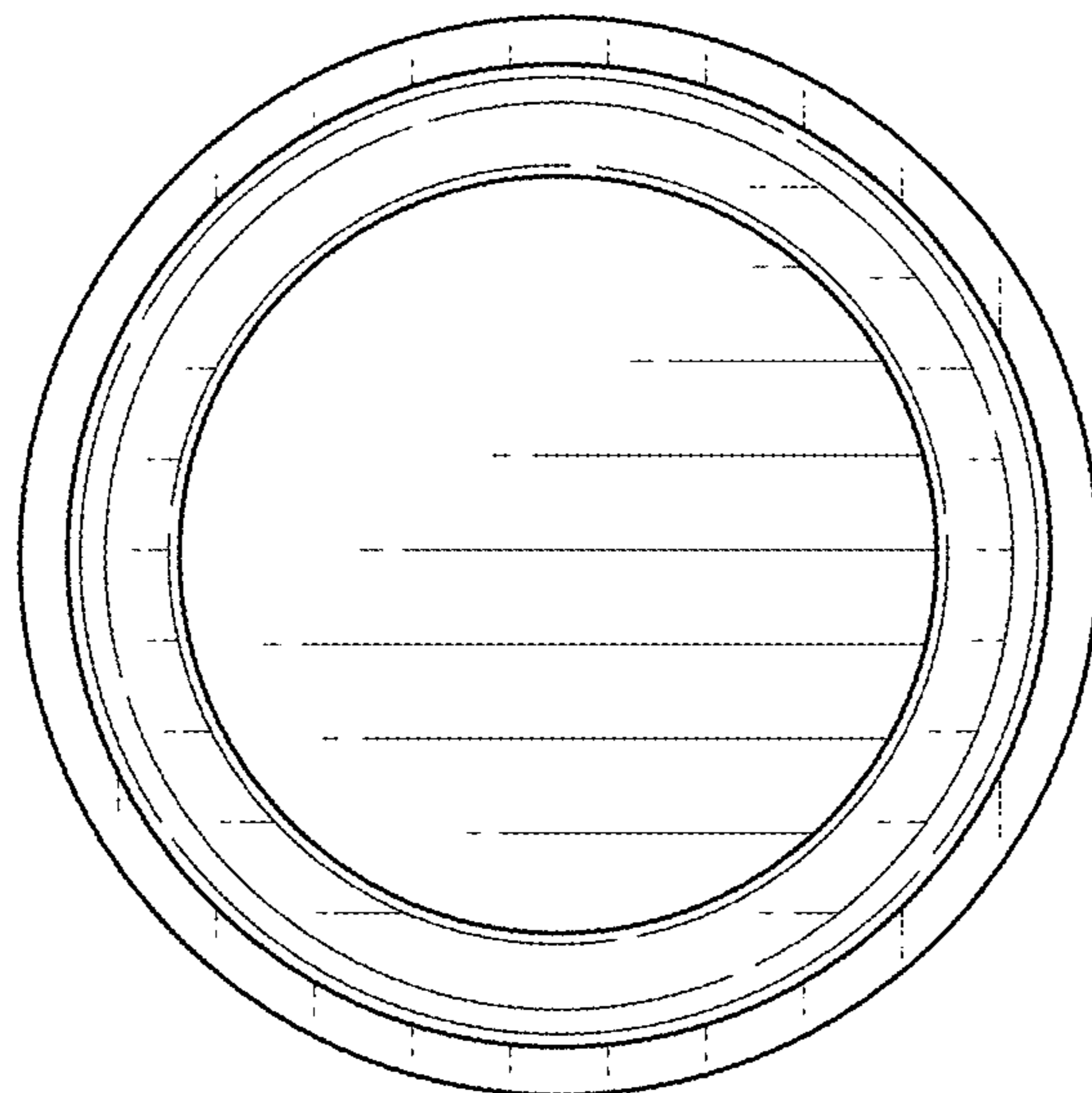

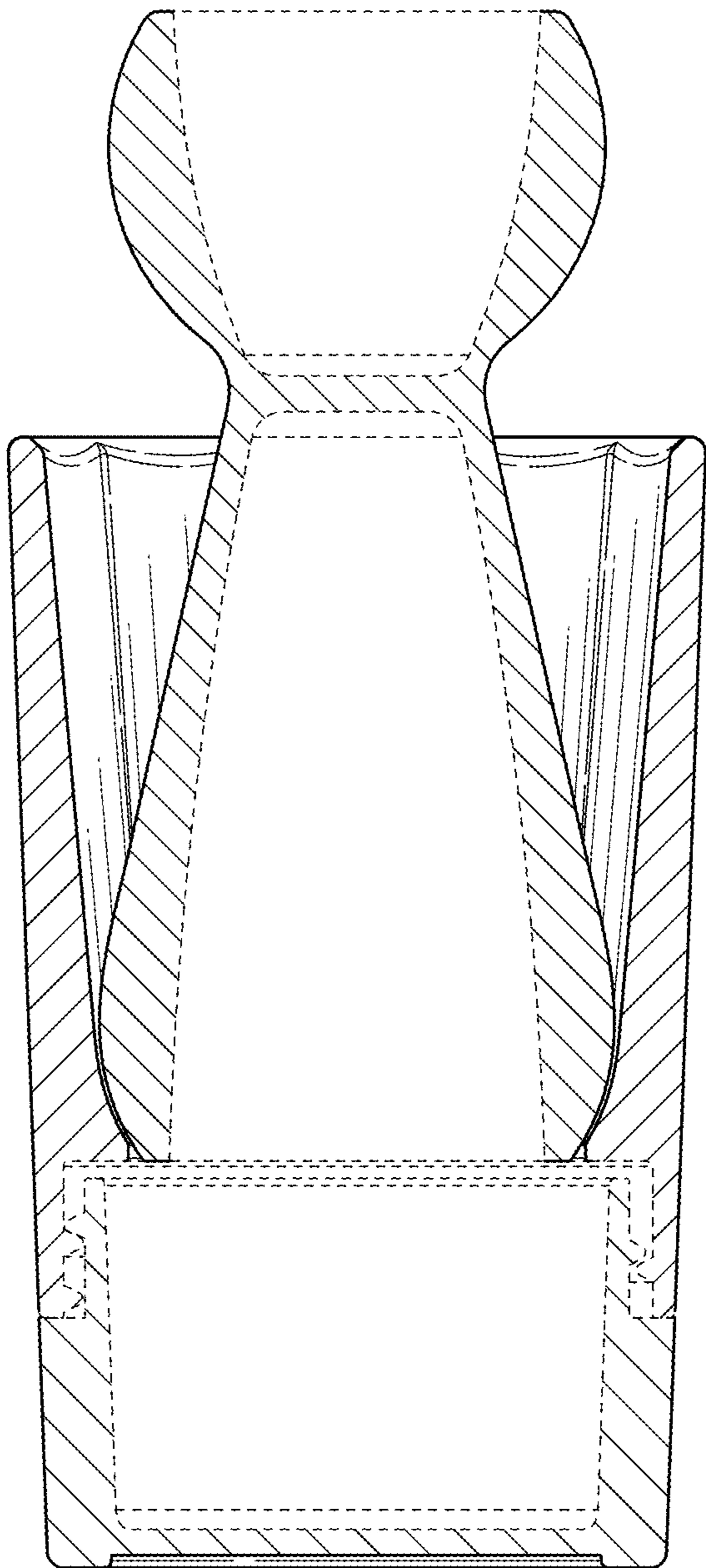

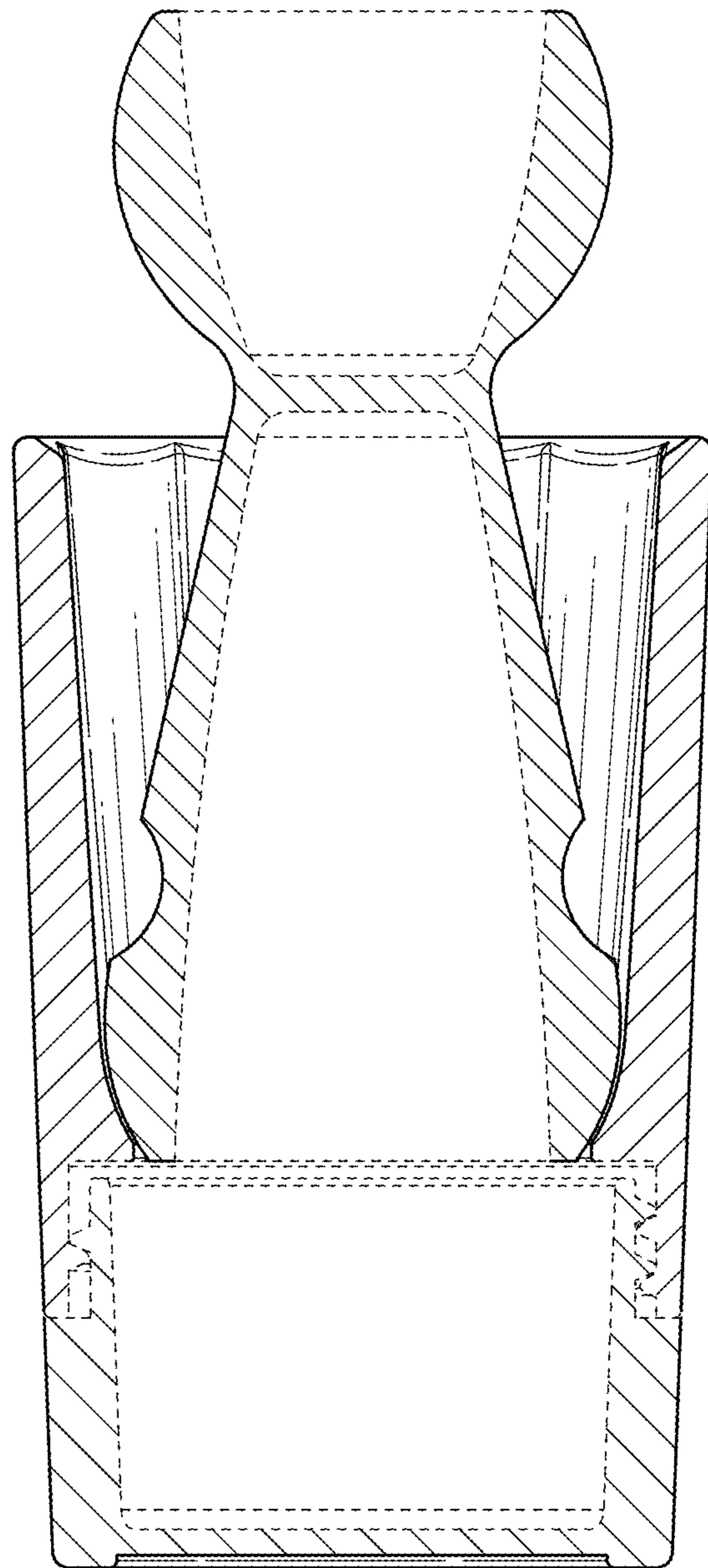

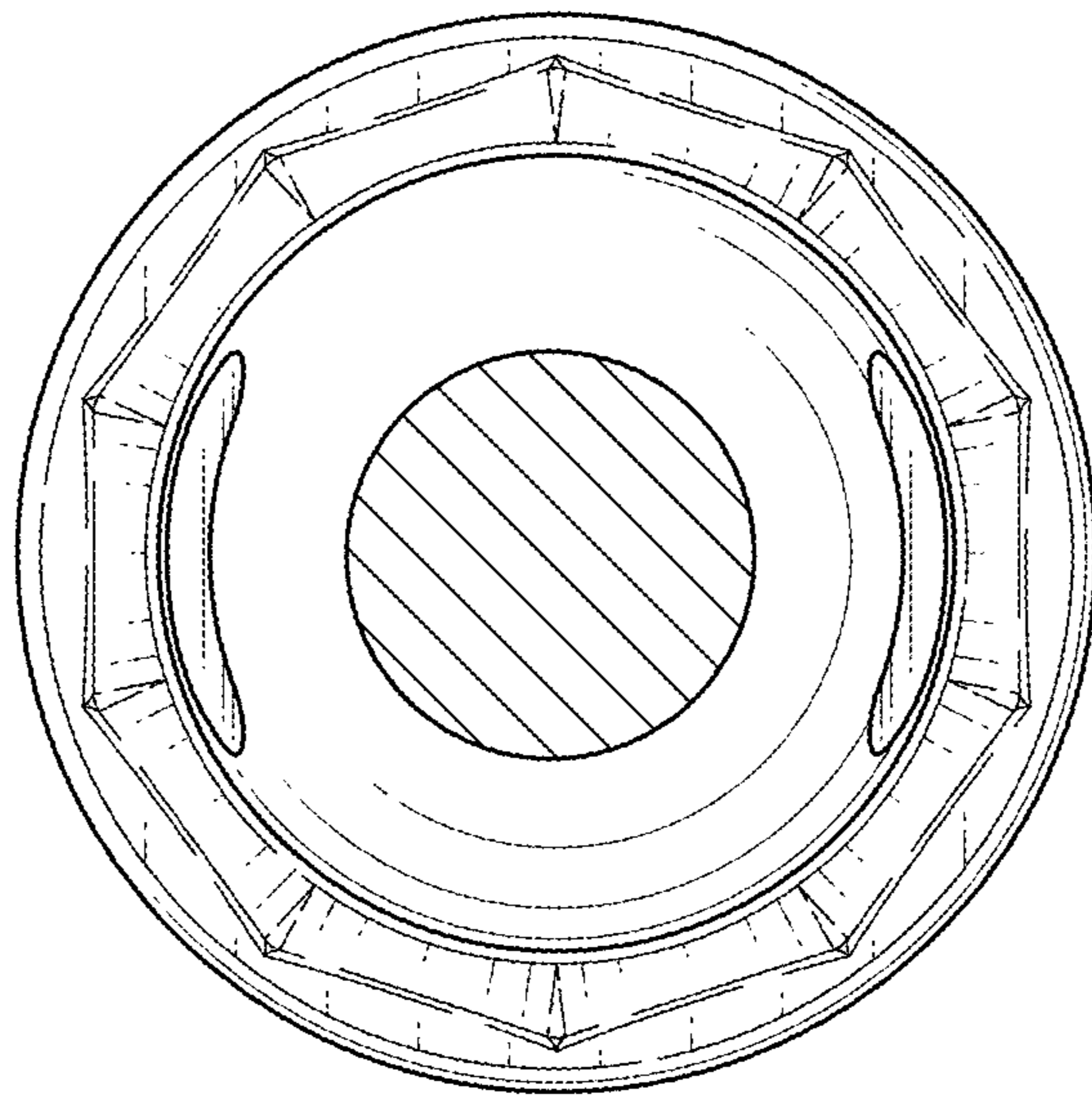

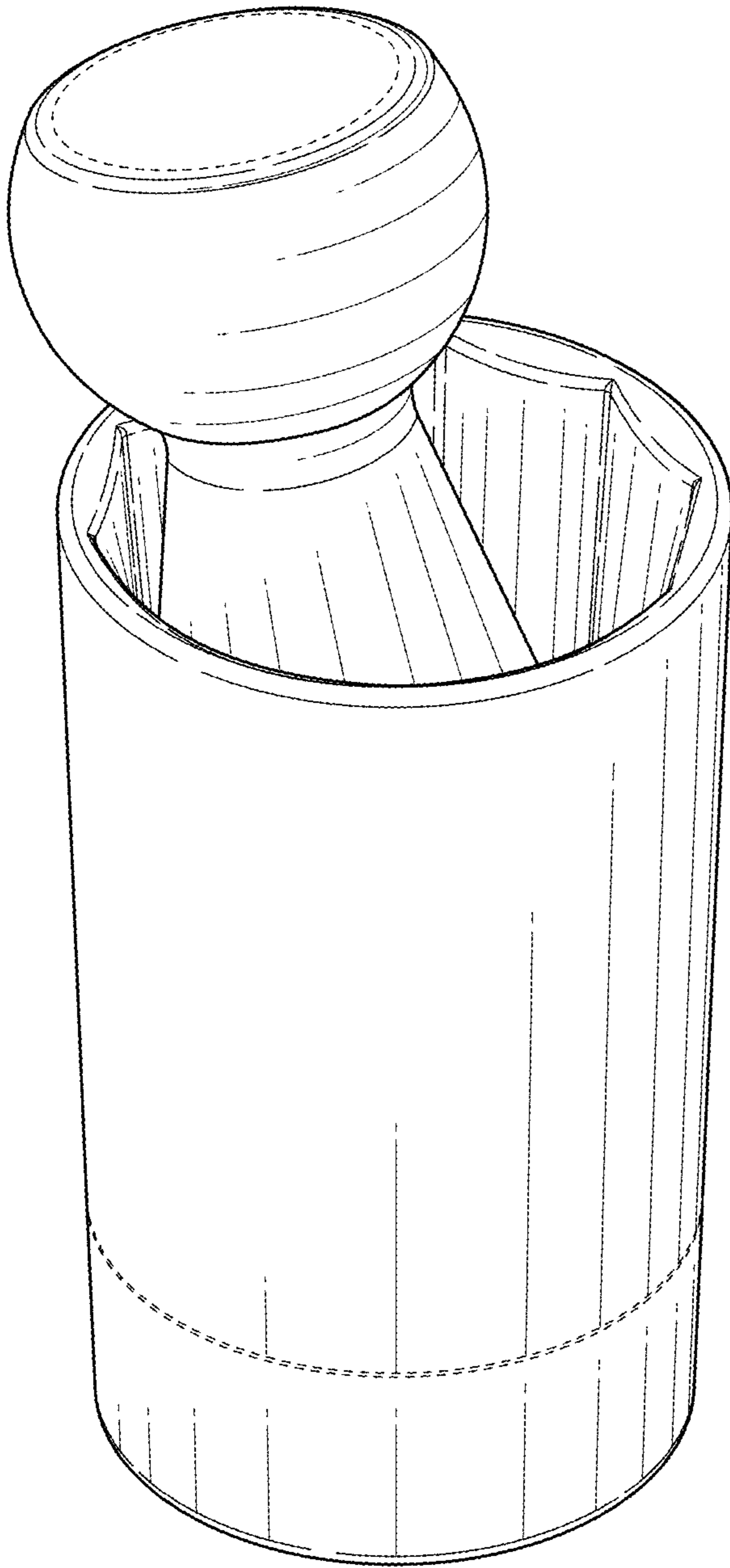

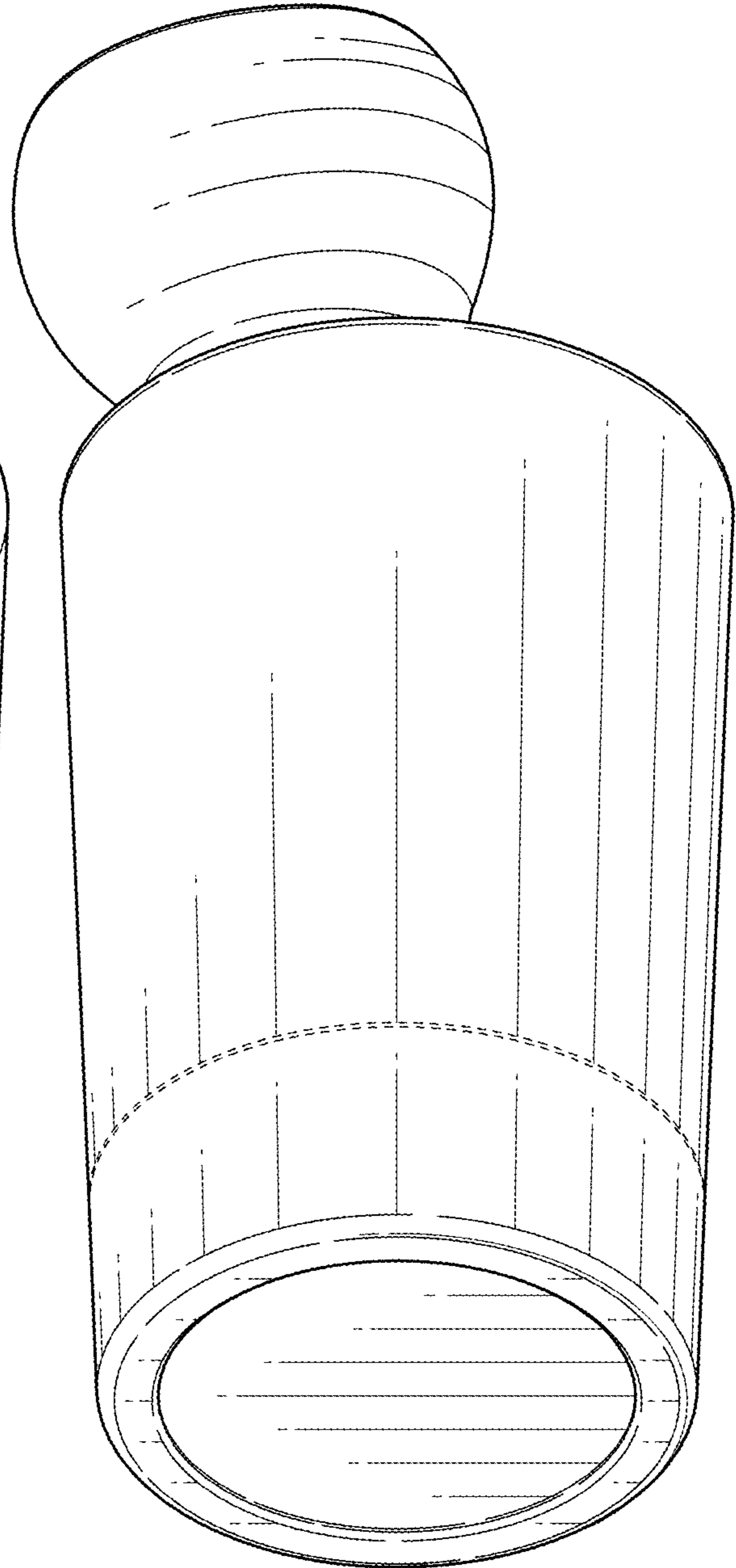

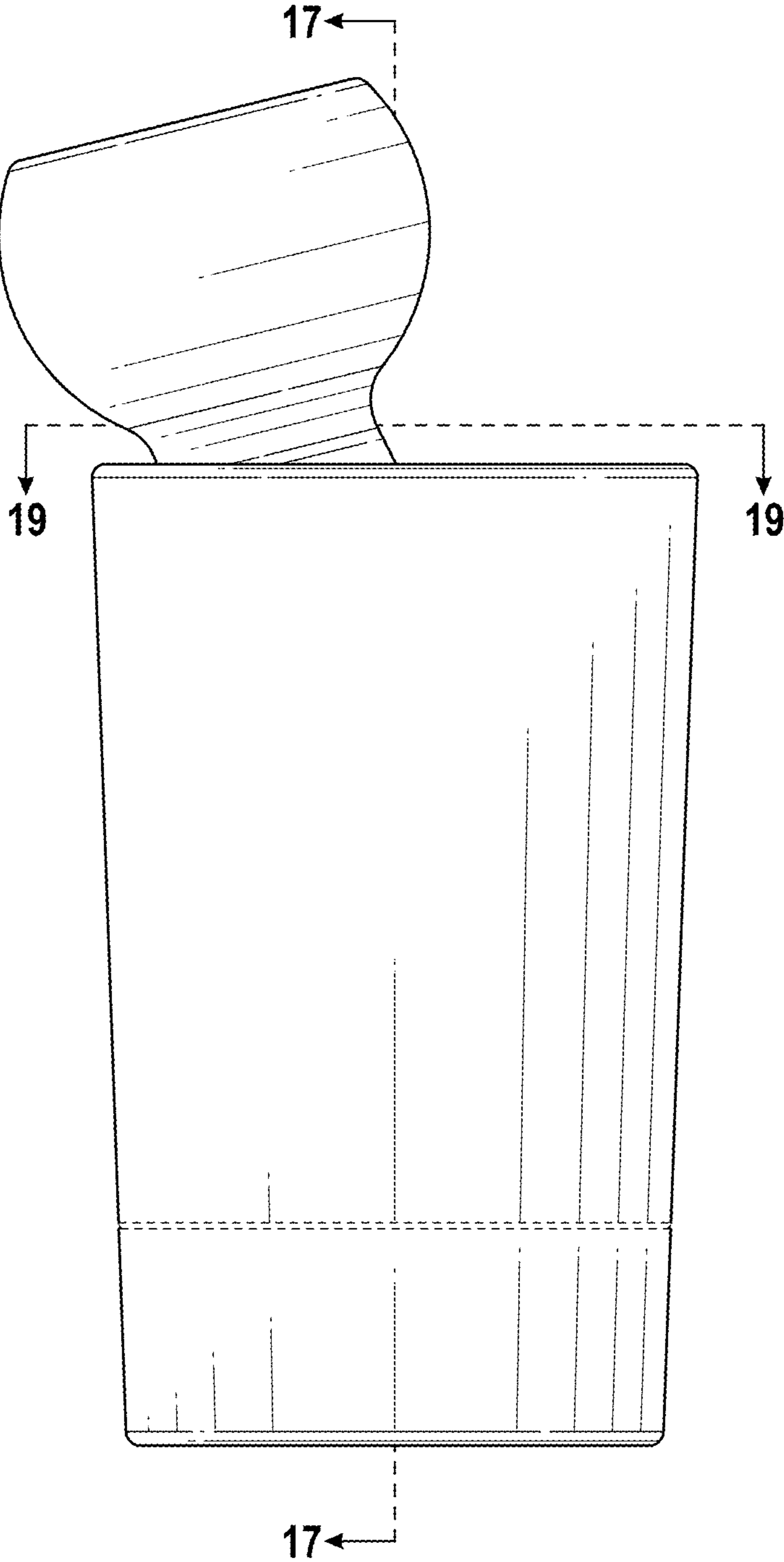
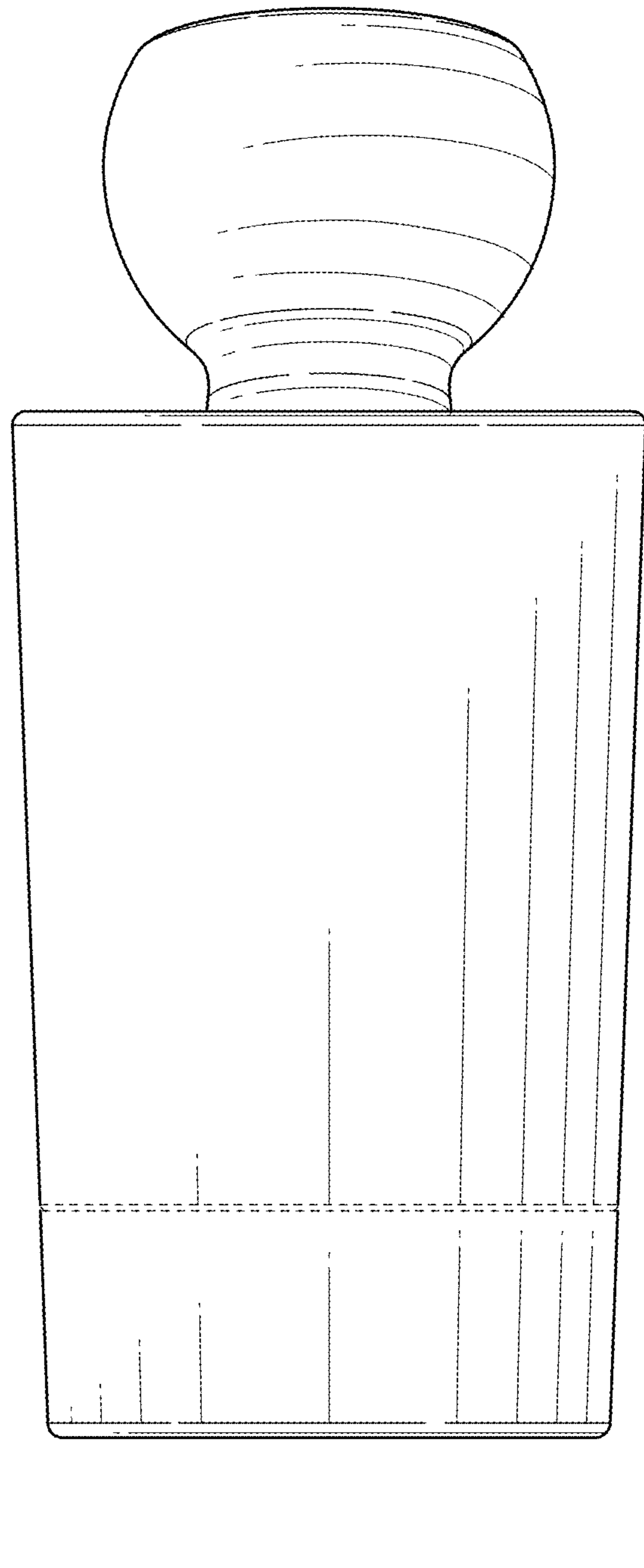
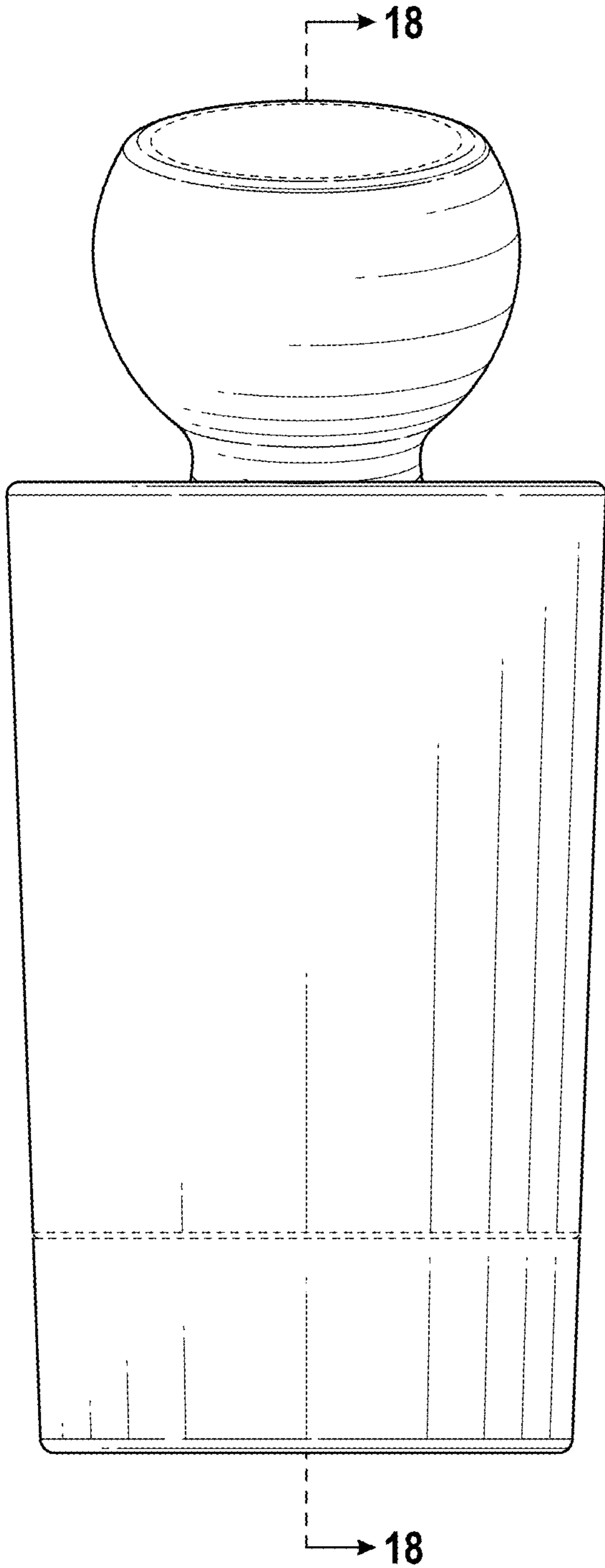

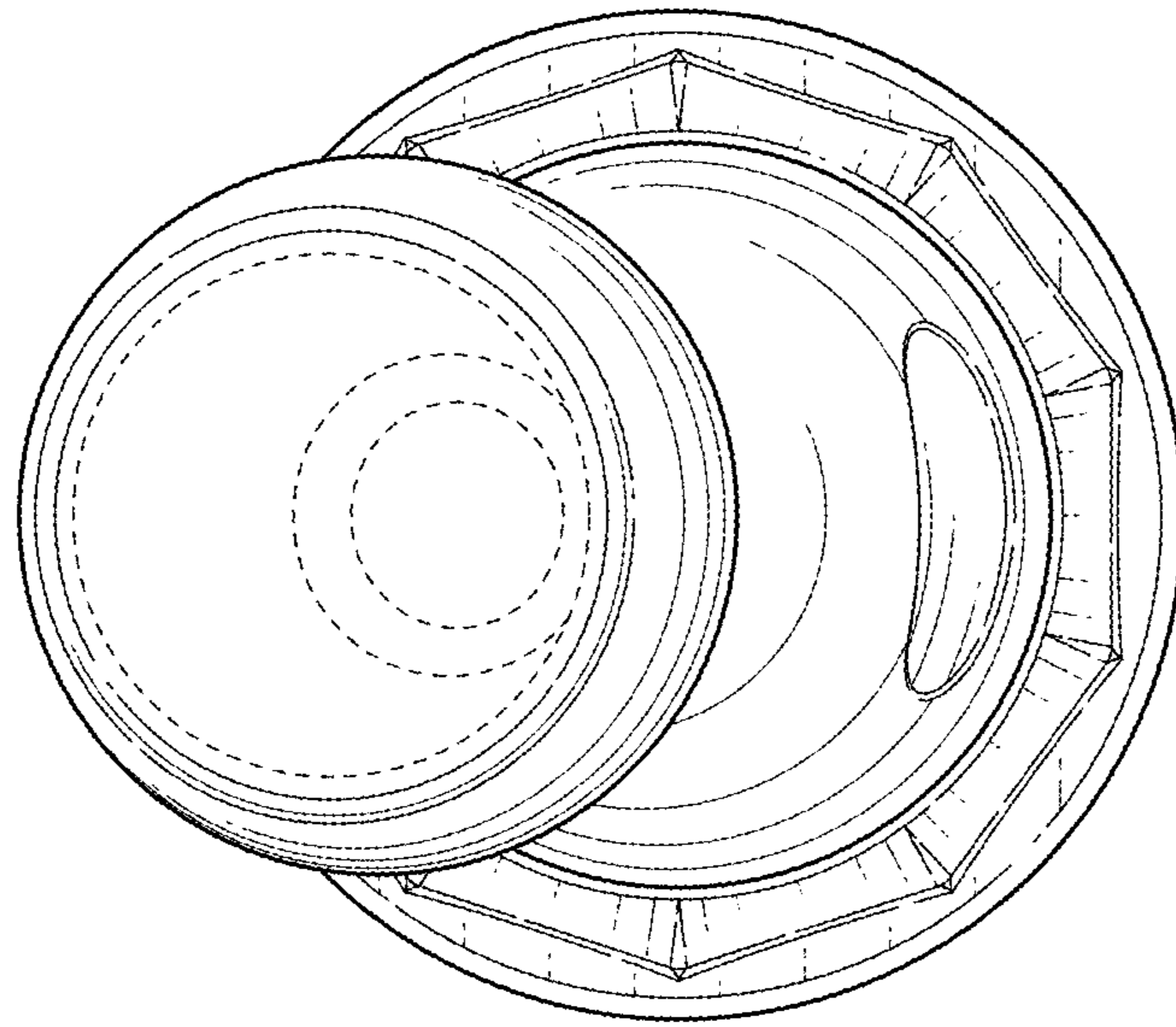

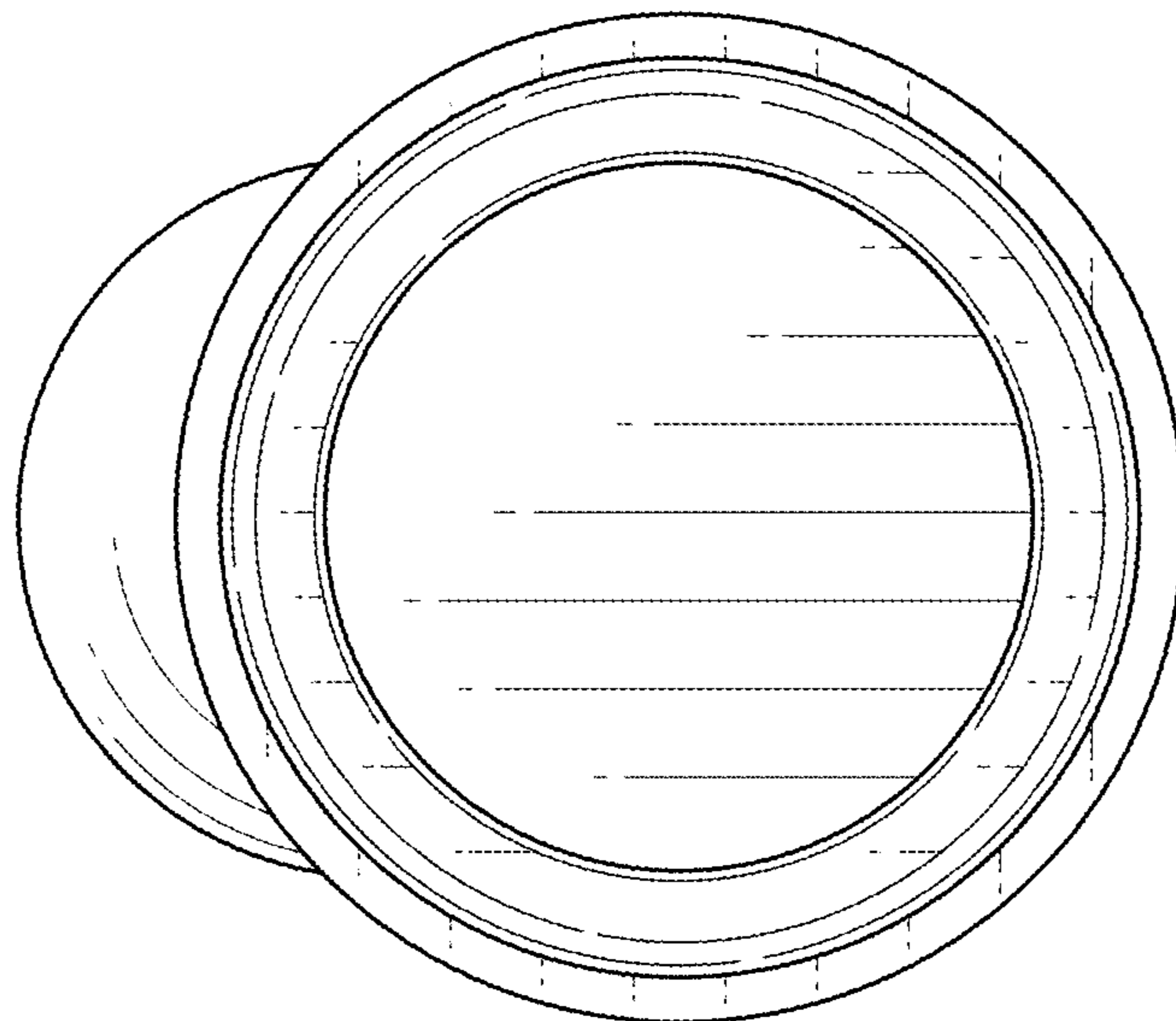

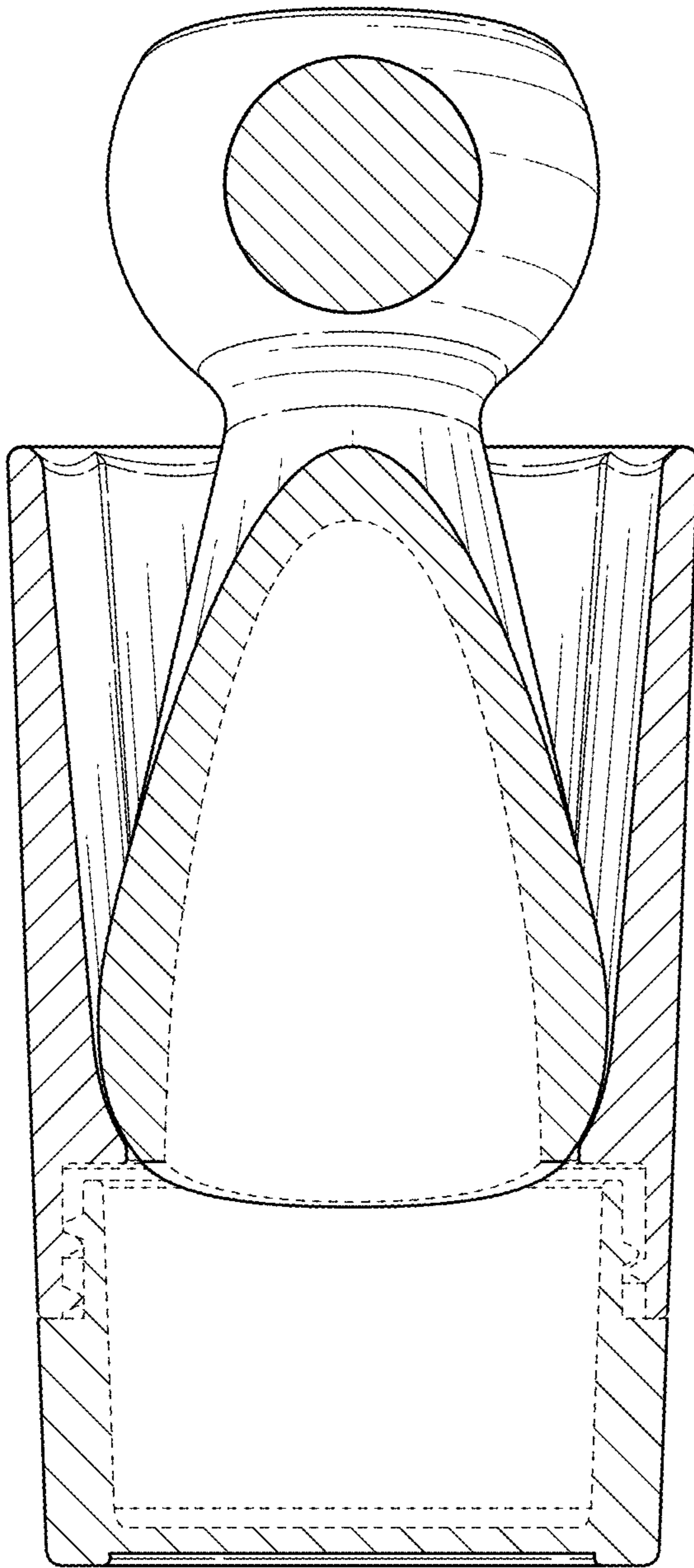

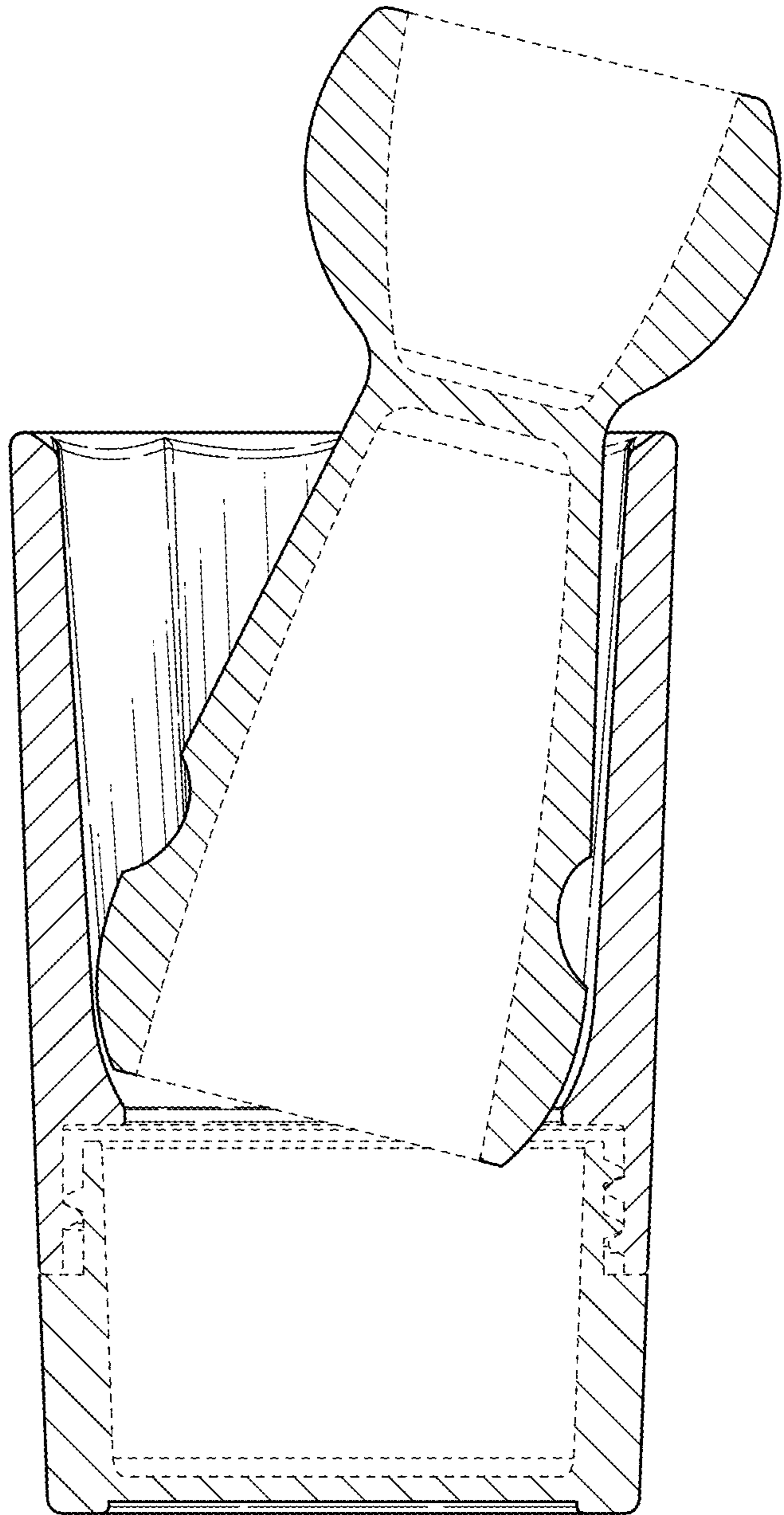

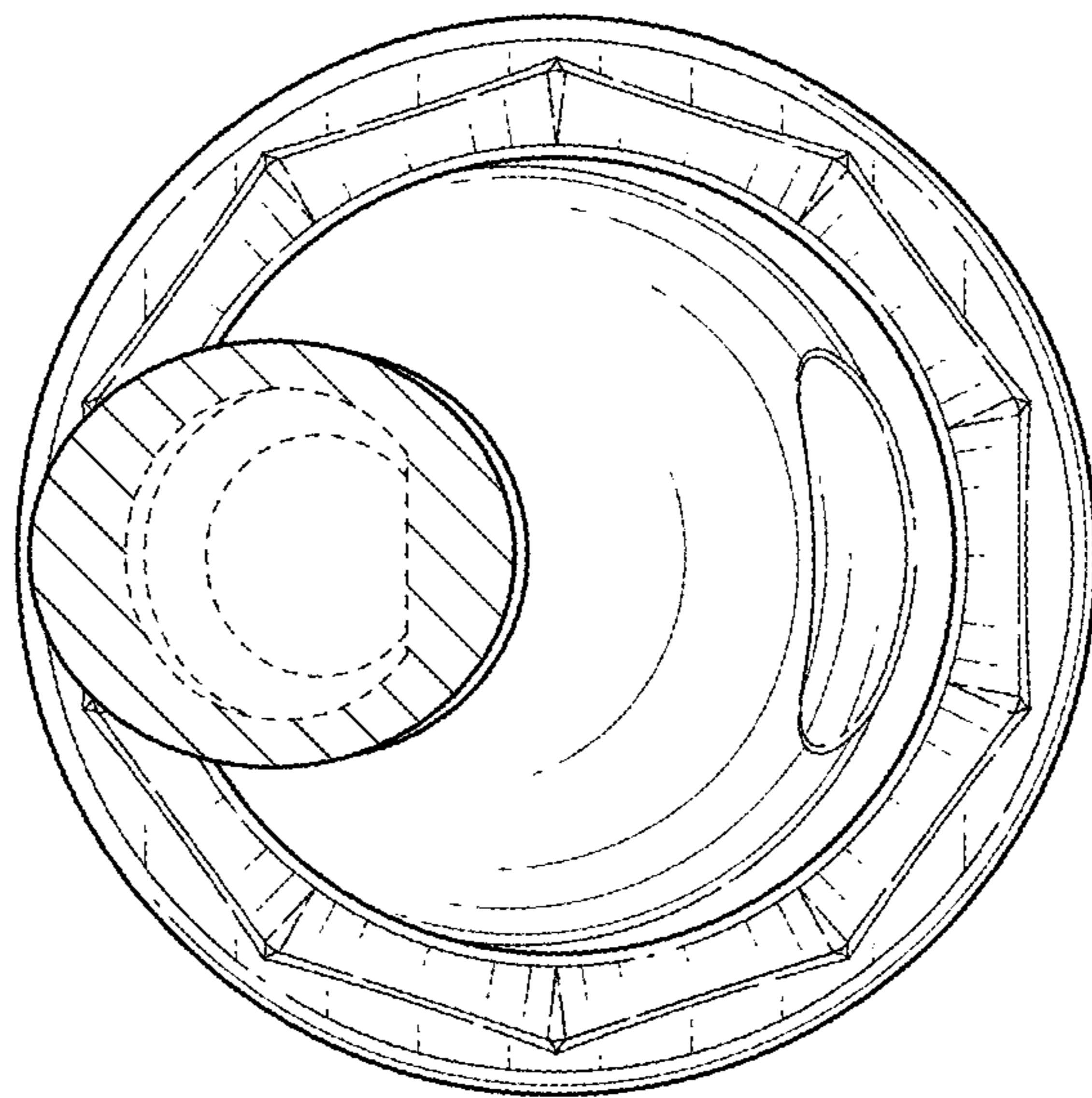

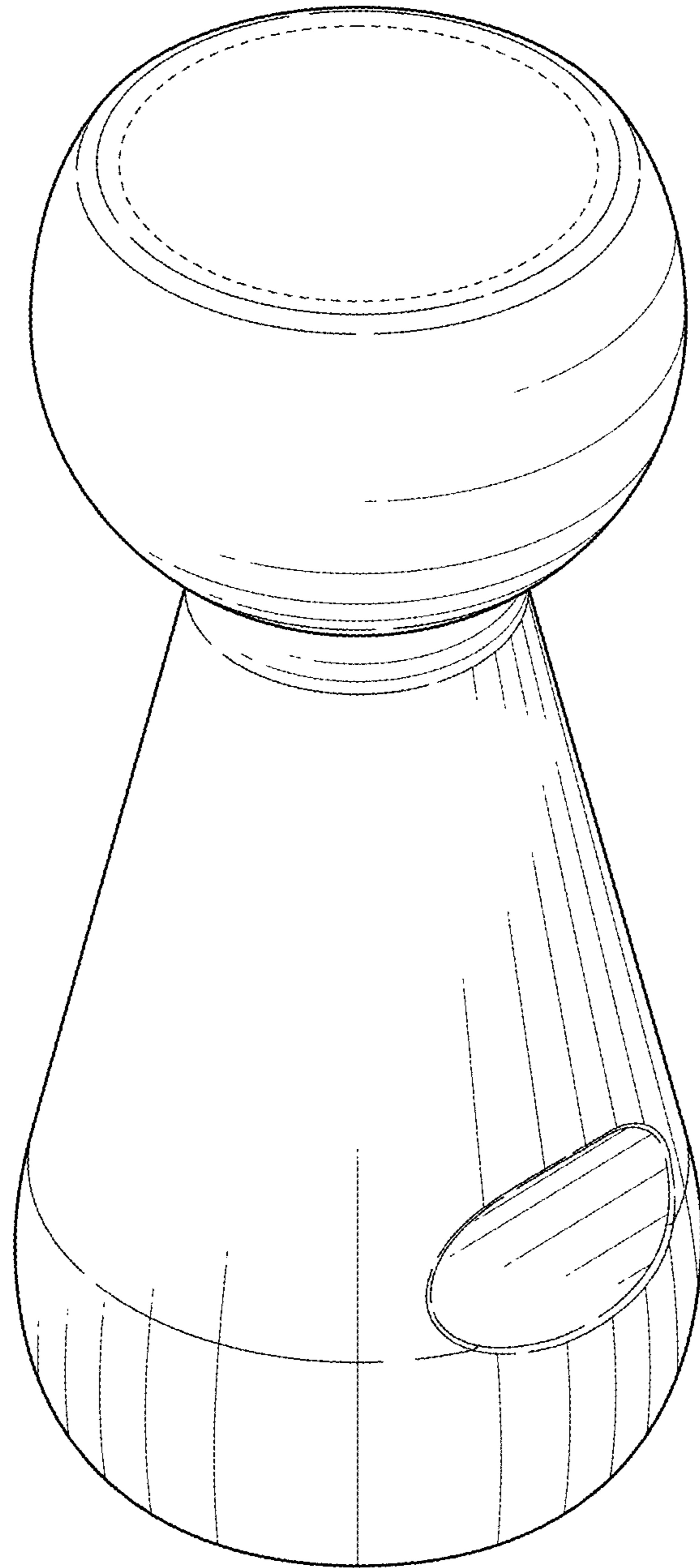

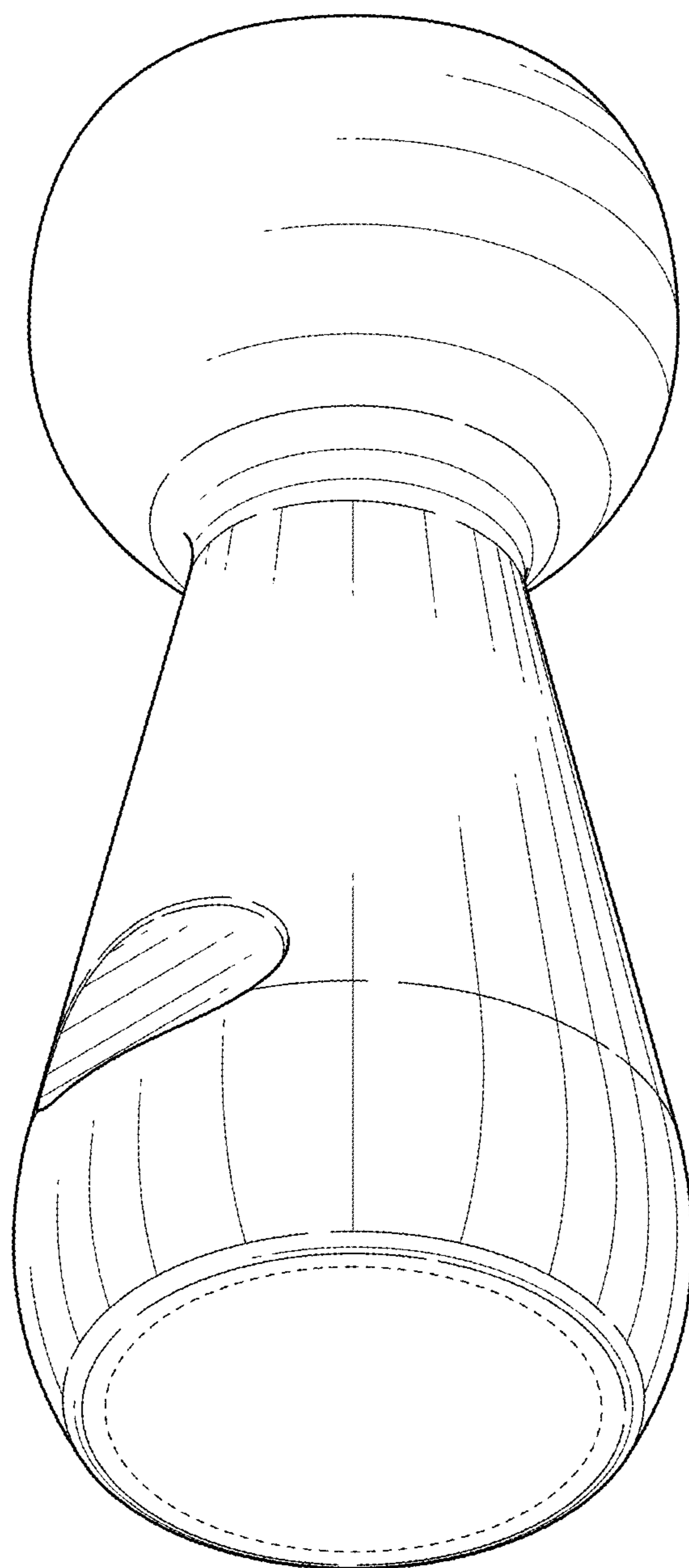

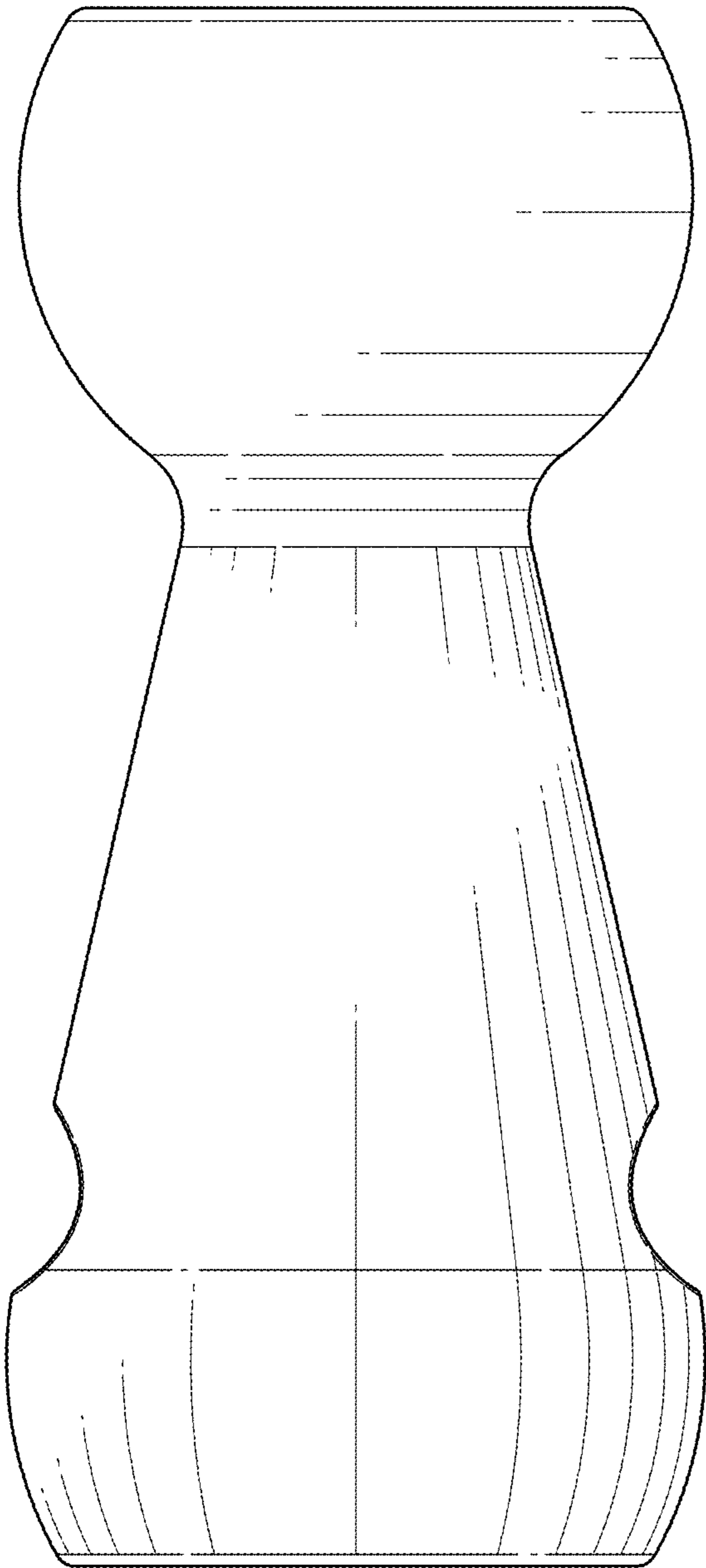

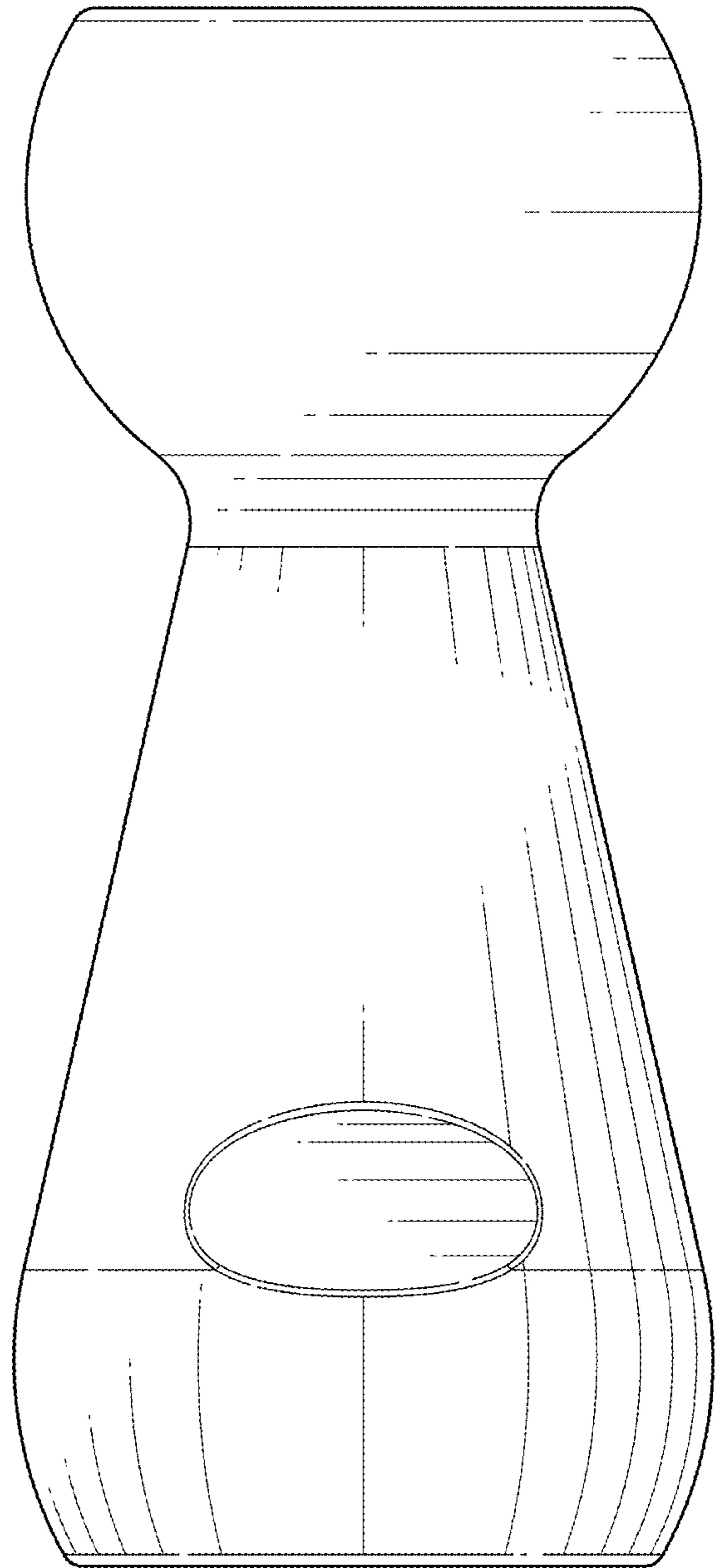

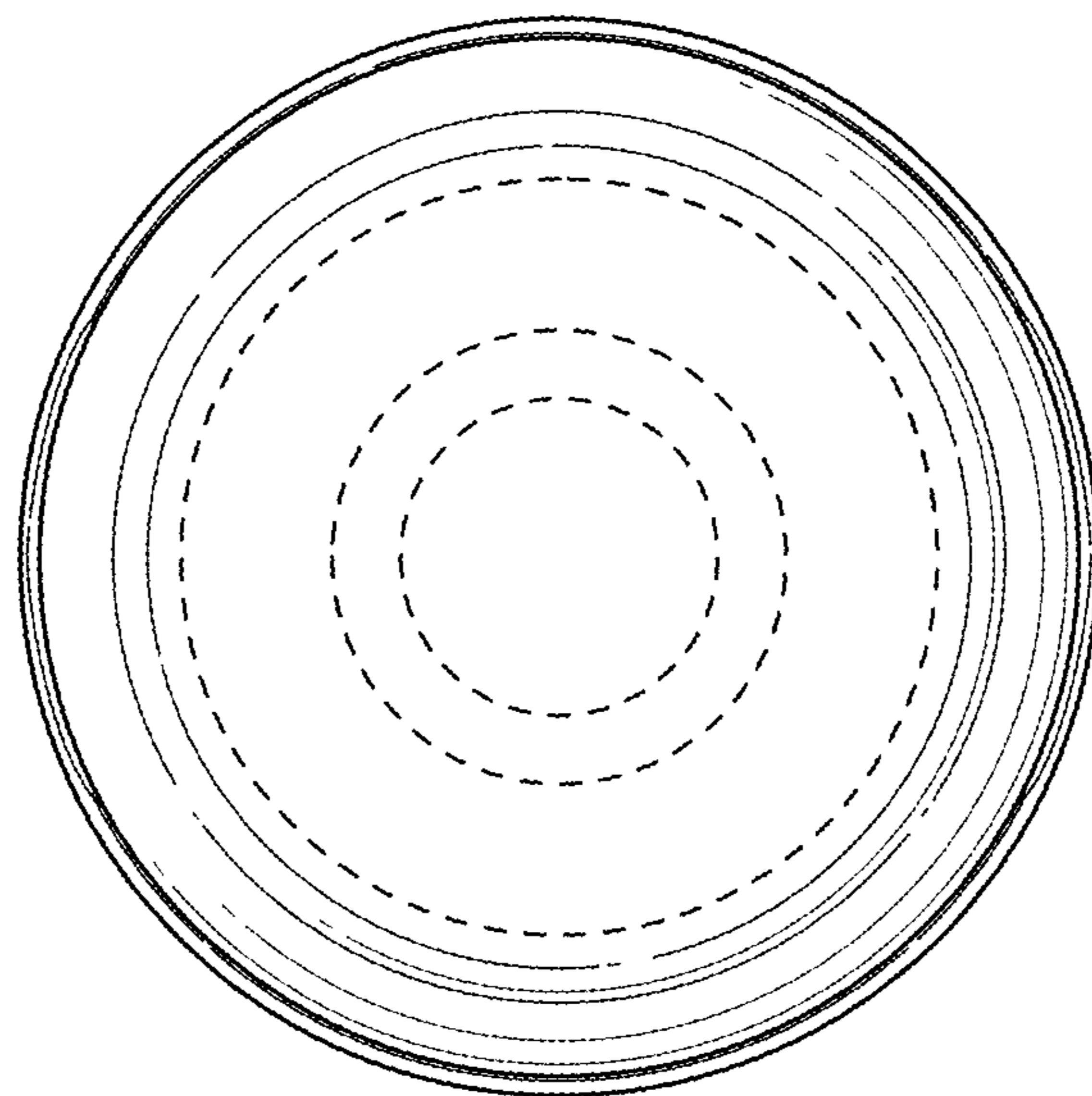

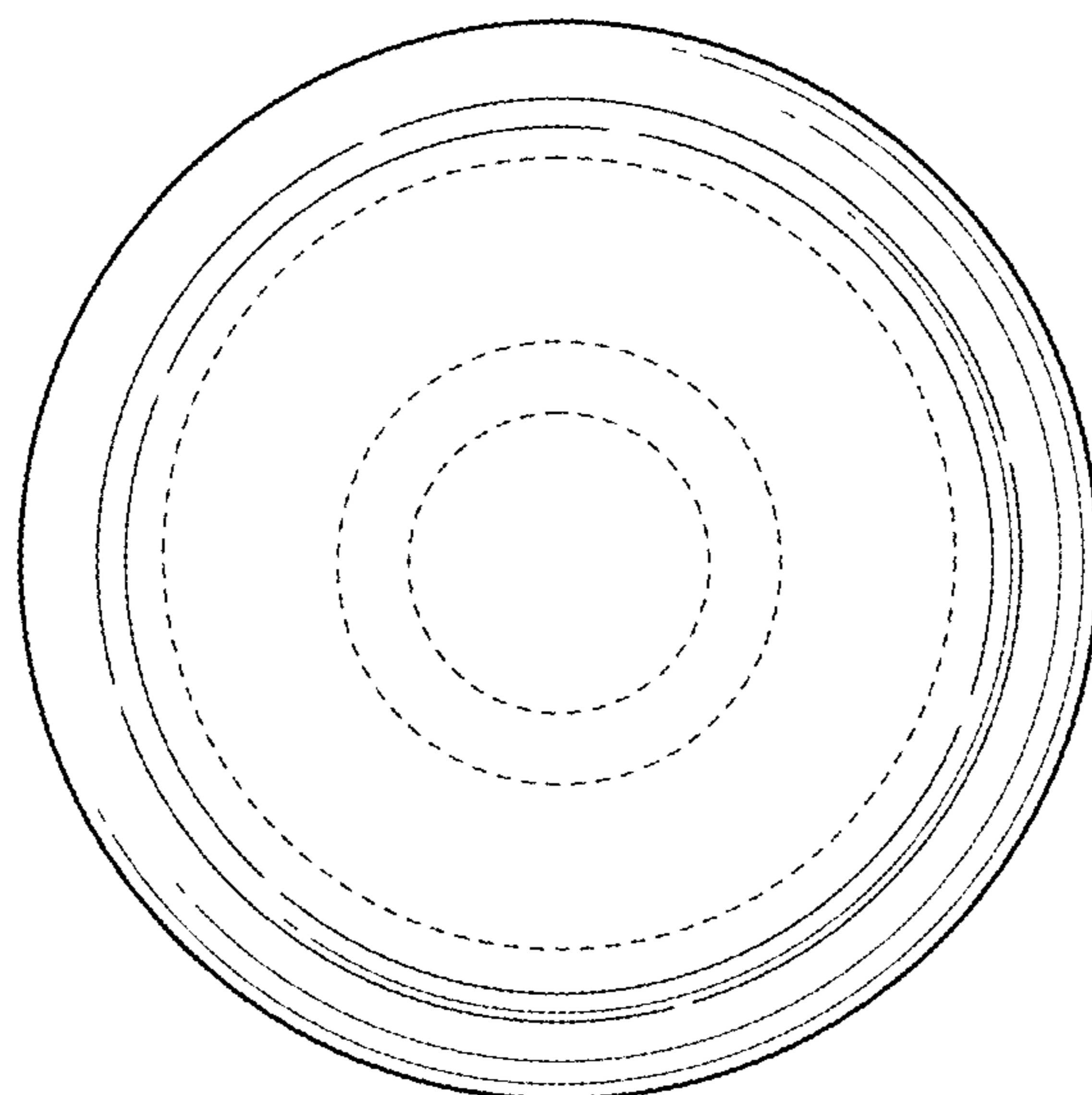

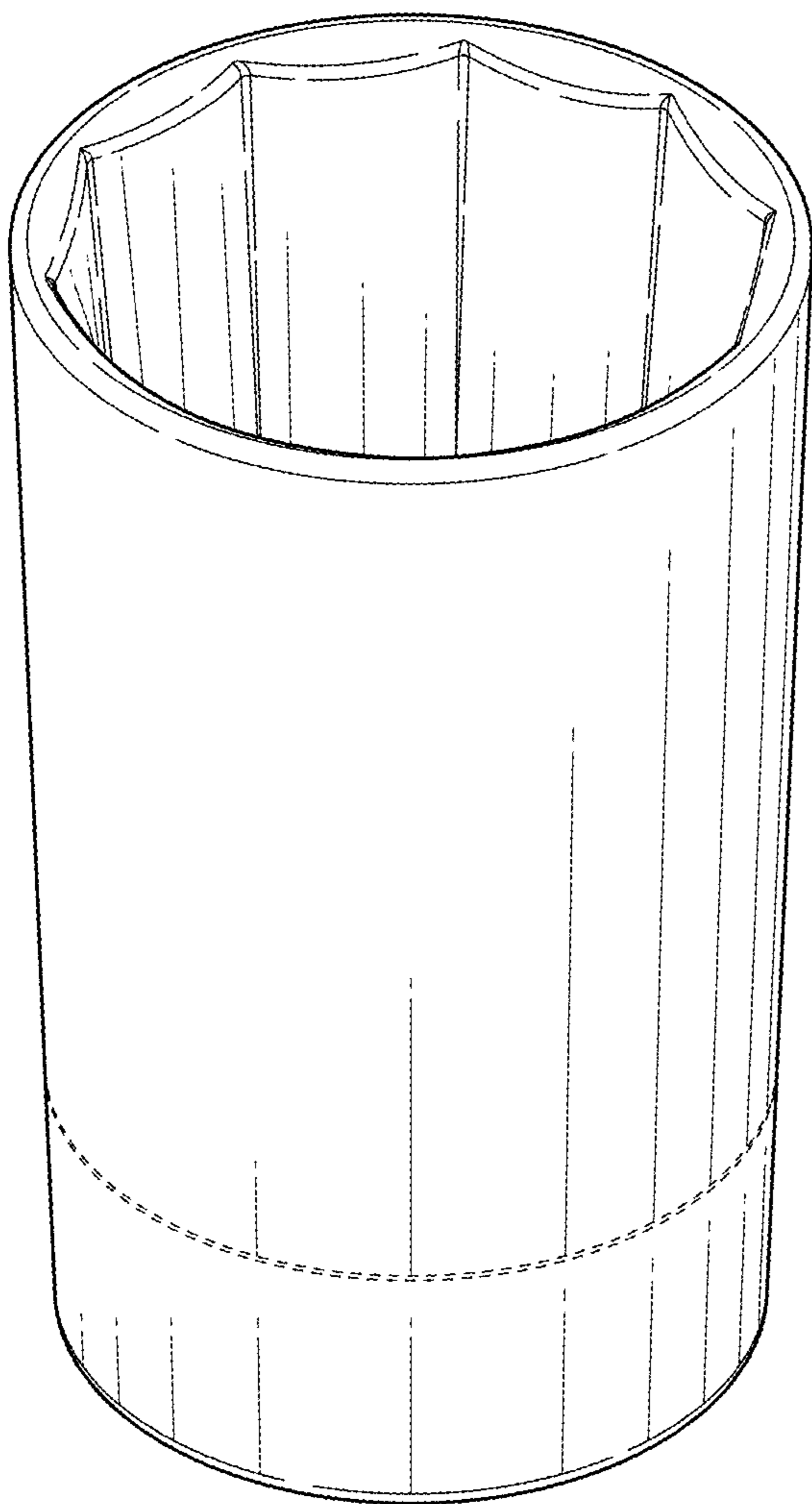

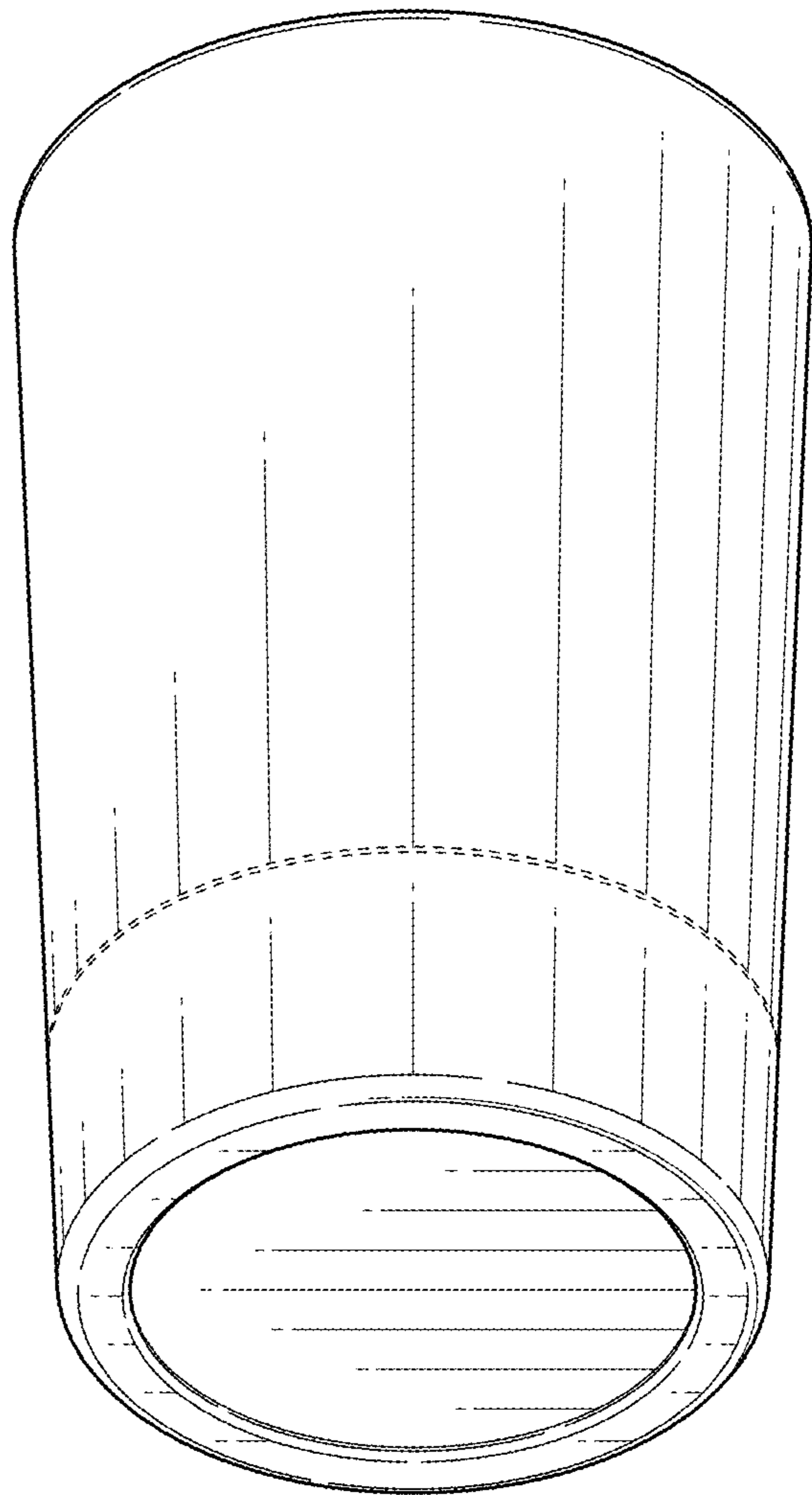

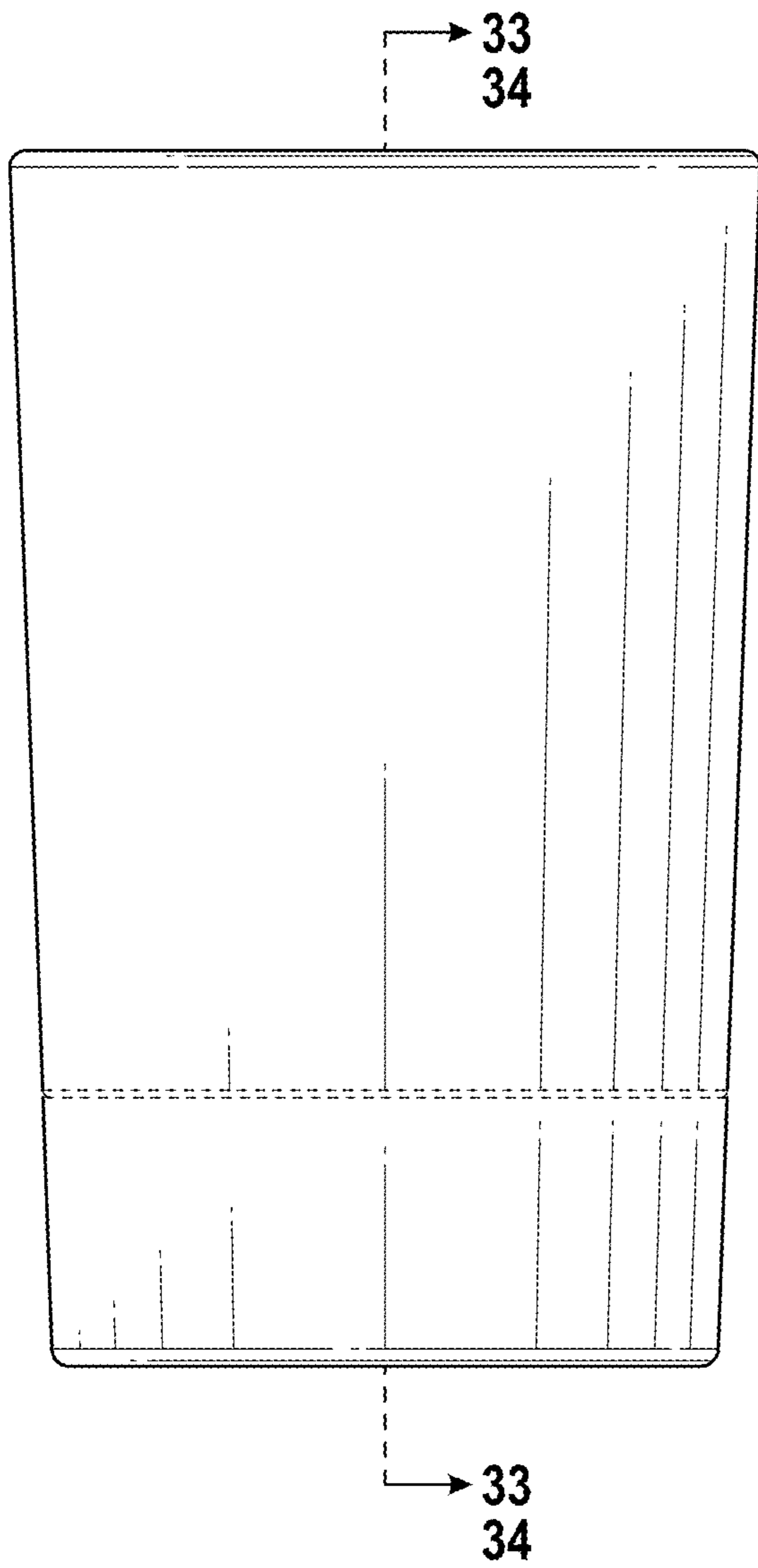

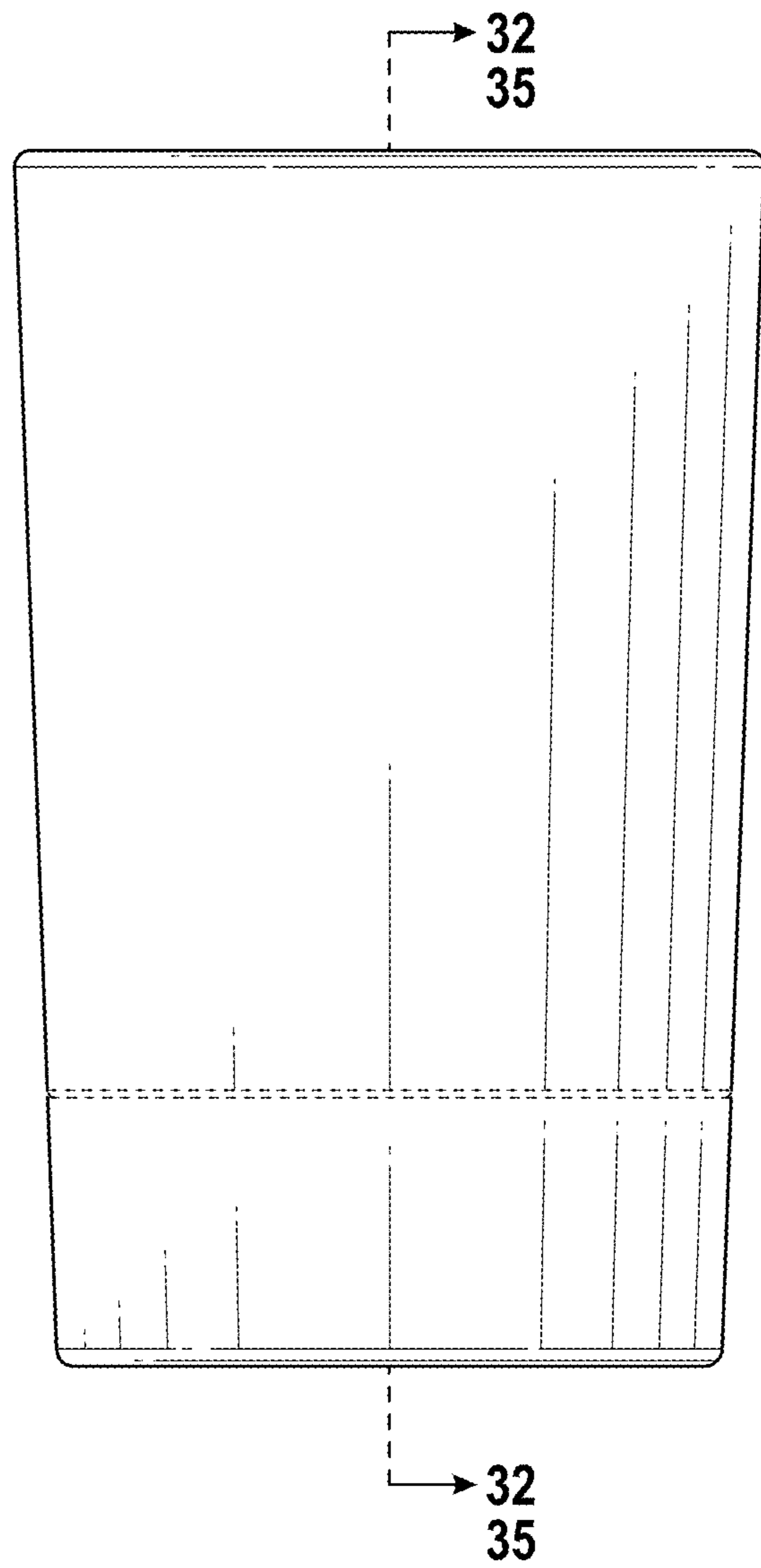

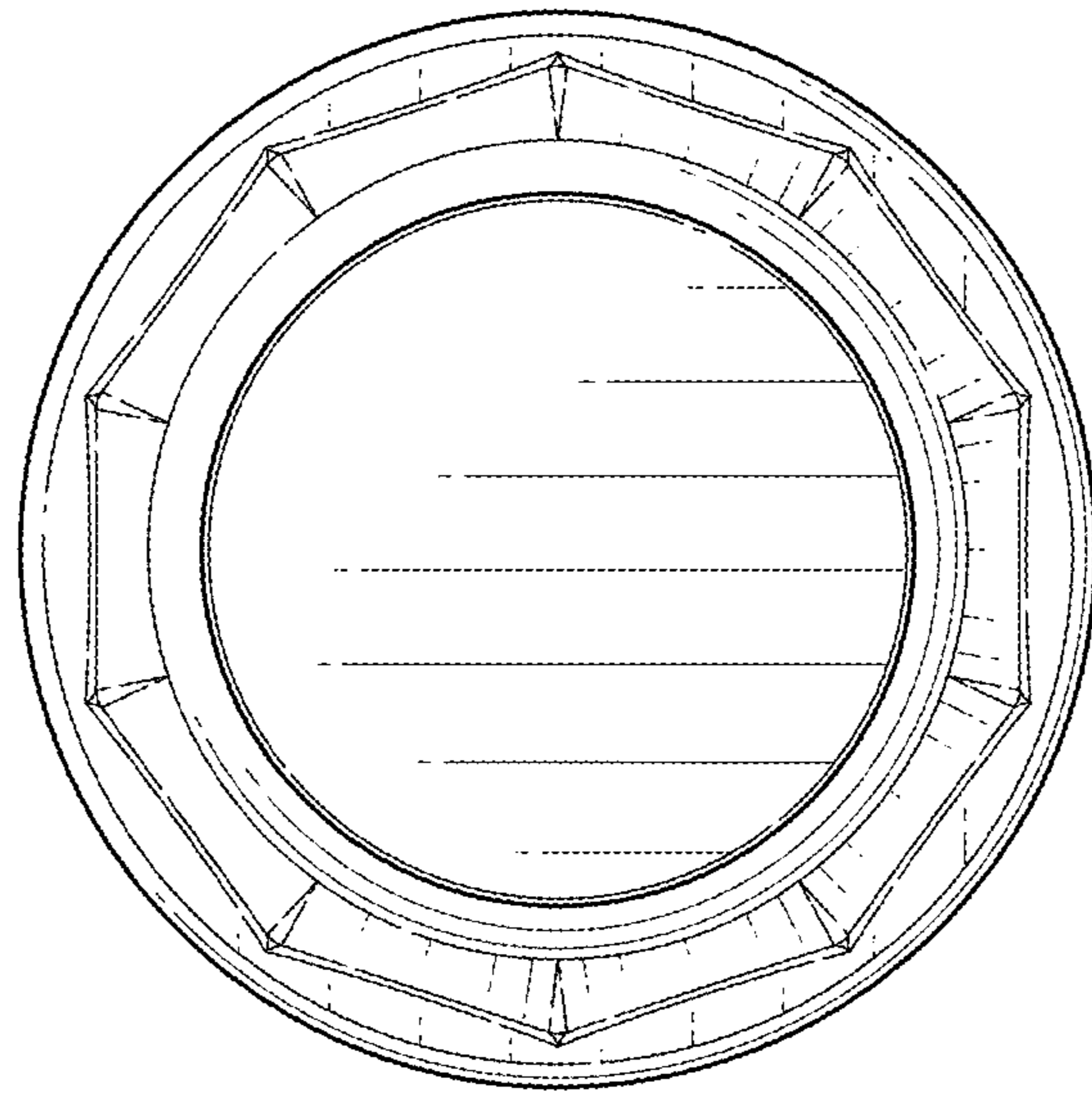

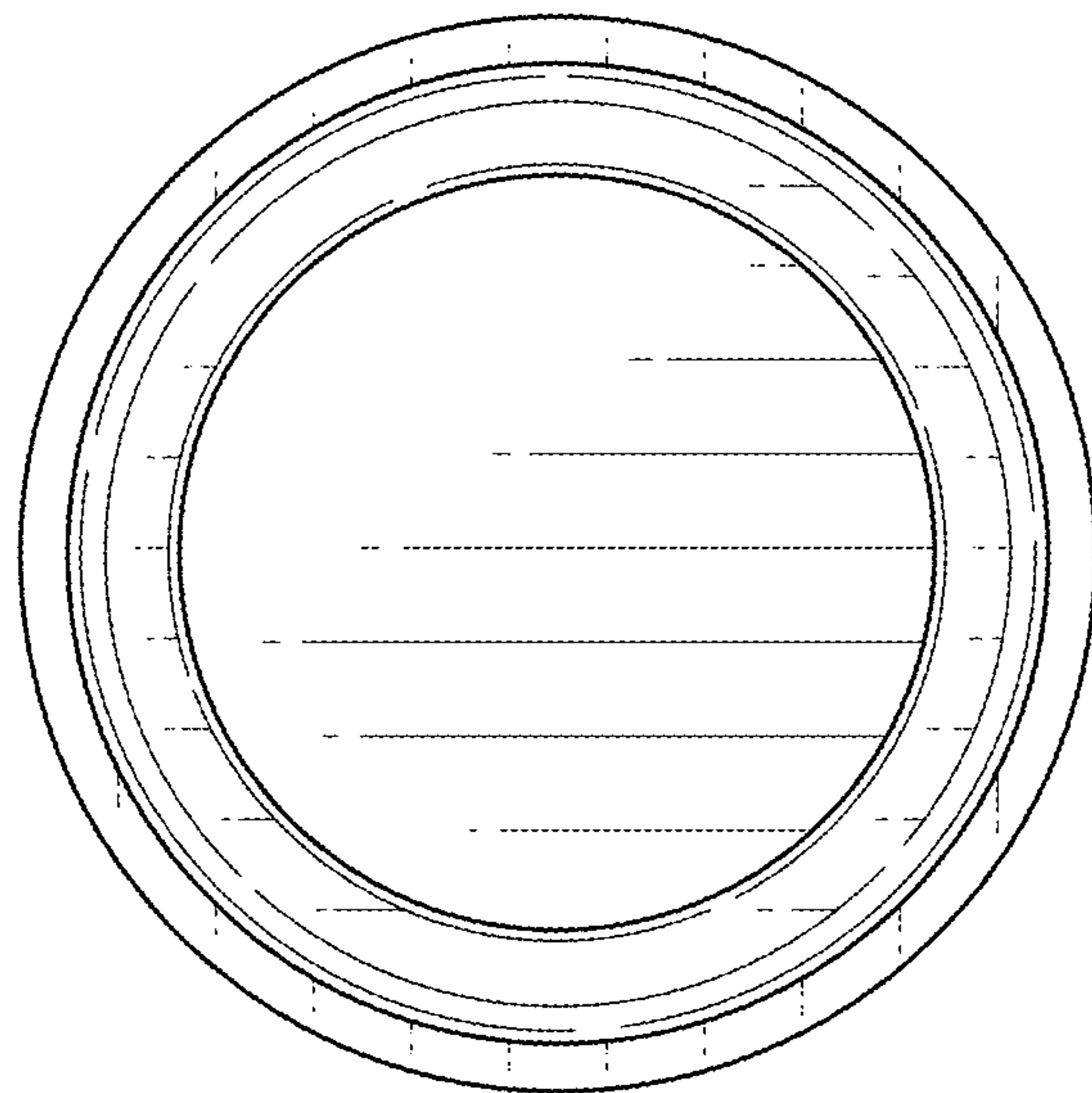

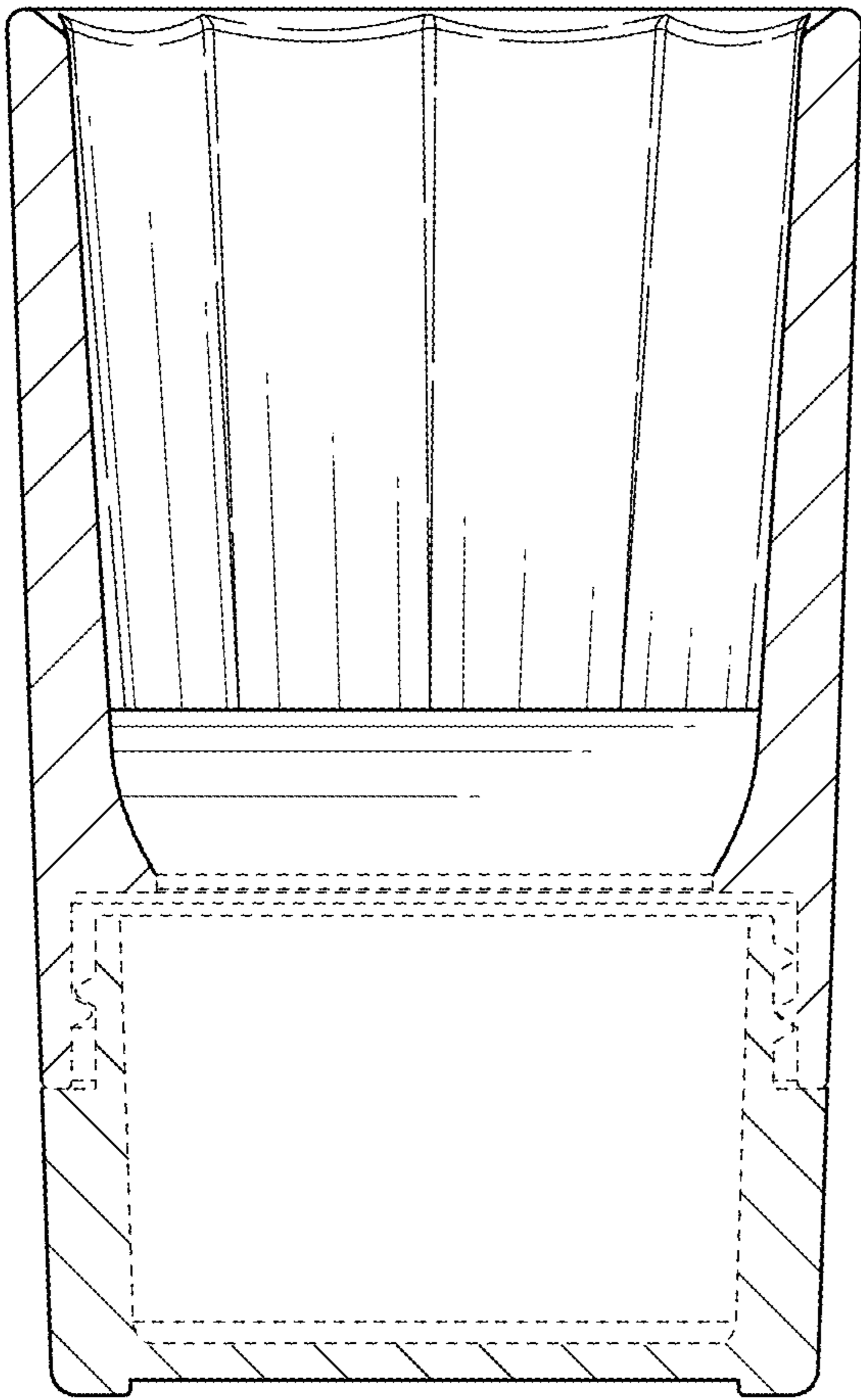

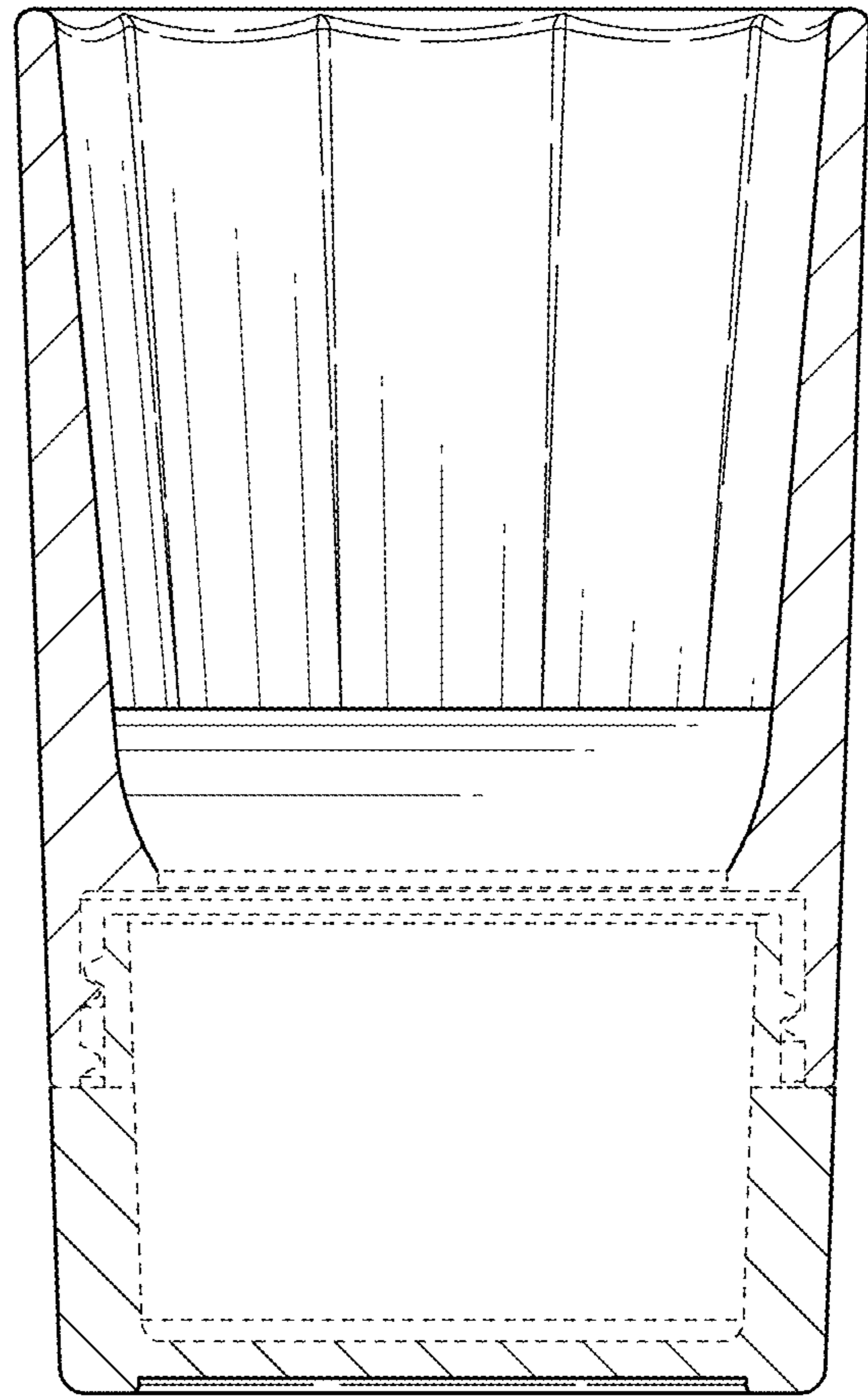

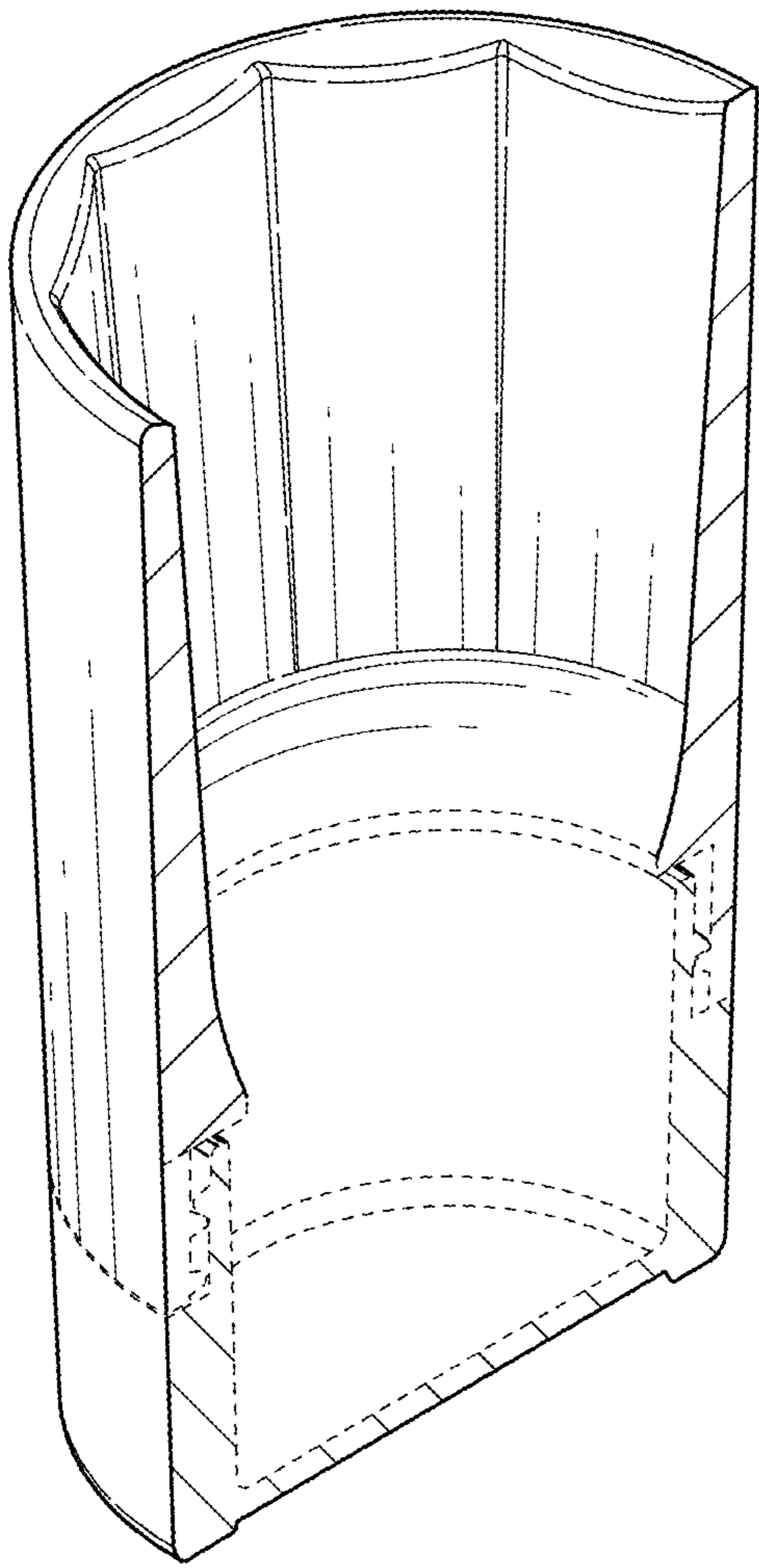

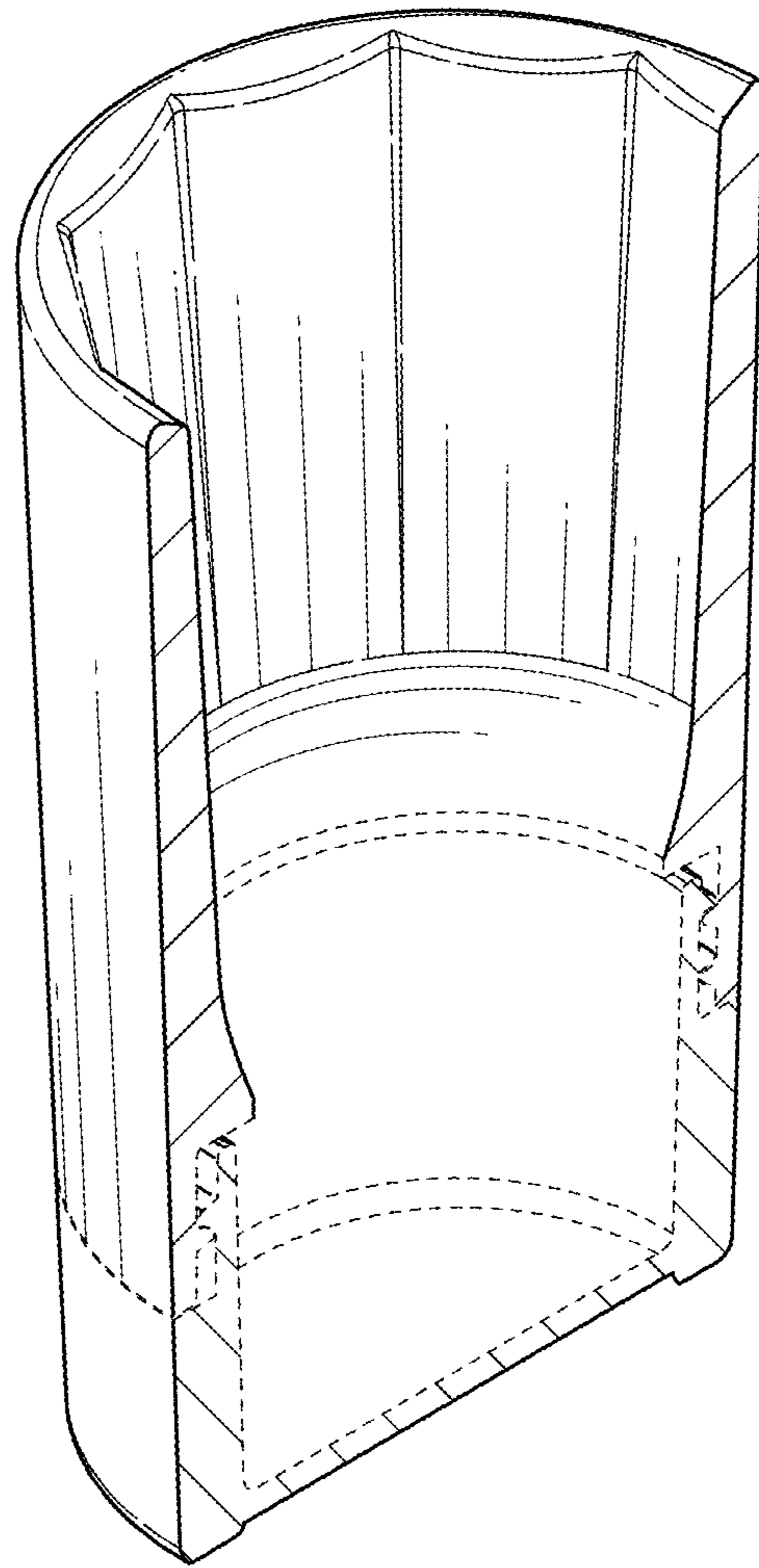
