DESCRIPTION

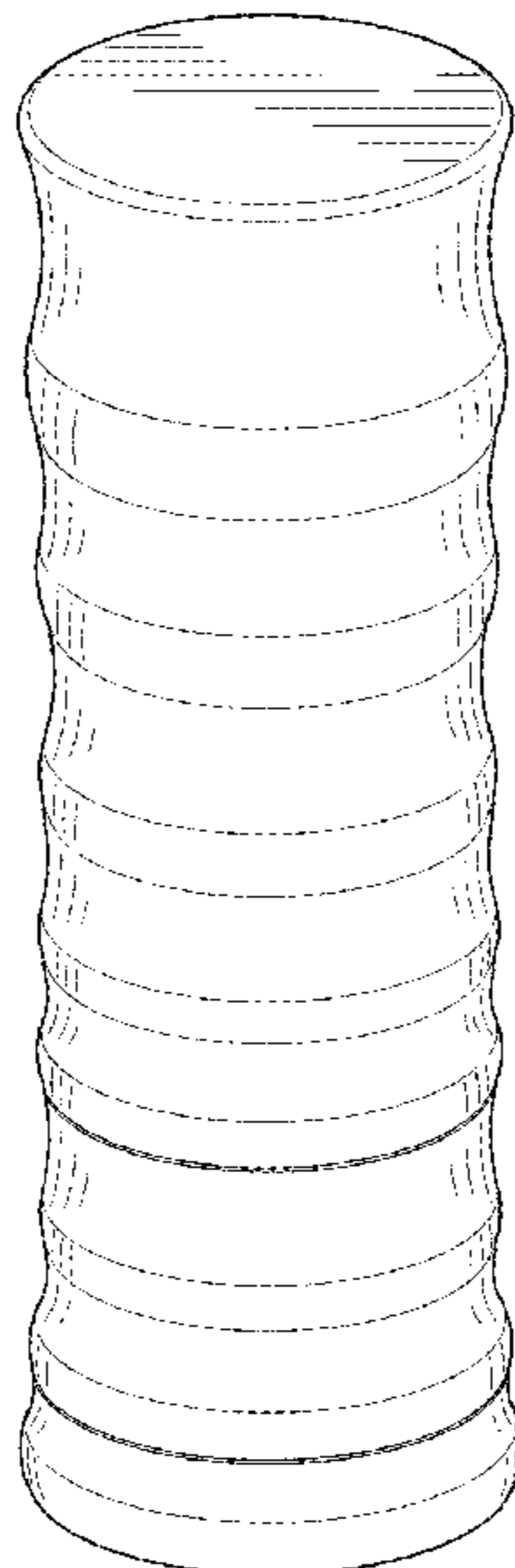
FIG. 1 is a perspective view of a lipstick case with bamboo shape showing my new design;

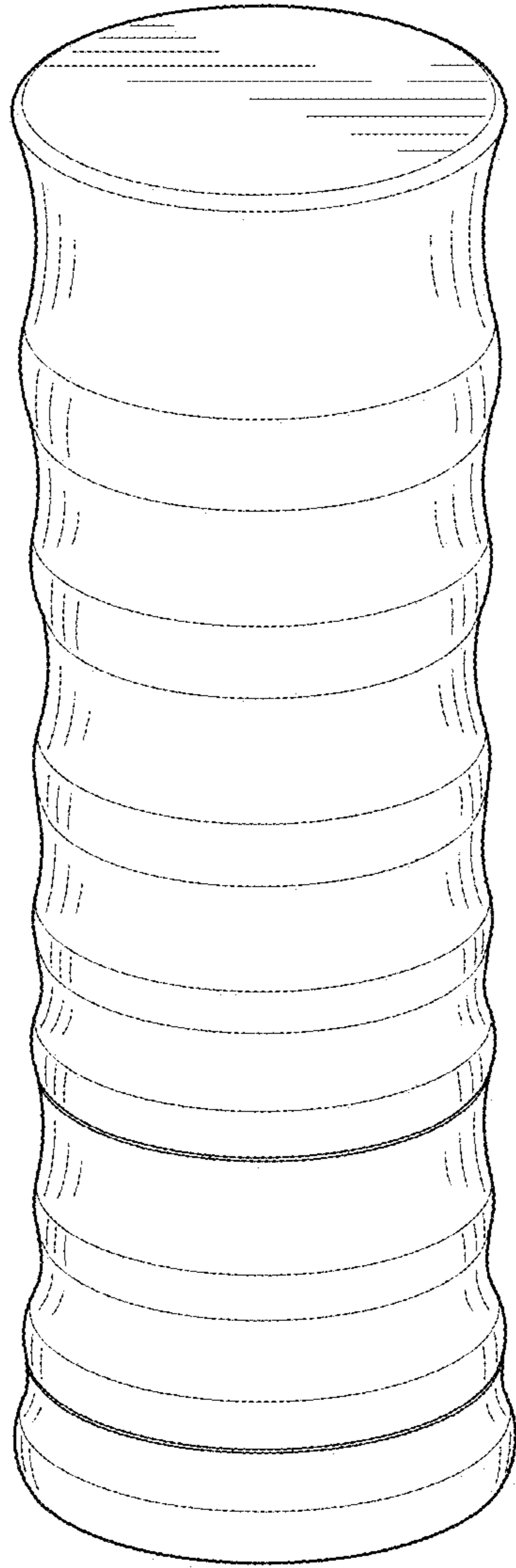

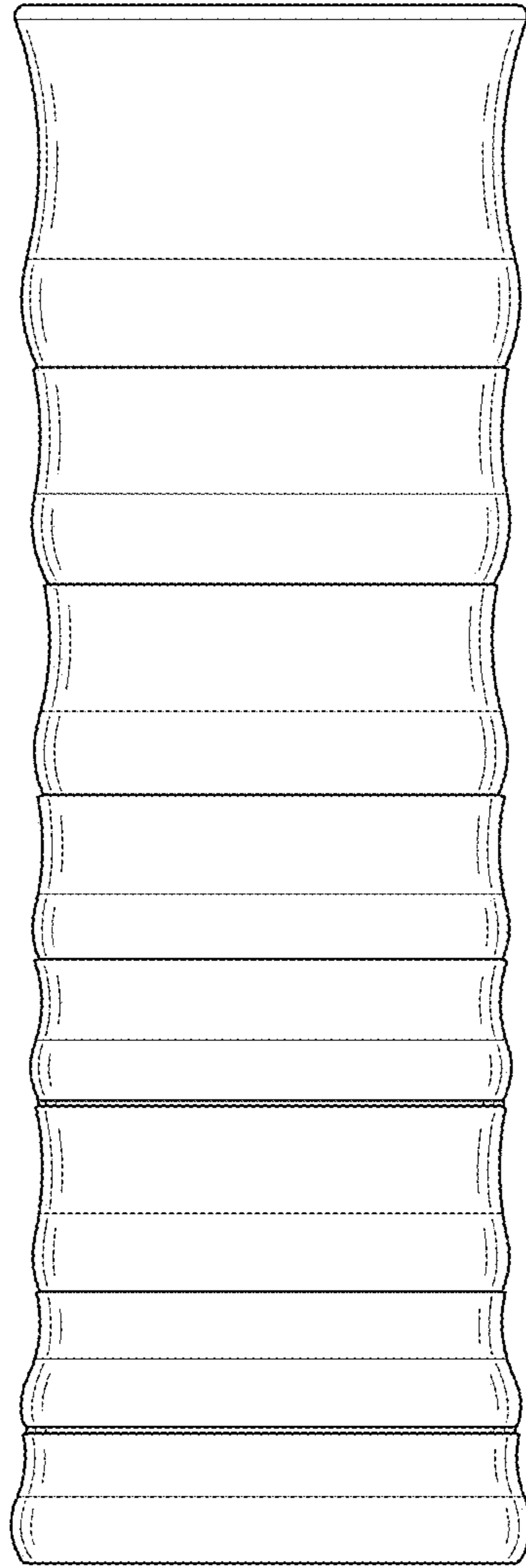

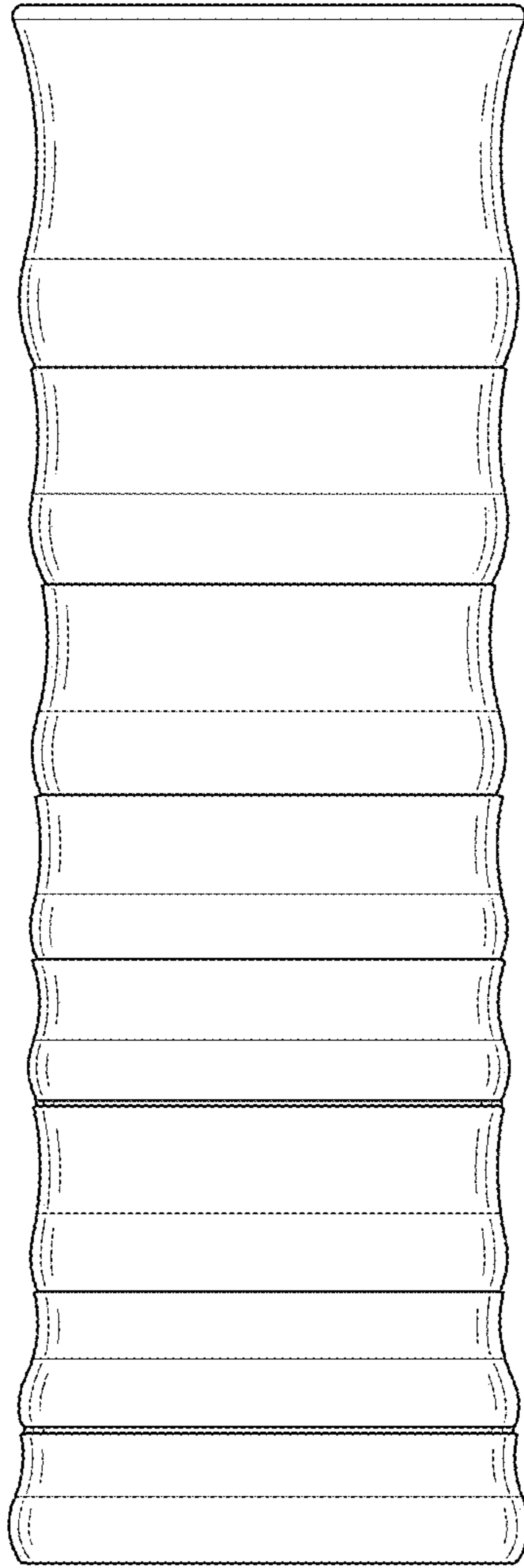

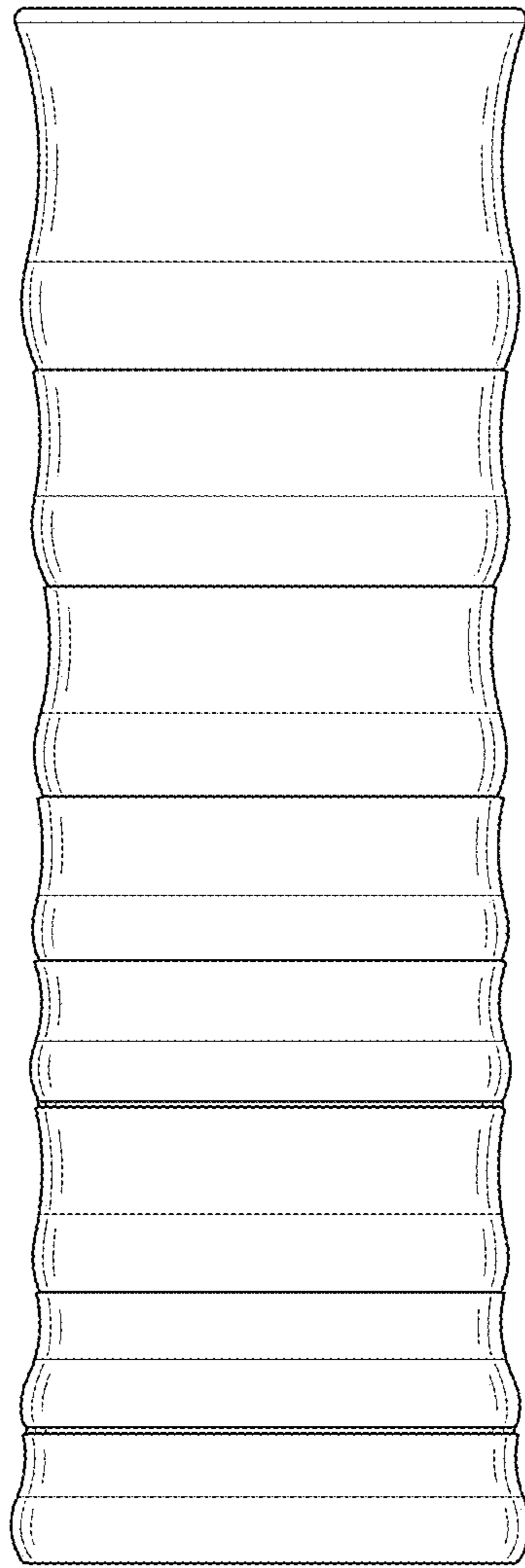

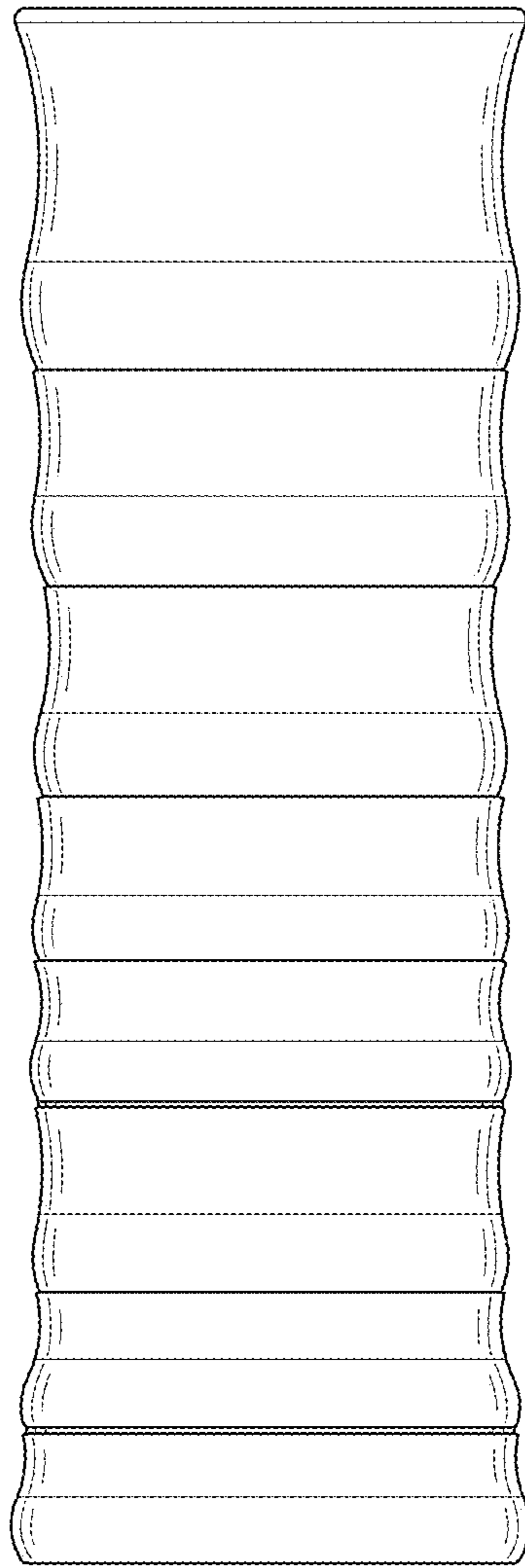

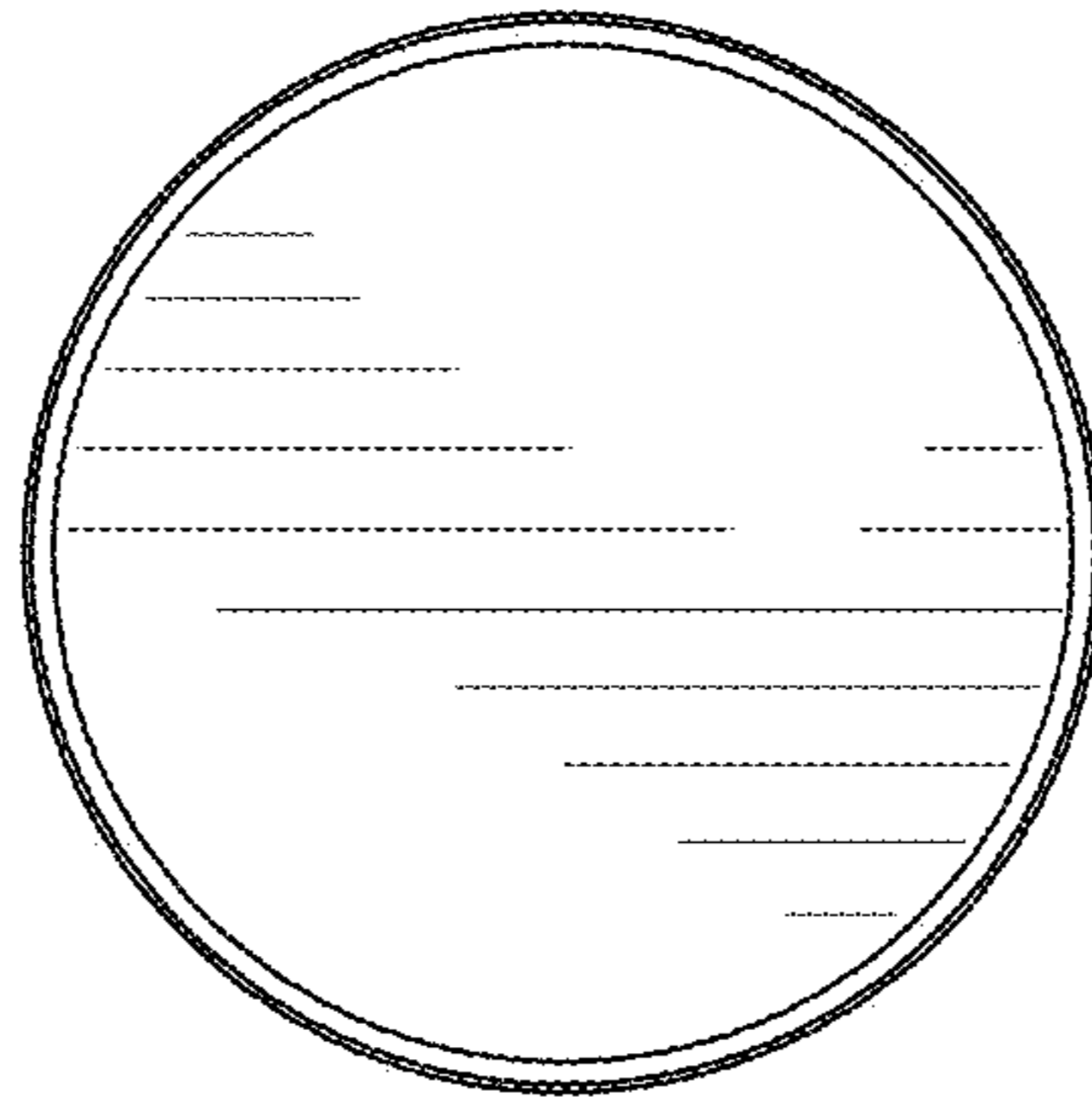

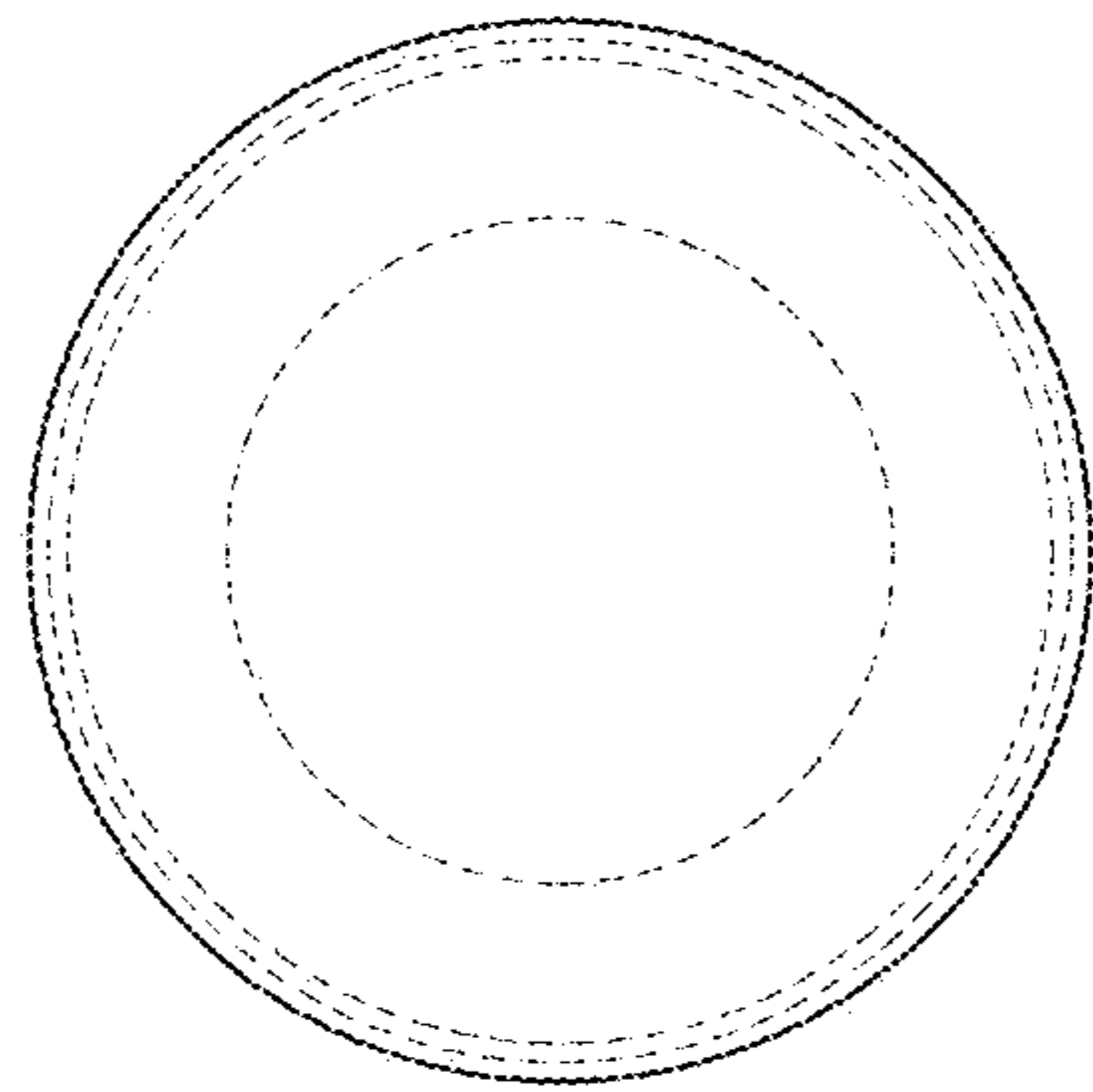
