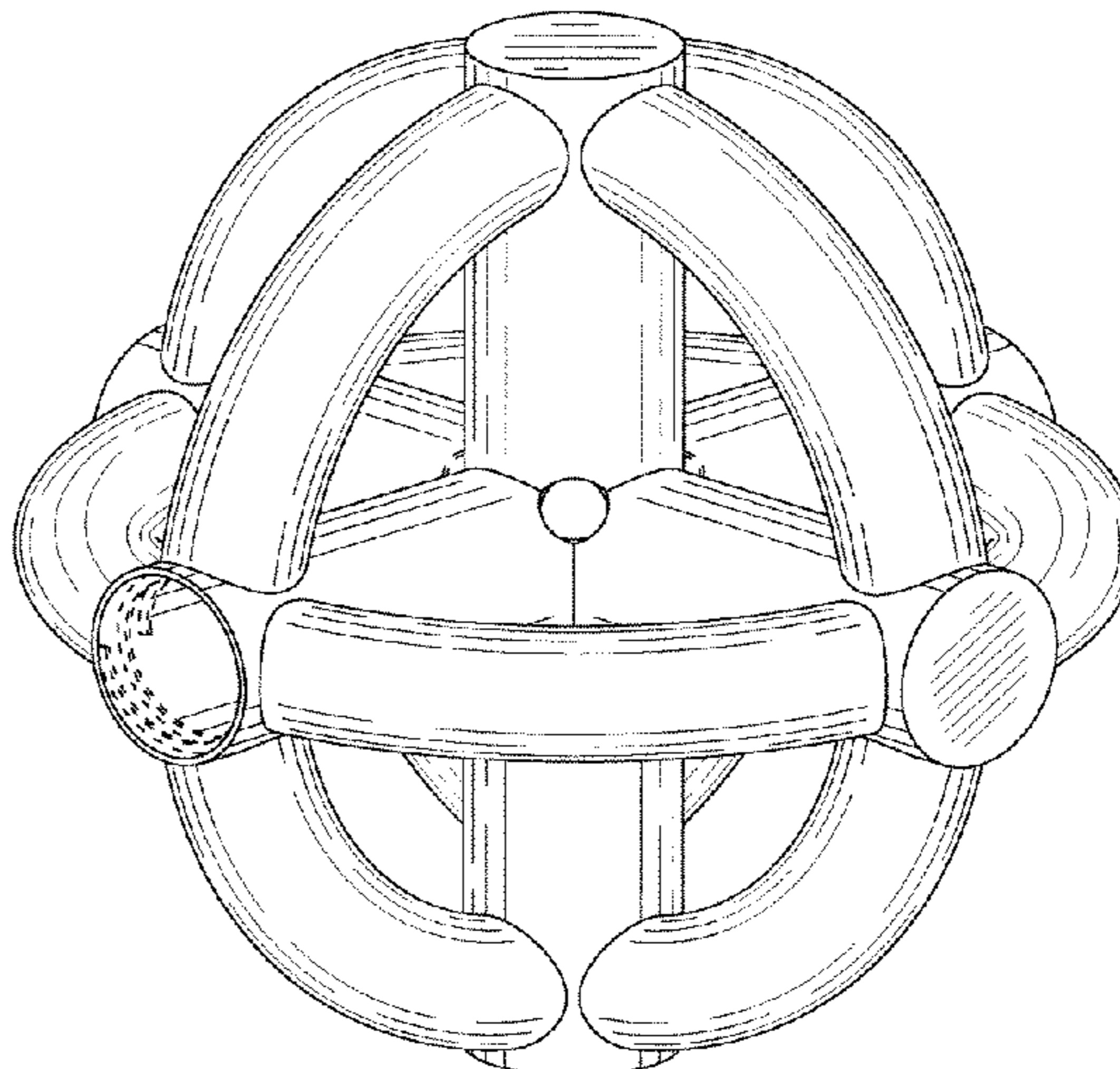
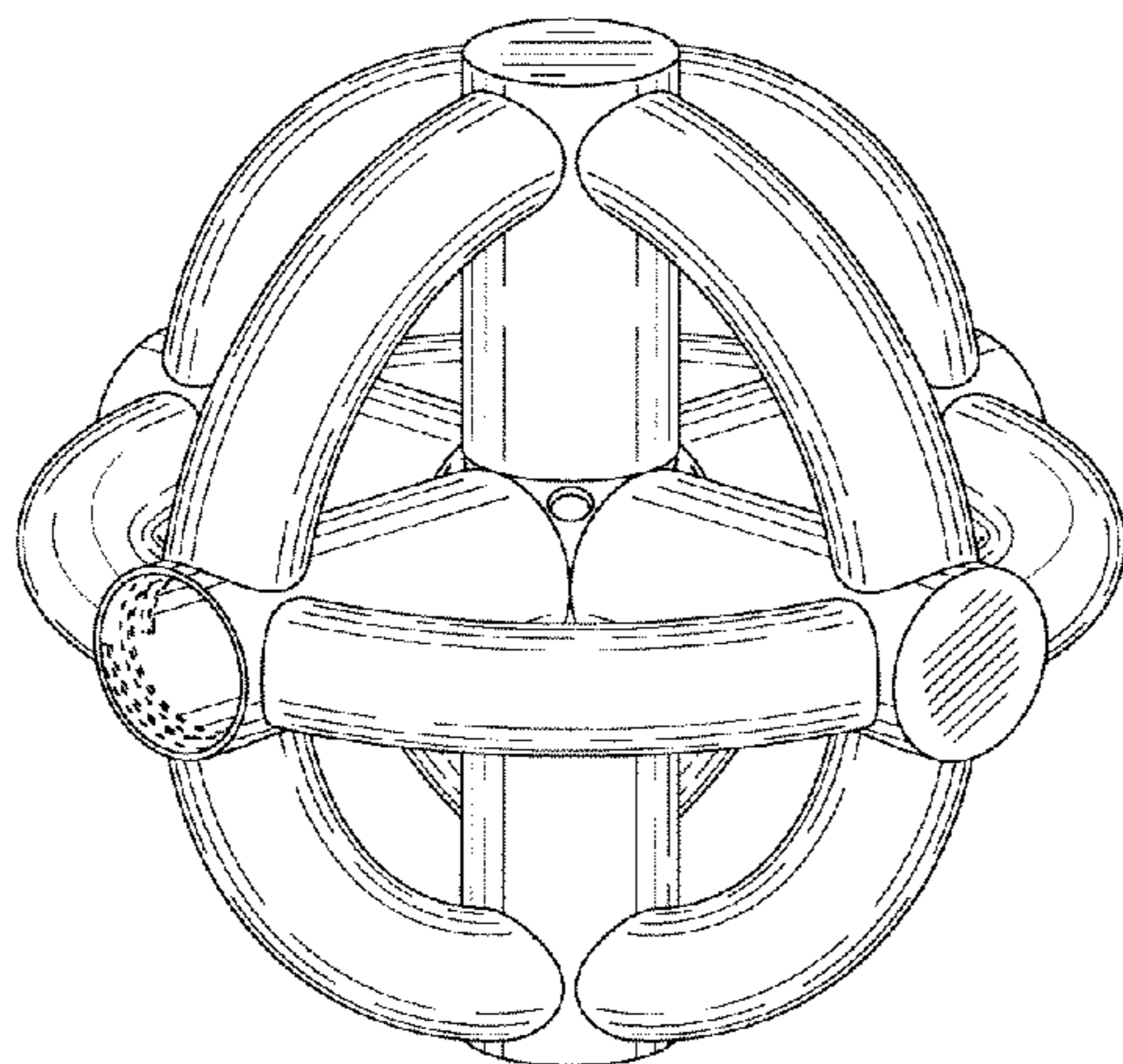
The ornamental design for a treat dispensing pet toy, as

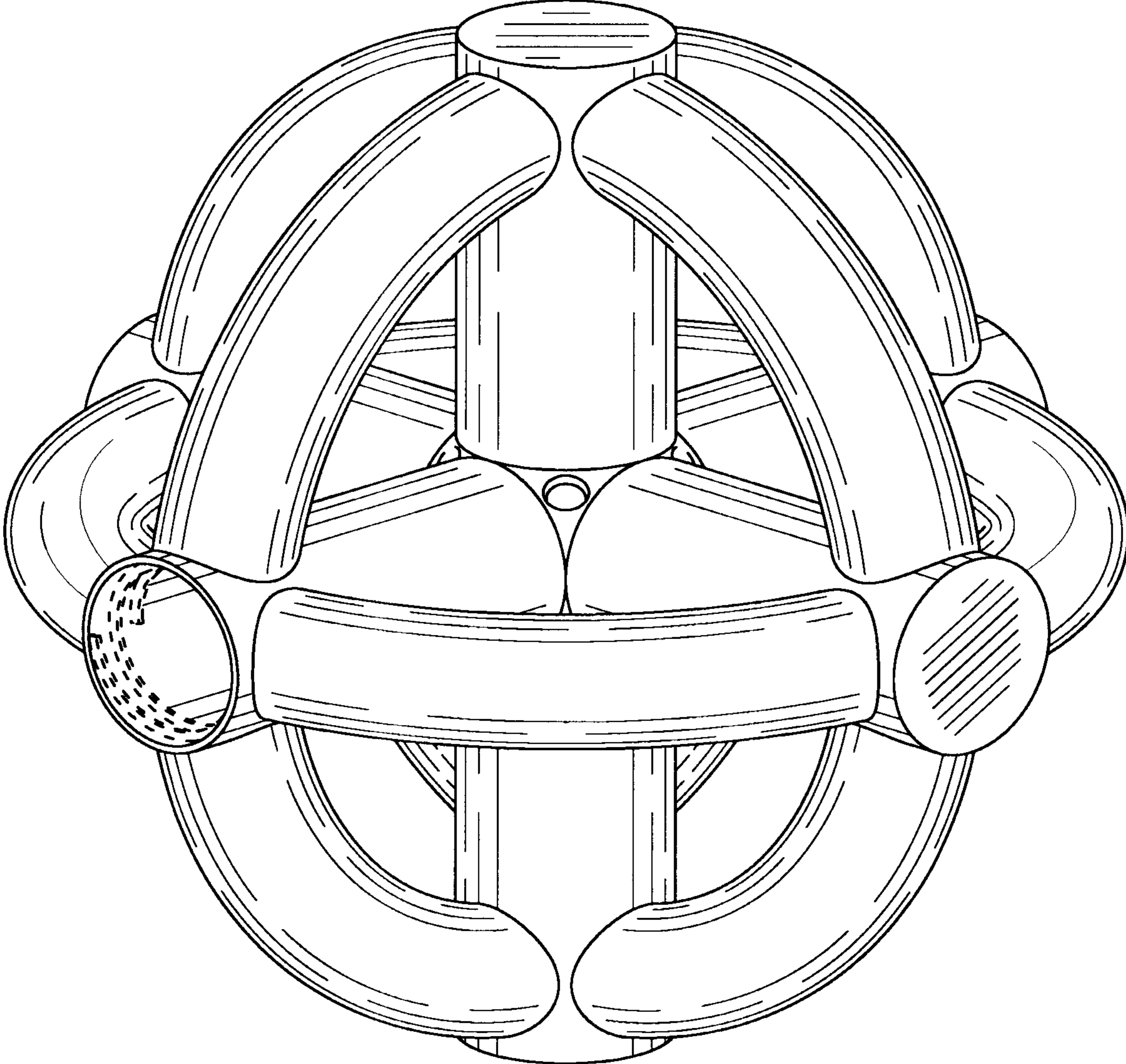

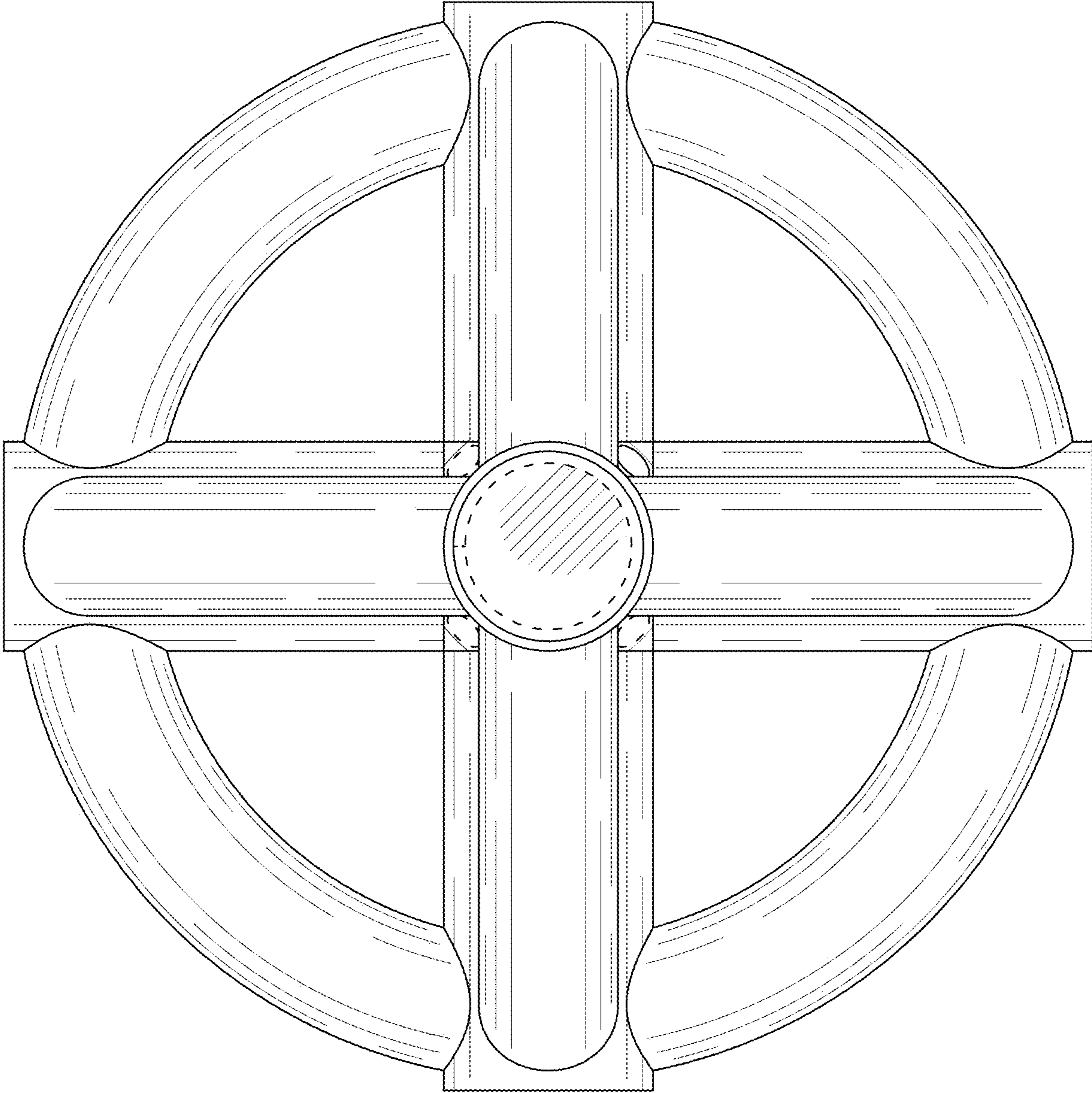

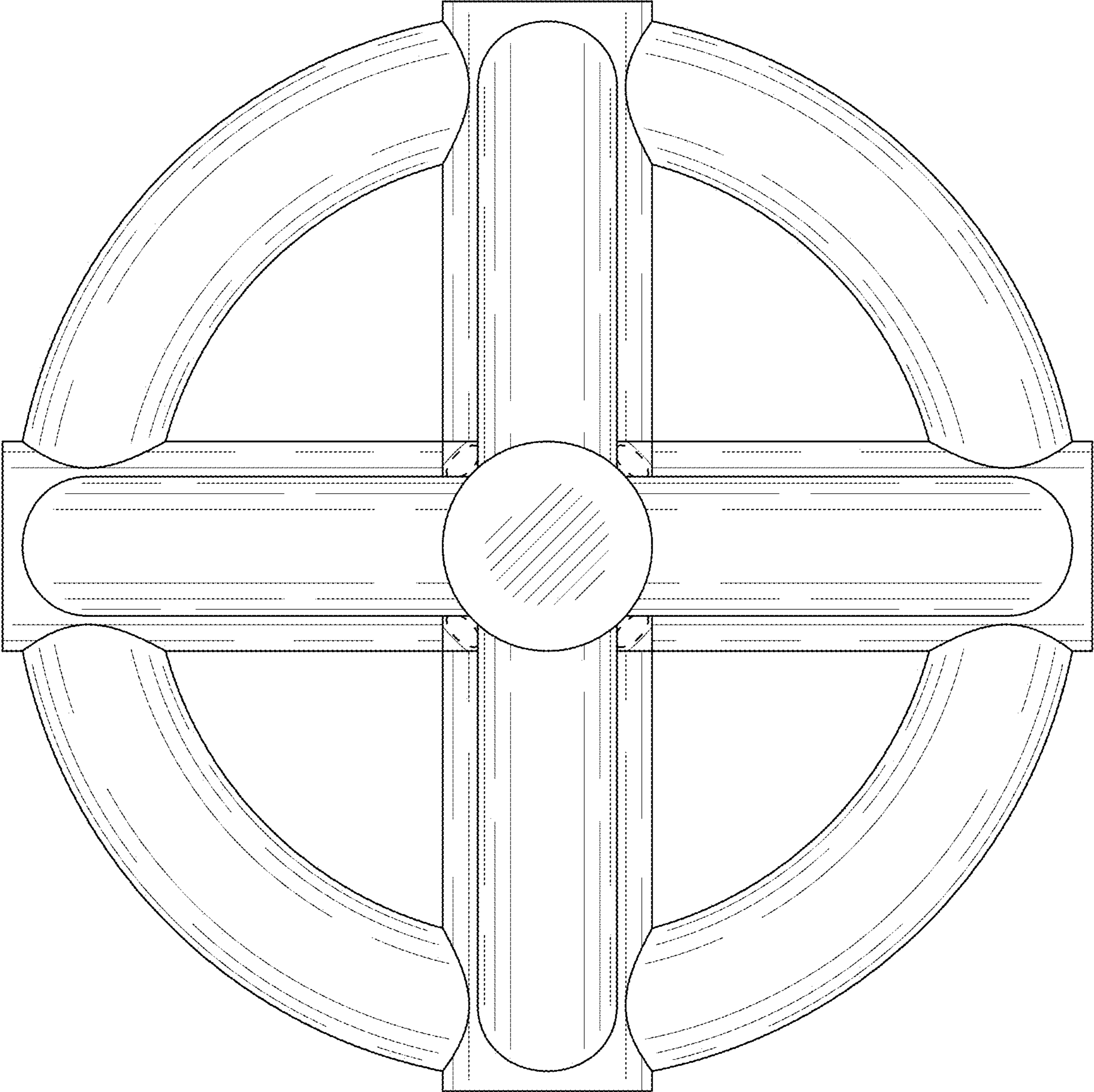

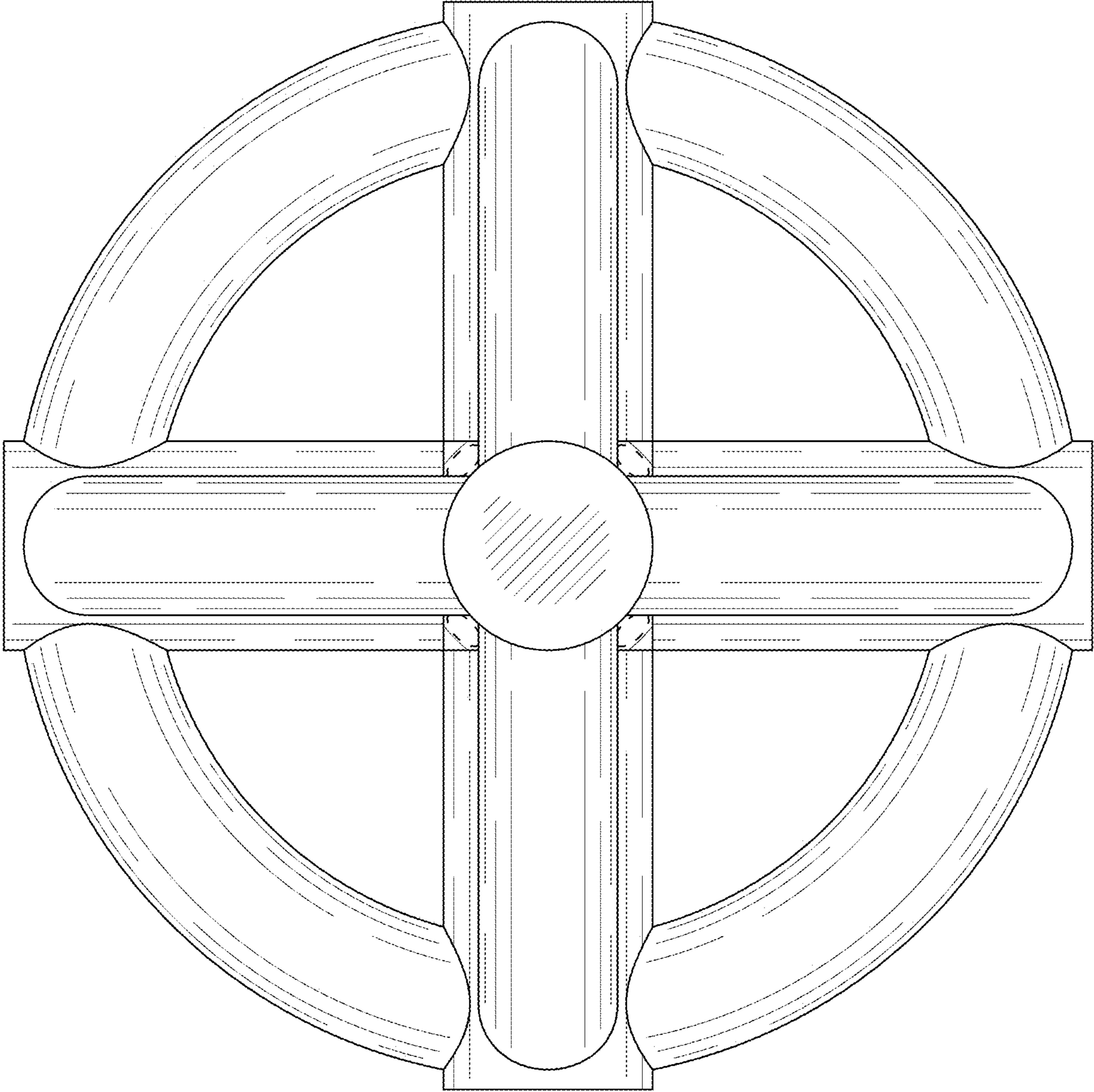

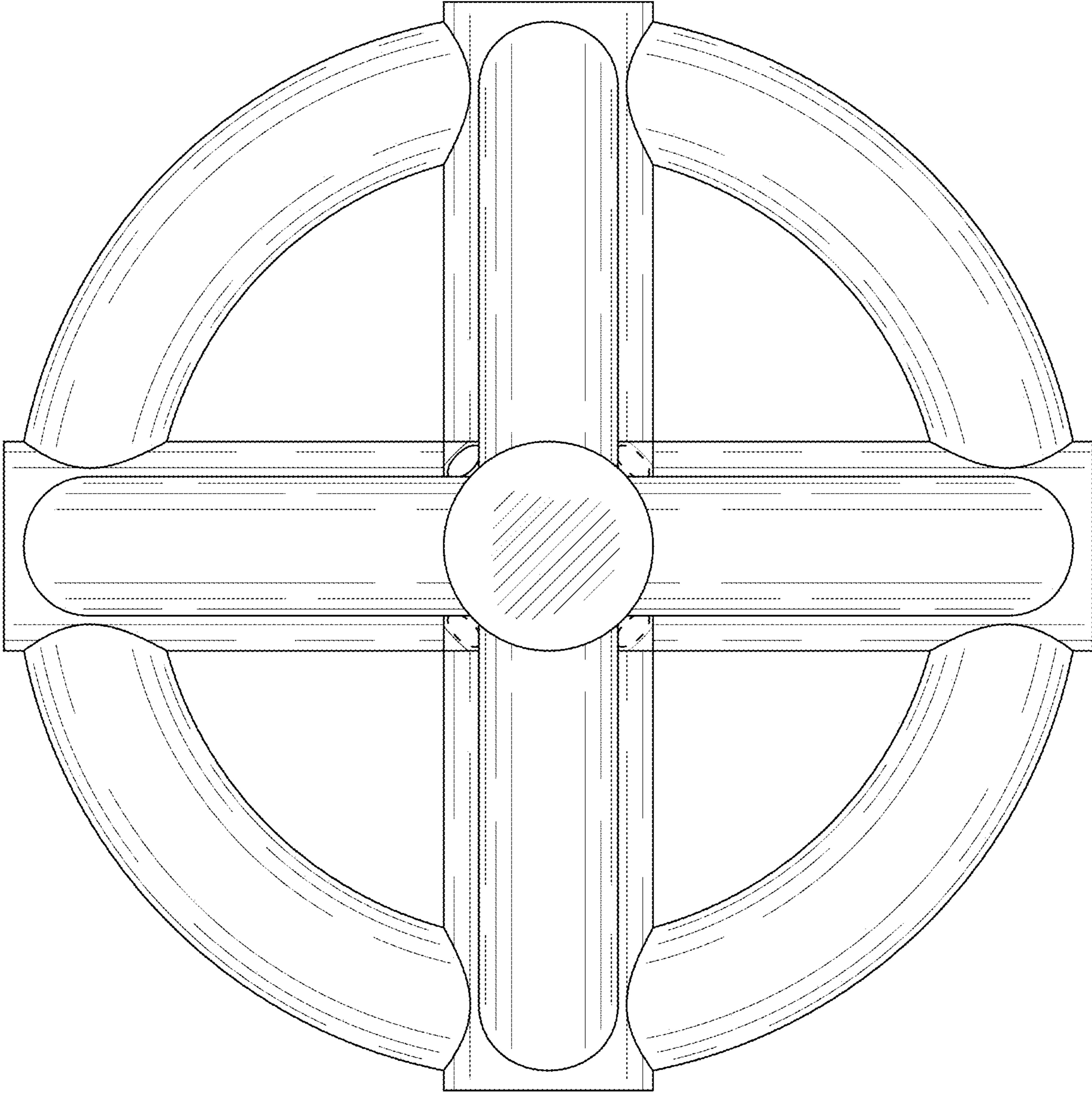

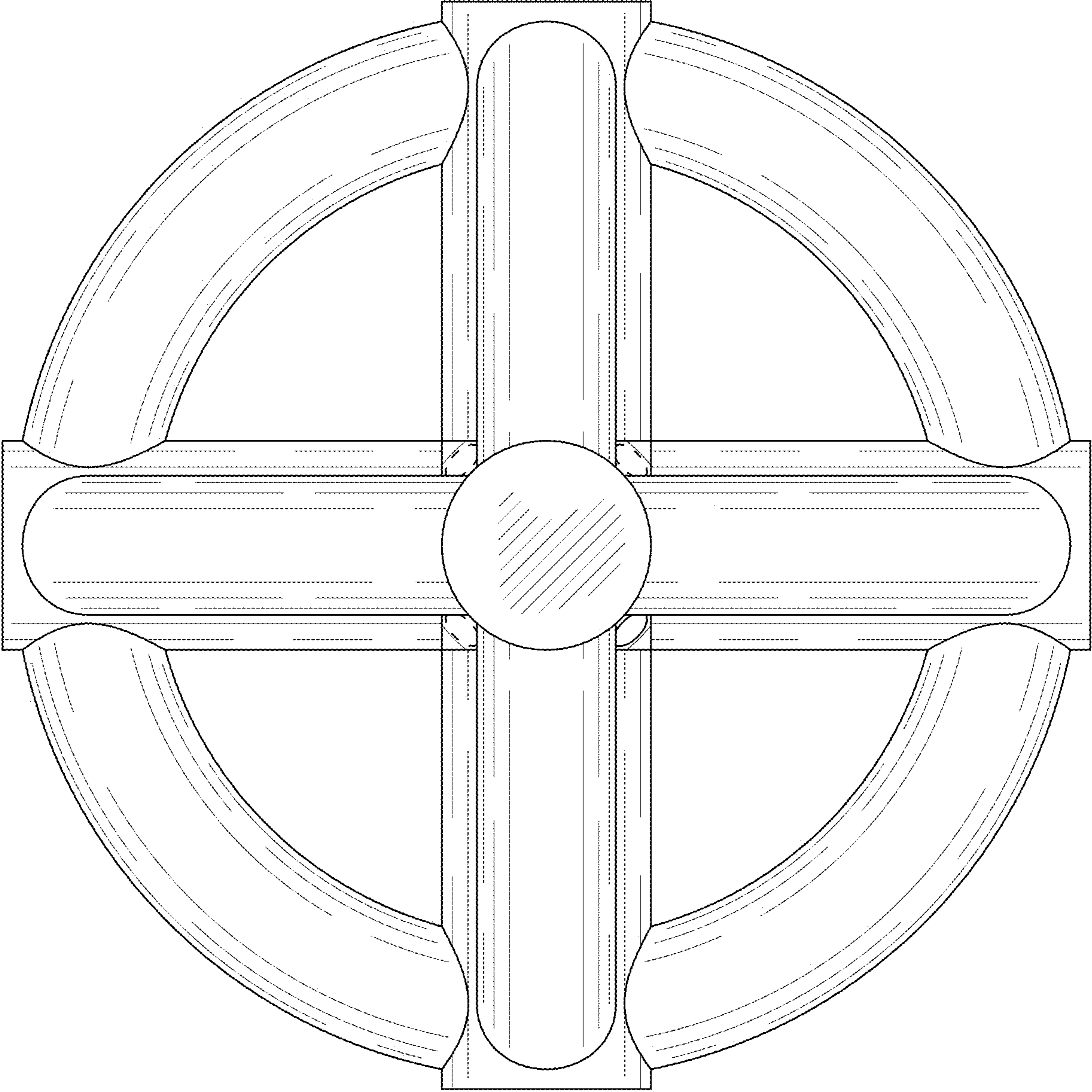

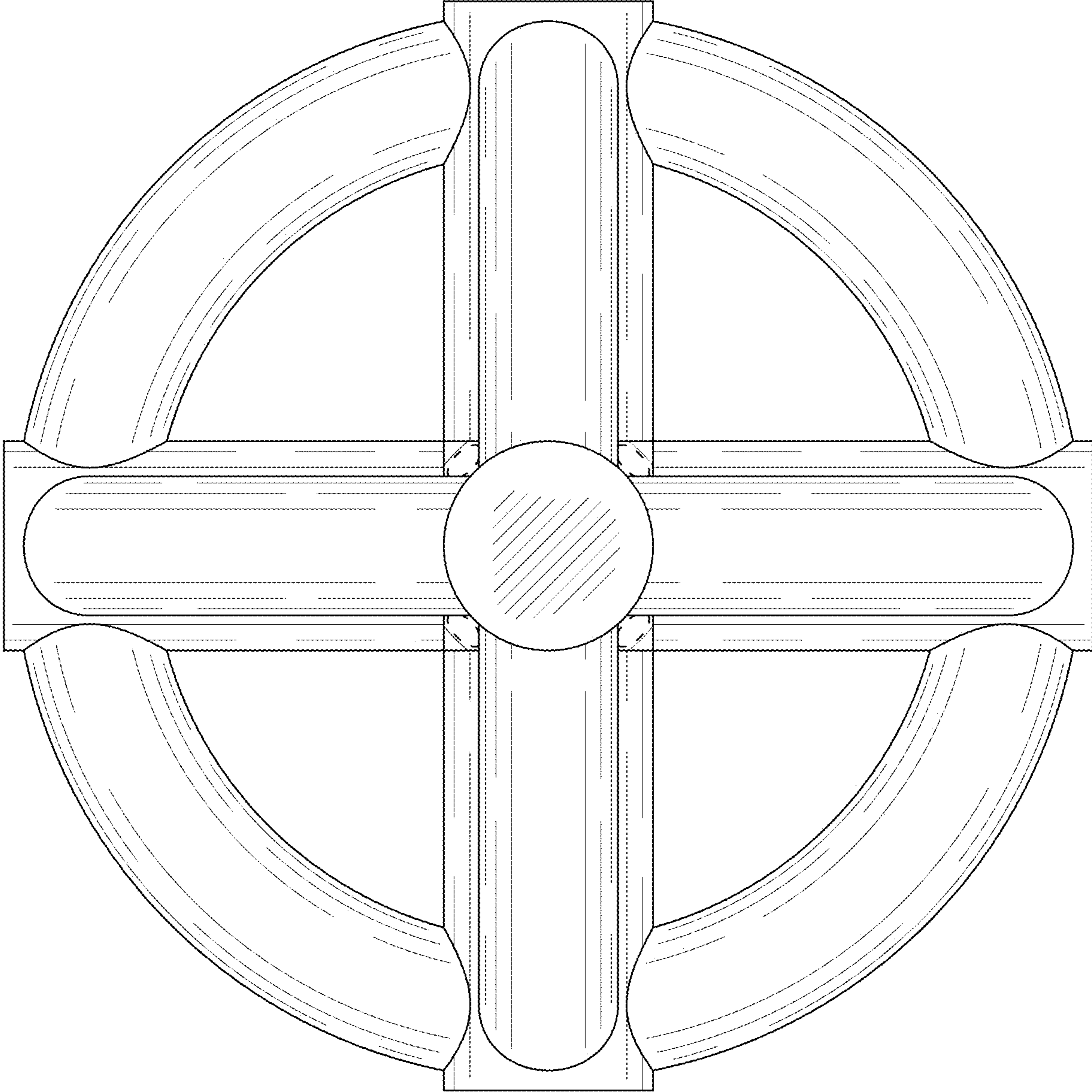

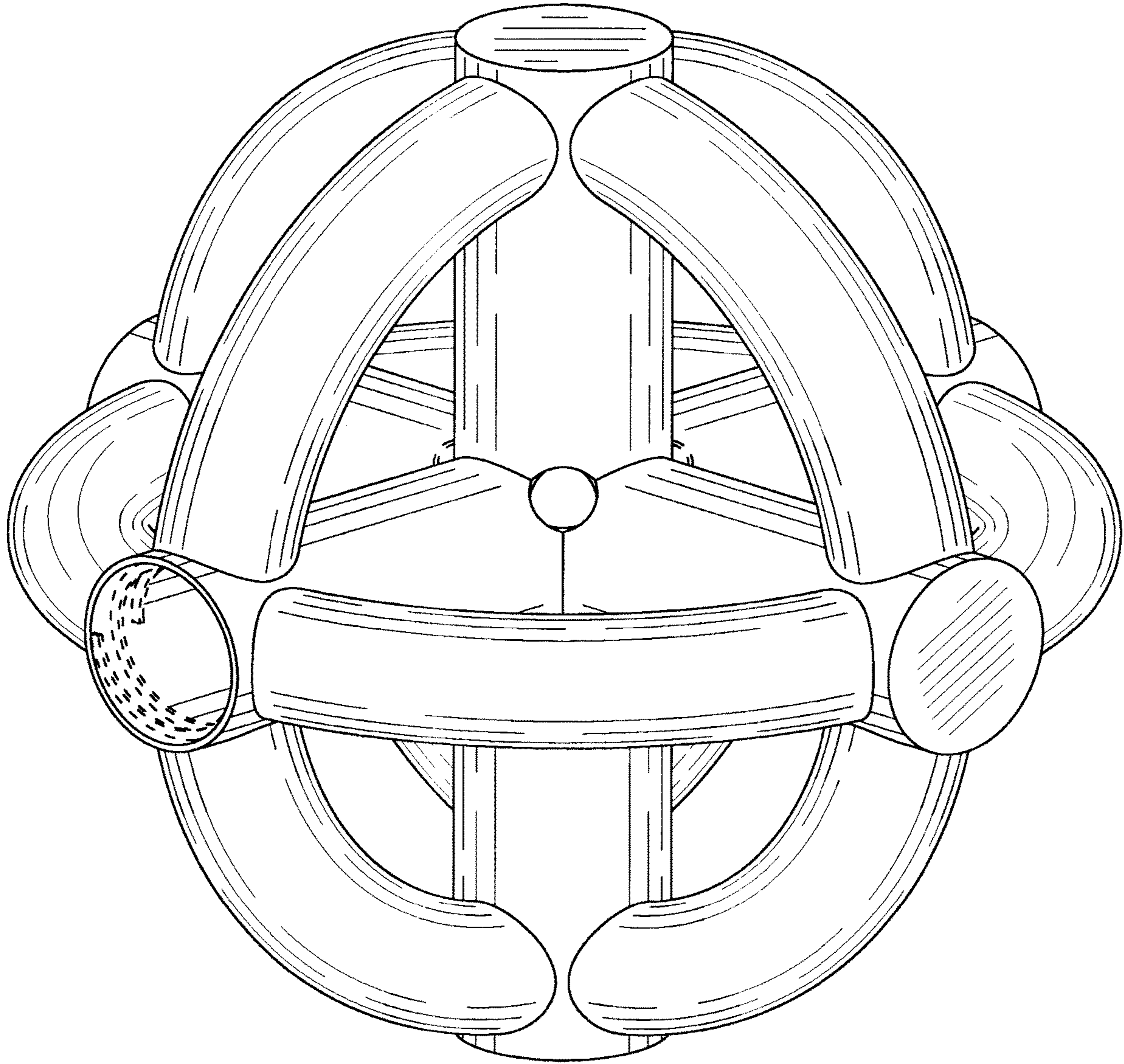

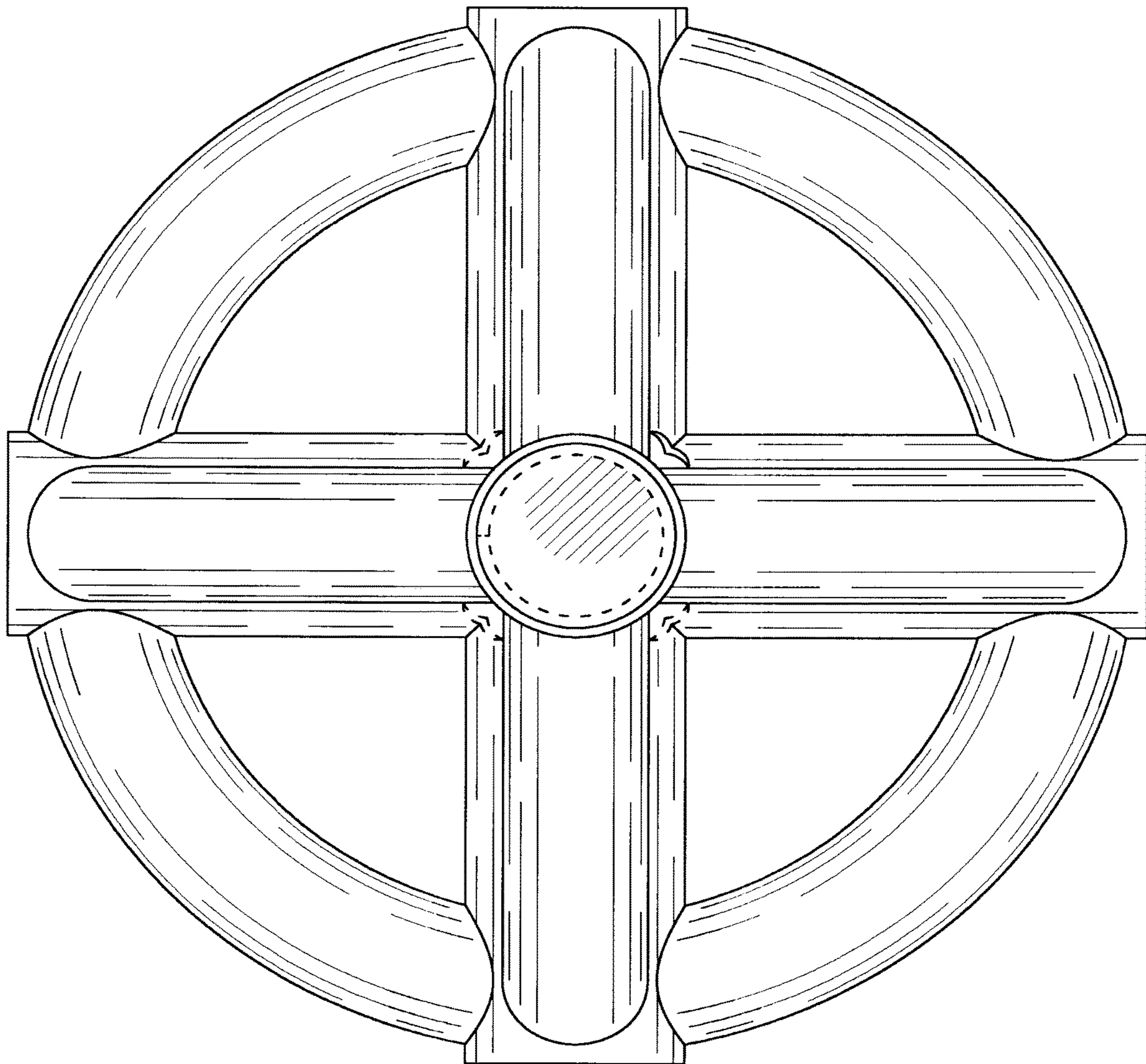

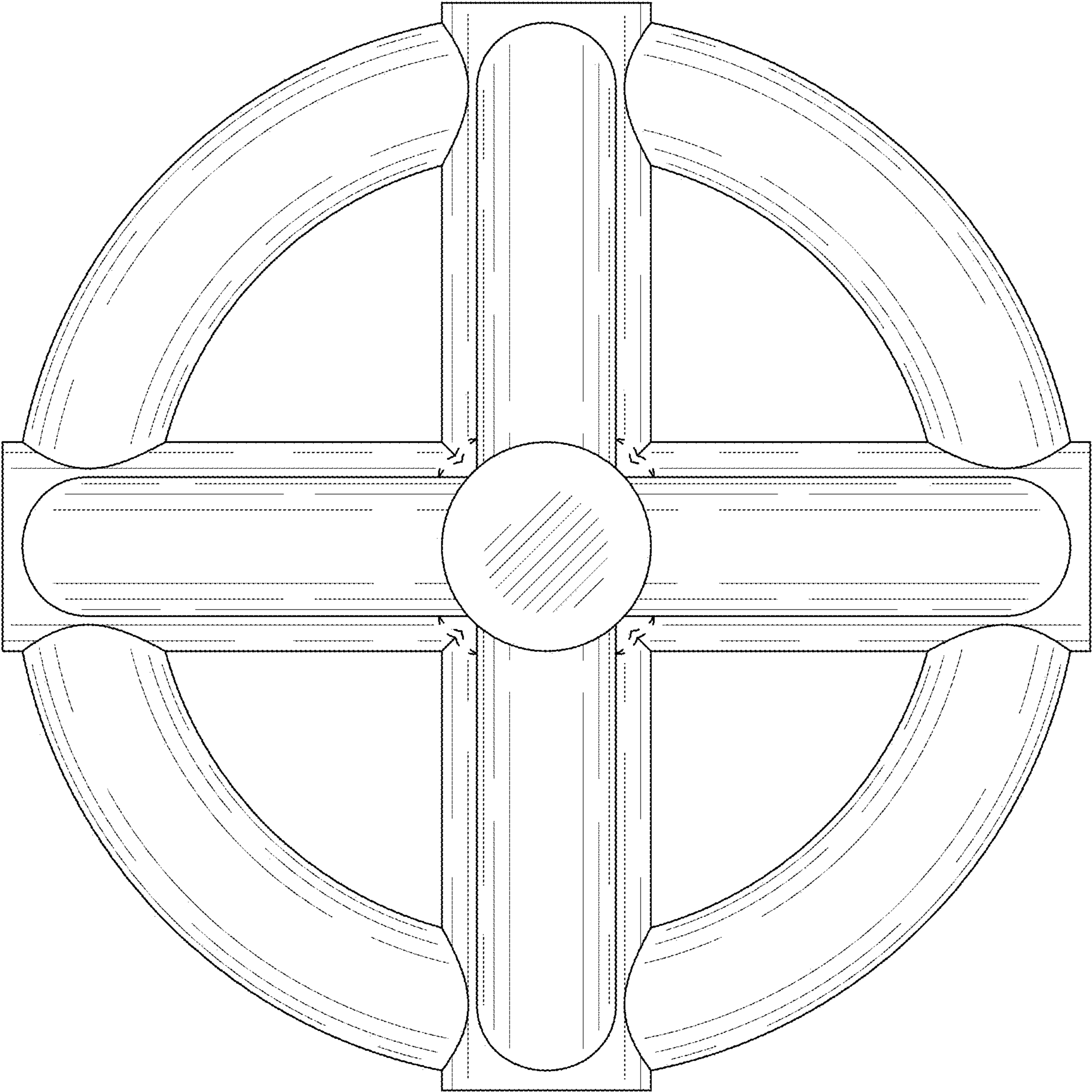

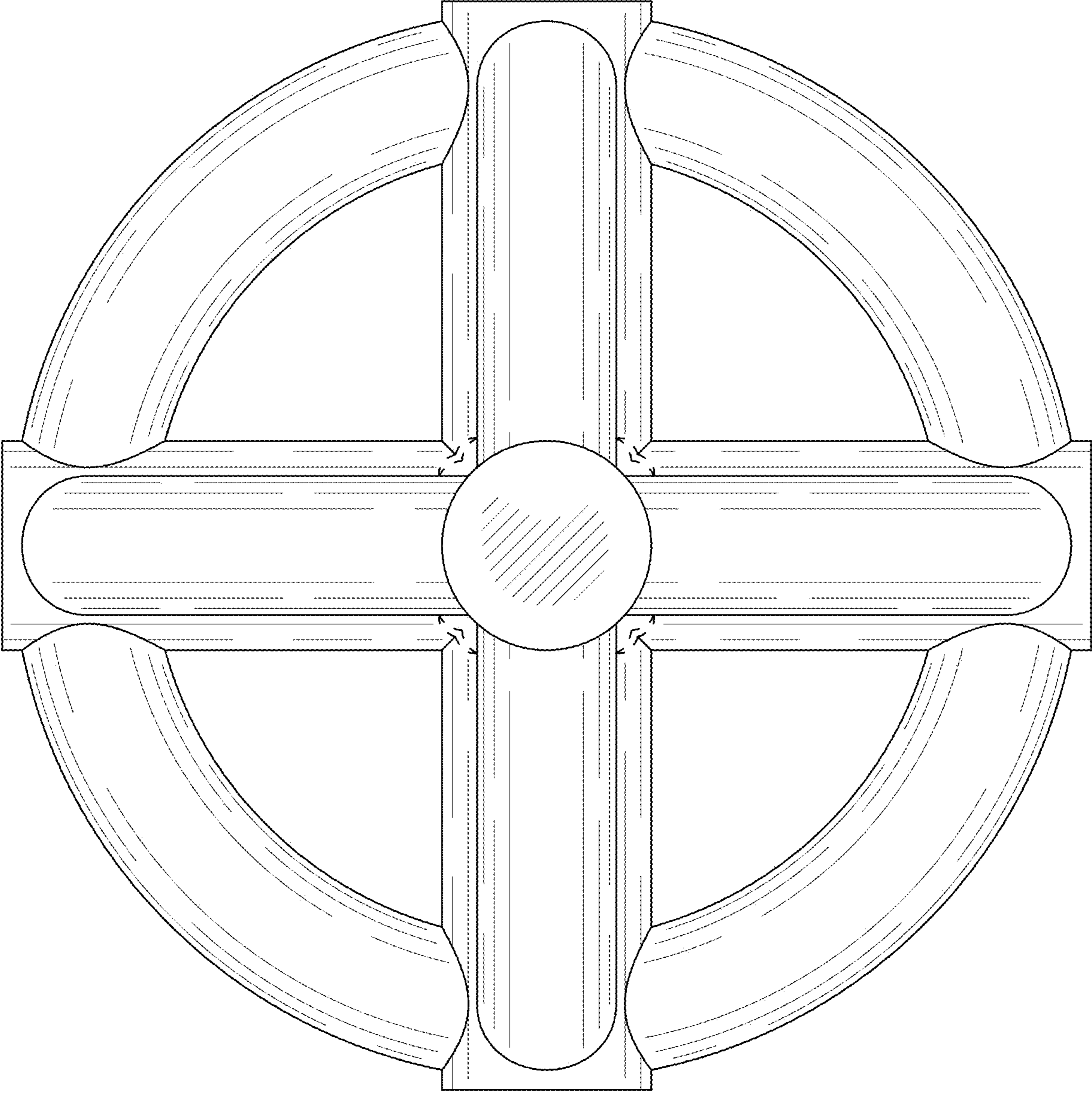

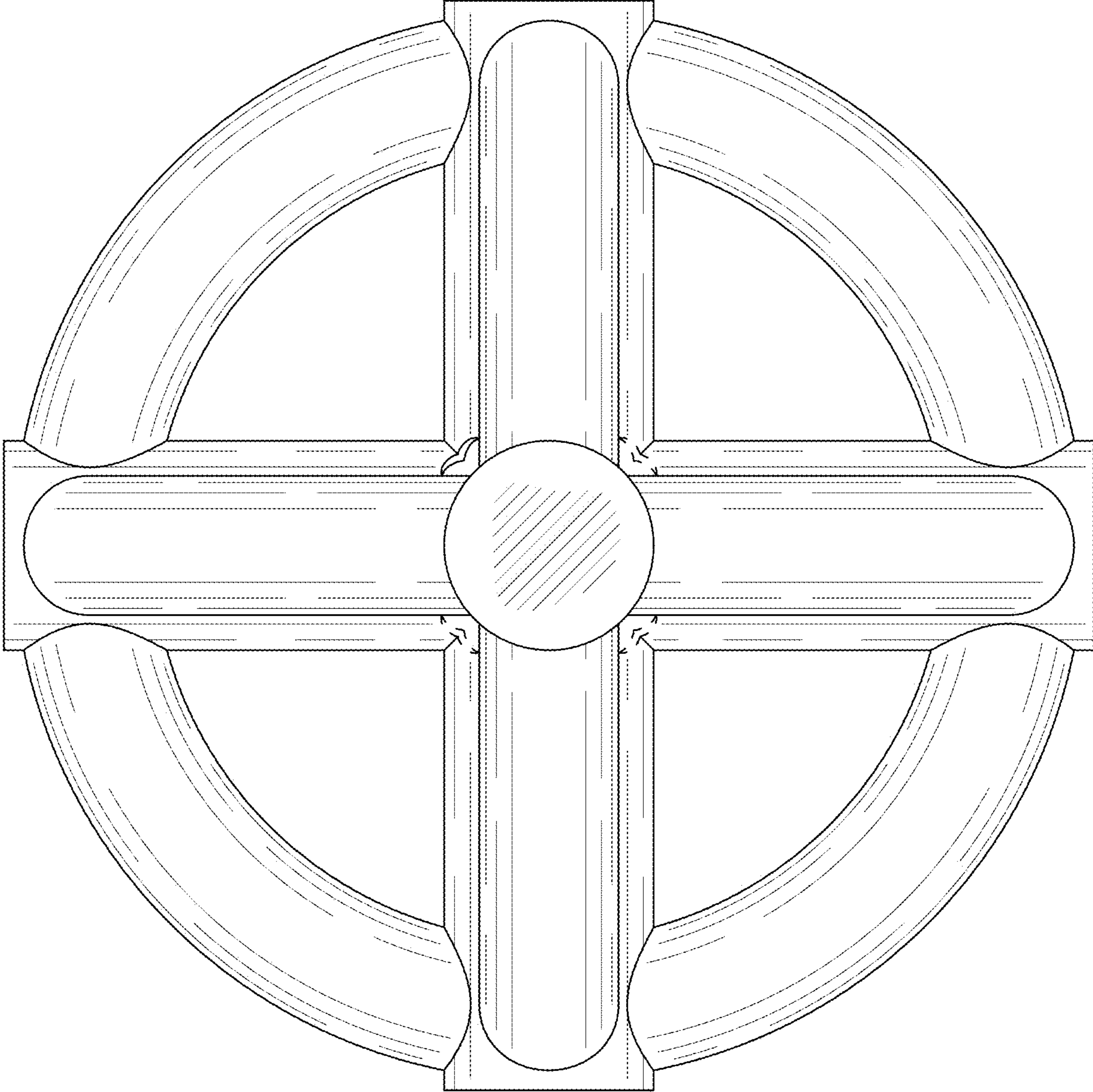

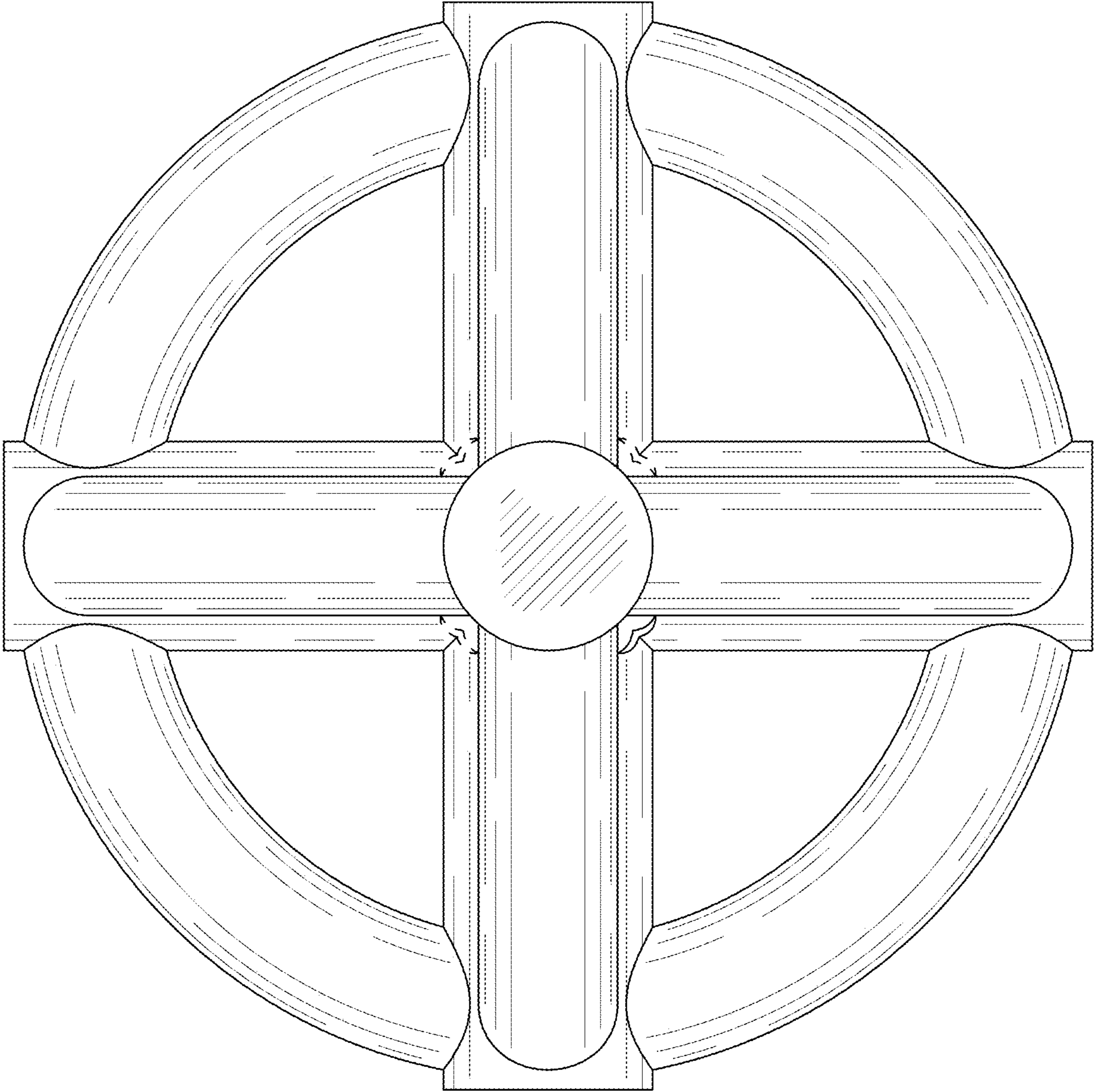

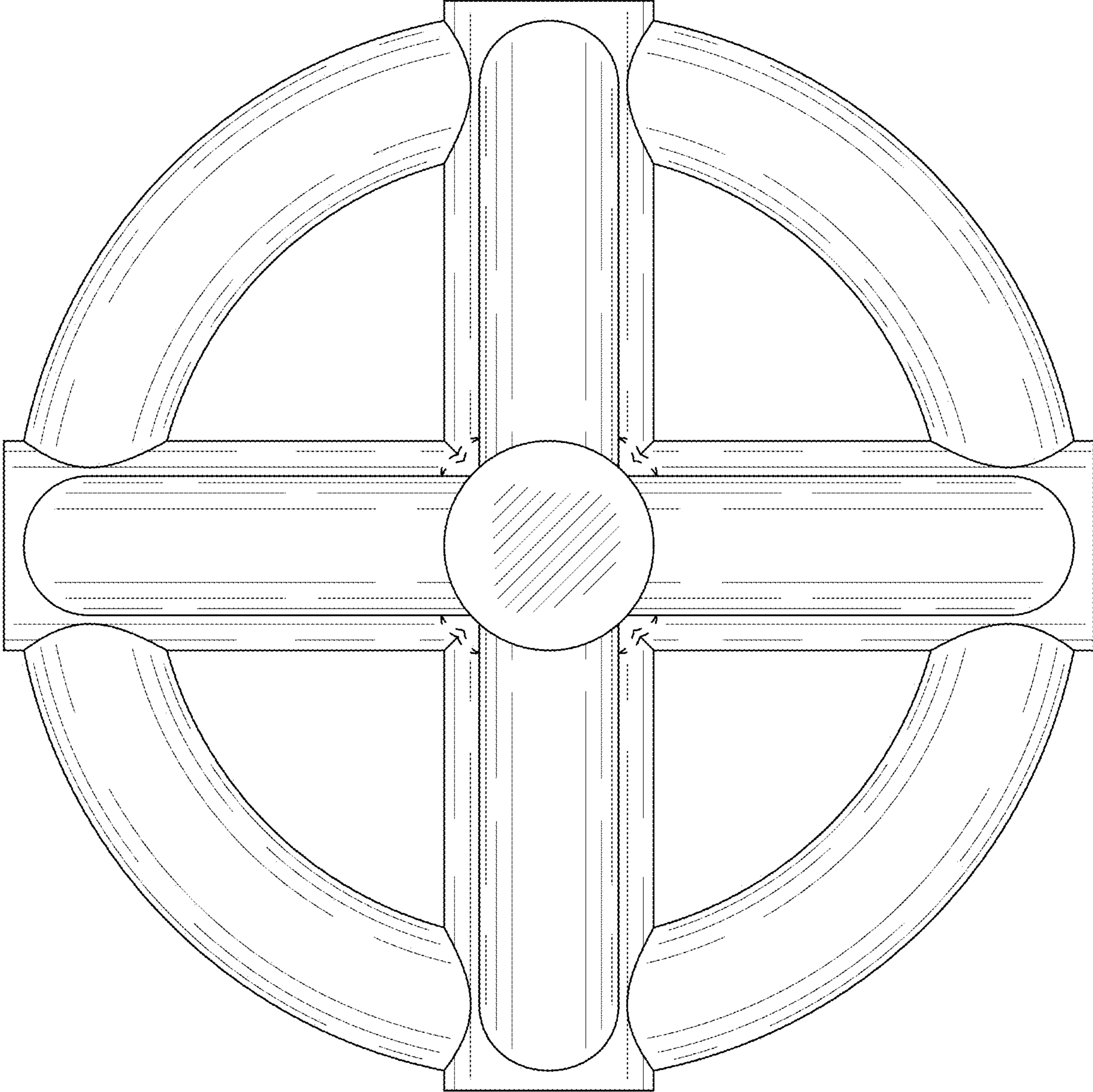
