(57) **CLAIM**

The ornamental design for a long-handled brush, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, top and left side perspective view of our design for a first embodiment of a long-handled brush; FIG. 2 is a left side elevation view of the long-handled brush of FIG. 1;

FIG. 3 is a right side elevation view of the long-handled brush of FIG. 1;

FIG. 4 is a top plan view of the long-handled brush of FIG. 1;

FIG. 5 is a bottom plan view of the long-handled brush of FIG. 1;

FIG. 6 is a front elevation view of the long-handled brush of FIG. 1;

FIG. 7 is a rear elevation view of the long-handled brush of FIG. 1;

FIG. 8 is a top, front and left side perspective view of our design for a second embodiment of a long-handled brush;

FIG. 11 is a top plan elevation view of the long-handled brush of FIG. 8;

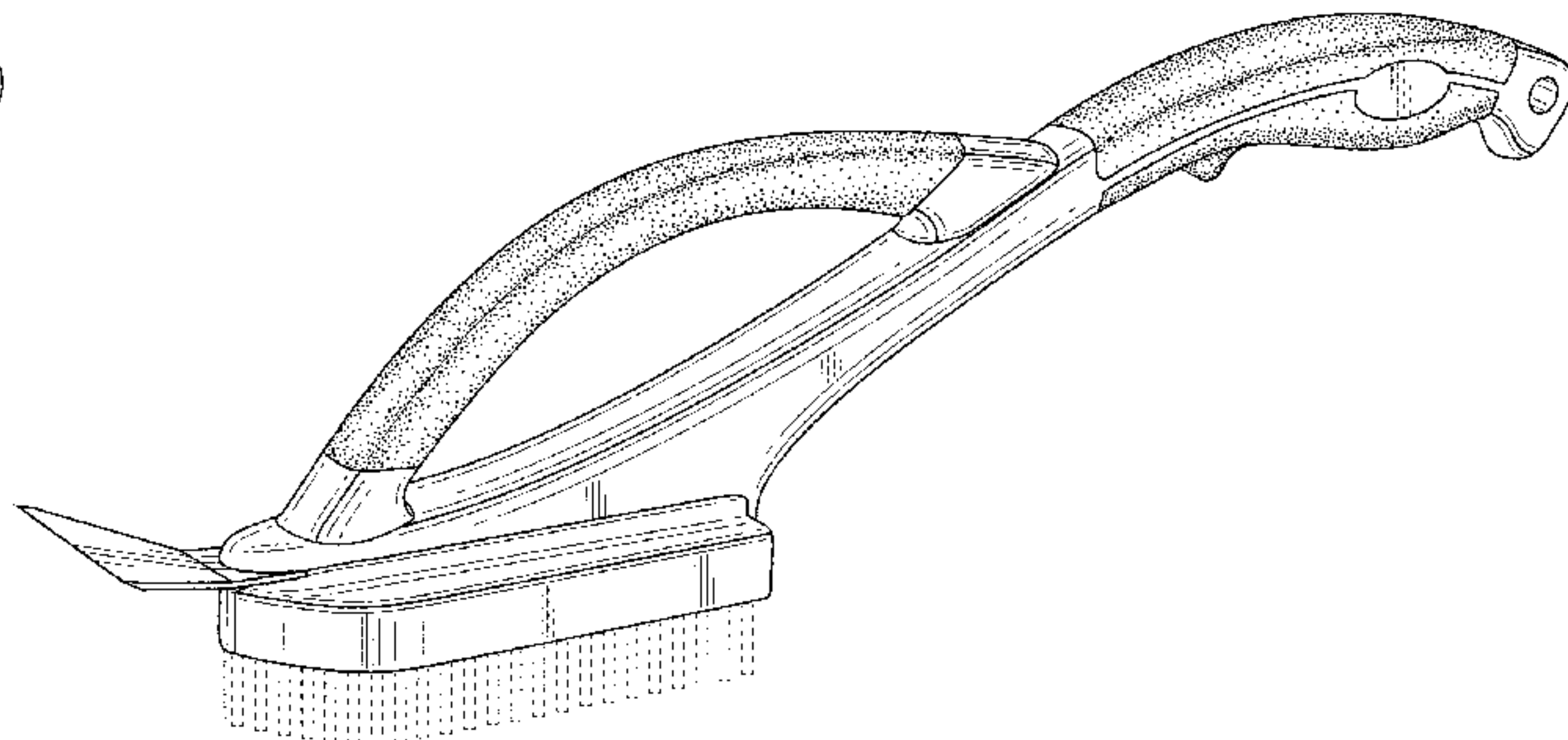
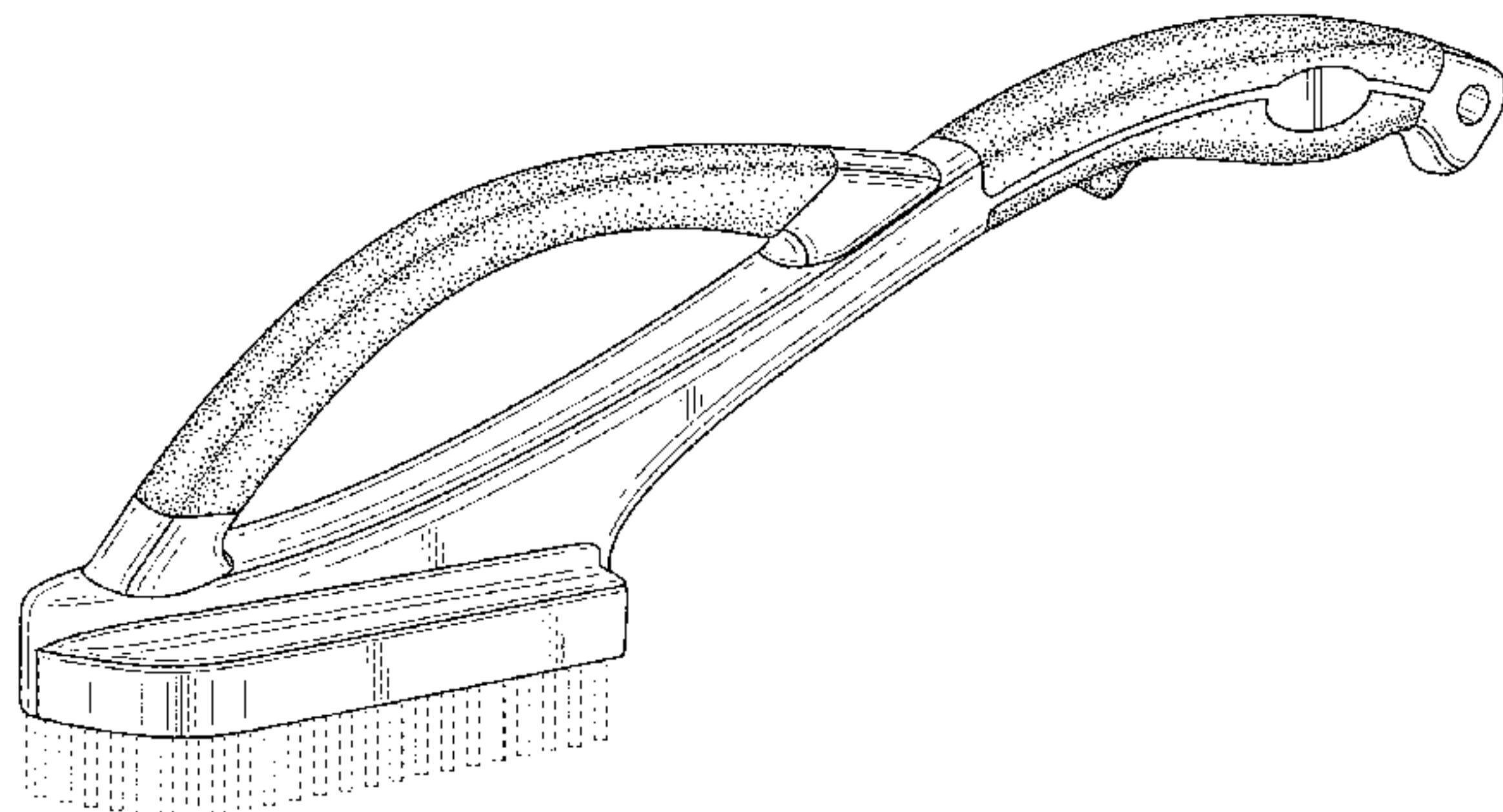
FIG. 12 is a bottom plan elevation view of the long-handled brush of FIG. 8;

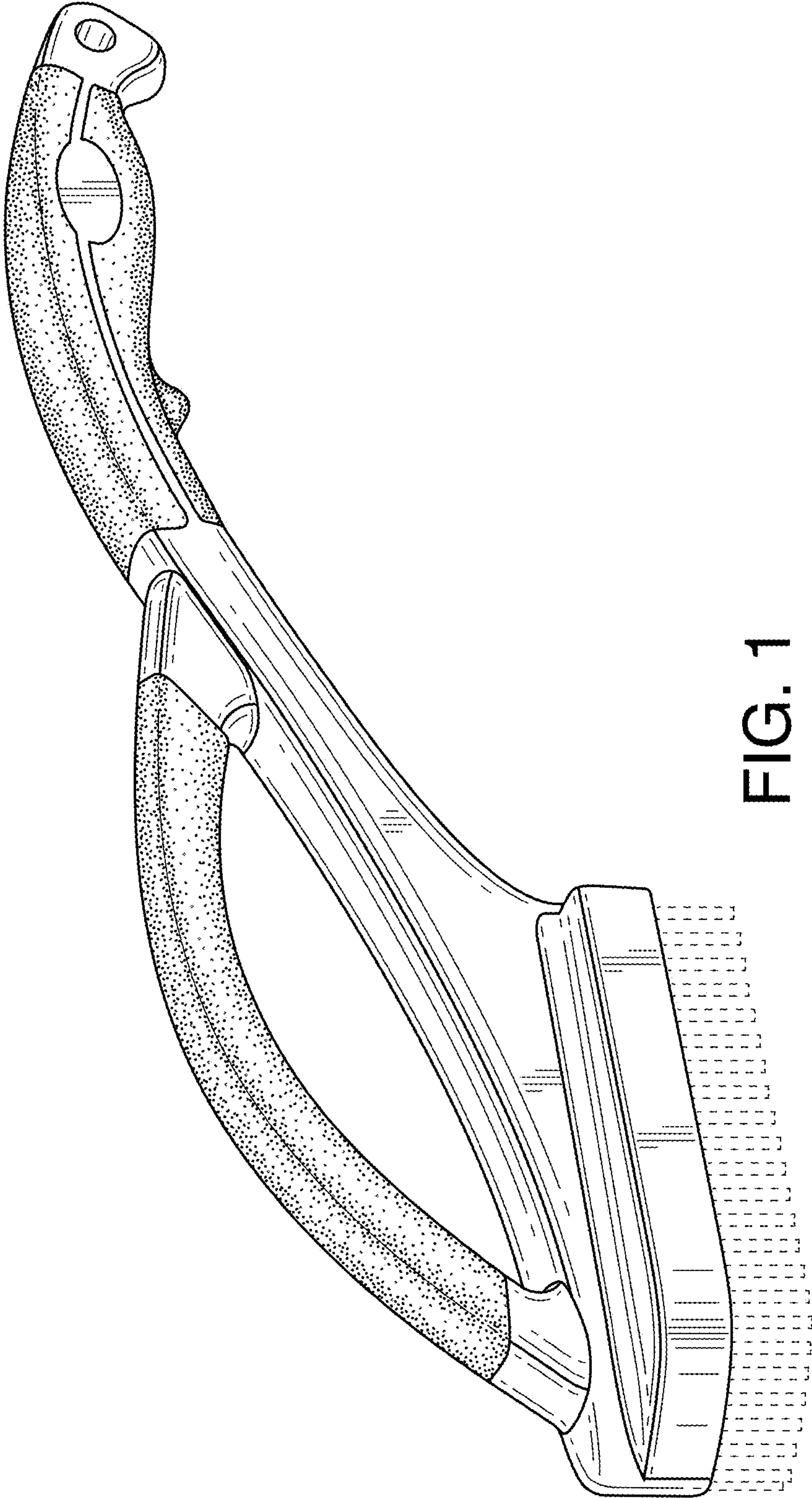

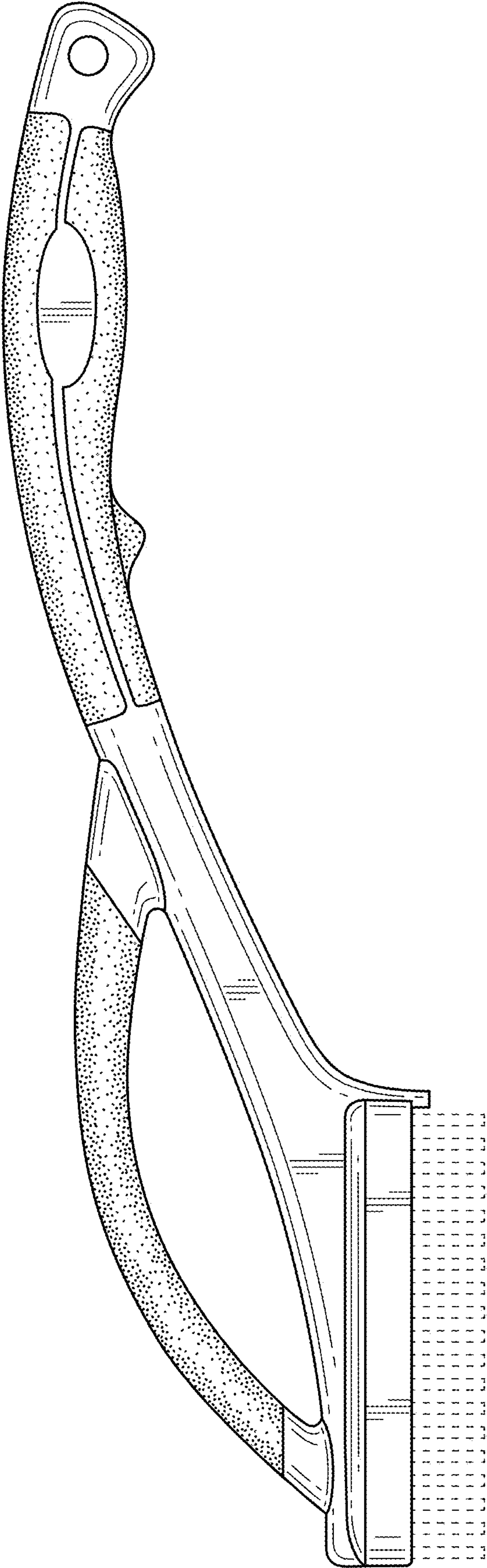

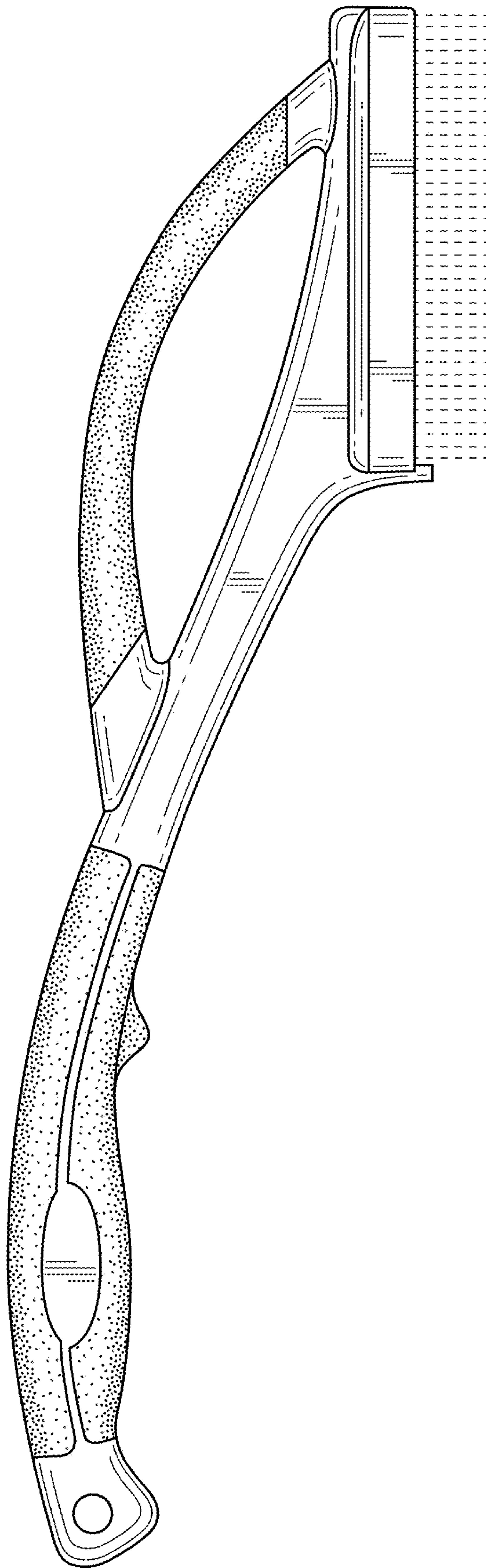

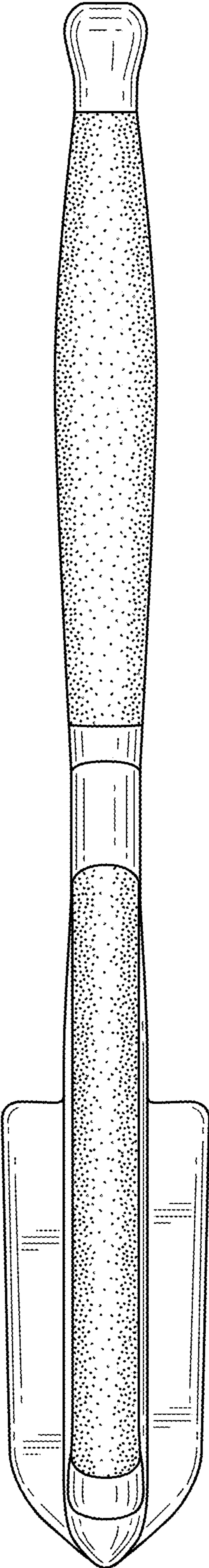

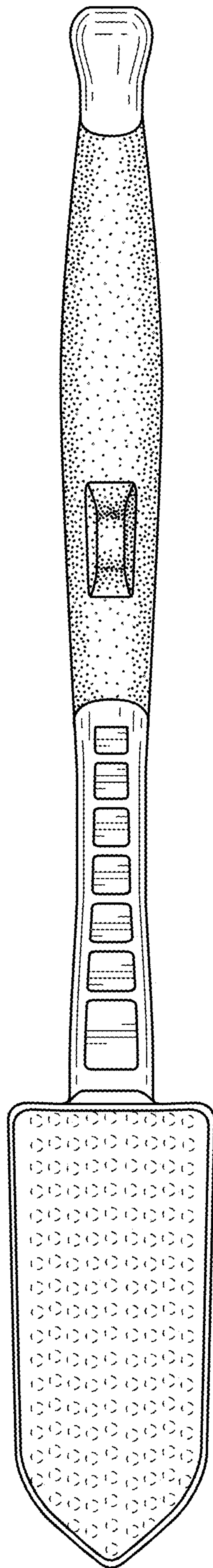

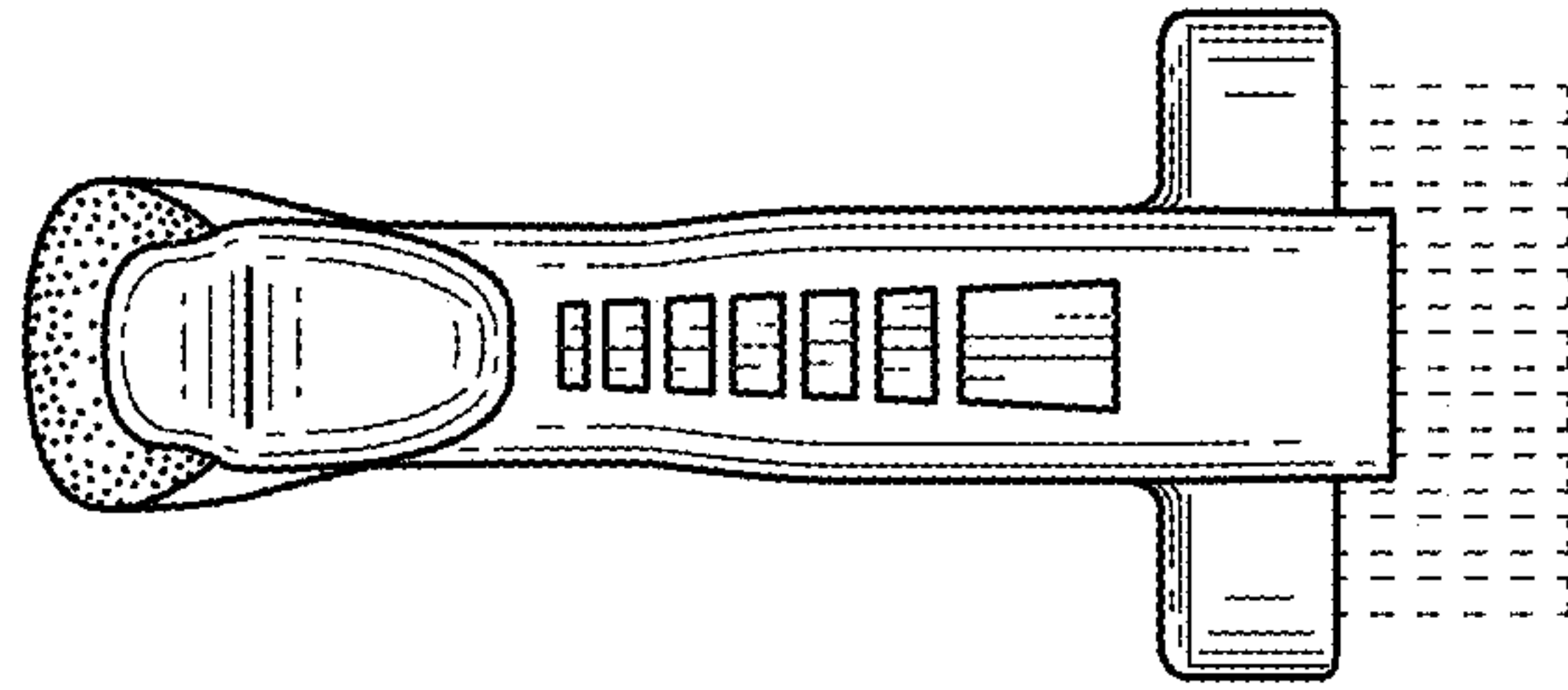

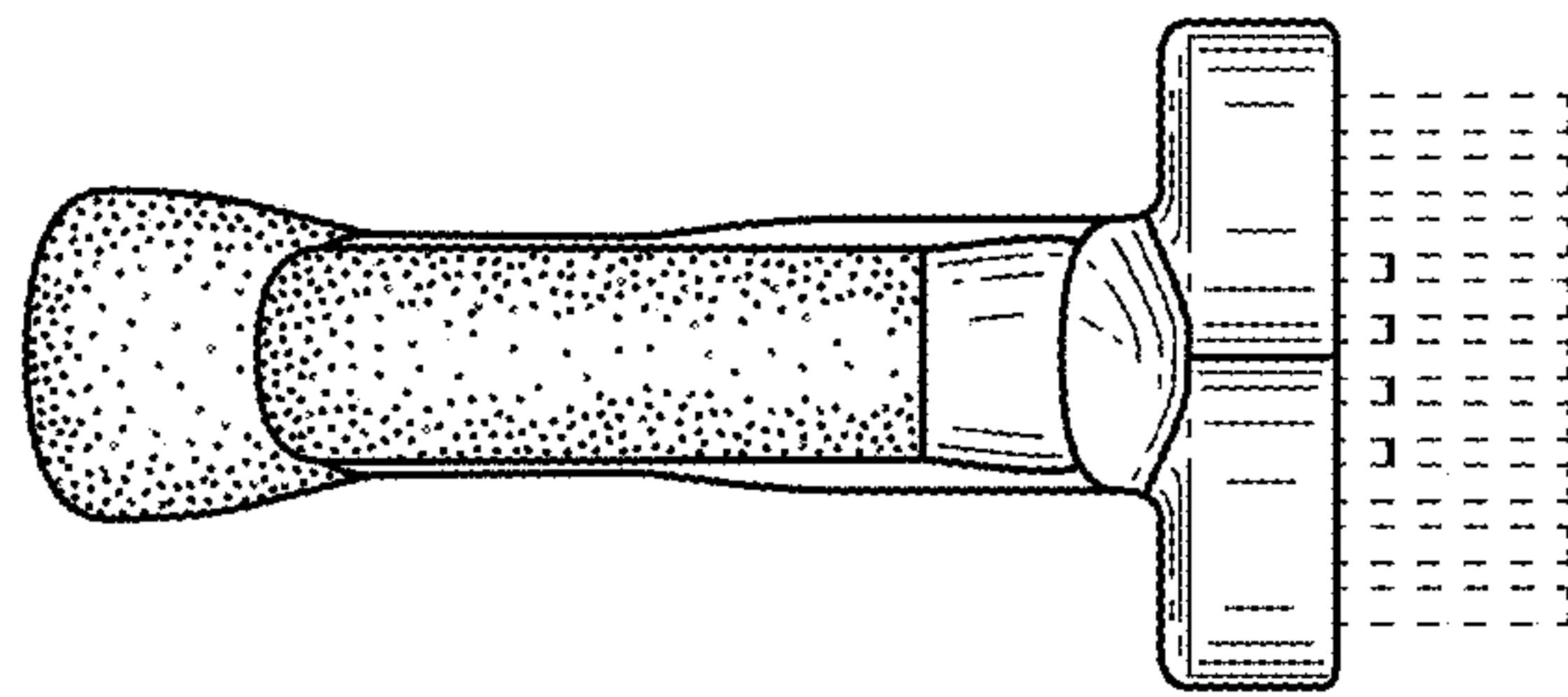

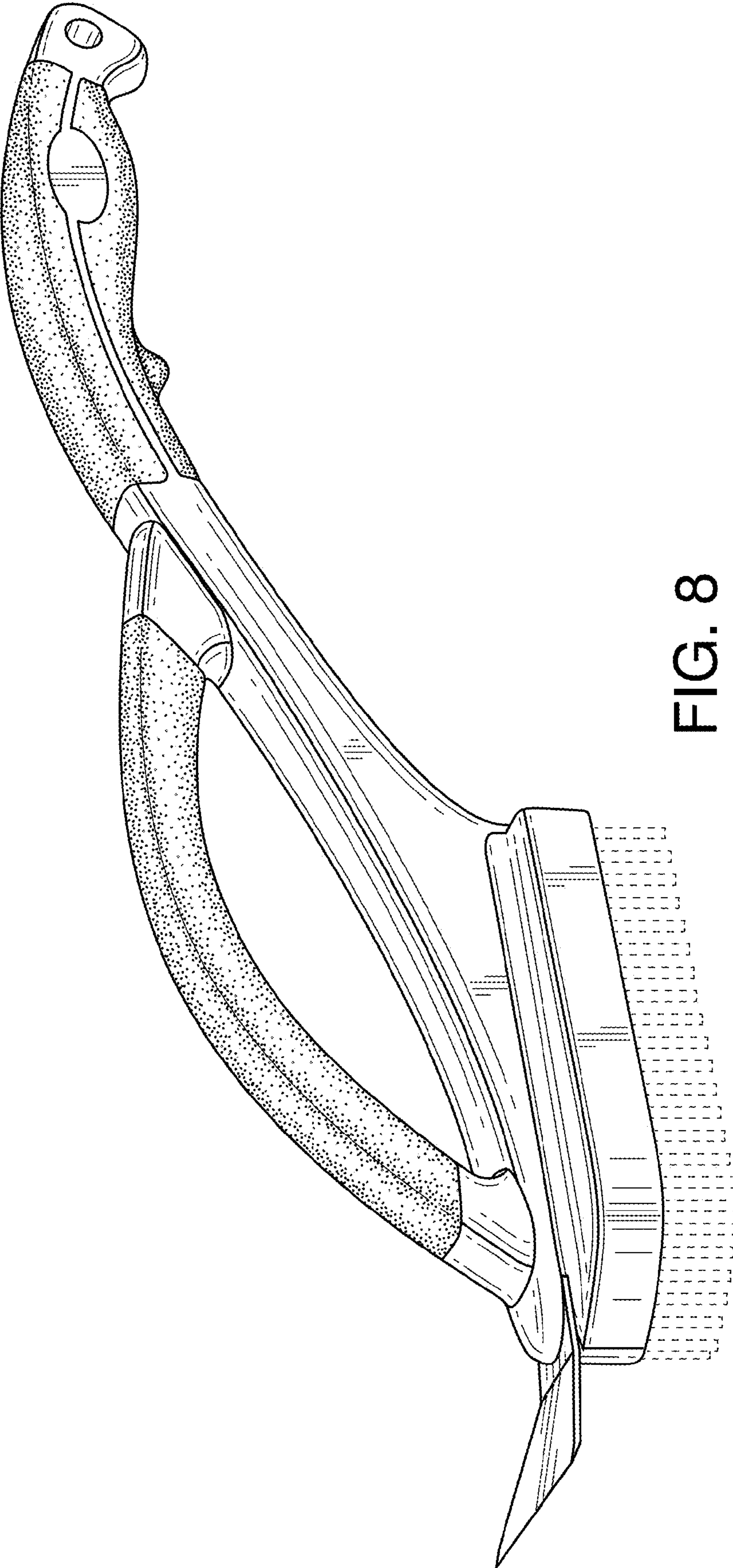

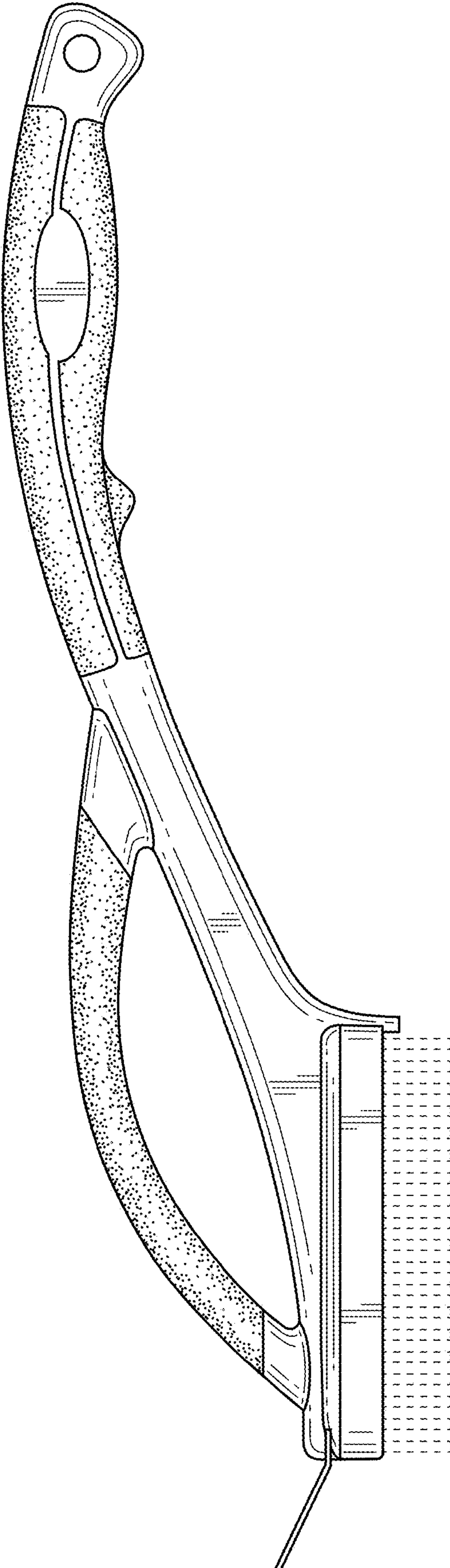

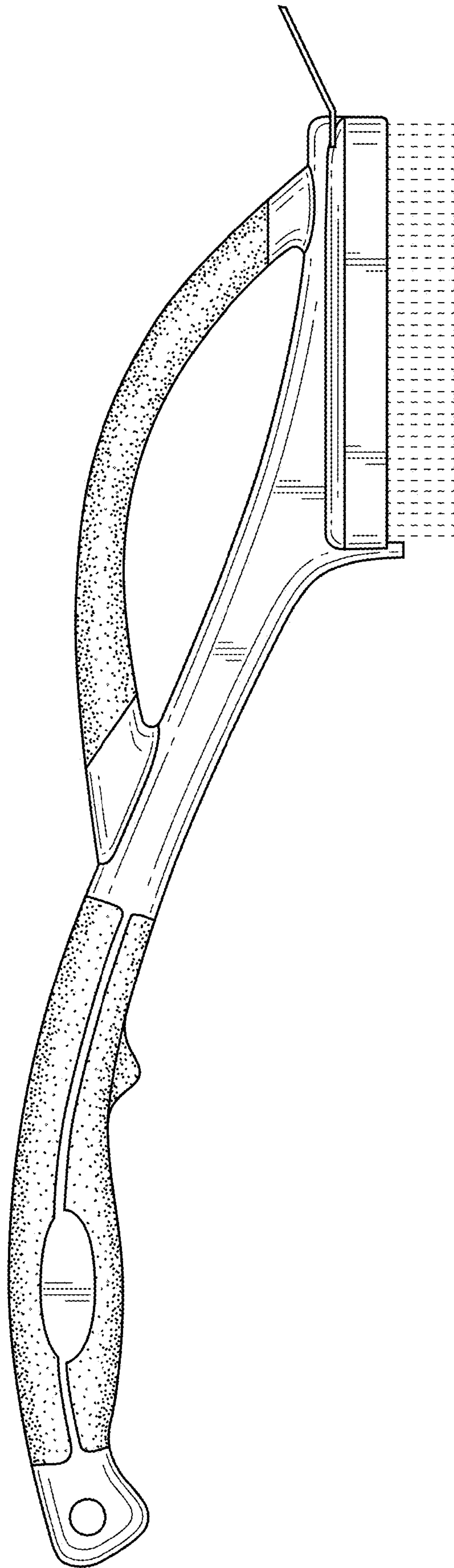

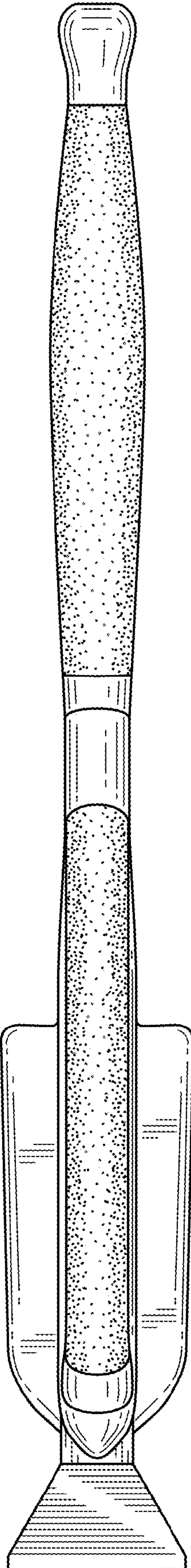

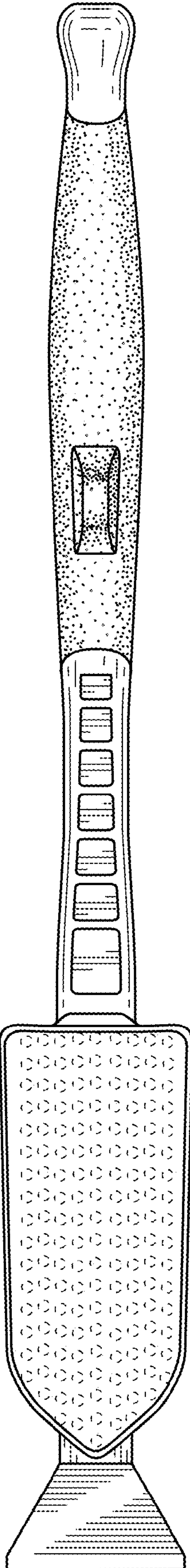

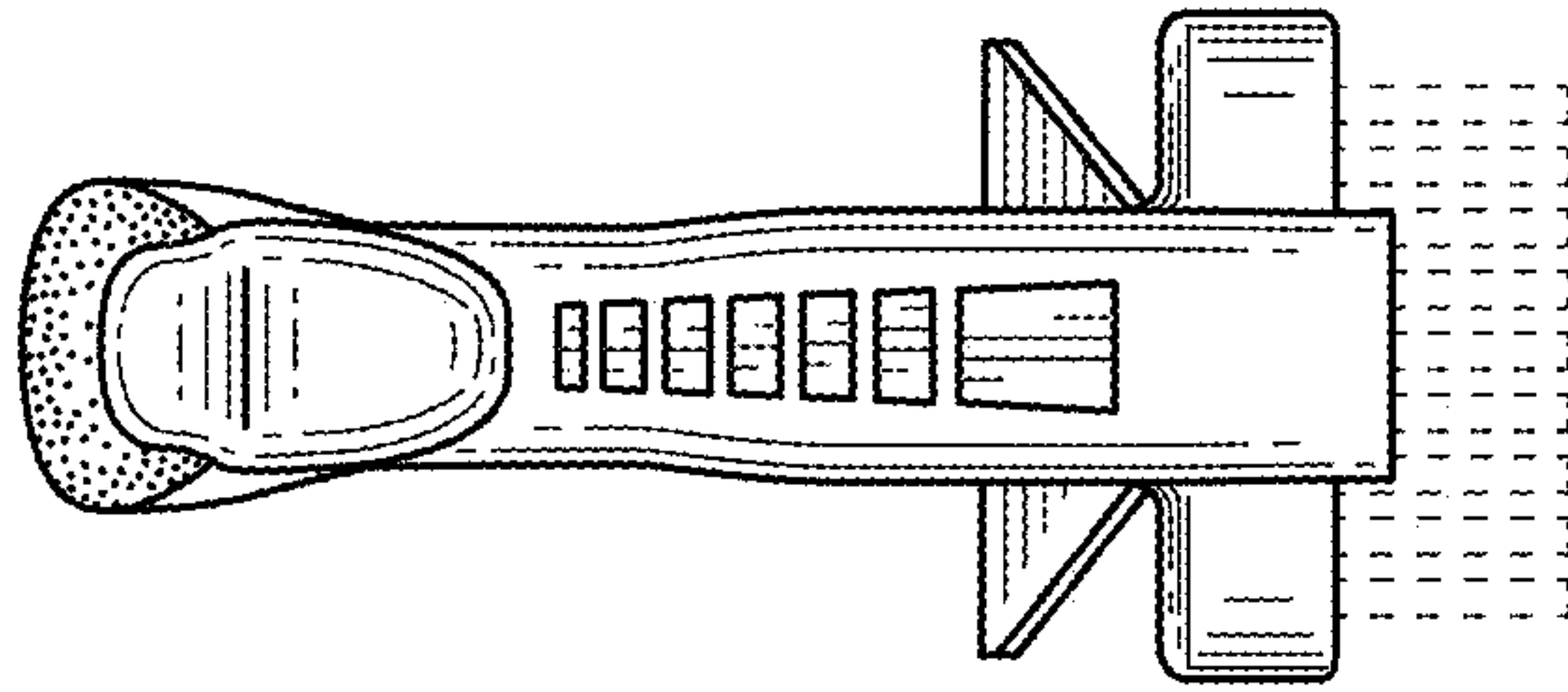

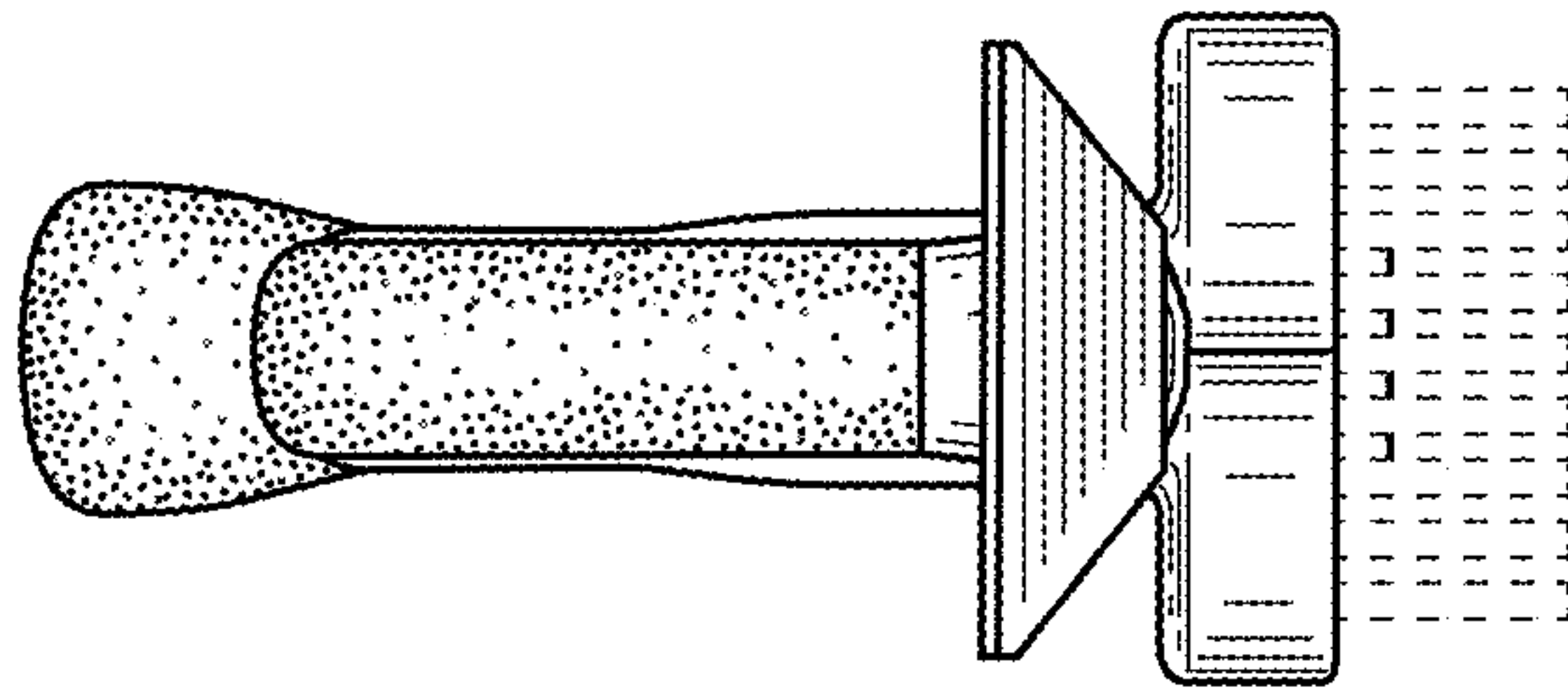
