DESCRIPTION

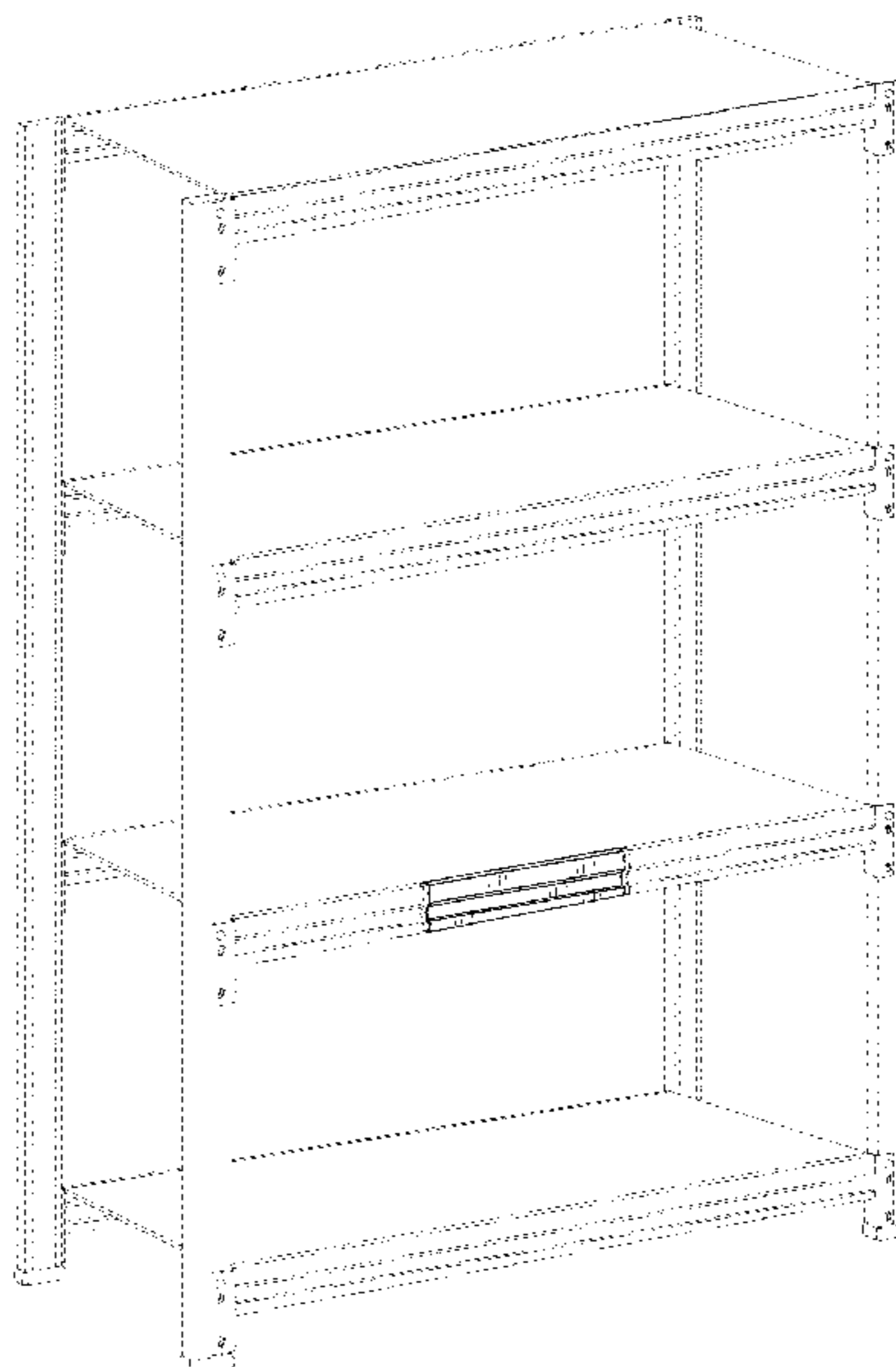
FIG. 1 is a front perspective view of a support beam profile showing the new design, shown with environment.

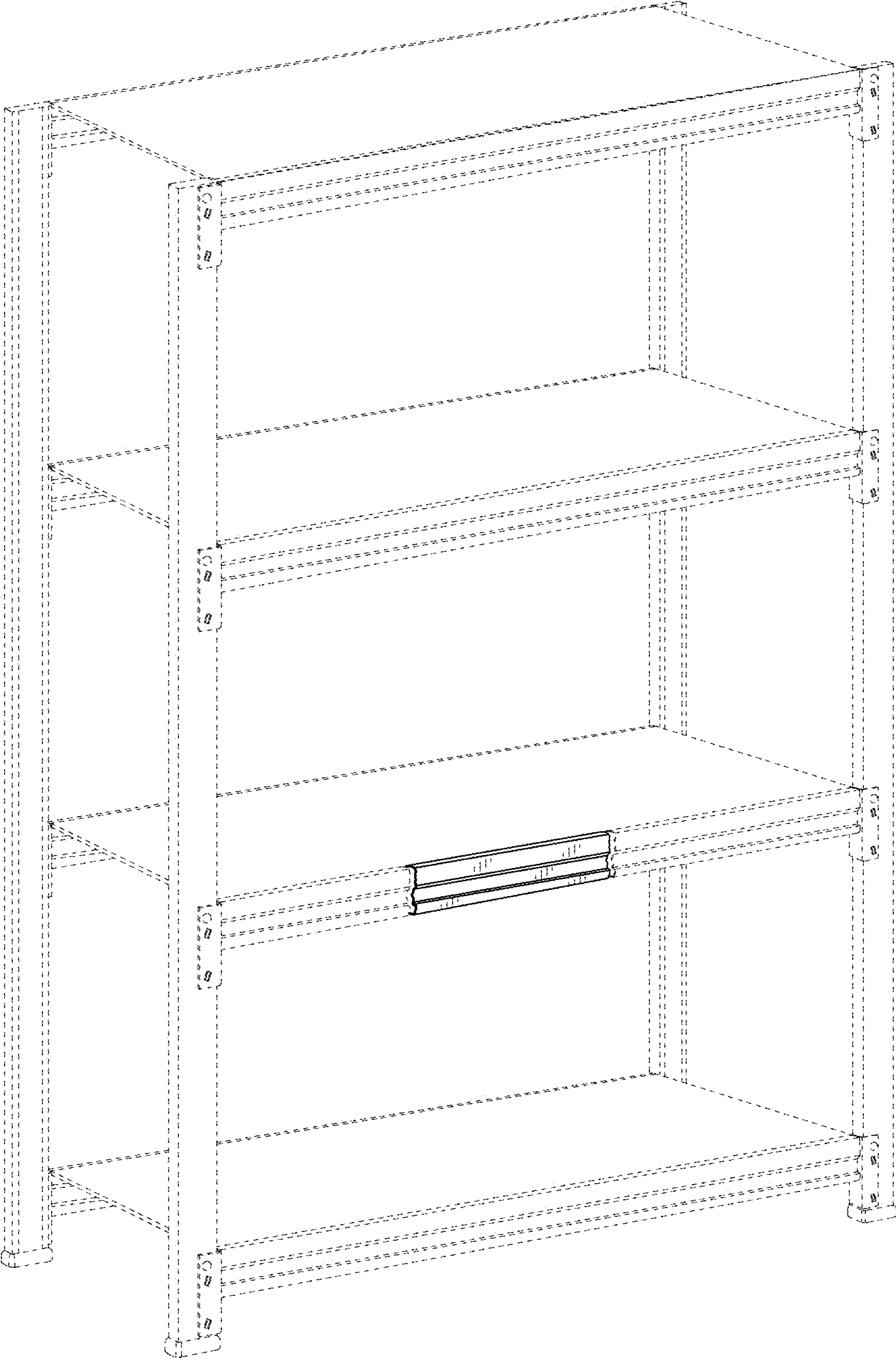

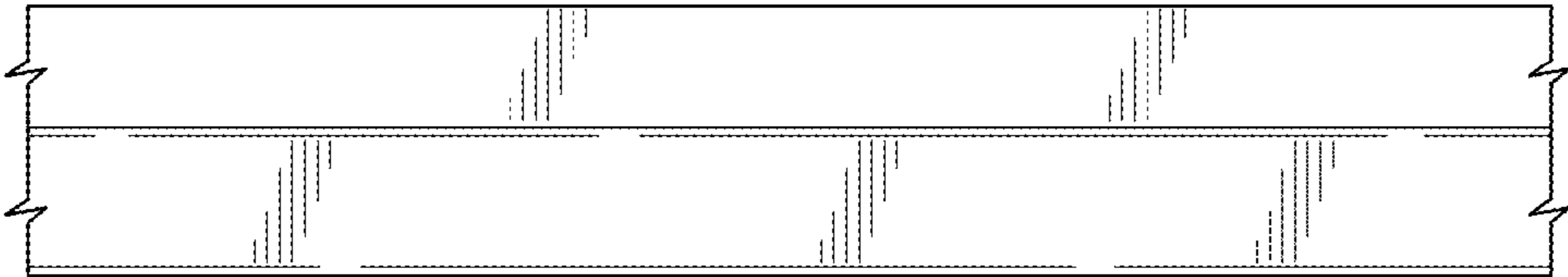

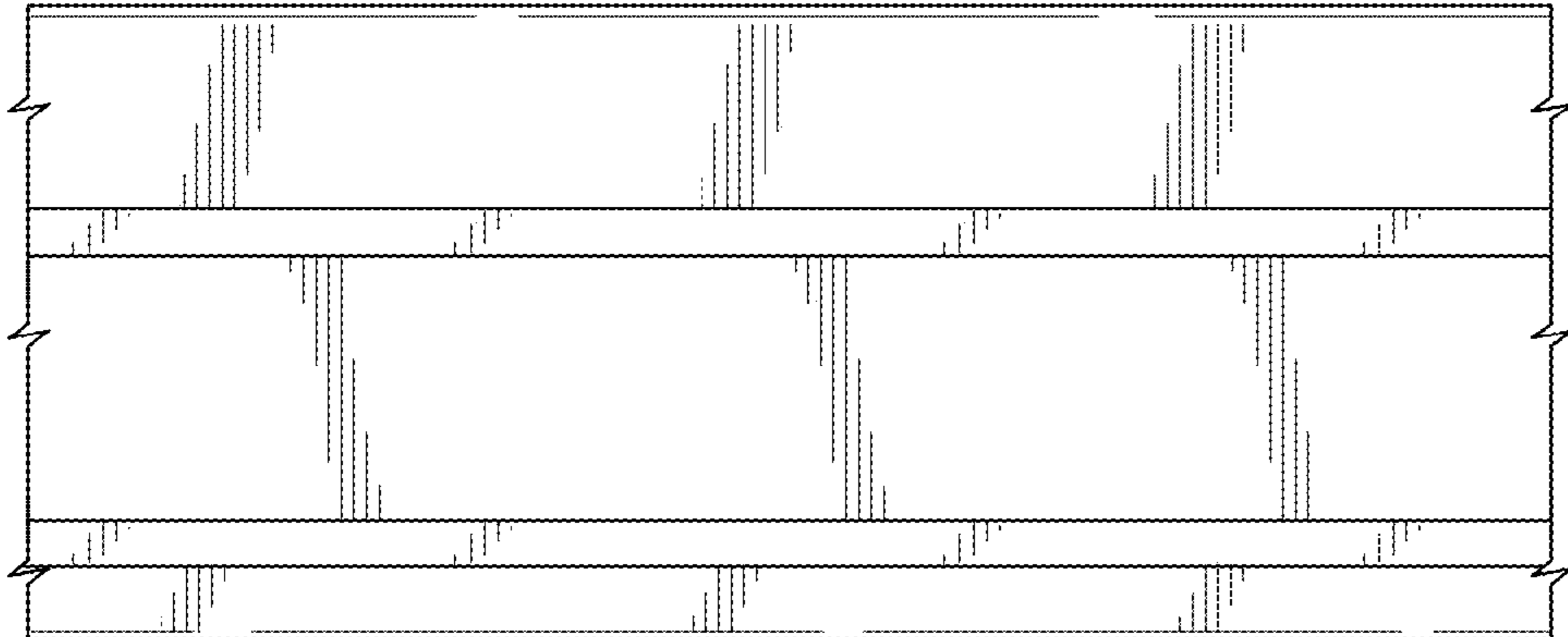

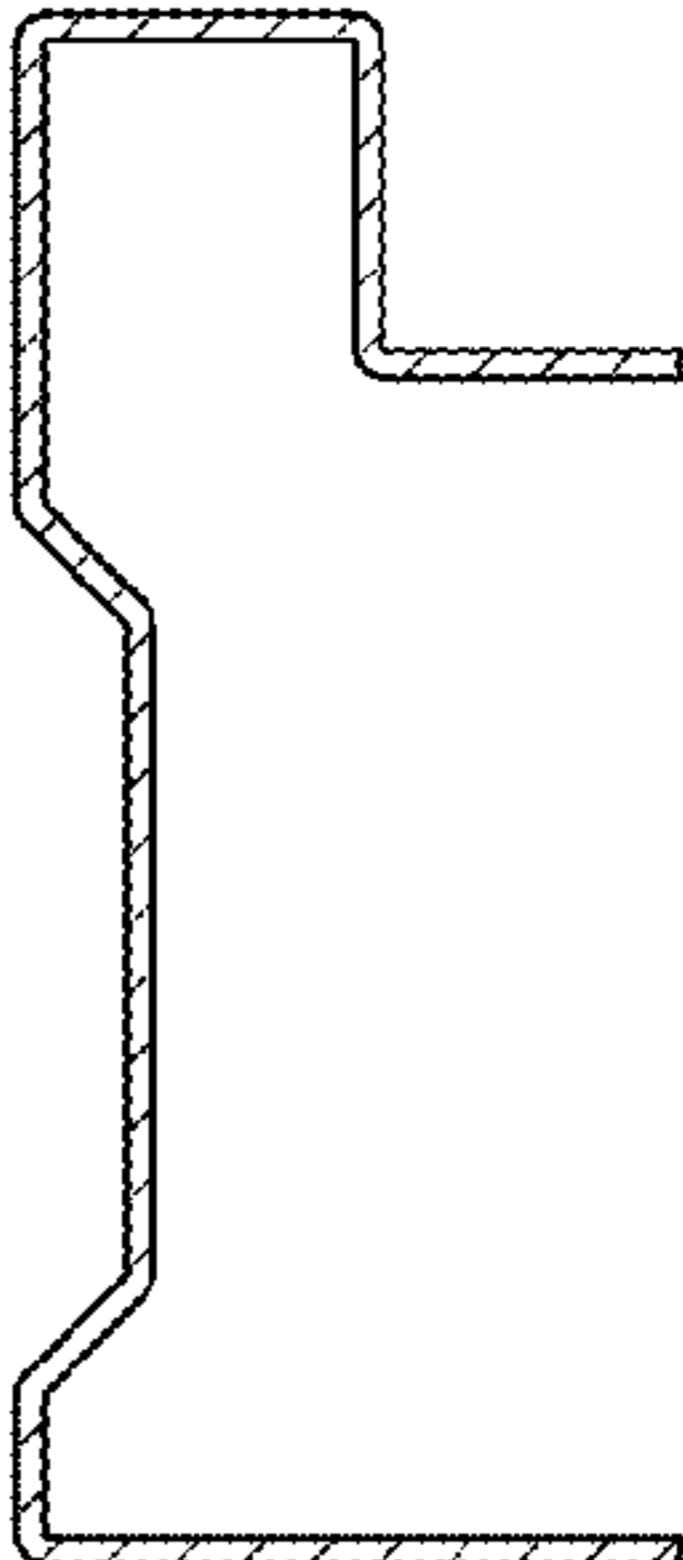

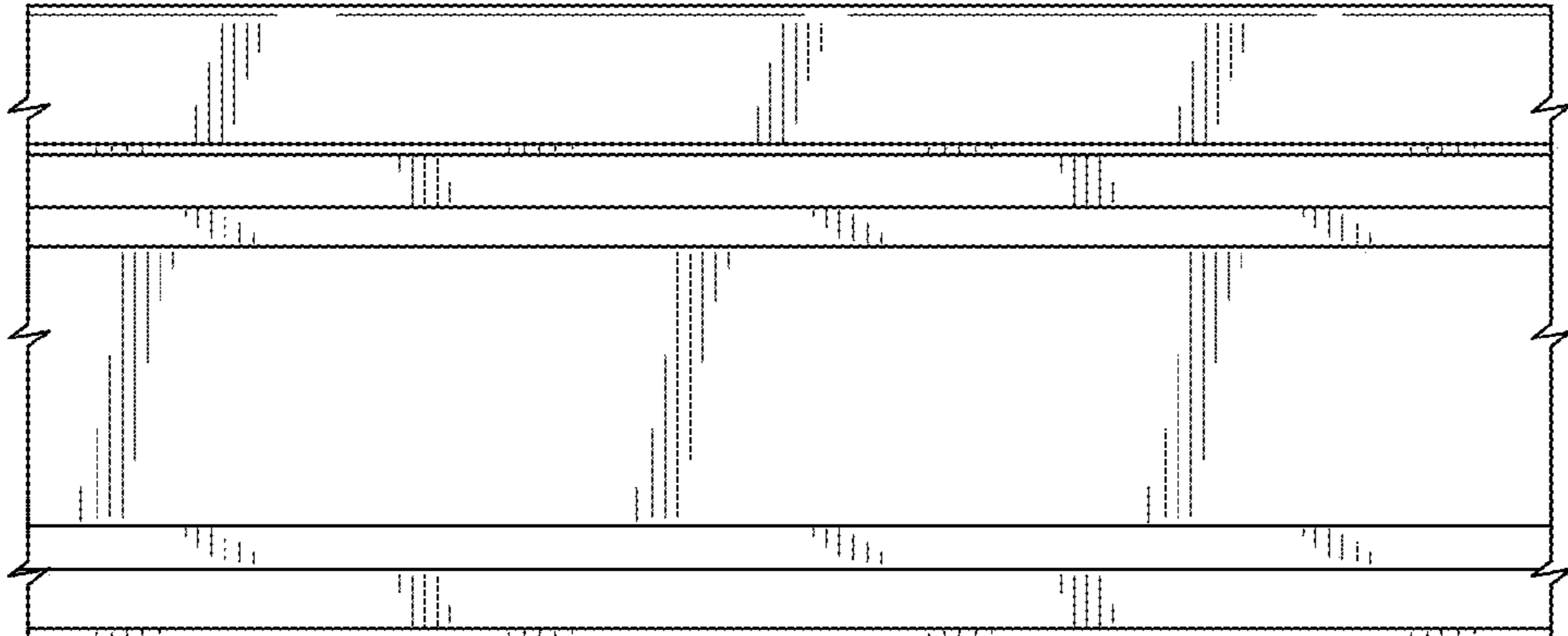

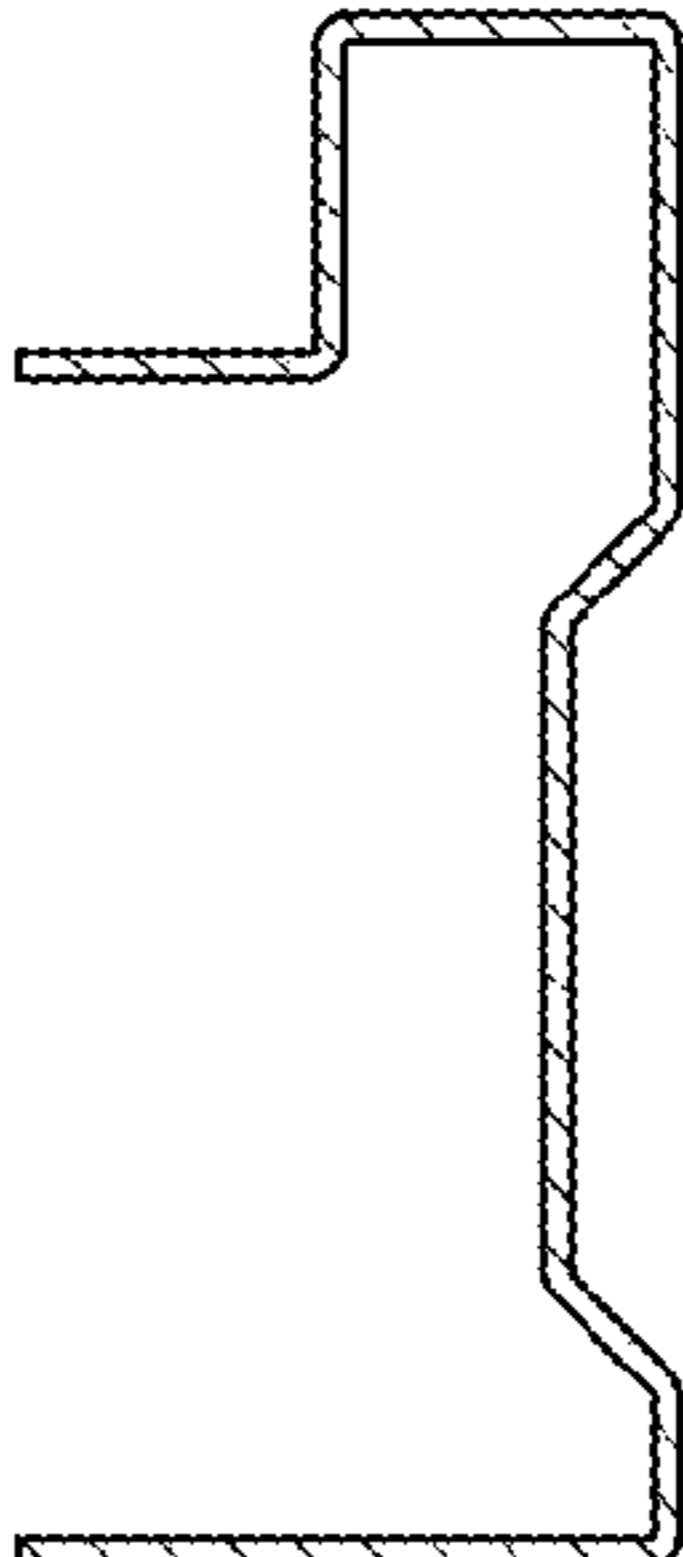
