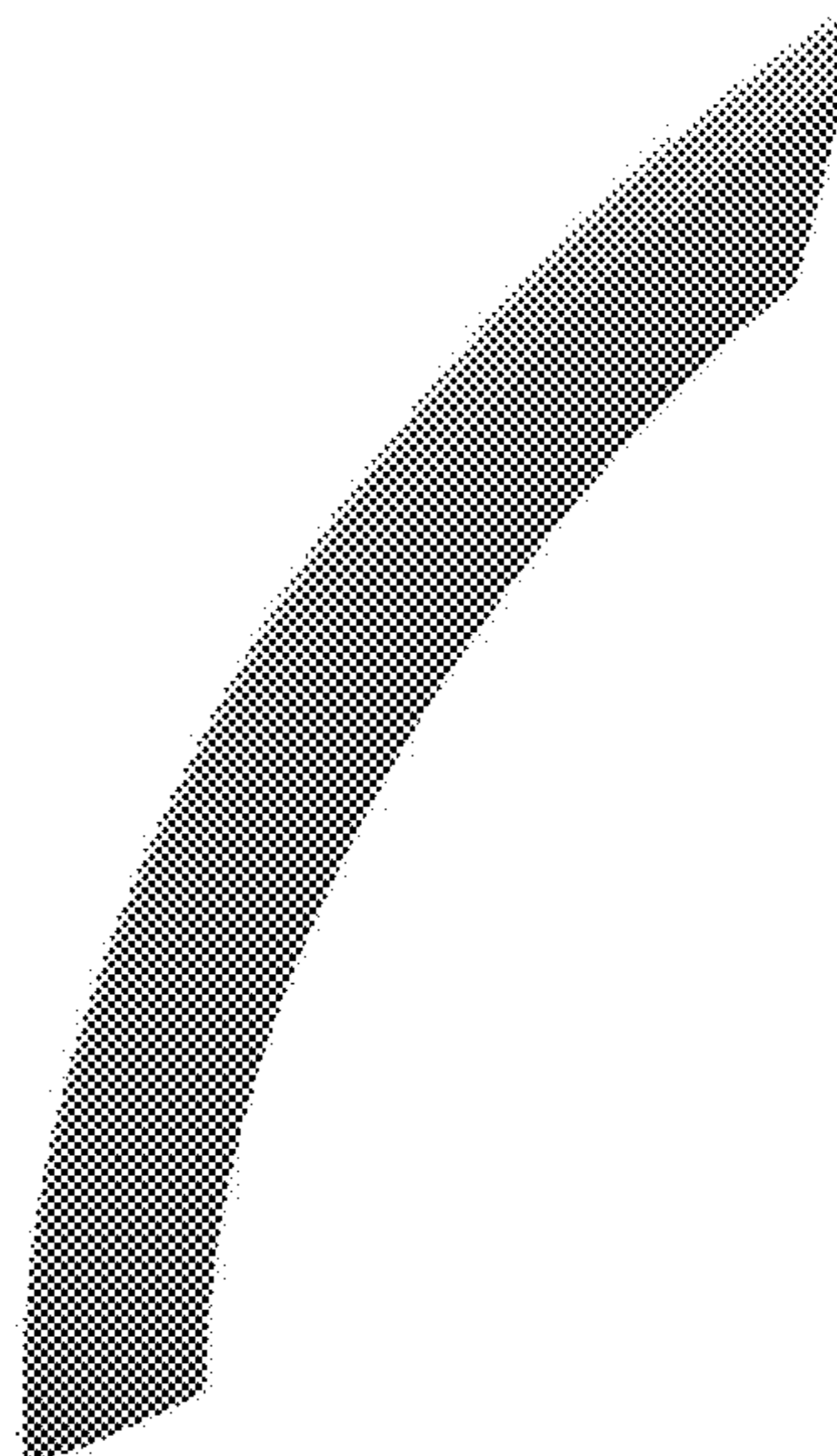
(57) **CLAIM**

The ornamental design for a body part for motor vehicle, as shown and described.

**DESCRIPTION**

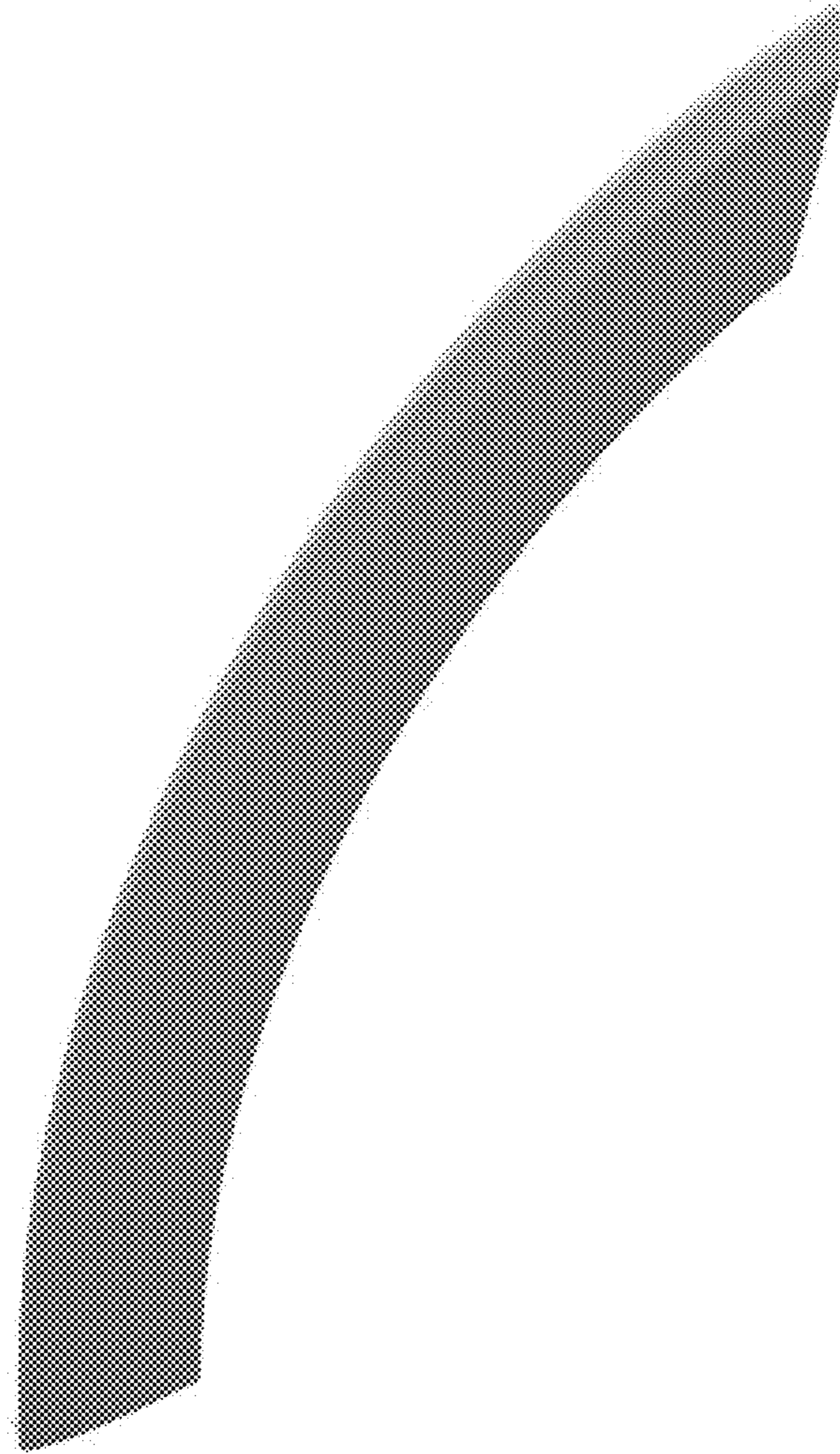

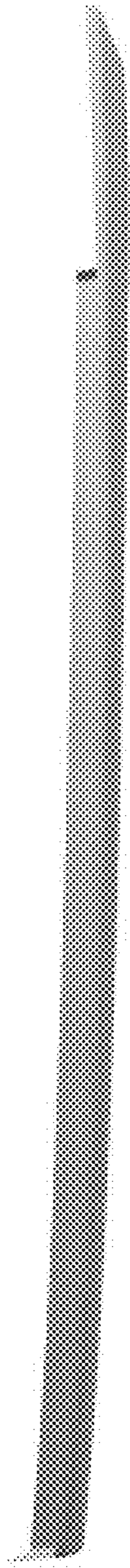

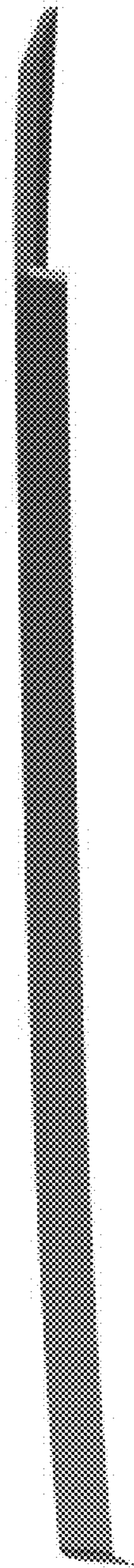

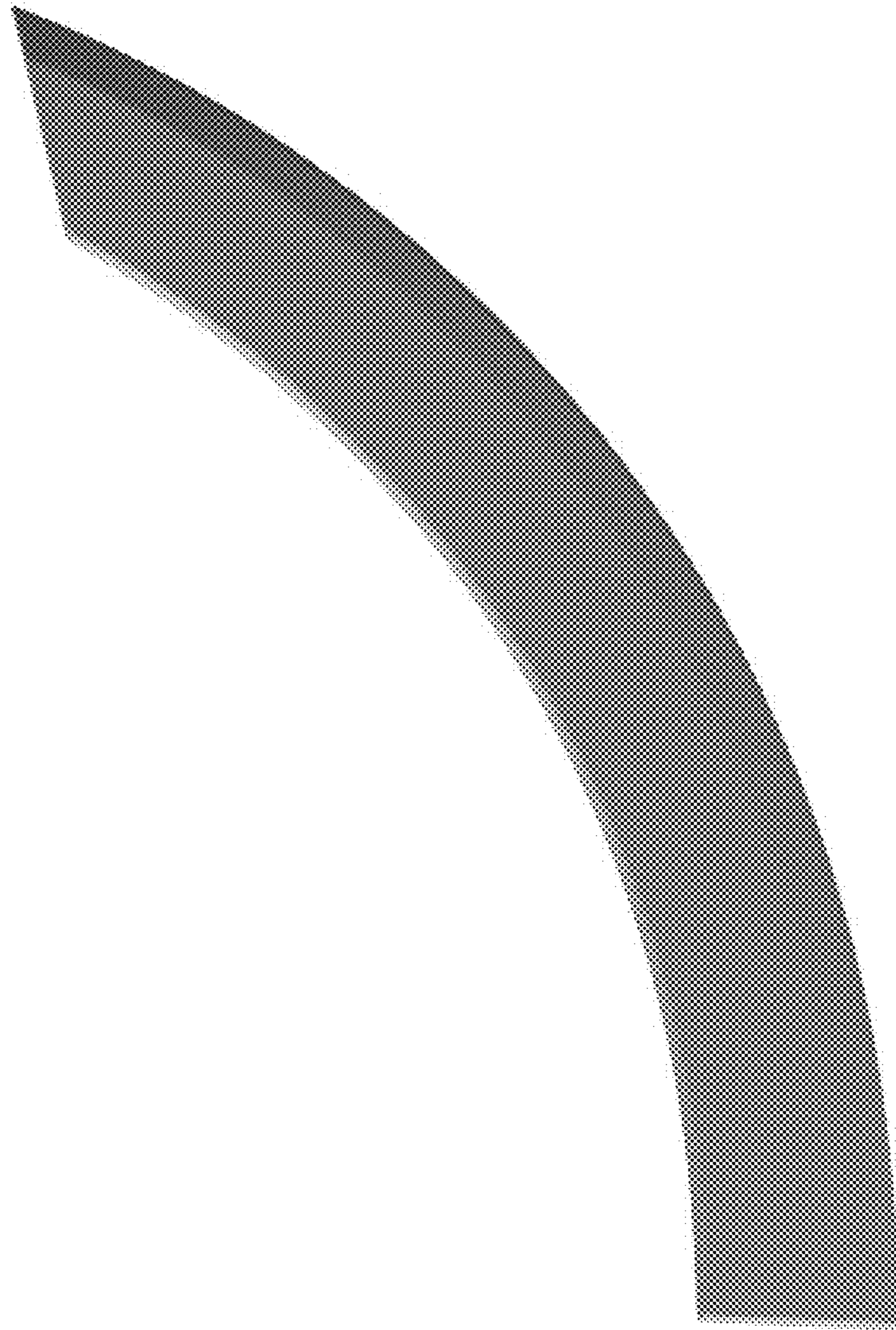

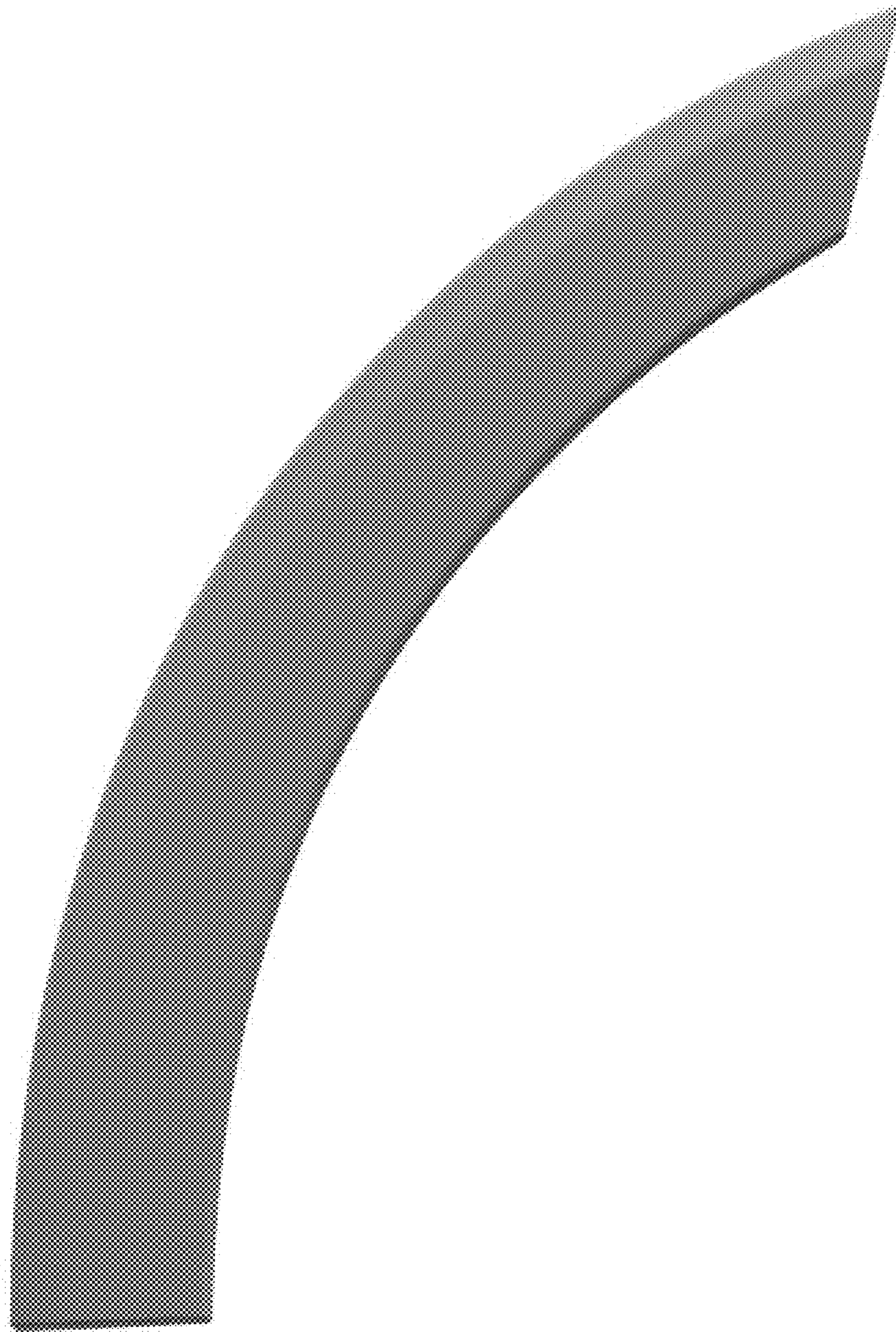

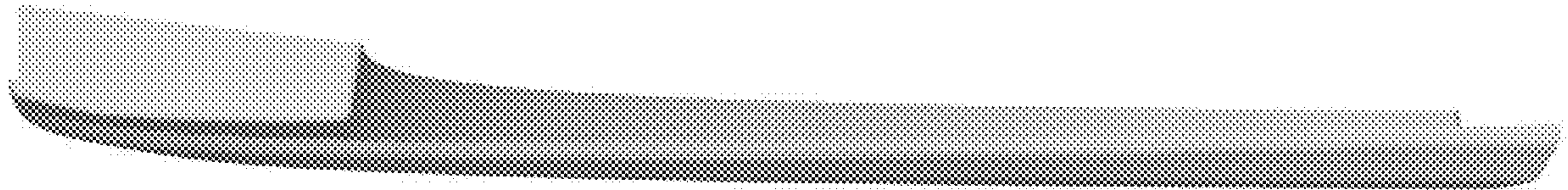

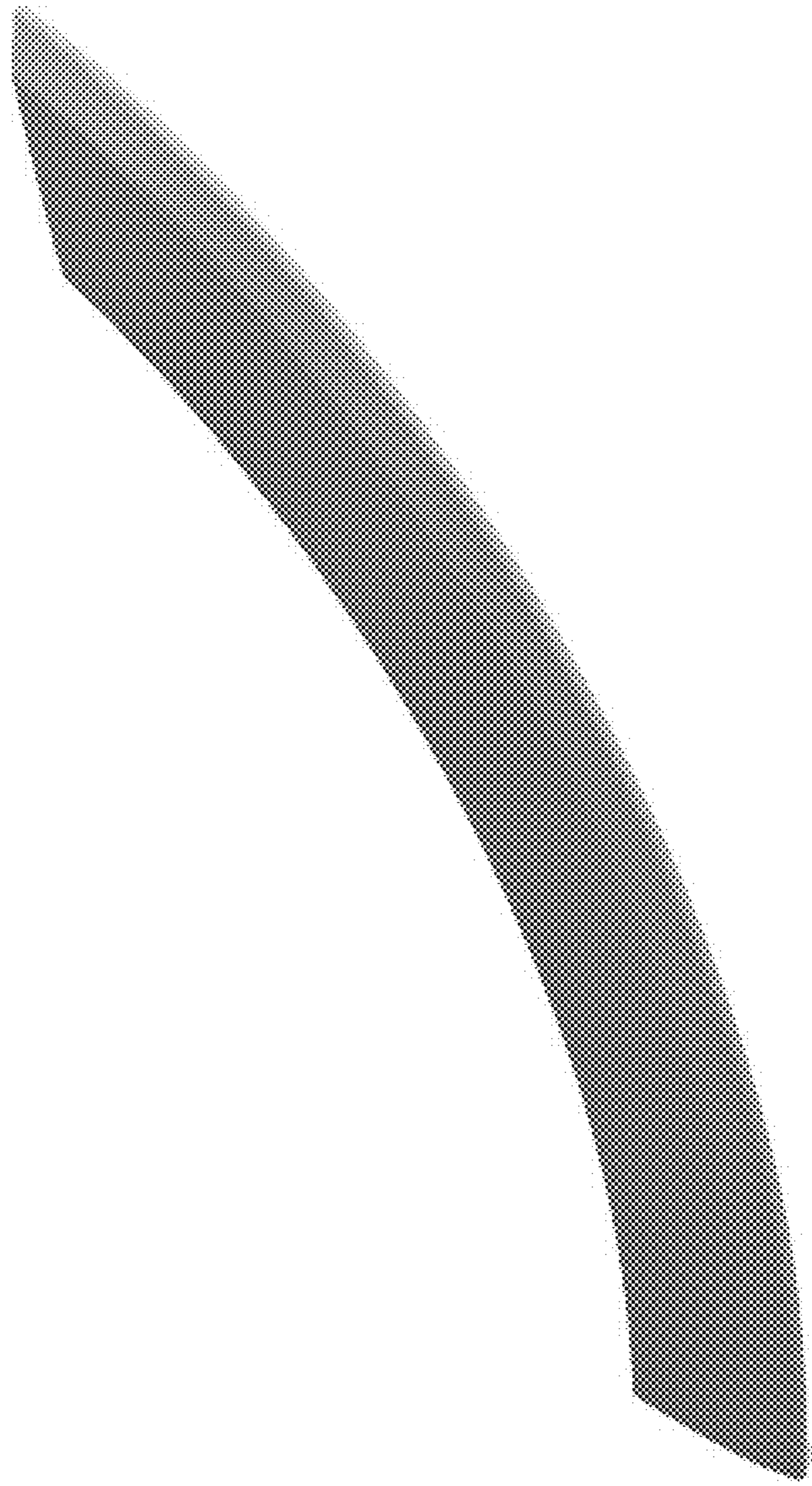

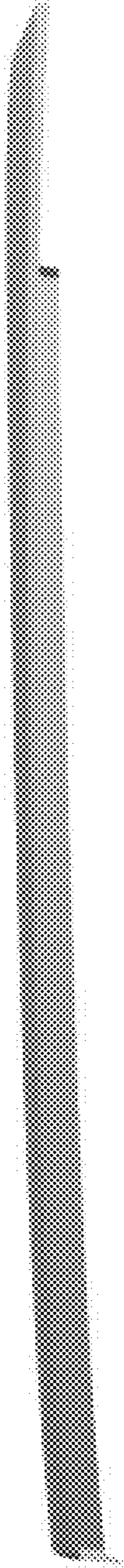

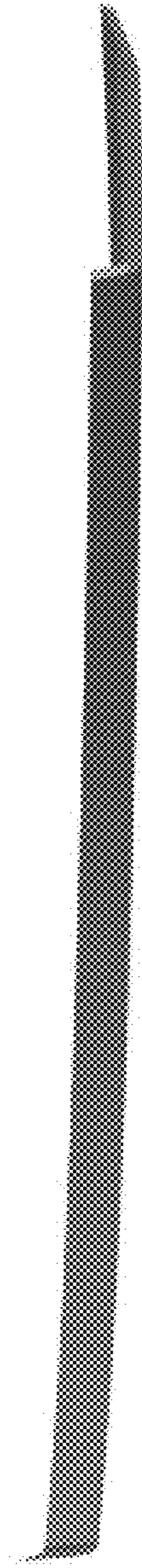

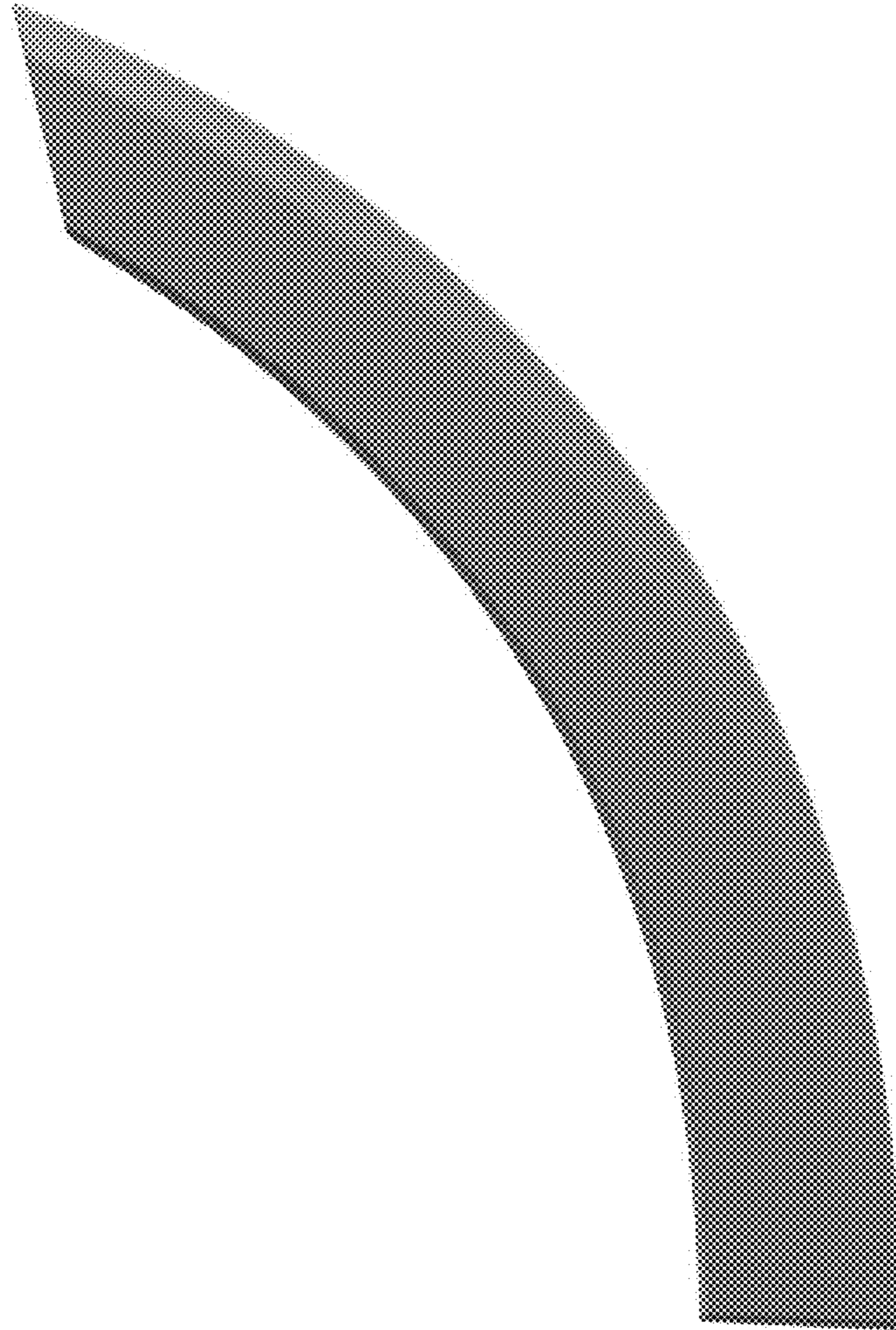

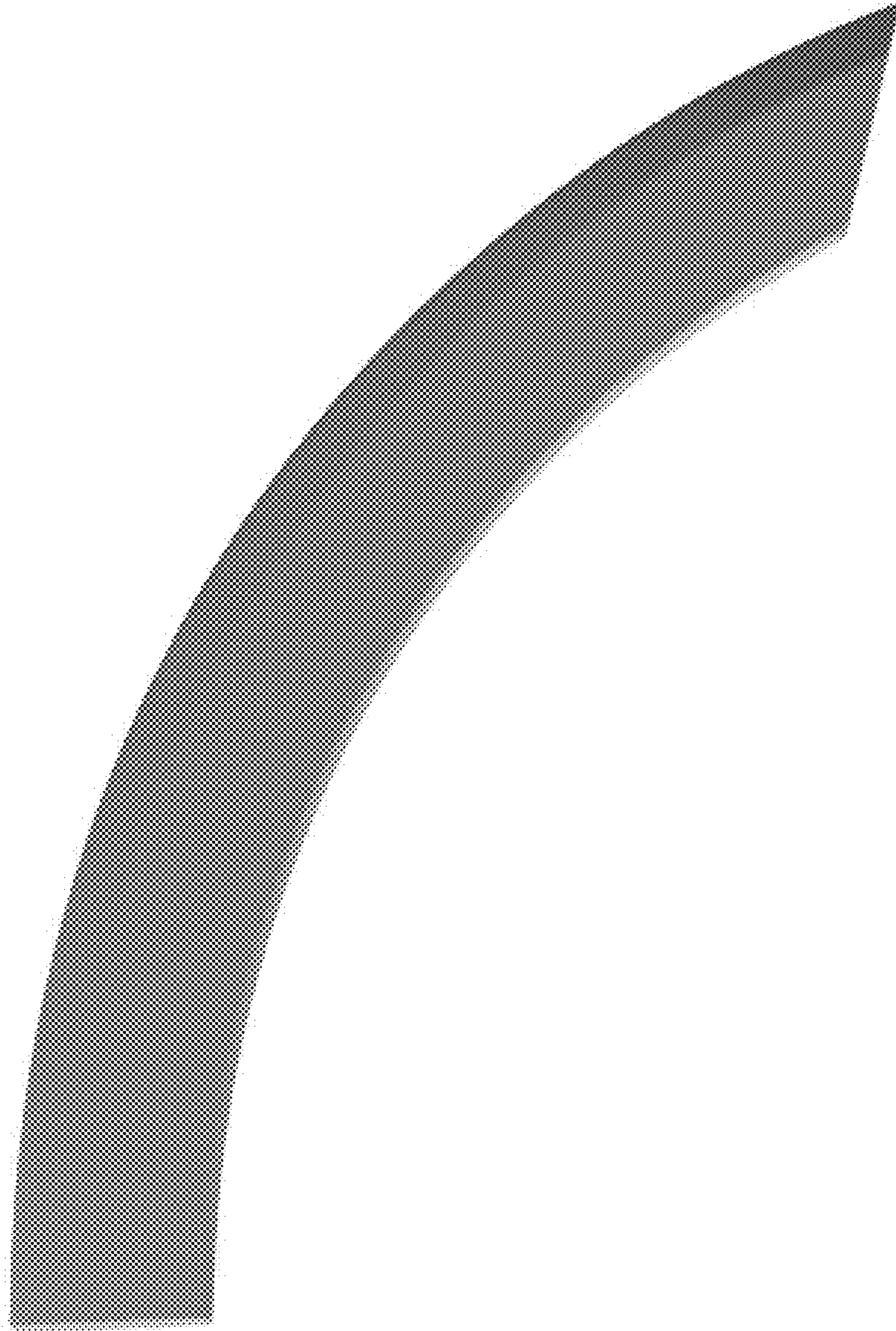
